PORTRAIT OF EXCELLENCE

The feature of Portrait of Excellence for this issue of *The Reporter* is bestowed on three chapters . . . Rasco Chapter at the University of Miami, first place winner in the Outstanding Chapter Competition, deDiego Chapter at Catholic University of Puerto Rico, second place winner, and Lawson Chapter at the University of Missouri-Columbia, third place winner.

Rasco Chapter — Repeated again as the number one chapter in PAD. Total membership of the chapter as of April 14, 1991, was 309 persons. The chapter conducted some very outstanding professional programs during the school year, including programs on law related education, first year academic orientation workshop, series of speakers, career counseling seminar and current problems in Russia's legal system.

Chapter members also participated in a gender symposium, a lecture series, visits to the Court of Appeals, moot court competitions and client counseling in volunteer income tax assistance.

Among the chapter's many social functions were the Night in the Tropics rush party, a beach volleyball challenge and a haunted house Halloween party.

The secret to the chapter's success is a finely-tuned committee system which includes committees on membership and rush, law related education, scholarship auction, tailgate club, Thanksgiving food drive, alumni and faculty relations, test packets, outlines, old folks home, children's hospital, Halloween party, exam preparation, scholarship, speaker series, PAD directory and Operation Home Front. The chapter uses a computerized database system to make the final decision for appointments to committees.

Rasco's scholarship auction raised \$4,200 which was distributed in scholarships.

Chapter members hold virtually all positions in the law school student body and class and student affairs, including SBA president, vice-president, secretary, treasurer, moot court board president and vice-president.

Law school chapters seeking to take advantage of the success of Rasco Chapter can write the Executive Office for a copy of the chapter's competition questionnaire.

deDiego Chapter — deDiego Chapter at Catholic University of Puerto Rico had 132 members as of April 14, 1991. Its long list of professional programs included law clerk's program, visit to the Legis-

lature of Puerto Rico, visits to the Puerto Rico Bar Association, Bar Exam review classes and PAD week.

Its social functions included a clothing rally, Cancer Association lottery and a visit to the Yunque.

The chapter also enjoyed outstanding success with its Big Brother program, law clerk program, sponsorship of a seminar regarding ethics in the judicial profession, adopt a pre-law chapter program, PAD basketball tournament, PAD T-shirt day, and a post election party.

deDiego Chapter also operates under the committee system, utilizing a number of committees to involve the chapter members in chapter activities.

Almost one-half of students in the law school are members of PAD. Three out of five student council officers were PADs, all five members of the ABA were members of PAD, all officers of the sophomore and senior class were PADs, and five out of six officers of the freshman class were PADs. Sixteen of the 20 members of the law review were PADs.

New programs inaugurated during the year included a law clerk program, under which a member was placed in the office of a lawyer as a law clerk, and TV coverage of PAD week.

Lawson Chapter — Lawson Chapter at the University of Missouri at Columbia was the winner of third place in the Outstanding International Chapter Competition of PAD.

Membership of the chapter increased from 79 members to 116 members. Professional activities of the chapter included a luncheon trip to hear Supreme Court oral arguments, exam taking videotapes, brown bag luncheon with the dean, a speaker's program, an outlining seminar, a program on ethics in appellate advocacy and the maintenance of an outline in study aid file.

Lawson Chapter maintains committees on legal related education, community service, academics, professional, finance, social, alumni, publicity and pre-law.

The chapter initiated two faculty members and a Missouri Supreme Court Justice.

Jill Leonard Is New Field Representative

Jill M. Leonard, past Justice of Reese Chapter at the University of Nebraska School of Law, has been appointed the new International Field Representative for Phi Alpha Delta.

Jill was born in Ogallala, Nebraska, July 24, 1966, and was raised in Wauneta, Nebraska.

She received a B.A. in History in December of 1987 from Creighton University in Omaha, Nebraska. While pursuing her undergraduate degree, Jill worked as an intern at the Hall of History in Boystown, Nebraska. During the summer of 1987, she worked as a research assistant to John Browne, Member of Parliament for Winchester in London, England.

In 1988, Jill began her law school career at the University of Nebraska College of Law. She was initiated into Reese Chapter of Phi Alpha Delta in October of 1988. Jill served as justice of Reese Chapter during the 1989-90 school year. While attending law school, Jill was also involved in many activities which included membership in the Student Bar Association, the Community Legal Education Program and the American Trial Lawyers Association. She was the recipient of the William Hold Scholarship in 1988. She was named as an "Outstanding Young Woman in America of 1990."

In the fall of 1989, Jill accepted a position as a law clerk with James A. Cada and Associates and worked closely with Jim Cada, District VI Justice of Phi Alpha Delta.

In the summer of 1990, she attended the 48th International Biennial Convention in Fort Lauderdale, Florida, where Reese Chapter was recognized as the Outstanding Chapter in District VI for the 1989-90 school year.

In August 1990, Jill moved to Granada Hills, California, to begin employment as an International Field Representative for the Executive Office of Phi Alpha Delta Law Fraternity, International. During her first four months, Jill has visited 38 law schools, attended two District Conferences and has participated in one formal reactivation.

Neal Smith Receives LRE Award

During the Law Related Education Seminar held in Washington, D.C., on July 10, a special award was conferred on PAD Congressman Neal Smith for his Lifetime Service to the LRE Program.

The Award was called the "Lifetime LRE Service Award," the first such award ever presented.

Congressman Smith was introduced by Tim Buzzell, State LRE Coordinator of Iowa, who was in turn presented by PAD PSC Project Director Beverly Bunn.

Congressman Smith, a member of Cole Chapter at Drake University Law School was first elected to Congress in 1958. His leadership in the education field has made him the strongest House of Representatives supporter for legal services for the poor and for law related education since 1978.

In the words of Congressman Smith "PAD has long been recognized for its furtherance of high ethical and service standards in the legal profession. It has made a vast significant contribution to the public good by its leadership in LRE which serves a previously unfilled role in teaching good citizenship and respect for law to America's youth."

Complete New Business Directory To Be Published

The International Executive Board is pleased to announce that a new business directory, complete with all members, will be published in 1992. A contract has been entered with The Summit Group of Fort Worth, Texas, for its publication.

The directory will contain an alphabetical listing by last name, and middle initial, city and state; and a geographical section listing both business and residential address, state and city; name, address and telephone number of employer, residential address and telephone number, chapter of initiation and year of initiation.

Members who have paid their alumni dues will receive an expanded listing in **bold type** which will include primary areas of practice, FAX number of employer, name of graduate institution and year of first admission to the Bar. In addition, dues payers will receive a \$15 discount on the price of the directory.

Members will shortly receive a business directory questionnaire form which should be completed and returned as soon as possible.

The new directory will be the first published by the Fraternity since 1975 and promises to be a truly outstanding publication.

PADs' Drug/Alcohol Programs

Law related education is an idea whose time has come. The Phi Alpha Delta Public Service Center's (PAD PSC) role is to enable PAD chapters to be active participants in LRE. Most recently the PSC has created state specific manuals to train law students and resource people to implement drug and alcohol programs in high schools.

This program informs students about the legal and social consequences of drug and alcohol abuse. It assists students in developing skills needed to identify their own attitudes, values, and expectations and to better estimate the risk of personal drug/alcohol use.

The resource manual was written to be used by law students and teachers. It serves as a guide for law students conducting lessons jointly with teachers. The manual includes a DWI mock trial, a lesson focusing on the consequences of a drug conviction and lessons on community level problems resulting from the use of drugs and alcohol. Law students form a partnership with a classroom teacher. In the partnership, the teacher and the law student decide which and how many of six different lessons to present, where the lessons fit into the curriculum and when the presentations are scheduled. The

program can be adapted to meet the needs of the school and its students. For example, the Burton Chapter at Boston University teaches the program in Spanish to meet the demands of the students in the Boston school system.

A Resource Guide to Assist Law Students For Participation in a High School Law-Related Education Drug/Alcohol Education Program — Field Test Version II will soon be available for every state and Puerto Rico. Presently three state manuals remain incomplete. The manuals are available on 3.5 inch or 5.25 inch disks (Wordperfect 5.0) free of charge to all law school chapters. Interested chapters will be assisted in making contacts with educators, State LRE Coordinators and PAD PSC Advisors, and with scheduling classroom sessions. Additionally,

Position Opening Phi Alpha Delta Public Service Center

The Phi Alpha Delta Public Service Center is seeking a Project Director to manage its day to day operation. The PSC is involved in Law Related Education for youth and is funded by a grant from the Office of Juvenile Justice and Delinquency Prevention (OJJDP).

Located in Bethesda, Maryland, the project employs four persons. The PSC has produced educational materials for use by volunteers and teachers involved in LRE. A network of PAD volunteers is managed by the PSC. The PSC sits on the Coordinating Committee for Law Related Education which is responsible for the management of the project funded by the OJJDP.

A law degree or law related education experience is required and PAD membership preferred. Duties will include involvement in the program work and development, grant writing and presentation and financial and personnel management.

The person selected must be willing to relocate to, or be from, the Washington D.C. area. He or she should be interested in law related education, be able to relate well to volunteers, represent the PSC in dealings with the Justice Department and other grantees and be willing to make a commitment of at least two years.

include working with law school chapters and PAD volunteers. She will provide training for law students and lawyers who serve as resource persons working with school systems.

Gracemarie obtained her law degree at the University of Richmond's T.C. Williams School of Law in Richmond, Virginia in May 1991. While at Richmond she was a member of the Henry Chapter of PAD. She served as marshal of the chapter in 1989-90. That year the chapter received the third place award in the Stanley H. Kohn Outstanding Chapter competition. She served as justice in 1990-91. During her tenure, the chapter raised approximately \$4,600 for the Jean Tarpley Public Interest Scholarship Fund, a fund which enables students to work in otherwise unpaid summer clerkships. Texas Attorney General Becomes Honorary PAD

Texas Attorney General Dan Morales was recently initiated as an honorary member of Tom C. Clark Chapter at the University of Texas.

Presiding over the initiation were International Advocate Joe Deems from Los Angeles, California, Past Supreme Justice C. Raymond Judice and Texas Supreme Court Justice Bob Gammage.

In preliminary comments, International Advocate Deems said, "It is with a great deal of pride that I come here to Texas this afternoon to participate in this event. I look forward to working with the members of the fraternity over the course of many years to-

ward the accomplishment of mutual goals, mutual objectives."

training will be provided to law students by a PSC trainer before they enter the classroom. Teaching techniques as well as ideas for developing the lesson plan to fit the needs of students in specific classes are among the topics covered during training.

The drug/alcohol manual is modeled upon successfully implemented programs developed by PAD chapters. Rayburn Chapter at Texas Tech University School of Law developed a manual explaining the legal consequences of an arrest and conviction for drug or alcohol offenses in Texas. The law students present their program to high school students in the Lubbock, Texas school system. In St. Paul, Minnesota Monroe Chapter developed a mock trial program that takes students through all phases of a drunk driving case. This program can be adapted for presentation in one, two or three day segments as part of regular high school classes.

While these programs are the models the manual is based on, chapters are encouraged to adapt or develop programs to suit the style of their chapter and the community they are serving.

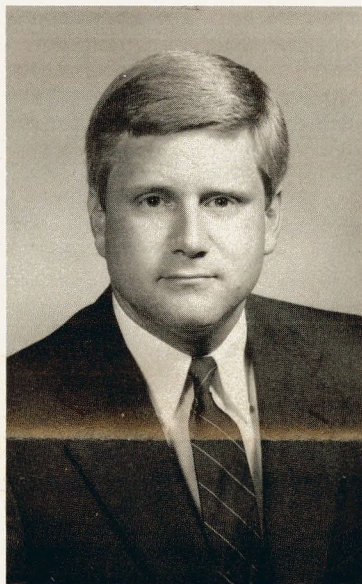
Robertson Becomes Missouri C/J

Brother Edward D. Robertson, Jr., a member of Benton Chapter at the University of Missouri at Kansas City, was recently elected Chief Justice of the Supreme Court of Missouri. Robertson joined the Supreme Court in 1985 when he was only 33 years of age.

The new Chief Justice was born in Durham, North Carolina, in 1952, and received his bachelor of arts degree from Westminster College in Fulton, Missouri. He entered the University of Missouri at Kansas City School of Law in the fall of 1975 and received his juris doctorate with distinction in 1977. While in law school, he served as an editor of the Law Review.

He earned a Master of Laws degree from the University of Virginia in 1990 and also received a Doctor of Laws degree from Westminster College in 1989.

He served as an Assistant Attorney General of Missouri from 1978-79; practiced law in Kansas City from 1979-81, during which time he also served as the municipal judge of Belton, Missouri; returned to government service as the Deputy Attorney General of Missouri from 1981-85, and prior to his appointment to the Supreme Court, served as Governor John Ashcroft's Chief of Staff.

Bower Receives A/F Medal

Glen Bower, District XIII Justice of PAD, was recently awarded the U.S. Air Force Commendation Medal in ceremonies at Scott Air Force Base, Illinois. The presentation was made by Col. Thomas Hemingway, Staff Judge Advocate of the Military Airlift Command and of the U.S. Transportation Command, and by Lt. Col. Michael McAntee, Staff Judge Advocate of the 375th Military Airlift Wing.

The citation accompanying the Air Force Commendation Medal states, in part, that Bower "... distinguished himself by meritorious service as Assistant Judge Advocate ..." "Major Bower's outstanding professional skill, knowledge, and leadership added immeasurably in the successful resolution of numerous complex and sensitive fiscal law issues." The citation continues, "the distinctive accomplishments of Major Bower reflect credit upon himself and the United States Air Force."

Bower is a Major in the U.S. Air Force, The Judge Advocate General's Department Reserves, assigned to Scott Air Force Base, Illinois.

In civilian life, Bower serves as Chairman of the U.S. Railroad Retirement Board, by appointment of President George Bush. The Railroad Retirement Board administers the \$7.2 billion retirement, unemployment, sickness, and disability programs that benefit the nation's 1.2 million active and retired railroaders and their families.

Previously, Bower served as Assistant Director of the Illinois Department of Revenue, as a Member of the Illinois House of Representatives, and as State's Attorney of Effingham County.

A Special Tribute to Robert E. Redding

Past Supreme Justice Robert E. Redding has recently changed his status with the Phi Alpha Delta Public Service Center in Bethesda, Maryland from the full-time Executive Vice President to a consulting status in order to have the freedom to pursue other activities. Brother Redding has also been involved in transportation issues for many years, both in government service with the Civil Aeronautics Board and the U.S. Department of Transportation and in private practice. He has recently accepted a position as a legislative assistant to Congressman Charles H. Taylor, a past International Justice of the Fraternity, on a part time basis. Congressman Taylor has responsibilities on the Transportation Committee, among others. Brother Redding will also remain available for international consulting through the United Nations and other organizations.

In his consulting role with the Public Service Center, Bob Redding will serve as a Program Developer on the Law Related Education and Drug/Alcohol Awareness projects. The LRE effort was initiated largely at the urging and through the work of Bob Redding. The Public Service Center and its predecessors have been the recipients of over \$2 million in grants over the past 13 years to supplement PAD efforts in service to our communities. In addition to his nearly 13 years as Project Director of these activities, Bob served as a Government Relations Consultant to the Board for nearly two years in getting the activities started. The enthusiasm and determination that Bob Redding always exhibits have been a large part of the success of the LRE program.

Brother Redding's service has hardly been limited to Law Related Education, however. He has always lent an experienced hand to PAD activities with the National Capital Alumni Chapter, including prominent roles in the annual Congressional-Judicial Receptions and all 25 years of PAD Day at the Supreme Court. To a generation of law students and young lawyers coming to Washington, he has been a friend, supporter, helper and counselor. Bob

Redding has touched the lives of literally thousands of his sisters and brothers in Phi Alpha Delta through a lifetime of service that began with his initiation into Taft Chapter while he was attending Georgetown Law School in 1946. After graduation, he served as both an officer of the National Capital Alumni Chapter, helping make it one of the largest and most successful alumni chapters in the Fraternity, and as District Justice. He was first elected to the Supreme Tribunal in 1954 and served on the Executive Board from 1956 through his term as Supreme Justice in 1966-68.

Bob Redding was largely responsible during his term as Supreme Justice for greater emphasis on professional service by our chapter. He also has been an unceasing promoter of community service activities. For all of his extraordinary contributions, Brother Redding was bestowed the honor of membership in the Distinguished Service Chapter of the Fraternity in 1972. Fraternity members may only be elected to membership in the Distinguished Service Chapter by the unanimous ballot of the International Executive Board, and this honor has only been accorded 14 members of our Fraternity in the past 89 years.

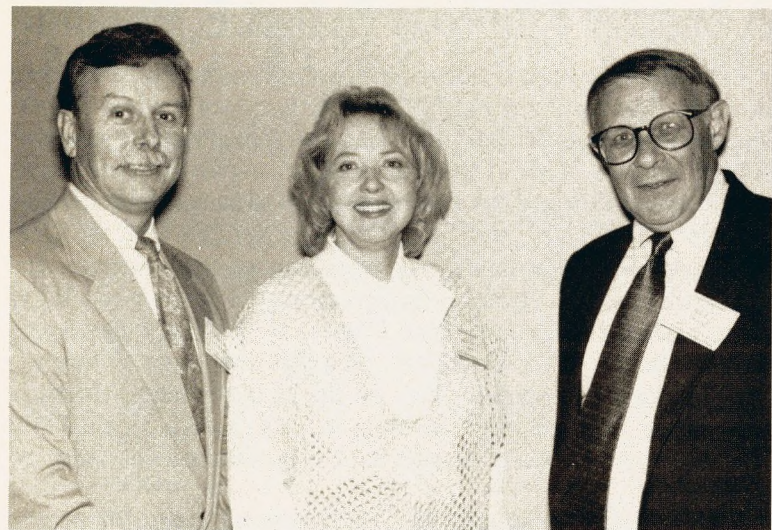
