



Public Service Has Special Meaning For Hughes Chapter



The Hughes Chapter at Denver University annually sponsors two blood drives. This year, however, the blood drives had a special meaning. Last May, we learned that our brother, former Hughes Chapter Marshal, Craig Negler was diagnosed with leukemia. Craig is now in need of a bone marrow transplant. PAD Hughes Chapter Vice Justice Chris Andaya, and Clerk

Katherine Markheim Lee along with Student Bar Association President, Carolynne White, organized the bone marrow drive in addition to the blood drive. Several thousand dollars were raised to fund the cost for the test.

With help from the DU student body, over 200 bone marrow tests were performed and deposited with the National Marrow Donor Registry. In addition about 100 pints of blood were donated to Belle Bonfils Memorial Blood Center. International Secretary J. Derek Hill, and District Justice Rhonda Hill were also instrumental in our efforts to raise donors as well as funds. We are pleased to report that Craig has found a bone marrow match.

Profiles In Excellence Carmody Chapter — On The Move In '92

Phi Alpha Delta Carmody Chapter, at the Syracuse University College of Law, is definitely on the move in 1992-93. Since returning to school in August, Carmody chapter has been going non-stop, bringing programs and services to the school and the community it serves.

In September, Carmody chapter sponsored a Blood Drive at the Syracuse University College of Law, drawing over 50 people. Both students and faculty alike came to support this event.

In October Carmody chapter sponsored "Opportunities '92" a job placement symposium aimed at helping students find a job in the legal field of their choice. Twelve different speakers from around the region came to share their experiences, and give students advice on how to approach looking for a job. Some of the featured speakers included:

• Ellen Zablan, a prominent Sports Agent, and the only female agent working in the N.F.L., who spoke on Sports Law & Sports Agency.

• David Greenspan, Director of Business Affairs and in-House Counsel for TROMA, Inc., who spoke on Entertainment Law.

• Jeff Rupp, a Capitol Area Phi Alpha Delta Alumni who works for the Department of Transportation in the Office of the Assistant General Counsel for International Law. He spoke on the topic of International Law.

In all, a total of over 400 students attended this symposium, which lasted the entire month of October, and two weeks into November. All of the students who attended felt they were greatly helped by the advice given to them by attorneys practicing in the "real world."

To further help fellow students, Carmody chapter set up a 1L Counseling session, where 2L & 3L members helped quell the fears of the first year students worried about upcoming exams. Carmody chapter also sponsored a Course Counseling session, where 2Ls and 3Ls shared their experiences in certain classes, helping each other decide what classes to take during the Spring semester. Questionnaires were distributed and filled out, to keep an ongoing record of teachers and their rating by students.

Also during October, Carmody chapter sponsored a Halloween party for the children staying at the Ronald McDonald House near Syracuse University. Over 200 children were in attendance for a 50s motif party. On November 16, 1992, Carmody chapter initiated 27 new members at the Onodago County Courthouse. Past Justice Keith Ebenholtz came back to Syracuse specifically to speak at the ceremony.

Wrapping up the fall semester activities, Carmody chapter sponsored a "Tree of Light" for the Salvation Army, in the Law School Lounge. This tree allowed law students to share their good fortune with those less fortunate than themselves. Special guest appearances by Santa helped keep everyone in a festive spirit throughout finals.

Carmody chapter kicked off its winter semester rush with its first annual "Wipeout Weekend," where festivities included a day ski trip to Song Mountain, and a social night at O'Tooles Pub. Later this semester Carmody Chapter will also be hosting the District XIX Conference.

For the coming months, Carmody chapter has many more events planned. Some of these events include adopting a whale through one of the conservation groups in the area, and the possibility of having attorney Jay Foonberg (who spoke at the Scottsdale Convention) give a presentation to the Syracuse College of Law.

Congressional Judicial Reception What A Party!

On March 31 the National Capital Area Alumni Chapter held its annual Reception honoring members of Executive, Judicial and Legislative Branches at the Rayburn Building in Washington, DC. "This year's event was the best yet in terms of attendance by VIPs, alumni and students," remarked District XXIII Justice Annette M. Wangl

Among the most notable honored guests in attendance were Virginia Governor. Douglas Wilder, United States District Court, D.C. Circuit Chief Judge, John G. Penn and Congressman Charles Taylor, a past International Justice. The NCAA honorarily initiated Congressman Howard Coble at the event, while earlier in the evening the Taft Chapter from Georgetown University held an initiation of its own.

"It was great to see this event come together after all the hours spent planning," remarked Nicholas A. Mirkay, chair of the reception. "It was great to see our Board Member Curtis Anderson and Associate Tribune Deborah Davis in attendance. Without their support and the support of individuals like Annette Wencl success would not be possible."

The reception, attended by some 150 legal professionals, was so successful students requested similar events to be planned. Events like this epitomize the full service programming PAD strives to achieve.

CLE Program Focuses On Sexual Harassment

A topic that was once taboo is increasingly in the news and on the list of things to worry about for corporate counsel and other attorneys charged with advising public and private employers. It is Sexual Harassment in the Workplace and that is the title of a Continuing Legal Education Seminar being sponsored by Phi Alpha Delta in conjunction with PAD Day at the Supreme Court. The Seminar is scheduled for Saturday, June 6, 1993, the Saturday immediately preceding the swearing in on Monday of PAD Attorneys from all over the country to practice before the Supreme Court.

The seminar is being organized by the staff of the PAD Public Service Center, Capitol area alumni volunteers, and members of the Taft Chapter at Georgetown University Law School. The seminar will be held at Georgetown Law School and proceeds from the seminar will go to the Public Service Center to assist the center in its non profit mission.

The seminar will focus on Intervention Steps to Take Before and Incident Leads to Litigation, Case Law Update, Damages, and Ethical Considerations for the Practitioner. The Faculty will feature Cathie A. Shattuck, of Epstein Becker & Green, P.C., who served on the Equal Employment Opportunity Commission under President Reagan and recently published a treatise entitled, The Employer's Guide to Sexual Harassment; Jonathan R. Topazian, of Fitzpatrick and Verstegen, who practices in this area; and Susan Morris, of the Office of Equal Opportunity, U.S. Army Electronics Command, Fort Monmouth, NJ, who is Chief of the Office of Equal Opportunity.

PAD is applying for CLE credit in states surrounding the District which have a CLE requirement as well as in New York, Texas and other states with a large number of bar members working in the DC area.

The program is scheduled to run from 8:30 A.M. to 1:00 P.M. The cost is \$65.00 for members who have paid their 1993 PAD alumni dues and \$80.00 for all others. P.A.D. ADOPT A PRE-LAW PROGRAM

In the late 1970s P.A.D. conducted fession P.A.D. developed the extensive research which uncovered a tremendous need for information among thousands of undergraduate students interested in law school and the legal profession. Law School administrative officials pointed out that students were quite often ill-prepared for the rigorous transition from undergraduate school to law school.

In addition it was discovered that the entire process of preparing for the LSAT, choosing a law school, and undergoing the law school application process could be frustrating and intimidating for many undergradutate students who lacked adequate information upon which to base their decisions. Each year these problems are personified by many undergraduate students who forego other educational or career alternatives to enter law school, only to find that law school is not what they expected and not what they want to do with their lives.

In an effort to "bridge the gap" which exists between undergraduate school, law school, and the legal proADOPT A PRE-LAW CHAPTER PROGRAM. P.A.D. Law School and Alumni Chapters are encouraged to work with and provide help to P.A.D. Pre-Law Chapters.

Since its implementation the program has been a huge success. One specific example is the Big Sibling - Little Sibling program which has developed between the Pre-Law members at California State University, Sacramento (C.S.U.S.) and the Clair Engle Law School members at McGeorge School of Law.

The idea behind the program is simple: pair up law school and Pre-Law students so that Phi Alpha Delta Pre-Laws will have a more accurate perception of the law school lifestyle. Once the pairs were formed, the course of relationship is left to the individual students.

Recommended activities include law school campus tours, Pre-Law attendance in first year classes, discussions regarding law school admissions policies and Pre-Law visitations with their assigned law students at the law student's place of employment. Pre-Law students are encouraged to accompany the law students to the Clair Engle Chapter's "Day With A Judge" program and discuss relevant legal issues and procedure.

Students were teamed up at a barbe-que held at the home of C.S.U.S. Chapter Officers, attended by approximately twenty law students and twenty-five Pre-Laws. One pair, Engle Chapter Director of Publicity Dana Mitchell and C.S.U.S. Chapter Vice President Pat Henning, traded chapter t-shirts on the spot.

Overall, the Pre-Law adoption program has been well received. The program provides the Pre-Law with a positive Phi-Alpha Delta experience, encouraging them to pursue active participation in membership and positions of leadership as law school members. And, law students are provided the opportunity to act as mentors to their Pre-Law partners and share their law school experiences.

PAD Attorneys Team Up With CRADLE

Under a program funded by the US Department of Education, PAD PSC will assist with a workshop in July 1993 sponsored by the Center for Research and Development in Law Related Education (CRADLE).

The conference will take place at Wake Forest University Law School in Winston Salem, North Carolina where CRADLE is located. PAD will assist state LRE Coordinators in selecting the attorney participants. The attorneys will team up with teachers from their local communities to build a LRE partnership.

Attorney participants will be trained to make effective LRE presentations in the classroom, to identify and motivate other community resources for the teachers with whom they are paired, and to understand the special need of the gifted learner. Attorneys will also be trained in the curricular offerings of the PAD PSC.

Teacher-lawyer partners will work for a year developing and testing lesson plans and creating an internship program that places students with professionals in the community. The training conference will occur from July 7-12 with the attorneys attending from July 9-12

NCAA Helps Law School Chapters Identify Potential Honorary Initiates

The National Capital Area Alumni (NCAA) Chapter embarked on a major initiative to help active law school chapters to identify potential honorary initiates and to prepare the applications for these distinguished persons. The goals of the initiative were to (I) increase the number of Honorary Members of the Fraternity, and (2) remind active chapters that alumni chapters can be tremendous resources if properly approached.

Prior to the 1992 International Biennial Convention the NCAA identified 68 U.S. Senators who were not affiliated with any law fraternity. The NCAA prepared applications for honorary membership for each of these unaffiliated Senators and submitted the applications to the International Board prior to the International Convention. The International Board pre-approved these applications with the understanding that the paperwork would be offered to the law school chapters in the state from which each Senator hailed, and those chapters would be given the first opportunity to initiate their Senator.

This initiative expedited the process for approval because the NCAA prepared the petitions, and the law school chapters know in advance that a particular person is approved by the International Board. It should also be obvious to

the active chapters that there are many other potential honorary initiates available, especially with the recent general election.

At the Convention the NCAA spoke with each District Justice and made an announcement during the General Session about the program and the applications to publicize the potential honorary membership petitions.

The NCAA encourages all of the Active Law School Chapters to file petitions on other potential honorary initiates, making sure to obtain the International Board's approval prior to contacting the individual. With the recent general elections behind us, it should also be obvious to the active chapters that there are many other potential honorary initiates available: new U.S. Senators, Ccongressmen/Congresswomen, Judges, Governors, Attorneys General, and other persons of distinction in the field of law.

The International Executive office prepared a manual for the 1992 International Convention "Alumni, Faculty & Honorary Membership." Use this manual to identify existing and potential Honorary members, then fill out the petition (included in the manual and in each Chapter Clerk's manual), and seek the International Board's approval right away. This is a way each Chapter can make a difference.

Pre-Law Chapters Chartered

Welcome to the newest members of the P.A.D. family. Pre-Law Chapters number 129, 130 and 131 at the University of Pennsylvania, Pasadena City College, and Salisbury State University have recently received their charter. Presiding at the University of Pennsylvania ceremonies was International Board member Curtis M. Anderson who was assisted by Margaret Cumisky. Anderson returned to the scene of his undergraduate studies in Philadelphia for the occasion. The Pennsylvania chapter has forty-four charter members

Within a matter of days, a similar ceremony was held in Pasadena, California. International Advocate Shelley A. Weinstein led the ceremony and was ably assisted by District III Justice Marci L. Bolter. Thirty new members participated in the proceedings and signed the roll as charter members.

Our most recent Chapter's chartering took place at Salisbury (Maryland) State University. The proceedings were capably handled by District XXI Justice David Benamy. He welcomed 17 new members to Phi Alpha Delta.

Our Pre-Law program has grown dramatically since its inception in 1981. International Justice Norman M. PRE-LAW PROGRAM TO HIRE FULL TIME COORDINATOR

Phi Alpha Delta's House Hunt

The full day of apartment hunting is followed by an informal picnic at the Law School. Many of the administration, faculty and alumni have attended in the past and are always welcome to attend in the future.

This worthwhile service project has proved to be very popular and well received by all involved.


