IEB Announces Award Winners

Zelkowitz Wins Stan Jones Award

The International Executive Board has selected **District Justice Alan Zelkowitz** as the recipient of the **Stan Jones Award for Outstanding District Justice**. As District XI Justice, Alan won the award for the second year in succession. His chapters were in the running for a number of awards, the District showed growth, and all chapters were rated highly. In addition, Fuller Chapter at Northwestern University School of Law was reactivated, after a long period of dormancy. Alan maintains constant communication with the chapters in his District and is readily available to provide leadership and assistance. This has enabled him to build one of the strongest Districts in the Fraternity.

The **Outstanding District Award** goes to **District XI**. The District led the Fraternity in initiations. All chapters have strong programming and the local Alumni Chapter, Chicago Alumni, is actively involved. The District has shown growth and development. It has improved the image of Phi Alpha Delta in the law schools and supported the activities of the chapters. The communication between the chapters, District Justice and alumni have contributed to success. Congratulations to District XI!

The **Best Professional Program Award** goes to **Morrison Waite Chapter** at the University of Dayton. Entitled "Lawyers In Practice", the program was designed to acquaint law students with different areas of law practice. Stations were set up and staffed by lawyers, who discussed their area of practice with the student on a one-on-one basis. Students were able to attend six stations, each for 20 minutes. Following the program, an informal reception was held. Students were able to visit with attorneys informally. The program was so successful the law school has used it in recruiting prospective students.

The **Most Improved District** is **District XXVI**. Under the guidance of District Justice Chuck Eiss, the District saw growth and development, in spite of the effects of Hurricane Andrew. In fact, the District exceeded its initiation goal by 47. What impressed the International Executive Board was the development of all of the chapters in the District. "Chuck Eiss

as a first year District Justice overcame many obstacles to lead the District through a very good year," said Norman Owen, International Justice. "We look forward to even greater successes next year. Congratulations to Chuck and all of the District XXVI Chapters!"

Earning **Chapter Merit Awards** for 1992-93 are the following chapters: William Blackstone, Chicago-Kent College of Law; James Dooley, Northern Illinois University; William O. Douglas, Bridgeport School of Law at Quinnipiac College; John Milton Hay, Case Western Reserve University; Clair Engle, McGeorge School of Law; John D. Lawson, University of Missouri-Columbia; Horace Lurton, Vanderbilt University school of Law; Edgar W. Timberlake, Wake Forest University school of Law; Daniel Webster, Loyola University (Chicago) School of Law; Harold Hitz Burton, Boston University; Abraham Lincoln, John Marshall Law School; John L. Sullivan, St. Louis University; and Harry S. Truman, University of Puget Sound. Congratulations to all for a job well done!

For the first time, the International Executive Board was asked to select the **Outstanding Pre-Law Chapter**. The winner is the Chapter at **St. Louis University**. The Chapter, under the leadership of its President Kris Gerhard and its officers, conducted a number of successful programs, held two initiations, one jointly with Washington University. The chapter awards book scholarships to seniors, hosts a monthly speakers program and sponsors a LSAT review course open to the University Community. Other programs included a voter registration drive, funding for the mock trial team, publishing a newsletter, and liaison with law school chapters.

Other Pre-Law Chapters submitting applications of special note are Canisius College, Buffalo, NY; University of Washington, Seattle, WA; University of Central Florida, Orlando, FL; Elgin Community College, Elgin, IL; Vanderbilt University, Nashville, TN; and University of Florida, Gainesville, FL. "All of these chapters can be proud of their accomplishments this year," noted International Justice Owen at the conclusion of the judging.

Profiles in Excellence

Each year the Fraternity recognizes outstanding individual chapters by presenting awards. This year, the International Executive Board faced a very difficult task as many nominations were submitted. "This is reflective of the excellent year Phi Alpha Delta had," stated Norman M. Owen, International Justice. "I am hopeful that everyone will use this year's experience and successes to build an even better 1993-94," said Owen.

The **Stanley H. Kohn Outstanding Chapter** award went to **George Sutherland Chapter** at the **University of Utah College of Law**. Under the guidance of District IV Justice Rhonda K. Hill and the leadership of Justice H. Kathryn Lamat, that chapter grew from 13 to 53 and initiated Utah Attorney General Jan Graham as an honorary member. Programming included many public service activities, food and blood drives, teaching law related subjects at the Salt Lake Community Alternative School, and Adopt A Highway clean up program. Rushing law school activities included outlining, exam taking and moot court seminars.

The chapter's well balanced programming offered the right blend of social events which drew good attendance. Initiations were held at the Utah Supreme Court in the fall and in the U.S. District Court in the spring. The chapter's aggressive fund raising program enabled it to raise more than \$1,000.00 to support

its projects and programs. Sutherland Chapter was the recipient of an LRE mini-grant from the P.A.D. Public Service Center which enabled it to implement its LRE program. Last, but not least, the chapter published a newsletter which received wide distribution.

The **Alex Hotchkiss Award** is presented each year to the individual who is judged to be the Outstanding Law School Chapter Justice. This year's winner, selected from twenty nominations, is **Tamara W. Ashford**. Tamara is the Justice of **Horace Lurton Chapter** at **Vanderbilt University School of Law**. Serving her second term as Justice, Lurton Chapter more than doubled its membership, engaged in a balanced program of social and professional events, received an LRE mini-grant from the P.A.D. Public Service Center, and was involved in the chartering of the Pre-Law Chapter at Vanderbilt University. She was the first to arrive and the last to leave an event. According to Treasurer Nicole Sippial, Tamara "made sure that all members had a voice in matters and by appropriate delegation, were involved in every aspect of any event the chapter sponsored."

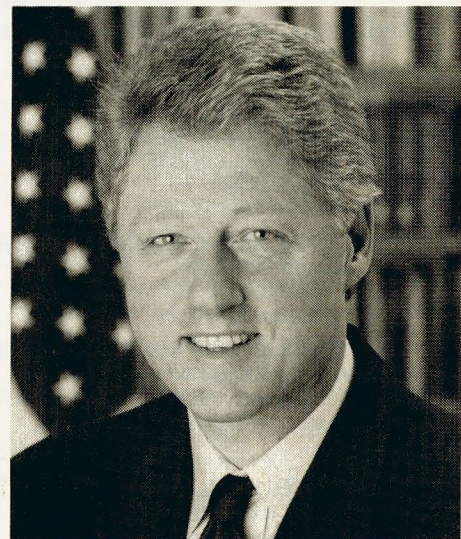
The **Frank E. Gray Award** is presented each year to the Outstanding Chapter Clerk. This selection is made by the Executive Director from nominations made by the Chapter Justice and/or District Justice.

Pre-Law Program is going to have to RUSH to hit its goal. The International Executive Board of P.A.D. has set an all-time high recruitment goal for our Pre-Law Chapters, and Pre-Law Director Maree Blackston predicts a recordbreaking fall.

The goal is 1998 new Pre-Law initiates in the fall 1993 Rush. "If we all work together to reach this Fall goal, then the Pre-Law Program will be well on its way to achieving its overall goal of 3200 new

initiates for the upcoming academic year. This goal is sponsoring top-quality educational and professional programming, and communicating with the Executive Office and P.A.D. members in their local areas," advises Pre-Law Director Blackston.

At its recent meeting the International Executive Board of our Fraternity reaffirmed its commitment to the continued success of the P.A.D. Pre-Law Program. The Pre-Law Program will be focusing on expanding its services to chapters and members with increased staffing and technical support to meet the growing needs of this Program.

The International Executive Board selected Houston, Texas, as the site of the 50th Biennial Convention. The hotel for the Convention is Del Lago Resort and Conference Center located in Conroe, Texas. The all-inclusive complex is ideal for a P.A.D. Convention. "Meeting rooms are plentiful, bright and cheery," according to Dalton W. Menhall, Executive Director. PAD Day at the Supreme Court a Success

In a special ceremony on June 7, 1993, at Washington, D.C., twenty members of Phi Alpha Delta Law Fraternity, International (P.A.D.) from twelve states were admitted to practice before the Supreme Court of the United States on the motion of Noel J. Augustyn, Assistant Director for Court Programs of the Administrative Office of United States Courts, and former Administrative Assistant to Chief Justice William Rehnquist.

Preceding the ceremony, Supreme Court Clerk William K. Suter welcomed the admittees to the Court. After taking the required oath before the full Court, Chief Justice Rehnquist welcomed the newly admitted members to the bar. Following the admission ceremony, the Fraternity hosted a reception with refreshments at the Court in honor of the admittees. Associate Justice Anthony M. Kennedy attended the reception to greet the admittees, their family members and friends. Justice Kennedy congratulated them, and expressed appreciation for their dedication to the law, which they have demonstrated by travelling to Washington to be admitted to the bar of the nation's highest court. He called on them to inspire others by their actions to serve the law with equal commitment.

Later in the day, the Fraternity hosted a

luncheon at the Congressional Rayburn House Office Building, under the sponsorship of the Hon. Frank R. Wolf, Congressman from Virginia. Norman M. Owen, International Justice of the Fraternity from Santa Rosa, California, congratulated the members on their admission to the U.S. Supreme Court Bar, and spoke about the many accomplishments of their Fraternity. Special guest at the luncheon was Emily Field Van Tassel, Visiting Professor of Law, Widener University School of Law, who spoke to the admittees on the inspirational work of the late Associate Justice Arthur Goldberg.

Toastmaster at the luncheon was Eli W. Bizic, Chairman of the Supreme Court Day Committee, with Scott P. Crampton as Vice-Chairman. Other participants in the program included Robert E. Redding, past Supreme Justice of the Fraternity, who gave the invocation, read a tribute to the late Alice O'Donnell, and who together with past Tribune William B. Robertson, presented Court memorabilia, and Jack Hanna, Director of the P.A.D. Public Service Center in Washington, D.C., who reviewed the activities of the Center in promoting Law Related Education programs throughout the United States.

While only one "winner" could be named in each category, with others receiving honorable mentions, the winners go far beyond those listed in print below. Each participant in PAD's LRE program was a winner, as were the many students whom the participants touched.

The 1993 PAD PRIDE LRE Chapter of the Year Award winner is **Engle Chapter, University of the Pacific's McGeorge School of Law**. In its first year of LRE program participation Engle Chapter focused on the fourth, fifth and sixth grade. Twenty-five law students visited eleven classrooms at two schools six times each, impacting approximately 300 students. The recurring visits enabled law student participants to form a bond with the children and their teachers while discussing the Bill of Rights. The programs implemented varied based on the needs and desires of those in the classroom. One team ran a mock trial from voir dire to verdict. Others created hypotheticals based on the Bill of Rights. Still others relied on PAD PSC ready to use curriculum. Engle's program was a huge success. Joseph Maloney, Executive director of the California LRE Center noted, "Requests are already being received for expansion of their program ... for the 1993-1994 school year."

The recipient of the PAD PSC Outstanding LRE Student Service Award for 1992-93 is **Michael R. Crabb**, a 1993 graduate from Cole Chapter at Drake University. Mike took it upon himself to motivate a small PAD chapter, make community contacts and get a LRE program not only off the ground, but established in the community. Mike worked with students at Ballard High school who conducted a mock juvenile hearing with the assistance of PAD law student coaches and community legal resource persons. The program culminated with a presentation of the hearing to the entire school.

This year's PAD PRIDE LRE Distinguished Service Award goes to the team of **Tim and Deb Phillips**, Tennessee LRE Advisors. This team, trained at PAD PSC's 1992 Training of Trainer's Conference took their commitment to LRE very seriously over the last year. Their energy, interest in LRE and ability to juggle the demands of family and work to make quality time for law related education impressed Tennessee state LRE Coordinator Suzanne Stampely. She noted, "These two attorneys have become an indispensable part of the Tennessee Consortium for Law Related Education ... They have shown their ability to make a difference in the lives of young people and those who teach them and they will continue to do so." For all their energy, enthusiasm and hard work, PAD PSC honors the Phillips Team.

upgraded room at the Convention and a scholarship.

International Treasurer Clifford Schechter noted that "Conventions are getting more and more expensive to produce. While we are fortunate to have access to great properties, the Fraternity must find alternative means of funding." The 1994 Ad Journal is one of the means available right now. International Justice Norman M. Owen emphasized the importance of "Our members realizing the need for delegates to assume a portion of the cost of sending them to the Convention."

In 1992, the Ad Journal raised over \$11,000.00 and in 1994 the Fraternity's goal is to double that amount. Details regarding the promotion and publication will be mailed to all chapters right after Labor Day. Watch for the mailing and get a head start on a rewarding fund raising project.

Delegate Incentive Program Adopted

To encourage Chapters to send more than one delegate to the 50th P.A.D. Convention, the International Executive Board has approved an incentive program open to all chapters. In announcing the program, the IEB noted the positive results from prior incentive programs.

Under the 1993-94 plan, any chapter that initiates one member more than their 10 year best will be entitled to the second delegate and receive reimbursement at the same rate as the first delegate. The Board set a minimum of 35 new members and any chapter that gets 100 new members will qualify for

the second delegate.

"We expect this will have a positive effect on our chapters and our members. Our Conventions are dynamic and fun," stated International Board Member Curtis M. Anderson, who will lead the program. Held at attractive resorts and hotels, members have long and fond memories of their P.A.D. Convention experiences.

Information regarding the program will be sent to each chapter and the District Justices around the first of September. It will include rules and procedures to be followed.

Fuller Chapter Re-Activated

On April 16, 1993, after more than a decade of inactivity, the Melville W. Fuller Chapter at Northwestern University in Chicago re-activated and initiated fourteen new members. With the authority of the International Executive Board, the Honorable Howard T. Markey, Chief Judge of the U.S. Court of Appeals for the Federal Circuit (retired) declared the chapter re-activated and then spoke to the new members about his long involvement in Phi Alpha Delta. Judge Markey, who is now the Dean at the John Marshall Law School, concluded his remarks by reiterating his now famous statement: "Phi Alpha Delta is not the best because we're the biggest law fraternity ... we're the biggest because we're the best law fraternity."

Following Judge Markey's remarks, the "re-activation team" of District XI Justice

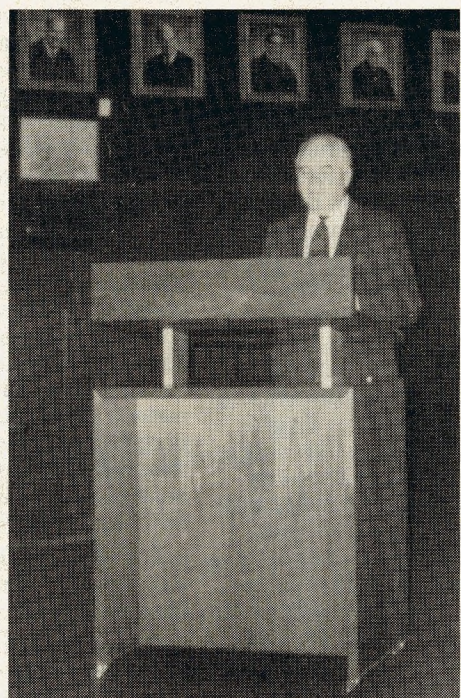

Summer Conference Starts a Public Service Legacy

Over 50 attorneys and 50 teachers gathered in the July warmth of Winston-Salem, North Carolina to participate in the fulfillment of a very hot idea: teachers partnering with lawyers from their home communities to better implement law related education programs in classrooms across the country. The conference called LEGACY!, Linking Educators and the Gifted with Attorneys for Civics: Yes!, was funded by the United States Department of Education through the Center for Research and Development in Law Related Education (CRADLE) at Wake Forest University Law school. The Phi Alpha Delta Public Service Center (PAD PSC) worked with state LRE Coordinators to select the attorney participants and conducted specialized training for attorneys and teachers at the conference.

Through its leadership role in this endeavor the PAD PSC has increased by 50 the number of attorneys serving as PAD LRE Advisors. PAD LRE Advisors support local and state LRE programs at the request of State Coordinators by conducting workshops, and developing community and professional support for LRE through contact with judges, lawyers, elected officials, and bar associations.

The attorney participants in last summer's conference will build a legacy of effective partnerships with individual teachers by designing and implementing a partnership plan with their cooperating teacher that takes advantage of their particular talents and fulfills the specific needs of the teacher. Attorney partners may be utilized to present lessons in the teacher's class, identify and recruit other community resources to present to the class, provide a "hot line" for teachers to call in with specific legal questions, coach mock trial teams, provide intern- ing and career shadowing opportunities

for students and provide any number of additional services teachers and students may require.

This year's conference focused on the reasoned resolution of disputes through history, literature, and innovation. Mock trials, simulated constitutional conventions, and mediation sessions were also part of the instruction offerings. PAD PSC made a variety of presentations at the conference including "Shakespeare on Drugs," a lesson that uses a scene from Othello to introduce the topic of alcohol abuse and "Rock and Roll and Censorship," a lesson that is introduced by the songs of Iced Cube and Charlie Daniels.

LEGACY '93 focused on middle school teachers. The project is slated to run for two more years with elementary teachers the 1994 focus and high school teachers in the spotlight in the summer of 1995. PAD PSC and CRADLE are set to continue their cooperative effort through LEGACY!

Mississippi Attorney, Pamela Dill, said of the experience, "I enjoyed the LEGACY Conference so much. The chance to work with such dedicated and knowledgeable people was well worth the trip." Schenectady, New York teacher, Deborah Escobar added, "It was a very ambitious undertaking and I returned home tired. However, my attorney partner, Alise Hiller, and I have already made out unit lesson plans and developed an overview of what we want to accomplish. I have received wonderful materials and I am so grateful to get to know and spend time with my attorney partner. I am flabbergasted that this has all been for free."
