Griffith Chapter Begins Pro-Bono Program

The Members of the Virgil A. Griffith Chapter at Mississippi College School of Law have established a new and innovative program which truly exemplifies the Phi Alpha Delta motto, "Service to the Student, The Law School, The Profession and the Community. After ten months of laborious planning and preparation, the program is finally past the embryonic stage and Griffith Chapter is about to give birth to the Phi Alpha Delta Pro-Bono Referral Service, which is the only program of its kind in Mississippi. Based upon the favorable response of the Mississippi College School of Law faculty and the members of the Mississippi Bar, the Referral Service promises to be a tremendous success. The Referral Service was kicked off with a reception where several highlyesteemed members of the Jackson legal community spoke about the necessity of doing pro-bono work and the likely impact that this program will have on Mississippi residents.

The primary purpose of the Phi Alpha Delta Pro-Bono Referral Service is to encourage attorneys to accept more cases on a pro-bono basis by matching them with eager Mississippi College School of Law students who are interested in doing legal research on a volunteer basis. Since the School of Law is located in Jackson, the state capital, the program has the ability to reach a large portion of Mississippi residents who qualify for, and need, legal aid. While these individuals are the ultimate beneficiaries of the Phi Alpha Delta Pro-Bono Referral Service, the students will also benefit from the program as they will gain valuable experience in researching pertinent legal issues and will earn recognition in the Jackson legal community. The students will have the unique opportunity to volunteer their

time at the Pro-Bono legal clinic, which is sponsored by the Mississippi Bar and the Pro-Bono Project of Jackson, and as such, will gain tremendous experience in screening and interviewing clients. At the end of every school year the Pro-Bono Project will calculate the amount of hours that were donated by students and will recognize this donation at an official function of the Mississippi Bar. There will be an award given at the end of every school year to the student who donates the most time to the Project and this award will be also presented at an official function of the Mississippi Bar.

The Referral Service, which is actually the first phase in a three phase program, will hopefully culminate with the establishment of a walk-in legal clinic at Mississippi College School of Law. The second phase of the program is intended to combine the legal research component of the Referral Service with a hands-on practical experience where the students will actually volunteer in a legal clinic.

The Pro-Bono Project has recently implemented a walk-in legal clinic and has opened it up to student volunteers from the Referral Service which has catapulted the Chapter unexpectedly, to the brink of the second phase of the program. As a result the Chapter is quickly approaching the ultimate goal of sponsoring a legal clinic through Mississippi College School of Law.

The three-phase plan is contingent upon a showing of dedication on behalf of the members of the Griffith Chapter as well as a commitment to the continuous administration of the Referral Service. In order to ensure the success and perpetuity of the program, an Advisory Committee has been established which is made up of May 1994 graduates who are planning on staying in the Jackson area and who were involved in the creation of the project. This committee promises to make itself available for advice and, if


All of this knowledge is why you believe. Believing is seeing our excellence, our dedication to our motto, our fraternalism, our benefits of membership.

1994 Biennial Convention Taking Shape

With the 1994 Biennial Convention, the Fraternity's 50th, only four months away, plans are beginning to take shape for this premier event. International Justice Norman M. Owen in commenting upon the planning observed "This Convention could promise to be one of the best in the history of a long line of outstanding conventions."

Already ten chapters have qualified under the 2nd Delegate Incentive Program.

There are a number of business sessions which will help the delegates organize and build their chapters when they return to their schools. Workshops on fund raising, time management, recruiting and programming are all planned. In addition, there will be a chapter to chapter workshop which will allow the delegates from the various chapters to discuss their projects and to learn about solutions to mutual problems.

The major work of the Convention will be done through the committee process which will begin on Thursday. By the time the Convention concludes on Saturday night many recommendations regarding the operation of the Fraternity

At this meeting the new board will officially begin its duties on behalf of the Fraternity.

Service Scholarship to be Awarded

Each year your Fraternity awards five scholarships to members who have contributed to their Chapter and community. Each scholarship is \$500 and only one application may be submitted by each Chapter. The applications are reviewed by the International Tribunal, consisting of Hector Mendez-Loucil, Deborah Ann Davis and Robert L. Schimmel. Judging is based upon Fraternity activities, service to the law school and need. Applications must be submitted by June 1, 1994 and the awards will be announced at the Biennial Convention. 
Fall Law Forums Scheduled P.A.D. Pre-Law Conference Planned

Monday, January 17, 1994, 4:32 a.m.: A date and time Southern Californians will never forget! An earthquake of 6.8 magnitude rocked the San Fernando Valley and the home of Phi Alpha Delta Law Fraternity, International. it was not until the next day that access to the building was accomplished. Filing cabinets were tipped over, files strewn all over, furniture moved and heavy equipment tossed around like ping pong balls. Water, power and telephone service was lost.

Within two days the staff had worked

diligently to restore some order out of the chaos. While service to chapters and members was interrupted for a few days it was not long before the telephones were being answered and the activities resumed. However, it took some time to restore normal operations.

The staff is extremely grateful that no one suffered severe injury and appreciate the expressions of concern and offers of help from many P.A.D.s.

Big Schools Can Make Big Differences

We've all heard of the University of North Carolina, the University of Wisconsin, Georgetown University, the University of Texas and the University of Florida to name a few of the big, national schools out there. These universities have in common awesome reputations, well known athletic teams and huge student bodies at minimum. Despite the numerous extra-curricular activities each student can select from, law related education is becoming one of the activities of choice at each of these schools which share the commitment of their law students to make a difference in their communities. Each of these schools is implementing a law related education program in its community. All are working with Phi Alpha Delta Public Service Center to place law students in classrooms to talk about the law and the need for all citizens to be involved in government.

Jason Slatkin has been heading the University of Florida's law related education program for two years. Slatkin and numerous UF students visit Gainesville high schools to discuss current events using P.A.D. P.S.C.'s Lesson Plan of the Month Series. Recently after successfully discussing Rock and Roll and Freedom of Speech a teacher pointed out a group of

students very involved in the classroom learning experience and indicated they were all convicted felons. Slatkin and the other UF students walked away knowing they were making a difference since these young adults were interested and engaged in learning.

At the **University of Texas** approximately 80 law students turned out for a training conducted by Austin teacher and P.A.D. P.S.C. consultant, **Jane Ann Craig.** Enthused and well prepared, these law students are now visiting Austin high schools under the coordination of T.C. Clark Chapter Justice, **Ashley Langdon** and LRE Chair, **Erica Worth.**

Ryan Chapter at the **University of Wisconsin** is a newly reactivated chapter with incredible enthusiasm. 

In Alemoriam Henry C. Rohr, 1904-1994

Past Supreme Justice Henry C. Rohr (1968-70), born two years after the South Haven Articles creating Phi Alpha Delta, initiated into Ross Chapter (University of Southern California) in the depths of the Great Depression, organizer of the 1948 Los Angeles Convention which inspired the post World War II renaissance of the Fraternity Supreme Justice who expanded Phi Alpha Delta's reach to the International, died on March 19, 1994. His career spanned the modern history of the Fraternity and exemplified its motto of service.

University of Southern California Alumni old-timers remember the years when Henry ran the gas station across from campus as he saved to one day enter Law School. When he was admitted to the California Bar in 1937 there were no jobs to be had, so he commenced a life-long career of successful solo practice on Spring Street, in the financial and professional heart of the city. Innumerable young attorneys starting practice before the War, and returning after, owe their careers to his advice and assistance. One took his advice to heart, went back home to Kansas to practice, and became Governor. For generations of P.A.D. graduates Brother Rohr was the Los Angeles P.A.D. placement service.

Brother Rohr was instrumental in rebuilding the Fraternity after the War. Working with A. A. McDowell, later Supreme Secretary, and other Los Angeles Alumni leaders he helped raise the funds requested by National to provide all the entertainment at the Los Angeles Convention. No Convention before or since has been so lavish, yet the funds raised were so in excess of need that the Alumni were able to start the Student Loan Fund which to this day provides aid to Los Angeles actives. Henry was a Trustee at his death.

Henry's National activity continued after the convention when he attended the first Post-war District Conclave in Lincoln, Nebraska in 1949, forging friendships with Brothers from throughout the nation. He brought the concept back to the West Coast and helped it spread throughout the country. He also worked closely with Supreme Justice Douglas L. Edmonds and was instrumental in recruiting Frank E. Gray as Executive Secretary.

Brother Rohr consistently advocated a search for the best and most prestigious leadership the membership could provide. He served with distinction as District III Justice for years, before finally going on the Board of Tribunes in 1954. During

this period he built the District, and the entire West Coast, into one of the strongest areas of Fraternity activity in the country. Meanwhile he also served the State Bar of California in enforcing ethical standards of practice in many volunteer capacities.

In 1960 the Convention elevated Henry to the Supreme Board as Supreme Secretary, a position he held for three terms. In 1966 he was elected Supreme Advocate and in 1968 he became Supreme Justice and saw a dream come true when he installed the first Chapter outside the U.S. at the University of Windsor, Ontario, Canada in 1969.

Henry Rohr helped shape the Fraternity as a bulwark of ethical professionalism. As its representative to the Professional Inter-Fraternity Conference he lead the successful effort to revive it and build it into a force for leadership in all professional fields encompassed by its member organizations. As a practicing lawyer he was respected by his peers and his clients. The profession, community and Fraternity are better for his having served among us.
