# Justice Ginsburg Initiated During P.A.D. Day at the Supreme Court

On June 6, 1994 in Washington, D.C., Associate Supreme Court Justice Ruth Bader Ginsburg became an honorary initiate of the National Capital Area Alumni Chapter of Phi Alpha Delta Law Fraternity, International. International Justice Norman M. Owen was in attendance at the initiation and had the following remarks, "I was honored to be able to participate in such a landmark event for Phi Alpha Delta. It was truly one of the highlights of my biennium as International Justice."

Justice Ginsburg attended Harvard Law School (1956-58) where she was a member of the Harvard Law Review. She also attended Columbia Law School (1959) where she was a member of the Columbia Law Review and a Kent Scholar.

Ginsburg was admitted to the New York Bar in 1959 and the District of Columbia Bar in 1975. She was a Professor at Rutgers University School of Law (1963-72) and Columbia Law School (1972-80) as well as visiting many faculties around the country and abroad. Justice Ginsburg was involved in various aspects of the legal profession before being nominated by President Carter (Keener Chapter) to the United States Court of Appeals for the District of Columbia Circuit in 1980. Most recently, she was nominated by President Clinton (Garland Chapter) as Associate Justice of the Supreme Court of the United States in 1993, a position in which she currently serves.

"It's an honor and a privilege to welcome members such as Justice Ginsburg into the Fraternity. Let me take this opportunity, on behalf of myself and the Executive Office, to extend the warmest of greetings and the sincere wish that she will reap the benefits of belonging to such a wonderful organization," stated Dalton W. Menhall, Executive Director.

## Teamwork



In a special ceremony on June 6, 1994, at Washington, D.C., sixteen members of Phi Alpha Delta Law Fraternity, International (P.A.D.), from eleven states were admitted to practice before the Supreme Court of the United States on the motion of Noel J. Augustyn, Assistant Director for Court Programs of the Administrative Office of United States Courts, and former Administrative Assistant to Chief Justice William Rehnquist.

Preceding the ceremony, Supreme Court Clerk William K. Suter welcomed the members to the Court. After taking the required oath before the full Court, Chief Justice Rehnquist welcomed the newly admitted members to the bar. Following the admission ceremony, Associate Justice Ruth Bader Ginsburg graciously met with the admittees, their families and friends. The members took this occasion to bestow upon Justice Ginsburg honorary membership in Phi Alpha Delta.

## Chapters Develop Unique Education Programs

All the chapters mentioned below have strong leaders and enthusiastic members. All have contacts in the communities and have their own way of letting educators know that the law students in their community care about vouth and seek to be involved in their education. Each chapter sends law students, usually in teams, into classrooms to lead discussions with students about citizenship and how the law affects each of us on a daily basis. Each chapter knows the importance of interaction with the next generation and has personally, through its membership, felt the rewards of this interaction. Each chapter is unique in its approach, however. Here are a few examples why all chapters teaching about citizenship and the law deserve applause.

One of the elementary schools Engle Chapter at McGeorge School of Law works with is Village Elementary where many of the students are from families of Russian descent who recently emigrated to the United States. The chapter's primary focus with these students is freedom of speech and press issues. The students learn about some of the basic rights of citizens of the United States. They also learned about the judicial system. The law students culminate their visits with a mock trial. The elementary students learn a great deal from the law students because Engle takes the time to work with the classroom teachers, find out about the students' backgrounds and teach lessons appropriate for each group of students based on what the students would be interested in learning.

Stephanie Singleton, from Ruffin Chapter at the University of North Carolina was instrumental in getting law related education off the ground in Chapel Hill. The Cofounder of Child Action, a campus group dedicated to providing an outlet for students interested in children's legal issues, Singleton united the two groups to serve the children of Chapel Hill. Sixty four law students helped middle school students learn how the law impacts current events. Teacher, Cissy O'Neal's eighth grade classes loved the law student's visits. "To them, I'm the Establishment, but ya'll are cool. You're like gods to them," she commented. Maybe that is the hook for law students. After being beaten by the Socratic method day after day, it is pleasurable to have someone appreciate you, let alone put you on a pedestal.

UNC's program is not going without notice. The faculty and administration are talking about it, as is the Dean who

has received letters from the elementary and middle school students praising the service by the law students. Consequently, the administration is spreading the good news about the chapter to the school's alumni through newsletters and articles in local newspapers.

Balance among presenters is a key part of the program developed by Fletcher Chapter at the University of Florida. The chapter encourages and recruits all members of the law school community to become involved in LRE. Both members and non-members of P.A.D. participate in the program. The instructional teams are carefully matched so that black, white, Hispanic and Asian students are all represented in the classroom. Age diversity among law students is sought. The obiective behind this action is to smash stereotypical conceptions of law students and the law profession while sending a message to students that they too can succeed in their chosen ca-

In Austin, Texas, **Tom C. Clark Chapter** has worked through the system established by the Austin Independent School District and won praise for the **University of Texas** program. Clark Chapter is part of the Adopt-A-School program in Austin high schools where they teach about a variety of law related subjects in sociology, geography, law and history classes. The chapter, nominated for a "Best Adopter" Award by Austin High School, is seeking official adopter status at all of Austin's high schools.

An extensive resource library has been created by Daniel Webster Chapter at Loyola University of Chicago. The chapter worked with 5 inner city Chicago elementary schools and 1 high school during the past year. They helped students learn about the Constitution, the branches of government, civic responsibility and citizenship. Law professors served as consultants to the participants regarding substance and procedure for teaching about the law. Materials were gathered, indexed and placed on reserve in the library for review by interested law students. Underprivileged children were enriched by the information from and interaction with the Loyola law stu-

## PSC Report

## One Person Can Make A Difference

In the District of Columbia there is one attorney who is single-handedly making a difference in hundreds of young lives. Keith Miles, a 1992 graduate of Howard University Law School, uses annual leave so he has time to visit students at Eliot Junior High School in northeast D.C. Miles began working with students during law school when Langston Chapter of Phi Alpha Delta was a pilot site for an elementary Bill of Rights publication. Gifted in front of students, he has continued to volunteer while getting his legal career off the ground. Miles served as a judge for the District of Columbia finals of the We The People Competition in January and started working with one school after riding the Metro home from the competition with some of its students.

When teacher, Andrew Givens called Phi Alpha Delta, after learning about the organization at a teacher awareness seminar, to request the assistance of a young African American male attorney there was one obvious choice: Keith Miles. The idea of visiting one class sometime in the spring to talk about the Bill of Rights immediately appealed to Miles. He and Givens took it from there. The results have been astounding. The one visit / one class concept is long gone. Miles has since adopted Givens' classes and a few more. He has spent days at Eliot and developed a relationship with "his students." Miles will be the first to say it wasn't easy getting through to students who have to be tough to survive, but he didn't give up and, in fact, has gotten through and made a difference in more than a few lives. Many students have sent personal notes to Miles thanking him, telling him how his visits have affected their lives. One young man wrote, "Thank you ... for helping us realize that we can succeed in life ... and helping me realize that I can do anything." Another wrote, "It's not everyday as youth of urban Washington, D.C. we get to voice our opinions." A young woman said, "I personally appreciate you coming out, because I learned how to express myself more and feel comfortable about whatever it is I've said. I think its really important that the students get a chance to express their feelings once in a while. You were the first speaker that has come to our class and allowed us to give some input ... I also found out that not everyone will like each other because we're all different." Finally, a young woman said, "Thank you for coming in to have a lecture with us about RESPECT. I was late, but I learned a lot in the time I was here, hearing a lot of things I need to hear, and

getting a lot out. I don't care what anyone said to you, you always said something positive back. I would really like to talk and hear from you again." Unquestionably, Miles was a huge success. He is making a difference.

Teacher **Andrew Givens** acknowledges Miles impact. "Unlike other visitors, Keith has been able to get the students to open up and express themselves." He and Miles have been plan-

ning activities together and are presently working on a field trip to Howard University for approximately 100 students.

All agree that **Keith Miles** is making a difference in the District of Columbia public schools. He has gone in, rolled up his sleeves, sat down with the students and told them that he expects them to set goals, achieve them and be active, productive citizens who, like him, can make a difference if they set their minds to it.

## State of Our Fraternity

As we close this 1992-1994 Biennium, we should all reflect with pride on the progress we have made in addressing the challenges with which we began. As we sought to emphasize the basic principals for which our Fraternity is recognized, we improved communication, promoted fraternalism, and exemplified our Motto: "Service to the student, the law school, the profession, and the community."

In our service to the student we enhanced our programming for our pre-law and law student members. Our Executive Office staff provided our law students with more information in a more efficient and timely manner, and our International Officers (District Justices, Regional Coordinators, Tribunes, and Executive Board Members) communicated more often and more regularly than ever before.

Our Law School Chapters initiated 7,051 new members and our Pre-Law Chapters initiated 4,911, for total initiations of 11,962 this Biennium. We Chartered seven (7) new Law-School and Alumni Chapters. Initiations took place at more law school chapters, and our pre-law initiations occurred at a record number of chartered pre-law chapters. Also a record, in this our 25th year as an International Organization, is that three of our newly chartered Chapters are in Mexico. Congratulations on your hard work.

In our service to our law schools, we have communicated more regularly with law school administrations, informing them through PAD Pride, the Dean's PAD and copies of The Reporter about P.A.D., our programs and our membership. In addition, our law school chapters have conducted more joint Chapter/Law School events and programs than have been conducted in previous years.

In our service to the profession, we have begun new programs and expanded others for our alumni, such as our Quest International travel program, our Members Long Distance Advantage telephone program, our expanded Mastercard program through MBNA, our Magazine Subscription Program, and our new catastrophic illness and gap Insurance Programs. We have also increased opportunities for networking among our alumni, as well as between our law students and alumni.

In service to the Community, our Public Service Center has been expanding our programming in Law Related Education across the United States and in Puerto Rico. New materials have been written, new teachers have been trained, and more elementary and secondary classrooms have been visited by our teams of lawyers, Judges and teachers than ever

before. Our recognition as a quality Law Related Education provider has increased exponentially in the education community this Biennium.

From a fiscal perspective, we began this Biennium with great concern. In response, operational expenses have been reduced and new revenue sources have been explored. Trust funds have been established for a building fund pursuant to Convention action, and a renewed effort to make our Endowment Loan Program more relevant and responsive, has resulted in new revenues for our Endowment Fund. In addition, we have operated our Fraternity with greater efficiency and fiscal responsibility, by focusing our operations on goal oriented, financially feasible procedures.

On a personal note, during this Biennium I had the privilege of representing our Fraternity in two ceremonies in which forty of our members were admitted to practice before the United States Supreme Court. The highlight of these ceremonies for me — and there were many highlights — was administering the oath of initiation into our Fraternity to U.S. Supreme Court Associate Justice Ruth Bader Ginsburg.

New possibilities for joint programming exist with other legal organizations such as the American Bar Association, the American Inns of Court, the President's Commission on the Employment of People with Disabilities, as well as Educational Organizations, all of which programming possibilities promise to enhance P.A.D.'s presence in the legal profession in the future.

While the State of our Fraternity has improved, it must improve even more in the next Biennium. We have made many difficult choices this Biennium which will become exciting opportunities over the next several years. Other hard choices will undoubtedly need to be made, as our Fraternity continues to progress; but these can be addressed as opportunities which will enable us to grow and prosper as an organization that makes a difference in our profession. Necessary continuing improvement will require us to work hard as well as the fraternal cooperation of each of us to meet the challenges ahead with confidence. Our business at this 50th Biennial Convention will enable us together to focus on our challenges with creativity and enthusiasm, and will provide us with opportunities to bring a stronger, more relevant, and even more viable Fraternity to our 51st Biennial Convention in 1996 than meets here at this Convention.

These challenges include:

## Addressing and resolving our continuing financial stress;

Last Biennium coincided with an economic slow-down and slow

recovery, resulting in reduction in initiations, and alumni participation with a consequent revenue reduction. This Biennium has likewise been so effected, both for

initiations and alumni dues; however, our initiations increased substantially this Biennium, but we need work on our alumni contributions. There remains a continuing reduction in the percentage of our alumni who pay dues. Our expenses have been outstripping our revenues for the past several years. And, although we have made remarkable progress in reducing our expenses and in seeking new revenue sources, our reserves remain essentially depleted. The International Executive Board you elect at this Convention must continue to take further measures in reducing expenses and services, unless and until, we find more new ways to improve our revenues. While we would all like to find some magic formula to improve revenues without cost to our members, historically, P.A.D., like every successful voluntary organization, is financed principally through the contributions of its members. Our members are, for the most part, more responsive than those of other organizations. However, we must work together to improve their motivation to be even more financially supportive of our work then they have been in the past.

## Providing opportunities for the majority of our alumni to be involved in our work;

Your International Executive Board has taken many steps to address the con-

cerns of our alumni. Some of our efforts are expressed in paragraph five above. Our efforts also include publishing surveys in The Reporter; and

communicating better with our alumni. I have appointed two committees this Biennium to provide recommendations on how better to address alumni needs and involvement. We have also instituted Continuing Legal Education on an expanded basis at Convention. We have contacted legal publishers and others to develop new benefits and programs for our members. We have exhibitors scheduled to attend this Convention. We will also have an alumni workshop as well as

an alumni committee to review reports and make recommendations to this Convention on getting our alumni motivated. However, some of our experiences this Biennium, as well as last Biennium, lead me to conclude that a significant majority of our alumni are not connected to the work of our Fraternity. Recharging their interest is vital to making Phi Alpha Delta more successful. This requires including more of our members in our programming, and in our information loop. Once they are included, our dues payments, insurance programs, Mastercard programs, and other items which generate more income for us, while providing benefits to our members, will I know, increase exponentially.

Defining in a more meaningful way the future role of our law student chapters and increasing our membership;

Phi Alpha Delta has continued to grow in terms of chapters and initiations. This Biennium we surpassed our new initiations over last Biennium significantly.

Achieving this level of initiations, however, is deceptive, since initiation

fees have not kept up with inflation. While we were experiencing an increase in law fraternity activities on law school campuses with which we compete, we also experienced a large increase in the number of other local and national student organizations that are competing for membership with our Chapters. This makes it more important than ever for P.A.D. to be relevant. To insure that we work on our strengths, and provide the best and most relevant legal organization for law student membership, we must continue to expand our communication with our local communities and to our peers of our relevance to legal practice and addressing timely issues. P.A.D. is justifiably proud of our role as an initiator and innovator, and of the network we have maintained among law schools. We must continue to improve upon these aspects of our organization and identify additional steps that must be taken to meet competition of an increasing variety of student organizations. If every chapter of our law Fraternity initiated 30 new members this year, or committed to having membership next spring of at least 15% of the total enrollment of their law school, our Fraternity, the best in existence, would play a greater role in legal education and participation. Your challenge, "if you accept it" is to communicate our excellence in the profession to your peers and to the community in which you live.

## Improving community service activities;

We can identify with pride all of the P.A.D. programs we administer and pro-

mote. We have produced tremendous results in many chapters, as well as with the number of chapters, students and alumni members who are involved with the Public Service Center in

LRE, Drug and Alcohol Prevention programs and are even expanding an array of new programs. If all chapters became involved in LRE now, they too

would enjoy the benefit of these programs. LRE is a great opportunity. Each Chapter should be involved. We also must develop new areas of community service. Community service, including locally developed community service activities and joint program opportunities with traditional service organizations can provide one of the more attractive aspects of membership in Phi Alpha Delta. This is particularly true if those community service activities provide law students and our alumni with the opportunity to be involved in law related issues in a "real world" context of community. I have tried it. It works. Everyone benefits. You will enjoy it and be better for it.

New service opportunities in Barrier Awareness and the legal rights of people with a disability;

Our Fraternity in 1990-1992, explored and developed a program in cooperation with the National Barrier Awareness Foundation, the California Department of Developmental Disabilities and the Santa Rosa Rotary Club to establish support for a National Barrier Awareness Day, and developed a program relating to the legal rights of people with a disability. At our 49th Biennial Convention, the plans and



initial results of the cooperative efforts between the National Barrier Foundation, Rotary, California State Government, and Phi Alpha Delta were reported to Convention through a video program. Each Chapter now has one of these video programs in its library. We also had a most timely seminar on issues relating to the Americans with a Disability Act as a significant part of our Continuing Legal Education Programming. During our community service workshop and at other times this Biennium, additional information has been made available on these programs. Adopt these programs as an element of the community service activities of your Chapter of our Fraternity. Expand this program and develop others. Offer your ideas on increasing our impact on reducing the barriers experienced by people with a disability. Bring your ideas and new programs to our 51st Biennial Convention.

## Additional structure and guidance for our Pre-Law Program;

Since the Pre-Law program was established 14 years ago, it has steadily grown. While it has yet to become a fully selfsustaining program, the Board has been dedicated to this principle for many years. Today, Pre-Law generates a much greater share of its expense than it has at any prior time. Because the number of inguiries we are receiving to charter new Chapters without promotion has produced as many new chapters as we can service, even with expanding staffing levels, our Board has not embarked on an aggressive expansion of the Pre-Law Program. Even though our Pre-Law staff has been increased, we continue to struggle to maintain our existing Pre-Law chapters. At the same time, the Board is aware that this is a program of promise, and in which expansion is possible. However, if we elect to expand the program, we must consider the front-end investment, the increasing need for regional, national, or international meetings, the cost thereof and the additional demand on staff time. Like every other area of endeavor in Phi Alpha Delta, it is far more desirable to develop our programs thoroughly and plan ahead, than it is to wait until problems overcome us and then seek to solve them. This upcoming Biennium should provide us with an opportunity to focus on how, and to what extent, Pre-Law will grow in the P.A.D. network.

During your participation in this 50th Biennial Convention, recommendations and ideas will be needed in the areas outlined above. In addition, other areas of activity in our Fraternity will be brought before our committees for consideration. Every two (2) years, the International Justice and International Executive Board have an opportunity to report to you on the progress of our Fraternity and receive your suggestions and input to guide the future development and growth of our

organization. From you, our members as the delegates to this Convention, we receive many of our best ideas. In forming your ideas, keep in mind that over a two (2)

year period circumstances can change and financial and other considerations can make what looked practical at Convention, impractical at another later time.

In proposing your resolutions make them in the form of recommendations to give the Board you elect at this Convention the latitude to adjust its implementation of your ideas as needs arise; but nevertheless, give your Board a sense the direction you, the members of this organization, want your Fraternity to go in the next two years, and beyond.
