Executive Board Chooses Doral for 1996 Convention Site



The Spa at Doral, where gracefully curving staircases and Italian marble floors reflect the charm and grace of the classic era.

The Doral Golf Resort and Spa in Miami, Florida has been selected by the International Executive Board as the site for Phi Alpha Delta's 51st Biennial Convention. The Convention will be held during August 6-11, 1996.

The Doral is located on 650 acres of beautifully landscaped grounds. It fea-

tures 81 holes of golf, 667 guest rooms and suites, 60,000 square feet of meeting space, two heated outdoor and one heated indoor swimming pools, a fitness center, and a world-class spa.

"The Doral is the finest combination of meeting space and recreational facilities I've seen in my eleven years with PAD," commented Director of Operations, Steve Moriarty.

The Doral is the home of the PGA's Doral-Ryder Open. Its "Blue Monster" Course was rated as one of Florida's tenbest by the January, 1996 issue of Golf

SMART START Helps Attorneys and Law Students

According to recently published law review articles and Bar Association surveys, one of every five young attorneys in the United States exhibits symptoms of substance abuse. American Bar Association statistics show that approximately 60 percent of attorney discipline cases involve some sort of chemical dependency or abuse, including alcohol abuse.

While it would be foolish to believe that all attorneys who face discipline or malpractice begin to be absorbed into chemical dependency only after law school, the law school environment can create an atmosphere which fosters substance abuse. All too often, law students fall into an environment and make individual choices about their own drinking/drug use that enables dependency and

The Public Service Center (PSC) will be closing its Washington, D.C. office and moving to the International Executive Office in Granada Hills, California.



Why Attend Convention?



while on my way to my first Convention in 1972, I speculated on what I would encounter.

Would I find elderly lawyers reminiscing? Or law students out for a good time? Who would be there? I reasoned there couldn't be more than 75 or 80 — most students worked, and why

would lawyers or judges come? Was this *Town and Country* the California equivalent of a Jersey motel?

I knew only three people who would be there: Mike Harwin, then the Executive Secretary and now a California Judge; Frank McCown, my District Justice who later became International Justice; and Alex Hotchkiss, the Supreme Justice who installed my chapter.

Upon arrival, I found a magnificent Hotel and Convention Center. I was treated like a long-lost brother by PADs I had just met, and was put at ease by the warmth and friendliness of everyone present — almost 400 PADs!

After Tuesday's reception, and Wednesday's opening ceremony (where a Supreme Court Justice addressed us), I felt as if we all were with good friends and understood that we are an important force in the legal community.

The next day really convinced me that I had made the right choice in attending. We *really did* determine PAD's course during the next biennium! Committee reports on major topics such as the Phi Delta Delta merger, and minor things like directing the Executive Office to supply materials to chapters, were considered and voted on by the Convention.

During the balance of Convention we debated reports, determined how PAD would be run, and who would run it. All of this was done within the context of fraternal caring. Saturday brought tearful good-byes, and promises to "keep in touch".

When I boarded my plane, I realized that I, a second-year law student, made a significant impact on a then-70 year old organization. I had also made more good friends and invaluable contacts than I could hope to make in a normal year!

Today, when I look at the 1972 Convention photo, I can count at least 40 attorneys, judges, congressmen and professors with whom I can speak to ask a question, refer a case, or simply say hello.

That week in 1972 was the most valuable of my professional life, and the dividends continue to accrue today. I hope you will attend The 51st Convention at The Doral. I guarantee it will be an experience you won't forget. It may be the most important week of *you*r professional life.

The strength of Phi Alpha Delta Alumni continues to grow, as Alumni Chapters in Kansas City and in San Diego were reactivated during the same February weekend.

The Kansas City Alumni Chapter held its reactivation events on Friday, February 23, 1996. Presiding over the reactivation was Reactivating Justice Filbert Munoz (Benton). Membership of the newly reactivated Kansas City Alumni Chapter has already reached 64 members, and is still growing.

The Kansas City Alumni used Benton Chapter's Brown Bottle Reception as a jumping off point for reactivation. Sister Teresa Rieger served as the Alumni Liaison between Benton and the Kansas City Alumni and generated interest among the PADs present in reactivating the chapter.

The San Diego Alumni Chapter held their reactivation ceremony on Saturday, February 24, 1996 in the Ceremonial courtroom at California-Western School of Law in San Diego. abuse. With this in mind, PAD has recognized that measures need to be taken to address alcohol and drug abuses that afflict law students.

Phi Alpha Delta Law Fraternity International's Public Service Center, along with George Mason University's Center for the Advancement of Public Health, several law schools, and the Department of Education's Fund for the Improvement of Post-Secondary Education, have been participating in an effort that gathers data and actively seeks solutions to the prob-

lems of chemical dependency and abuse among law students. Smart Start, the official name for our collective efforts, travels around the nation presenting workshops on alcohol and drug abuse. For the program to work, law schools commit themselves to addressing the problem and the Smart Start program provides the impetus and resources to expand current efforts.

The program's focus is maintained on law students' individual responsibilities and law school administrations' obligations to their students. Preventing abuse, not limiting moderate consumption, is the program's immediate goal. From Smart Start's perspective, abuse results from a failure of both the law school environment and individual choice. In addressing these problem areas and the deleterious impact associated with chemical dependency and abuse while students are in law school, PAD's motto of Service to the Law School and the Profession is implemented by helping law schools produce better lawyers.

Officer Transitions



... You don't have to reinvent the wheel...

With Spring comes officer elections for most law school and pre-law chapters. The transition to new officers can be a vulnerable point for any chapter, but there are a number of things you can do for a smooth and successful transition:

Schedule and conduct a **Transition Meeting** for all old and new officers.

Complete and file a **Roster of Officers (Form C)** with the Executive Office. Include *summer and permanent addresses, telephone numbers, and e-mail addresses* for each officer.

Transfer all **Accounts** to the new Treasurer and Justice or President.

Transfer office and locker keys.

Notify school administration, Faculty and Alumni Advisors of elections.

Transfer Manuals to the new officers.

Transfer **Ritual Paraphernalia** such as banners, gavels, books of the roll, etc.

Law school chapters should elect Convention **Delegates** and ensure they receive all mailings, bulletins, registration and credentials information

Transfer information on **recurring events** (golf tournaments, court use, parties, judge's nights) so new officers won't have to "reinvent the wheel."

File a **Budget** with the appropriate school entity. Many schools require filing before the end of the year.

Determine **Fall Orientation** date(s) to plan rush during the summer.

Determine whether your school will let you include PAD information in the **mailing to incoming students.** If so, make certain to find out the deadline for turning in materials for the mailing. At a minimum, include a welcome letter and application.

Contact the Executive Office to determine whether your chapter has any Pending Problems that should be cleared up before officer installation.

Despite upcoming final examinations at Duquesne University Law School, the John P. Egan Chapter of Phi Alpha Delta Law Fraternity, International was reactivated on Saturday, April 29, 1995 during ceremonies held in the John P. McArdle Moot Courtroom at the Duquesne campus.

Presiding over the reactivation ceremony were International Board Member Ronald Winter, District XIX Justice Bill Trezevant, and Judge John Brosky. Judge Brosky is an alumnus of Watson Chapter at neighboring Pitt Law School. Buffalo Alumni Justice-elect Noelle Kowalczyk was also present for the ceremony. Eleven new members were initiated into PAD that evening. Installed as new officers were: Justice Michael Sensor, Vice-Justice Dawn Gull, Clerk Jennifer Keith, Treasurer James Creenan, and Marshal Colleen Gallo.

Judge Brosky currently serves as Senior Judge of the Pennsylvania Superior Court and has been active in PAD affairs for nearly 50 years. Prior to his service on the Pennsylvania Superior Court, Judge Brosky served as a General in the United States Air Force. In addition to his duties on the bench, Brother Brosky was responsible for saving the 911th Airlift Wing and the Army Kelly Support Center from being closed by the Secretary of Defense.

Prior to the ceremony, a moment of silence was observed to remember the victims of the Alfred Murrah Federal Building bombing in Oklahoma City. In keeping with PAD's motto of "Service to the Community", one of Egan Chapter's early projects was to raise donations for the Oklahoma Bar Association's Disaster Relief Program.

Egan Chapter was named for John P. Egan, a Duquesne University Law Professor who later became Dean of the Law School. The Chapter's namesake also served as a Judge for the Allegheny County Court of Common pleas. Egan Chapter was originally chartered in 1963.

Following the ceremony, everyone in attendance retired to the student lounge for a catered reception and to strengthen their newly formed fraternal bonds.
