Year after year, one of the most touching and fraternal moments I continue to experience is viewing (and in later years--as an International Officer--participating in) the Opening Ceremonies of our Fraternity's biennial convention. To this day, I can close my eyes and recall vividly our convention video, narrated so eloquently by Past International Justice Don Hutson. Those of you who have benefited from attending one or more such conventions will undoubtedly recall with fond memories Don's unique, profound and almost God-like voice as he leads us down the path of

Phi Alpha Delta history. Rumor has it that Peter Graves (formerly of Mission Impossible fame) took lessons from Don in connection with his narration and hosting of Biography, currently airing on the A & E television network. In any event, our history video concludes with Don proudly proclaiming:

"...Fear not, the Flame burns bright, P.A.D., as always, is on the march!"

Never has this proclamation been more evident and accurate. P.A.D. continues on the march and the pace is swift. In fact, we are no longer pacing; we are sprinting! When I took the oath of office as your International Justice, I received many words of encouragement, advice and counsel from several of my predecessors. In addition to the various individual "words of wisdom" supplied by many of our Fraternity's Past Supreme and International Justices, a common theme was echoed by many: the two-year term of office elapses so quickly; it is essential to seize every opportunity. In short, they were absolutely right. It is difficult to believe, as you read this issue of *The Reporter*, roughly one-third of the biennium (and my term) has passed.

Fortunately, with the assistance and dedicated efforts of our Members, Officers and Staff, we have seized every opportunity along the way and are indeed in the fast lane. With the numerous successes of the Fall Semester now quickly becoming a faded memory, our attention is focused on the Spring Semester, where our Chapters are primed for a flurry of new and existing programs designed to provide continued and expanded service to the student, the law school, the profession and the community, all the while keeping in mind (and putting to action) the constant need for the initiation of new members. The accomplishment of our objectives of increased contact, communication and networking with and by our alumni are now evident and we hope that alumni support in the form of expanded involvement with our students, interaction among alumni and financial assistance (e.g., alumni dues receipts) will likewise be increased.

Everything is moving faster and swifter. In addition to the obvious technological advancements, our Committees have been diligently at work, producing outstanding results in such areas as translation of materials, alumni and pre-law issues, long-term development, constitution and by-laws revision and the celebration of our Centennial, to name a few. Perhaps most exciting, however, is the progress we have made with "Project P.A.D. Headquarters. "Phase I, the establishment of our Building Fund is in high gear, producing fine

PHASE II OF LONG-TERM PLAN BEGINS BOARD APPROVES SITE SEARCH

The International Executive Board, while meeting in Los Angeles in January, gave its unanimous approval to a plan to locate an appropriate site for a permanent home for Fraternity Headquarters. This decisive Board action was undertaken to move the Fraternity one step closer to its goal of eventually owning its own building.

Phase Two of the long-term plan is designed to isolate areas of the country that would be most suitable to accommodate Phi Alpha Delta's base of operation. Toward that end, the Board has granted authority to the Building Committee to obtain the services of a real estate brokerage firm for the purpose of determining specific areas of the country that match their "wish list." This list of priorities includes, in no particular order, accessibility by air, density of population, quality of life and health, real estate cost, cost and availability of labor force, and concentration of P.A.D. Chapters and activities.

With the implementation of this phase of the process, P.A.D.'s dream of owning its own permanent home moves one step closer to reality. The creation of the Building Fund, a separate Fraternity account funded partly through Initiation fees and charitable donations, represents Phase I of the long-range plan. Future plans call for purchasing land for construction of an office complex, or an appropriate structure for conversion into offices.

TEEN PARENT PROJECT KICK OFF!

P.A.D. PSC is coordinating a Teen Parent Law-Related Education Program this year. The program will be piloted in the Los Angeles area at New Directions for Youth. It is a collaborative effort among P.A.D. PSC and numerous local organizations such as Public Counsel Children's Rights Project, Bet Tzedek Legal Services, the Legal Aid Foundation, the District Attorney's office and the Los Angeles Superior Court Dependency Department. Pre and post program testing and evaluation is being conducted by Dr. Marcia Wilson, Counseling Services Coordinator for the Neighborhood Academic Initiative, University of Southern California and Professor Shirley Krathamer, Department of Psychology, Los Angeles Community College.

The program will consist of classes that will be held twice per week for eleven weeks. Volunteer attorneys will be teaching the classes, which will focus on practical legal issues relevant to pregnant and parenting minors. In addition to covering the legal principles, each class will include a segment on how to fill out legal forms. The development of job interviewing skills will also be part of the program. Individual legal advice will not be given, but P.A.D. PSC will be developing a "help list" of agencies that can provide individual advice to the teens regarding specific problems. A series of lesson plans that can be adapted for use in every state will be developed for this project. The program officially began on January 29, 1997, when the first teen parent class was taught. We are receiving excellent feedback from teachers and students alike on our work in this innovative project.

P.A.D. has become well-known for its annual International Food Drive, and once again the P.A.D. PSC is proudly sponsoring our International Food Drive Competition throughout this academic year. Entry forms were sent to Chapter Justices last fall. If you did not receive one or lost it, you can download one from our Web Site at http://www.pad.org. We encourage Chapters to conduct a local Food Drive, and report the results to us. It's a wonderful way to help the needy in your community. The PSC sponsors Awards and national recognition for Chapters who collect the most food in various categories based on size of school. Awards will be announced at the International Awards Banquet in June.

P.A.D. students at *Middleton Chapter* (Western New England College of Law) held a Food Drive in October and collected 200 non-perishable goods and \$140. They not only donated much-needed food to a local soup kitchen, but also helped out personally by preparing and serving a meal there. We are very proud of their efforts and the generous donation of their time.

VOLUNTEER OPPORTUNITY

The National Center for Missing and Exploited Children (NCMEC) is looking for lawyers interested in international family law. Since 1995, NCMEC has worked with the U.S. Department of State on cases coming into the United States arising under the Hague Convention on the Civil Aspects of International Child Abduction. This treaty addresses the serious and growing problem of parents involved in international relationships wrongfully taking the child(ren) of that relationship to another country (usually returning to the parent's home country in an attempt to gain custody in a favorable court).

Through the Hague Convention, the left-behind parent is assisted in locating the child and finding representation in the United States where a hearing will be held. Most, but not all, of these parents require pro-bono assistance. Although experience in family law is helpful, NCMEC offers technical legal support as well as extensive background information on the treaty and how to handle a case. Children are taken from other countries and brought to towns all across the United States, and NCMEC is looking for lawyers in every state.

International family law is a fascinating twist on the traditional family law practice; in fact, attorneys in *Martindale-Hubbel* list "Hague Convention" as a specialty. If you are interested in being placed on a list for possible referral of cases in the future or simply want to learn more about implementation of this treaty, call Nancy Hammer in the International Division of NCMEC at (703) 235-3900 or Christen Bruu at the American Bar Association at (202) 662-1747.

NCMEC is a private, nonprofit organization operating under a Congressional mandate and working in cooperation with the U.S. Department of Justice's Office of Juvenile Justice and Delinquency Prevention. As the nation's resource center for child protection, NCMEC spearheads national efforts to locate and recover missing children and raises public awareness about ways to prevent child abduction, molestation, and sexual exploitation.

The P.A.D. Public Service Center asks that you consider getting involved in the above project. You would be providing a tremendous service to parents badly in need of your assistance to locate their children and return them home safely.

P.A.D. HISTORY WITH A 21ST CENTURY TWIST **New Fraternity Pin Debuts**

This is Part III in a series of Reporter articles devoted to commemorating the 2002 Centennial Celebration of Phi Alpha Delta.



¶he new Fraternity Pin debuted on January 16 at the Los Angeles Alumni Chapter Winter Dinner at which the L.A. Alumni Chapter graciously hosted the International Executive Board of Phi Alpha Delta. In a special presentation, International Justice Clifford Schechter pinned the first new Fraternity Pin on the lapel of Past Supreme Justice and current Justice of the L.A. Alumni

Chapter Matthew S. "Sandy" Rae who has worn every version of the P.A.D. Pin for the past half century.

The new P.A.D. Pin, approved by the International Executive Board at the Summer 1996 Board meeting, was designed by P.A.D.'s foremost expert in Fraternity History, Past Supreme Justice C. Raymond Judice. Shaped like the Shield of the Fraternity, the Pin, (pictured above), prominently features the Phi Alpha Delta Crest in what is known among members as a "P.A.D. Purple" background. Both the Crest and Shield are trimmed in gold.

In the December 1911 Phi Alpha Delta Quarterly (forerunner publication of *The Reporter*), there appeared a poem about the P.A.D. Pin by Brother Alexander Hamilton V, an Alumnus of Calhoun Chapter at Yale. While not "politically correct" in today's parlance with the co-ed nature of Phi Alpha Delta, the sentiments remain much the same and worth sharing.

Our Frat Pin

By Alexander Hamilton V Dedicated to Phi Alpha Delta

When away from school and comrades, Striving our daily bread to win, Thinking over old remembrances, Conjured up by my old "frat" pin.

How I call to mind the old scenes, Twas in college and the day, When friendships most sincere Caused happy hours to flit fast away

This teleconference will discuss how Law-Related Education can be successfully institutionalized in schools as one element of a comprehensive approach to solving the growing problems of violence, crime, and drug abuse among our nation's youth. Law-

Related Education is a program designed to educate K-12 students about the law, the legal system, and the fundamental principles and values upon which these are founded. Young people are taught about their rights and responsibilities under the law so that they can live their lives within the law and become productive citizens in our constitutional democracy. Lawyers, law students, law enforcement professionals and other members of the community are an integral part of the programming, serving as resource persons in the classroom and teaching interactive LRE lessons in partnership with teachers. For more than 20 years, Phi Alpha Delta has been involved in developing successful LRE partnerships in all 50 States and Puerto Rico.

The video teleconference will discuss recent findings and research on the effectiveness of Law-Related Education. In addition, the teleconference will discuss the importance of developing a solid infrastructure within communities and school systems for reaching at-risk students through Law-Related Education.

Anyone interested in LRE and the positive impact it can make in schools and communities is invited to participate in the teleconference. All state LRE coordinators, law enforcement officials, attorneys, judges, corporate executives, law students, legislators, state and local school board members, teachers, and parents are strongly encouraged to attend the teleconference center in their area.

Judge Jamoa Moberly Teaches From the Bench

Judge Jamoa Moberly of the Orange County Harbor Municipal Court, near San Diego, maintains a strong interest in educating the public about the legal system, respect for authority, and acceptance of responsibility. In fact, she takes the time to explain her decisions and perceives her role as one of a Teacher.

Appointed to the Court in 1996 by Governor Pete Wilson of California, Sister Moberly distinguished herself very early in her legal career. During her days at Hastings College of Law in the early 1970's, she joined the *Temple* Chapter of P.A.D. and became the first woman to be elected a Chapter Justice.

Following her graduation from law school, Sister Moberly took a position with the P.A.D. International Executive Office to become the first woman International Field Representative (IFR). She traveled to law schools throughout the United States and Mexico chartering and reactivating Chapters of our Fraternity.

Several years after her tenure as IFR and while with the firm Schell & Delamer of Los Angeles, Sister Moberly handled a case for which she is still recognized: Frances T. v Village Green Homeowners Association, 42 Cal.3d 490 (1986). This case changed the law in the area of individual director liability for gross negligence or maliciousness. Numerous law review articles have been written about this particular case.

Though enjoying her days as a judge, Sister Moberly recently told the *Los Angeles Daily Journal*, "she still misses the thrill of winning a case." During her career as a trial attorney, Sister Moberly never lost a case she tried.

Judge Moberly and her husband, Michael Caruso have two children, ages 9 and 7.
