### Deems Elected IJ



elegates to the 52<sup>nd</sup>Biennial Convention of Phi Alpha Delta Law Fraternity, International by unanimous ballot elected Joseph E. Deems International Justice.

International Justice Deems was born and

raised in Los Angeles. He graduated Loyola University (Los Angeles) in 1970 with a B.A. in English. He obtained his J.D. from Southwestern University School of Law in 1974. While at Southwestern he was initiated into the Sammis Chapter in 1971 and was elected Justice of the Chapter. From that time until the present, he has been actively engaged in Phi Alpha Delta activities.

Brother Deems served as District Justice for District III from 1974 until 1978, when he was elected to the position of Chief Tribune. He served in that position until 1982 when he was elected to the Board as International Marshal, and thereafter has served as International Historian, Treasurer, Secretary, Advocate, Board Member-at-Large and Vice-Justice, until this past summer when he was elected International Justice.

Senior partner in his own firm located in Los Angeles, California, Brother Deems is a trial attorney whose practice specializes in jury and court trials, representing business and entertainment to tort defense.

Joe and his wife Sharon have two children, Evan and Marissa, and reside in Tarzana, California.

# New Headquarters Purchased



January 15, 1999 will forever be noted in the annals of Phi Alpha Delta history. On that historic date the Phi Alpha Delta Law Fraternity, International acquired its first

office building. The vintage structure that P.A.D will soon call home is located at 345 North Charles Street in Baltimore Maryland. The International Executive Board in conjunction with the Building Committee and the Endowment Fund Trustee Committee spent countless hours seeing this project through to completion so that Phi Alpha Delta could have a permanent home to be proud of for years to come.

The purchase of our new building was largely through the efforts of the Chairman of the Building Committee, Past International Justice Cliff Schechter, current International Justice Joseph E. Deems and International Treasurer Curtis M. Anderson. Their efforts were rounded out by the members of the Endowment Fund Trustee Committee; Chairman Fredric Pearson, past International Justice and past International Justices Larry Crigler and Jack Miller.

It should be noted that the purchase of the building, jointly owned by the general Fraternity and the Endowment

# DISTINGUISHED SERVICE CHAPTER INDUCTS NEW MEMBER

FRATERNITY BESTOWS HIGHEST HONOR UPON RICHARD P. McCULLY



During the International Awards
Banquet on August 8, a new
member was added to the Rolls of
the Distinguished Service Chapter.
Members of the Distinguished
Service Chapter are chosen by
unanimous vote of the
International Executive Board. The
traditional Ritual to install a new
member into the Phi Alpha Delta

Distinguished Service Chapter began to unfold as current Members of the DSC began to search the ballroom to find the newest Member of the Fraternity's most prestigious group. The search ended and the DSC members converged on the surprised Brother Richard P. McCully.

Brother Richard P. McCully attended Memphis State University, School of Law and was initiated into the McKellar Chapter in the early 1960's. While in law school and a member of McKellar Chapter, he served as its Justice.

After graduation, Rick came to work for the Fraternity as its National Field Representative and served as such from 1967 to 1970. During that time, Brother McCully visited hundreds of law school chapters and assisted in their maintenance. He then went to work for the Attorney General of Tennessee. From 1971 to 1973, he served as District Justice of his area. He then relocated and served as disciplinary counsel in Florida and ultimately practiced law in Ft. Lauderdale. All the while, Rick worked with and visited law school chapters and kept the bond between law students and alumni alive.

Brother McCully helped to establish and then lead the Ft. Lauderdale Alumni Chapter. He helped to establish a colony at St. Thomas School of Law and later installed the Mentschikoff law school chapter there. In many instances, Rick performed services for P.A.D. as a District Justice, without the title. He was offered District Justiceships on many occasions but declined them to allow others to serve. He assisted in the reactivation of his chapter even though it entailed travel to Tennessee where he no longer lived. Most recently, he was the catalyst in reactivating the Russell chapter at the University of Georgia during the past Biennium.

Brother McCully's service to our Fraternity has included attendance at numerous conventions, serving as Chairman of the Convention Host Committee on two occasions, participation on two Executive Director Search Committees, Chair of two Nominating Committees, and acting as a personal resource to countless P.A.D. members for job searches, professional courtesies and co-counsel requests.

# BARBARA JORDAN AWARD PRESENTED TO JUSTICE MARY ANN McMORROW

The Honorable Mary Ann G. McMorrow (Webster) was awarded the Barbara Jordan Award for Lifetime Achievement in Public Service during the opening session of the 52<sup>nd</sup> Biennial Convention. In February 1996, shortly after Jordan's death, the International Executive Board established the Barbara Jordan Award to recognize those P.A.D. Brothers and Sisters

who have had outstanding achievements in the field of public service.

Justice McMorrow is the first woman in Illinois' 173 year history to be elected to the State Supreme Court. Prior to her history-making election to the Supreme Court of Illinois, she served as a trial court judge in the Circuit Court of Cook County for ten years, and on the Appellate Court of Illinois for seven years.

Justice McMorrow has other distinctions: she was the only woman to graduate in her law school class in 1953, she was the first woman to prosecute major felony cases in Cook County, she was the second woman in Illinois history to serve on the State Appellate Court, and she was the first woman to be elected Chairperson of the Executive Committee of the Appellate Court of Illinois.

Justice McMorrow is the recipient of numerous awards, including the "Medal of Excellence" of Loyola University School of Law Alumni Association (1991). She is also the recipient of the Midwest Women's Center "Tribute to Chicago Women" award (1993); recipient of the Catholic Lawyers Guild "Lawyer of the Year" award (1993); recipient of the Advocates Society Award of Merit (1994); recipient of the Illinois State Bar Association, Illinois Bar Foundation 1996 Fellows Award for Distinguished Service to Law and Society; recipient of the Loyola University Chicago School of Business Administration President's Distinguished Leadership Award (1998); and recipient of the Women's Bar Association Myra Bradwell Woman of Achievement Award (1998). She was selected one of "Chicago's 100 Most Influential Women" by Crain's Chicago Business (1996).

Justice McMorrow is a Past President of the Women's Bar Association of Illinois. She is a member of the Illinois State Bar Association, the Chicago Bar Association, she is a Master Bencher of the American Inns of Court, a member of the American Judicature Society, the National Association of Women Judges, a member of the Leadership Illinois Advisory Board, and a former member of the Board of Directors of the Illinois Judges Association. She was a faculty advisor at the National Judicial College in Reno, Nevada, and has often served as a faculty member at Illinois Judicial Conferences.

# 52<sup>nd</sup> INTERNATIONAL CONVENTION HEATS UP SCOTTSDALE, AZ!

Phi Alpha Delta Law Fraternity, International held it's 52nd International Convention August 4-9 at the Radisson Resort in Scottsdale, Arizona. In attendance, representing 91 law schools and 16 alumni chapters, were over 250 law students, alumni, and guests.

This years theme, "Celebrating the Past - Building for the Future," directed Convention activities throughout. The Stanley H. Kohn International Justice Reception on Tuesday night, allowed old acquaintances to be renewed and new friends to be made. The following morning International Justice Clifford Schechter opened the convention and reinforced the theme by a showing of The History of P.A.D., a visual review of Phi Alpha Delta's history since its humble beginning in 1897.

Wednesday and Thursday consisted of chapter workshops addressing questions about the Fraternity, leadership, programming, rushing, fund-raising, alumni networking and Law-Related Education. Thursday afternoon was spent in committees, reviewing information, debating recommendations, and preparing reports to the International Chapter for the Friday and Saturday business sessions.

Each evening also provided ample opportunities for socializing, politicking and networking, with all Convention attendees invited to the Purple and Gold Roundup and Fiesta Dinner for food and fun in the cool desert air.

Friday began with the District breakfast, highlighted by one delegate's confusion with defining a toga as business dress. The afternoon proceeded with nominations and speeches by the candidates for the 1998-2000 International Executive Board.

Saturday proved to be one of the busiest days of the

week. Morning business sessions consisted of the final convention committee reports, the election of new International Officers. Also the announcement that the final steps were being taken to purchase a building in Baltimore to be used as the

International Headquarters. The evening was then filled with the International Awards Banquet, where the best and the brightest of the nominated candidates were recognized and presented with their respective awards (see box). All involved agreed that with so much Fraternalism surrounding the event, the evening was a tremendous inspiration for old and young P.A.D.s in attendance.

#### **PSC** Expands Teen Parent Law Program

The P.A.D. Public Service Center is expanding its program to teach practical law to lacksquare teen parents and pregnant teens. In 1997 pursuant to its grant from the Federal Office of Juvenile Justice and Delinquency Prevention (OJJDP) the PSC developed a curriculum to teach subjects that affect this population's everyday lives. Such classes as the law of child neglect and abuse, health care, landlord-tenant, consumer law, fraud, statutory rape, juvenile courts and numerous others were taught by local lawyer specialists.

When an independent evaluation by the University of Southern California found the program to be extremely successful, the decision to expand the program from Los Angeles County schools to the City of Los Angeles Unified School District and to Ventura County was made. A grant from the Streisand Foundation made possible the production of a compelling nine minute video on the project. Copies of the video are available at cost to chapters.

#### Elementary Student/ Law Student LRE Initiative

The PSC is set to begin its Elementary/Law Student Law-Related Education ▲ Initiative in three pilot sites across the country. A law curriculum was developed after consultation with law professors and elementary school specialists.

It was a great challenge to develop a curriculum that explains in an interactive way concepts from breach of duty and damages to burglary and robbery for elementary school children in terms they can understand. It has not been done before and we are at the forefront of a new program. We will be teaching five subjects as follows: criminal law, torts, contracts/consumer law, trials, and rules and laws. There will be three classes per subject for a total program of fifteen classes. The unique aspect of this program is that PAD law students will use our lesson plans to teach these classes.

We have recruited the students and coordinated with the respective school districts. This program exemplifies the goals of PAD. We are using members of our local chapters in professional programs. PAD students and chapters provide a valuable service from which their local communities benefit. The chapters and cities involved are: Clark Chapter at Washington Univ. and Sullivan Chapter at St. Louis Univ. in St. Louis, Rasco Chapter at Univ. of Miami and Mentschikoff Chapter at St. Thomas Univ.in Miami, and Sammis Chapter at Southwestern, Ford Chapter at Loyola, Ross Chapter at U.S.C. and A.L. Stephens Chapter at Whittier College in Los Angeles.

#### Brother Willie Gary Continues to Triumph

**B**rother Willie Gary of Watkins Chapter has continued both his winning ways in court and his charitable activities out of court. He recently won a \$12.2 million dollar settlement for a St. Louis, MO family whose son died from burns received in an elevator fire when he was trapped due to a malfunctioning elevator door. The man was working in the elevator refinishing metal when the cleaning liquid ignited.

Brother Gary has pledged \$100,000 each to four colleges and given over \$100,000 to "challenger" scholarships to encourage kids to stay in school and go to college.

He currently represents 160,000 nurses in the National Black Nurses Association in a \$2.5 billion dollar lawsuit against Smith Kline Beecham for misrepresenting that the association endorsed various Massengill products.

Part IV:

The Years Of Adversity, Depression and War

Phi Alpha Delta was now to enter a period of troubled years. The economic conditions during the great depression - followed almost immediately by the outbreak of World War II - severely tested the mettle of the fraternity.

Later, after these troubles had passed, members were to look back upon this period and appreciate the basic strengths of the fraternity which served to pull the organization through this

period of greatest adversity.

Economic conditions in the United States during the depression were so severe that only four new active chapters and six alumni chapters were chartered during the period of 1933 to 1946. Then, the war years devastated the established active chapters, with the vast majority of the chapters becoming inactive because of the sparse enrollments in the nation's law schools.

Because of the biting effects of the depression, the 1932 convention scheduled for Los Angeles was summarily cancelled. In early 1933 a mail ballot vote

was taken of chapters to determine if they desired to schedule a convention for 1933. The returns almost unanimously favored further postponement.

Common occurrences were bank failings and dragging with them all of the financial resources of local chapters, as well as the personal resources of the chapter members. These failures included the Bank of Hollywood in which the general funds of the fraternity were deposited. However, there was little loss to the fraternity, "due to the small amounts of money on deposit."

At the 1933 board meeting, the Supreme Executive Board voted that the officers should personally visit each chapter. This was followed by proposals to "work out a plan of reducing the income of the national fraternity and at the same time maintaining good service to the chapters and their members."

Accordingly, the annual dues were reduced from \$7 to \$5, and adjustments were made extending near-delinquent chapter debts. In a 1933 issue of The Reporter, the Supreme Secretary issued a call for everyone in the fraternity to observe the 35th birthday of the fraternity by mailing a financial gift to the secretary's office of not less than three cents for every year of the fraternity's existence.

Two fraternity highlights of 1934 were the National Phi Alpha Delta Night and, one month later, the George E. Fink Night.

Both events were designed to bring brothers together during this period and promote fellowship. Accordingly, National Phi Alpha Delta Night called for every chapter, active and alumni, to hold a meeting of some sort on January 20, 1934. Then, from radio stations throughout the country, messages to Phi Alpha Deltas everywhere would be broadcast. The plan met with success.

In Los Angeles, both actives and alumni met at the Los Angeles University Club and listened to speeches, followed by the university band from the University of Southern California accompanying Lorraine Bridges singing the "Phi Alpha Delta Sweetheart" song. Then, the program was closed by the assembled brothers singing "True To Thee,

Phi Alpha Delta." The entire event was broadcast over radio station KMTP

Further north in San Francisco, area members met, and jointly listened to Phi Alpha Delta radio programs emanating from Seattle. In Salt Lake City, Judge William H. Folland of the Utah Supreme Court spoke over radio station KSL. And chapter members at the University of Idaho, University of North Dakota, University of Oklahoma, and University of Nebraska tuned in.

In the South, Morgan Chapter in Birmingham, Alabama, and Martin Chapter in New Orleans reported listening parties "in full

swing." In Tallahassee, Florida, Governor David Scholtz and State Treasurer J. Edwin Larson spoke about Phi Alpha Delta and all area chapters (Brewer, Fletcher, Keener, Fish and the Atlanta Alumni Chapter) tuned in.

In Chicago, U.S. District Attorney (and brother) Dwight H. Green told area radio audiences "there never was a time when our courts and other institutions had so much need for support from all sides." The speech carried such an impact that every Chicago newspaper commented editorially upon it the following day.

A month later, members throughout the country joined in publicly honoring a stalwart of the fraternity, Brother George E. Fink. The evening of February 20, 1934, was designated "George E. Fink Night" and brothers around the country toasted Brother Fink's good deeds. The March, 1934, issue of The Reporter was dedicated to Brother Fink, praising him as the man who "so loyally served our fraternity."

Additionally The Reporter stated: "On Tuesday night, February 20, over 100 members of the Chicago Alumni Chapter gathered at the Hamilton Club for the regular monthly meeting. Previous to this meeting, Brother Fink had been invited to talk on the early history of the fraternity to make absolutely certain his attendance.

Following the disposition of the business of the meeting, the brother justice announced that the meeting was being held in honor of Brother George Fink. Brother Fink was deeply moved and acknowledged his tribute in words of gratitude to Phi Alpha Delta. He spoke of the early days of the fraternity and of many of the conventions he had attended."

It was in a weakened financial condition that the twentythird biennial convention was called to order.

Thirty-two active chapters and 10 alumni chapters were represented. Of course, the financial plight of the fraternity was the prime topic of discussion. And, records indicate, talk about revoking delinquent chapters' charters was popular.

In the end, though, the delegates decided "no immediate steps" should be taken toward revoking any charters, as the end of the depression apparently was in sight, and because it seemed best that the word 'revocation' be forgotten in favor of the word 'rehabilitation.'

Perhaps the first formal step toward firming up a sound fraternity policy on non-fraternity politics was conceived at this convention. A committee recommended that the fraternity in its group activities remain absolutely free from partisan politics, and that no national policy be adopted to either encourage or discourage active and alumni chapter from supporting a brother engaged in a political contest.

For extracurricular activities, delegates attended the Century of Progress World's Fair then in progress in Chicago. Brother Harry E. Rice, commodore of the fair's fleet, surrendered his fleet to the delegates for a boat trip

around the fair area. The day the delegates attended the fair was designated "Phi Alpha Delta Day" and featured a nationwide N.B.C. radio broadcast of the address of the Supreme Justice preceded by the singing of the "Phi Alpha Delta Sweetheart" song.

Soon after the convention, word was received of the death of Brother Roland M. Hollock, the first Supreme Justice of Phi Alpha Delta, who had been living in retirement from the United

States Army in Washington, D.C.

A year after the first "Phi Alpha Delta Night" - which had been successful - the second "Phi Alpha Delta Night" was called. The Reporter called the event the "second effort to have the 16,000 members of our fraternity sit down together to review the splendid record of Phi Alpha Delta, to live once again the glorious days of fraternal life, and to draw new inspiration from this meeting, to carry Phi Alpha Delta on to greater heights."

The Reporter stated the second "Phi Alpha Delta Night" was a greater success than the original occasion.

But continuing the move to combat the economic conditions of the country, the Supreme Executive Board meeting in September, 1935 reduced the annual subscription rate of The Reporter from \$2 to \$1.50, and the compulsory life subscription to the official magazine was eliminated. Additionally, alumni dues and alumni fees were suspended for 1935 and 1936, and the annual per capita chapter "tax" was reduced from \$8 to \$5.

As a result of the austerity program of financial belt tightening, the picture was starting to brighten.

Continuing this uphill turn, the twenty-fourth biennial convention meeting in Washington, D.C., in February, 1936, was called outstanding.

Making appearances or mounting the speaker's rostrum during the convention were Chief Justice William Howard Taft of the U.S. Supreme Court, Senator Millard E. Tydings, Senator F. Ryan Duffy, Senator Alben W. Barkley, and General Brien McMahon (later to become a United States Senator).

The following year, with the fraternity continuing its comeback from the depression, Hamlin Chapter was transferred from the discontinued University of Maine law school to Loyola University School of Law in Los Angeles. Several months later the Capen Chapter charter was transferred from the extinct Illinois Wesleyan University to the University of San Francisco. (Subsequently, Hamlin Chapter was renamed the William Joseph Ford Chapter and Capen Chapter became the Matt I. Sullivan Chapter.)

The twenty-fifth biennial convention opened in Kansas City in 1938 on this continued note of optimism. The country was thought to be recovering from the depression and hopes

were up that the fraternity would regain solid economic footing side by side with the national economy's recovery.

War clouds loomed on the horizon, though. And the delegates did not know this convention would be the last for several years or that the officers elected at this convention would serve until 1946.

The storm of war finally broke through in 1940 when Hitler began his intensified march across Europe. The American draft became a

reality. And again - as had occurred during World War I - American youth put aside their academic thoughts and began picturing themselves in uniform. Correspondingly, Phi Alpha Delta was to take a back seat to the war effort.

History had taught Phi Alpha Delta a lesson, though. The national officers anticipated the results and began a "buttoning up" of fraternity loose ends which was to later serve the fraternity well when peace returned.

The twenty-sixth biennial convention (scheduled for 1940) was postponed until 1941, and in 1941 was postponed

He began as Director of Risk Management and General Counsel for Kappa Sigma Fraternity International in Charlottesville, Virginia. He later became Assistant Executive Director, before leaving to become Executive Director of the professional Sales and Marketing Fraternity Pi Sigma Epsilon.

At the January 1999 International Executive Board Meeting in Baltimore, MD, Frank was initiated into the Egan Chapter of Phi Alpha Delta.



indefinitely by the Supreme Board. And in its place the national officers worked to keep Phi Alpha Delta in the public eye. The future President of the United States, Senator Harry S. Truman, was honorarily initiated, as were Francis Biddle and Tom C. Clark, attorneys general, and Associate Justice of the U.S. Supreme Court Robert H. Jackson.

The New York Alumni Chapter had dinners in honor of William O. Douglas and Wiley B. Rutledge, justices of the Supreme Court. The Chicago Alumni Chapter honored past Supreme Justice Dwight H. Green on the occasion of his election to the governorship of Illinois. Interest was kept alive in other parts of the country through visitations by the national officers.

Other activities engaged in by Phi Alpha Delta during the war years were the establishment of a placement center: celebration of a national Phi Alpha Delta day at the San Francisco exhibition in 1939: preparation and distribution of a historical sketch of the fraternity: holding district conclaves in Kansas City and New York: active support of the defense program promulgated by Brother Robert H. Jackson, then Solicitor General of the United States: support of and cooperation with the American Bar Association special committee on national defense: and the pledging of assistance and services of Phi Alpha Delta to the U.S. Attorney General's office.

Steps were taken to conserve the fraternity's limited finances. In 1942 the Supreme Executive Board discontinued the salary of the Supreme Secretary and in 1941 the Supreme Secretary discontinued charging regular secretarial expenses.
