

# On to Our Second Century Doers, Not Viewers

hat an exciting

moment it was for

me to take the oath of office as Phi Alpha Delta Law Fraternity's International Justice. We were finishing up a terrific Centennial Celebration at our Convention in Phoenix having named C. Raymond Judice as International Historian Emeritus, having just elected a new International Executive Board (IEB), having just bestowed the Barbara C. Jordan Outstanding Public Service Award on Justice Adolpho Birch, the Chief Justice from the state of Tennessee, and having bestowed the Distinguished Service Chapter membership on Clifford Schechter. My family was there, and all my brothers and sisters of P.A.D., including my wife who was initiated along with me into the Erskine M. Ross Chapter at the University of Southern California in the Fall of 1979.

The underlying current throughout the convention was the P.A.D. Building Opportunities Capital Campaign. Having purchased our new headquarters in Baltimore only a few years ago, we had established a campaign goal to raise \$500,000 over five years. Going into the convention we had pledges of \$206,000. During the convention an additional \$20,000 was pledged by law students and alumni bringing us 45% of the way towards our goal. Ninety-two percent of the alumni in attendance had become contributors by the close of the convention. A truly outstanding record which is due in no small part to the two co-chairs of the campaign -John F. Weitkamp and Clifford Schechter. They have set a new interim goal of raising an additional \$23,000 by the end of September. Further, they have challenged the Pre-Law and Law School Chapters to each buy a brick before our true Centennial Founders' Day which the IEB will observe in Chicago on November 8, 2002, in conjunction with our annual Pre-Law

Conference. Soon thereafter we hope to have both mortgages retired leaving only the endowment for the building remaining.

I have set the theme for this biennium to be about P.A.D.s who are "Doers, Not Viewers." Those mentioned above are a couple of those P.A.D.s who exemplify the essence of P.A.D. - service to the student, the school, the profession and the community. I have challenged each of the elected IEB and International Tribunal members, each appointed District Justice, and each delegate to the Centennial Convention to be doers in this biennium and to return to the 2004 Convention to showcase what can be done.

The new IEB met Sunday following the convention and set the following goals for the biennium:

- A. To improve the communication among all members of the Fraternity.
- B. To improve the financial condition of the Fraternity by (1) completing the Capital Campaign, (2) increasing law school and pre-law initiations, and (3) enhancing benefits to all brothers and sisters of P.A.D.
- C. To reconsider the structure of the Fraternity by (1) revising the structure of the Phi Alpha Delta Public Service Center (PSC) board, and (2) reconsidering how we want to expand internationally.
- D. To enhance the image of P.A.D. in the legal community.

These are worthy goals to prepare the preeminent law fraternity for its Second Century.

But goals by themselves have little value. The value will be created by the energy and enthusiasm of the officers and members of this fraternity, and we need your help. We want every P.A.D. to have a part in this celebration of our history and our future. Consequently, each of the IEB members has agreed to chair a committee to further these goals, and to seek out volunteers to work with us. We have established eight committees or councils [see page XX] chaired by IEB members, and a subcommittee comprised of the International Tribunal. Each of these full committees will be staffed by a member of our professional staff in Baltimore to ensure that these efforts will continue past this biennium and these particular committee members.

Each of these volunteer chairs is looking for additional doers to help them carry out their committee goals, and by extension the Fraternity's goals, for the biennium. I thank each of them for their dedication and enthusiasm, and encourage each of them to test the limits of what P.A.D. can do. *Philos Adelphos Dikaios*.

At our Centennial Convention in Phoenix, our delegates passed many significant recommendations and resolutions. In particular, the delegates recognized "P.A.D.'s courage to assume the responsibilities associated with increasing diversity in the justice system," and encouraged "P.A.D. to continue to undertake the tradition of promoting diversity." This was welcome recognition that the Fraternity of Firsts will continue to be a spokesperson for the principle of "Equal Justice Under Law," which is the underlying principle of P.A.D.'s Tom C. Clark Award. I was proud this year to have visited with U.S. Supreme Court Justice Ruth Bader Ginsburg in her chambers as then International Justice Shelley Weinstein presented her with the Tom C. Clark Award.

Finally, our principles of integrity, compassion, courage and professional service continue to serve us well. The convention resolved "to remind [P.A.D.'s] over 200,000 members that a lawyer's word is his or her bond, and that rule should guide his or her professional activities." In that vein, at the closing banquet, the delegates pledged to each other that they will attend P.A.D.'s Convention 2004. I hope that each chapter is already planning for special fund raising to encourage even better attendance at Convention 2004 than we have seen at recent conventions.

I look forward to seeing each of you in two years if not before.



How do employers feel about this?

She wants you to avoid letters altogether, and e-mail a casual not to those friends of friends (or alums), meet them, and through them meet *their* friends – your potential employers – in person. *That's* your best, surest, and fastest way to the job of your dreams, and it avoids writing icky cover letters altogether.

Dear MF,

Things are a lot brighter than they seem right now, MF, even though the Job Goddess has got to start you out with a bit o' bad news: don't waste your time even contacting headhunters, not for at least a year. The Job Goddess will elaborate a bit on exactly why this is so, but it basically boils down to this: as a new law school graduate, you don't yet have a head worth being hunted.

Let's take a moment, shall we, MF, and discuss the world of headhunters in the legal market. Our guide will be Sue Gainen, Career Services Director at the University

> of Minnesota Law School - and herself headhunter for seven years in a prior incarnation. She explains that "The headhunters get paid is that when an employer hires through them, they get a commission of 25 to 30% of your first year's salary." (The Job Goddess hastens to point out that this payment system accounts for that ahem - not particularly shy retiring and personality headhunters are known to have.) So if you're talking about a job that pays, say, \$75,000 to start, the employer is

going to have to cough up 25 grand if they hire someone through a headhunter. And what does that in turn, tell you? That "Headhunters are the employer's sources of employees of last resort," as Sue Gainen says. In other words, an employer is really going to need an expert on Iranian freedom of religion issues right now before they're going to go to a headhunter to find said person. The Job Goddess acknowledges that that is a rather obvious exaggeration, but you get the point, MF. In order to entice a headhunter, you've "Got to bring


Dear RM,

Times they are a-changin', eh, RM? It seems that the time-honored tradition of law school – stamping and sealing hundreds and hundreds of letters addressed to "Hiring Partner" – is a practice facing its golden years.

Ah - but not so fast, RM. The Job Goddess posed your question to a number of legal employers, most of whom feel this way about e-mail: While it is perfectly fine informal correspondence, like a note to an alum from your school asking for advice about breaking into the legal market in their city, or inviting a friend of a friend out for a cup of coffee to pick their brain about being entertainment lawyer, it's probably too informal for your "Dear standard,

Attorney Godzilla: Rodan, your colleague suggested I should contact you because of your expertise in construction law...yadda yadda yadda." If you think about the e-mail you yourself get, RM — and at this point I am not discussing the rather graphic jokes about Bill Gates that seem to make their way into many of the e-mails the Job Goddess receives — you'll note that they tend to fall into the "just a quick question" category. Formal correspondence over the Internet is just a little bit off-putting, at least right now.

The Job Goddess has a sneaking suspicion that the way society is progressing; this won't be



Is It Worth Going to a Headhunter for My First Legal Job?

Dear Job Goddess,

I have been sending out a bunch of letters in hopes of finding a job after graduation, with no success. I have been thinking about trying a different strategy and using a headhunter. How effective are legal placement agencies in finding jobs for recent law school grads? And if they are effective, can you recommend any around Philadelphia?

expertise to the table," as Sue Gainen points out. Most law firms are *deluged* with resumes of new law school graduates, a flood to which you yourself have contributed, MF. They don't *have* to cough up a five figure financial hairball to find you. And they don't.

What does this mean to you, MF? It means that barring the unusual – for instance, you neglected to mention your U.S. Supreme Court Clerkship, or that your initials aren't really MF but instead JFK, Jr. – most headhunters won't talk to you for your first foray into the legal job market.

But all is most definitely not lost, largely because you can be your own headhunter, and you'll be far more effective than anybody could be on your behalf. After all, what a headhunter does is to bring you to the attention of employers, and entice them to hire you. You're far better qualified, and motivated, to entice them yourself. What you have to do is to get yourself in front of potential employers, in the way that you find most comfortable. If it's Philadelphia you want, you can, for example, find out who runs the local bar association section on the specialty you want to enter. Call that person, and in your most enthusiastic tone, volunteer to help out any way you can - be it organizing events, researching issues, whatever - and explain that you're doing this to break into the field, in Philadelphia. Or visit law firms, in person, and drop off your resume, instead of sending it. The Job Goddess has never known anyone who required more than a week to find a job when they took this "personal visit' route, because legal employers are so impressed when law school graduates do anything to break out of the "mass mailer" mode. There are a bunch of other things you can do, MF - most of which are outlined in the Job Goddess's book, Guerrilla Tactics for Getting the Legal Job of Your Dreams. But you get the point. Don't waste time contacting headhunters who aren't motivated to help you find that first job. Contact them a couple of years from now, when you've taken the Job Goddess's advice, found that first job yourself, developed an expertise - and then watch those headhunters jump through hoops for you. You'll deserve it!

How Do I Handle Job Ads That Want 'One to Three Years of Experience,' If I'm a New Graduate?

Dear Job Goddess,

I am very frustrated. I'm in my last year of law school, and it seems as though all of the ads I see are looking for somebody with one to three years of experience. Is there any way I can get one of these jobs anyway?

Dear VS.

There may well be, VS, and the Job Goddess congratulates you for contacting her instead of just throwing in the career towel.

From the outset you have to appreciate that what employers advertise for and what they will accept are often two very different things. Many employers have pointed out to the Job Goddess that when they write job ads, they are describing their "ideal" candidate. It is often the case, VS, that that ideal candidate may not apply for the job, and so it will go to someone else who – like you – does not have the exact credentials stated in the ad.

With that in mind, how do you improve your odds of being the lucky candidate? Lisa Lesage, Career Services Director at Lewis & Clark Law School (and herself an attorney for several years), gives you two steps to follow: one is researching what you've got, and the other is finding out all you can about the employer.

When you look at what you bring to the table, Lisa Lesage says that, "When attorneys say they want one to three years of experience, what they really want is someone who knows the ropes. Jobs you have during law school can easily give you that." She advises you to "Look at all the law-related work you've done, no matter what it is, and disgorge a line or two on every single things. Don't simply say that you 'researched issues' or 'drafted memoranda and motions.' Instead, be very specific. Say that you drafted a motion for summary judgment in a 1983 case concerning privilege. Or that you prepared a deposition for a Title 7


case involving sexual harassment." For non-legal jobs you've had, be similarly specific so that you can pull out the skills that you can transfer to the legal job you want. Lisa Lesage advises that "If you managed a restaurant before law school, don't just leave it at that. How many people did you manage? Did you handle budgets, or scheduling, or any other activities that would be similar in any setting?" The important thing here is that you "shouldn't ever self-select out!"

What will this self-research do for you, VS? As Lisa Lesage says, "It will help give you fodder for a cover letter, and it will also help you overcome any interview objections. You will be able to say, 'I may have just graduated, but I've got the experience you're looking for."

The other task at hand for you, VS, is to research the employer. Most ads state whom the employer is; if you find ads that don't - in other words, it's a "blind ad" - you are not out of luck. Lisa Lesage says that, "If the return address is a P.O. Box, and the employer is incorporated, the post office must tell you the name of the box holder. Once you know who the employer is, go to your career services office at school and see if they've compiled data on the employer or if there are alums from your school who have worked there." Such an alum can be an enormous help, since they will not only be able to tell you about the employer and how you can position yourself to get a job there - but they may also be willing to walk your application over to the person who's doing the hiring, and perhaps even put in a good word for you. Needless to say, this is a great way to distinguish yourself form other people applying for the same job.

Of course, VS, you know that the Job Goddess prefers that you find your dream job by getting to know people, through school and law-related activities, than through job ads. But the fact remains that many people do find jobs they like through ads, and if you follow the advice here – why, VS, there's no reason why you can't as well.

### What Gives With Mass Mailers?

Dear Job Goddess,

I read your book "Guerrilla Tactics for Getting the Legal Job of Your Dreams," and I know you are really against mass mailers. Don't they ever work? If they're such a bad idea, why does everybody do them?

-CF, Pennsylvania

Dear CF.

Moo-oo-oo. That's why, CF. Everybody does them, well, because everybody had *always* done them. It's the equivalent of salmon spawning. And in the

Job Goddess's mind, that's simply not a good enough reason to do anything.

But does that mean mass mailers never work? course not. For one thing, CF, if you've got mind-boggling paper credentials, mass mail away. If your letter begins "As President of the Harvard Law Review, I..." you could etch your resume on a rock and hurl it through law firm windows and get job offers.

Of course, that isn't most law It students. certainly wasn't the Job Goddess when was in law school. And outside of the grade-blessed, mass mailer statistics pathetic. As a rule of thumb, only one or two percent of mass-mailed letters result in interviews. So a typical law student can expect one or two thumbsfor ups every hundred letters they mail. While that is abysmal, it contains the essence of why the


Job Goddess can't universally condemn mass mailers. As Gloria Yolanda Rivera, the Career Services Director at St. John's University School of Law, says, "Four interviews from 200 letters are four interviews you didn't have otherwise. Out of those four, you might just get an offer."

But there's a catch, CF, and it's this: the Job Goddess has yet to find the law student who can easily stomach dozens and dozens of rejections without having their morale beaten into a spiritual pulp. If you go into a mass mailer realizing two important facts, you might be able to overcome this overwhelming rejection and make a mass mailer work for you. One fact is this: those paper rejections are meaningless. The Job Goddess knows a number of law students who were rejected repeatedly by a given employer when that employer was lumped into a massmailer - only to subsequently find themselves invited for an interview when they met one of the attorneys in the firm at a job fair, bar meeting, or conference. Same students, same credentials, totally different result. So blame your mass mailer rejections on the approach, not yourself.

The other point to remember about mass mailers is the importance of not making them the sole focus of your job search. Because mass mailers take so much time to put together, and are so physically impressive - all of those envelopes! All of those stamps! - you'll be tempted to do nothing else. As Wendy Werner, Career Services Director at the St. Louis University School of Law, comments, "It's so much more comfortable to do a paper search, and have your paper meet their paper." Please don't let that happen to you, CF - if necessary, jettison the mass mailer and do everything else, anything else, instead. The happiest law school graduates the Job Goddess knows are those who got their jobs by being flesh and blood human beings by meeting their prospective employers in person, through school activities, volunteering at legal functions, attending conferences, and the like. Great jobs, all over the world, have fallen into students' laps when they made the effort to be a smiling face instead of a standardized letter. And that, of course, is what - caution: shameless commercial plug ahead - the Job Goddess's fabulous book, Guerilla Tactics, teaches you how to do, no matter how shy you are.

So, yes, CF, mass mailers aren't a total loss. But the job Goddess believes you deserve so much better than that, CF!

# The Judiciary Reaches the Schools through Technology

May 1st, 2002, Hon. José Andréu García (De Diego, Honorary), Chief Justice of Puerto Rico Supreme Court spent two hours talking with high school students from several locations around the Island at a videoconference about "Juveniles Rights and Responsabilities". In a Law Day activity sponsored by the Puerto Rican Judicial Branch, the Inter American University of Puerto Rico (IAU) and as an initiative of Phi Alpha Delta members in PR, about 200 high

school, junior high school and college students had the opportunity to hear Chief Justice Andréu addressing issues such as responsibility and to discuss with him the 1994 PR Supreme Court case of People on interest of N.O.R.

Puerto Rico is a constitutionally organized Commonwealth of the US through an act of Congress, since 1952. This past Law Day is historical it is the first time that the leader of one of the Island's Constitutional Government Branches used technology to address young citizens islandwide at once. At the videoconference originating from the Ponce Campus of Inter American University of Puerto Rico. IAU's President, Manuel J. Fernós, Esq. (Muñoz), who attended the event offered a welcome message to the students and the Chief Justice. After the Chief Justice Andréu introduction, the subject students were allowed to ask questions and make comments directly to him from the remote locations and at the conference site.

The lesson plan that served as a basis to the video conference cyber dialogue between the students and the Chief Justice was developed by P.A.D.'s Dr. Vanesa Bird (Muñoz) and José R. Cepeda (De Diego) both faculty members of IAU. One of the highlights of the activity was when Chief Justice Andréu signed the Supreme Court Resolution for the Law Day 2002. After the cyber dialogue ended other judges attending at the remote locations spent some time with each group of students answering the remaining questions and assessing the experience with them and their teachers.





# Bar Exam Preparation Making the Right Choice Lesley Yosses, Micromash Bar Review

It's back-to-school time, and for most of you the thought of taking the bar exam—let alone preparing for it—is nothing more than a distant contemplation, a fairly low ranking item on this year's "to-do" list. Classes, interviews, and extra-curriculars are far more pressing matters.

But it's there, nonetheless. That little thought in the back of your head, reminding you periodically that at the end of all this - after three years of case briefs, outlines, law review articles, moot court competitions, and exams - there still remains that one last hurdle between you and your law license. The Bar Exam. It's not something to freak out about now; trust me when I tell you there will plenty of time for that later. But it is important to know two things now: (1) you have a choice when it comes to bar exam prep, and (2) awareness of the habits you are creating right now will help you make a more prescient choice when that time does come.

## The Power of Choice

I was fortunate enough to attend Phi Alpha Delta's Biennial Convention in Phoenix this past August, and in my many conversations with students about bar exam preparation I discovered a common misconception. A good number of students were unaware of the many options that are available to them with respect to bar review, and some were unaware that there is even a choice at all. But the truth is that there is a choice, and making the right one can be the difference between success and failure.

The first step is deciding whether you'll use a commercial bar review course at all. It's certainly not unheard of to pass the bar exam without utilizing a review course, but given the breadth of

information potentially tested (and the fact that by third year you've pretty much forgotten everything you learned during your first year), it's a fairly big risk. Add in the time and money you've invested in law school, and going it alone seems even more foolish.

The next step, which is too often overlooked, is investigating your options. In addition to the ubiquitous seminar-based review courses, you'll find comprehensive home-study home-study courses, supplemental reviews (MBE or essay only), lecture-based supplemental courses, and intensive tutorials. Prices can range from as little as \$200 for a home-study supplemental essay review to as much as \$5,500 for a tutorial with a

three-to-one

instructor student ratio.

When investigating your options, talk to everyone that you can. Talk to people who have passed the exam about their experiences preparing. If possible, talk to some who have failed the exam about their experiences. Talk to the people who work for the bar review courses you're considering. Ask detailed questions about what the review entails. Make sure you understand everything you get and everything you're expected to do. Don't feel like you're being bothersome or annoying if you have numerous questions - this is a decision that impacts the rest of your professional life.

When sorting through bar

review choices, however, the critical element to remember is that no matter where you go, the content is essentially all the same. It's the delivery method that varies. And this is key, because how you learn is absolutely going to dictate how much you learn when preparing for the bar exam.

# Choosing Wisely

bar examiners,

Choosing your bar review method is not something to be taken lightly, and neither is it something to rush into. If you are a first-year student, there isn't much need to be seriously considering your bar review options yet. You haven't really had time to figure out what works for you when it comes to learning the law. The most you should be concerned about with respect to the bar exam is considering which bar exam you'll take and looking into the registration process for that exam. Some states require that you register to sit for the bar exam as early as your second, or even first, year in law school, and the registration process can be very lengthy. You'll probably need to report to the



former residences, all former employers and supervisors, and any legal matters in which you've been involved, from motor vehicle violations to civil actions. So look into your state's requirements and be sure to leave yourself plenty of time for gathering all the necessary information.

If you are a second or third year student, you probably have a good idea of the ways in which you best learn. Some of this information is of course based on your undergraduate and even high school years, but the most valuable will have come from your law school experience. Pay close attention to those study techniques that work best for you. You'll need to be very self-aware by the time you're ready to choose your bar review.

Once you've ascertained which review options are available in your respective bar exam jurisdiction, the next step is to determine which one best suits your needs. You need to be sure that you are getting the best fit for you, and you must be fully confident in your choice. The best way

want is a review that is tailored to your personal learning style. This is not the time to try something new; the possibility of being under-prepared for the bar exam is too great a risk to be adventurous now.



If you learn better by hearing material presented in a lecture, a seminar or tutorial review is better suited for you. If, on the other hand, you prefer to learn by reading, you should find a review based more on texts. If you possess the self-discipline to stick to a study schedule that you've created for yourself (and, indeed, if you prefer to set your own schedule) home study may be better for you. Whereas, if you are the type in need of externally-imposed structure, you'll most likely do better in a course where you're told exactly what to study and when to study it.

Another factor to consider is your test-taking ability. Are you confident in your essay-writing skills? How do you perform on multiple choice exams? If either of these has you particularly anxious, you may want to consider supplementing your comprehensive course with extra help in one of these areas. Or, at the very least, find a course that will provide



if simply being surrounded by others in your situation would brighten your viewpoint.

After you've considered all these factors and chosen the best review for you, keep in mind that your work is nowhere near done. You can't rely too heavily on a bar review course to get you through the exam. The burden is primarily on you, the student. It is your job to ensure that you are as prepared as you can be when the day comes. This means following your study schedule. It means reading everything assigned to you. And, most importantly, it means practice. Practice as many MBE questions as you can get your hands on. Write as many practice essays as your cramped hand will allow. This is how you get the feel of the exam and, thus, how you make sure you'll be prepared both psychologically and intellectually.

So keep all of this in the back of your mind as begin a new school year. There is no reason to rush into a decision about bar review. Yes, you may save a few dollars and time spent doing research by signing up early. But considering the cost both financial and emotional if you have to take the exam more than once, how much will you really have saved?



# A period of dynamic change

Over the past decade or so, the experience of studying law in Australia has undergone a period of unprecedented growth and change. Australia boasts 28 law schools, including only two private law schools. This is a particularly high number considering our population of slightly less than 20 million people. More than half of these have been established since the last significant review of Australian legal education, the Pearce Report, was completed in 1987. At that stage, there were only twelve university law schools, most of them clustered in the six State capital cities. There are 37 universities in Australia, so it is now considered the norm for a university to have a law school, and indeed, the establishment of a law school has come to be seen as a mark of prestige for Australian universities, as well as a very valuable source of revenue. Australian universities have used the establishment of law schools not only to attract prestige, but also to bring professional links and excellent students.

This phenomenon of law school growth appears to be unique to Australia. As the Australian Law Reform

Commission noted in its recent *Managing Justice Report*, over the same period since 1987, only nine new fully ABA-accredited law schools were established in the US, one in New Zealand, and none in Canada. The US now has 185 ABA-accredited law schools, which is more than six times the number in Australia – but with about 14 times the population base. Canada has 21 university law schools within its 91 universities, with a population of more than 30 million.

# Contrasting approaches to legal education

Australian law schools believe that they have a dual mission: to provide a broad

liberal education, as well as to provide a basic grounding for those entering the legal profession. One of the main rationales of this dual mission is the fact that law is generally studied as an undergraduate degree in Australia, in contrast to the graduate structure of law studies adopted in the US.

Most Australian law students study "combined law" – that is, they combine another undergraduate discipline, such as arts, science, or commerce, with law and study a combination of subjects from both degrees during the first three to four years of their university studies, before turning to focus purely on law subjects in the final year or two. This means that there are no separate tests for admission to law schools, and Australian law students do not have to sit LSATs or prepare personal statements before being offered a seat. Law is also offered as a graduate degree at many universities.

The advantage of the combined degree structure is that studies in one discipline inform those in the other, meaning that the study of law is seen as just one part of a student's liberal education. In fact, to some extent, law is coming to be seen as a prestigious generalist degree that can prepare students for a variety of occupations. This is reflected in the fact that approximately 45 per cent of Australian law graduates do not go on to practice law. Australian law graduates are highly employable, and many of those who do enter the legal profession are now taking jobs overseas, with Asian jurisdictions such as Hong Kong and Singapore now competing with more traditional employment destinations such as London. Increasing numbers of Australian graduates are also sitting US bar exams and seeking work in the US.

At the same time, Australian law schools do recognise their responsibility to provide the training necessary to prepare future legal practitioners, and there is a vibrant debate in Australia about the place of clinical skills training and "live client" programs of the type that are widely used in the US. Unfortunately, a much lower level of resources is available to Australian law schools when compared to their US counterparts, with the majority of law school income being derived from the Commonwealth government, rather than from student fee income. This has the enormous advantage of providing at least some equity of access to legal education, but when coupled with the continuing



had several criminal justice and international relations courses in college. I was even on the Model United Nations Team, and not just any team -Wright State University's award-winning team. But none of that prepared me well for the law school experience or my appellate defense of Aimal Kasi in a high-profile national, homicide case. I would like to give something back to the organization I was asked to join twenty years ago this year -The Morgan Chapter of Phi Alpha Delta at the University of Alabama. Hence, I am honored to write this article on terrorism law and policy for The Reporter and explain why knowledge of this topic is so essential for lawyers, law students and prelaw students.

Sadly, this emerging area of the law kicked into high gear after September 11 of last year. Now it is a ubiquitous part of the American landscape, fundamentally affecting all of us in a myriad of ways, and triggering a host of complex and novel legal issues that will remain unsettled for years. This is the key reason that I decided to develop and teach a terrorism law undergraduate course at the University of Richmond's School of Continuing Studies: to bring some analytical clarity to the most urgent law and policy conundrums facing us in our radically new way of life in America. My appellate defense of a Pakistani citizen greatly sensitized me to some of the nuances inherent in terrorism law.

In 1997, Aimal Kasi was convicted of the 1993 shooting deaths of several persons

at the entrance to CIA headquarters in Fairfax County, Virginia. Immediately after the shootings, Kasi went to Pakistan, where he is a citizen. In 1997, he was taken by Federal agents and brought to a state court for trial. The public defender and his office were appointed to represent Kasi at trial and because he was sentenced to death, the appeal was sent to my office, the Appellate Defender. We ( I was lead counsel) raised 92 (I thought it was 91 but the United States District Court in denying habeas relief stated we miscounted) assignments of error in the state court appeal. Most of my appellate attorney colleagues indicate that may well be a record for points of appeal. As Kasi has now been argued before the U.S.. Court of Appeals for the Fourth Circuit, it may ultimately be heard before the U.S. Supreme Court. Of course I cannot reveal confidential information about the case but can certainly discuss the fascinating legal issues that were raised.

Many of the objections were routine, preserved only due to the nature of the case and the ultimate penalty received. Others were simply common law or state law issues not relevant to terrorism. But a number of the objections raised go to fundamental questions of constitutional and international law.

The leading question was should the Supreme Court overrule Alvarez-Machain v. United States. In that 1992 case, the Supreme Court of the United States held that the extradition treaty with Mexico did not prohibit forcible abduction by government agents and thus American courts had jurisdiction to try Alvarez-Machain.

Alvarez-Machain should be overruled. But we also argued that Alvarez-Machain was distinguishable from the Kasi case in that the treaty between the United States and Pakistan required its use when the treaty refers to the law by reference and the Pakistani law states that "Every fugitive offender" shall be extradited by legal means. Virginia finally conceded at the habeas hearing that the United States did in deed invoke the treaty - filed a rendition to do so - but that Alvarez-Machain excuses it. Our third approach was to suggest an alternative remedy for treaty violations other than want of jurisdiction: Suppression of evidence.

The record showed that Kasi was held in solitary for 72 hours in Pakistan. We argued that this had the effect of overbearing his will.

Perhaps a most disturbing assignment of error dealt with the issue of classified evidence: Agents of the government refused to give many details of the abduction. The trial court upheld that and blunted cross-examination. Many details of the abduction are even now only coming to light. We saw a redux of this type of government secrecy in the John Walker Lindh "Taliban" case when he was interrogated by FBI and CIA agents on a U.S. Navy ship in the Arabian Sea last winter.

The terrible events of September 11 brought about sweeping changes in the law in many areas. Wiretapping statutes were liberalized, the reach of the money laundering and currency transaction laws were vastly broadened with an increase in the regulatory powers of the Secretary of the Treasury, and, for the first time since World War II, there is discussion of legal racial profiling and military tribunals. In South Carolina, an American civilian

citizen is being held in a military prison, allegedly for conspiring to build a "dirty" nuclear bomb. The federal government takes the position that the civilian courts have no power to adjudicate whether his detention is legal or not. And, on the weapons front, the threat of smallpox, anthrax, or other weapons of mass destruction(WMD) create cinematic-like legal dilemmas such as the right to forcibly quarantine those suspected of being exposed to a biological agent.

The USA PATRIOT Act made substantial changes which will affect nearly every attorney. Many businesses must now examine the sources of cash of their customers, including travel agencies, precious metal dealers as well as virtually every kind of investment vehicle. The need for a Suspicious Activity Reports and/or reports of deposits of more than \$10,000.00 of cash will arise. Suppose you get a whopping legal fee in cash. Is it tainted money? What assurances will I need that I will not be accused of money-laundering? And what reports must be made? What questions will they have to ask? And the European Union wants lawyers to be gatekeepers of the financial system. So you

only do house closings? Think that you are immune to all of this War on Terrorism onus? Not hardly. The mortgage company will require you to "know your customer" since the see no evil defense will no longer work.

Want to go to the library to forget about September 11? Forget it. The FBI may seize your library records - and gag the librarian from telling you that the agency wants to know what you read in your private time. New rules on surveillance might mean that public meetings or church services might be attended by stealthy FBI agents. Colleges and universities will find tighter government restrictions on research use of various chemical and biological agents and certain personnel will not be allowed access to it. What if I am counsel for a trucking company? There are new hazardous materials rules for you to learn as well.


Let me close with a compelling reason why knowledge of terrorism law and policy is equally important for pre-law students. With its unique synthesis of practically every law practice area, terrorism law could better equip pre-law students for the rigors of law school and


the legal profession. Moreover, in interviewing for both law and non-law related jobs at the CIA, State Department, Peace Corps, and World Bank, for example, a terrorism law course on your resume could give you a competitive edge in a very tight job market.

Why do so many lawyers want to write novels? Aside from the fact that many lawvers have become successful novelists, writing is a pleasant counterbalance to the rigid, rule-bound world of the law. As lawyers, we maneuver our cases and negotiations through client demands and libraries of rules. Sometimes we feel pretty powerless, like cogs in a machine. Writing a novel is, in some sense, the opposite of legal practice. As the author, you are the puppet-master god of your characters. Your imagination alone brings people to life, makes them love or hate, and even, carries them to their deaths. In short, there is no greater liberty for the mind than to write a novel. What follows is the story of how I came to write and publish my first novel, The Law Review, and what I learned about writing along the way.

# 1. THE IDEA

The genesis for any book is a good idea, and good ideas are often free if you keep your ears open. The idea for The Law Review came from a law school mini-scandal in which the editor in chief of a law review accused the executive editor of attempted murder in the midst of an internal power struggle for control of the journal and its booty (prestigious clerkships on the United States Supreme Court). You might also actively search for ideas by increasing your exposure to criminal cases. Read criminal law case books. Consider taking a clerkship for a trial or appellate court that hears criminal cases. Accept a pro bono case. These last two options are also ways to experience the nobility of the legal profession through public and pro bono service, something that is all too often lost in the hustle of big firm civil practice.

# 2. RESEARCH

Every book requires a certain depth of realism that either comes from your personal experience, or alternatively, from research. It is obviously easiest to write about where and what you know. In the case of *The Law Review*, I set the book at my law school and at an island where I had twice vacationed. You will be surprised what dangers you can learn about when you are wandering the world on business or pleasure, dangers that you can make your characters experience.

Character development is no different. If you interact with interesting people, pro bono clients included, your character portfolio will be all the richer. So too can you interview strangers for your research purposes. In the book that I am currently writing, one character is a happily married professional woman who nonetheless has an affair. I managed to speak candidly with dozens of women who fit my character's bill. Remember, strangers in bars will talk about almost anything if you preface the conversation with, "Excuse me, but I'm doing a little research for a character in my novel. . . ." Every now and then you might get slapped, but it comes with the territory of being a writer.

# 3. THE HOOK: CHAPTER ONE

The first thing publishers want to see is the "hook", an opening event in the first chapter that captures the reader's interest. If your book starts with, "here is Joe Smith, he has black hair and green eyes," your chances of selling the book, however good its remaining 300 pages may be, are basically zero. In *The Law Review*, my hook is a bomb threat to a judge's son, the editor in chief of the law review. Before you do anything else, you should write the first chapter of your book, introducing your principal characters in the midst of the "hook".

# 4. THE OUTLINE

After you have written the first chapter, you should start an outline of the rest of your book. My outlines are just a few pages long, summarizing in a couple of sentences what I plan for each chapter. The less detail you have in your outline, the more leeway you will have for creativity when you sit down to write the rest of the book.

# 5. THE REST OF THE BOOK

Once you start writing the second chapter, just keep writing straight through to the end. I find that weekends are the best. I will start in the mornings and write until I lose my creative urge. During the following week I will think about the progress of my plot. Then I will pick-up where I left off the next weekend, with the benefit of a week's reflection.

Every writer has his or her own approach to bringing a literary world to life. I tend to think of myself as being inside my characters. The closest thing to this experience is a movie called *Being John Malkovich*, in which a portal allows others to experience what it is like to be inside another person's conscience. When I am writing, the characters take on an existence of their own, and they will do and say things on the page that I had never contemplated they would in my outline. Letting the characters go where they want to go will make your characters come to life.

# 6. EDITING

Resist the temptation to edit until you have completed the first draft of the book. The flow of the book is important, and editing in its midst can disrupt the overall rhythm of a story. When you are finished with the first draft, then you can sit down and read it. Unless you are really, really special, your first draft will be very rough, and it will take you far more time to edit your book than it did to write it.

That being so, where do you start? You should start big. Identify plot inconsisten-

cies and places where the pace of the book is too slow or too fast. Then go back and delete and add as necessary until you are happy with the whole. My editor at Creative Arts told me to ask, with respect to each scene, "How does this scene progress the plot, develop the characters, etc. If you do not have a good answer, delete it." When you are pretty comfortable with the draft, let your spouse or a trusted friend (preferably one who reads a lot of fiction) read it, focusing like you did on the big picture. Accept his or her criticism. Only after you are happy with the whole should you polish your prose and dialogue (otherwise you might lose the forest amid the trees).

# 7. GETTING PUBLISHED

By far the hardest part of writing a novel is getting it published. The large publishing houses will not even read the first page of a novel that is not submitted by an agent, and most agents will not accept a writer who has not had a successful novel. Unless you already work for a large publishing house or otherwise have inside connections, getting published by a large press, or getting a decent agent, is next to impossible. I actually worked with two agents who accepted unpublished authors as clients, but there was a reason they accepted unpublished writers as clients—both agents were pretty worthless.

The best way to get your writing career started is to buy copies of the publishing directories and identify those presses that accept submissions directly from writers and that have published work similar to yours. Once you have this list, follow each publisher's submission guidelines (often they ask for the first couple of chapters and a synopsis) and wait for the rejection letters to come. Persistence is the key, though. If your book is good enough, it will eventually find a home. You should also never fail to mention to every person you meet that you are shopping your novel manuscript. You never know, someone's sister may be the vice president of Random House.

# 8. MARKETING YOUR BOOK

Assuming you have not sold your book for \$1 million to your colleague's sister at Random House, it will probably get published by a smaller press. One day you will get a letter from your press telling you that

there are 5,000 copies of your book sitting in their warehouse and at Amazon.com and that it is time to start marketing, that is marketing with a small "m". Your publisher's marketing department has sent review copies out, and your book has probably been reviewed once or twice in national magazines. Nonetheless, you will not find a pile of your books sitting on the front table at your local Borders, and your publisher will not be taking out full-page advertisements in USA Today. Once your relatives and friends have bought their one-hundred copies, how do you sell the remaining 4,900 books? You will have to make appearances and sell copies one at a time, hoping

that each buyer will recommend the book to someone else. Needless to say, this is hard work, but without it, your opportunity at making a career as a writer will be over.

Of course, you might think about how your book's idea, or setting, affects your marketing strategy. For example, The Law Review is set at a law school. As a law student, I read every book I could get my hands on that was set in law school (e.g., One L) or a law firm (e.g., The Firm). Reading about what I was doing made me feel important and full of opportunity. So I have targeted my marketing efforts at law and pre-law students. I addressed the P.A.D. national convention and have offered a complimentary copy of The Law Review to any student who is willing to write a review of the book for his or her law school or university newspaper. The book has been on the market since late-May and is selling about two-hundred copies a month. My hope is that these sales can be maintained, or even, grow.

Perhaps the ultimate commercial dream of every novelist is to have his or her book made into a movie. It is the marketing home run, and books that sold only a few thousand copies can be catapulted instantly to

ne word that is often associated with the study of law and the law profession is stress. First year law students enter law school with worries about not sleeping for weeks while studying, and law graduates worry about possible eighty hour work weeks at their new firm.


The process of applying to and getting into law school can often be just as stressful as actually attending. When I made the decision to apply to law school, I felt behind in the game; no one in my family practices law, I had no contacts, and I had no idea where to begin.

I became overwhelmed. Finding my university's Phi Alpha Delta chapter turned out to be an excellent thing for me, but even joining this group of my talented peers was stressful. I walked into my first meeting and everyone seemed so far ahead of me, throwing out phrases and words from the LSAT like "arguments" and "games", and I had no idea what to do. I realized I needed to accomplish many things such as study for the LSAT, take the LSAT and do well, figure out the best schools for me to apply to, get recommendations, apply, and (hopefully) get accepted. With much to figure out and time working against me, I threw myself into the pursuit of getting into law school while still retaining my grade point average and my sanity.

I applied to seven schools, and I am grateful I made it through the process unscathed. I was accepted to five schools, offered a scholarship at three of those, waitlisted at one school, and denied to one. While my Phi Alpha Delta chapter gave me many tools that I used to my advantage, I still went through the process alone, learning as I went. However, there is no reason you must travel this road alone. The advice I offer is only a place to start, but perhaps it will allow you to feel more confident in beginning the law school application process.

There are hundreds of pre-law publications on the market, and one piece of advice that will be found in many of them is to start early. Two examples of things you should not procrastinate on are drafting your personal statement and studying for the LSAT, but the most important thing I found that should be

taken care of early is asking for letters of recommendation. The people you approach will probably be hard-working and busy. There is no way of knowing what their workload will consist of from day to day or from month to month, and they will need ample time to write your letter so that it will reflect well on



you. Ultimately, it is not worth your stress or your letter writer's to worry that your letters will make it to your LSDAS file by the time you are ready to send in your applications.

Beginning early will only help you in this stage of the application process. Find the people that you believe you want to write your recommendations and ask them when their workload is lightest. You should allow three weeks for LSDAS to process letters after they arrive. If you intend to apply in mid-October and wait until September to ask for recommendations, you may end up facing unexpected time restraints. For example, professors are just settling into a new semester at this time; and if you are counting on them to write something outstanding about you, it may not be a wise idea to burden them with more work when they already face a stressful time of the year.

Since I had no connections in the law field at the point that I needed recommendations, I relied on three professors with whom I had taken several courses. I approached them the day after final semester grades were due, which gave them three months of summer to finish my letter and mail it off — minimizing the stress factor for all involved. Many applicants do not begin thinking about their letters of recommendation the May before they apply; but once yours are in your file and processed, you will rest easier.

Several different national publications rank law schools and other graduate programs every year. It seems students who consider applying to law school become either concerned by the rankings or pay little attention to them. The applicant is the one with whom the importance of these rankings really lies. The seven schools I applied to ranged widely in how they

ranked, and they all had individual pros and cons according to what I wanted in a school. Ultimately, what you want in a school should be your concern as an applicant. Visit all of the campuses that will be sent your application. Decide what you want. In order to better look at all of the different choices, I recommend "The Complete Guide to ABA Approved Law Schools,"

which you can purchase through LSDAS. You will be spending three years in law school, and you need to be somewhere you feel comfortable. You also need to be at a school that you believe can help you achieve your professional goals.

No matter what type of law you may want to practice, an essential tool to any lawyer doing his or her job is the ability to write well. Therefore, in the months and years before you apply to law school, write as much as possible. Never underestimate the power of the answers you give on an application question, and never underestimate the power of your personal statement. For some of the more competitive schools, you will need convincing arguments to prove to those making the decisions that you belong at their school. Your two page personal statement does not allow much time to convince the admissions committee that you are worthy for admission into their school and that you will make an outstanding lawyer. In the short space you are given, every word counts and every mistake can be seen. In preparation for this important piece, write as much as possible both for yourself and others. Keep a journal, or write a letter to the editor of your university's paper. When you do complete your personal statement, use your editing resources. If your university has a law school, ask whether there is someone there with whom you can set up an appointment to read your piece and ask for feedback. Just remember that your first


New Chapter has Exemplary Programs

new chapter of the Fraternity was installed on February 26, 1966, at Indiana University in

Bloomington, Indiana, as the John Adams Chapter. Thirty-three second and third-year law students were initiated as charter members and forty-eight freshman students were pledged as members of the first pledge class of the new chapter.

While still a colony awaiting formal installation, the members of the Adams Chapter, during the period of September, 1965 to February, 1966, prepared a law school library guide and distributed copies to all incoming freshmen; when the bookstore was unable to obtain sufficient copies of the Remedies course textbook, the members obtained copies from students who had previously taken the course and had them placed on reserve in the library for those students who were unable to purchase copies for themselves; they set up a series of review sessions for the freshmen courses offered during the fall semester; while planning what proved to be one of the best organized and professional installation of a chapter, they conducted a rush function ten days before the chartering and obtained forty-eight pledges, all against the competition of a competing law fraternity which had been operating at this law school for some time! Nor did our new members rest on their laurels.

At the formal installation, plans were announced for future programs of the chapter including: scheduling a series of speakers on various aspects of law practice, planning and establishing a legal aid society for the Bloomington area, developing a program which would enable law students to spend several hours each week in a lawyer's office to obtain practical experience, implementing a summer placement program in conjunction with the University Business Placement Office, and formulating a voluntary student ethics program to better prepare the law student for the practice of



law. In a short period of time, the charter members of Adams Chapter certainly perfected a record of professional programs that would be difficult to match!

Soon after we acknowledged the death of Brother Harold Burton, we welcomed into our ranks a number of distinguished jurists when on April 11, 1966, all of the justices of the Supreme Judicial Courts of Massachusetts and Maine, and of the Supreme Court of New Hampshire, received the oath of membership from Supreme Vice Justice Tom C. Clark. The ceremony was conducted in the Supreme Judicial Courtroom of Massachusetts and was attended by members of the three Phi Alpha Delta chapters in Boston: Burton, Frankfurter, and Boston Alumni. The ceremony was followed by a reception and dinner at the Union Club of Boston.

Within the two-month period extending from March 22 to May 28, 1966, four new chapters were chartered. The Douglas L. Edmonds Chapter was chartered at Santa Clara University in California, the Robert M. LaFollette Chapter at Marquette University in Milwaukee, the Kenneth Douglas McKellar Chapter at Memphis State University, and the Theodore Frelinghuysen Chapter at Rutgers University School of Law, Camden Division, Camden, New Jersey. Unfortunately, the same year was to see the deaths of two former Supreme Justices of the Fraternity, Albert T. Gilbert and William S. Culbertson.

# Contingency Fund Strengthened

The Thirty-Sixth Biennial Convention was described by the delegates as a "tremendous success." The 1966 Kansas City gathering was officially preceded by a meeting of the Supreme Executive Board during which a report stated that the Fraternity was in the strongest financial position in its history. And the Board felt that at times such as this "funds should be set aside to protect the Fraternity against the risk of a financial reversal such as that suffered during the depression of the thirties and the war years of the forties." For this reason the Board resolved to maintain cash reserves in the general and contingency funds in an amount equal to at least the expenditures of the last fiscal year, in addition to the reserves for the convention, directory, and directory supplement. It was during this biennium that the Supreme Executive Board, under the guidance of Supreme Justice Robert E. Redding, began to utilize a highly structured committee system, targeting specific, key aspects of Fraternity operations for review, analysis, and action. The success of this type of structure became readily apparent and it continued to be effectively utilized for more then two decades. Many professional programs were also instituted during this period.

# Distinguished Service Chapter Established

At the suggestion of Supreme Vice Justice Tom C. Clark, this pre-convention meeting also established the Distinguished Service Chapter to "recognize members who had contributed outstanding service to the Fraternity." This program proved to be very popular in that it provided a vehicle to recognize those members who had made long, effective, and dedicated service to the Fraternity, many of whom would not have been formally recognized otherwise.

# Convention Workshops Established

The official opening of the Convention was sparked by the keynote address of The Honorable (Brother) Charles E. Whittaker, Associate Justice of the United States Supreme Court. This convention witnessed the first Convention Active Chapter Workshops which proved to be such an outstanding success that they were adopted as a permanent feature for future conventions. Decisions of the Convention included the following: deleting the office of Supreme Second Vice Justice and replacing it with the office of Supreme Advocate; limiting tenure on the Supreme Executive Board to eight consecutive years; raising the maximum amount for student loans from \$500 to \$1,000; and urging law schools to uniformly adopt the Juris Doctor degree for law graduates possessing baccalaureate degrees.

# Phi Alpha Delta Day at the Supreme Court

Monday, May 20, 1967, marked the first Phi Alpha Delta Day at the Supreme Court. On that day, thirty-eight members of the Fraternity from nineteen states gathered in Washington, under the auspices of the Fraternity, to be admitted to practice before the United States Supreme Court. Mr. Justice (Brother) Tom C. Clark hosted a reception for the admittees and their families in the West Conference Room of the Supreme Court Building prior to their presentation to the court. He also formally moved their admission before the court. As with so many other innovative programs developed by the Fraternity, the Phi Alpha Delta Day at the Supreme Court has become an annual tradition for the Fraternity.

Sirica later played significant roles in the Watergate hearings involving unethical conduct on the highest level of the Executive Branch of the Federal Government. Later Brother Williams served as counsel to the President of the United States William Jefferson Clinton in another ethics investigation.l

# The Office of Juvenile Justice and Delinquency Prevention Nominates a New Administrator

he Phi Alpha Delta

(PAD PSC) receives

Delinquency Prevention (OJJDP). Since
1985, the PAD PSC has received over 3.5
million dollars. The PAD PSC is very
grateful to OJJDP for its continuous

On April 12, 2002, J. Robert Flores was confirmed by the Senate, and sworn in as the Administrator of OJJDP, Office of Justice Programs (OJP), U.S. Department of Justice.

As Administrator, Mr. Flores is responsible for the agency that Congress has mandated to address the public safety issues of juvenile crime and youth victimization. His OJJDP leadership responsibilities include identifying effective strategies for addressing juvenile crime through research; coordinating, implementing, and supporting effective programs and encouraging innovative approaches to deal with existing and

This Phi Alpha Delta Public Service Center page was produced under Grant #95-JS-FX-0018 from the Office of Juvenile Justice and Delinquency Prevention, Office of Justice Programs, United States Department of Justice. emerging juvenile justice issues; developing priorities and goals and setting policies to guide Federal juvenile justice issues; providing technical assistance and training to essential components of the juvenile justice system; disseminating information on juvenile justice trends, programs, and new approaches; and awarding funds to States to support local programming nationwide.

In setting forth his goals for his tenure at OJJDP, Mr. Flores has emphasized the importance of protecting public safety and the significance of failing to prevent delinquency. "When we fail with children, the economic costs are great, but the cost in terms of lost opportunity are astronomical", he notes.

Mr. Flores envisions an expanded role for private organizations and community groups in delinquency prevention efforts and believes that it is critical that these local groups receive the support they need.


Mr. Flores brings experience in both the public and private sector to his new position. Prior to his OJJDP appointment, Mr. Flores was the Vice President and Senior Counsel for the National Law Center for Children and Families. From 1989 to 1997, Mr. Flores was Senior Trial Attorney and Acting Deputy Chief in the Child Exploitation and Obscenity Section, Criminal Division, of the U.S. Department of Justice. During his tenure in the Criminal Division, he supervised several national investigations, including the U.S. Customs Service's "Operation Long Arm," which targeted individuals in the United States who imported child pornography from a foreign-based bulletin board service, and the Federal Bureau of Investigation's "Innocent Images" effort to halt distribution of child pornography images through America Online, the Internet service provider. Mr. Flores prosecuted United States v. Kimbrough, the first Federal computer child pornography case to go to trial. He successfully argued the appeal to the Fifth Circuit Court of Appeals.

Prior to his service in the U.S. Department of Justice, Mr. Flores was an Assistant District Attorney in Manhattan where he successfully prosecuted numerous child sexual abuse cases, including highly publicized cases involving a major child prostitution network and a millionaire philanthropist who operated a non-profit organization through which he seduced and sexually abused children. Mr. Flores regularly lectures at conferences and

seminars throughout the United States on child abuse and exploitation, criminal procedure, criminal and constitutional law, and investigative procedures and computer crime. He has also served as a consultant to Federal and State legislators and government officials. In 1999, he was appointed to the Child Online Protection Act Commission by the Speaker of the U.S. House of Representatives, Dennis Hastert.

Mr. Flores earned his Juris Doctor degree from the Boston University School of Law and Bachelor of Science degree in business administration from the Boston University School of Management.



# INTERNATIONAL TREASURER'S REPORT

As presented on August 1, 2002

TO: Audit and Finance Committee Phi Alpha Delta Law Fraternity, International

I am pleased and proud to report to you that this Biennium finds our Fraternity in exceptionally sound financial condition, perhaps the best in well over a decade. We have just endured and successfully passed the most comprehensive financial audit in Fraternity history.

During this biennium, we brought payroll and all related tax filings in-house thereby realizing an annual savings of \$2,000. We reduced the number of our bank accounts by 50% and placed all monies into sweep accounts. Accounting personnel, the Executive Director and International Treasurer were bonded for the first time in decades. We changed the accounting software from DacEasy to Quick Books which allowed me to keep a current and complete set of books at my office.

In FY 2002, we undertook a five-month data base conversion. We replaced our customized version of FoxPro, which had been installed in the 1980's, with a new database called Pinnacle. Pinnacle allows for checks and balances not previously available to us. This conversion cost approximately \$66,000. Not only will this new database track overall member history in a more efficient manner but it is already showing us a return on our investment. For example, one of the features allows mass e-mails to various sets of members with just a few keystrokes. As a result, this year, the sale of graduation cords increased seven-fold due to this mass e-mail capability. It cuts the workload in half for recording of initiations and collection of alumni dues. It will also eliminate unnecessary, costly duplicate mailings.

In the past, the Fraternity established a line of credit that was accessed in the fall of the year prior to initiation fees coming in. That line of credit was not accessed in FY 2001 or 2002. Additionally, unlike recent years, we will not be borrowing money to pay for the Convention and have in fact already pre-paid expenses in excess of

\$62,000 related to this Convention. As of June 30, 2002, we have \$275,000 cash on hand. This figure greatly increases our chances of not having to access our line of credit. Therefore, our current financial status should allow us to complete FY 2003 without the necessity of accessing the line of credit. We have made all transfers required by our International Constitution and we are current in our tax filings.

During this biennium, pre-law initiations increased. However, law school initiations and Alumni dues decreased. Affinity income has risen from 5% of total revenues in FY 1999 to 15% of total revenues in FY 2002. During this biennium, the Fraternity entered into new strategic alliances with Barrister Books, Geico, JKM Communications, Home LSAT and Collegiate Funding Services. These alliances brought our total affinity income to \$106,547.

The Endowment Fund is a separate 501(c)(3) corporate entity. Pursuant to the International By-Laws, \$2.50 of each alumni dues payment is to be transferred to the Endowment Fund. As a result, the Endowment Fund has earned \$4,685 from alumni dues this biennium. The Endowment Fund has made loans of last resort to qualified Phi Alpha Delta law student members resulting in \$1,517 of interest earnings and interest on deposits. While substantial efforts have been made. at minimal cost to the Endowment Fund, to collect on these delinquent loans, history has shown that many of these loans will remain uncollectable. The audit report on the Endowment Fund reflects this reality and has increased the allowance for doubtful accounts accordingly. This results in a net note receivables being shown as \$3,515 as of June 30, 2002. Additionally, the Endowment Fund has \$33,626 in cash on hand and an investment in P.A.D.E.F. Holdings, LLC (reflecting the Endowment Fund's 54% ownership of the LLC) of \$33,538 with an amount due from the LLC of \$77,632. In addition to the net occupancy expense associated with ownership in P.A.D.E.F. Holdings, LLC and other miscellaneous expenses, the Endowment Fund pays to the General Fund an annual administration fee of 6% of its assets. However, the Fraternity did not draw down or collect this fee this biennium resulting in a current liability of \$13,193 in FY 2002. The fund balance as of June 30, 2002 is \$149,347 compared to \$115,233 at the beginning of the biennium.

The District Leadership Conference

(DLC) Fund was established within Phi Alpha Delta's 501(c)(7) entity. Pursuant to the International By-Laws, Chapter XII, Section 4, \$5.50 of each law school and alumni initiation fee is to be transferred to the DLC Fund. Of this, \$3.50 is assigned to the District in which the initiation occurred and \$2.00 is assigned to a discretionary fund administered by the Executive Director to assist Districts that need special assistance. During FY 2001, revenues exceeded expenses by \$4,322. During FY 2002, expenses exceeded revenues by \$2,039. This resulted in a net increase in the DLC Fund balance of \$2,283 for the biennium, leaving a total fund balance of \$44,498. For purposes of the audit, assets, liabilities and fund balance of the DLC Fund have been consolidated with the General Fund audit and are also separately reflected in an attached schedule.

To purchase our building at 345 North Charles Street in Baltimore, the Endowment Fund and the General Fund established a new entity, P.A.D.E.F. Holdings, LLC. The Endowment Fund owns 54% of this entity and the General Fraternity owns the remaining 46%. The Endowment Fund is responsible for leasing the first and second floors of the building while the General Fund is responsible for leasing the third floor and basement. At this time, the Endowment Fund has leased all of its space. The General Fund occupies the majority of the third floor and the entire basement. The remainder of the third floor is leased to the Phi Alpha Delta Public Service Center. P.A.D.E.F. Holdings, LLC shows as its assets the building less depreciation, cash in a bank account and receivables from the General Fund and Endowment Fund. Its only liabilities are the mortgages payable on the building. The equity positions of the two shareholders are held at the original level to maintain the 54%/46% ownership ratio while the net revenue/expenses for each shareholder's portion has passed through to the respective entities.

The purchase of our new building was accomplished in part by obtaining two mortgages totaling \$340,000. Regular monthly mortgage payments combined with the pay-downs brought about by the efforts of the Capital Campaign enabled us to reduce the principal amount of the mortgages at the end of the biennium to \$177,376.

The International Building Fund, established to help with the purchase of our new building, still exists. It can be used to pay a portion of the net occupancy costs,

# Capital Campaign at the Centennial Convention

Our 2002 Convention was a spirited one as you can tell from the enthusiasm evident throughout this issue of The Reporter as well as that which has been shared over the Listserv - as is befitting our Centennial Convention.

The Capital Campaign Co-Chairs want to thank all of the Convention attendees for the spirit they exhibited toward the P.A.D.

Building Opportunities Capital Campaign during the Convention. From start to finish, our sisters and brothers truly made the Campaign their own and, as a result, an additional \$20,000 in pledges were made, bringing our total to date to over \$226,000 – in excess of 45% of our Campaign goal. Of this additional pledged amount, some \$13,000 in cash contributions have already been received and added to our coffers. As a result, immediately following the Convention an additional \$15,000 has been paid against our headquarters mortgages, in addition to the \$120,000 previously paid.

The funds received during Convention were raised in a variety of ways: from new donors; by increased pledges from existing contributors; through the Purple & Gold Party; by voluntary fines on members who failed to state "name and chapter" on the Convention floor; by tributes to the victims of September 11th; proceeds from the Escort Auctions; and, yes, even from the sale of the caps of the Campaign Co-Chairs. By Convention end, 92% of the alumni in attendance had become contributors to the Campaign, following in the footsteps of the members of the International Executive Board and the Distinguished

Service Chapter, both groups of which have 100% participation in the Campaign as well as all past Supreme and International Justices.

With the Convention behind us, we have established two more short-term Capital Campaign goals: (1) to achieve 50% (\$250,000) of our overall goal by the end of October, which will require our raising \$23,000+ in the next 7 weeks; and (2) to celebrate our Centennial Founders' Day by maximizing contributions through our chapters, pre-law, law school and alumni, by our November 8th anniversary date.

Sisters and brothers, we could use y o u r individual support in achieving the first shorted the assistance

contribution. first short-term goal and beyond! We need the assistance of all of our chapters to achieve the second goal. The importance of this Campaign is startlingly evident: Every dollar ratsed now will result in a savings to our Fraternity of close to three dollars over the next 20 years. In other words, through the dedicated efforts of the contributors to date, we have already saved Phi Alpha Delta over \$500,000 in




# Alumni Dues Statement to Take on a New Look!

any improvements or repairs to P.A.D.'s space or to purchase new furnishings. Pursuant to our International By-Laws, Chapter XI, Section 2, \$2.00 of each law school initiation fee, \$25.00 of each alumni initiation fee, \$3.00 of each alumni dues payment and one-third of each life membership is to be transferred to the Building Fund. As of June 30, 2002, the International Building Fund had no outstanding liabilities and \$4,097 in cash on hand. \$28,570 is invested in P.A.D.E.F. Holdings, LLC. It shows a net expenditure of \$13,040 for the biennium. For purposes of the audit, the assets, liabilities and fund balance of the International Building Fund have been consolidated with the General Fund audit and are also separately reflected in an attached schedule.

The Phi Alpha Delta Public Service Center (PSC) is a separate 501(c)(3) corporate entity but is related to Phi Alpha Delta Law Fraternity, International. Its primary source of income is a grant from the United States Department of Justice, Office of Juvenile Justice and Delinquency Prevention (OJJDP).

In summary, our Fraternity finishes its first century with the programs and assets in place for a strong start on its next 100 years. It has been an honor for me to serve our Fraternity as International Treasurer.

regulatory emphasis in Australia on mastering substantive areas of the law, rather than mastering fundamental lawyering skills, has meant that such clinical programs are not so well integrated into law school curricula

as they are in the US.

In order to complete a law degree in Australia, it is compulsory to have studied eleven subjects, known as the "Priestley 11". Some important and high profile areas, such as family law, environmental law, taxation and competition law, are popular with students, but rarely compulsory in law schools. As a result of globalisation, increasing numbers of law schools are making public and private international law courses compulsory, and the Commonwealth Attorney-General's International Legal Services Advisory Committee is also looking at which internationally-focused subjects should be introduced into law school curricula to increase student awareness of the increasing globalised nature of legal practice.

# The student experience

As a result of the different approaches to legal education outlined above, the student experience of law school in Australia is quite different to that in the US, although perhaps it is true to say that our experience is moving closer to that of US law students. Increasing numbers of Australian law schools are adopting Socratic and problem-based learning methods, teaching law in small and interactive groups. These changes have been welcomed by students, whose initial perspectives on legal education are often informed by American novels and movies displaying the use of such methods in US law schools. The Australian law student experience is also enriched by the large numbers of opportunities to spend a semester studying overseas on exchange now offered by all law schools.

Extracurricular involvement of law students is widespread, and Law Students' Societies exist in every law school to accommodate the wide range of student interests, including competitions such as mooting and witness examination, pro bono and volunteer activities, social events and educational support. The Australian Law Students' Association represents these concerns on a national level, and continually strives to ensure that the Australian law student experience produces well rounded graduates, passionately concerned about justice and the preservation of the rule of law.


