

# How to find an Alumnus Advisor

One of the key features of a strong and successful P.A.D. chapter is to have one or more Alumni Advisors to offer guidance and support to the chapter's officers and members. The Alumnus Advisor is a valuable resource to assist the chapter with its programming, rush, and community service initiatives. In addition the Alumnus Advisor can provide a sense of consistency for the chapter by linking members who generally have graduated within 2-3 years of joining P.A.D.

Most chapter leaders understand the desirability and importance of an Alumnus Advisor but complain that it is difficult to find alumni willing to help out or remain active with the chapter. This article will give you some proven ideas that may help you find at least one Alumnus Advisor for your chapter. It isn't as difficult as you may think. The unique bond of P.A.D. fraternalism makes it easier to enlist your P.A.D. brother's assistance and help you build a stronger chapter.

To start you need only look to the roll of your chapter for the last five (or more) years to find potential Alumnus Advisors. Former members and officers that have graduated still retain their joyful memories of the P.A.D. experience and may desire to "keep the flame alive" by becoming involved with your chapter. Recent graduates can provide a relevant history of previous chapter successes and failures that the current officer group might find useful. As they are in the early stages of their career, recent graduates may not be able to devote as much time as an advisor as the chapter might like. That should not be an impediment, reassure your brother or sister that you are sensitive to their availability and would appreciate whatever level of commitment they can provide.

Regardless of your Alumnus Advisor's availability your chapter should pursue and have at least three advisors. Receiving advice and support from multiple Alumnus Advisors gives your chapter more and varied resources and makes it easier to accommodate each advisor's time constraints without adversely affecting the chapter.

In addition to the younger and more recent graduates of your law school you should also consider approaching your older alumni. Many P.A.D. alumni members would welcome the opportunity to work with law students and become involved in the various programs and service initiatives that chapters generally sponsor. The older graduates may be more secure in their profession and thus may have more flexibility. Accordingly, they may be able to attend meetings or events during the day or early evening when many chapters tend to schedule their programs. With their legal and professional experience, the seasoned Alumnus Advisor is a valuable resource.

Finding P.A.D. alumni from your school or chapter is very easy. In addition to your own historical records, your district justice or the International Office can assist you. You may also consult your school's alumni office and any directory they might have published. The easiest source of P.A.D. membership information is on the P.A.D. website (www.pad.org) which contains an online directory of every P.A.D. member. If you haven't used that resource yet, you should make it your first stop after reading this article.

# Hickman Chapter receives "Outstanding Community Service" and "Outstanding Volunteer of the Year"

The Professional Fraternity Association (PFA) today represents sixteen professional fields - including law, medicine, engineering, dental, architecture, nursing, music, law, insurance, education, pharmacy, band, veterinary medicine, business and economics, marketing, and agriculture. PFA initiates over two million professional men and women through more than 2500 collegiate and alumni chapters across North America. Each year PFA honors one chapter with "Outstanding Community Service" based on extraordinary efforts to better their community. PFA additionally names as "Outstanding Volunteer of the Year" the

> member group displaying in the preceding year exceptional service or commitment to their fraternity community. The Hickman Chapter of Phi Alpha Delta Law Fraternity International (P.A.D.) at the University Houston Law Center and one of its members, Wendy M. Miller, are the

one individual member of a

recipients of these two PFA annual awards for 2004-2005. At the heart of both awards are the benefits to the Houston community sparked by Hickman's annual Camp COOL (Children's Orientation On Law). Hickman and Miller, the camp's creator and chair, were honored this past September at the PFA annual conference in Orlando, Florida.

Recognition on a national level first came to Hickman on behalf of the premiere year for Camp COOL at PAD's 55th Biennial Convention in Los Angeles, CA. Camp COOL 2003 received Law-Related Education awards for both Outstanding Student Service (Miller) and Chapter of the Year. Camp COOL 2004 repeated as the Law-Related Education award recipient in 2005 at P.A.D.'s annual International Executive Board meeting in Dallas, Texas. The other annual P.A.D. awards captured by Hickman in 2005 were: Best Professional Program-2nd place for Professional Speaker Series Program: Animal Law; Outstanding Community Service-1st place for School of ROK (Rights of Kids); and Outstanding Community Service-3rd place for the National Youth Service Day program on Family Violence. Hickman also notably captured 2nd place out of the 190 PAD law school chapters in the Stanley H. Kohn Outstanding Chapter Competition.

Hickman's efforts are acknowledged in Houston. Two of their public service projects, Camp COOL 2004 and School of ROK 2005, found community support in the form of generous individual grants from the Houston Young Lawyers Foundation. The camp specifically earned



campus recognition two years in a row with University of Houston Campus Activities leadership awards for Best Community Service Project in 2003-2004 and 2004-2005. Hickman additionally received appreciation for its contributions to the University of Houston Law Center with the title of "Student Organization of the Year" for 2004-2005.

Wendy Marie Miller, a recent graduate of the University of Houston Law Center and outgoing Justice for Hickman Chapter, has a thirteen-year-old daughter, A'Lee. Miller graduated magna cum laude in 2002 from the University of Houston with a B.A. in Philosophy and minors in Political Science and Religious Studies. As an undergrad she was the public relations officer of the Golden Key International Honor Society, a member of the Omicron Delta Kappa National Leadership Society, and a staff writer with a weekly column in the campus newspaper, Daily Cougar. As President of the Phi Alpha Delta prelaw chapter, her organization captured a national award in 2002 for the Best Community Service Program of the Year for the work replenishing the library at the campus Child Care Center following the devastation of Hurricane Allison.

Ms. Miller entered the University of Houston Law Center in 2002. While in law school, Miller captured Dean's Scholarships, the Bridgeway Foundation scholarships, the 2004 Houston Young

Lawyers Association law student grant, and was the 2004 winner of one of only five International Service Scholarships awarded annually by P.A.D. In addition to the recent accolades in 2005 from both P.A.D. and PFA, Miller was the 2004 statewide winner of the State Bar of Texas Law Student Division Legal Professionalism Award. Other highlights for Miller's law school career include being a finalist in the Tom Newhouse Mediation Competition and working as Chief Managing Editor for the Journal of Texas Consumer Law and as Writer-at-Large editor for UH Law's student newspaper-Legalese. She served on the Board for the Houston Association of Counsel for Children, as President and co-founder of the Criminal Defense Law Students Association, and as a member in the Texas Criminal Defense Lawyers Association and the Harris County Criminal Lawyers Association. Miller donated her time at local animal benefits on behalf of the Animal Welfare Committee of the Houston Young Lawyers Association and as a volunteer guardian ad litem representing children in custody proceedings with Children's Friend in Court. Miller most recently fulfilled a one-year national appointment through the American Bar Association as the Law Student Liaison to the Standing Committee for Legal Aid and Indigent Defendants.

In her second year of law school, Wendy Miller created and coordinated Camp COOL (Children's Orientation On Law). The camp developed out of necessity. The first two days of Thanksgiving week are holidays for Houston-area school districts, while the university's holiday does not start until that Wednesday. Full day care facilities leave younger relatives and children of college students and employees enduring a "long" day at the university. Camp COOL offers a low-cost alternative [cost per camper is \$5] and a safe alternative to leaving gradeschoolers home alone. Campers look forward to entertaining (and educational) law-related activities taught by law school and high school volunteers.

The camp grows each year. Camp COOL 2003, a two-day camp for area students in grades K-6<sup>th</sup>, had twenty campers. The second annual camp doubled in size as Camp COOL 2004 treated nearly forty campers to a cornucopia of activities. The camp is always held on the Monday and Tuesday of Thanksgiving week from 8:30 am to 2:45 pm. All campers enjoy breakfast, lunch, and lots of law-related programs, including an "Actus Reus: Let's Get Active" physical education event. Campers complete arts & crafts and never see an empty snack table.

Hickman utilizes the entire university community to keep the three tracks of age groups running constantly in the camp for K-2nd, 3rd-4th, and 5th-6th. The big events are the mock trials. The first day of camp ends with a mock Teen Court trial featuring K-4th as the 'jury' and 5th and 6th graders as the attorneys and witnesses (under the instruction of high-school members of the City of Hedwig Village Teen Court Advisory Board). Camp concludes on the final day in the law center Auditorium with all campers participating in a mock criminal trial for an audience of family, friends, and law school faculty/ students.

Hickman Chapter anticipates an exciting Camp COOL for 2005 with Dawn Onusko, Hickman member and

Dear Brothers and Sisters,



## Marathons in One Year

Phi Alpha Delta member, Dane Rauschenberg (Burr), has begun the unthinkable... to run a full marathon every weekend in 2006 to benefit the organization L'Arche-Mobile!

"I've always wanted to see how far I could push myself athletically and combining that personal goal with a great cause makes it that much better. It is only when you look at what others are missing do you realize how much you have and how it would be a shame to waste those gifts," said Dane who continues to hold down his job as a Licensing Associate in Chevy Chase, MD during this entire event.

All of the money Dane raises will go directly to L'Arche-Mobile, which is one of many L'Arche communities worldwide. L'Arche is an international federation of communities in which people with a mental handicap and those who help them can live, work, and share their lives together. For those who have spent their lives being shifted from one institution to another, L'Arche is a refuge and a permanent home. For many, L'Arche is their first encounter with an environment where family, friends and relationships have real meaning. L'Arche Mobile is a permanent member of the International Federation of L'Arche.

In preparation for this task, Dane ran 11 marathons competitively in 2005, with a stretch of 4 in 47 days at one point. Not too bad for a guy who had only run 2 marathons in his life until 2004. "The bug hit when I decided I wanted to run a marathon in every state by the time I

was 50," said Dane who is currently 29. "But then I got impatient."

Dane doesn't see what he is doing as all that special. "I really think that most of us have something inside that makes us attain things previously thought to be unreachable. In running, it really is one foot in front of the other and I urge everyone to come out and run with me, even if it is only for a mile."


## Hickman Chapter's **Professional Program**





Another source of Alumnus Advisors can be found within the P.A.D. alumni chapter in your geographic area. Not all cities or states have active alumni chapters but if you have one nearby, your chapter officers should have already made a connection with their alumni brethren. Alumni chapter members have already demonstrated their desire to remain active and connected to P.A.D. Most alumni would be happy to work with and support a local chapter if they are asked to do so. As noted above, alumni members are busy people too. If a prospective advisor indicates he or she is "too busy" then ask for a minimal commitment of time. If you do this with three to five "prospects" your chapter will be better for it as you will undoubtedly always have at least one advisor available when needed.

As with any professional relationship the key is to ask for what you want and be respectful of the other person's time constraints.

If there is no active alumni chapter in your area you need only turn to the international executive office or internet as outlined above. P.A.D. is the largest legal fraternity in the nation and our members can be found in every geographic location. You need only take the initiative to find the alumni in your area and you will be well on the road to having at least one – or more – Alumnus advisors for your chapter.

Finding an Alumnus advisor is not difficult. Most active P.A.D. alumni are happy to help out but they need to be asked to do so. Chapter officers and alumni committee chairs should not be afraid to be proactive and ask for advisory assistance from any number of their brethren. You may consult your faculty advisor, district justice, alumni chapter officers, and current and former International Executive Board members. Any of these individuals can help your chapter find at least one Alumnus Advisor if you just reach out to them. The most important step is simply to ask for help. Once you have found an advisor, make sure you express your gratitude on occasion for his or her service to your chapter. You'll find that the bonds of fraternalism will continue to run strong and your chapter will prosper.

## Why Volunteer?

I live to help others.

What makes me 'me' is the characteristics that the prep books warn potential law students not to reveal in personal statements – a caring soul, a kind spirit, and hopeless optimism. If not for the nasty habit of fainting at the sight of blood, nursing might have been my calling. But life gently nudges us in the right direction.

Three years of law school come and go in a flash. The roadblocks in an otherwise blur of memories are my public service as a Hickman Chapter officer. Law school dominated my thoughts for three years, but Hickman captured my soul. I mention a few of those projects now in hopes of inspiring current chapters to consider creating 'roadblocks' of their own.

I was blessed to be a part of numerous efforts with Hickman. My chapter at the University of Houston Law Center hosted its second annual Camp C.O.O.L. (Children's Orientation On Law) in 2004. Compared to the previous year, the camp doubled in size and treated nearly forty campers to a cornucopia of activities. The camp is held daily on the law school campus the Monday and Tuesday of Thanksgiving week and is open to any area elementary-grade child.

Camp C.O.O.L. may have been a learning tool for K-6<sup>th</sup> grade, but in 2005 Hickman expanded its law-related education portfolio to reach high schools. School of ROK (Rights of Kids) had thirty-nine participants from four Houston-area high schools. With a focus on educating teens on constitutional rights, the full day included attending law classes covering topics, such as juvenile delinquency and medical decision-making, and supporting Law Day 2005 during the second half of the day in exposing the teens to a privilege gained at age eighteen – jury service.

In honor of National Youth Service Day, Hickman in April of 2005 taught a lesson on family violence to thirty eighthgrade students. Phi Alpha Delta-Public Service Center (Carole Collins, director) made this event possible by awarding Hickman Chapter a mini-grant of \$200 to support it. And Hickman also worked as a co-sponsor for several events. To celebrate the Roper decision (prohibiting the execution of juveniles), for example, Hickman and five other student organizations in conjunction with a speaker panel explaining the long-overdue Supreme Court opinion conducted a teddy bear drive to benefit Afghani children living near landmines. Hickman also participated with other organizations in a "Clothes Sorting Party" at the building housing "Aid to Victims of Domestic Abuse." Law student volunteers at this event helped the non-profit entity to organize and fold donated clothes in preparation for the beginning of the holiday season.

Graduation from law school gives me my wish – the opportunity to help others. My public service experiences in law school on behalf of PAD will make

substantial in the area of investment. For investors, the AUSFTA has put in place legal guarantees and other measures that provide greater certainty. The AUSFTA is increasing US investor interest in Australia as arrangements for screening US investment have been eased and Australian investment in the United States remains strong. Increased investment will, in turn, spur greater linkages and synergies between our firms, and encourage best practice in both the private and public sectors. The Agreement will result in a more transparent business culture, an acceptance of each country as an important and growing trading partner, and lead to easier market entry for businesses from both sides of the Pacific.

## "London-Paris-Geneva" Program

#### American University-Washington College of Law

The Comparative Law program in Europe nicknamed "Paris Geneva" is a study tour of Europe usually consisting of around 60 lawyers and law students from different law schools and countries around the globe. In addition to classes and seminars taught by AU/ WCL faculty, the law students receive challenging seminars by officials and experts at numerous international institutions and organizations visited. The basic educational concept of the program is to provide experiential, on-site learning about evolving legal concepts and structures in Europe and their effect on the international arena. Program participants are required to strike a fine balance between "absorbing the culture" and enjoying Europe, while at the same time keeping up with a demanding study schedule in accordance to ABA rules and guidelines. The dates for 2006 are June 4-July 2.

By visiting the institutions of the European Union, United Nations, OECD, International Court of Arbitration and many others, students can better comprehend the functions, importance and usage of international law. This holistic understanding of the interaction and impact of institutions using international law is imperative today for law students and lawyers in their careers. Over the past 10 years, depending on that year's itinerary, the program has visited and offered seminars in international organizations in London, The Hague, Brussels, Luxembourg, Frankfurt, Strasbourg, Paris, and Geneva. AU/WCL faculty has included Nancy Abramowitz, Andy Pike, Jamin Raskin, Jim Salzman, Emilio Viano, Perry Wallace and Durwood Zaelke.

The program consists of three courses: "International Economic Law: The New European Legal Order;" "International Human Rights Law: Changing Concepts, Approaches, and Enforcement;" and "International Institutions and Sustainable Development." Each is worth 3 credit hours. Students can enroll for a total of 6 credit hours. All students must take the "International Economic Law" course, but they have a choice between the "International Institutions and Sustainable Development" and "International Human Rights Law" courses. "International Economic Law" provides students with solid instruction on new legal concepts, jurisprudence and institutions reflecting the globalization of commerce. Particular attention is given to the European Union, the Organization for Economic Cooperation and Development (OECD), the European Bank for Reconstruction & Development, and the World Trade Organization (WTO) The International Human Rights course focuses on legal developments, court decisions and international agreements in human rights and humanitarian law generated by substantial changes in the international order, ethnic conflicts and warfare in various regions of the world, and the more active role undertaken by the United Nations Human Rights and Refugees Branches, the International Labor Organization, and the International Committee of the Red Cross, among others, in addressing these problems. "International Institutions and Sustainable Development" focuses on the international institutions responsible for promoting environmental law and sustainable development including the OECD, Council of Europe, UNEP, WTO, During the program briefings are also offered by prominent lawyers from major law firms in London and Paris. One day is spent in Brussels to meet with and be briefed by high level civil servants in the European Union.

Visits to the courts and to the legal establishment in London and Paris are also offered. Ample time is available for the participants to take advantage of the many cultural, artistic and tourist attractions offered by London, Paris and Geneva. ## How to Put Together a Successful Community Service Event

To be truly successful planning for a community service event needs to begin a few months before the date of the potential event. To be successful as a community service director or chairperson, depending on what your chapter calls it, you need to set your schedule of events a semester a head of time. The following is your chapter's guide to make any event you host a success! I will be using two of our big community service events, Party for a Purpose and St. Baldrick's, as examples. This is not the only way to do a community service event, but merely what I have found to work best.

Depending on the size event you are doing you will want to put together a committee to manage the event. For an event the size of St.Baldrick's you will need three to four people to help with the various aspects involved prior to the event and five to six the day of the event. This will all very on what type and size of community service event you are doing.

I arrange a location that can accommodate the number of people you think will be attending. It is best to do this as soon as possible because without the location the event can not be done. For example with St. Baldrick's the location needs to accommodate 50-100 people with an area that can be set up like a stage so that everyone can see their friends as they get their hair shaved off or cut off. Once the location of your event is taken care of then you can turn to the other details.

For a fundraiser that is going to a party like Party for a Purpose which benefits the American Cancer Society, you will then need to decide if there is going to be a DJ or if you will just use someone's CD collection. If you choose a DJ start calling local DJ's to see if you can find someone who might be willing to do it for free since it is a benefit. I got lucky in this respect because a close friend is a DJ and he was willing to do the event for free for us. If you opt to just use a CD collection just make sure that you know what it is early on and that you have a boom box or sound equipment to use.

About three to four months before an event where you are doing a raffle you will need to send out letters to local businesses requesting donations. For St. Baldrick's I start sending out letters late December or early January. Sending out letters to local businesses is one way to do this, but be sure to keep a running list of where you send the letters you will need it later. I have found that it is best during the three months before the date of the event to have a form letter and carry copies of it with you when you go shopping or out to eat. That way you can simply drop the letter off at more businesses. Here again keep a list of where you drop them off.

The reason for keeping a list of where you mailed or dropped off the letters is because about 2-3 weeks after mailing/dropping off the letters you will need to start calling those places back. Many places won't just respond with items, you have to call them and speak to someone. You can expect about 1/3 to 1/4 of the places that receive a letter will be able to give you some form of item or gift certificate. Just keep in mind that there are many large businesses that will have to send their letters to a corporate headquarters to get permission to donate an item. Some items will need to be picked up so be sure to arrange with the companies a time to do so. If you can pick them up the week before the event do so that you don't have to store them for several weeks. This is especially true if florist donate items.

Some time about a month before the benefit you will want to contact the local media about covering the event as well. You might consider advertising the event with local media to get a larger crowd. Also consider publishing the event in the school newspaper if there is one. Even publishing it to the undergraduate school that the law school is attached to is a good idea because it gives the event more exposure.

In the last few weeks before an event make sure to confirm with your volunteers the time and location of the event as well as with the location itself. Go over any last minute details at this time. The day of the event show up early and set up.

THE MOST IMPORTANT THING IS REMEMBER TO HAVE FUN WITH ANY EVENT YOU HOST.

- b) You will need volunteers to: i. Check in your shavees
  - ii. To help sell raffle tickets
- You will want to make a poster thanking all of your sponsors
- d) Be sure to sell "Lucky" Charms ahead of time. (These are provided by ST. B's.)
- e) Try to get a professor or 2 to participate. I would suggest your faculty advisor if at all possible. You can then ask the students in the professors classes to help sponsor the professor. Also ask the rest of the faculty to sponsor the professor. We did this and found it to be highly successful.

# FAQ's of DC dco@pad.org

Spring Programming – Second verse, same as the first (even better!)

## 1. What kind of programs do we need to bold in the Spring?

Believe it or not, a lot of the programs held in the fall should also be held in the spring.

For Law chapters, 90% of the 1Ls class will be trying to crack the top 10%, so academic assistance programs such as outlining and exam preparation are always a strong draw for current and potential members. For 2Ls and 3Ls programs that focus on networking, career options and professional development are also encouraged. Those programs tend to include speakers who discuss what they do for a living, how they got into it, different ways that they prepared for the bar exam or looked for jobs.

Pre-Law chapter programming in the Spring should continue to focus on helping members and potential members decide whether a career in law is for them by bringing in speakers who discuss the different occupations an individual can pursue with a law degree. For those members and potential members who have already decided that law school is for them, programs that help prepare for. law school such as LSAT preparation programs through The Princeton Review or other prep courses are essential. Of course, chapter visits to different law schools is always helpful in making a decision about which school is right for them, especially when you contact the local Law chapter officers and meet with them!

As you'll see throughout this issue, each Law and Pre-Law chapter should be conducting community service programs. Whether it's Law Related

Education, Habitat for Humanity or a local charity of your choice, the important thing is that your chapter does something! As law students and lawyers, we are in a position to help others. I believe that if we can, we should!

Finally, every Law and Pre-Law chapter needs to hold a Spring initiation. At the Pre-Law level, students at your schools are trying to decide throughout the year whether they should go to law school, so initiations for semesters, or every other quarter are required. In law school, the interest in becoming a member doesn't end after a students' first semester. In fact, it often grows. The only reason that most people don't join an organization is that no one asked them to! The other main reason people don't join is that they don't see the benefits of membership. By holding programs that are for members only and providing discounts for P.A.D. members to participate in P.A.D. events, you'll be able to show tangible reasons for joining, along with all the great intangibles that come from belonging to the world's largest international legal organization!

## 2. Should our chapter have committees?

Absolutely! Committees enable chapters to hold programs without taxing chapter officer's schedules too much. The most typical committees are Programs (sometimes split between Professional and Social), Fundraising, Recruiting and Community Service. In addition, they are a great way to develop future chapter leaders. Chapter committees are also a great way to keep chapter members involved after their initiation.

investments totalling \$A78 billion (\$US57.5 billion).

Australia is one of the world's largest importers of American films, aircraft, machinery, information technology, communications equipment and software. The United States has a large trade deficit overall. On the other hand, with Australia it had a merchandise trade surplus of \$US 6.7 billion in 2004. This was the United States' second largest trade surplus. The US Census Bureau said that for 45 of 50 US states Australia is one of the top 20 export destinations.

The value of the Australian market was also testified to by the large number and the diversity of the types of companies that joined the US business coalition for a FTA with Australia and the bipartisan support for the Agreement in Congress. US company support ranged from large multinationals to many small and medium-sized businesses. They included companies from every sector of the US economy.

#### The Forward Agenda

While immediate gains were realised on entry into force, the full potential of the Agreement will be achieved through the work of the various committees and working groups established by the AUSFTA. Several committees and working groups have already met, including the Sanitary Phytosanitary (SPS) Committee, the Working Group on Animal and Plant Health Measures, the Professional Services Working Group (through which Australia is exploring prospects for the mutual recognition of professional qualifications - including in the fields of law, engineering, accountancy and architecture) and the Financial Services Committee. The inaugural Joint Committee meeting, which will review progress, generate momentum in the forward work program and address any outstanding implementation issues under the Agreement, is likely to take place in early 2006. I look forward to co-chairing that meeting with my counterpart, United States Trade Representative Mr Rob Portman.

Importantly, the AUSFTA is a

"Living Agreement," with the flexibility to evolve as the trade and economic relationship grows. Already, current and potential opportunities under the Agreement have been enhanced by Congress recently passing legislation to create a separate visa category (the E-3 visa) specifically for 10,500 Australian business people and professionals, seeking to live and work temporarily in the United States. This came into effect on 2 September 2005. Developments such as this will ensure that the Agreement remains relevant and that more trade and economic benefits flow over time for our mutual economic advantage.

#### Multilateral Trade Liberalisation

The AUSFTA was reached in the context of the long record of close cooperation between Australia and the United States to promote global trade liberalisation. Australia has a vital interest in United States policies on the international economy, trade and investment. We work effectively with the United States in APEC and in the World Trade Organization (WTO) and pursue issues of common interest such as strategies to advance the Doha Round trade liberalisation agenda, especially in agriculture. We will continue to work together to take advantage of the benefits of globalisation.

Australia remains committed to multilateral liberalisation and rule making for the conduct of international trade. The successful conclusion of the Doha Round remains Australia's top trade priority, as it does for the United States. However, where we can move ahead in a way that is "WTO plus" and achieve outcomes on a bilateral basis, such as through the negotiation of the AUSFTA, or other free trade agreements, we will do so.

#### Conclusion

Open and liberal economies are essential parts of the Australian and American success story. This puts both countries in an outstanding position to take full advantage of the commercial opportunities that are opening up bilaterally and globally.

#### Courtroom Drama

Justice in review as N.Y. prosecutor mines street climes, classics

Joel Seidemann, an assistant district attorney in Manhattan for 20 years, has had a front-row seat in the crime and punishment business. His fascinating book, "In the Interest of Justice," draws from some of the nasty street crimes his office tried but also a handful of court-room classics (Scopes, Eichmann, O.J., Bill Clinton) and even some media-saturated cases (Martha Stewart, Sean "Puff Daddy" Combs, Marv Albert) whose outcomes reflect currents in popular culture.

Thankfully, Seidemann doesn't shill for prosecutors or climb on a political soapbox to call for "tort reform" to squelch showboat defense attorneys. Rather, he retains a sense of idealism about dramatic courtroom showdowns.

"They stand out as moments," he writes, "and I'm not being mystical – in which a higher witness seems to hover over the courtroom." Maybe he was thinking of Dr. John Wood Sr.'s heart-rending ode to his murdered son, a young doctor who was shot dead by two muggers as he walked to Columbia Presbyte-rian Hospital in 1981. In describing the devastating toll on each member of his family over the 20-year span between crime and trial, Wood told the jury, "We are on a more even keel now, but the old joy is gone."

If a cumbersome legal system failed Wood's family, at least New Yorkers had an evening angel in Bernhard Goetz, the Subway Vigilante. When one of five young toughs approached him and asked for \$5, Goetz open fire with the pistol he'd started packing after a previous mugging. Before firing a second shot into a wounded youth, Goetz, said, "You look all right; here's another."

Prosecutors argued that Goetz crossed the line, but a crime-hardened New York jury acquitted him on 12 or 13 counts in 1984.

Stepping back from the wild streets of New York, Seidemann turns to Nazi henchman Adolf Eichmann, who was tried in Jerusalem in 1961 and executed a year later. Eichmann coordinated the deportation of 3 million Jew to World War II extermination camps.

The trial, Seidemann writes, served not only to convict an even man but also a national education project that would "echo through the generations."

The public education theme also ran through U.S. Rep. Henry Hyde's 1999 speech to the Senate calling for the impeachment of President Clinton over the Monica Lewinsky scandal. Given that people are in prison for lying under oath and obstruction justice, Hyde argued, "What in the world do we say to them about equal justice if we overlook this conduct by the president?"

In 1986, Georgia defense attorney Bobby Lee Cook stressed to jurors that the Bill of Rights bestowed on his client, Tennessee banker C.H. Butcher, the presumption of innocence. Jurors tend to assume an accused person must be guilty of something (particularly if they hire a hotshot like Cook). They needed reminding about fundamental rights because, as Cook observed, the Founding Fathers "understood more about liberty and justice and freedom than my generation or my children's generation."

Maybe that's even more true today then when Cook spoke.

Seidemann concludes that even the finest advocates usually can't overcome





## Speech Delivered by the Hon. Anabelle Rodriguez, Associate Justice of the Supreme Court of Puerto Rico

at the Initiation Ceremonies of the Ernesto Ramos Antonini Chapter of Phi Alpha Delta Law Fraternity International. (Spanish version by Rosanna Rivero-Marín, Ramos Chapter - page 36)

To answer the call of young people who are preparing themselves to become the lawyers of tomorrow is a duty that one fulfills with pleasure, especially when that call is given in a context as significant as this one. The centenary existence of the Phi Alpha Delta Fraternity is reason enough to celebrate. In a world of passing fancies, vanity fairs, and short attention spans on the truly important matters, it is comforting to note that there are efforts and commitments that transcend perfunctory pleasures. This Fraternity's persistence and growth reflect the character of its members and the inspiration they derive from its guiding principles.

The breadth of its outlook is evident in the make up of its members, integrating within its folds all the sectors of the legal forum: students, professors, lawyers, and judges. Hence its theme of Service, to the student, to the school or faculty, to the profession and to the community. When one serves one of its sectors with excellence, one does well by the rest. The student is the professional in the making, where our hopes of an Advocacy of true service lies. The Law School and Faculty are the hands that mold and shape this professional. The profession, made up of lawyers active in the practice, is one of the living forces of Society. The community is the reason for being behind all of its sacrifices and its service is the lawyer's true North.

The Phi Alpha Delta Fraternity also recognizes the importance of having a general culture, of cherishing the gifts of the spirit, and of travailing in intellectual forays, beyond the confines of legal studies. So doing is a testament to the

correctness of its full-rounded vision of Advocacy. Legal knowledge and culture, regardless of how vast, are insufficient tools with which to become a lawyer. Inspiration, imagination, creativity, essential components for true advocacy, are not always found within the pages of an opinion or a treatise. However, they may be encountered in the verses of a poem, the pages of a story or novel, the monologue of a play, the lyrics of a song, the quiet contemplation of artistic brushstrokes on a painting, the scene of a film. There, the Truth that we have been unknowingly searching for suddenly finds us and illuminates our understanding. And thus we become better lawyers as we become better persons.

That sensibility, developed through contact with the spirit's highest manifestations, grants us lawyers a point of view more attuned to the needs of the community, which we must serve. It is impossible for us to remain indifferent to the destruction of the environment, to accept the oppressive treatment given to groups in our society, which are marginalized due to causes beyond their control, inherent causes. It is also impossible for us to look the other way as the State violates the Civil Rights of members of its citizenry. The heart demands that we use our intellect to help ameliorate the suffering of those who are unable to defend themselves against life's hardships or against the tyranny of unequal battles.

I believe that organizations like the Phi Alpha Delta Fraternity may contribute greatly to this paradigmatic change in our Profession. We have the duty to mold lawyers who understand that the administration of Justice need not be a bloodthirsty battle of legal wits, nor a game in which to measure strengths or attempt strategies. It is not a matter of manipulating a process to take legal advantage and favor the client, but one in which Justice should be made. The complete knowledge and understanding of the legal process should not lure us to bog it down, in detriment of the goal of a fair and speedy trial with which we are committed as members of the Court.

All of us must demand much more of ourselves, not only academically, but in everything we set ourselves to do. To know and to understand the Law is so much more than quoting the Civil Code, or the Rules of Procedure word for word, or to be current with the latest opinion of the Court; this is, in the best case scenario, but a mere starting point. What really matters is our ability to ask "Why?" and "Why Not?"; it is the careful questioning of the law, the principle or the precedent. It is to reject legal calques made without thought, or to follow the wellworn way of the use and custom without reflection, without a second glance, offering ready-made solutions.

This Fraternity, that welcomes students, professors and lawyers alike in the practice of our profession, is at a perfect moment to be the example of what Advocacy should be. These young, upstart lawyers need to become street savvy, but not with the ruses and tricks that many think are necessary to succeed. It is not innocence or overwhelming naivete that we espouse, but the need to be honest and ethical in our professional dealings with others. Justice cannot be served properly if one lacks clean hands and an honest heart. The reality of advocacy practice, as difficult as it may be, need not turn us into professional cynics.

We have to retain the desire and hope with which we began our legal career. That fervent desire to fight against injustice, to help the weak, to shield our civil liberties and vindicate everyone's rights, must not be lost. That is the Quixotic ideal that rides within each and every one of us, the ones who have sworn to do battle against the windmills of life, regardless of how unequal the fight may be.

The Country needs the talent and integrity of its lawyers, to help in the fulfillment of its Laws, to contribute in making public life more decent and just, and to reconstruct our Society's mores. I entrust you to the task.

Acudir al llamado de la juventud que se prepara para la abogacía es un deber que se cumple gustosamente; sobretodo cuando se da dentro de un contexto tan variadamente significativo como éste. La existencia centenaria de la Fraternidad Phi Alpha Delta es va, de suvo, ocasión suficiente para celebrar. En un mundo de modas pasajeras, ferias de vanidades, "deficit de atención" sobre cosas verdaderamente importantes, reconfortante comprobar que existen esfuerzos y compromisos transcienden entusiasmos momentáneos. La persistencia de esta Fraternidad, y su crecimiento, son reflejo del tesón de sus miembros y de la inspiración de sus principios rectores.

Su amplitud de miras se evidencian en la composición de sus filas, integrando en ellas todos los sectores del foro: estudiantes, profesores, abogados y jueces. De ahí su lema de servicio al estudiante, a la escuela, a la profesión y a la comunidad. Cuando se sirve bien a uno, se sirve bien a los demás. El estudiante es el profesional en ciernes, en quien descansan las esperanzas de una abogacía de verdadero servicio. La escuela o facultad de derecho es el ente formativo de ese profesional. La profesión, compuesta por los abogados activos en su ejercicio, es una de las fuerzas vivas de la sociedad. La comunidad es la razón de ser de todos nuestros desvelos, y su servicio es nuestro norte.

Que la Phi Alpha Delta además, reconozca la importancia de la cultura general, los dones del espíritu y los afanes intelectuales, más allá de los linderos de los estudios jurídicos, habla elocuentemente de lo correcto de su

visión sobre la abogacía. No basta con la cultura jurídica- no importa cuán amplia - para ser abogado. inspiración, la imaginación y la creatividad, que son elementos esenciales para la abogacía de bien, no siempre están en las páginas de una decisión judicial o en las de un tratadista. Muchas veces las encontramos en un verso, en un trozo de cuento o de una novela, en el parlamento de una pieza de dramaturgia, en la estrofa de una canción, en la contemplación de un lienzo, en la escena de una película. Allí, de pronto, nos sorprende esa verdad que andábamos buscando, quizá sin saberlo, y se ilumina nuestro entendimiento. Entonces somos mejores abogados porque somos mejores personas.

Esa sensibilidad desarrollada por el contacto con manifestaciones excelsas del espíritu se traduce en un punto de vista más a tono con las necesidades de la comunidad a la que debemos servir. No es posible, entonces, que seamos indiferentes a la destrucción del ambiente, que aceptemos el trato opresivo para ciertos grupos marginados por condiciones que les son inherentes, o que nos hagamos de la vista larga ante las violaciones de los derechos civiles de las personas intervenidas por el Estado. El corazón nos manda a que usemos la mente para ayudar a aliviar el sufrimiento de aquellos que no pueden defenderse de los embates de la vida misma o en las contiendas desiguales.

Me parece que entidades como la Phi Alpha Delta pueden contribuir grandemente a este cambio de paradigma en nuestra profesión. Hay que formar abogados que entiendan que la administración de la justicia no es batalla encarnizada ni juego en el cual se miden fuerzas o astucias. Que no se trata de manejar un proceso para sacar ventaja a favor del cliente sino de hacer cumplida justicia. Conocer bien los recursos procesales no debe llevarnos a utilizarlos en detrimento del logro de la justicia rápida y económica con la que estamos comprometidos como funcionarios del tribunal.

Tenemos, pues, que exigirnos mucho

más, no solo en el plano académico sino en todos los demás en los que nos desempeñamos. Conocer y entender el derecho es mucho más que citar de memoria el código o las reglas, o estar al día con la jurisprudencia; eso es, en el mejor de los casos, un mero punto de partida. Lo que importa verdaderamente es la capacidad de preguntarnos "¿por qué?" y "¿por qué no?"; es el cuestionamiento ponderado de la norma, el principio o el precedente. Es el rechazo de los calcos jurídicos impensados o el seguir el camino trillado del uso y la costumbre, de las soluciones hechas.

Esta Fraternidad, que hermana estudiantes, profesores y abogados en el ejercicio de la profesión, tiene la ocasión de propiciar el ejemplo de lo que debe ser la abogacía. Ese abogado joven que comienza necesita, sí, que se le enseñe "calle" o "cancha", pero no las malas mañas que muchos piensan que son necesarias para triunfar. No se trata de ser inocente o ingenuo en demasía sino de ser recto y limpio en el trato profesional. No se puede servir bien a la justicia si no se tienen el corazón y las manos limpias. La realidad de la práctica - por dura que sea - no debe convertirnos en cínicos profesionales.

Hay que conservar la ilusión y el anhelo con que nos decidimos a seguir la carrera de Derecho. Ese deseo ferviente de combatir la injusticia, ayudar al desvalido, apuntalar el regimen de libertades y reivindicar los derechos de todos, no se puede perder. Ese es el Quijote que cabalga dentro de cada uno de nosotros, los que hemos jurado dar la batalla contra los "molinos" de la vida, no importando lo desigual de la batalla.

El país necesita del talento y la integridad de sus abogados, para ayudar a la realización plena de su estado de Derecho, contribuir al adecentamiento de la vida pública, y a la reconstrucción moral de la sociedad en general. A ello los conmino.

weak evidence or a powerful "social current."

That current was flowing swiftly when William Jennings Bryan told a Tennessee jury in 1925 that it had an obligation to defend the Christian faith in the trial of John Scopes. "A bloody brutal doctrine – evolution – demands, as the rabble did nineteen hundred years ago, that He be crucified," he argued.

Johnnie Cochran rode the current, too, when he argued the jury in the 1995 O.J. Simpson double murder trial to send a message about the performance of the Los Angeles Police Department, which was widely despised in the local black community. Nine of the 12 jurors were black.

Simpson later lost a civil case over the double murder, Seidemann writes, largely because the jury profile and rule of evidence were do different.

Perhaps Seidemann's best example of prosecutors' skillfully slamming the door on the defense was a the Oklahoma City bombing trial. It hardly mattered that the case against Timothy McVeigh was largely circumstantial; he was convicted and executed.

Yet clever defense attorneys are full

of tricks. Consider how Atlanta's Jerry Froelich used a personal anecdote in the municipal corruption trial of Mack Wilbourn to splatter doubt in a case based on circumstantial evidence.

Froelich invited the jury on a trip back to his own rough-and-tumble childhood home, where he was one of five brothers. Toughest of all was his brother Brian, an ornery heavyweight wrestling champion. Larry was tough too, but no match for Brian. One night when Brian was late for dinner, Larry decided to take a chance and eat his pudding. As he was enjoying it, he heard Brian at the front door. Thinking quickly, Larry decided to arrange the family dog, Mo, a boxer, to take the fall for the crime. He rubbed the dog's face in the pudding and fled upstairs.

Concluding with a memorable line, Froelich told the jury: "Don't let Mack Wilbourn wind up like Mo."





