

"The purpose of this Fraternity shall be to form a strong bond uniting students and teachers of the law with members of the Bench and Bar in a fraternal fellowship designed to advance ideals of liberty and equal justice under law; to inspire the virtues of compassion and courage; to foster integrity and professional competence; to promote the welfare of its members; and to encourage the moral, intellectual, and cultural advancement; so that each member may enjoy a lifetime of honorable professional and public service.

Message from the International **Justice**

During the awards banquet at our 2004 Convention, I challenged each of you to RAISE THE BAR. Well, here is it one year later, and RAISE



THE BAR you did! Our law Fraternity is in the best shape we have been in a very long time - perhaps the best ever!

A quick look at our numbers tells us that we initiated 4,633 law school members (including law school students, faculty, honorary and alumni). This is a record!

We initiated 3,777 pre-law students. This is also a record! For the first time in our history, the combined total of law school initiates, faculty, honorary, alumni and pre-law members exceeded more than 8,000. This is a record total of 8,410!

Equally important as new initiates is that for the first time in more than 10 years, the number of Chapter reactivations and new Chapters chartered outnumbered the Chapters going inactive. We finished the fiscal year with an inspiring 85% of our law school Chapters active!

While numbers give us raw data, they really translate into what P.A.D. is all about. Through sustaining and growing your Chapters, you enable Service to the Student, the Law School, the Community and the Profession to be a reality. Programming last year was second to none. The sheer number and excellence of the various award applications from our law school chapters was overwhelming. Elsewhere in this issue of "The Reporter" you will see the winners in all of those categories.

The Alumni Advisory Council and the Pre-Law Advisory Council both presented comprehensive reports at our recently concluded summer key volunteers' meeting in Dallas, Texas, the site of our 2006 Convention. Both of these Councils are kicking out the sides of the box and we expect serious and substantial proposals from them for discussion and implementation before and at the 2006 Convention.

We have accomplished all of these feats through the relentless and dedicated hard work of our students, District Justices, alumni members, the International Executive Office and the International Executive Board. Along the way, as students, you are developing lasting fraternal bonds and leadership skills which will serve you well during the years to come. I extend a heartfelt THANK YOU to all of our Brothers and Sisters who are making a positive difference.

And now is the time to RAISE THE BAR even higher! You have set us on a course of distinction. Make sure you, all of your Chapter officers and as many members as

While interning in chancery court, I often thought of Dickens' *Bleak House*. In his vivid illustration of the judiciary and its players, Dickens' depiction of chancery, replete with impersonal lawyers and oppressive sluggishness, while comical, rings quite true. Family feuds erupt over the course of will contests and subsequent property disputes. When litigation spans

years, yes, sometimes the players become cartoonish, their behavior outlandish. Similarly, lawyers' constant omissions and procedural errors become jokes. On the other hand, many confident and competent attorneys embody the professionalism due, whether in a state chancery court or the U.S. Supreme Court.

P.A.D. is sponsoring its **THIRD** annual student writing competition. The purpose of the competition is to encourage and reward student-written articles in the areas of the essential aspects of a lawyer: compassion, courage, integrity and professional service. This competition is open to law school and pre-law students. Winning articles will be selected quarterly. Each winner's paper will be published in "The Reporter." The annual winner will be selected from the quarterly winners, receiving additional recognition along with a monetary award of \$1000.00.

THE SUBJECTS

Eligible articles address one of the following areas of the essential aspects of a lawyer: **Transamore** Tompassion**

3rd Integrity
4th Professional
Service

HOW TO APPLY

The piece must be written by a student member (law or pre-law.) Only one piece by a member shall be submitted in a quarter. Eligible pieces include any unpublished essay or written article prepared by the student. All pieces must be the work of an individual student. Joint works are not permitted. Pieces should be no more than 1500 words in length and be submitted in their final published form.

Entries are to be made by submitting four copies of the piece along with a completed Entry Form. The quarterly winners will be announced and published in the Phi Alpha Delta Reporter. An entry form can be downloaded from www.pad.org - click on Pre-Law or Law School Downloads.

AWARDS

The cash prize for the writing competition is \$250 per quarter. A \$1000 prize will be awarded to the best submission of the four quarters annually. In addition to the cash prize, the winning article will be published "The Reporter" and P.A.D. Website.

JUDGING

Eligible pieces will be judged on (1) quality of scholarship; (2) originality; (3) contribution to the understanding and development of the essential aspects of a lawyer, (4) analysis and reasoning; and (5) quality and clarity of writing.

All decisions of the judges, who are appointed by the International Justice and Executive Board, are final. The Fraternity reserves the right to screen entries and limit the number of papers submitted to the judges for final decision. The Fraternity also reserves the right to make no award if, in the judges' discretion, a worthy paper is not submitted.


RECORD BREAKING YEAR!



As part of the Summer Meetings, the International Executive Board announced the winner of the 2004-2005 Stan Jones District Justice of the Year Award. This year's recipient is Thomas H. Bentz (Webster).

District Justice Bentz began his career in Phi Alpha Delta as a Pre-Law member of the University of Michigan Chapter while an undergraduate student in Ann Arbor. Appoint and/or ask for members to volunteer to "chair/coordinate" the projected programs. Delegation ensures a "chapter effort."

"How To" Series...

First-year students can easily feel "lost" and "alone" during the first semester. They eagerly look for guidance and advice, especially from fellow law school peers, about what they are "supposed to be doing" to survive and succeed during the first year. An effective program strategy to get first-years out in record numbers, is for the chapters to sponsor a series of "How To" workshops that focus on the needs of first-year law students. This series should be open to anyone, without a membership requirement.

How to #1: Within the first two weeks, organize a "How to Brief" workshop, going over basics of outlining a case. Provide a few take-home examples.

How to #2: During the middle of the semester a "How to Outline" session will be a lifesaver as the first years begin to wonder what to do with all those endless notes. If your chapter has an outline bank, point out that one of the key benefits of "membership" is access to great outlines. Also, bring some examples of the various study aids that are available such as tapes,


flashcards, commercial outlines and discuss the pros and cons of them. If your chapter has a study aid library, emphasize "members" can check-out study aids.

How to #3: During early to mid November, present a "How to Take a Final" session. Provide an opportunity for students to ask questions about specific professor's finals (have several chapter members be available to field these questions). Emphasize that one of the most effective methods of study is analyzing and practicing old finals. Be prepared to advice the students on where to obtain their specific professor's old finals (have a list of the professor's who have old finals available; old finals may be online). General Tips: Ask professors to come and share their insight on what they expect on a final or brief. Target professors who teach first-year topics. Provide some sort of snack food following the sessions such as pizza. Check with representatives of the various Bar Reviews such as Micromash, Bar Bri, and PMBR or Lexis/Westlaw student associates for sponsorship of the program. These

company reps generally have an interest in gaining a high visibility with first-years, and are often willing to provide partial or total financial funding for related costs such as food.

Pre-Law "Sponsorship"

Pre-Law P.A.D.'s are key candidates for law school, and thus future potential members and leaders. You can contact the Executive Office to find out if there are any active P.A.D. Pre-Law Chapters near you. If so, make contact with the Pre-Law Advisor/ President, and offer to

"sponsor" the chapter. Sponsorship programs could range from pairing a law school chapter member with a pre-law member to serve as a "mentor," dinner/social with pre-law/law school chapter, or arranging for the Pre-Law Chapter to visit the law school/sit-in on class. General Tips: Discuss with law school administration your chapter's willingness to assist with "potential student" orientation activities such as tours/accompany visiting students to sit-in on class.

Professional Programming

Fall is on-campus interview season. Sponsor a "How to Ace Your First Interview" workshop. It is never too early to plan for your rush! Locate a few P.A.D. area alumni who would be willing to discuss what they look for during interviews. Note that one of the many benefits of P.A.D. is the extensive network of legal professionals available to members.

Communication is Key!

Effective publicity and dissemination of chapter programming events is vital. A variety of communication mediums will ensure widespread student body awareness of chapter programs.

- 1. Chapter Web-Site: A home-page is a great place to post officer contacts and program dates. Often, space is available for student organizations through the school. Also, your chapter page can be linked to the International page(email info@pad.org).
- **2. Bulletin Board:** Post officer contacts, calendar of events, photos on the board.
- 3. Chapter email/distribution lists can be utilized to send out "last minute" reminders and meeting minutes. Gather names/emails of "interested" students at programming events and add them to the distribution list. You can easily create a separate "chapter" email account/distribution list through yahoo or hotmail i.e.chaptername@yahoo.com (HarlanChapter@yahoo.com).

ATTENTION ALL STUDENTS!

My name is Byron Rupp, and I am the Director of Chapter Operations. As the fall semester begins, I'd like to talk to you about *RUSHING*. Effective rushing is crucial to maintaining membership, insuring growth, expanding programming, and discovering leadership potential.

Rushing is a year-round event! This does not mean that you need to have a rush table set up every day of the semester. However, it means that with each event, the name and image of Phi Alpha Delta is presented to potential members. Use these opportunities. Know the benefits of joining P.A.D., and talk about your chapter's events. Know why you joined P.A.D. Many times, this is the first question that a potential member may ask you.

Recruiting/information tables are one of the most effective ways to let students know of P.A.D.'s presence at your school. Most schools have an organization fair or picnic during the first few weeks of the semester. This is one of the best times to set up a rush table. Make sure that you have plenty of

materials, and members to staff the table. Have an Interested Students Sheet at the table – this will help with the collection of names, and email address so that students are contacted later regarding initiation and other chapter events.

First and foremost, recruitment should always be about personal relationships. you are doing more than finding new members you are making new friendships which will last a lifetime. Don't forget the "Rule of Five." 1. Meet them.

2. Make them your friend. 3. Introduce them to your friends. 4. Introduce them to P.A.D. 5. Invite

them to become a member of P.A.D. Most of us will practice law after school. These are the folks you will spend the next 30-40 years of your professional lives with. Wouldn't you rather network with friends than strangers?

I look forward to meeting and working with all of you. Please do not hesitate to contact me with any questions you may have. Best of luck in the upcoming year!




"SCHOOL OF ROK"

- Right of Kids by, Wendy Miller Hickman Chapter Justice

Hickman Chapter received recognition from the Houston legal community at a May 2005 banquet hosted by the Houston Young Lawyers Association. Hickman was a 2005 grant recipient from the Houston Young Lawyers Foundation. The grant of \$1,650 supported Hickman's newest lawrelated education project, School of ROK (Rights of

Kids) -

held at



UH Law campus on April 26, 2005.

"School of ROK" had thirty-nine participants from four Houston-area high schools. The event began with a greeting by UH Law's Assistant Dean Sondra Tennessee and a morning of law classes focusing on legal rights of teenagers. Topics included Juvenile Law (taught by Kiry Tuos-Southwest Juvenile Defender Center) and watching a film on "In Re Gault"; Consumer Law (taught by People's Law School Richard founder-Professor Alderman); Making the Legal Transition from Teenager to Adult (taught by Barbara Stalder, Children's Legal Services of Houston); and Decision-Making (taught by Jane's Due Process, Austin-TX).

At lunch, the high school students learned about the American Jury (materials courtesy of State Bar of Texas and American Bar Association), were "sworn-in" as jury members, and received their jury instructions. Divided into four juries, the students (with the assistance of law student "jury observers") then participated in jury deliberations covering a set fact pattern. The

jury observers played an active role in the deliberation process by "acting out" opening and closing arguments, and by helping the 'jurors' with the necessary legal concepts, such as "beyond a reasonable doubt." The day concluded with a jury quiz, a visit with UH Law's Dean Nancy Rapoport, and the awards/presentation of certificates.

The two main awards for School of ROK 2005 were Best Advocate and Best Juror. Best Advocate (based on participation in the law classes) was Alberto Gonzalez from Milby High School. Best Juror (based on the total score from jury observer scores and the jury quiz) was Elise Tobey from Memorial High School. Wendy Miller

NATIONAL YOUTH SERVICE DAY

Wendy M. Miller, Hickman Justice 2004-2005

In honor of National Youth Service Day, Hickman Chapter of Phi Alpha Delta Law Fraternity joined forces with Mikki Wagner's eighth grade class on April 15, 2005. Ms. Wagner graciously for one class period turned her class over to five law students for a lesson on family violence. From 8:30 am to 9:50 am at T.S. Grantham Academy in the Aldine Independent School District (Houston, Texas), the five Hickman volunteers presented an interactive lesson on "family violence" to thirty eighth-grader students. The program began with an 8-minute age-appropriate video, "It's Not O.K.: Let's Talk About Domestic Violence." The video (hosted by 'Boy Meets World' star Ben Savage) was produced by the American Bar Association in conjunction with Walt Disney Company and was followed by a discussion with the students using the teaching plan of Lesson Four from PAD's "Respect, Reflect, and Resolve" Anti-Violence manual for middle and high school students.

Students participating in the program with Hickman volunteers began by exploring where they stood on the issue of spanking children and learning about the surprising statistics surrounding family violence. Using examples of in-home violence, the students divided into five thoughtful groups to discuss 'why' the behavior happened. The program concluded by bringing the students back together to find 'solutions' on how the behavior could have been prevented.

As a National Youth Service Day Partner, Phi Alpha Delta International Public Service Center (Carole Collins, Director) made this event with the topic of violence prevention possible by awarding Hickman Chapter a grant of \$200 to support it. The grant was used to purchase the materials and handouts (including the ABA video), the candy "rewards" for the students, and also paid the toll expenses for the law student volunteers in their travel from the law center to the middle school. Ms. Wagner's classroom gift as a "thank you" for allowing Hickman to spend time with her students was an U.S. History-themed gift basket with items from the WB-TV program, "Liberty's Kids." In addition to books and a DVD from the TV program, the basket included an U.S. History bundle of CD-ROMs with interactive lessons and games on the entire history of the United States (from the founding fathers to the presidency of George W. Bush).

National Youth Service Day, April 15-17, 2005. National Youth Service Day is the largest service event in the world, engaging millions of young Americans and focusing national attention on the amazing leadership of young people. As a national partner of National Youth Service Day, P.A.D. Public Service Center offered the sponsorship of 25 mini-grants for Violence Prevention. 

One of the most important components of a strong P.A.D. student chapter is the alumnus advisor. Student chapters often overlook these committed P.A.D. brothers and sisters who want to serve the fraternity and profession by working with a local chapter. The alumnus advisor should be an integral part of every student chapter to help insure that the fraternity will stay strong and the benefits of membership will be available for future members.

The alumnus advisor's job is generally to support the student chapter by providing advice and assistance to the officers and chapter membership. In addition the advisor serves as a resource to aid the members in their fraternal and professional development. Alumnus advisors carry out their duties in a variety of ways. Some actively meet with the chapter officers on a periodic basis; others show their support by attending chapter events or providing logistical or financial support for activities. Still others keep in communication via phone or email and make themselves available on an as needed basis. Most alumnus advisors are very happy to respond to their chapter's needs and help in any way they can.

Student chapters often do not recognize the value and importance of the alumnus advisor. The alumnus advisor can provide a sense of history and consistency to the chapter. Student membership is transitory and as such most chapter leaders have little knowledge of

what programs and activities have worked (or not worked) in the past. Each chapter seeks to be innovative with its programming, however, the alumnus advisor's historical perspective can help the chapter leaders avoid making the same mistakes of previous programs. The alumnus advisor provides more input than "that's not how we used to do it," rather his/her legal and fraternity background and collective knowledge is a valuable reference that should be embraced by the chapter and its officers.

In addition to their broad experience, alumnus advisors can help their chapters by utilizing their contacts in the legal and business community. Law students often want local attorneys and judges to participate in or attend chapter events. In many instances it can be difficult to get through to a well-known attorney or get on a judge's schedule. This is an example of where the alumnus advisor can help facilitate the introduction or invitation on behalf of the chapter. Most practicing attorneys - especially P.A.D.'s - have an extensive network of legal community contacts that can be very useful to a student chapter. These contacts can be utilized for panel discussions, lectures, mentoring, job fairs, and almost any other programming, rush, or educational activity that the chapter may sponsor. Most good programs and projects can be enhanced by the participation and support of the legal community. The alumnus advisor is the bridge to the legal community and is thus serves an

important role in keeping the chapter strong and successful.

Through their legal experience and contacts alumnus advisors also serve a practical function. Most law students, especially third years, would like assistance finding a clerkship or a position as an associate in a law firm. Legal jobs can be very competitive, thus, the advice and assistance of a practicing attorney can be very helpful. The alumnus advisor certainly can't hire every P.A.D. member but his recommendation or referral may be the deciding factor between two otherwise equal candidates. In addition, the alumnus advisor can provide useful information to members about various types of law practice and practical advice on how to achieve one's legal career goals. Few law school organizations integrate alumnus and students together professionally and socially. Phi Alpha Delta is unique in that student chapters, when properly organized, have at least three alumnus (District Justice, Alumnus Advisor, Faculty Advisor) who have committed themselves development of the chapter and its members. How much you recognize and take advantage of this benefit is up to you.

The purpose of this article is to remind student chapters how important the alumnus advisor is to the strength and success of your chapter. Alumnus advisors are P.A.D. members who want to strengthen the fraternity and their profession by helping the student members develop the professional, leadership, and legal skills necessary to be responsible members of the legal profession. They have made the commitment to you and are available as a steady resource to your chapter. If you don't have at least one (you can have more than one) alumnus advisor then approach your District Justice and begin the process of having one appointed for you. You, your chapter, and the fraternity will benefit from your decision.

The Goods and Services Tax or the "GST" as known to most Australians will have been in operation for five years in July of 2005. Taxation laws in Australia form one of the most complex systems in the world. It was hoped that through the introduction of a Goods and Services Tax of 10%, this would alleviate the inconsistent tax laws that were in place prior to the reforms, which not only contained too many loop holes, but favoured the wealthier classes. However, the process of change has been far from smooth or, in many cases, welcomed by all sectors from consumers to businesses and political spheres. Following the passing of the A New Tax System (Goods and Services Tax Transition) Act 1999. The new system came into operation on the 1st July 2000. Some of the most problematic realities of implementing the scheme was in the retail industry, in which there were 'exceptions' for items to be sold that were classified as 'items of necessity'. These merchandise included all raw foods, uncooked meat, female hygiene products and soap. One of the media frenzies that resulted from this classification system was the "cooked chicken" debate. The process of cooking

and storing the chicken (or any other food product for that matter) attracted the GST because it was at an additional cost to the business to provide the service of preparing an item that could have otherwise been undertaken by the consumer. So in the end, for the sake of what often amounted to a difference of only a couple of cents, businesses were forced to spend thousands converting not only their accounting databases and records, but also on additional wages for employees to re-price all items on the shelves by the magic moment when the new laws came into force. Larger companies hired temporary staff during this time to work all night "graveyard" shifts as they raced against the clock. Unfortunately this was only the beginning of the GST Jitters to follow...

According to Robert Richards who is a specialist in revenue and associated corporate law in Australia, lawyers are now in favourable position to effectively administer the GST because it is a transaction based tax. There are still doubts as to whether a supply is GST free or not, and there are on going issues involving one-off transactions. These create unique difficulties because it is the

supplier of goods or services who is liable for any GST, and they are also the vendors. Hence if that supplier does not recover the GST from the recipient at the time of supply, they may never recover the GST. Further, if this agreement ignores GST, the supply will be deemed 'GST free' automatically according to law. Sometimes an indemnity is made by the recipient of the goods or services, which essentially amounts to a promise to pay GST where if it is determined to be applicable. However indemnities are notoriously unreliable and often a financial risk. There are some avenues of recourse for suppliers despite the difficulties associated with enforcing indemnity assurances. For example a supplier may draft and submit a 'ruling request' form to the Australian Taxation Office according to the Taxation Administration Act. Following a successful lodgement, a ruling by the Tax Office will be made. The Tax Office has the authority to issue Public rulings and determinations or private rulings. These are distinct from each other in the sense that public are intended to have a general application and private rulings result from requests made by individuals. All rulings are published and available on line for reference. The review process is not strictly regulated and there are no set guidelines for review of requests for GST determinations or rulings. It is accepted that the Office is given the discretion to scrutinise submissions by people specialised in the taxation field to a greater extent than unassisted members of the public.

This is not an efficient process for this reasons coupled by the fact that the Taxation Office is under no obligation to issue a ruling within a specified time and it cannot be forced to make a speedy finding according to the Act s14ZAO. Requests on the progress can only be made every three months. Finally, the last sting in the tail is the fact that any determination regarding a GST matter that is made by the Tax Office will not be binding on the office as other Taxation decisions (for example Income Tax). In effect this means that rulings can only be relied upon to the extent of the accuracy contained within the information supplied to the department. This is subject to assessment at any time in the future. Note also that the Office is not bound by any oral advice offered by its employees, and applicants cannot rely upon such advice. (Principle does not apply across the board, advice on other Taxes can be)

A recent court case involving assessment of GST concerned tax payers that are large multi-national companies including International Lease Finance Corporation Incorporated (American jet aircraft owners), two of its wholly owned subsidiaries and Australian airline leasing company. The NSW Supreme Court dismissed proceedings by these four companies who sought declaratory relief in respect of their liabilities under the GST Act. As a result of restructuring lease agreements, the complex transactions between the companies attracted a large GST which prompted

the Commissioner to serve notices of assessment under s22 of the Taxation Administration Act 1953 and a declaration under s165-40 of the GST Act. This effected increased the net amount in specified tax period to approximately \$AU70 million dollars payable. The taxpayers opposed this claiming it had been a tentative assessment to which the court held that the evaluations were conclusive, the Commission had provided signed copies of the assessment notices and conducted their investigations in accordance with the legislative requirements. There was no scope for residual arguments with respect to which figures and sums should have been utilised. In conclusion, this represents a very strong stance taken by the courts to rigidly enforce the GST scheme

This article has touched briefly upon some of the social and legal dilemmas associated with the Australian Goods and Services Tax. It is important to realise that this is simplification of the issues in one area that exists within a vast array of tax laws that are as complex as they are numerous. 
Does your major really matter? That is the question I am asked repeatedly each year by applicants trying to decide the next step on their paths to law school. College is a time to bend and stretch your mind in a variety of new directions. Your degree should give you the opportunity to explore the breadth and depth of what your university has to offer. Fortunately, you can build the essential skills to law school success in almost any major.

A lawyer must be able to think analytically and logically. He or she must possess strong oral and written communication skills, as well as superior researching abilities. There are innumerable combinations of major and electives courses that can help build these skills. Your major will provide your educational foundation, and by carefully selecting electives, you can supplement any areas of deficiency presented by your major. For example, a student majoring in Music could still be headed down the road to law school, as long as he or she compliments that major with courses that will teach and hone the skills relevant to success in law school.

Taking courses that require you to think analytically and logically will not only help prepare you for law school, but can also help prepare you for the LSAT. After all, it is your analytical and logical reasoning, reading comprehension, and writing skills which are being tested.

Admission committees are looking for academic rigor in your undergraduate course of study, irrespective of your major. After all, law school is an academically challenging endeavor and we want to know that you are capable of performing at a high level in the classroom. Admission committees do not expect or require you to have taken any law related courses prior to entering law school. Moreover, law schools value diversity in the broadest sense of the term, and diversity of thought and educational background are keys to enrolling a talented pool of students. So, to all those who ask "Is there one major that is my ticket to law school?" the answer is no.

Undoubtedly, some majors are more common among law school applicants than others. Political Science is generally considered to be the most logical path to law school. But majoring in Political Science will not necessarily render you more prepared than students with other majors; it can, however, be helpful in evaluating your tolerance for intensive reading and writing and your desire to pursue law as a career. Upper division courses in subjects such as English, history or philosophy will also require you to



research and write about a variety of issues, honing the competency needed in law school.

Many of us forget lawyers also serve as counselors and that the legal profession is in many ways a "healing" profession. Majors such as psychology, sociology or other social sciences can give you insight into human nature, behavior and issues impacting our society. In turn, this knowledge will allow you to better relate to, and serve, your future clients.

Students majoring in business or economics will develop an understanding of the corporate world and the specific needs of the companies and organizations they serve should they later pursue a career in corporate or business law.

You should remember that the majors listed in this article represent only the tip of the iceberg of law student educational backgrounds. For example, there were 57 different majors represented in this year's entering class at my school. Our students hold degrees from Art History to zoology.

Should you decide to pursue a unique or lesser known program of study that may be unfamiliar to admission committees, you should provide course descriptions or other academic information that the committee can review in evaluating your transcript. Be sure to highlight those courses that required proficiency in utilizing skills relevant to law school.

You should choose a major based on your interests and not your desire to attend law school. It is clear to admission committees when an applicant has chosen



EVALUATING LAW SCHOOLS:

THE ROLE OF RANKINGS By, Tracy Simmons and Aaron N. Taylor

We rank everything: hotels, cameras, restaurants, football teams, etc. Rankings are commonplace in our society because they provide a readily accessed and seemingly readily understood evaluation of worth or quality. In higher education, specifically legal education, rankings are used to rate everything from tuition to employment rates, library volumes to bar pass rates, and so on. Some are humorous. Some use complex formulas to derive their data. Seek and you shall find. Rankings are everywhere.

Law school rankings are big business. They sell magazines. They increase traffic on websites. Applicants embrace them because they purport to do the "work" for them. Some schools even embrace them (at least when the news is good). Rankings can be sources of helpful information; but too many applicants rely on rankings to determine the best law school for them. Because of this, the two major law school-related organizationsthe American Bar Association (ABA) and the Law School Admission Council (LSAC)—have made it their policies to caution applicants against over-reliance on rankings.

The ABA, the principal law school accrediting body, frowns on law school rankings. The organization states that "no rating of law schools beyond the simple statement of their accreditation status is...advocated by the official organizations in legal education." Further, the ABA states that "qualities that make one kind of school good for one student may not be as important to another...." The organization implores prospective students to "consider a variety of factors in making their choice among approved schools."

The LSAC levies even harsher criticism upon law school rankings. In a letter, endorsed by 181 law school deans, discussing the shortcomings of

commercial rankings, the LSAC states that "these ranking systems are inherently flawed because none of them can take your special needs and circumstances into account when comparing law schools." The letter states further that measuring law schools by the same yardstick "ignores the qualities that make you and the law schools unique, and is unworthy of being an important influence on the choice you are about to make."


There is a common criticism of law school rankings in both of these assessments: rankings fail to account for the unique qualities of applicants and law schools. This major, even fatal, flaw of law school rankings makes their value dubious and over-reliance on them unwise. In this article, we hope to provide a guide to the proper usage of law school rankings and give you tips on performing comprehensive research into the nation's law schools.

What role should rankings play in evaluating schools?

The answer to this question is simple: a limited one. For starters, rankings are incapable of measuring actual quality of law programs. Rankings have some use, however, in measuring perceived quality; thus, as they relate to reputation, rankings can be one of many factors you consider. But do not rely too heavily on rankings, even in this limited manner. The inherent "relativity" of reputations and perceptions render rankings unfit as primary selection tools. Besides, your decision of where to apply and where to attend law school should go far beyond reputations. Thus, your research should go far beyond rankings. The particular factors that you find most important will reflect your individual situation—a reality for which rankings are unable to accommodate.

How should I evaluate schools?

If you were to use Google to search the term "law school," you would get over one hundred million hits. Needless to say, this is more information than you could ever utilize. The sheer volume of information out there overwhelms many



prospective law students. This phenomenon probably best explains the popularity of rankings; their orderly manner of presenting information is welcomed relief for applicants suffering from "information overload". But unfortunately, the only way that you are going to gain the information you need about schools is through in-depth research—immersing yourself in the "sea" of information. This type of research is time-consuming and at times unpleasant; but it is necessary.

Prior to beginning your research you should make a list of factors and qualities in a law school that are important to you. These factors will obviously be based on your own desires; but in compiling your list you should also seek the advice of other knowledgeable people, particularly current law students or recent law school grads. You could benefit from their ability to utilize hindsight and experience in helping you determine what qualities are important. At this stage, most of your factors will be general in nature, becoming more specific as you acquire more information. Do not be afraid to alter, add, or subtract factors.

Once you are satisfied with your initial list, you should begin to research schools. Using your list in this early phase of your research will help prevent you from becoming overwhelmed because you will know what you are looking for and will be able to distinguish important information from unimportant. Be sure to utilize an array of sources, both primary and secondary. Contact individual schools, perform internet searches, read magazines like this one, and purchase guides such as the ABA-LSAC Official Guide to ABA-Approved Law Schools. There are countless resources

available to you that are easy to obtain, and most of them are free.

Of course, the initial purpose of your list will be to help you determine where to apply, and the general factors filling your list should be effective in performing that task. But when it comes time to decide where to attend, your factors should become more specific and thorough in nature. For example, if one of your goals is to attend a school on the cutting-edge of academic technology, you should now begin to research and compare the particular technologies in use at schools from which you are choosing. Or if cost is a major factor, you should not only assess specific grant opportunities in the first year, but also in the second and third years.

At this stage, you should also judge schools based on both tangible and intangibles factors. The tangible factors are obvious—tuition, diversity, course selection, GPA/LSAT medians, location, scholarship opportunities, etc. But the intangibles can be just as important. What feeling do you get when you interact with members of the school community? Is admission office staff helpful, pleasant, etc.? If you have visited a school, did the environment seem supportive and collegial? Or did everyone seem to be on edge and unfriendly? Do not ignore your "sixth sense," it can prove valuable.

So as you navigate the admission process, your list should be your trusted guide. Be particularly mindful of glaring contrasts between the schools on your list. If you notice that your list is made up of a low-tuition public school, known for its public interest focus as well as a high-tuition private school, known for its corporate focus, make sure that there is a rational reason for this contrast.


One last word about rankings

Different lists employ different methods for assigning ranks. Therefore, when utilizing a ranking list be sure to pay close attention to its research methodology. At a minimum, you should be aware of the factors that are measured and the weight assigned to each factor. You should

also take note of inherent biases (smaller schools vs. larger schools, older schools vs. newer schools, etc.) created by different methodologies. You should assess the compatibility between factors that are important to you and factors deemed important by the compilers of the list. Taking the time to develop this type of thorough understanding of the rankings might defeat the purpose of having such a "neat and tidy" list before you, but it is the only way to truly place them in the proper context.

Good luck in your research. Law school will be a wonderful journey. Empower yourself with the information you need to choose the best school for you. 


Pre-Law Chapters Set New Rushing Record!

So you should consider all of your options before choosing your major, and once you have done so, be certain that your particular program of study is adequate preparation for what faces you in law school. No matter what major you choose, it is important that you engage in a wellrounded course of study and strive to do your best by giving your studies the utmost attention.

the pre-law members and should make for much more e f i c i e n t communication.

Verlaine Walker and Michael Harnden have been spearheading another project aimed at improving the services we provide in our mock trial programs. Under their guidance, PLAC is looking to provide PAD with recommendations on issues such as (1) whether to expand or alter the programs to include or switch to similar aspects such as moot court competitions or opening and closing statement competitions, (2) how to finance an expansion of the programs, and (3) how to improve the general quality of the programs. As you can imagine, the scope of this project is enormous and Verlaine and Mike are looking for help in this undertaking. Anyone interested in contributing to this project (or any of our tasks) is asked to e-mail me at jerwin@erwinlawfirm.com and I will forward their information accordingly.

Over the past several months, I personally have been dedicated to developing a more self-sustaining infrastructure for the pre-law membership. Many of you may not be aware of this, but you belong to the fastest growing segment of PAD and within the next year, we may well be initiating over 5,000 new pre-law members each year. As the membership continues to grow, we remain dedicated to ensuring that each of you has the opportunity to maximize the quality of your experiences with PAD. For that reason, we are working on creating a separate staff and volunteer support framework and a new set of services and programs exclusively for pre-law students. I am excited about some of the concepts we are working on and am certain that your chapters will soon be able to benefit from our work as you will be able to offer greater recruiting incentives and more tools to keep your members involved and active in your chapter activities.



All recruiting tips are for BOTH law and Pre-Law Chapters. A reminder that alcohol is prohibited at all Pre-Law events. For a copy of the Alcohol and Hazing Policy, visit www.pad.org.

Have Questions about Recruiting?

1. Can we hold more than one initiation per year?

ABSOLUTELY! Each chapter is required to hold at least one initiation per semester! In the fall, every chapter should hold their first fall initiation within six weeks from the first day of school. In the spring, each chapter should hold their first initiation within four weeks from the first day of the semester.

Some chapters hold six, seven or even eight initiations each year! Chapter officers should schedule a second or third initiation as soon as they receive applications. A person is not a member, and cannot receive all the benefits of membership, until they have been through the initiation ceremony.

2. How do we rush new members?

Publicity – Publicize early and often! Use a publicity committee. Distribute a chapter calendar to members and interested students. Use in-class announcements, notes on classroom chalkboards, notes on the P.A.D. bulletin board, email blasts and flyers in individuals' mailboxes.

3. What if no one wants to join or nobody's interested?

Make sure that your chapter holds events that will benefit its members academically, personally and professionally! The Executive Office guarantees that every chapter can develop and implement programs that will aid in the chapters recruiting effort by being unique, successful and most importantly, will be beneficial to the student body.

4. Recruiting - Importance?

Ask the students who have indicated their interest in P.A.D. to join! The number one reason that individuals do not join an organization or fraternity is because NO ONE ASKED THEM! Use personalized invitations and phone calls to connect with potential members.

5. You've initiated 'em now what?

Assign them to committees! A members' interest in P.A.D. is typically at one of its highest points when they join P.A.D. If your chapter does not utilize a committee system, now is the time to implement one. A committee system allows a chapter to hold a full and diverse calendar of events while reducing the amount of work each individual contributes as well.

The bar and bench face many obstacles in the area of legal professionalism. A primary problem is preventing unprofessional behavior from pervading professional service. Much analysis and commentary suggest that we must remedy these ills from the ground up, plant the seeds for professionalism early, in law school.

In its 1986 report, the American Bar Association asserted that because the law school provides the student's first exposure to the profession, schools should adhere to the highest standards of ethics and professionalism. An additional ABA report contends that in order for a professional group to create a positive identity grounded in professionalism,

[I]t must not only claim as its own a special body of learning and skills ... but it must also embrace a core body of values which sets members of the profession apart and justifies their claim to an exclusive right to engage in the profession's activities.2

Professionalism, asserts the report, lies in strict adherence to this core body of values.3

Although many reports of the ABA Commission on Professionalism declare that lawyers' efforts to comply with professionalism rules are on the rise, I fear that the trend in lawyers' actual professional service may well be in a precipitous decline. While I hope that these negative statistics are inaccurate, in my recent experience in chancery court, I believe that this trend does in fact exist, and is dangerous.

Competency.

Dickens accurately summarizes chancery's climate. Two key components foster what can lend to a derisive atmosphere: (1) the subject matter and (2) the attitudes of attorneys appearing before the chancellor.

Chancery is a court of equity. The majority of proceedings before a chancellor constitute "small time" disputes: will contests, heirship determinations, divorces, and custody battles.

However, these proceedings do not feel small to the parties involved. Rather, as Dickens illustrates, such matters often become larger than life

Attorneys who engage in primarily chancery practice tend to show more deference to the court. Many of these attorneys contribute to the positivism and professionalism which compliment and uphold the integrity of all courts.

Frequently, lawyers who spend most of their time in circuit court or federal court make a circus of chancery. They are not necessarily despicable creatures or even bad lawyers. Many are simply not used to handling chancery matters. When a criminal defense lawyer handles of a divorce for an indigent friend of a friend, the situation is ripe for error. Whether the case is a viable source of revenue or whether it's what he or she "does," is irrelevant. Model Rule of Professional Conduct 1.1 states as follows:

"A lawyer shall provide competent representation to a client. Competent representation requires the legal knowledge, skill, thoroughness and preparation reasonably necessary for the representation."

When an attorney appears before the chancellor equipped with less than the nominal requirements, it detracts from the court's integrity, disrespects the chancellor, and inhibits professional service to clients.

Usually, these attorneys are extremely polite to the chancellor, making frequent requests of the court's indulgence. A chancellor who gently but firmly reminds counsel of her professional responsibility of competence (regardless of her "regular" work) usually observes improved courtroom performance.

Yet some lawyers who spend most of their careers in chancery contribute to the perception of the downward spiral of professional service. Despite 25 or 30 years of practice, they may forget their duty to clients, court, and the profession. One lawyer scratched his head and asked:

"Judge, what's the statutory percentage for support for three children?"

"Counsel, you've been practicing for twenty-six years. You should know that portion of the code as well as I do."

(Laughing) "Well, yes, Your Honor, I know. But, what is that figure again...?"

Most law students could probably quote the statutory guidelines for calculating support in their state. Those who do not know the guidelines could easily remedy their unfamiliarity. This common problem does not connote professional service; rather, it weakens the integrity of the profession. Even the most capable attorneys demean the court and our profession by not being prepared or allowing arrogance to inhibit professional service.

We all lose.

Clients bear the cost of poor professional service. If ill-prepared counsel performs poorly, clients suffer. Many petitioners and respondents are undergoing major life changes: divorcing a spouse, seeking custody of a child. Clients may be working second and third jobs to pay attorney's fees. Thus, when counsel does not prepare for the case with due care or when he disparages his client, parties lose from all angles:

Father filed petition for modification of decree and citation for contempt. Mother cross-complained, alleging use of alcohol and cigarettes in the presence of the child, a violation of the decree, She also complains that Father's 12 by 30 foot cabin is unsuitable for visitation. Father works fifty-five hours per week and has arranged his work schedule to devote entire weekends to his son. Father's counsel refers to his client's home as "the shack you live in" and the "dump that you call home." Father responds to counsel's questions:





"Sir, I was unaware that that there decree said that I couldn't have those things in the house."

"Are you literate, sir?" Counsel demanded sharply. "Yes, sir."

"Can you read and write?" "Yes, sir." "Then why didn't you follow the decree?"

"As soon as I realized, sir, I disposed of all alcohol and cigarettes. I want to see my boy. I don't need those things. I just want to spend time with my son. He's all that matters."

In a few thoughtless maneuvers an attorney can devastate lives, *while* accepting undeserved fees from cash-strapped clients. In order to raise the bar we must elevate our expectations. Unless we adhere to them, we reduce the Model Rules to a meaningless void of aspirational ideals.

What We're Certifying as True.

"I hereby certify that I know the foregoing information to be true and correct to the best of my knowledge." Then we sign our names, which should mean something:

"How long have the parents been separated?"

"Don't know, Your Honor."

"Your pleadings say that they've been separated since January. Why's that?

"I don't know exactly when it was, Your Honor. I just threw that date in to get the complaint filed."

"Why don't you know the date?"

"My client didn't tell me. I didn't ask her."

"When you sign your name to a document and file it with the court, you are swearing that to the best of your knowledge, it is a true and correct statement ... the court takes that pretty seriously."

"I know, I know, Judge. I was just trying to get it filed. I'll amend it, but the *point is* ...

The point is mistakes are inevitable. But many are avoidable. Blatant laziness does not minimize that risk. Clearly, the canons we commit to memory and the oaths we take to uphold our commitment to professional service are worth something.

Only we can sustain that value.

I look forward to great things from our Fraternity this coming academic year and know that you will continue to RAISE THE BAR for all of us!




