

Incidental Advantages of Fraternal Meetings

By J. F. T. O'CONNOR ::: Professor, Yale University

It is a pleasure to respond to the editor's invitation to write an article on the incidental advantages of fraternity meetings. Four factors largely contribute to the success of any local college fraternity meeting; first, an energetic fraternal spirit; secondly, a carefully thought out set of by-laws; thirdly, the enforcement of those laws; fourthly, adherence to parliamentary practice.

As any or more of these factors are minimized, the efficiency and beneficial results of the local organization will be impaired. An energetic fraternal spirit is one constantly alert, one unmindful of the sacrifices and the inconveniences, necessary in all organized bodies, holding one ultimate goal in view; namely, to purify the stream of college thought, and to make college associations a source of strength rather than a source of weakness in after life.

It is just as necessary that the chapters have a carefully thought out set of by-laws, as it is for the mason to have a trowel, the carpenter a hammer, and the builder proper plans and specifications. These will vary with local conditions, but they should embody the general and particular rules of conduct to which members are subjected, not defined by the constitution. They will be more exhaustive and minute if the members live in a chapter house, than if only meeting rooms are maintained. Once adopted the by-laws and rules should be enforced. Never allow a by-law to become inoperative, rather repeal it, if found inexpedient. General Grant said: "If you have a poor law enforce it; the people will do the rest." The fearless and impartial enforcement of bylaws will create and maintain respect for the rules and order of the chapter. When this rule is firmly established each member will cheerfully submit to fines and penalties imposed when rules are thoughtlessly broken. An energetic, fraternal spirit, carefully prepared by-laws, and the fearless enforcement of them are sufficient factors to make a meeting successful, but add to these an adherence to parliamentary rules, and greater benefits will accrue. Some of the benefits to be derived from the last point are: economizing time, a premium on propositions clearly stated; minimizing friction and ill feeling; finally affording an invaluable training for those who expect to participate in conventions and other deliberative bodies.

The first attempt to transact business in conformity with parliamentary law will, generally speaking, be disheartening. Business may suffer. The same objection was found to each new rule in arithmetic

also to each new formula in physics, but when the rules and formulas were mastered considerable time was saved. In presenting a case for trial a certain procedure is necessary. A lawyer may slip through without adhering to the rules, but such indulgence often brings regret and defeat. Every day we witness some excellent emotions lost in conventions, or other meetings because not properly made. When a member realizes that he can speak but once on a motion, unless all have spoken who desire, or no objection is raised, that member will find it highly expedient to have his thoughts logically arranged. This will also prevent two members from answering each other which frequently causes a discussion on personalities to be substituted for the point in issue.

This enforcement of parliamentary law is predicated on a good fraternal spirit. It is one thing to know throughly parliamentary law it is another thing to use that knowledge to block legislation. These tactics are on a par with the lawyer who constantly seeks to win his cases on technicalities. In our fraternity meetings if a motion is improperly made, a member knowing the proper motion should ask leave to state it. Even if the motion when properly made is contrary to the member's opinion making the correction. This attitude is indicative of the big man who is fearless and fair, to set right his opponent. The justification of this is that in a fraternity meeting it is generally useless to gain a point, pass a by-law, resolution or anything else by means of parliamentary sagacity for the sentiment of the fraternity will not be crystalized in the by-laws, or resolution and hence it will be a dead letter.

College fraternities have, in a measure, displaced local literary and debating clubs. This is unfortunate. The fraternity, however, can give its members many of the advantages of a debating club, without impairing its work. If all the members will take an active part in the business meetings aiming to state their position clearly, definitely, convincingly; and, at banquets those honored by being called upon, do likewise, much of what the debating clubs contributed can be saved.

Our fraternity, dear to every one of us, can be no stronger that the weakest link. In our fraternity meetings the strength and weakness of a man are at once apparent. This is true in all such organizations. The clear, cool headed, gentlemanly member, will not only gain respect and confidence, attract admiration, win the plaudits of his opponents, but he will be of immeasurable value to the local organization. We grow strong in giving. If any one factor has made Phi Alpha Delta, internally, the strongest fraternity in existence, it is the spirit of subverting the individual's ambition to the good of all the members. A healthy spirit, high ideals, culture emphasised, progression rather than retrogression, a sincere study of law because it is a dignified profession and when mastered, a means to make humanity better—these ideas associated with and interwoven in the name of Phi Alpha Delta have made her shrine a worthy place of worship—a fountain at which men may drink and become strong.

A Red Letter Day

Saturday, February 25, was a red letter day in the history of Phi Alpha Delta. The installation of Corliss, the new chapter at the law school of the University of North Dakota and the joint banquet of five Chicago chapters at the Sherman house on that date are events that will long be remembered by Phi Alpha Delts who participated in either of them.

While the ceremonies incident to the installation of the new chapter at North Dakota were informal they were carried out to the letter, and the local club is now a full-fledged working section of the country's biggest legal brotherhoods.

Edward J. Fleming, first supreme vice justice, and Horace Guffin, of Kansas City, Missouri, members of the Benton chapter of Phi Alpha Delta there, together with Albert J. Lobb, of the Ryan chapter of Madison, Wisconsin, at present history teacher in the Grand Forks high school, conducted the ceremonies, which began at 6 o'clock and lasted until 8:30, when the members gathered at the Hotel Dacotah and enjoyed a sumptuous banquet and an excellent program of toasts.

After the completion of the ceremonies and regular installation work the banquet was held at the Hotel Dacotah. This feature of the installation, while it came last, was by no means the least, for it served to bring the members of the fraternity into closer touch with the faculty of the law school and with President McVey, who was present and responded to a toast. Besides the members of the club and President McVey, the following guests were present: Dean A. A. Bruce, who acted as toastmaster; Prof. L. E. Birdzell, Attorney H. A. Bronson, Prof. Chas. E. Carpenter, and Attorney B. G. Skulason. In addition to these the fraternity men who conducted the installation, Messrs. Fleming, Lobb and Guffin were also present.

Among his literary honors may be mentioned the Virginia Colonial Dames' prize for best essay on a colonial subject.

Ryan Chapter men who found favor at the hands of the voters last November include Paul R. Newcomb of Pepin, Wis., William W. Storms,


of Racine, Wis., and Charles E. Briere of Grand Rapids, Wis., all of whom were elected district attorneys of their respective counties.

Ryan Chapter suffered its first death loss when Peter Henry Schram passed away at his home in Madison, Wis., December 14. His health had failed rapidly for several months, and after a hurried trip to the south in an effort to bring about an improvement through change in climate, he was brought back to Madison at the point of death. He was 28 years of age.

Brother Schram, affectionately known to several generations of Wisconsin students as "Pete," graduated from the University of Wisconsin in 1906 with nearly all the honors that it is possible for one man to receive. He was a member of Phi Beta Kappa and Phi Alpha Tau honorary fraternities, Iron Cross senior honorary society, Philomathia literary society, and a number of lesser organizations. His success as a debater and orator was brilliant. He was closer of the joint debate of his senior year, and in the same year represented Wisconsin in the intercollegiate debate with Michigan. His literary ability was prominently exhibited in his work on the "Cardinal," the university daily, of which he became managing editor, and also in the 1906 "Badger," the junior annual, of which he was general chairman.

His career since graduation from the university gave great promise of a successful life. After a year of newspaper reporting, Brother Schram became a statistical clerk for the Railroad Commission of Wisconsin, in which capacity he rendered increasingly valuable service to the state. Entering into the politics of his home city, he became alderman from the fifth ward, the university section of Madison, and held this office until his death. He was also a member of the board of education and president of the associated charities. In addition, he was the moving spirit in a number of associations and clubs.

Brother Schram's career as an active member of Phi Alpha Delta fraternity was short, as he did not finish the law school, but his subsequent interest in the fraternity was most pronounced. Despite his extremely numerous duties, he found time to be present at initiations and other social events of Ryan Chapter, and lent valuable assistance to the chapter in many ways. Withal, he was a man whom it was a pleasure to know, a man whose character and talents made him a worthy model for the men of the fraternity. Ryan Chapter is vastly the better for having had Brother Schram in its membership.



EDITORIALS

MEETINGS OF THE SUPREME EXECUTIVE BOARD The executive board of the fraternity was in session December 31, 1910, and on January 1, 1911, at the Hotel La Salle, Chicago. These meetings will go on record as the most successful, from every point of view, in the history of Phi Alpha Delta. Every member of the supreme board, excepting only Supreme Historian Edward Meier, were present. The

board very much regretted "the old head's" absence, but as he was out of the city on a holiday jaunt, it was unavoidable.

Those present were: Supreme Justice, "Jack" Carmody, Washington, D. C.; First Supreme Vice Justice, Ed. Fleming, Kansas City, Mo.; Supreme Recorder, Ed. Hess, Chicago; Supreme Treasurer, Frank Adams, Bloomington, Ill.; Supreme Financial Secretary, James McKeag, Chicago, and ye editor-in-chief.

This exceptional attendance of the board, as the Supreme Justice remarked on opening the first session, indicates that Phi Alpha Delta "has cast off its swaddling clothes and is now a real grown-up."

The board acted favorably upon the petitions of two organizations at representative institutions of legal learning, that were presented for consideration. Four other chapters were considered and it seemed the board was favorably inclined toward their admission when a proper application would be presented.

An alumni key, to be worn on a watch fob or as a charm, is to be a novelty in Phi Alpha Delta jewelry. The Chief Justice appointed a committee to submit a design. This form of emblem is deemed more desirable by alumni than the pin.

Other routine business was disposed of and the fraternity's financial condition was again pro and coned.

Supreme Recorder Hess was complimented by every member of the board, not only on the systematic and efficient manner in which he has been discharging the duties of his office, but also upon the neat and complete records of the fraternity he has prepared.

The meeting also brought to light that our Supreme Treasurer, "Mac," had only recently embarked upon the sea of matrimony, as said "Mac" was wont to put it, and hearty congratulations and a "bon voyage" were extended him by his fellow members on the board.

NOTICE TO CHAPTERS

Heretofore chapters have been in the habit of remitting to Supreme Financial Secretary McKeag by check covering the price for pins and money due the Supreme Board. This practise should be discon-

tinued. When McKeag buys the pins for a chapter he does so as a courtesy. The Supreme Board is not in the business of purchasing pins. This is none of its business. While McKeag does not object to buying the pins in the least, the trouble is that his check is made in an amount covering both items and so he cannot send it direct to the Supreme Treasurer as he should. The Supreme Board requests that hereafter the items of pins and dues will not, at least, be placed on a single check.

Glancing through the chapter letters one will notice that a prominent item common to the younger chapters is that telling of preparations for the building of fraternity houses, to be owned by the chapters. This

sounds good to the ear of every loyal P. A. D. everywhere.

After the December issue of the Quarterly was off the press printed solicitations for subscriptions were sent to all alumni whose names appeared in the directory. The address as given in the directory was used. The response to this call was as decided, as it was a discouraging, sur-

prise. Not one tenth of the alumni responded. The burden of the magazine is now, in the greatest measure, on the students in school. Considering that the magazine is of equal interest to alumni, their support should be accorded. The only way to get their support which now seems feasible is through the chapters. WILLIAM E. LUNDGREN



IN MEMORIAM

WILLIAM E. LUNDGREN, an alumni member of Joseph Story Chapter and First Assistant State's Attorney of Cook County, Illinois, died of pneumonia at Seattle, Washington, on March the 8th, 1911, after an illness of

about four days, while on an official business trip.

Brother Lundgren was born in Chicago on July 12th, 1878. He secured his early education in the Chicago Public Schools, later taking up the study of law in the offices of John W. Smith and John J. Knickerbocker. His legal education was completed at the Illinois College of Law, Chicago, receiving there his LL. B. degree with the Class of 1899 and graduating with honors, though the youngest member of his class, lacking at the time of graduation some weeks of his majority.

He was admitted to the Illinois Bar in the fall of the same year and immediately entered upon the practice of his profession in which he continued with success until the election of his office associate, Mr. Wayman, to the State's Attorneyship, wh n at the earnest solicitation of the latter, he accepted the position which he filled with honor and credit to himself and the office until death called him. During the absence from the city, of Mr. Wayman,

Mr. Lundgren was Acting State's Attorney.

In speaking of Mr. Lundgren's death, Mr. Wayman said: "The death of William Lundgren is an inexpressible shock to this office and to me personally. The state has lost a most loyal servant and a young man of exceptional promise. He was the noblest young man I ever knew and we are all in gloom and grief over his death."

Besides his membership in Phi Alpha Deita, Brother Lundgren also belonged to Edgewater Lodge, A. F. & A. M., the Edgewater Country Club, the

Royal Arcanum and was a member of the Chicago Bar Association.

Brother Lundgren left his widowed mother, Mrs. Johanna S. Lundgren, his brother Ralph E. and his sisters, Alica A. and Lydia L. Lundgren, surviving him.

The Chicago Chapters took appropriate action when advised of his death and many of the Chicago members of the fraternity attended his funeral. Services were held at his residence, 5354 Wayne Avenue, and Masonic services were also conducted at the cemetery chapel. All the courts in the Criminal Court Building were closed and the judges attended the funeral in a body. The following assistant State's Attorneys acted as pall-bearers: Roy Fairbanks, Claude V. Smith, Robert Crowe, Victor P. Arnold, William Feindt and George Guenther. He was interred at Rosehill Cemetery, March 13th, 1911.

William E. Lundgren, honored as he has been by his fellow citizens and beloved by those most intimately acquainted with him ever held the highest rank in the respect and admiration of his associates. His gentle disposition, his noble and many qualities, his earnest attachment and devotion to his friends, his watchful care over those entrusted to his keeping through the early demise of his father, and his utterly unselfish nature, won for him

IN MEMORIAM

WILLIAM E. LUNDGREN, an alumni member of Joseph Story Chapter and First Assistant State's Attorney of Cook County, Illinois, died of pneumonia at Seattle, Washington, on March the 8th, 1911, after an illness of

about four days, while on an official business trip.

Brother Lundgren was born in Chicago on July 12th, 1878. He secured his early education in the Chicago Public Schools, later taking up the study of law in the offices of John W. Smith and John J. Knickerbocker. His legal education was completed at the Illinois College of Law, Chicago, receiving there his LL. B. degree with the Class of 1899 and graduating with honors, though the youngest member of his class, lacking at the time of graduation some weeks of his majority.

He was admitted to the Illinois Bar in the fall of the same year and immediately entered upon the practice of his profession in which he continued with success until the election of his office associate, Mr. Wayman, to the State's Attorneyship, wh n at the earnest solicitation of the latter, he accepted the position which he filled with honor and credit to himself and the office until death called him. During the absence from the city, of Mr. Wayman,

Mr. Lundgren was Acting State's Attorney.

In speaking of Mr. Lundgren's death, Mr. Wayman said: "The death of William Lundgren is an inexpressible shock to this office and to me personally. The state has lost a most loyal servant and a young man of exceptional promise. He was the noblest young man I ever knew and we are all in gloom and grief over his death.'

Besides his membership in Phi Alpha Deita, Brother Lundgren also belonged to Edgewater Lodge, A. F. & A. M., the Edgewater Country Club, the Royal Arcanum and was a member of the Chicago Bar Association.

Brother Lundgren left his widowed mother, Mrs. Johanna S. Lundgren, his brother Ralph E. and his sisters, Alica A. and Lydia L. Lundgren, surviving him.

The Chicago Chapters took appropriate action when advised of his death and many of the Chicago members of the fraternity attended his funeral. Services were held at his residence, 5354 Wayne Avenue, and Masonic services were also conducted at the cemetery chapel. All the courts in the Criminal Court Building were closed and the judges attended the funeral in a body. The following assistant State's Attorneys acted as pall-bearers: Roy Fairbanks, Claude V. Smith, Robert Crowe, Victor P. Arnold, William Feindt and George Guenther. He was interred at Rosehill Cemetery, March 13th, 1911.

William E. Lundgren, honored as he has been by his fellow citizens and beloved by those most intimately acquainted with him ever held the highest rank in the respect and admiration of his associates. His gentle disposition, his noble and many qualities, his earnest attachment and devotion to his friends, his watchful care over those entrusted to his keeping through the early demise of his father, and his utterly unselfish nature, won for him
