

All have come into the fold but recently.

Ross Chapter at Southern California was installed Saturday evening, March 27th, under the direction of Brother Henry R. Saltmarsh, of Portland, Oregon, member of the Board of Tribunes of the fraternity.

The ceremonies incident to the installation were conducted without any detractions and reflected considerable credit upon those in charge.

After the installation an elaborate banquet was held and a wholesome display of good fellowship and some entertaining toasts by the masters of the ceremonies and the new Phi Alpha Delts were in evidence. Ross Chapter promises great things for the order.

Preparations For The Convention

The Convention Arrangements Committee, consisting of Brothers Geo. E. Fink, Charles L. Daly and Edward J. Hess, appointed by the Supreme Executive Board at its last meeting, reports that considerable has been done toward making the coming Convention the finest in every respect that the Fraternity has ever held.

This General Committee has appointed subcommittees on Publicity, Reception, Entertainment and Banquet, all of which are meeting at least once per week. A special effort is being made to get out the older members of the fraternity, and some of the most prominent men in the fraternity in days gone by have accepted places on these sub-committees and are found working hard with the younger men. The first general meeting called numbered among those present three past Supreme Justices and four past supreme officers and interesting meetings are held of the sub-committeemen each Monday evening at De Jonghe's Restaurant. The Publicity Committee has arranged to send invitations to the Banquet to every member within a radius of seventy-five miles of Chicago.

The sub-committee on Banquet, headed by Bro. Wm. P. J. Halley, has arranged to hold the banquet at the new Hotel La Salle, where the business sessions of the Convention and luncheons will also be held. A suitable room has also been reserved as general headquarters for the delegates where they may meet and get acquainted and secure information and keep in touch with everything pertaining to the Convention.

Every delegate will be met at his train by members of the Reception Committee and taken to Headquarters. It is requested that delegates should, if possible, advise the General Chairman, Geo. E. Fink, by letter if possible, when his train is due to arrive in Chicago and over what line, in order that members of the Reception Committee may be assigned to meet them. If this can not be done by letter, it should be done by wire, and messages sent collect. Bro. Fink may be addressed at 203 Chamber of Commerce, Chicago, prior to Friday, June 23rd, and on Friday and Saturday, June 23rd and 24th, at La Salle Hotel, La Salle and Madison streets, Chicago.

The Entertainment Committee has planned to charter a boat for a trip out into Lake Michiganand back Friday night, June 23rd, a trip to one of the amusement parks Sunday afternoon, June 25th, and an old fashioned P. A. D. outing Saturday and Sunday, July 1 and 2, the expenses of which will be borne by the Chicago Alumni Chapter.

It is also requested that incoming delegates provide themselves with the fraternity colors and pin same to coat lapel before leaving train to permit of ready identification by members of Reception Committee assigned to them, and the Reception Committeemen will be so badged as to be readily distinguishable by any member of the fraternity.

Chapters Responding

RYAN CHAPTER

Ryan Chapter has had the good fortune, since the last letter was written, to install into honorary membership Hon. A. J. Vinje, Associate Justice of the Wisconsin Supreme Court, and Hon. John H. Roemer, Chairman of the Railroad Commission of Wisconsin. Judge Vinje is a graduate of the University of Wisconsin, having taken his law degree here in 1887. For fourteen years before his appointment to the supreme bench to fill a vacancy, he was circuit judge at Superior, Wis. He was elected for the full term upon the Supreme Court in the recent spring election.

Mr. Roemer was a well known member of the Milwaukee bar before his appointment to the Railroad Commission in 1907. He graduated from Yale Law School in 1892, and made a specialty of insurance practice in Milwaukee. He is a member of Alpha Sigma Phi and Phi Beta Kappa fraternities.

Another triumph of Ryan Chapter was registered in the field of university politics, when William H. Spohn, senior in the college of letters and science and junior in the law school, was elected president of the senior class for the present semester, defeating the captain of the varsity baseball team by a substantial majority. Brother Spohn is the third successive P. A. D. to hold the senior presidency, the example having been set by Brother Ryan Duffy last year and Brother Gustave Buchen the year before.

Brother Jimmie McDonald, law '13, has just been elected to the joint debate team of the Hesperia literary society for next year. The joint debate is the time-honored forensic event of the year at Wisconsin. Brother McDonald also represented Wisconsin on the wrestling team, in the conference gym meet at Chicago in April.

Ryan Chapter has drawn first blood in the battle for new men, by pledging George E. Cleary for next year. Cleary has just been elected to Phi Beta Kappa, and is going to make a mighty good P. A. D. Our annual spring smoker, which will be held May 16, is expected to result in a number of other pledges.

Brother William J. Hagenah, '05, who has been employed as special expert by the Chicago city council to arrange a schedule of rates for the Chicago Gas Company, has submitted a 150-page report to the council,

recommending 77-cent gas for that city. The report goes into detail upon matters of valuation of property and income account. He previously conducted a similar investigation of the Chicago Telephone Company.

Myron T. Harshaw, '12, was initiated into Ryan Chapter in April. Brother Harshaw entered the law school from Beloit College, and is a member of Kappa Sigma.

Brother Fred Esch, '11, has been highly honored by the law faculty in being selected to represent the law school as commencement orator next June.

Now for the convention!

HAMLIN CHAPTER

Since our last message of good cheer Hamlin Chapter has been exceedingly fortunate in some respects and very unfortunate in others. The chapter roll has been increased, class offices have been monopolized by Phi Alpha Delta men and the high rank men of the various classes have been wearers of the purple and old gold. To support our contention let us cite the case of Charles B. Hosmer, who is, by the way, one of our delegates to the national convention. Mr. Hosmer, although not having completed his full course at the school had sufficient courage and energy to take the Maine Bar examinations in February, the result being that he was the recipient of the highest mark ever given in the state by the bar examiners, a rank of ninety-three and one-third. This illustration suffices to show the kind of men that Hannibal Hamlin Chapter possesses.

On the other hand the Phi Alpha Delta house was totally destroyed by the terrible conflagration that swept over the Queen City on Sunday, April 30th. Not only did the P. A. D. house succumb to the flames but the College of Law also fell an easy prey to its inroads so that on Monday, May 1st, the greater majority of P. A. D. boys arose to find themselves schoolless and homeless, a hard situation to face. The men worked like demons while the fire was raging around the house, many of them risking their lives in a hopeless endeavor to save not only their own personal effects, but also the fraternity property. It was wonderful to see and note the spirit shown that night; not one of them gave even a thought to what he had, or what he might have, until the assurance came that the charter, the seal and the records had been snatched from the flames. When it was seen that nothing further could be done to protect or preserve our property the boys went to work to assist other people in the neighborhood who were in dire straits and then rendered valiant and efficient work to such an extent that many of them have since received messages of gratitude from people whom they aided.

Prompt action was taken by the faculty at the instigation of the Phi Alpha Delta men composing the student body. Brother Gould ,in a remarkable outburst of eloquence, convinced the faculty that the only thing to do under the circumstances in view of the fact that many of the man had lost practically their entire belongings, would be to suspend the work of the college, award the seniors their degrees and start a movement toward the erection of the finest law school building in the country The different members of the faculty, considering that there was no law school in which to hold recitations, soon saw the logic of Bro. Gould's remarks and his plan was accordingly adopted. A committee was ap-

pointed of which Bro. Gould is the chairman, and also the brains, to provide for the erection of a new building, the cost of which will undoubtedly be in the vicinity of one hundred thousand dollars, a sum which was in the judgment of the committee deemed sufficient to erect a structure second to none.

Now, although the fraternity has received a set back, it is not going to yield to adverse circumstances. Phi Alpha Delta in Bangor will be housed and quartered in better shape than before and if any visiting brothers are so fortunate as to arrive in town next fall they will be both surprised and astonished at our celerity in re-establishing ourselves. We were well covered by insurance and while each and every individual member of the fraternity has sustained a loss, yet all are united on the proposition that the fraternity as a whole shall not suffer as a result.

The delegates from Hamlin Chapter to the convention are Bros. Charles B. Hosmer and Daniel I. Gould. Bro. Gould is a Lieutenant in Co. G., N. G. S. M., and was in command of the company at the time of the fire doing exceptional work protecting the lives and property of the citizens.

GUNTER CHAPTER

The Supreme Executive Board convened at the Hotel La Salle, Chicago, Saturday, April 29th. Present: Supreme Justice Carmody, First Supreme Vice Justice Fleming, Supreme Recorder Hess, Supreme Treasurer Adams, Supreme Financial Secretary McKeag and the editor-in-chief. Absent: Supreme

Historian Meier. Regular routine matters having been disposed of the Board proceeded to the matter of arranging for the Twelfth annual convention of the fraternity. The Supreme Justice appointed a committee to take the matter in charge and the spirit of the meeting was that the next convention be not only a memorable event for Phi Alpha Delta but for Chicago fraternalism, in general. During the meeting Brothers Roberts, Fink and Daly "dropped in" and let the Board know that they were still as enthusiastic as ever in the greatest legal fraternity in the world. Much of the work the Board accomplished will appear in other pages of this number.

SUPPLEMENT POSTPONED

This number concludes Volume 4 of the Quarterly. It was originally intended that this number should TO DIRECTORY contain a supplement to the Directory, but, as it is impossible for the Supreme Recorder to have the names of all new members in time for this issue,

because of the congestion of work that accumulates in his office just before convention time, and because many chapters have failed to turn in a list of their new members, in toto, rather than have a supplement that was not complete it was decided to defer the matter until after the convention when a supplement could be made not only inclusive of all new members but further revised as to old members.

AN APPRECIATION

There comes a time when every speaker must say "thanking you for your kind attention," or something to that length,—and it is quite as true of an editor-in-chief. The editor acknowledges

THE WANING ADMINISTRA-

As the voice of the Supreme Board the Quarterly hesitates in saying anything about the administration that has almost completed its service. Some noted essayist, other than Emerson, says

that "a man may, with propriety, speak of his achievements, not by way of boast or self satisfaction, but in justification." And so the editor, without any collusion with the rest of the Board and understanding that the consequences will be visited on him, takes occasion to call to the brother reader's attention the progress of Phi Alpha Delta in 1910-1911. It has been a big stride,—the variety that retains for Phi Alpha Delta the title of "the greatest legal fraternity in the world." Four new chapters have come into the fold, and with them eighteen carat material. Surely the administration and Phi Alpha Delta, everywhere, have accomplished all that could be expected of them, and a great deal more.

TO HAMLIN CHAPTER

The sympathy of the entire order is extended to Hamlin Chapter in the loss of their chapter house in the great fire that swept Bangor, Maine, recently. The ability to meet and withstand a misfortune of

this character is indicative not only of a high fraternal enthusiasm, but much individual sacrifice: it is a test of strength.

THE STANDARD OIL MONOPOLY CASE

The recent decree in the case of the United States vs. The Standard Oil Co., et. als. by the Supreme Court of the United States, declaring the defendants guilty of a com-

bination in restraint of trade under the first and second sections of the Sherman Anti-Trust Act, has elicited comment from all legal periodicals. While it is uniformly conceded that the ultimate decision properly visits the penalty of dissolution on the defendants, the case being the monument that it is, is unfortunately grounded on questionable theory. The position of Justice Harlin in dissenting from the grounds upon which the decision is reached, (though concurring in the decision itself,) has been favorably regarded by many enlightened jurists and practitioners. That every contract no matter whether "unreasonable" or "undue," is in positive violation of the Sherman act seems to be the logical legal construction. Otherwise, as Justice Harlan maintains, the Supreme Court legislates in that it reads into the act the above elements of being "undue" and "unreasonable," rather than following the evident meaning of the

when it says, "Every contract, combination in the form of trust, or otherwise, or conspiracy in restraint of trade or commerce, among the several states, or with foreign nations, is hereby declared to be illegal." Nothing in the act suggests the qualification made by the majority of the Court. As the decision, though doubtful from the standpoint of substantial legal theary, is in accord with justice and fair public sentiment the excellent test that is suggested by the majority should be incorporated into a new and more explicit trust act.

WHEN A GRANTOR COURTS THE MUSES.

It is said that the following unique transfer is of record in Book 40 of Deeds at page 215, in the office of the recorder of Cass County, Illinois. Mr. Shaw, who wrote the deed was a talented lawyer and died while serving in the Illinois legislature.

I, J. Henry Shaw, the grantor herein,

Who lives at Beardstown, Cass County, within,

For seven hundred dollars to me paid today

To Charles E. Waymann, do sell and convey

Lot two (2) in block forty (40) said county and town Where the Illinois river flows placidly down,

And warranty the title forever and aye,

Waiving homestead and mansion, to both a good-bye,

And pledging this deed is valid in law,

I add here my signature, J. Henry Shaw.

(Seal.)

Dated, July 25, 1881.

I, Sylvester Emmons, who lives in Beardstown,

A Justice of Peace of fame and renown,

Of the County of Cass and Illinois state,

Do certify here that on this same date,

One J. Henry Shaw to me did make known, That the deed above and name were his own,

And he stated he sealed and delivered the same

Voluntarily, freely, and never would claim

His homestead therein; but left all alone,

Turned his face to the street and his back to his home.

(Seal.) Date August 1, 1881. S. Emmons, J. P.

Shaw at the time of the above was a widower and without kith or kin alive. The deed appears to effectually convey the title and is believed to be without precedent or sequence, in form.

The object of the conference is to consider what action the various fraternities will take with reference to the Dodds Bill in the matter of

postal rates.

IN THE HOUSE OF REPRESENTATIVES.

April 11, 1911.

Mr. Dodds introduced the following bill; which was referred to the Committee on the Post Office and Post Roads and ordered to be printed.

A BILL

To admit to the mails as second-class matter periodical publications issued by or under the auspices of benevolent and fraternal societies and orders and institutions of learning or by trades-unions, and for other purposes.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That from and after the passage of this Act all periodical publications issued from a known place of publication at stated intervals, and as frequently as four times a year, by or under the auspices of a benevolent or fraternal society or order organized under the lodge system and having a bona fide membership of not less than one thousand persons, or by a regularly incorporated institution of learning, or by a regularly established State institution of learning supported in whole or in part by public taxation, or by or under the auspices of a trades-union, and all publications of strictly professional, literary, historical, or scientific societies, including the bulletins issued by State boards of health, shall be admitted to the mails as second-class matter, and the postage thereon shall be the same as on other second-class matter, and such periodical publications, issued by benevolent or fraternal societies or orders, trades-unions, strictly professional, literary, historical, or scientific societies, shall have the right to carry advertising matter, whether such matter pertains to such benevolent or fraternal societies or orders. trades-unions, strictly profesional, literary, historical, or scientific societies, or to other persons, institutions, or concerns; but such periodical publications, hereby permitted to carry advertising matter, must not be designed or published primarily for advertising purposes, and shall be originated and published to further their own objects and purposes, respectively; and all such periodicals shall be formed of printed paper sheets, without board, cloth, leather, or other substantial binding, such as distinguished printed books for preservation from periodical publications: *Provided*, That the circulation through the mails of periodical publications issued by benevolent or fraternal societies or orders, or by trades-unions, strictly professional, literary, historical, or scientific societies as second-class matter shall be limited to copies mailed to members, exchanges, and bona fide subscribers, together with ten per centum of such circulation in addition as sample copies: *Provided further*, That the office of publication of any such periodical publication shall be fixed by the association or body by which it is published, or by its executive board, and such publication shall be printed at such place and entered at the nearest post office thereto."

It was the spirit of the meeting that every member of the respective orders write to his Congressman, urging him to vote for the bill, stating the exact facts about their respective magazines.

Accordingly it is suggested that every Phi Alpha Delta write a letter to his Congressman substantially as follows:

Washington, D. C.

Dear Sir:-

As a member of your district and a member of the Phi Alpha Delta Law Fraternity I am greatly interested in the passage of the "Dodds" bill H. R. 3792. The fraternity publishes a Quarterly magazine, solely in the interests of its members and the legal profession, not for the benefit of any particular person or as a means of getting advertisers. We have very few advertisements, not enough in any way to pay the expenses of the publication. The magazine is supported by the members of the fraternity. The deficit is paid by the Supreme Board of the fraternity.

If the Postmaster General's scheme prevails it will put us out of business as we cannot afford to pay the great increase of postage. The Dodds bill will prevent us having to close down.

CONVENTION COMMITTEE MEETS.

In The Greek World

Chapters from eight schools were admitted to membership in the Delta Sigma Rho fraternity at its convention at Fisk hall, Evanston yesterday morning. The main purpose of the convention was to revise the constitution, but the question of admitting certain colleges was taken up and voted upon. The schools which are newly admitted are Cornell university, Leland Stanford university, Albion college, Carleton college of Minnesota, Knox college of Galesburg, Ill.; North Dakota university, Ewarthmore college, and Western Reserve university. Allegheny college, Amherst, Colgate, Coe, Drake university, and the University of Tennessee were refused admission because their general rating is lower than the standard desired by the fraternity.

The following is from a Chicago paper of recent date:

"Declaring that the Phi Beta Kappa, the oldest Greek letter fraternity in the country, tends to the creation of an intellectual aristocracy, and is undemocratic in form, tastes and tendency, John Gutknecht, the twenty-one-year-old son of Godfrey Gutknecht, a contractor living at 2835 Warren avenue, has refused the honor of becoming a member of the fraternity, which is said to be the highest compliment that can be paid a student.

Young Gutknecht is a member of the graduating class at the University of Michigan, and has won, among other things, the Chicago Alumni Medal for oratory and the Kaufman testimonial \$100 prize for oratory. By refusing to accept membership in the fraternity Gutknecht and his chum, Louis P. Heller, of Omaha, Neb., who has also declined a "bid" has set a precedent."

The action of the two students elicited considerable comment from the press from coast to coast, lauding the action of the "precedent makers." Without entering into the motive that prompted the attitude, it would seem that the long list of members, including some of the most distinguished men of the day and the past, who have had the opportunity to decline the recognition, would indicate to the press that the precedent is one, rather for cheap eccentricity, than sound discretion.


