

Francis Michael Gorman

Francis Michael Gorman, junior member of the prominent legal firm of Roettinger & Gorman, of Cincinnati, is one of the leading members of the bar of Hamilton County, with which he has been identified for a number of years. Mr. Gorman was born September 4, 1857, in Cincinnati, and is a son of William and Nora (Nestor) Gorman, both of whom were born in County Galway, Ireland.

Judge Gorman was reared on his father's farm in Sycamore township, Hamilton County, Ohio, preparing for college in the local schools, and becoming a student at the National Normal University at Lebanon at a later date. There he graduated with credit in 1878 and began to teach school and study the law. His preparation for the Cincinnati Law School was made under the careful tutelage of the late Timothy Danielson Lincoln. After his graduation in 1884 Judge Gorman practiced his profession alone for two years and then entered into a partnership with Charles M. Thompson, under the firm style of Gorman & Thompson. This association continued until September 1, 1902, when the firm dissolved by mutual consent of the parties. Both partners were for years concerned, either together or individually in much of the city's litigation.

Judge Gorman has shown much legal ability as solicitor for numerous villages, the affairs of Reading, St. Bernard, Lockland, Elmwood Place, and Arlington Heights being in his hands for a number of years. He has also been prominent in political circles and in 1887 was a Democratic candidate for county solicitor, and in 1903 was the candidate of the same party for judge of the Court of Common Pleas. He is regarded as one of the most able advocates as well as the safest counsellors among the exceptionally brilliant and able men who represent the bar at Cincinnati. He is well known among those citizens who have proved themselves solicitous for the welfare of the city and deserves, as he receives, the respect and esteem of the public.

On June 14, 1887, Judge Gorman was married to Lillian Herancourt, a member of a prominent family of Cincinnati, and they have one daughter, Helen, and two sons, Harold and Robert. The pleasant and attractive home is located in Hartwell, where Judge Gorman delights to show hospitality to his many friends.

In the year 1909 he was elevated to the bench of the Common Pleas Court of Hamilton County, Ohio, and during the three years of his four year term has proved his wonderful abilities as a jurist.

The Injustice of Court Delays And A Remedy

By the Honorable Frank M. Gorman, Judge of the Court of Common Pleas, Cincinnatti, Ohio.

The administration of justice in Ohio and Hamilton County and without question throughout the entire country occupies twice as much time as it should. Judges waste too much time upon technicalities and courts now in existence could very well be abolished if immediate legislation remedying these defects was commenced. Courts set aside criminal convictions and reverse civil verdicts on mere technical grounds, regardless of whether substantial justice has been done and I summarize my opinion of the courts first in that "speedy justice" is a myth in Ohio in particular and throughout the country generally, under present conditions; secondly in that public criticism generally of the courts and their procedure is well deserved; and thirdly the average citizen is not financially able to reach the public service corporations in damage suits, but is often forced to compromise claims for small amounts because of the uncertainty of obtaining justice in the courts.

Under present conditions the time consumed for an ordinary jury case to reach final determination in the State Supreme Court is from five to seven years, according to Hamilton County records. In some counties even longer than that is required. In some instances however, for special statutory reasons, some classes of cases may reach determination in a somewhat shorter time. In Hamilton County, at the present time it takes from one to two years to get a jury trial in the Common Pleas Court. In the Circuit Court no hearing can ordinarily be had in less than a year to eighteen months, and in the Supreme Court from two to two and a half years. This is entirely too long for the ordinary man to wait for the determination of a cause whether he be a business man involved in business litigation or a citizen involved in a dispute with a public service corporation.

Lawyers can assist in hastening justice, and archaic laws could be made to suit modern conditions without trampling on Constitutional rights. The time for the trial of a case could be shortened one-half to one-third by giving the trial Judge more power in determining what evidence should be admitted or rejected. This would limit the introduction of cumulative evidence and eliminate immaterial testimony which so often burdens the court records.

The time devoted to the trial of a case could be shortened if the trial Judge were really learned in the law and could pass on the admission


and exclusion of evidence without being required to listen to lengthy arguments from lawyers.

Judges should be paid a salary commensurate with their work and ability. Judges hearing jury cases under present conditions are underpaid. The business of the court should be so arranged that the Judges could be on the bench at least five hours a day. Many and nearly all, now are not engaged on the bench more than half this time.

I favor such reforms as the reductions of the time for getting a case at issue on the pleadings, from eight weeks as required at present, to four weeks; reduction of the time for appeal on error from the Common Pleas to the Circuit Court from four months to two months; reduction of the time for appeal from the Circuit to the Supreme Court from four to two months; reduction of the time required to argue and prepare a case in the Supreme Court from eight to four months; reduction of time allowed for printing briefs and records; and lastly a verdict by a majority or three-fourths of a jury in civil cases.

In the criminal branch of the law, too much stress is laid on technicalities and more so than in any other branch of the law. Too much time is wasted in the qualification of jurors. The crucial test of a juror in the matter of qualification should be "Is he fair, is he honest and intelligent and will he bring in a verdict in accordance with the evidence and the law? The reversal of criminal convictions because T's are not crossed or I's dotted, should not be considered by the trial court or the reviewing court.

I also suggest proper amendments and legislation governing the class of cases which may come up from Justice Courts as by such means unnecessary litigation could be thwarted at the threshhold of the law.



Big Men

An Impromptu Address by J. J. Tobias, LL. B., Ph. D., Chancellor of the Chicago Law School, Webster Chapter, Twelfth Convention Banquet, Phi Alpha Delta.

Mr. Toastmaster, Supreme Justice, Associate Justices, and Brothers, I consider it an honor to be called upon to address this select coterie of men on this occasion.

I send greetings to President James of the Illinois State University from where you, Mr. Toastmaster, hail. Judge Moran and myself were born down in "Egypt," I at Vandalia, the first capitol of the state. Having "grown up like Topsy," in Illinois, I feel at home here and welcome you strangers to our soil and hospitality.

I see in the letters of our fraternity, Phi Alpha Delta, the circle and the triangle, symbols of completeness and hard work; symbols of your ethical completeness, intellectual completeness, or intellecutal, legal equipment for the tremendous hard work for eminence which awaits each of you. The emotional in the human mind is always pleased with climaxes and anti-climaxes, and so the circle and the triangle at the same time suggest the sublime and the common place. My sainted sire travelled the circuit with Stephen A. Douglass, Peter Cartwright and Abraham Lincoln in this state sixty years ago as a Methodist preacher. At stated times he held love feasts; truly, this assembly is a love feast, a feast of legal reason and a flow of poetic soul in which all are noe, with the exception of a few variations. "Variety is the spice of life." We have here the bachelor county judge who compels delinquent, evasive lawyers to come into court and try their cases; we have the learned lawyer and judge with the natural judicial temperament; we have here the silver tongued orator, the eloquent, cultured and popular supreme justice; the flowery man from Yale, and others as eloquent. What an inspiration to you, brothers, to become big men.

The elder Pitt once dictated a message in a rather apolegetic manner to be sent to the premier of France, who was threatening war against England. The message was too diplomatic for the younger Pitt, who fired up, saying: "Make the message big English." You, brothers, are of the stuff to become big Americans. Using a nautical illustration: British dreadnaughts lose 20% of guns in action, French lose 38% of guns in action, while the United States dreadnaughts have all guns in action. In the science of applied jurisprudence, without the loss of any force, have all your guns in action.

Some years ago it was my privilege to be in conference with President Adams of the University of Wisconsin. The suggestion was made that no senior should receive any honors at commencement who had not

averaged 90% in his studies on a scale of 100. I am glad to know this has been the requirement for candidacy to our membership, to know the secrets of the archives of this fraternity. I now appeal to you, as delegates of this convention, to hold yourselves high, let no ordinary man take our sacred obligation. Let your ultimate choice be, "I will be a big American." This is your destiny, for you are already picked men. You recall how surprised you were when the membership committee called on you? You were a picked man then; henceforth let there be no more surprises for you; make good; you know you have it in you. Lead on. conquer, possess, rule in righteous, mighty power. This is your destiny; the statesmanship of the law, the statesmanship of political science. Why this delay for speedy trial and the cry for justice, the constitutional right of every citizen. Why so much graft and political corruption in our country? Why this confusion and delay at present in Congress? There are too few big Americans with a right conscience in the United States Senate. There are too many small politicians at the bar, in Congress, on the bench. Again I ask you, what is your destiny?

Hark back to the trial of Socrates. Who was there? Plato, the statesman; Crito, his friend, with stronger love than Damon for Pythias, or Jonothan for David; Alcibiades, the golden mouthed oracle, whose oratory won him the appellation of Socrates, "who in conversation is the conqueror of all mankind, and this not only once but always." There was Agathon, the lawyer. After that famous trial conducted by men of great erudition, but biased, Socrates asked these friends to be with him in prison at his death. "What is this outcry." said he, "I have forbidden women to be here, yet you sniffle worse than women. Be men!" Crito replied, "There are persons who at great loss are willing to save you and bring you out of prison, and so for the court or jury, you may say that they are far from being exhorbitant. My means which are ample are at your service. Here is Simias, the Theban, who has brought a great sum of money, Cebes, and many others are willing to spend their money." Then a matchless argument followed. Hear the words of the great philosopher-statesman: "I am to play truant, and when the laws and the government interrogate me, tell us Socrates, they say, are you by an act of yours to overcome us, the laws and the state? Do you imagine a state can subsist in which the decisions of law have no power, through the administration of weak men. For seventy years you have been with us and made covenants. My friends, you have nothing to say in answer? Then let us follow the arguments and covenants of law and be true to the state and follow the intimations of the will of God."

This voice has come to you through the ages—"Be men." Now, like the voice of the flute; now, like the voice of the spheres; now, like the still, small voice that Elijah heard at Sinai, "Be men!" The people are calling for statesmen with profound knowledge of constitutional law and administrative political science. The vastness of our territory and its resources demand big men. You, picked men, must be judges of our circuit and supreme courts; you must be statesmen, state-attorneys, gover-

nors, majors, congressmen and presidents. Who calls you? The people! Who can stop you?

May this occur, as in the great painting, The Award of Goethe, while angels are showering roses upon his head for his greatness, devils are endeavoring to drag him down, the very petals dropping from the brow of Goethe, falling upo nthose devils, become liquid tongues of consuming fire, the expression of the wrath of all good souls. May this come to your enemies, while the plaudits of the American people are showered upon you for great acts in the judicial and legislative departments of our government. President Taft being a member of our fraternity, let the presidents of the United States for the next hundred years come from our ranks. Then will begin Christ's thousand years reign of righteousness.

Thus has been the sun rising of your professional life, like the star of the nativity leading wise men to shrines of glory and power. With the renowned Emerson, one day at high twelve I was standing at the south end of Goat Island at Niagara Falls, when ancient Helios with his golden car was, as it seemed, but ten feet above the horizon, impelling, crowding, rushing onward and forward, yet ever according to law, those seething, irresistable waters towards the rapids. On, on, to the placid bosoms of the Great Lakes. So you will guide men in the meridian splendor of your professional greatness. When the sable curtains of night are falling, and your eventide of life has come, then your sun-setting will be as between the alabaster pillars of the Golden Gate, in the fleecy whiteness of the mist, reflecting myriads of crowning glories in colors sublime. So the richly earned plaudits of men, of angels and almighty God will voice in great glory and harmony, "Come up higher; you are the best of men."

ITINERARY OF SUPREME JUSTICE CARMODY

As already announced in the Quarterly Justice Carmody, will officially visit a number of the western chapters. He started from Washington, D. C., on March 1st, to visit the chapters in the following states: California, Oregon, Colorado, Kansas, Missouri, Illinois and Ohio, having previously visited Taft Chapter at Georgetown, Rapallo at New York and Calhoun at Yale.

This trip will have, without doubt, a greater influence in uniting the various chapters than any other factor could have. The conventions are attended by delegates only, but Supreme Justice Carmody takes this effective means to reach all active and alumni members. Owing to the many miles this trip will cover it is not possible for the Quarterly to give an exact schedule even at this date, but the various chapters will be advised in advance. Each chapter should hail our respected leader with all genuine Phi Alpha Delta fraternalism and should be prepared to receive from him exemplifications of the ritual of "the greatest legal fraternity in the world."

The History of Phi Alpha Delta

(PART TWO)

At the end of the first year Phi Alpha Delta was established as Lambda Epsilon could never have hoped to be. Many of the former members were not invited to join the new fraternity. Everything was harmony and enthusiasm, and there was present only a desire to do that which would be for the best interests of the organization, for already it was felt that, rightly managed and properly organized, here was the beginning of a professional fraternity that would in time take its place as first.

The first National Council realized that after it had established chapters in the law schools of Chicago, its most important work was to give the fraternity a good constitution, one which would give every chapter a voice in the government of Phi Alpha Delta, so after John Marshal Chapter was admitted the National Council applied to drafting a constitution that would have some chance of being adopted at the next convention.

The fourth convention was held at Pistakee Bay, Fox Lake Station, Illinois, and to it was referred the task of providing the fraternity with a form of government that would permit a natural and healthy extension as contemplated by the articles of organization. The convention, unable to finish the work in the time at its disposal, appointed Brothers John A. Brown, Robert E. O'Brien, Charles L. Daly, Lewis C. Garver and Paul C. Meier a committee to revise the constitution and report at an adjourned meeting of the convention to be held at Chicago.

Pending the report of the Constitution Revision Committee, the National Council deferred election of National Officers, and organized by electing John C. Witt, Acting Chief Justice, and Paul C. Meier, Acting Recorder.

The Constitutional Revision Committee held many meetings during the fall of 1903, and it was late in the year when the fourth convention was again called to order, this time in the Northwestern University Building, Clark and Lake Streets, Chicago, where the recommendations of the Committee were gone over section by section, and a constitution finally adopted.

After this constitution had been adopted the National Council permanently organized by electing the following National Officers: William C. Healion, Chief Justice, Paul C. Meier, Vice Chief Justice, Hugo

L. Pitte, Recorder, Robert E. O'Brien, National Financial Secretary, and August H. Schroth, National Treasurer. The other members of the National Council were John C. Witt, Charles L. Daly, Julius R. Klein, Thomas P. Octigan, and Lewis C. Garver.

It was during this administration that the first chapters not in Chicago were organized, Ryan Chapter at the University of Wisconsin, March 11th, 1904, with charter members as follows:

and Magruder Chapter at the University of Illinois, also on March 11th, 1904, with the following petitioners:

These chapters were installed in Chicago, the occasion being made a gala one, concluding with a banquet at Kinsley's where Brother G. G. Schmitt of Marshall Chapter was presented with a jeweled Phi Alpha Delta watch fob, the first made, in recognition of his work in organizing Ryan Chapter, Brother Schmitt later did excellent work in interesting students at the University of Michigan, and also had no small share in the organization of Williams Chapter. An effort was made to secure a Chapter at the University of Michigan, but without success. It was during this administration also, that much work was done in the way of securing information that might lead to the installing of chapters at the greater universities, and at the next convention, being the fifth, seven chapters were represented.

At the fifth convention the constitution was again changed, and the National Council was abolished, the National Officers being elected by the annual convention. The National Officers were elected, being Waldemar C. Wehe, Chief Justice; George M. Clendenin, Vice Chief Justice; Lewis C. Garver, Recorder; Charles L. Daly, National Financial Secretary; August H. Schroth, National Treasurer. Brother Schroth resigned the office of National Treasurer in December 1904, and Paul C. Meier was appointed by the Chief Justice to act as National Treasurer until the next convention.

With the assistance of Brother G. G. Schmitt of Marshall Chapter, another effort was made to establish a chapter at the University of Michigan, this time with success, and James V. Campbell Chapter was installed on November 11th, 1905, with seven charter members.

making eight chapters represented at the next convention.

The sixth convention was held in Chicago, at the Northwestern University Building, on July 21st, 1905, and for the first time in the history of the Fraternity there was no revision of the constitution, there being only a few unimportant amendments. The officers elected by this convention were: Paul C. Meier, Chief Justice; Paul W. Boehm, Vice Chief Justice; Thomas P. Octigan, Recorder; Edward L. McConaughty, National Financial Secretary; and Charles E. Varley, National Treasurer, who held office for eight months only, the constitution having been so changed that thereafter the terms of the National Officers should begin on June 1st. August H. Garland Chapter at the University of Arkansas was organized by this administration, and installed at Little Rock, Arkansas, on April 28th, 1906, with eight charter members.

And on June 16th, 1906, the same officers with the assistance of Brother Eugene Lippincott of Marshall Chapter, who rendered valuable assistance in the work of organizing, installed John Hay Chapter at Western Reserve University at Cleveland, Ohio, with five charter members:

Paul DeShaw Knight Walter H. Cook Cleaveland R. Cross Jos. I. Eagleson Willis R. Godfrey

The organization of Hay and Garland Chapters was far from the home of the Fraternity, and the expense of organizing and installing the chapters necessitated the greatest expenditure of money the Fraternity had known up to that time, so that it was greatly in need of funds, and it became necessary fortheNational Officers to use influence in order to secure half rate tickets when installing new chapters, thereby saving the Fraternity Treasury.

At the Seventh Convention held at the Sherman House in Chicago on May 5th, 1906, the subject of a Fraternity magazine was again brought forward, and the Chief Justice, as ex officio chairman of the convention, appointed Brothers Charles H. Wilber, Richard J. Finnegan and W. Crown Smith, a Board of Editors to establish a Phi Alpha Delta Quarterly magazine. This was the first determined effort to publish a Phi Alpha Delta paper, and was the beginning of the present magazine. At this convention, Thomas P. Octigan was elected Chief Justice; Stoy J. Maxwell, Vice Chief Justice; Clark A. McMillon, Recorder; David M.

Taylor, National Financial Secretary, and Lawrence W. Ledvina, National Treasurer.

During this administration not much extension work was undertaken, it being considered advisable to strengthen and to conserve the finances, preliminary to missionary work which was planned.

On July 6th, 1907, Thomas H. Benton Chapter of the Kansas City Law School was installed at Kansas City, Missouri, with six charter members:

The eighth convention of the Fraternity was held in Madison, Wisconsin, on May 11th, 1907, when the following National Officers were elected: Lawrence W. Ledvina, Chief Justice; Charles H. Wilber, Vice Chief Justice; Richard J. Finnegan, Recorder; Douglas Heard, National Financial Secretary; and George E. The wisdom of dissolving Lambda Epsilon can no longer be questioned, for Phi Alpha Delta is the institution its founders intended it to be, and it is now proved that they were not destroyers, but builders. The work of the organizers they selected has brought its reward in the knowledge that it is enduring and that their principles are still taught and striven for by the fraternity that has no equal, Phi Alpha Delta. Credit must also be given to those who so carefully piloted the fraternity through the dangerous places of its first three or four years of existence, the members of the National Councils, busy lawyers and men of affairs, who so freely gave their time and endeavours that the organization might grow; earnest men who gladly laid aside their differing opinions and personal ambitions for Phi Alpha Delta, firm in the conviction that their time and energy was not

wasted. The task of the National and Supreme Officers who succeeded the National Council was by no means a small one, for theirs was the responsibility of ever keeping the fraternity on the high level chosen by their predecessors, and in this they have been faithful to their trust. Let us honor the men who now guideus, they need our support, for of them us honor the men who now guide us, they need our support, for of them men than ever before, and if we continue to be wise in our selection, Phi Alpha Delta will not only remain the great law fraternity, but in a short time be the grandest and best of all Greek letter fraternities, first in every respect, a model for all others, the realization of the hopes of the little band of rebels who met at South Haven that hot July Sunday morning in 1902.

RAPALLO CHAPTER

The Founder's Day Banquet of Rapallo Chapter was recently held at the St. Dennis Hotel and as is the usual happening at all Rapallo's social events, everyone enjoyed himself and arrived home feeling happy and contented.

The principal speaker of the evening was Mr. Frank Sullivan Smith, who is one of the board of bar examiners of this state, and who further is a true brother in the broadest sense of that word. Mr. Smith's talks and advice are always of prime interest to the boys and this time he followed the requirements for admittance to practice from admission by motion to the present rigor or red tape. He also brought out a fact which was enlightening to many of us, viz: that New York University was the first law school recognized by the State of New York in lieu of an office clerkship and that Harvard was second, and it is the concensus of opinion that New York is now the first school of law in the state and possibly the second in the United States, although not so stated by Mr. Smith.

Mr. Smith also went into, quite fully, the code of ethics of this state, and gave a few illustrations of answers which he had received to the various questions submitted on examination. One answer was quite amusing and for the benefit of our brethren who have not had New York City experience will be instructive. There being what is known in this city as ambulance chasers, who for their own benefit or that of some attorney, "stand in" with those granting admittance to hospitals, etc., and gain the ear of injured persons and incite litigation against those who

caused such injury, a clause has been inserted in the Code against such practice, and a question was made part of a late examination, as follows: "If a person came into your office and offered to bring you so many negligence cases per month, for a fixed commission, would you accept his offer? State reasons fully." This man answered "No" which was correct, but scan the reason. "If such commission were accepted, it might be found out and prejudice the jury." Mr. Smith stated that such characteristics and ideals were the cause for the fifty odd rejections at each examination by the character committee, as well as for the hundred or more disbarments constantly before the Bar Association. New York is after them and getting them all the time.

Another important outcome of the dinner was a movement put on foot by Brother George F. Orr, whereby a complete set of representative papers in every action under our statutes is to be obtained, either from the offices in which some of the brothers work or to be copied from the papers on file in the County Clerk's office, and made a reference and part of a course of lectures to be given at the house by members of the New York Bar. In this connection we might add that Rapallo Chapter has the honor of having as a brother, the man who had the best code paper in the entire January examination, and who possibly some of you may have met at the Convention as our representative, viz: George A. Washington.

The house is progressing finely and in fact making money but it certainly means a lot of hard work. If any of you fellows are not afraid of that, we assure you that the game is worth the candle.
