AN EPITOME OF THE FIFTEENTH CONVENTION

It was originally intended by the Supreme Board to print verbatim the entire report of the last convention. However, the report is not only voluminous, but containing as it does, expressions which are essentially rutters of purely fraternity concern, it was deemed best not to make the verbatim report public through the pages of the QUARTERLY. The following epitome has been carefully compiled from this report and, it is believed, will be found adequate for all practical purposes by both active and alumni members. Detailed information may be obtained from the Supreme Recorder's office where the verbatim report is on file.

To the brother who has attended past conventions the last held at Hotel LaSalle, Chicago, June 26 and 27, 1914, appeared as quite a contrast. The delegates compared favorable with the type of men who made up former conventions but each and every delegate participated in the deliberations of the assembly. There were leaders (such as Brothers Carmody, Hess, Jonas and O'Connor, the patriarchs of the Order), but every delegate came to the convention, it seemed, with something to offer on at least one of the many propositions he knew would be passed on by the Convention. The good of this forethought to the fraternity cannot be overestimated. Each delegate appeared to have some one thing he desired to present and was heart and soul in having it pass the Convention.

The Convention also demonstrated that the committee system is the only feasible solution of transacting the business of a convention. And even with this time-saving device there was quite observable the fact that there was not ample time to satisfactorily discuss everything that came up for consideration. The three days' convention amendment passed will no doubt remedy this in the future.

Another cumbersome method was brought to light in the handling of the credentials of delegates. Credentials were insufficient; chapters were in arrears and too many chapters left the adjustment of their accounts to the last minute, when time was valuable. To remedy this glaring error in the future an amendment was passed requiring the submission of credentials ten days prior to the Convention dates. The greatest and most momentous action of the Convention was, as was expected, the adoption of the bi-annual convention and province amendment which goes into effect in 1916. The amendment in a condensed form was passed substantially as the Supreme Board had recommended.

While the Convention did much to facilitate the business of future conventions, and afforded financial relief for the Supreme Board to some extent in the passage of the bi-annual convention and province amendment, much of its action was uncertain and it will be difficult for the Supreme Board to apply the newly made regulations this year. Much was left to the discretion of the incoming Board but not enough details were given to enable the Board to exactly understand what was meant or expected of it in these new matters. It may be that the idea was, as the time was limited, to merely bring the matters up in some form or other so that they would be recorded and could be properly taken up at greater length at the next and future conventions.

The officers' reports in some manner or other all expressed the inadequacy of the present financial system of the fraternity. As Brother Jonas (now Supreme Justice) remarked in his report as Vice-justice, "we have outgrown the framework upon which we builded only yesterday." The remarks of Brother Jonas in this report are summarized and printed elsewhere in this issue and as they represent the course of endeavor for this year and the immediate needs of the Order may be profitably read by every brother.

Brother James P. Aylward, who presided as Supreme Justice, is to be complimented on the skillful and adroit manner in which he conducted the Convention, which, because of the many important matters involved, and the limited amount of time allowed for handling them, made his task the most difficult that has ever been imposed on a presiding officer.

The three new chapters, Clay, Kent and Dunbar, were each represented by a delegate. All chapters were represented save two active chapters.

To bring the delegates together informally before the convention was called a reception smoker was held at the North Side Fraternity House, 200 East Erie Street, on the Thursday evening previous, and the occasion afforded a real opportunity for the delegates to become acquainted not only with each other but Phi Alpha Delta as it is "rit" in Chicago. This was a new feature of the convention arrangements and proved so successful that it seems it should be retained.

To refresh the delegates from their convention labors an outing at Riverview Park on Friday evening was "sprung" by the Arrangements Committee. Everybody was there.

The banquet in the Red Room "with cabaret features" on Saturday evening served as a fitting climax.

WHAT THE CONVENTION DID

Heard the delegates' reports and approved those of the Supreme Officers.

Approved the report of Brother George E. Fink, Trustee of the 1915 Convention Fund, showing total receipts of \$1,544,70, with 24 chapters who paid neither of the two assessments and 6 chapters delinquent on the second.

Ordered that the incoming Supreme Executive Board buy and award to Brother Frank R. Hurlburt, writer of our fraternity song, a suitable trophy, in recognition of his service.

Did not decide whether or not alumni chapters were subject to the convention tax. The sense of the discussion beemed to be that as the alumni delegates would be entertained from the fund as well as the active men, that there was "a moral obligation" on their part to pay it, especially as their delegates at the thirteenth convention had voted for the tax. The discussion also brought out that some of the alumni chapters had paid the tax.

Ordered the incoming Supreme Board to prepare an amendment to the Constitution as to the time of the year for holding conventions. No certain time nor any change from the usual time was suggested but the convention appeared to want the time fixed once for all time, inasmuch as the question has always been agitated at each convention.

Passed the bi-annual convention and province division amendment, and provided for a three days' convention session. The country to be divided into three provinces with a chairman for each and the several provinces to hold conventions in the even numbered years. Bi-annual conventions to be held in the odd numbered years. Amendment goes into effect after the 1915 convention. Cost of holding province divisions to be apportioned among the chapters constituting each province equally.

Granted Magruder Chapter a two years' extension of time in the privileges it now enjoys as to pledging pre-legal men, on the recommendation of Brother George E. Frazier of Ryan Chapter, Comptroller of the University of Illinois, appointed by Supreme Justice Aylward to investigate conditions and report same to the convention with his recommendations.

Provided that prior to the sixteenth convention and each convention thereafter that the credentials of delegates shall be submitted on forms furnished by the Supreme Recorder, to be sent by registered mail to the Supreme Financial Secretary at least ten days before the opening day of the Convention. Duplicates to be retained by the delegates.

Passed by a rising vote resolutions of respect and condolence upon the deaths of seven brothers who departed during the year. Received the favorable report of the Committee on Petitions and Charters on the petitioning body at Boston University and ordered that the petition take its usual course.

Passed a resolution congratulating Brother Jesse F. Dyer, Captain in the United States Marine Corps for his bravery shown in the line of duty at Vera Cruz.

Empowered the incoming Supreme Executive Board to make arrangements for transportation facilities to the next convention in San Francisco.

Went on record as favoring San Francisco as the place for holding the 1915 Convention, but set no date, leaving this to the discretion of the Supreme Executive Board under the Constitution.

Amended the Constitution providing for \$3.50 per capita tax after January I, 1916, the \$1.00 increase to go to the support of the QUARTERLY. (In the meantime the magazine tax prevails.)

Rejected the resolution of the retiring Supreme Executive Board to pay only one-half of the delegates' expenses to the (fifteenth) convention.

Tendered a rising vote of thanks to the outgoing Supreme Board for their services. Brother Aylward was presented with a gavel by the other members of the retiring Supreme Board.

Elected officers for the ensuing year. (See fraternal directory, pages 2 and 3.)

Retiring Supreme Justice Aylward installed the newly elected officers. Supreme Justice elect Jonas installed Brother Aylward as a member of the Board of Tribunes. The Convention adjourned *sine die*.

THE NEW CHAPTERS

Phi Alpha Delta emerged from the last collegiate year with three new chapters, Henry Clay Chapter at the University of Kentucky, Lexington, Ky., James Kent Chapter at the University of Idaho, Moscow, Idaho, and Ralph Oregon Dunbar Chapter at the University of Washington, Seattle, Wash. While the aim of the Fraternity is not to indiscriminately add new chapters to the roster, the state universities in the Western states have proven to be desirable fields for new chapters. The chapter at Lexington, Kentucky, it was expected would flourish from the start and reports are that it has. The chapters in Idaho and Washington caused greater concern because they were farther away from other chapters and in schools where the enrollment was smaller. However, advices from Brother Lyman P. Wilson, who is a member of the faculty of the law department of the University of Idaho, indicate that the chapter there under his guidance is fast becoming one of the staunch organizations among the fraternities there. At Seattle Brothers Nelson R. Anderson and J. Fletcher Lewis and the other Φ A Δ alumni practising in the City assure the Supreme officers that the new chapter is thriving

Petitions for several new chapters are under consideration and several have already been mailed to the active chapters for their approval, but up to this writing there is no definite report to make on any of the petitioning chapters as the time for sending in the chapters' ballots has not yet expired.

"SAN FRANCISCO--1915." GREETING

Eastern brothers will, no doubt, be surprised and somewhat amused to know that California actually celebrates Christmas, as we have no snow in our locality. For what is Christmas without snow? But that did not prevent San Francisco from preparing this year a gigantic Christmas tree, covered with the usual good things for the less fortunate children of the city. The tree was placed in the "Court of the Universe" at the Exposition grounds and half of the population entered the gates to see the fun and the Fair buildings, nearing completion.

San Franciscans love their City, and to the most casual visitor in that great Christmas crowd, this inherent love was apparent. But one must be here to know why. It cannot be expressed in words.

As had the writer, many of you had the good fortune of visiting the famous Chicago World's Fair in 1893, and will long remember its beauties, but Brother Φ A Δ , you have the biggest surprise in your career coming to you when you visit the Golden Gate in August, 1915. You will see something different, as well as feel the thrill that we feel, to appreciate in some measure as we do, the stupendous task that San Francisco has performed and which is now practically finished.

Hall accommodations are now reserved for at least four hundred visitors and this space may be enlarged as soon as we know the actual number that will attend the Convention. The dates determined upon, Thursday, Friday and Saturday, the 5th, 6th and 7th of August, 1915, are such as to fit into the vacation period of almost all, if not all, of our colleges, and is convenient to most of our graduate members in business.

But make your plans now. Figure upon and reserve at least two weeks for a minimum trip. You will undoubtedly want more when you see what you have in store for you, so arrange for it ahead if you can. Come in bunches and in car-loads if it can be arranged, but come anyway, from whatever place you hail, and celebrate with us the double event. Come

It is primeval in its nature and appeals to every soul who is willing to find common ground for stronger fraternity. Get ready and plan for it. We will be here to meet you and make it worth your while.

May the jubilant New Year celebration of this splendid carefree city, now arising to my windows as these greetings go forth, be echoed so that every Φ A Δ may hear, and answer the long call to California.

JACKSON TEMPLE CHAPTER

Jackson Temple Chapter (University of California) recently held one of the most novel initiations of any of which we have heard, even on the Coast where things are done in new ways. The ceremonies took place at the "Tavern," which is situated on the top of Mt. Tamalpais (pronounced Tam'-al-pit'-is) about twenty miles distant by railroad and ferry from San Fransisco.

Mt. Tamalpais is known to all world travelers, both because of its unique setting and its distinctive view, but for the benefit of brothers who should visit our State in 1015 and who may not know of its charms, we will state that it dominates all of Marin County adjacent to the San Francisco Bay Region, overlooking the Pacific Ocean on one side and the City and Bay on the other. The panorama can only be appreciated by those who have once visited the place and spent the day and night at the top. The lower reaches of the mountain are thickly wooded with manzanitas brush and evergreen trees, and deep in one of the canyons is located the famous Muir National Park of redwood trees. The peak (2600 feet high), is ascended by one of the most crooked railways in the world. The track virtually ties a double bowknot and is nine miles in length.

The journey up was made on the afternoon of a typical California day—the hills green with new verdure and the sun bright as in the East in June. Our party reached the top just before sunset

and were treated to an unobscured view of the old Pacific Ocean, its deep blue laden with the gold and crimson of the dying sun. Few of us will forget the sight.

After the ceremony, which took place deep in the cavity of the rock beneath the "tavern," the four initiates and their enthusiastic brothers made merry over a real California banquet in one of the larger private halls, the seclusion of which was several times invaded by curious merry-making couples from the ballroom, attracted, no doubt, by echoes of the rousing good time which escaped through key holes and an occasionally opened door. Following the dinner, those who did not fall victims to the charms of the dance, promenaded the mountain walks and terraces in the brilliant moonlight.

The return trip was made just before midnight in what is known as a "gravity" car and the descent became one grand toboggan ride, with no motive power other than that furnished by a heavy grade, in and out of the canyons with their fresh odors of balsam and redwood, until we glided into the station 22 minutes later at the little village of Mill Valley.

NOTICE TO CHAPTERS

The per capita tax is now due and payable. The last meeting of the Supreme Board brought to light the fact that nearly every chapter in the Order was delinquent to the Fraternity's affairs that the chapters meet these obligations promptly. The address of the Supreme Financial Secretary to whom remittances should be made is "Charles B. Adams, Waterbury, Vermont."

Do not send money to the Supreme Treasurer. The convention tax may be paid direct to George E. Fink, Chamber of Commerce Building, Chicago, Illinois. The Board will enforce the regulations and penalties relating to delinquencies rigorously this year, as the increased expense attendant upon holding the Convention on the Pacific Coast requires it.

Chicago has lost Chris. Whalen, who early last November betook himself to Kansas City, Missouri. And it was a sad farewell that Chicago Φ A Δ's bid him. The reason for all this is that Chris. has been one of the hardest workers for Phi Alpha Delta that Chicago has ever enrolled. Not alone that but he had a habit of cheerfully contributing real money to fraternity occasions and to the joint chapter house in Chicago that more than once saved the day. Aside from setting August 5, 6 and 7 as the San Francisco convention dates, the matter of transportation rates by special train out of Chicago was considered, and with recommendations referred to the committee which has charge of this detail. Other arrangements were tentatively decided on. The May issue of the Quarterly will give authentically all the details pertaining to the different stops which will be made, fares, accommodations, etc. Brother Tillotson was appointed to investigate the matter of awarding a trophy for the writing of the fraternity song by Brother Hurlburt. All the honorary members proposed by chapters received the favorable vote of the Supreme Board. Brother Roads, as Supreme Recorder submitted a copy of the re-drafted Constitution containing the amendments of the last convention. These will be printed as soon as practicable. After the transaction of routine matters the Board adjourned.

SONGS AND MUSIC OF PHI ALPHA DELTA

During the past two years an occasional letter has come to the office of the Editor-in-Chief inquiring about the songs and music of the

Order. Some of the letters mention parts of the song and taken collectively these letters indicate that there are several fraternity songs, aside from the official one by Brother Hurlburt, that have been written. The only musical composition this office has ever learned of is "The Phi Alpha Delta March," dedicated to the Fraternity by Brother Jesse Darden, now deceased. Magruder Chapter has several copies of this march in its archives, as well as on the piano, and the various older brothers of that chapter have copies.

The editorial ink has about dried up since there was last occasion to use it for these effusions. There has been an unusually long interval of quiescence even for the QUARTERLY. The QUARTERLY has been tried and found guilty of habitual apologizing more than once or twice. As one brother intimates he fears it may some day become a repository for nothing but apologies in its endeavor to catch up with its misgivings and short-comings. But the QUARTERLY is constituted somewhat like the deacon's "one hoss shay"—it goes to pieces all at once, (though hardly as durable.) In this connection it is suggested that the historian or clerk of the various chapters be instructed to keep up a file of the QUARTERLIES and that it be a duty of his office to turn them over with the other papers and charges of his office when his successor is elected.

Honorary Brother James Lawrence of Hay Chapter.

Judge James Lawrence of Cleveland, an honorary member of John Hay Chapter, died on July 4, 1914. His death deprived Hay of one of its most interested members, for Judge Lawrence was rarely absent from one of the Fraternity banquets or smokers. His son, Keith F. Lawrence, is an active member of Hay Chapter. The Cleveland Leader of July 5, said in part:

Judge James Lawrence died after three hours' illness at 3 o'clock yesterday morning at Brookside, on the crest of the Alleghenies of West Virginia.

His death, unexpected, caused expressions of deep regret among the lawyers of Cleveland, and deprived the Democratic Party of one of its most distinguished members.

He was not only on the common pleas bench, but he was the unopposed candidate at the Democratic primary for the nomination for Judge of the Court of Appeals. It is understood that Governor Cox intended to appoint him on the special committee to revise and simplify judicial procedure which will report to the next Legislature.

Judge Lawrence, who had not been entirely well since February, left Cleveland last Wednesday with Mrs. Lawrence to spend the summer in the mountains. At midnight of July 3 his family, at 1822 E. 82nd Street, received a telegram that he was seriously ill. Dr. J. P. Sawyer, 1850 E. 63rd Street, started immediately for Brookside in response to the summons.

Mrs. Lawrence is expected to arrive here this morning with the judge's body. Arrangements for the funeral have not yet been made.

Few Cleveland men have had so brilliant a public career as was that of Judge Lawrence. As a young lawyer he was elected Attorney General of Ohio in 1883 with Governor George Hoadley heading the ticket. From 1887 to 1889 Judge Lawrence served as President of the Board of Aldermen of Cleveland.

In 1893 Mayor Robert Blee, of Cleveland, appointed him Director of Law and he held that office until 1895, starting, during his term of office, the famous lake front case, which is now pending in the Supreme Court of the United States.

This suit, which was against the Pennsylvania and other railroads, involved the title to millions of dollars worth of lake front made land. Throughout the progress of the case, which has gone all through the federal courts and the state courts, Judge Lawrence was active in presenting the city's side.

In 1902 he was elected to the common pleas bench, serving until 1909. He was defeated in 1908, but was elected in 1910, leading the judicial ticket. During his term as judge perhaps the most noted suits tried before him were the low fare street railway cases in the earlier vears of the traction war.

Candidacy Unopposed

Judge Lawrence was urged by Mayor Baker and the Democratic committee to run this year for the Court of Appeals, and he became the unopposed candidate for the Democratic nomination at the primaries. His death not only leaves vacant a place on the common pleas bench, but one on the Democratic ticket.

The son of Congressman William Lawrence, Judge Lawrence, was born at Washington, Guernsey County, Ohio, January 15, 1851. He was graduated at Kenyon College in 1871, and while in college he was a charter member of the revived chapter of Theta Delta Chi and was a member of the legal Fraternity of Phi Alpha Delta. He read law in the office of White & Campbell at Cambridge, Ohio, and was admitted to practice in 1873, coming to Cleveland in 1874.

For fifteen years he was a professor of law at Western Reserve University, severing his connection soon after a serious illness in 1010.

Judge Lawrence was married to Miss Jennie Porter, of Cleveland, in May, 1888. He leaves, in addition to his widow, three children, Miss Margaret Lawrence and Keith F. Lawrence, of Cleveland, and Miss Harriet Lawrence, of Ann Arbor. A brother, Attorney Albert Lawrence, 329 Society for Savings Bidg., is the only other member of the family.

The Cleveland Plain Dealer of July 8 said:

Marked by simplicity, the funeral for Judge James Lawrence, who died Saturday at Brookside, W. Va., was held at 4 o'clock yesterday afternoon.

At the services, held in the Lawrence residence, 1822 E. 82nd Street, were many members of the Cuyhoga County bar, the entire common pleas and municipal court benches, city and county officials. Representatives also were present from the Iris and Holyrood Masonic lodges, in which the judge held membership.

Rev. Dr. A. B. Meldrum, pastor of Old Stone Presbyterian church, conducted the services. He read selections from the Scriptures, delivered a eulogy and offered prayer. In his eulogy, Rev. Dr. Meldrum said:

"The sense of Judge Lawrence's loss is shared not only by those who are here today, but the whole city and the community. It is men of his stamp who give wealth to a city. He has contributed things to the life of Cleveland which cannot perish.

"He was a man of irreproachable integrity, honor, justice. He loved righteousness and strove ever after the most exalted ideals. He believed first of all in God."

The pallbearers were Mayor Newton D. Baker, Common Pleas Judge C. J. Estep (Honorary Member of Hay Chapter), William M. Raynolds, Frederick Green, Robert W. Ney and William G. Taylor.

The body was buried at Lakeview cemetery.

RESOLUTIONS OF HAY CHAPTER

Whereas: At the time of his death the deceased was an highly esteemed honorary brother of John Hay Chapter of Phi Alpha Delta in good standing, and

Whereas: His sound legal judgment, his keen sense of justice, his courageous stand on the side of the right stamped him as a judge whose decisions have stood and will stand among the best legal opinions of this state and nation, and

Whereas: His uprightness, fairness and aggressiveness, both in the interests of those who sought his counsel, as well as in the proper interpretation of the law proved him an ideal exponent of the profession and officer of the courts, and will approximately the first human correction.

Whereas: His fine human sympathies, loyalty and congeniality placed him as a true brother to his fellow men,

Be it resolved: That John Hay Chapter and Phi Alpha Delta Law Fraternity has sustained the loss of a brother whose irreproachable character, whose preëmience as a jurist, lawyer and public official, whose fine intellectual attainments and whose friendliness and loyalty proved him an inspiring example and true brother of the younger mem-

Be it resolved further: That while we are mourning our loss deeply, we extend to the bereaved family our sincerest felicitations in their sorrow.

Be it further resolved: That a copy of these resolutions be spread upon the records of John Hay Chapter, a copy sent to the sorrowing family and a copy furnished the Phi Alpha Delta Ouarterly for publication.

Brother Homer W. Green, of Hammond Chapter, Phi Alpha Delta, died on June 20, 1914. Only one short year had passed since he had departed from his Fraternity, his Alma Mater, and his friends. His life's work had just commenced. His success was assured. And then—like a lightning bolt from a clear sky that strikes to the ground the tall, stalwart pine, the great guider of human destiny took from us "Our Brother."

He was a man—with all that that term implies. Faithful to his friends, true to his ideals, and conscious of life's obligations. A man, who was loved and who will always be remembered by those who knew him. He was a zealous worker in Phi Alpha Delta. Ever cheer-

ful and optimistic, he, in his quiet way, stood always for the truest, the best and the noblest interests of his Fraternity.

He is gone. We cannot question the laws or justice of Providence. We must feel that somehow, someway, somewhere, there is adequate compensation for the personal loss and sorrow we feel. Brother Green will best be remembered as a man among men, quiet, sympathetic, and honorable, one whose life will be a lasting example to his brothers, ever helping them toward higher and better things.

THE AIM OF THE ADMINISTRATION

In a letter to the active chapters under date of December 12, 1914. Supreme Justice Jonas outlined the policies of the present administration. His outline is almost identical with the suggestions he made in his report as First Vice-justice at the last Convention. Some of his ideas are novel, some were adopted by the last convention and the remainder are ones that the older members of the Fraternity have often advocated.

These suggestions will be made the policies of this year's administration and are tabulated here for the Order inasmuch as details are not to be perfected, the first meeting of the Supreme Executive Board having convened in Chicago December 27, last. A report of this session will be found on the other pages of this number.

- To devise a scheme to increase the finances.
- 2. To encourage the building of fraternity houses by chapters.
- To create a trust fund for trophies for awards for fraternity service.
- 4. To foster a greater bond of fraternalism between chapters in close proximity to one another.
- To have a uniform lecture system of initiations.
- 6. To stimulate greater interest in the Ouarterly.

THE SAN FRANCISCO CONVENTION

The Supreme Executive Board has officially announced that the San Francisco Convention will be held on August 5, 6 and 7, next.

The Board made the announcement at an early date so that all members of the Order, not alone delegates, may lay their plans now, giving ample time to all to reserve these dates.

Chapters should elect their delegates as early as possible and not defer this choice until late in the school year as has been the habit heretofore, notwithstanding the constitutional provision regulating the same.

All details concerning the Convention, including the route chosen

for special train, the stops, the fare, the accommodations, the reservations, etc., will appear in the May QUARTERLY. The route now proposed is settled in the main, but several important details are still undetermined and cannot be decided upon for another month. The rate made for the Phi Alpha Delta Special will be very low in any event. The round trip rate with berth and meals en route to San Francisco from Chicago with special side trips and for return by optional route will be about \$86.00. This rate will be available to members and their wives and friends.

IN THE GREEK WORLD

The medical fraternities are planning the organization of an Intermedical fraternity organization.

The Order of the Coif (honorary law) held their annual Convention in Chicago, December 29, 1914.

Aesculi, a forestry organization at Ohio State, has been incorporated under the name of A II Y fraternity. Steps are now under way for the establishment of chapters in other schools of forestry, each chapter to be named after the dominant tree in that region.—

Banta's Greek Exchange.

The College Fraternity Reference Bureau, which as its name implies, is the repository for all data relating to the college fraternities of this country, and located at Evanston, Illinois, is publishing a Pan-Hellenic Encyclopedia, under the name of Leading Greeks, which will be off the press soon. The publication is edited by William C. Levere, S A E.

At the meeting of the Interfraternity conference. November 20, 1014 a resolution was passed disapproving of the use of all forms of alcoholic liquor in chapter houses and at fraternity banquets. The resolution was passed unanimously The Conference also passed a resolution directing its executive committee to enter into correspondence with the several medical and legal fraternities with a view of cooperating in the formation of a Medical Interfraternity and a Legal Interfraternity.

Phi Delta Delta is the name of a national legal sorority. It is said to have chapters in the University of Southern California, the Washington, D. C. College of Law and the Chicago-Kent College of Law. There is said to be a second national legal sorority Kappa Beta Phi whose Alpha Chapter is at the Chicago-Kent College of Law.—




