

#### SIXTEENTH NATIONAL CONVENTION

PHI ALPHA DELTA LAW FRATERNITY

San Francisco, California, August 5, 6, 7, 1915

Your committee after careful consideration and advice from members interested, has selected the Chicago & North Western Ry., Union Pacific R. R., Southern Pacific Co. (the Overland Route) as our Official Line of Travel.

Arrangements have been made for a special train consisting of open section, compartment drawing room, sleeping cars and dining and observation car, to leave Chicago from the New Passenger Terminal of the Chicago & North Western Railway, Madison and Canal Streets, Chicago, on the following schedule.

#### The Route:

Leaving Chicago at 9:35 p. m. the night is spent in riding over the heavily ballasted smooth double tracked railway of the Chicago & North Western Ry. This railway, together with the Union Pacific R. R. and Southern Pacific Co., the route of this train, have more miles of double track than any other transcontinental line. Automatic electric safety signals guard your safety every inch of the way.

#### Ist day

In the morning the train is passing through the western central part of Iowa, with its rich and fertile farm lands. The Missouri River is crossed at Council Bluffs, and you arrive in Omaha, the Gateway to the Great West. Omaha is the metropolis of Nebraska, and the distributing point of a large grain producing country.

Leaving Omaha the route lies through the Valley of the Platte River and is identical with that of the famous Overland Trail of history and

the Lincoln Highway of today. The prosperous towns of Fremont, Columbus, Central City and Grand Island are passed. These are all growing and industrious cities of the prairie lands. From Grand Island to Julesburg, the track lies directly west without a single curve, and a very pretty sight is to watch the mosaic-like appearance of the disappearing roadbed. At Kearney can be seen the buildings of the new Nebraska State Normal School, a military academy and State Industrial School for boys. North Platte is located at the junction of the North and South Platte Rivers. Julesburg, Col., marks a historical spot where stage coaches in the old days rested over night.

#### 2nd day

The night is spent in passing over the uninteresting arid lands of Wyoming, and in the morning Rock Springs, with its many coal mines is reached. Next Green River presents an attractive sight as the train winds along the bank of the river bearing that name. All through Western Wyoming the unexpected changes in scenery are entertaining. Aspen Tunnel through Aspen Ridge offers a diversion, then Utah is entered. From here on is one of the most enjoyable parts of the journey, first Echo Canyon, with its Grand Teapot, Steamboat Rock, Pulpit Rock, where it is supposed Brigham Young preached his first sermon in the "Promised Land". Beside the track is the foaming waters of a mountain river, which is crossed and recrossed. Next is Weber Canyon, with its gigantic walls of rock, its tree lined ravines and picturesque waterfalls. Leaving Weber Canyon the eye is met with a level farming country, and Ogden is reached, nestling against the frowning Wasatch Mountains. Continuing westward from Ogden the Great Salt Lake Cut-Off is crossed in the glow of the afternoon sun. This is a marvelous piece of railway engineering and the traveler enjoys the novel experience of "going to sea by rail" for about thirty miles.

#### 3rd day

The Great American Desert is crossed at night, and the morning of the third day finds us at Reno, Nevada. Reno is situated at the foot of the Sierra Nevada Mountains a great wall rising to the westward and separating California from the rest of the country. The train now begins to climb up the beautiful canyon of the Truckee River. From Truckee, located 35 miles west of Reno, a side trip may be taken to Lake Tahoe, if you care to stop over a day. Lake Tahoe is the largest of the world's mountain lakes, twenty-three miles long by thirteen miles wide, 6,220 feet above sea level. The surrounding country is beautiful. West of Truckee you pass Weber, Donner and Independence Lakes. The route winds around the shores of Donner Lake, rising until it appears far below. Since leaving Truckee the ascent has been very marked and 12 miles west of Truckee the summit of the Sierra, 7,018 feet above sea level is reached. The ride down the western slope is filled with interest, passing as it does, Emigrant Gap, Dutch Flat and Cape Horn, and many other historical places. From Cape Horn the Sacramento Valley is spread out below as a great relief map of orchards, villages and cities, winding rivers and green valleys. Sacramento, the capitol of California, affords a pleasing sight, situated as it is by its orchard with the winding Sacramento River at its doors.

Across the lowlands from Sacramento can be seen the mountains surrounding the Bay of San Francisco, and at Benicia, the train is placed upon the largest ferry boat in the world and the Carquinex Straights crossed. Past Richmond, a manufacturing city, and Berkeley, a beautiful residence city and the seat of the University of California, the train rushes into Oakland.

At Oakland Pier the traveler leaves the train for the ferry from which a panorama view of San Francisco and the Panama-Pacific Exposition and Bay may be had, and you arrive at the Ferry Building at the foot of Market Street in San Francisco, where electric cars or automobile will convey you to your hotel.

Should the traveler desire to continue his journey to Los Angeles and San Diego, he has the choice of either the Valley Route or the Coast Line, the former leading through the famous California orchards; the other skirting the Pacific Coast a greater portion of the journey.

#### Return Routes

It is suggested that after the meeting at San Francisco the route of travel be to Los Angeles, making side trip to San Diego and return, thence to Salt Lake City over the Salt Lake Route, the Denver & Rio Grande R. R. to Colorado Springs and Denver, and the Union Pacific R. R. and Chicago & North Western Ry. to Chicago.

If any other return route from Los Angeles is desired by any of our members the same can be arranged either via Southern Pacific or Santa Fe Railways.

#### Rates

The rate covering railroad transportation for the round trip via the route above mentioned from Chicago is \$62.50, including the side trip to San Diego and return.

If the return is desired via Portland, thence via the O.-W. R. & N., O. S. L., D. & R. G. to Colorado Springs and Denver; Union Pacific and Chicago & North Western Ry. Denver to Chicago; or via the Northern Pacific Ry., Great Northern Ry., or Canadian Pacific Ry., to St.

Paul, thence Chicago & North Western Line to Chicago, the rate will be \$17.50 additional.

Tickets are good three months from day of purchase.

#### Sleeping Car Rates:

The rate for a lower berth in standard sleeper Chicago to San Francisco is \$13.00; upper berth \$10.40. Two persons may occupy a berth at these rates. The cost of a compartment is \$36.50; drawing room, \$46.00.

Our Fraternity, embracing as it does, men of affairs, whose professional duties may keep them engaged up to the last minute before leaving, made the selection of a through line of travel such as above mentioned, Chicago to San Francisco, more advisable.

The return of the members may be made as their leisure permits, making stop-overs at points of attraction at their option.

The Committee urges you to bring before the attention of members and their families and friends, this special train arrangement, so that we can have the required number of persons to insure a success. Delegates from Kansas City, St. Paul, Minneapolis, etc., can join the special train at Omaha, and those from Denver at Cheyenne.

#### CONVENTION POINTERS



#### IN MEMORIAM

Fred Masters Lyon, 'IIL., died, from tubercular meningitis, in Paola, Kansas, on June 4. He was born in Hillsdale, Kansas, on February 8, 1886, the son of William H. and Mary J. (Masters) Lyon, and after graduating from the high school in Paola, to which place his family had later removed, he entered the University of Kansas. After receiving the degree of B.A. from that institution in 1909, he came to Yale, entering the second year class in the School of Law, where he was a member of Phi Alpha Delta. Upon graduation he returned to Kansas, and in February, 1012 was admitted to the bar in that state. For a time he was associated with his father in the real estate and loan business in Paola. Later he became connected with the Cornbelt Mortgage Company in Kansas City, Mo., remaining with that concern until February, 1914, when his illness compelled him to give up his work. was unmarried .- Yale Alumni Weekly, Jan. 29, 1915.

Brother L. Lloyd Bickle, of Hay Chapter, died on August 23, 1914, and news of his sudden death caused profound sorrow in the ranks of  $\Phi$  A  $\Delta$ . Brother Bickle was Scout Master of the Boy Scouts at Chardon, Ohio, and while bathing in the Chagrin River, near the Scout camp, he was drowned. The Scouts endeavored in vain to rescute him.

Brother Bickle was born in Chardon, June 17, 1887, and after graduating from the local schools he entered Adelbert College in Cleveland, receiving his degree in 1909. Brother Bickle was there a member of the Phi Gamma Delta fraternity, president of the literary society and the chess club, and a member of the musical clubs. He graduated from the law school of Western Reserve University in 1911, and he was a zealous worker in behalf of  $\Phi$  A  $\Delta$  and Hay Chapter.

Returning to his home in Chardon, Brother Bickle took up the practice of the law, and as an attorney and citizen acquired the respect and confidence of the entire community. As Justice of the Peace, he dealt with varied problems of law and it was evident that a career of great promise was ahead of him. At the time of his death he was the Republican nominee for Prosecuting Attorney of Geauga county and his election was assured. Brother Bickle was superintendent of the Chardon Congregational Sunday school.

His associates in Hay Chapter remember Lloyd Bickle as a quiet, unassuming lad, a diligent student, and, in short, a manly man. He was popular with all whom he knew, and at Chardon and vicinity the impress of his life will long be felt. In his young manhood he fully realized and completely attained the Justinian concept of the law,—he lived honestly, he injured nobody, and he gave every man his due. With him duty and honesty and public service were big words, and he gave them a big

Soon after his untimely death a memorial to Lloyd Bickle was published by the Rev. F. W. Hart and dedicated to the Boy Scouts Troop of Chardon in memory of their founder. Besides his parents, Brother Bickle is survived by a wife, Mrs. Pearl Bickle, an infant daughter, a brother, Mayor H. C. Bickle of Chardon, and a sister, Mrs. Mae Evans of Erie, Pa.



The annual news-letter of Campbell Chapter is off the press, and as usual it is a publication that will delight the heart of the old Campbell

"grad". It is chuckfull of alumni notes and covers minutely the chapter's activities. This feature deserves emulation among the older chapters of the Order.

### BROTHER WILSON TO OKLAHOMA

### A WORD ABOUT CREDENTIALS

Active chapters will please take notice that credentials of delegates to the Sixteenth Convention at San Francisco must be sent to Supreme Financial

Secretary Charles B. Adams, Waterbury, Vermont, by registered mail, at least ten days before August 5, next, the opening day of the Convention. This is in accordance with the new constitutional amendment passed at the last, the Fifteenth, Convention. Chapters, however, are urged to send on their credentials before the closing of their respective school terms. This will avoid "last minute" haste and irregularity. The chapters will be supplied with the prescribed forms in ample time to do this. Don't neglect, therefore, to send in credentials before your chapter closes for the term. Retain a duplicate original copy for identification of delegates.

The January Quarterly contained an editorial concerning a dilemma that had bobbed up in the promising career of Brother George E. Frazier (Ryan). Brother Frazier, it will be remembered resigned his office as comptroller of the University of Illinois so that he might marry Miss Helen James, daughter of the President of that University. But hardly had he announced his intended resignation when he was besieged with entreaties to enter upon new and more promising labors. Knowing him to be a man of purpose and perseverance Montgomery, Ward & Company of Chicago sought him out to head the important department of that great mercantile institution which investigates "leaks" and injudicious merchandising in its business. And Brother Frazier accepted. Incidentally, his new post carries with it an increased remuneration over the old. We are aware that the old saw,

"Faint heart ne'er won fair lady," is about worn threadbare, but permit our saying that that sort of a heart fails to win other desirable things. Again, Brother Frazier, we all concur.

Brother Palmer Blackburn (Jefferson) kindly furnishes us with the details of the McGowin-Gover nuptials, announcement of which appears elsewhere in this number. Brother Blackburn tells us that six Phi Alpha Delts were present at the event, which was a very pretty one. Incidentally, he says, this was the largest gathering of Phi Alpha Delta ever known in Alabama, and for this reason the occasion should be accorded especial fraternal attention.

The OUARTERLY is, and always has been, largely a ON MAGAZINE creature moulded by the Fraternity Convention. The LEGISLATION. Constitution provides (Art. IV. Sec. 7.) "that any annual [hereafter biannual] Convention may make such provisions as it deems best for the ensuing year" concerning the magazine. The QUARTERLY has always been a severe strain on the otherwise meagre treasury of the Order. This year because of the increased cost of the Sixteenth Convention the publication was necessarily curtailed more than ever before. The alumni magazine tax, as it is called, has proven cumbersome and wholly unsatisfactory. The last, the Fifteenth Convention, provided by constitutional amendment of Article VII, Sec. 12, that after the current convention the per capita tax be increased from \$2.50 to \$3.50, repealing the alumni magazine tax and providing that the \$1.00 increase go exclusively to the OUARTERLY. Investigation proves that a similar plan is followed by all fraternities conducting regular and creditable publications. It is hoped that the Sixteenth Convention will not disturb the force of this enactment but will expressly ratify it. After five years' experience under four administrations your scribe has come to believe that this is the only present means of obtaining a QUARTERLY commensurate with the standing of our Fraternity in the Greek world. The fact that all the past officers of the Fraternity of the past five years and those of the administration about to retire have arrived at the same conclusion leads our making a recommendation to the Sixteenth Convention that they expressly confirm the action of the last convention in this particular.

OBEY THAT SIREN CALL Classes of obligations a man may owe—those he owes to others and those he owes to himself. Likewise there are two pliance with its tenets is but one, the other is the obligation you owe to

yourself as a Phi Alpha Delt. Quite like the supreme events which it is said occur in the life of every Nation and decide its stability there are supreme events in the life of a fraternity. You will grant that the departure of a convention away from a central point and the "home town" of Φ A Δ is such an event when you are told that your Fraternity is the youngest of those who have assayed a convention on the Pacific coast. The idea of a convention at the time and place of the Exposition was first broached by Past Supreme Justice John Dovle Carmody at our Thirteenth Convention, which devised means of effecting the undertaking. Ever since that time the chapters on the Pacific Coast have dreamed of this convention. They have worked and planned hard for its assured success and with present indications that almost forty per cent of the total membership of the Order will attend the convention and that many will take the trip that will spell Phi Alpha Delta across the Continent, the realization of these fond dreams will become a fact, and we will add another achievement in our Fraternity annals. August 7, next, has been designated "Phi Alpha Delta Day" at the Exposition. We entreat you to pay Phi Alpha Delta that other obligation you owe her and vourself, we want you to be with us at the convention for her sake and for your own, we want you to help us and yourself by making "Phi Alpha Delta Day" an event of significance befitting "the greatest legal fraternity in the world." If you fail Phi Alpha Delta in this you have failed vourself.

AN EDITORIAL WELCOME

Since the last QUARTERLY appeared Manoch B. Reese Chapter in the law department of the University of Nebraska, Lincoln, Nebraska, and David J. Brewer

Chapter in the law department of John B, Stetson University, Deland, Florida, have been granted charters by the Fraternity. The policy of the Order is now one tending to reënforce the individual chapters rather than to extend to new fields. Under this critical inspection these new chapters are to be highly complimented for passing rigid inspection, and the welcome of the Fraternity is all the greater and more hearty.




