Be It Resolved, by the Supreme Executive Board thereof, that the next, the Seventeenth Convention of Phi Alpha Belta Caw Fraternity be and it hereby is postponed to such date as shall be later determined by this Board.

PASSING THE CONVENTION

Although the Supreme Executive Board had earnestly desired the holding of a convention of chapter representatives before the end of the year 1917, if such were possible under any reasonable combination of conditions, the conviction has been gradually growing that the time is not yet.

While the chapter survey, elsewhere mentioned, is very encouraging and throughout the country evinces that typical, undying spirit of which we are indeed proud, yet it also bids us look first to the survival and maintenance of the local chapters themselves. Some of those chapters which might well have been in good financial condition, had it not been for the sudden call to arms last April, will need a little longer in which to acquire that status which qualifies them for representation at convention.

A convention conspicuous for the absence of many chapter names upon the roll-call might have been technically sufficient, but could not bring to Chicago the joy and general good feeling that marks the truly representative conclave. There will be enough of the older loyal brothers missing from that roll-call under any date selected prior to the end of the war, without having virtually disfranchised many chapters by a meeting in December next. And the end of the war is something which may not be discussed at present, if the best information at hand may be relied upon.

The Supreme Executive Board, and for that matter, all supreme officers who have patiently held over for several months, and who will be called upon in case of postponement to direct the affairs of Phi Alpha Delta for yet a little longer, naturally desire a convention at the very earliest date possible. They retain their offices at the sufferance of the Fraternity, and will gladly relinquish their duties when opportunity offers. The spirit of service is the one thing that now holds them until their successors may take up the work. For the good work must go on.

At the present time a convention is in the nature of a luxury that cannot be enjoyed without a large expenditure of money all of which is not at present available. Even the adoption of the new Constitution

the times. Let us have more fraternity events in the chapter-house or rooms, but devoid of all elaboration.

As the great majority of college men are financially dependent upon others it should be the peculiar attribute of such men, particularly at this time, to be saving, to avoid expenditures for absolute non-essentials, and to curtail materially what they customarily spend for amusements. It is not expected that our members shall practice self-denials to a point where life becomes wretched. It is obvious that this would be as disastrous as wanton extravagance, which has so often been charged to the college fraternity. But especially among the younger members there is a tendency to yield to too much amusement and the expenditure of too much money for what the writer heard an "old grad" designate the other day as "gee-gaws." Thrift and its corallary, judicious expenditure of money, are valuable assets at any time, and while transgression could possibly be condoned when there was no imperative and immediate necessity, it is unjustifiable now. The Fraternity expects the older members to double their efforts to enjoin upon the vounger members habits of thrift and economy. A fraternity offers supplemental advantages to its members over those afforded by the college and community, and this injunction of economy and thrift should be this year intensified as never before as one of these additional advantages. Our chapters last vear purchased Liberty Bonds. With increased costs and the federal tax on dues and fees, there may be only smaller sums available for war savings purposes. But if no more can be done we commend the purchase of war savings stamps and certificates by chapters and members.

The most notable achievement of Greek-letter fraternities in the past two years has, been a complete refutation of the common charges made against them, viz., breeding poor scholarship and snobbishness. Actual statistics at leading educational institutions show that as a result of a general "scholarship first" effort the fraternities rank well above non-fraternity men in this regard. The rapid formation of new chapters in all representative institutions, thereby increasing the number of fraternity men, has had much to do with the present changed attitude of the public and press. Fraternity men with shoulders to the wheel can achieve much. Our members can meet the changed world conditions of today.

The Fraternity asks that its members observe a policy of sane saving and economy in their chapter and personal affairs. If this is adhered to, the perplexing problems of the times will be much easier of solution and the fabric of the Fraternity will not be seriously impaired. may very well await the time when its proper consideration is possible by all chapters.

Meanwhile Phi Alpha Delta needs the helpful coöperation of its widely scattered alumni as it never did before and perhaps never may again. This means those brothers whose work is at home, rather than at the front. Now is the time to form alumni chapters in the cities. Now is the time, Brother Alumnus, to take an interest in the welfare of that little band of-loyal workers who are striving to uphold the standard of that chapter which it may be you have not even visited for a long time. As an alumnus it is your only direct affiliation and your first one—the closest of your college ties. Drop the boys a letter and ask them if they need your aid. Even if they do not, you will be surprised at the appreciation it will bring forth. Get a copy of the new Directory and note the present location of your old chums. It will repay you well.

ECONOMY IN CHAPTER ACTIVITIES

With thrift, economy, and food conservation being urged on every hand it may seem unnecessary to burden these pages with any remarks along these lines. But the Supreme Executive Board desires to lay especial stress on these features as they relate to active chapters.

Formal social functions should give way to informal ones, and banquets should be eliminated and smokers or lunch only take their place. Banquets and formal social functions in the past had reached such proportions of importance in the affairs of some fraternities that it is not to be wondered that those on the outside often believed that the chief function of the college fraternity was the promotion and carrying on of such activities. More frequent gatherings in chapter-houses are urged but elaborate social affairs and large menus should be altogether eliminated. If members cannot be attracted to fraternity gatherings and events unless there be a big "feed" scheduled, there is something the matter with the fraternity or the member, and all the chances are that the fault in that event is with the member. A genuine fraternity man is not attracted to fraternity meetings or gatherings by an appetite. While we are all aware that goodfellowship follows easily over the testive board, we are satisfied that less elaborate and costly "spreads" would not interfere with that spirit. As has been said, elaborate social functions and banquets have become so commonplace within the past years because of their frequency that it will be a real novelty and genuine relief to turn now to simple and informal gatherings in the spirit of

There has been printed but a limited number of copies and if you wish a copy you must act at once, as a new directory will not be issued for three years. Supplements will be issued to the directory at least annually for the purpose of adding names, noting changes of address, and corrections.

The cost of the directory is approximately \$900, and every loyal member should do his bit and assist the Fraternity by purchasing one of these directories. In these war times we cannot depend alone upon the active members to support and finance the Fraternity, so we ask your help in this respect.

TO THE CHAPTERS OF PHI ALPHA DELTA LAW FRATERNITY:

IMPORTANT

Supreme Financial Secretary G. E. Miller, of Portland, Oregon, has been obliged to resign on account of local duties caused by the war. His successor is Bro. Frank E. Rutledge, 213 W. Schiller St., Chicago, Ill.

The survival of our Fraternity during the war crisis depends much upon a better observance of the financial provisions of the Constitution. Your supreme officers are rendering their services without charge and should not be compelled to keep unnecessary accounts with chapters, or carry on fruitless correspondence.

Delinquent balances due the Supreme Chapter, prior to the beginning of the year 1917-18, should be settled now, even if sacrifices are necessary to do this. Let such be your patriotic contribution to Phi Alpha Delta.

Supreme Justice Stewart is advised by the U. S. Treasury Department that the War Revenue Act requires each new member to personally pay a ten per cent tax upon the sum charged him by the chapter as an initiation fee (if such fee exceeds twelve dollars). It further requires every active member to pay monthly a ten per cent tax upon his regular dues as a member, if such dues exceed the sum of thirteen dollars annually. All chapter war tax returns must be made upon the enclosed new monthly financial report forms to Supreme Financial Secretary Rutledge, who in turn is required to render monthly his account for the active members of all chapters to the United States Collector of Internal Revenue, Cleveland, Ohio. These new forms will supersede the old bimonthly blanks heretofore in use. It is believed that this monthly return will not prove much of a burden to the chapters when once the system is installed. It should be borne in mind that this is not a fraternity requirement but a duty you owe to Uncle Sam.

Please execute in duplicate the blanks for January and February, 1918, and return the originals of these two forms at once, as the February returns are now delinquent.

EDITORIALLY

We requested all active chapters to supply us with a roster OUR ROLL giving names, rank, branch of service, and location as near OF HONOR as possible of all their active and alumni members in the military or naval service so that we might present an alphabetically arranged Roll of Honor in this number. Even now before we close our forms we are tempted to attempt this, but we find that so many chapters confess that the lists sent in are far from complete, and some chapters having ignored our request, we feel we could give at best only a very incomplete list at this time. Practically all chapters responding with chapter letters have embodied therein all the information they have as to their members in the service. Many have asked for more time. We appreciate that those left behind have tasks that require much of their time, but we urgently request that those chapters who have not complied do so for the next number. The forms for the next number will close April 1, next. By turning to the chapter letter of the active or alumni chapter with which a given brother is affiliated, the reader can ascertain from this number whether he is known by his chapter to be in the service at the time of the closing of the forms. Many chapter correspondents have been very careful to keep their lists up to date in this office.

After many delays the new triennial edition of the Phi OUR NEW Alpha Delta Directory has materialized. Much effort DIRECTORY has been lavished upon it by Supreme Historian O'Connell. and his task was not lightened when so many of our members entered

the service just when it was thought compiled. Announcements in this number should be carefully read by members. Quite a number of members are entitled to Directories by reason of joint subscriptions with the QUARTERIX. All will be supplied and these joint subscriptions will in every case be honored. Agreeably to the economy policy of the board, a quota of these Directories will be sent to Editor's agents in the larger cities for distribution, accompanied by a list with the names and addresses of those entitled to same. This will save no little postage and will assure a more careful distribution in cases where subscribers have changed address and not advised this office, of which change the agent will no doubt be aware. Members living at points where there are no Editor's agents will be supplied direct by mail. This process will require some time, so before you inquire for your copy allow at least ten days after the receipt of this number of the QUARTERIX therefore, before corresponding with this office or communicating with the Editor's agent.

THE WAR AND PHI ALPHA DELTA

With bestarred service flags flung in nearly every fraternity house, whether social or professional, and with many chapters of every

fraternity so reduced in numbers that chapter homes have been temporarily abandoned, and with different fraternities living under the same roof, the reader can appreciate that Phi Alpha Delta is passing through a period of trial common to all fraternities and to all educational institutions.

Before me are the reports that came to the Executive Board in late summer. Magruder and Capen Chapters then had but one man to carry on the good work for the current academic year. There were many chapters reporting only two or three at that time. It was foreboding. No chapter reported at this time even enough men to form a nucleus for a new chapter. Then matters were held in abeyance until late October. Reports then became somewhat more encouraging. A survey of the order was made about this time. The few men left did more than could be expected of them. In short the reports disclosed that there would be enough members to prevent dormancy. True, the reports indicated that conditions were far from normal. Chapters were surrendering their houses or doubling up with general fraternities. They could not hope to be able to promptly liquidate their indebtedness to the order. But we would not be compelled to remain dormant, that grave fear was dispelled.

During November reports came in that chapters were gradually adapting themselves to new conditions and were becoming stable enough to become about half efficient. At this time it was hoped a holiday conven-

tion could be held. But as explained in the announcement elsewhere finances and the absence of so many brothers who were entitled to participate in the convention made it impractical. It was happily abandoned.

A board meeting was planned for the holidays but service of the members of the Supreme Executive Board on local legal advisory boards prevented the board's meeting. By correspondence the very urgent requirements of the Fraternity were turned over to Supreme Justice Stewart for remedy. Brother Miller having been forced to resign, Brother Stewart was compelled to look for a successor and was fortunate in finding him in the person of Bro. Frank E. Rutledge, a patriarch of the Order, who has already seen fraternity service. Brother Rutledge being then in the same office building in Cleveland with Bro. George S. Myers, Acting Supreme Recorder for C. G. Roads, who is in the service, afforded excellent opportunity for the two offices of the Fraternity requiring no little detail to be in constant touch with each other. The Supreme Board has ratified Brother Stewart's action in this regard unanimously.

The finances of the Fraternity are naturally seriously disarranged, but it is the intention of the Supreme Board to conduct the affairs of the Fraternity with the keenest economy so that those active men who have done so much may be relieved in every possible manner of their enormous burden, not only of reorganization and adaptation to the new order of things, but so that they may know that the effort of the board is to give every aid to them in assisting to keep the "fires of the Fraternity burning."

To this end but two numbers of the QUARTERLY will be published during the academic year. All subscriptions and advertisements will be extended accordingly so that full value will be given to both subscribers and advertisers. Matter in the QUARTERLY will be somewhat curtailed and much general matter that these pages have reflected in the past will be materially reduced or altogether eliminated for the same reason.

One of the best things recently said is a remark by William T. Ellis: "There are three kinds of people in the world: the wills, the won'ts, and the can'ts. The first accomplish everything, the second oppose everything, and the third fail in everything." Those few active men who went back to their active chapters this year and have accomplished a task the board had not dared to hope for, are surely of the first. Being mostly younger men with but one year of college work, their task was the harder and their achievements the greater. They have truly been "wills" and we trust that their efforts in behalf of Phi Alpha Delta in those crucial days of the fall of 1917 will go ringing down through the Fraternitv's annals.

THAT TEN PER CENT WAR TAX Before this issue is in the mails active chapters will have learned that the Executive Board of the Fraternity has been advised definitely that it will be

required to pay this tax where the dues and fees are in excess of the twelve dollars per annum. Complete announcement of this appears on other pages.

Section 701 of the War Revenue Act, which covers this tax, reads: "That from and after the first day of November, nineteen hundred and seventeen, there shall be levied, assessed, collected, and paid, a tax equivalent to ten per centum of any amount paid as dues or membership fees (including initiation fees), to any social, athletic, or sporting club or organization, where such dues or fees are in excess of \$12 per year; such taxes to be paid by the person paying such dues or fees; provided, that there shall be exempted from the provisions of this section all amounts paid as dues or fees to a fraternal beneficiary society, order, or association, operating under the lodge system or for the exclusive benefit of the members of a fraternity itself operating under the lodge system, and providing for the payment of life, sick, accident, or other benefits to the members of such society, order, or association, or their dependents."

Before it was definitely ascertained that Phi Alpha Delta would be required to pay this tax, there was considerable doubt expressed by many members that it would apply to us, these members believing we were covered in the exception.

But it is now settled that every chapter which receives dues from a member in excess of twelve dollars per year, or an initiation fee in excess of twelve dollars is required to collect from the person paying the same a tax of ten per cent and "make monthly returns under oath in duplicate, and pay the taxes so collected and the taxes imposed * * * to the collector of internal revenue of the district in which" the chapter is located (Sections 702, 503).

In the last issue of the *Delta Chi Quarterly*, in an article by Phil S. Bradford, that fraternity goes on record as "of the opinion that college fraternities do not come within the scope of the law," and that "until final authority to the contrary is established, chapters should not prepare to pay the tax." No doubt Delta Chi has now been similarly advised by the department, as in our case.

In an article in the December, 1917, number of Banta's Greek Exchange, Nathan F. Giffen of Alpha Tau Omega arrives at the same conclusion as the writer although in that article Mr. Giffen did not enter into any discussion as to the effect on professional fraternities, expressly excluding them from his consideration.

He concludes:

"In conclusion, I may say that I am writing no brief for the statute; I believe that those who framed it as they did showed less statesmanship than they were supposed to possess; that the revenue which will be derived from this source and which will be about \$500,000 annually might better be collected from other sources, more able to pay it. But such is the law and it is our duty to abide by it."

Chapters collecting with initiation fees, cost of badges or "shingles" should remember to deduct these and similar items from the aggregate amount in determining whether they are subject to the tax. Such items are not dues or membership fees.

REPORT TO SUPREME BOARD

The following is the report of Supreme Justice Stewart to the Supreme Executive Board covering the urgent and vital questions referred to him by the other members of the board who were unable to attend the proposed board meeting because of being members of local advisory boards. The other members of the board delegated unanimously to Brother Stewart authority to dispose of these questions and have ratified his action in the premises:

To the Supreme Executive Board Phi Alpha Delta Law Fraternity:

As stated in my recent communications to this board, it became necessary with the closing of the year 1917. to appoint a successor to Supreme Financial Secretary Miller, who has ably conducted that trying office since August, 1015. Brother Miller's resignation was urgent and unqualified, and I did not feel justified in filling this most important office, with its increasing duties, without a consultation with my fellow-members, or failing in that, at least a personal canvass of the most central and likely field for selection, to wit: Chicago. The absence of many possible candidates for this office, owing to the war, further rendered a random selection by mail impracticable, and this has been amply verified by my own findings here upon arrival.

Hence my call for a conference of at least a working majority of the board. In order to attend, I was compelled to ask a leave of absence from the Legal Advisory Board of San Francisco, where I was serving. I had, of course, no absolute assurance that the attendance of other members could be procured, but felt that the particular emergency was but one of several things that demanded immediate attention. I enter thus into detail, in order that there may be no misapprehension among the board members as to the expediency of

the expenditure involved. I had already concluded that this financial outlay would have to be personally advanced by the undersigned and reimbursement indefinitely deferred, owing to the condition of the national treasury.

After a careful review of the Central-Western Field. I have procured the services of Former Tribune Frank E. Rutledge, of Webster Chapter, who has generously consented to assume the duties of Brother Miller's office upon the same basis as now provided in the Constitution Brother Rutledge is an ardent & A A, well known in several of our larger centers, and I feel that we are to be congratulated upon obtaining his assistance at this time. Brother Rutledge is not practicing law, but, as is the case with all desirable and available men, he is at present well occupied with his own business affairs and his incumbency will require a personal Especially fortunate is the sacrifice. circumstances that he will make his headquarters (care of Gaylord and Company) in the Engineers' Building, Cleveland, Ohio. With the Acting Supreme Recorder and the Supreme Financial Secretary in the same building. I feel that much of the lost time, confusion, and duplication of energy heretofore characteristic of the present system will be

I have not by any means given up the plan of a general or temporary secretary, which, however, I had not expected to institute in conjunction with the salary as outlined in the proposed Constitution. Such an inference was apparently drawn by one of our board members. At most it was my plan to ask such a secretary to serve without other compensation than a slightly increased office expense. It is hoped that the appointment of Brother Rutledge will temporarily approximate the same results and possibly lay the ground work for the new General Secretary. I shall,

at the proper and not far distant time, again urge this innovation, because I am positive its institution will mean efficiency, the presumption being, of course, that no present officer affected thereby will for a moment consider his personal status in the premises.

Realizing the difficulty a new officer always experiences in assuming his duties without a personal talk with his predecessor, I have, in the brief time at our disposal, endeavored to outline for Brother Rutledge what is officially expected of him by the Fraternity.

The U. S. Treasury Department having ruled that "college fraternities" are liable for payment of the war revenue tax, I do not for a moment think it policy for us to differentiate between the various classes of fraternities, or to claim exemption. The only undetermined question in my mind was the best method of collection. The law provides that collection shall be made through the General Secretary, or other similar officer, as in a corporation, and although the fraternity, as such, is not affected by reason of any present national tax, most of our chapters are so affected, through liability of their individual members. Any active (and as far as I can see, alumni) member paving dues or a tax or assessment exceeding twelve dollars annually, must make a payment to his local chapter monthly. For the purpose of ascertaining liability, initiation fees are added to annual or monthly dues and the return made on both. It would seem that for practical purposes, is the initiate paid his ten per cent tax upon entry, he would not thereafter be liable, unless his dues to his chapter exceeded one dollar per month. or twelve dollars annually.

Inasmuch as monthly reports are required, I am suggesting to the Supreme Financial Secretary and Recorder a new form of chapter financial report, which will perhaps assist the former officer in compiling the returns. I am leaving to them the method and details of that proposition and will be glad to have their suggestions.

The Directory is out and speaks for itself. I have taken up with the Editor a plan for local "large city" distribution, supplementary to his original plan. Sale of the entire issue would mean an early convention. I have asked the Chicago men to consider the purchase of the Directory as a patriotic contribution to the Fraternity, if it did not appeal to them on any other basis. Voucher has been issued for the proper sum and the balance due upon this voucher will be paid as soon as may be.

The QUARTERLY is being held and I have suggested to the Editor that the four issues be embodied in two, using the names, November-January and March-May, the size and cost to be the same as for two present issues. Whether we shall feel disposed or be compelled to further cut this particular expense in order to make possible a convention, is an open question for this board. I will be glad to hear suggestions thereon.

The ritual should soon be ready for presentation to the Board and I am using every means of persuasion with Brother Frank Messer to have it completed as early as possible.

The chapter survey is yet incomplete, but the Recorder is using every effort to get returns, as well as obtain the data that the 1915-1917 credentials contain.

The convention seems as far off as ever, although June, 1918, may present a more hopeful aspect. I am in favor of encouraging the district assemblies this year, if WE CANNOT MEET IN CONVENTION UNTIL CHRIST MAS, 1918. If the summer convention (1918) appears possible, then I believe that the assembly should go over until 1910.

Upon behalf of the Supreme Executive Board, I wish to convey to Bro. Glenn E. Miller, of Portland, Oregon, our keen regret that he must relinquish those arduous duties which he has so tactfully and persistently performed for two and one-half years. I know that his efforts have been greatly appreciated by his fellow-officers and I feel that he would not ask to be relieved of the duties of office did he not feel that the

military situation at Portland demanded the appointment of his successor.

I have realized that every board member may not have been so fortunate as myself in procuring a leave of absence to be present at Chicago, and in view of the fact that definite action was necessary, I have endeavored to act as nearly in accordance with what I believe to be the wishes of the other members as I possibly could. At the next regular meeting of the board, I will suggest a ratification of any action that has been taken, or that will be necessary between now and such meeting.
