

#### REPORT OF PLEDGE PIN COMMITTEE

To the Supreme Board, Phi Alpha Delta Law Fraternity:

Your Committee, appointed to investigate and report on the matter of an official pledge pin for the Fraternity, reports that it finds very little uniformity in pledge pins used in the various chapters, principally for the reason that many of the chapters, especially the newer ones, have never been informed that there is an official pledge pin and consequently have been adopting and using pledge pins of their own designs.

Your Committee believes it is very important that the pledge pin of the Fraternity be uniform so that one pledged to the Fraternity may be recognized by the older members whenever they may happen to meet. While it is true that the pledge pin is seldom seen away from the college where the chapter is located, the pledgee is nevertheless entitled to wear it wherever he goes and it is not hard to conceive of instances where pledgees may be away from the campus on trips home during vacations or while attending intercollegiate contests, making business trips, etc. Pledges are acquainted with the official badge of our members and are privileged to wear pledge pins, enabling them to be known as prospective members of the Fraternity to those who are pledged and to actual members of the Fraternity; on the other

hand, the membership at large is entitled to know, for obvious reasons, that they are so pledged.

In determining upon a design for an official pledge pin your Committee is unable to recommend a better one than the pledge pin adopted by the founders of the Fraternity, which is a button of keystone shape, notched in the upper right and left hand corners, having a gold border with a gold band or bar running diagonally from upper right hand notch to a point on the left border of pin slightly above the lower left hand corner, the fields of the pin being enamel of a distinct purple, the whole conforming as nearly as may be to the official Fraternity colors, old gold and purple.

Your Committee, therefore, recommends:

- I. That the Board adopt or rather continue in use the original pledge pin above described;
- 2. That a cut of the same be shown in the next issue of the QUARTERLY;
- 3. That arrangements be made with some manufacturing jeweler who will undertake to keep a supply of these continually on hand;
- 4. That the chapters be made acquainted with the name and address of such jeweler.

### THE NEW CONSTITUTION

(By the Supreme Justice)

For a long time I have felt that our present Constitution, respected and useful though it may once have been, was fast becoming unsuited to the needs of the greater new Phi Alpha Delta. I also felt sure that my fellow-members of the Supreme Executive Board would, when they had carefully studied the financial situation, be of like opinion, and as the two years of our administration now draw to a close, we are unanimous in the belief that an immediate and concerted effort should be made to give to the Fraternity a new and broader charter more suited to its needs.

The most casual study of the minutes of the recent meeting of the Supreme Executive Board at Chicago, which are printed in detail in this issue for this purpose, will reveal the fact that for one thing the present national system is too costly and does not make for efficiency. This condition is in no wise a result of the new biennial plan, and would have ultimately demanded attention whatever the province system, as long as the present Constitution remained unchanged as to National Officers. For the province system I have nothing but praise. The difficulties did not present themselves as long as we were small and few in number of chapters, but our tremendous growth has made plain the inadaptability of those portions which provide for National Officers. It has also been impossible to obey the present Constitution as to the holding of meetings of the Board. If but one meeting were held each year (and as a matter of fact that is all that was held, although the Constitution calls for four) the present Constitution would still mean bankruptcy to us, as it is necessary to bring together seven members from all parts of the United States, at a cost of approximately \$550 for railroad fare and traveling expense alone. Yet we must have a managing board of reasonable dimensions, and not alone one but properly two meetings each year.

In the second place it is difficult to assemble so large a number of officers at a time convenient to all, even if such number were actually required to do the work, an assumption which may be negatived at the start, with the concurrence of all present members. Board members repre-

sent no locality and certain officers now on the Board could accomplish practically the same work if they carried on a well directed correspondence, and rendered periodical reports to a much smaller Supreme Executive Board, as well as to the Convention as heretofore.

We have too many Supreme Officers whose expenses to Convention must be met as long as they encumber the National system. Their places at Convention might better be filled by the District Justices, whom we now charge with responsibility for the welfare of their respective districts, and who do not go out of office at the same time as the National Officers. They should be required to attend the Convention and to take back to their respective districts the spirit and enthusiasm of that body, as well as a thorough understanding of what the coming year's policy will be. They are the only link between the National and District systems.

Returning again to the functions of the Supreme Officers, there is too much red tape attached to the handling of Fraternity money. The administrative and secretarial work incident to the office of Supreme Recorder may very well be combined with the work of the Supreme Financial Secretary and the Treasurer. There should be but one place to which and one officer to whom all funds should be sent and all correspondence directed. This alone would eliminate endless delay and confusion. On the other hand, the office in which these duties are combined should carry with it a salary as nearly commensurate as possible with the work it entails. For many years Conventions have seriously considered the necessity of providing some compensation for those officers whose duties were most arduous and exacting. The most that has been done has been to provide reasonable office expenses for the Supreme Officers, notably that of the Editor. Under our new plan the payment of a salary to the General Secretary will be unavoidable, but the provision for a reasonable per capita tax of \$5.00 at least, will permit of this arrangement and at the same time we will be able to remove that much assailed section which provides for the magazine tax of \$1.50.

Modern books of account must be kept in approved manner and closed regularly in time for audit at least once a year. Vouchers must be issued without delay. Correspondence must receive attention—not after the law work of the officer, but at least with like despatch. The tremendous financial sacrifice always required and heretofore experienced in greater or less degree by our leading executive officers, must be reduced to a minimum. Otherwise, competent brothers will not be found for the positions that demand special ability, as well as experience. With a proper system, service to the Fraternity may be made a condition subsequent to the tenure of office. Let no one presume to even aspire to an office, who does not stand willing and as equally able to devote the necessary time and attention to its efficient administration.

These are some of the changes that are essential. There are many which become necessary in order to give effect to the foregoing, and yet others still which may not appear absolutely necessary but in the view of the Supreme Executive Board are nevertheless highly recommended, and therefore embodied in the draft which is being submitted to the chapters. It is fully realized that this draft is not perfect, but it has been drawn only after years of experience on Constitutional revision committees, and the extensive annotations made during my incumbency in office, when the weakness of the old system has again and again been forced upon my attention. There may be minor points as to the expediency of which both the undersigned and the Supreme Board have had some doubt, but in cases of this character the points were given earnest thought and left to the option of the chapters.

A radical change is required. Mere superficial treatment is worse than none, as it gives a false sense of security. It is also unfair to the incoming administration which we would like to see untrammeled by the difficulties that have beset our own. The larger portion of the present Constitution will be recognized as having been merely rearranged in logical and systematic order, with occasional additions and eliminations. A comprehensive index has been added, which it is also planned to carry along in connection with the body or subject-matter proper, by indentation throughout the paragraphs. This is so complete and easy of reference as to save the need and extra expense of printing cross-references.

Finally it is desired that the chapters have as full an opportunity as possible to consider and study the proposed document, and to this end it is suggested that the chapter meeting is far superior both in available time and judgment, to the efforts of any one delegate from such chapter. Ample time will be given for consideration and return to this office, and space provided for comment. The serious objection of a majority to a minor feature as submitted, will mean its elimination from the draft to be finally passed upon by the Convention in July, but at that time it is trusted that no delegate will venture to question that which has been studiously given the previous O. K. of his chapter. It would be impossible to give serious attention to many differences of opinion at Convention. That is the reason for submitting the draft now. By no other means can the prodigious task be accomplished.

The Supreme Executive Board members have eliminated all other questions but that of good of the Fraternity and it is submitted that if the adoption of the new Constitution be all that is accomplished by them, their labors will not have been in vain.

Owing to the absence of the Supreme Recorder and the unexpected burden that the work would entail upon the Acting Recorder, Brother Myers, as well as my own familiarity with the draft, I have assumed the task of submitting the same to the chapters and I will greatly appreciate promptness upon the part of the chapter officers in the consideration and the return of same.

Brother Messer, whose progressive spirit is well known to our older members, has a penchant for work and has accepted the office. He will be assisted in an advisory capacity by Brothers Robert E. Lee (Hughes), Denver, Colo., and Nelson R. Anderson (Marshall) of Seattle, Wash. All appointees are actively engaged in the practice of the law.

Brother Messer may be addressed at Iowa City, Iowa. It is hoped that the new draft will be ready for the perusal of both the Supreme Executive Board and the subordinate chapters, prior to the next Convention.

### MINUTES OF THE BOARD MEETING

Minutes of meeting of the Supreme Executive Board of Phi Alpha Delta Law Fraternity, at the LaSalle Hotel, Chicago, Illinois, on December 30 and December 31, A. D. 1916, beginning at 10 o'clock A. M. on December 30.

Members Present: George L. Stewart. Supreme Justice; C. G. Roads, Supreme Recorder; Glenn E. Miller, Supreme Financial Secretary; A. J. Hart, Supreme Treasurer; Oscar W. Hoberg, Editor-in-chief; Joseph P. O'Connell, Supreme Historian.

Members Absent: James W. Barnitt, First Supreme Vice Justice.

Upon the meeting being called to order by the Supreme Justice, the minutes of the last meeting were read and approved.

Brother Stewart, Supreme Justice, reported that he had for presentation for the consideration of the board members, a draft of the Constitution amended in accordance with the urgent necessities of the Fraternity as created by its rapid and widespread growth, and recommended by him for adoption by the Board. Upon motion said draft was laid upon the table and held for consideration in its regular order.

A communication from Brother Barnitt, First Supreme Vice Justice, expressing his regret for his inability to attend the meeting was then read.

Brother Roads, Supreme Recorder, reported that because of his absence from Cleveland, he had been unable actively to perform the duties of his office and that Brother George S. Myers of Hay Chapter, Cleveland, Ohio, had been appointed by the Supreme Justice to perform the duties of that office. Upon motion the appointment of Brother Myers was unanimously ratified. Brother Miller, Supreme Financial Secretary, reported that since the last meeting of the board he had received from various chapters the sum of \$2200.00, and that the balance on hand

is \$38.76, the remainder having been r matted to the Supreme Treasurer. He also reported that the following chapes had failed to discharge wholly or in part their financial obligations for the school year of 1915-1916: Capen, Calhoun, Clay, Jefferson, Garland, Rapallo, Hamlin, Staples, Dunbar, Gunter, Holmes, and Lawson. Upon motion said report was ordered approved and incorporated in the minutes.

Brother Hart, Supreme Treasurer, reported that he had a balance of \$510.44 on hand and that all outstanding vouchers with the exception of a voucher of \$76.66 had been paid. Upon motion said report was ordered approved and incorporated in the minutes

Brother Hoberg, Editor-in-chief, reported that the November issue of the QUARTERLY had been printed and sent to the various chapters and that the cost of the same had been within the estimate of \$400,00 per issue as laid down by the Supreme Executive Board. He further reported that the next issue of the QUARTERLY would go to press on January 15. A motion was carried. approving this report and further approving the style and contents of the first issue of the QUARTERLY, and instructing Brother Hoberg to continue the same policy.

Brother O' Connell, Supreme Historian, reported that the work of compiling the data for the directory had been practically completed and that he had received bids for the printing of the same. Upon motion said report was approved and Brother O'Connell was instructed to proceed at the earliest possible moment with the printing of the directory at an approximate total expense of \$700.00.

The names of Hon. C. H. Cahan and Mr. C. H. Cahan, Jr., presented by Rapallo Chapter as candidates for honorary membership were approved; and the names of the candidates who had been approved by mail for honorary membership were ordered approved.

The Ritual Committee heretofore appointed by the Supreme Justice in accordance with the resolution adopted by the sixteenth convention was upon motion ordered dissolved and Brother Stewart was instructed to appoint a new committee which would proceed at once with the work of drawing up a new Ritual.

The report of the committee on a uniform pledge pin was then read and upon motion was approved. The same was referred to Editor Hoberg with instructions to report the findings of the committee in the next issue of the

QUARTERLY together with a cut or design of the pin as described in said report.

The matter of the 1915 convention fund was then brought up for discussion and Brother Stewart reported that a number of chapters had failed wholly or in part to pay the assessments prescribed by the resolution creating the fund. Upon motion it was unanimously agreed that every effort should be made to collect this fund and Brother Stewart was instructed to take charge of the work of collecting the full amount due from the delinquent chapters.

A motion was carried instructing the Supreme Recorder to require each chapter to furnish on or before January 30, 1917, a complete list of the active members of the chapter as of January 1, said list to be signed and verified by the Clerk and the Justice of the chapter.

A resolution was proposed and carried expressing it as the consensus of opinion that chapters should be more strict in the enforcement of the obligations due from their members and that all chapters should at once collect all moneys due and payable to them from their members, resorting to the expulsion of the delinquent members if necessary.

A motion was carried instructing Brother Stewart to investigate Garland Chapter at once and expressing the sense of the board members that unless the obligations of this chapter be paid before the next convention, a recommendation should be made to the 1917 convention that the charter of this chapter be revoked.

Brother Glenn E. Miller was instructed to make a thorough investigation of Williams Chapter and to make a recommendation to the Supreme Board at its next meeting as to what, if any, action should be taken with reference to this chapter.

A motion carried that Brother W. S. Culbertson be requested to personally investigate Calhoun Chapter and ascertain its financial standing with the Supreme Chapter.

Motion carried that Brother John Doyle Carmody be requested to aid District Justice Culbertson in an investigation of Staples and Jefferson Chapters and ascertain their financial standing with the Supreme Chapter and make such recommendation to the Supreme Justice as might seem to him advisable.

Upon motion Brother Glenn E. Miller was instructed to collect the initiation fee of \$5.00 per man from McReynolds Chapter for each and every charter member of said chapter.

The Supreme Recorder reported that inquiries with reference to the installation of a new chapter of Phi Alpha Delta had been received from the Minnesota College of Law, the University of Florida, Cumberland University,

Ohio State University and the Indiana Law School. The Supreme Recorder was instructed to take up for further consideration the inquiries from the University of Florida and from Ohio State University.

The matter of the election of directors of the corporation of Phi Alpha Delta Law Fraternity, in compliance with the Illinois Law with reference to corporations, was brought up for discussion. A motion was carried instructing Brother Stewart to prepare and file with the Secretary of State of Illinois a certificate showing the names of the members of the Supreme Executive Board and the dates of their election.

The date and place of holding the seventeenth convention was brought up for discussion. After considerable discussion a motion was carried fixing the date of said convention July 12, 13, 14, 1917, and the place of said convention at Chicago, Illinois.

By previous arrangement with the Supreme Justice, Brother George G. Landon reported on conditions at Magruder Chapter and the custom of said chapter with reference to the pledging and initiating of pre-legal men. Brother Landon was instructed to advise his chapter that it would be necessary for the chapter to comply with the rules of the board and with the resolutions of the past conventions on this point.

The amended draft of the constitution as prepared by Brother Stewart was next brought up for consideration. After careful discussion item by item, a number of amendments were unanimously agreed upon by the board. Brother Stewart was instructed to prepare copies of the constitution as amended by the Board and submit the same to each of the subordinate chapters in the Fraternity at the earliest date advising them that the amendments were proposed and endorsed by the Supreme Board and that the same would

be submitted to them for their consideration at the next convention.

Upon motion Brother Hoberg was instructed to send to each of the new chapters of Phi Alpha Delta all available issues of the past editions of the Phi Alpha Delta Quarterly.

Brother Stewart finally called the Board's attention to a resolution passed by a former convention, authorizing and directing the publication of the Minutes of the 1914 Convention at Chicago, and to the later recommendation of the Central District Assembly that said Minutes be printed. He further stated that to

date he had been unable to procure the official transcribed copy from present or past officers. The Board thereupon ordered the Editor, Recorder, and Historian, respectively, to institute a thorough and systematic search for said Minutes and report to the Supreme Justice at an early date.

Upon motion the meeting was adjourned.

## PERSONAL NOTES ON THE FIRST ASSEMBLY OF THE PACIFIC DISTRICT

The Pacific District of our Fraternity being the entire Pacific slope of the United States and including chapters in Idaho, Washington, Oregon, and California, is one of great distances and it was a problem as to where the Assembly should be held in order that the greatest number could attend at the least expense.

San Francisco is the central point, but we felt in view of the splendid efforts put forth by San Francisco at the last National Convention, that it would be riding our horse too hard. You see, we of the Pacific Coast like San Francisco all the time, and don't want to impose too much upon her

hospitality. So a suggestion was received from each of the nine chapters comprising this District as to the assembly place, and finally Portland, Oregon, was agreed upon. The Los Angeles delegates had a long hard pull but we got there.

Three from Los Angeles, Howard B. Henshey, Clinton F. Seccombe, and the writer left the "Angel City" on the good ship *Harvard* on the eleventh of July, 1916, arriving in San Francisco the next morning. The alumni chapter of San Francisco, with its usual "good taste" had arranged a luncheon at the Commercial Club, which was satisfactorily disposed of. Then the next

day the Los Angeles "3" were joined by the Supreme Justice, Emil R. Hoerschner, and one Milton W. Vedder; this last a person of rare attainments, of which more later.

We all stepped upon the "Floating Palace of the Pacific," the leviathan Great Northern, and she was some boat. No sooner on board than cries of "When do we eat" from the worldly, mingled with cries of "Gee, some bearcat; some curly wolf" from the esthetics in our bunch. This person Vedder, mentioned above and young Henshey were extremely agitated over the appearance of two "fair ones" from Portland, and they adopted various forms of finesse in getting to them. Oh, yes! they got 'em.

The rest of us were of a more sober mind, remembering that those of us who were not married were engaged, and so we conducted ourselves accordingly. (This last now squares us all.)

After an eventful trip, which will live long in our memories, and during which Hoerschner looked pale, and Vedder and Henshey saw them all, we arrived at Flavel, Oregon, where we took a train for Portland 125 miles away, with nothing to eat until we got there.

Finally we arrived and watched Brother McCarl of Portland pay the Hotel Benson bus two bits per head in order to ride five blocks in order to register at the said Hotel, in order that they would know our names, in order that the bookkeeper could make out our bills correctly. SHE DID.

That night (July 14, 1916) we called the Assembly to order, with all chapters represented by delegates except Dunbar, located at Seattle, and whose location was one of the reasons the Assembly was called at Portland.

The permanent organization was perfected that evening. Next day constructive work was taken up, and we remained in session all day, except, of course, the lunch hour, which was taken in order to appease Brother Vedder, whose cry from about 11:30 on was "When do we eat?"

The next day, Sunday, we viewed the Oregon "mist" (how these Oregonians kid themselves; it rained like h---), and now and then caught a glimpse of a house between rain-drops. Brother Hitch of Portland had impressed a fair damsel with our importance, and she graciously drove four of us all around Portland seeing the sights. We remember her. Two of us, to wit, Henshey and McDougall, this latter from Idaho decided to see Washington, and crossed the river to Vancouver, where they picked some Vancouver cherries. Vancouver is an Army post, and the soldiers were away in Mexico, so from the reports of the two gentlemen above named it was a nice trip.

Monday we again held a session of the Assembly in the morning. After luncheon the Portland boys motored us out along the Columbia River Highway. This is one of the scenic drives of America the road winding for miles alongside of the famous river, passing every now and then falls of sheer beauty. I mean water-falls. Good old Al (Ridgway) drove the car the writer was in, and gave a splendid exhibition of handling an automobile. His only trouble was that as "fair ones" were passed, he refused to stop, or even hesitate.

The next day (Tuesday) we left Portland, one shy. Sometime the above mentioned Vedder decided he knew a "speak-easy" in Seattle, and proceeded North.

And this brings me to a much discussed problem, to wit, the dryness of Portland. The state has a prohibition law which prevents anyone from drinking less than two quarts of whiskey or twenty-four bottles of beer at a time.

"Louis" and "Don" of Portland proved that the briskness of their Northern climate certainly did keep men in better condition than the warmer more sensuous parts of our country. I have nothing but praise for them; they are "MEN."

Going back to San Francisco, the whole affair was gone over, and all present voted Portland a splendid city, but we are hoping some day to meet its weather man. It is only a small world and some day we shall meet. No violence now, boys.

Those of us from Los Angeles were gone from home eleven days. Eleven days crammed full of excitement, sight-seeing, sea-sickness, Portland, rain, and the spirit of Phi Alpha Delta. And right now before I forget I want three cheers for George Stewart. He gives his time and his money unselfishly that  $\Phi$  A  $\Delta$  might prosper, and his spirit it was which dominated our Assembly. It was his good ideas that caused the

thought and constructive work gone through at the Assembly.

The next Assembly will be held in Los Angeles in 1918. To those of the fraternity who have never really seen "God's Country" a cordial invitation is hereby given. Put it down in your date book—"Los Angeles—1918." It will be well remembered, we guarantee.

We had some Assembly, believe me. You of the fraternity who were lucky enough to attend last year's Convention at San Francisco know what the West can do, and know the real meaning of California. We are daily looking for immigrants composed of those who were present last year. You know you have only a short span of life, why not enjoy it most by living where it is most enjoyed.

And again I say, we had some Assembly. If you don't believe me, ask "George."

#### THE COLLEGES IN CONGRESS

In England the leading universities are represented directly in parliament by members elected by the alumni. In the United States we have no such system, but, nevertheless, our collegesand an astonishingly large number of them-get represented in congress. By the 380 members of the present senate and house who report collegiate education, 173 different institutions are named. No college would have more than two if they were equally distributed, but they are not. The University of Michigan, with twenty-seven of its graduates in congress, still holds the Washington pennant which it wrested from Yale some years ago. The University of Virginia, as we should expect under a democratic régime, follows

next with twenty. Then come Harvard, nineteen; Yale, thirteen; Wisconsin, ten; Alabama, seven; Mississippi, seven; Missouri, seven; Minnesota, six; Iowa, six; and Georgia, six. The fact that of the eleven institutions which have more than five representatives in congress all but two are state universities, shows what an important factor in political life these institutions have become. It is equally interesting to observe that such large and important universities as Columbia, Pennsylvania, Cornell, and Princeton have only three of their men in congress and Johns Hopkins and Stanford none at all. Twenty-eight per cent of the members mention no institution of higher education and presumably attended none.—New York Independent.

## **EDITORIALLY**

CONVENTION THOUGHTS

In consequence of the San Francisco Convention's having adjourned *sine die*, the Supreme Executive Board at its last meeting fixed Thursday, Friday, and

Saturday, July 12, 13, and 14, 1917, as the time and Chicago, or vicinity, as the place of holding the first biennial Convention of the Fraternity.

The time fixed, while unfortunate in point of being in the mid-summer heat, was, nevertheless, believed to be the best time for bringing together the graduate and undergraduate members. At other seasons of the year the older members' attentions are closely engaged in practice and business, and the Order can better afford some discomfiture caused by weather conditions than the absence of many of the older and ever faithful brothers.

Chicago, or its environs, came both as a logical and necessary choice. Aside from its central location and financial considerations that city has always had a natural and preëmptory claim on the Convention, as "the cradle of Phi Alpha Delta." These details were decided after no little deliberation, in which the suggestions of those Assemblies, which offered an expression in these matters, were not disregarded.

Chapters which have not already done so, should at once choose their delegates and alternates. The program for the Convention will be peculiarly replete with action upon matters of a constructive character and departures from some of the older policies of the Order. This mass of proposed changes should be thoroughly digested by delegates before the Convention is called to order, so that the program may be carried out with the despatch the amount and importance of these matters demands. No little useless debate, which prevented matters from reaching an early vote, has been responsible for the small achievement of several past conventions.

WHY MAGAZINES
ARE NOT RECEIVED

Several chapters have complained to this office that they did not receive their quota of the November number of the QUARTERLY. We have

often repeated this: that when a chapter does not advise this office of the name and address of its correspondent or clerk, we send the QUARTERLIES to the best available address: viz, to the chapter in care of the law school to which it is accredited. When this is done one delivery only is attempted by the postoffice, often and if not successful the matter is advertised, with rarely a response.

Please remember that in order to be assured of your QUARTERLIES reaching you, we must have some definite address. If we do not have this, and you fail to receive the magazines, do not impute the fault to this office. We are interested in having every QUARTERLY reach the proper officer. In the case of the November issue this neglect and consequent non-receipt was particularly unfortunate as there was a decided shortage in the number printed, and lost copies could not be supplied by this office.

THAT ORDEAL
THE "EXAMS"

One cannot read the chapter letters in this number without appreciating that active men regard "exams" as a most uncomfortable ordeal. We believe it has "been ever thus." Yet the bustle, excitement and dread "exams" appear to engender, remind us of the soldier and lawyer unprepared for the contest. There is the same excitement and realization of shortcomings. It stands out too prominently. Dread of "exams" spells unpreparedness. It is a confession of weakness. There is no "short cut" or Aladdin's lamp method, in or out of college. By keeping abreast throughout the semester, dread of examinations wears off. Yes, we are inclined to deliver a preachment now and then.

There has been a growing demand for the publication in the QUARTERLY of a correspondence list of active chapters, to be revised with each number. This office now chiefly concerns itself only with the name and address of the member in each chapter who furnishes the chapter's correspondence to the QUARTERLY. In many cases this member is not the proper person to whom to address general fraternity correspondence. Active chapter correspondents are, therefore, requested to supply this office with the name and address of the brother to whom general fraternity correspondence is to be directed, without fail before the next number for this feature. If sent with the chapter letter before March 15, next, this matter will be in due time.

THAT "ANTI-PRO" In the exchange department of this number we reprint an article written by Carlyle S. Baer, Asso-SENTIMENT ciate Editor of The Owl of Σ N Φ (legal) and appearing in the January number of that journal. The article is timely. The professional and honorary Greek-letter Fraternities have always been rather kindly disposed toward the general or social Fraternities, but the latter do not always accord the former the same sincere consideration. The later numbers of the general fraternity journals voice directly or indirectly a renewal of sentiment against the professional fraternity, in particular, which appears to have been dormant for some years. The opposition of the general Fraternity, as appears from the recent articles mentioned, is laid to the fact that there is some incongruity in the professions and aims of the professional fraternity. In spite of all that has been thus far charged against the professional Fraternity we are not convinced that the spirit of brotherhood among men preparing for, or in the same, or a similar calling, is not much intensified by common interests. And the stronger the bond of brotherhood, however effected, so long as the means and end be honorable, the greater the Order. While we are not prepared to say that any desirable advantages would accrue to a member of a fraternity, confining membership to those who have a hankering for hovering over a pool table, or to those who aspire to possess all the dance programs of a season, the success of all representative professional fraternities, in essential things, would seem to demonstrate that our critics often confuse facts with fancies. It makes us chuckle to have a general fraternity magazine assign as a reason for its opposition to them that the professional fraternity draws men from the general fraternity, which is a common complaint. It always reminds us of that exclamation of spinsterhood, "I saw him first." The strength of any fraternal organization lies not in its ability to acquire men, but in its ability to hold men. If a member of a general Fraternity on joining a professional fraternity ordinarily loses his interest and loyalty in the former as a consequence, (which we do not believe is in any degree as prevalent as the general fraternity writers are inclined to believe,) the fault would seem to be not with the man, but with the general Fraternity. There is no reason why a man cannot be loyal to both. Men have many interests. They belong to one or the other of political parties, a religious denomination, and various other organizations and yet do not thereby necessarily lose their interest in any of them. The preferences men have are natural and cannot be overcome. We do not doubt that there are professional Fraternity men who still prefer to identify themselves more actively with their general Fraternity. It is obvious that men are not all constituted alike. But if it is generally true that a general Fraternity man loses his allegiance to it on becoming a member of a professional Fraternity, which we most seriously doubt, then the weakness of general Fraternities to hold their members must be conceded. If general Fraternity writers mean that the obligation of a general Fraternity man to his Order is one that in any manner enjoins him to deny himself other advantageous and beneficial affiliations, then they have yet to discover that all true brotherhood comes from volition and not injunction. All in all, we feel that the anti-professional Fraternity sentiment among these general Fraternity writers would be quickly dissipated by an impartial investigation of general conditions in this regard, rather than of isolated cases.

#### COLLEGE POLITICS

In looking over some of the causes for fraternity agitation we have discovered the fact that the activity of the

fraternities as a unit in college politics have been at the bottom of it all. In many places there is a tendency among the fraternities to grab or control all of the elective offices in the college-and as a result the fraternities are pitted against the nonfraternity members. Of course, the fraternity men as such have no right to monopolize politics—though being in the minority it does seem as if the ability to elect their candidate should be rewarded. However, the same foresight should enable them to see that the very contest in which they delight may be their undoing, for it is seldom that such contests do not make an enemy. It is well for fraternity men to be interested in college affairs; and they are not loyal to the college if they are not. Such interest, however, should be as a college student and not as a fraternity member. The fraternity should be always kept in the background. And while participating in college affairs it is well to forget that one is a fraternity member except to express that nobler concept of the gentleman and brotherhood which one's fraternity teaches. Fraternities can not have too many friends-and the college is a good place to begin their cultivation.—Σ A E Record.

#### FRATERNAL MISINFORMATION

"The Greek-letter press has noted merit of late with reference to the professional and honorary fraternities. It can plainly be seen that the college fraternities as such are getting ready to stir up agitation in direct opposition to those fraternities which are classed as professional and honorary. The articles which have come to your Associate Editor's notice are aimed directly at us as fraternities, and are so biased as to be interesting reading material, hence I reproduce them in full for the benefit of fraters in Sigma Nu Phi.

"The first of these articles to come to my attention is clipped from The QUAR-TERLY of Phi Alpha Delta, one of the legal fraternities classed by the general college fraternities as professional. The article was taken by The QUARTERLY from the Quarterly of Beta Theta Pi, and appears in Vol. 9, Number I, of The Quarterly. The article follows:

"'Some men seem to take delight in making a collection of fraternity badges. We recently saw in one of the college annuals the name of an assistant professor with nine separate titles in Greek after his name, and it really looked as though he had been taking courses of study in different departments for the purpose of joining different Greekletter societies in such departments. This problem is becoming a real serious one and will have to be taken up and considered, and so far as our fraternity is concerned, decided, if we are not going to lose much of the loyalty and enthusiasm of our members and have their energy dissipated away in all sorts of undesirable directions.'

"The above was followed by a sharper and more direct attack in *The Centaur* of Alpha Kappa Kappa (professional medical fraternity). This article is copied by *The Centaur* evidently, inasmuch as it appears in quotation marks, but the source is not made known:

"'Not content with their characters as learned societies, they now aspire to fraternalism in its true sense; they have begun the renting and building of chapter houses, and worst of all, many, if not all, not only admit barbs and Greeks alike to their ranks, but are in open and ofttimes hostile competition with the general college fraternities for material. That is to say, they are now seeking the level of the general college fraternities.

"'No serious objection can be taken to this, if they will assume the duties of self-respecting general fraternities at the same time that they seek their advantage. If they wish to be general fraternities, the right hand of welcome awaits more fraternities. But they must then assume every ethical obligation now resting upon decent general fraternities, and they must cease to initiate men who are already members of the general fraternities. They cannot be both fish and fowl. They cannot be permitted to hold themselves forth as a class different from us for one purpose (that is, for the purpose of initiating our members) and as like us for another purpose (that is, for the purpose of competing with us).

"'Whatever may have been the practice in the past, no self-respecting college fraternity will today admit to its ranks the members of any other college fraternity. Indeed, even expelled members of a fraternity find that the bars of all others are closed to them with possibly rare exceptions. Yet these fraternities are in close competition with each other and have been so from the very beginning of the Greek world. Why then should professional fraternities, likewise now in competition with us, be permitted to initiate our members? They are neither fish, fowl, nor good red herring.

"The naked truth is that they are college fraternities in order to compete for barbarians and professional fraternities in order to initiate fraternity men. To nonfraternity men they pretend to offer all the advantages of a general fraternity, and to fraternity men they propose advantages which their general fraternities are supposed to be unable to supply. And we respectfully submit that they must be either one or the other, and that if they persist in being both, the strong arm of the general fraternity must be exerted against them."

"'The third and by far the most crude article that your Editor has read, or that has been brought to his attention, is the following taken in full from *The Carnation* of Delta Sigma Phi:

"'Dean Clark, in his clever little book, The Fraternity and the College, says, in recalling one of his experiences with fraternity men, that "in the eyes of the

fraternity man . . . . there was no honor so great as being bid something else, and nothing so much to be desired as to belong to an organization outside of the fraternity, unless it were to belong to a number of such groups of men." Here is clearly stated one of the greatest sources of evil in the whole fraternity system. The time is coming when the undergraduate fraternity will go to the mat with this problem of extrafraternity organizations. Plainly stated. the question is this: are we going to permit the so-called honor and "ribbon" societies to suck, leech-like, the vitality from the legitimate undergraduate fraternities?

"These organizations primarily depend upon the regular fraternity for their existence. In the majority of cases only fraternity men are eligible, a condition that will militate against the goodwill of the college because it destroys democracy, promotes snobbishness, and lends color to the charge of the "barb" that fraternity men are clannish. They dissipate energy that might be well employed by the fraternity man to the benefit of his own organization. They are a constant drain on his financial resources, the burden of which is thrown on his fraternity because he tries to meet all his obligations and ends up by not paying any. They create jealousies among members of the same fraternity, and factions develop, all because the men so honored carry a few more secrets than the rest.

"'The most serious indictment that can be raised against them is that they are generally not responsible and serve no honest or worthy purpose in college life. Their initiations are nearly always public, crude, vulgar exhibitions that, as Dean Clark aptly says, "tend to bring all fraternities into disrepute in the minds of the general public, who do not discriminate in any way between the methods employed by the various organizations which have the name of frater-

nity." This is not an over-statement of conditions. We have seen these things with our own eyes. And what shall the answer be when, as The Delta of Sigma Nu remarks, at least one "professional" fraternity drops the mask, appearing in direct competition with the regular fraternities, with the result that alumni members are automatically placed in rival organizations? Shall we suffer this fraternity parasite to thrive and eat its way into the fraternity system destroving in its path those virtues which we have won and cherished for nearly a century?"

"The writer of this article will take for granted that the writers of these three articles are in all cases members of but the one fraternity whose medium they use in giving to the world a lot of peculiarly misleading information. They are not representative of the best thought in the fraternity world of today. They show positive opposition to groups of men who were not organized to compete with the college fraternities, and who are not doing so. They show a lack of feeling and sympathy that a fraternity man hardly expects to find in another fraternity man, even though one should belong to an organization founded in the early history of the United States while the other to an organization founded in 1915.

"The article in The Carnation of Delta Sigma Phi is so hopelessly untrue in general, as it would lead you to believe, as to be worthy of but little serious attention. It not only attacks the professional and honorary fraternity system as they now exist in these fields. but it gives a lot of most startling information with reference to professional fraternities, that even members of these 'so-called invaders' themselves did not know. Quoting from this article I find 'they dissipate energy'; 'they are a constant drain on his financial resources'; 'they are generally not responsible and serve no honest pur-

pose': 'their initiations are nearly always public, crude, vulgar exhibitions'; 'shall we suffer this fraternity parasite to thrive and eat its way into the fraternity system,' etc., etc. hardly seems fair for this writer to hide his identity in an unsigned article. If it should come to a fight to a finish, I know the men who hold dual fraternity memberships will refuse to give them up. In the writer's own range of experience as a dual fraternity man the above articles are not only untrue but are excellent examples of already biased minds. In my own case, in a professional fraternity, every member of my chapter was a member of more than one fraternity, and I can say truthfully and without fear of contradiction, all of them stood out as big men in their general fraternities as well as in their professional fraternities. They were responsible men belonging to responsible fraternities, and I know they will back me up in my contention that we, as a chapter, were of more than ordinary merit, a representative chapter of a professional fraternity, responsible both morally and financially, whose ritual and initiation are the reverse of what this writer says is characteristic of the ritual of professional fraternities—'nearly always public, crude, vulgar exhibitions.' defense the writer of the anonymous article will refer me to the initiations of some of the medical professionals, some of whose initiations have been criticized both inside and outside of the fraternity world, but I ask why condemn the whole because a very small part is bad or objectionable. There are dark spots in many religions, fraternities, fraternal organizations, and races, but is one justified in branding all of any one religion, fraternity, lodge, or race as bad or serving no honest purpose because there are defects in one small branch or because one of its members or adherents goes astray. As a law fraternity we neither aspire to the place of the

general college fraternity nor are we in conflict with any of the tenets of any of the college fraternities. We occupy a niche all our own, and we firmly believe we occupy it so well that we are destined to go to better things and to a larger life that the future holds in store for us. We are willing to meet honest criticism, but we are not willing to besmirch ourselves to fling back mud that is thrown at us.

"The professional fraternity has no doubt changed materially as it has developed. As the Editor of The Centaur of Alpha Kappa Kappa has aptly expressed it: 'It arose in the first place because it supplied some wants the general fraternity did not give, and it assumed more of the appearance because in that way it could become more useful." -Owl of  $\Sigma$  N  $\Phi$ .


