History of the University of North Carolina Law School

The Law School which developed into the Law School of the University was founded in 1843 at Chapel Hill, as a private school by Hon, William H. Battle, then a judge of the Superior Court of the State. In 1845 Judge Battle was made Professor of Law in the University, and it was provided that the degree of Bachelor of Laws should be conferred on those completing the prescribed two-year course. Judge Battle was assisted by Hon. Samuel F. Phillips, a member of the Bar of North Carolina, who afterwards was Solicitor General of the United States, under the administration of Presidents Grant, Haves, Garfield, and Arthur. For a long time the school maintained a certain independence of the University. In 1899, however, the school was completely incorporated into the University, with the late Judge James C. MacRae, previously a justice of the Supreme Court of North Carolina, as the first Dean of the Law School. The courses of instruction in the Law School, originally requiring two years study for Bachelor of Laws degree, was increased to three years in 1919.

The Law School occupies a separate building situated on the campus of the University of North Carolina. A library of nearly 6,500 volumes is maintained for the use of the students and faculty, containing the reports of several of the States, the National Reporter System, the complete reports of the United States Supreme Court and other Federal Courts, English Common Law and Chancery Reports, and others too numerous to mention.

Last year a very radical change was made in the moot court. Instead of the old moot court several Law Clubs were organized consisting of about twelve members each. The purpose of these Law Clubs is to drill the student in the art of searching for the law and relate it to an agreed set of facts. The procedure in the Law Club work is practically the same as that before the Supreme Court—only questions of law being argued. Besides these Law Clubs there is only one other organization in the Law School, that being a chapter of the Phi Delta Phi Legal Fraternity.

The Law School is the leading Law School of the State of North Carolina. Its teaching staff numbers four full time men and its course leading to law degree in three years. At the present time membership is sought in the American Association of Law Schools, the Law School being able to comply with all requirements for admission to that association. The method of instruction is that of case-book. The passing grade is seventy. There are approximately one hundred and fifty students enrolled in the Law School at present, ninety per cent of whom have had college training of one year or more, the school is co-educational. In quality of the work done and standing among the profession, the Law School is entitled to rank as one of the leading law schools of the South.

The Ruffin Law Club

The Ruffin Law Club is the outgrowth of a spontaneous desire for expression of the real spirit of scholarship in the Law School of the University of North Carolina. Its original name was Omega Alpha by which name it was known from its beginning in the fall of 1919 till the recent realization by its members of the need of a more representative designation, which realization

expressed itself in the present name.

As already noted the history of the Club is rather brief, but the motive that actuated its charter members-ten in numberwas such as to inspire it with confidence in the possibility of a wonderful accomplishment in the Law School from the beginning. Its members, while taking no undue credit to themselves, considered that they were representative of the legal type of mind in scholarship at the University of North Carolina and set themselves to the task as they saw it confronting the student body of the Law School. They considered that the Law School was falling short of its legitimate goal yearly on account of a lack of mutual understanding among the students themselves and a lack of concerted action in the attainment of the highest standard in scholarship.


The local meetings proved quite a success and much beyond the original expectation of the members, but, being handicapped by a limited appeal made inevitable by the existence in the Law School of a chapter of a national legal fraternity, the Ruffin Law Club members conceived the larger vision for usefulness made possible by identification with an active national organization. This vision, heightened and increased by sincere encouragement of the Dean of the law school, naturally suggested the step that followed. After due consideration, therefore, and a careful study of the relative merits they set to work in earnest to secure a chapter under the Phi Alpha Delta National Fraternity.

Owing to its brief existence and the purpose for which it was organized and membership of the Ruffin Law Club has never been very large. Two of its members are now practicing law in the state and doing well. Three others, licensed attorneys at the present, are agin in school for degrees. The men in school at present—fifteen in number—are picked on account of their eminent scholarship and general promising qualities. They are friends of the Law School. They stick together and enjoy the benefits of the best understanding. The association is stimulating and helpful.

The officers of the club are: A President, Vice President, Clerk and Treasurer. These hold office for the quarter. Meetings are held in the Y. M. C. A. and are devoted to the problems outlined above. We expect soon to be enabled more comfortably to hold meetings in the proposed Graham Memorial Building.

The Club is named for Chief Justice Thomas Ruffin-Chief

Justice of North Carolina from 1840 to 1848. It was in grateful recognition of the conspicuous ability displayed by him while on the bench and the fond memory we cherish of the distinction accorded him by Chief Justice Marshall and his decisions in the halls of Wesminister in England that we chose the name dear to every aspiring attorney of the State.

Dear Sir and Brother:

In pursuance of your request of November 1st, I visited the Omega Alpha Law Fraternity (local) at the University of North Carolina, Chapel Hill, on the 20th of this month and met personally the members of that society. With reference to the petition that they are now making to the Phi Alpha Delta Law Fraternity for a charter, I beg to make the following report.

Local conditions: There is at present only one other legal fraternity at the University of North Carolina, that being Phi Delta Phi very recently installed There are approximately 150 men in attendance at the Law School out of approximately 1350 men attending the University. There are two other law schools in the state of North Carolina (Trinity and Wake Forest) and at neither of these is a chapter of either Phi Delta Phi or Phi Alpha Delta.

Faculty Attitude: The Faculty of the University of North Carolina is favorable to fraternities, a number of the leading academic fraternities being represented on the campus. The Dean of the Law School is in thorough sympathy with the movement to install Phi Alpha Delta and expressed to me personally a hope that the petition be granted and the opinion that there was an opportunity for Phi Alpha Delta at this University. The Faculty of the Law School with one exception are honorary members of the Phi Delta Phi

Standing of Law School: The Law School of the University of North Carolina is the leading law school of the state of North Carolina. Its teaching staff numbers four full-time men and its course leading to the law degree is three years. Its membership in the Association of American Law Schools is being sought at the present time I understand, the Law School being able at the present time to comply with all requirements for admission to that association. Method of instruction: Casebook, Passing grade: 70. In quality of work done and standing among the profession, the Law School is entitled to rank one of the leading schools of the South.

Personnel of petitioning group: The petitioning local numbers in its membership some of the ablest and most promising men of the Law School. There are in all cases men of maturity. Of the total membership of fifteen, only three are to graduate this year which means a certain return of a nucleus next year. A number of academic fraternities are represented in this petitioning group and the men seem to be representative in all cases. I was particularly struck with the enthusiasm of the men in their petition and felt that they were all Phi Alpha Delta material. The members that I came to know personally were very likable and gentemenly, and the others whom I saw only in a general meeting of the group, from a careful study of their individual records, I feel sure are as promising as the ones with whom I talked at some length.

Nature of the petitioning local: The petitioning group is a local legal fraternity of good standing on the Campus. Its age is only one year but is well organized and is in a position to assume immediately the work and responsibilities of a chapter of Phi Alpha Delta.

Recommendation: It is recommended that the petition of the Alpha Omega Local be granted and a charter of Phi Alpha Delta be granted them. The facts of the situation as stated at some length will themselves perhaps warrant the granting of the request without any expression of opinion from myself as a committee of inspection, but I desire to commend the members of this group as men who are worthy of the ideals of the fraternity and the University of North Carolina, as presenting an opportunity for present expansion for Phi Alpha Delta.
