chapter thereof.



## The Harlan Law Club

Measured by length of existence, Harlan Law Club is not old, it having come into existence in the early fall of 1919. But measured by the completeness of organization and the definiteness of purpose, it might have had its inception twenty years ago. When about a dozen of upper classmen, at the instance of Dean Ferson, gathered together with the idea of founding a new organization which should supply a need which was lacking in other university organizations, there was little thought of affiliation with a national fraternity. The idea was merely to draw together men who were seriously interested in the study of law and who intended to practice after graduation. The meetings were to be rather informal, with addresses by prominent jurists or attorneys, or discussion of legal problems by members. This was seriously carried out, but the organization soon came to realize the limited appeal which a local organization offered, and the handicap of competition with the local chapter of a national legal fraternity was robbing it of some of the most attractive prospects. They thereupon set seriously to work to secure a charter from Phi Alpha Delta, which they conceived to be the foremost legal fraternity.

First, and last, Harlan Law Club has had perhaps forty members. Some wore tried, found wanting, and dropped. Others have withdrawn from school. As this is being written, one of our most valued men is on his way to Florida. The net result is a picked organization of in the neighborhood of thirty men. Every man is a good student; every man will make a good lawyer. Every man has the qualities that make for fellowship - the men stick together, support one another, encourage

one another.


Harlan Law Club felt that the Law School was not getting a "square deal" from the Student Council; therefore Harlan Law Club engineered and put over a Law School Senate. Harlan Law Club felt that the activities of certain men were inimical to the best interests of the Law School; those men were retired from office. The Club has always put the School first, the interests of the individual members

second, and its personal interests last.

And now as to organization. The Club has for officers a Chief Justice, two Associate Justices, a Clerk, a Deputy Clerk and a Bailiff, who hold office for one semester. The meetings are held on the first and third Mondays of each month. At these meetings, there is either most court work of an appellate character presented by two members on each side of the case, or, as stated above, the Club is addressed by some eniment lawyer and jurist. The meetings are held at the War Risk Club House and one of the Moot Court Rooms of the Law School. A serious attempt was made to secure a house for the Club, but these efforts failed because of the congested condition of the city and the fact that we were not affiliated with any national organization. Next fall, whether we are granted a charter or not, we shall establish ourselves either in a house or an apartment in a locality convenient to the School.

The Club is named for Justice Harlan of the Supreme Court who was for many years a professor in the Law School. It was in commemoration of the services which he rendered to the Law School that this name, and the emblems of the Club - the corncolo pipe and bandanna hankerchief, which each member is supposed

to have with him on all ceremonial occasions - were adopted.



## History of the George Washington University Law School

The Law School of George Washington University, originally known as Columbian University Law School, is the oldest law school in the District of Columbia, it having been established in 1865. Its course of instruction, originally requiring two years study for the Bachelor of Laws degree, was increased to three years in 1898. A year of graduate work leading to the degree of Master of Laws, was added in 1877. It now has in addition a course of study leading to the degree of Master of Patent Law.

When, in 1900, the Association of American Law Schools was organized, this law school was one of the charter members and it has remained a member of the organisixty per cent of the students have had college training, while the number of college graduates have averaged between thirty and thirty-five per cent. The average age of students is over twenty-five years. The school is co-educational, members of the

two sexes being admitted on equal terms.


The Law School occupies the entire fifth and sixth floors of the New Masonic the University. A library of nearly 9,000 volumes is maintained for the use of students and faculty, containing the reports of forty-six states, the District of Columbia, Court and the other federal courts, the English Common Law and Chancery Reports and others to numerous to mention. The Law School maintains both morning and service attending the early morning and late afternoon classes. The number of students registered during the present year is considerably in excess of six hundred.

The method of instruction is that of the case-book. The faculty is made up largely time to that work. Courses in procedure, however, are presented by active practitioners. At the present time, gradutes of George Washingon University, Boston University, University of Chicago, Harvard University, and the University of

Iowa are represented on the faculty.

The Law School is an integral part of the University and therefore it has few distinctly Law School organizations. The members of Columbian Debating Society, and Delta Sigma Rho, however, are largely drawn from the Law Schools, and the In addition, George Washington Law School has a chapter of Phi Delta Phi legal fraternity, Phi Delta Delta, legal sorority, the Woman's Legal Club, the Harlan Law Club, and the Law School Senate,
