The Victory Convention of Phi Alpha Delta

(We are indebted to Brother Frank M. Ludwick, of Benton Chapter for the following excellent account of our Victory Convention.)

The 17th National Convention of Phi Alpha Delta Law Fraternity was called to order by the Supreme Justice George L. Stewart, at Chicago, Illinois, in the Morrison Hall, at 9 A. M. December 29th, 1919. Prosecuting Attorney Harry B. Miller addressed the Convention and welcomed the delegates to the city in behalf of the city and its officials.

Upon motion of Delegate H. W. Norman (Marshall) the permanent officers of the Fraternity were selected as the temporary officers of the convention. Following a roll call the following credentials committee was appointed: Supreme Marshal Frank S. Ginnochio, Chairman, George K. Brasher, and J. G. Driscoll, Jr. Other committees were appointed as follows: Auditing committee: Humble of Green, Chairman Toomley of Dunbar and Johnson of Reese: Memorial Committee; Wherli of Hammond Chairman, Lambert of Campbell and Adams of Blackstone; Sub-committee on legislation who were ordered to familiarize themselves with proposed legislation and be prepared to report when convention convened as a Committee of the whole: District Justice Ludwick, Kansas City Alumni, Chairman, Norman of Marshall and Roberts of Chicago Alumni.

Supreme Justice Stewart reported to the convention with a brief summary of events since the Convention of 1915 as follows:

When the Sixtieth Convention clos-

ed at San Francisco in 1915, this administration started in earnest to accomplish a new order of things in P A D. To recount to you in detail the many things which have happened since that date would draw too heavily upon the time at our disposal. The Board realized that they could not do all that they wished, owing to our inadequate fundamental law. The officers, being truly representative of the National Fraternity and living at many points of the compass, could not meet as required and actually did meet but a few times. A system of arduous correspondence became necessary and has followed ever since.

The speaker served on previous constitutional committees and knew the inadequacy of the present constitution. He undertook to build a new one, using the desirable portions of the one already in use and it was ready we been able to meet. Then came the for consideration in July 1917, had war. For two years the present officers held over and all who were not called away to Service agreed to remain with us until relieved.

Twice we hoped to convene, only to be held back. First it was the war, then lack of funds, for we received little income while the boys were in the service. There was but one thing to do and that was to appeal to our Alumni to assist us. The result was the reconstruction fund campaign and \$1,692.50 has been added to our reasury since July 1st, 1919. Brother Glenn Miller rendered splendid services as Supreme Financial Secretary until he was forced to go to Washington.

The Board was unable to meet for lack of funds and available timber for his successor proved difficult to get, for Uncle Sam had been over the ground first. The speaker, after some fruitless correspondence, in this dilemma, went personally to Chicago, in the hope of not only procuring a new officer but of combining the secretarial work as proposed in the new Constitution. It was also hoped that the sale of the Directory might be stimulated and additional funds thereby provided. Brother Frank E. Ruteldge was finally induced to accept the thankless task of collecting fraternity funds, the combination of the financial offices being necessarily deferred. He had, however, scarcely become acquainted with his work, when a change in business connections forced him to resign and since that time Brother George K. Brasher, of Kansas City, has been doing what he could to pick up the scattered ends of this difficult work. While in Chicago a campaign to dispose of the Directory was begun, under the auspices of the editor and historian. whose reports will acquaint you with that situation.

The 1915 Convention Fund was next investigated and although assumed by the Supreme Justice, to avoid confusion with collection of our regular revenues, this campaign was abandoned as the Supreme Board felt after a thorough investigation that to pursue the matter further would be unconstitutional, inequitable and unjust. It was therefore, decided to release all chapters still technically owing balances on this fund from any further obligation.

Systematic chapter financial reports had in the meantime been in-

augurated and up to the time of the war the plan was working well. The new Supreme Board voucher system was prepared and used by the Board and the recommendations of the 1915 Convention Auditing Committee as to the keeping of the books was called to the attention of the proper officers. Investigation of general fraternity accounting systems was made by the present Marshal, Brother Frank Ginocchio, and it is believed that a compromise system of simple character would now be in general use by our chapters had the great conflict not prevented it. A permanent record of the decisions and rulings of the chief executive has been kept and will be of aid in construing the new Constitution.

Owing to the lack of funds, we could not continue to publish the Quarterly after last May, but it should be again in your hands after January, 1920. The ritual committee appointed by the 1915 Convention, being unable to meet and do business. the Supreme Justice, with the approval of the Board selected new members and Brothers Frank Messner, of Iowa City, Iowa: Robert E. Lee, of Denver, Colorado, and Nelson A. Anderson, of Seattle, Washington, were appointed to prepare a new Ritual. Although still encountering difficulty, a majority of this committee met at Denver, Colorado, recently in conference with Brothers Knauss and O'Connell, prepared a document which meets the approval of the Supreme Executive Board. It is felt that this will fill a great want in our fraternity. It will no doubt be perfected and printed once for your use.

We have endeavored to carry out

the suggestions of the 1915 Convention as far as it lay within our power and you will admit that conditions in this great country might have been more favorable. Elsewhere you will hear of our report on inactive Chapaccomplished you have heard from ters and what rehabilitation has been the delegates here.

Despite all of this chaos, we have divided the fraternity field into five districts agreeable to all concerned, and district assemblies were held with notable success in every district in 1916. The speaker has endeavord to fill the want felt by the lack of a traveling Secretary and has personally visited a large majority of the Chapters. At every opportunity the other Supreme Officers have been encouraged to do likewise.

This convention must not, in closing, forget the services of temporary Supreme Officers who filled the breach during vacancies without other incentive save the realization of their duty to P A D. They well know how much their services were appreciated by your humble servant. All officers, no doubt, did the best they could and you will hear from them in due course.

In conclusion may I beseech you, especially the delegates assembled, to forget petty and local grievances, if any you perchance have, and by your united action give P A D what it now needs to live and grow in greatness. Bear in mind that Alumni with many years of experience are unquestionably better prepared to direct your activities than members who are new to the order. You can then go back to your chapters—and do not forget to go back—and tell them that this was indeed the greatest conven-

tion that P A D has ever known and you will have a right to be proud if your records.

Following this were reports from the Supreme Historian, O'Connel, Editorin-Chief Hoberg, Supreme Financial Secretary Brasher, and Supreme Recorder Rhodes all of which were duly approved by the Convention.

The report of the Supreme Financial Secretary was as follows:

SUPREME FINANCIAL SECRE-TARY BRASHER, (Kansas City Allumni): This report was made up, gentlemen, the day before I left Kansas City. Of course, it does not include any collections made since this report was written. We are making collections now and endeavoring to make others.

In December, 1918, your Supreme Justice, Brother George L. Stewart. wired me asking that I assume the duties of the office of Supreme Financial Secretary of this Fraternity, due to the fact that the business connections of the then Acting Supreme Financial Secretary, Brother Rutledge, were such that his business absolutely prevented his giving attention to the details of that office. About the middle of January, 1919, I received the first records and information bearing on the subject, Brother Rutledge having sent me, by express, a box containing all the papers and other data that he had in his possession.

As soon as I had sorted the records and correspondence which were sent to me, I ascertained that no books had been kept by the Secretary, or at least none had been furnished me either by Brother Rutledge or by Brother Miller, his predecessor. It was an almost hopeless task to en-

deavor to find out just where each individual chapter stood, financially, with the National Board. It required many hours digging in the files and in several cases I have not yet been able to ascertain the financial status of the chapter.

As quickly as possible after straightening out the records and correspondence. I sent out a form letter to all of the chapters, using the addresses of the various officers available to me. Those letters did not elicit very many responses and apparently most of the chapters were still suffering from the depleting effects of the recent war. Later in the year, however, especially toward the end of the school year, 1919, reports began drifting in from the various chapters. In the fall of this year, after the majority of the colleges had again resumed normal activities, further reports came in from the various chapters and up to this date (December 26, 1919) I have received communications of some sort from every chapter except twelve.

I have received some remittances from all but nineteen of the chapters, but of these nineteen from whom no money has been received, I have received credentials and other cummunications from seven.

Within the last week I have received the alumni charter fee for the granting of an alumni charter to the Alumni at Bloomington, Ilinois. I have also received a petition from the Alumni at Seattle petitioning for the granting an alumni charter to that city.

I have collected, since I took over the affairs of this office, the total sum of \$1773.05, all of which has been accounted for to the Supreme Treasurer. This office has been conducted during my regime at a total expense to the fraternity of the sum of \$14.95, which covers some small items of postage, telegraph, cost of rubber stamp, ledger, and filing cabinet for the papers relating to the Fraternity.

I have prepared a schedule which is attached to this report, showing all remittances received by me, showing the various items for which remittances were made and the name of the chapter from which the remittances have been received.

Beginning with the first money that was received by me upon taking over the affairs of this office, I have obtained and have kept a ledger. I have kept a separate ledger account with each chapter and have tried to keep the records in such shape that at all future times the application of any remittance received by me may be quickly and accurately determined.

The outlook, from a financial standpoint, at the beginning of the year 1919 was very discouraging, but in the last few months, especially within the last ninety days, the situation has changed so much that I am extremely hopeful for the financial future of Phi Alpha Delta.

I am not going to read the schedule because it is long and involved and if any of the Delegates want to examine it they will find it here with the records. The total amount received by me was \$1,773.05 up to this morning, and I have vouchers for that amount. The schedule is also on file, being attached back of the report.

Reports were received from the delegates present on conditions in their respective chapters. Courtesy of the floor was extended to all visiting brothers. Adjourned until 1:45 p. m.

Convention called to order by the Chairman, roll call and reports on chapter conditions received from del egates late in arriving. A letter from Charles Halla, Pres. N. Y. Alumni Chapter explaining the delinquency of Rapallo Chapter was read. solution from Hamlin Chapter read asking that Hamlin Chapter be suspended and declared inactive until such time as the National Chapter should deem reinstatement advisable. After considerable discussion a motion by Norman of Marshall, amended by Schiller of Story and by Welch of Taft was carried, referring the above to the Resolutions Committee with instructions to report on this matter to the present convention and to report to the next convention on the condition of chapters having no delegates at the present convention.

Delegates were instructed to furnish Wehrli of Hammond, Chairman of the Memorial Committee with a list of Brothers who were killed or who died while in the military service of the United States in the late war.

Upon motion of Supreme Historian O'Connell duly seconded and passed, the Supreme Historian was instructed to furnish copies of the Directory, free of charge to all brothers who contributed to the reconstruction fund, and to distribute, without cost to the Fraternity, the remaining copies of the Directory.

Sutton of the Chicago Alumni, Chairman of the Entertainment Committee announced a smoker and entertainment to be held in the evening. He was also requested to arrange for dinner for the delegates in the Terrace Gardens. Vouchers of members of Board of Tribunes and Second Vice Justice covering expenses to the Con-

vention and of the District Justice of the Western District for one half of his expenses were approved and ordered paid. Supreme Financial Secretary Brasher presented an additional report to the effect that since his previous report he had collected from the delegates on behalf of their chapters the amount of \$533.25.

The report of the Committee on Credentials was presented by Chairman Ginocchio and duly approved by the Convention and the following delegates were seated:

Motion duly seconded and carried approving previous actions of the convention and ratifying same now completely organized. Duly moved, seconded and carried that the Convention resolve itself into a committee as a whole for the purpose daking up the proposed Constitution. Second Vice Justice was chosen as Chairman of the Committee as a whole and the appointment of the sub committee on Legislation, already named, approved.

The report of the sub-Committee on Legislation was presented by District Justice Ludwick, Chairman, as follows: The Sub-Committee, after a careful consideration of the proposed draft previously submitted to the Chapters individually, together with certain amendments suggested by said Chapters and added to the original context at a conference of the Supreme Executive Board, hereby presents to the Committee of the Whole this constitution and recommends its adoption by the Committee of the Whole, subject to certain amendments which your committee asks the privilege of suggesting as the Constitution is read to the Committee of the Whole section by section.

The Committee of the Whole then proceeded to take up the matter of the new Constitution Article by Article and Section by Section.

Adjourned until 9:00 a. m., December 30th, 1919.

Met pursuant to adjournment.

Chairman Stewart received the report of Chairman of the Committee of the Whole which follows: The Chairman of the Committee of the Whole reports that the Constitution, with amendments, which has been read during 'vesterday's and this morning's session has been adopted by the Committee of the Whole and said Committee recommends its acceptance and moves the adoption of this Constitution by the Convention.

Motion duly seconded and carried. Duly moved and carried that the Constitution and the Phi Alpha Delta Law Fraternity. Supreme Executive Board then instructed to have copies printed.

Chairman of Credentials moved that the following Brothers present by seated as delegates from their respective chapters, seconded and carried; and following seated:

W. C. Barnes, McGruder.

W. C. Wehe, Milwaukee, Alumni. Fletcher Lewis, Seattle Alumni.

Supreme Executive Board instructed to take the necessary steps to iile an emended set of articles of incorporation at Springfield and that the incorporation cover each subordinate chapter so that each subordinate chapter is thereby incorporated.

Communication from Local Reception Committee received and approved.

Adjourned until 1:30 same day.

Convention met pursuant to adjournment.

Moved by Wheeler of Ryan, duly seconded and carried, that the Supreme Executive Board be authorized to levy a per capita tax of Seven Dollars as of date of January 1st, 1920.

Communications were read from Brother John G. Carmody, Lt. Col. Air Service, and from Brother Tom Octigan.

The following report was presented by District Vice Justice Frank Messer, Chairman of the Ritual Committee. The Committee has done the very best they could to prepare a ritual. None of us were masters of the English language, but we did the very best we could considering the nature of our Fraternity. We wanted to put into this ritual something of a legal nature and we also wanted to do it so there would be something impressive and beautiful about the ceremony, and we could hardly do it by adopting everything as it actually is in law. So we have prepared a ritual which we will submit to the Supreme Chapter here.

(Reading and explanation of Ritual not reported.)

Upon motion of McShane of Kansas City Alumni, duly seconded and carried the Ritual was adopted as the Ritual of Phi Alpha Delta Law Fraternity.

Ritual Committee was instructed to prepare a Pledge Ritual to be submitted to the Supreme Executive Board.

Vote of thanks was extended to the Alumni members who made it possible by their generosity, subscriptions and contributions, to assemble and convene this convention.

Brother Wehe of Milwaukee spoke on the advisability of establishing a chapter at Marquette University. Matter referred to the incoming General Secretary. Report of Higson of Ryon, Chairman of Grievance Committee received and approved.

The following resolution was offered by Wherli of Hammond, Chairman of Memorial Committee.

RESOLUTION

Presented at the 17th National Convention of Phi Alpha Delta Law Fraternity, held at Chicago, December 29th, 30th and 31st, 1919.

WHEREAS; many of our brothers gave up their lives while serving their country in defense of liberty, humanity and justice, and

WHEREAS, we recognize in these, our brothers, loyal and patriotic citizens who believed in and fought for American institutions and ideals of freedom and democracy, and who closed their earthly pilgrimages in the pursuit of duty and in supreme fidelity to their God, their country and their homes;

Now Therefore be it Resolved, that we, the brothers of PHI ALPHA DELTA, in National Convention assembled, do hereby express our reverence and love, our great esteem and our high regard for those of our brothers who have sacrificed all in the service of their country and God; and be it resolved that we tender to their loved ones our sincere sympathy in their affliction, and bid them find comfort and consolation in the fact that the sacrifices made by those gallant men have not been in vain.

AND BE IT FURTHER RESOLVED that these resolutions be spread upon the minutes of the 17th national Convention of the Phi Alpha Delta Law Fraternity.

And it is further recommended by this committee that a complete list of Brothers who lost their lives in the world war, be compiled by the proper national officer, and that a copy of this resolution, with such complete list or a part thereof be given proper space in the first ensuing issue of the National Magazine of Phi Alpha Delta Law Fraternity, and that a copy of the issue containing the same be sent to the families of the respective deceased brothers.

Resolution and recommendation adopted. Supreme Historian instructed to compile such list.

The following resolution was offered by Ludwick of Kansas City Alumni: We have just passed through a very critical period of our existence. I have been more or less closely connected with Fraternal affairs since the last Conventiion in 1915, and know some of the handicaps which our present Supreme Board have been required to meet. I think that there is no Supreme Board that has ever served Phi Alpha Delta that has worked more conscientiously. has sacrificed the time and money and has had more discouragement than our present Supreme Board. I would like to move that we extend a rising vote of thanks to our outgoing Supreme Executive Board and officers at this time Motion carried with cheers

Motion to go on record in regard to bonus for ex-soldier men lost.

Motion of Welch of Taft that a Committee be appointed by the next Supreme Executive Board to investigate conditions in our Eastern Law Schools where Chapters of Phi Alpha Delta are located duly seconded and carried.

Report of Humble of Green, Chairman of Auditing Committee receiv-

ed and approved, and Supreme Treasurer Hart extended vote of thanks.

Vote of thanks and appreciation extended to Brother Myers for his assistance as Acting Recorder during the war.

Vote of thanks extended to Brother Harry Keates and Chicago brothers for hospitality shown.

H. M. Welch (Taft) Nominated by H. W. Humble (Green) Elected unanimously.

Chairman of the Board of Tribunes. G. L. Stewart (San Francisco Alumni) nominated by A. A. Rendigs, Jr. Elected unanimously.

Member of Board of Tribunes.

H. C. Moran (Chicago Alumni)

Nominated by W. C. Barnes (Mc-Gruder) Elected unanimously. Member of Board of Tribunes.

C. G. Roads (Cleveland Alumni) nominated by C. N. Latz (Benton) Elected unanimously.

McShane of Kansas City Alumni, moved that Kansas City be chosen as the next place of meeting for Convention, seconded by Latz of Benton and Ludwick of Kansas City Alumni. Partee of McReynolds withdrew his suggestion of Havana, Cuba in favor of Kansas City. Motion carried and Supreme Executive Board instructed to select date.

Chairman Stewart expressed his thanks to the delegates for their spirit of co-operation, and requested that as many as possible remain over for the installation of officers December 31st, and the informal meeting for the good of Phi Alpha Delta following.

There being no further business the 17th National Convention of Phi Alpha Delta Law Fraternity was declared adjourned sine die.

BRIEF RESUME OF THE THIRD DAY OF THE CONVENTION

The convention assembled for the third day about ten o'clock in the morning, and the first order of business was the installation of the newly elected officers. The oaths were administered by retiring Justice Stewart, who ,in turn, was sworn in as chairman of the Board of Tribunes by Supreme Justice elect Rendies.

The convention then informally considered measures and plans for the welfare of the Fraternity. The discussion, though delightfully informal, was pertinent with numerous suggestions which merit serious consideration.

Fraternity Pin-It was suggested that a standard design of our Fraternity pin be copyrighted in Washington, and that licenses be issued to certain jewelers throughout the country, authorizing them to manufacture the pins. It was suggested that a standardized pin be adopted by the Supreme Board at its first meeting (which is to occur next fall) and that this information be given out through the Quarterly, so that anyone having suggestions with reference to the type of pin to be adopted for a standard pin shall have ample opportunity to transmit suggestions to the Justice before the Board shall be called in meeting.

Fraternity Songs—It was unanimously agreed that a great need exists for additional fraternity songs. The official song which we now have, although appropriate, is not suited for all occasions. It was emphasized that several types of song are needed, for instance, a lyric, a marching song, a song with plenty of pep, which might be utilized on occasions where pledging was to be done.

Brother Eric Scudder, formerly of California, but now living in Chicago, suggested that in order to bring things to a head we announce a prize fund of \$100 to be divided into three prizes as the Supreme Board may see fit, for the purpose of encouraging the members of the Fraternity and their friends to write. Brother Scudder headed the list of donors by subscribing \$25, and the Supreme Justice announced that he would undertake to procure three additional subscribers and that

the conditions of the contest would be announced as soon as possible.

Measures Affecting Alumni—It was the consensus of opinion that the by-laws of local chapters should be amended in order that alumni who are delinquent financially might be subject to expulsion. It was agreed that too frequently men would graduate from college and move to a different section of the country, leaving unpaid some part of their financial obligations to their Chapter.

It was further decided that the alumni chapters should provide in their by-laws that no graduate active member should be permitted to join the alumni chapters until all of his financial obligations to his active chapter have been discharged in full. It was even suggested that a certifificate to this effect, signed by the Treasurer of the active chapter, should be required of an alumnus desiring to become a member of an alumni chapter.

National Conventions—An pression of opinion was had as to the best time for holding our national conventions. The question was discussed in full and it was almost unanimously agreed that national conventions in the future should be held during the Christmas holiday recess. It was pointed out that better work can be accomplished at such period than in the heated days of summer; that the delegates at such convention immediately return to their chapters full of enthusiasm and ideas of the convention. and the chapters are correspondingly benefitted. The only objection was that it was inconvenient for delegates to attend a convention during the Christmas holidays, but the consensus of opinion was that there were many men to be found in the chapters who would be very willing to attend the conventions despite this fact.

District Assemblies - Discussion with reference to the time for holding the District Assemblies resulted in the same expression of sentiment. It was agreed that the most benefit could be derived from holding the district assemblies at approximately the same time as the national convention, in the alternate years. If for any reason the districts should deem such time inadvisable for holding the same, it was thought that the Thanksgiving holiday recess would be the second choice as to time. However, the almost unanimous opinion was that the best results could be accomplished by holding the district Assemblies during the Christmas recess.

BIG MEN SAY 'TO HELL WITH LAW'—SCANLAN

This is taken from the Chicago Daily Journal of Dec. 31, 1919.

"Too many men in Chicago are saying to hell with the laws, the courts and the decisions of the courts", Judge Kickham Scanlan of the Circuit court told 400 lawyers at a meeting of the Phi Alpha Delta fraternity at the Hotel Morrison.

"One manifestation of this social unrest is the disregard of law," Judge Scanlan declared. "This is by no means confined to working men, as a great many persons believe. It exists among all men, rich as well as poor.

Big Men Defy Court

"Anyone who will study the de-

crees of Cook county courts for the last six months will find that some big men in this community who have found themselves in conflict with the processes of our courts have said, 'to hell with the courts and their decisions; to hell with law.'

"I am not one of those who make little gods of judges. In fact, I realize more than most men how frail and human judges are. The least a judge can give to his position is honesty, and I appeal to our public and a virile bar for the support of courageous judges who realize that the foundation of our freedom is a respect for law and order as guaranteed in the constitution.

Patriotism is Needed

'What we need is a citizenship that will stand up and assert its patriotism on every occasion that the agents of destruction show their hands.

"A few months ago I had a horrifying experience in the Criminal court. I sat as judge in twelve murder cases. They were plain cases of assassination in which even the lawyers for the defendants admitted the guilt of their clients and pleaded with the juries for verdicts of manslaughter, instead of murder.

Four Slayers Acquitted

"And yet juries acquitted all the murderers. Two or three men on each jury had the 'hell with the law spirit." They said, 'Why punish these poor devils? Why not try a few rich men?" and the other nine or ten men on each jury did not have the stamina to stay out all night if necessary to stand up for the law. As soon as darkness came and they thought of their comfortable homes they surrendered to the lawless and freed the guilty."

"It's a pity that the average man can't stop his dollar chasing long enough to make a sacrifice for his country, its laws and its homes."

HENRY WILBUR HUMBLE EDITOR IN CHIEF

In the fall of 1908, there arrived at the University of Kansas Law School, as Associate Professor of Law, Henry Wilbur (Harry) Humble, whose prior career may be briefly rehearsed: Born in Cincinnati, April 30, 1883, graduated at the head of his class at Cincinnati University Law School, 1904, A. B., same in 1907; A. M., Cornell, 1908; later J. D., Chicago University, 1915. Brother Humble was soon made a member of Acacia and Phi Alpha Delta, after the establishment of Green Chapter in 1909.

I can recall with much pleasantry the early days of Brother Humble, then a bachelor, but after one year in Kansas, a benedict. But, earnest and sincere of purpose, he struggled against many obstacles until today I can say truthfully that he is known and respected throughout the State of Kansas as one of K. U.'s best and most enthusiastic law instructors, as well as one of her most popular profs and loyal friend of the law student. Hence, his elevation to the rank of professor in 1913 was regarded as merely recognition of work well done. Perhaps the most popular courses of Professor Humble are those in Agency, Insurance and Partnership. I unite with the other alumni of Green Chapter in congratulating Phi Alpha Delta on the selection of our new Edttor-in-Chief.

Retrospect and Prospect

Another national convention has taken its place in the history of our fraternity, and it will long be remembered for the constructive legislation consummated and for the ante-bellum enthusiasm and P A D spirit with which it was alive.

The two striking phases of legislative effort are revealed in the adoption of a new constitution and a new ritual. The former, largely the handiwork of Brother Stewart, the retiring Supreme Justice, adequately supplies our needs at this time. The beauty and practicability of the new ritual remains to be revealed at the approaching spring initiations. The high calibre of the delegates to the convention, and the enthusiasm, energy and zeal displayed by them, were reminiscent of the conventions in the good old days before the war, and now, as the last echoes of the convention are dying away it is well that we pause and devote a moment to reflection before starting forward on our two year journey.

We survey with pride the national position of Phi Alpha Delta today, but withal comes the realization that there is still much to be done, still room for improvement, for the expenditure of constructive energy toward the betterment of our beloved Fraternity. We realize with satisfaction that as an organization we have come through the late conflict almost unscathed—I say "almost" because there are very few chapters that must either be materially strengthened in the immediate future, or give us their charters.

We are content, too, with the work which we did, with the part we played in the World War. We note with pride the thousands of P A D's who were actively enrolled in the military organizations of our country, and those numerous others who, through reasons over which they had no control, were obliged to do their bit as a part of the great civilian auxiliary; and we pause in solemn reverence as we count over our Gold Stars, mute evidence of our priceless sacrifice at the altars of civilization. Though we deeply grieve their loss, ours, to use the immortal words of Abraham Lincoln in his letter to Mrs. Bixby, "is the consolation that may be found in the thanks of the Republic they died to save."

And now, in the aftermath of Victory, in this great era of reconstruction in which we are living, we must turn our thoughts forward, we must consecrate our best efforts towards the solution of the problems of the nation and of our fraternity. Assistance in the solution of the former can best be offered by talking and living one hundred per cent Americanism and through the medium of the numerous brothers, who, throughout this great land of ours. hold public positions, positions of trust and responsibility, and through those who are yet to be called to similar offices. The solution of our Fraternity problems lies in the keeping of each one of us, and this realization brings with it the presistent question, "What are YOU going to do to help?"

next two vears will. perhaps, be the most important in the history of the Fraternity. would not be human if I did not express to you my grateful appreciation of the confidence reposed in me by electing me to the highest office in the gift of the Fraternity. I appreciate, too, the responsibility of the office, but in entering upon the administration of these duties I approach the task supremely confident of the cooperation of the loyal, able brothers who have preceded me and of that innumerable legion of splendidly loyal P A D's stretching from California to Maine, ever ready and willing to do their utmost for the solidification, growth and development of the Fraternity.

And so I call upon you all, individually, Active and Alumnus. Let us go forward with confidence, let us make harmony and cooperation our watchwords of progress, let us "carry on" and insure to Phi Alpha Delta the position to which it is justly entitled, that of the best, the most perfect, truly the greatest legal fraternity in the world.

You may prevent the sale of one of the latter makes, but what you want is to sell Hupps! That's how you'd make your living. This is the ethics, the expedient thing and it is more and more the practice in modern business. Boost your own line, but don't knock a competitor. By analogy, let us spend all our time in making Phi Alpha Delta the best fraternity we can. We will have no time left over, then, to knock our rivals. Furthermore, I believe an old saying more applicable to frat life that anywhere else: Every knock is a boost. Every time a P A D knocks another fraternity, he is only really knocking P A D and is

August A. Rendigs, Jr., Supreme Justice

Brother August A. Rendigs, Jr., Supreme Justice of Phi Alpha Delta, was born in Cincinnati, Ohio, on the 26th of January, 1895. He matriculated at the Cincinnati Law School in the fall of 1912 and in November of the same year was initiated into Chase Chapter.

His interest and unfailing support of P A D was recognized in 1915, when Brother Rendigs was elected Vice Justice of Chase Chapter, and was sent as the only Chapter delegate to the San Francisco convention, where he was elected Second Supreme Vice Justice of the National Organization. The next fall after his graduation from the Cincinnati Law School, Brother Rendigs entered Harvard University and also took post-graduate work in Harvard Law School, where he was elected a member of Sigma Alpha Epsilon.

Brother Rendigs returned to Cincinnati in 1917, and became associated with Mr. Charles M. Leslie in the practice of law. He had only gotten started on his life work when the call came for higher duty, in the service of his country. Among the first to go, he entered the First Officer's Training Camp at Ft. Benja-

min Harrison, on May 1, 1917, where he was soon commissioned a Second Lieutenant of Infantry, and assigned to Company H of the 332nd Infantry. Sixty days later he was promoted to First Lieutenant and left for overseas duty on June 6, 1918. Still with the 332nd Infantry he traveled through England, France and Italy, and saw service in Dalmatia and Montenegro. He was in the trenches on the Piave front, and was under fire in the final offensive against the Austrians in the fall of 1918.


Returning to this country, Lieutenant Rendigs resumed the practice of the law at his former office with Mr. Leslie. His fine service to Chase Chapter and to his country as well as his undoubted ability, were fittingly recognized at the National Convention when he was the unanimous choice of thirty-seven active Chapters and fifteen alumni chapters for Supreme Justice of Phi Alpha Delta. He was the prime mover, and the one to whom Chase Chapter is chiefly indebted for its Chapter House, having personally solicited the funds and purchased the furnishings for House.



UNCLE JIMMY GREEN

On November 4, 1919, Uncle Jimmy Green died after more than 40 years' service as Dean of Kansas University Law School and past 78 years of age. Probably no other school teacher in the history of education has captured so completely the affection of all who knew him as Uncle Jimmy. From Maine to California, there were students and friends who knew him and marvelled at the affection and lovalty of his students who held their acquaintance with Uncle Jimmy as one of the greatest influences in their lives. While Uncle Jimmy was often considered lax in matters of discipline, this was not entirely the case. In a way, he was one of the strictest disciplinarians I have ever known.

so far as mere outward show and formalism were concerned. Uncle Jimmy cared little. But when it came to the true essence of manhood, the very marrow of a gentleman, I have never known anyone more exacting than he. It was the spirit, not the form or the letter, which appealed to him. He was anxious that his "boys", as he called all his students, should be first of all, gentlemen. Like Washington, Providence left him childless, but to everyone he was "Uncle Jimmy." What a contrast between the typical, bespectacled, shriveled-bodied and shrunken - souled teachers whose name is Legion, and even the scientific, impersonal, research professor of the present day, and the warm hearted, affectionate and loving Uncle Jimmy, patron saint of Green Chapter. As his picture adorns every frat house at K. U., even so may we find his spirit in every gathering where brotherly love abounds.

boosting the organization which he is attempting to knock. The mind of the outsider runs about as follows: "He wouldn't spend his time knocking X Y Z if he did not fear its competition. If he fears its competition, it must possess merit." I insist therefore, that is is unethical, inexpedient and injurious to P A D for any of its members to speak disparagingly of a rival organization.

EFFECTIVE COOPERATION

I plead for co-operation among the law and other professional fraternities. Furthermore, I hope that this co-operation may take concrete form. While it is of advantage to a P A D in a city to know the other members of P A D in his city, it is also to his advantage to know the members of other legal fraternities and also the other professional fraternities. might almost say, that it is more to your advantage to know prominent physicians, engineers and architects, who can throw you business, than it is to know merely your competitors in the legal profession. Hence, I plead for: Professional Pan-Hellenic Smokers, Councils and Conferences in every large city as well as in schools and universities where P A D has chapters.

This is a day of vocational training. Uncle Sam is now sinking a lot of money to foster it. Then, why not professional Pan-Hellenic unity, where the common tie exists of training in college with a definite aim in view? Certainly other professional fraternity publications have permission and are urged to copy this sentiment.

INTER SE

On the inside there is much to be done. There is, first of all the general problem of discipline where fraternity houses are supported. What a vast array of problems we have here. A mere enumeration is all that space will permit: quiet during the study period, adequate furnishings and board; the often strained relations between P A D's who are in and those who are not members of general or literary fraternities. This is a problem which must be faced and a definite code or understanding arrived at, if endless friction and disappointment is to be avoided. Then there is the problem of table and social etiquette. Does this sound like a sorority talk, or a pike tea gossip? It should not be so classed. We must frankly recognize that some of the brothers have not had the opportunities in younger days of others who were more fortunate in their birth and environment. I know of no greater service which any brother can perform than to give a little coaching in this field. This may not be necessary everywhere, but it is certainly a thing not to be ignored in some of our chapters. Next, there is the development of the "fraternity consciousness." It is easier to define what this is not, than what it really is. There is no fraternity consciousness among a group of strangers in a cheap hotel. They do not know each other, they do not speak when passing, each entertains his guests singly; each elbows for himself and himself alone. Where the proper fraternity consciousness exists, every member knows the others guite intimately, calls them by first names, knows who they are and where they live; they greet each other heartily when passing: no guest ever crosses the threshhold except as a guest of the entire fraternity and no one looks at the guest suspiciously or without making him feel that he was expected and is welcome. True fraternity men are always kind to each other and on the lookout for an opportunity to do a good turn for each other, particularly in the presence of strangers. Differences must inevitably arise, owing to the closeness of association, but these must be promptly aired and adjusted. I have heard of fraternitty chapters where certain active members were not on speaking terms! Such an organization may be a fraternity on paper but its existence is nominal only. You can not avoid having differences, but you can adjust them, and that p. d. q.!

THE FRATERNITY HOUSE

To my mind every fraternity house is a sacred edifice, whether I belong or not. It is a temple, dedicated to the cause of uplifting the intellectual and ambitious young people of our country, upon whom the future destiny of our country depends. matter whether it is owned or rented, large or small, there is no place more sacred. Hence, anything which tends to detract from its high purpose is a sacrilege. The fraternity must spend its energy not merely in picking good men, but in developing young men to the highest point along social and intellectual lines. It demands dignity, bearing and presence on the part of each of its members. To live for two or three years during college in a well regulated frat house is a privilege second to none which the American college has to offer. On the other hand the same amount of time spent in a mere excuse of a frat house, where things are allowed

to drift, to say nothing of the men, means that a man will leave school less able to face the problems of life than when he entered. Habits of shiftlessness are the greatest of handicaps.

WANTED: SONGS AND A SONG BOOK

One of the finest expressions of frat sentiment is the fraternity song. In addition to knowing perfectly the songs of his alma mater, every P A D must be able to sing our songs, or perhaps, I am forced to say, our song. A paddle should be in waiting for every undergraduate who does not sing every note of every song when requested by the leader.

WANTED: A NEW NAME FOR THE QUARTERLY

Pursuant to this suggestion the Supreme Board sent out several letters to prominent Alumni and the project met with immediate and enthus-

iastic support.

For the next five songs that are accepted, honorable mention will be made and their authors given a year's subscription to the quarterly,—making a total of nine prizes offered.

The conditions of the contest are these:

- The word "Song" is understood to mean the complete song,—including words and music. It is, however permissible to use music already written, which would adapt itself to the purpose.
- The contest, while primarily for P A D's, is open to outsiders who may submit their efforts through an active member or alumnus of the fraternity.
- Two or more persons may collaborate their efforts; when this is done it should be so noted on the manuscript, that credit may be given accordingly.
- All manuscripts to be in the hands of the Supreme Justice of the fraternity by midnight of September 1, 1920, at which hour the contest closes.
- The Supreme Board to be the judges of the contest, provided, however, that they may if they see fit, consult some eminent musician or composer for advice and assistance.
- 6. The Supreme Board will award the prizes at its annual meeting in October or November, and the results will be announced to the winners at once and will also be published in the following issue of the Quarterly.
 - The right is reserved to reject any or all of the manuscripts offered for sufficient reason.

It is earnestly hoped that this contest will meet with an enthusiastic response and that there will be a number of good songs submitted. The need of the same must be apparent to all who seriously consider the matter and all P A D's are urged to stir things up and co-operate to the desired end. If you have a friend who

is not a P A D go to him, tell him about our contest and encourage him to exert his talent in our behalf. There must be a great amount of talent in our ranks that only awaits the proper encouragement. Get after these men and encourage them to submit their efforts; each manuscript will get the utmost consideration.

With reference to the type of songs needed it is to be hoped that we can find:

- 1. A good "Ode" or "Lyric".
- 2. A good "marching song."
- A good song to be used in conconnection with Pledge Ceremonies and for "rush" purposes.

However, in making the awards the Board will make the same without regard to the type of the song, the idea being to accept the best song submitted regardless of type. We are desirous of getting a great number of good songs of all types.

Any further inquiry on the subject may be addressed to the Supreme Justice or to the Editor-in-Chief; it is hoped however, that this article is sufficiently definite to obviate the necessity of further inquiry.



OUR NEW SECRETARY

George K. Brasher, Benton '10, the newly elected General Secretary of Phi Alpha Delta, is a native of Kansas City, Missouri, having been born in that city in 1889. He attended the ward and high schools in that city, graduating from the Central High School in 1907. From the time he was big enough to earn a dollar, he worked his way through school. In the fall of 1907 he entered the Kansas City School of Law and graduated cum laude in 1910. He immediately entered the practice of law.

In 1912 Brasher received a tempting offer to locate in the Philippine Islands in a legal connection and he took a trip throughout the Orient, during which he investigated the Philippine proposition, but decided ne liked Missouri better, and in September 1912 returned to Kansas City, Missouri, where he resumed the practice of his profession. In October 1917 he entered into partnership under the firm name of Thomson, Dew & Brasher, in Kansas City, Missouri, of which firm he is still a member. He has attained an enviable standing at the Kansas City Bar and enjoys a large and remunerative practice. In December 1917, he married Miss Harriett Edwards, also of Kansas City, Missouri.

From the time of his initiation in Benton Chapter in 1908, Brother Brasher has been untiring in his service to Phi Alpha Delta. Nothing has ever been too burdensome or irksome for "Brash" to do for P A D, and no one could get results or render satisfaction better in the work assigned to him than he. As a reward for service to his chapter, he was sent as an alumni delegate to the National Con-

vention at San Francisco in 1915. In 1918, when, due to the war conditions, the finances of the Fraternity were necessarily neglected and almost depleted, Brother Brasher was requested to accept the office of Acting Supreme Financial Secretary. Although at the time he had already assumed work additional to his business to assist others to take part in the great war, he did not flinch at the new responsibility and accepted the office, and by dint and hard and careful work got the financial affairs of the Fraternity in surprisingly good condition by the time of the convention of 1919.

No one ever deserved a reward more, and no one was better qualified for the responsibility assigned to him. than Brother Brasher when he was honored and intrusted with the office of General Secretary at the convention held at Chicago in December 1919. He has taken hold of his new work with characteristic energy and faithfulness and no doubt at the end of his term will have acquitted himself splendidly in his new capacity.
