We severally agree to abide by the constitution and the rules of said Fraternity, if accepted as charter members of a subordinate chapter thereof.







HISTORY OF THE OHIO STATE UNIVERSITY COLLEGE OF LAW

The College of Law of the Ohio State University opened October 1, 1891, with an initial enrollment of 33 students. Classes were first held in the county court house. From there they were transferred to the basement of the main building. In 1903, Page Hall, the present home of the Law College, was completed. It was built at a cost of \$110,000, and named after Henry Falsom Page, an emiment attorney of Circleville, Ohio

The Ohio State University Law College was the first in the country to require two years of Arts work as a prerequisite for a law degree. This was in the year 1895 and preceded a similar requirement by the Harvard Law School by one year.

All classes are held in the mornings, five days a week. The casebook method of instruction is used. Classroom instruction is supplemented by the holding of moot courts. From its beginning the school has been a member of the American Association of Law Schools.

The law faculty is headed by John J. Adams, former Circuit Court Judge in Ohio and law author. Other members of the faculty number five, the services of all of whom are frequently demanded in writings or consultations. Otherwise their time is devoted exclusively to the university.

The Law Library contains over 21,000 volumes, comprehensive in scope. The leading legal periodicals are subscribed for. Ample facilities are provided and full opportunity to make use of the library is accorded.

The present enrollment is 160. The legal fraternities now existing are Phi Delta Phi and Delta Theta Phi.

Being located in the city of Columbus, the capital of the State of Ohio, the Law School offers unusual advantages to its students for observation and study of the various departments of the State Government in action. The law students have opportunity to attend the Supreme Court of Ohio, the Federal District Court, the Circuit Court, the Local County Court and the Municipal Courts of the city of Columbus. They also have opportunity to attend sessions of the State Legislature when it is in session, and follow the workings of that body.

REPORT OF COMMITTEE OF INVESTIGATION

Mr. August A. Rendigs, Jr., 805 Second National Building, Cincinnati, Ohio.

Your committee, appointed to investigate the group of law students at Ohio State University, Columbus, Ohio, who are contemplating petitioning Phi Alpha Delta Law Fraternity for a charter, beg leave to submit the following report:

OHIO STATE UNIVERSITY

Ohio State University is located at Columbus, the capital of the State of Ohio. It is ideally located in the northern end of the city, having a large and beautiful campus which fronts North High Street, one of the principal thoroughfares of the city. Practically each department of the University has a separate building of its own. These buildings are all modern in structure and equipment and many of them of beautiful and imposing architecture.

Ohio State University was founded in 1870. Among its many departments are included the following: Arts, Graduate, Law, Medicine, Agriculture, Engineering, Education, Commerce and Journalism, Pharmacy, Dentistry and Veterinary.

The University has a large faculty of able educators. There are one hundred and sixty professors and about three hundred instructors in the various departments of the University.

At present the enrollment in all departments of the University is approximately eight thousand students. In 1920, the graduating class of the University numbered one thousand.

Ohio State University ranks high as an institution of learning. It has a large and growing body of alumni, many of whom have attained advanced positions in the various activities of the country. The University is a member of the following organizations: The Association of American Colleges and Universities, The National Association of State Universities, and the National Association of Land Grant Colleges.

In athletics Ohio State University holds an enviable position. It is a member of the Western Conference and as such its athletic teams in the various sports, meet the teams of practically all the universities of the Middle West. Last year the Ohio State Football Team won the Western Conference Football Championship.

Practically all of the leading literary and professional fraternities of the country are represented by thriving chapters at Ohio State University. There are about forty national and local fraternities and sororities represented on the campus. Many of these fraternities and sororities have beautiful chapter houses located in the residential section which surrounds the University campus.

LAW DEPARTMENT

ATTITUDE OF UNIVERSITY AUTHORITIES TOWARD FRATERNITIES

Fraternities are neither encouraged nor discouraged. There is, however, perfect freedom of organization allowed to the students.

There is a ruling of the faculty that all students who wish to become charter members of a new fraternity must have an average mark in their

class work of "A." "A" in the University system of grading means average grade. This rule is strictly enforced and it precludes any organization of the less diligent class of students. It also insures a high grade of students to any group seeking to organize themselves into a fraternity.

PERSONNEL OF THE GROUP

Of the sixteen members of the group, seven have Liberal Arts degrees, and the other nine have all had at least one year of College work. Ten members of the group are members of literary fraternities.

With one exception, all the members of the group were engaged in some branch of the Service during the late war. One member was a first lleutenant, four were second lieutenants, and three bear wounds received while in action with the American the American France.

The members of this group are all mature, serious-minded young men. They are aggressive and earnest. They possess character as men and stand well in their classes in the Law School. They enjoy the respect and good will of the Law faculty and of their fellow students. The group as a whole is a well balanced one and will mould itself into an organization of the highest calibre.

RECOMMENDATIONS

After careful survey of conditions at Ohio State University and the Law Department in particular, after personal interviews with President Thompson of the University and Dean Adams of the Law Department, and after meeting personally the members of this group, your committee respectfully makes the following recommendation:

- (1) That Ohio State University, being an institution of the first rank, is entirely worthy of being granted a chapter of the Phi Alpha Delta Law Fraternity. There are already two chapters of our fraternity in Ohio, one at Cleveland, another at Cincinnati. Phi Alpha Delta should be represented at Ohio State. There is a chance to become at once one of the two leading law fraternities there.
- (2) We feel that we can not recommend too highly the petitioning group. They are deserving young men. We are sure that they will, if granted a charter, be a valuable addition to our fraternity — distinctly an asset on the credit side of the ledger.
