Our Front Cover Page

The Hohfeld Analysis Simplified and Graphically Presented by the Editor

The Editor found himself without anyphing good for a front cover page. Hence, he decided to construct some esoteric graphs which might serve to terrify the layman, fortify the barrister and clarify the mind of the law student. He hopes seriously that it may help the law student of the present day in mastering the Hohfeld analysis.

For the benefit of the novice let me say this: The last place to go for an insight into the Hohfeld analysis is the writings of my late friend, Wesley Hohfeld. You will not know a whit more about it when you get through reading his pamphlet on Fundamental Legal Conceptions than when you started. This is the verdict of some of the most eminent law teachers in this country. The place to go is to Professor Corbin's article in the Yale Law Journal, Vol. 29, page 163.

It is to be noted that there are but eight terms: right, privilege, power and immunity; and their respective opposites: no-right, duty disability and liability; their respective correlatives being: Duty, no-right, liability and disability.

In other words, our table of opposites is:

Right: If White has a right against Black, the law will compel Black to do something for White.

Duty: Black's end of the same situation.

Simplest illustration: Black has assaulted White, without justification or excuse. White has a right to damages from Black and Black is under a duty to pay White.

Privilege: May be roughly compared to a "dud"; that is, a shell which never explodes,

hence is of no consequence in warfare. Thus, if no law prevents White from building a spite fence on his land, his neighbor, Black, has

No-right to interfere in the matter. White's building the fence is of no legal consequence. White's building it is therefore the exercise of a privilege.

Power: Black has put himself in a position where, by the act of White alone, a new legal relationship may come into existence between himself and White. Simplest illustration: Black offers to sell a book to White While the offer remains open, it is within the power of White to say: "I accept." Such acceptance changes the legal relationship between the parties. White now has a contractual right, against Black. Of course, Black incurs a liability from the time he makes the offer; he becomes under a duty to White only from the time white accepts.

Immunity and Disability: Assume that California forbids a Japanese to own land in California. This puts Tokarama under a disability to acquire such land. At the same time he acquires an immunity from the woes of a landlord. He is immune from having people devise their land to him, because he is immune from such encumbrances. "Tis an ill wind that blows nobody good."

The Jap being disabled, his American neighbor is doubtless immune from keeping his contract to convey land to Tokarama. As to the diagrams.

The graphs of opposites must be looked at from the standpoint of just one person.

Let the dotted line swing on the base as a pivot. As A's rights increase, his no-rights decrease, and so on.

The graphs of correlatives involve two perns.

As A's rights increase, there is a corresponding increase in B's duties.

Combining the two sets of terms, we have the last set of graphs.

Illustration of the First Combination Graph

White and Black are strangers to each other. Black owns \$300. White has no right against Black. As against White, Black has the privilege of doing as he pleases with his

money. Then Black assaults White, to White's damage in the sum of \$300. Now White has a right worth \$300 against Black whose duty is a minus quantity of \$300. Black's privilege to do as he sees fit with his money is cut down \$300 worth; White's 'noright' against Black is lessened by the same amount.

When no legal relation exists between the parties we may represent the two cross-lines as completely coinciding, that is, if it be conceivable that two human beings can by any possibility sustain no legal relationships towards each other at any moment of time.

The editor welcomes criticism and suggestions along this line for the next Quarterly from students and teachers, whether members of P A D or not.

Test Questions

What is the jural opposite of the privilege

of walking eastward over A's farm? The privilege of walking westward, the duty to walk eastward or westward, or the duty to stand still?

Instead of calling our first group opposites, why not call them supplements? Do they not bear the same relation to each other as supplementary angles; as one increases, the other decreases?

Are not the correlatives more properly called opposites—if we must call somethings opposites—than the pairs which Hohfeld called opposites? In other words, is not the opposite, if we must use the word, of a right of A to collect \$100 from B, the duty of B to pay A that amount?

The term no-right is hard to swallow. Why not call it a negative duty, in contrast with Hohfeld's "duty," which is generally positive or affirmative?

The new officers assure us that they will give the absent chapters due and timely notice and having no response will send our good friend, Jeff D. O'Connor after them.

After the assembling of the Credentials Committee, which was personally superintended by our Supreme Secretary-Treasurer, Frank Ludwick, the convention got under way showing the following officers present: District Justice, Frank L. Fawcett; District Vice Justice, Allan T. Gilbert; District Secretary, Frank K. Gleason; District Treasurer, Emmet F. Byrne.

The conveniton was then addressed by the most tried and true P A D in the United States, George E. Fink, of Chicago. If you don't know who he is, we refer you to the last edition of the QUARTERLY. The record there shown is more like an obituary than anything else, but we believe many years will go by and many feats of note will be added to his notable career ere it will be used as such. Brother Fink gave everyone at the convention a most hearty welcome. After the minutes of the previous convention were read and the Credentials Committee had reported, this report showing a little difficulty on the part of some of the chapters to make the financial grade, a few of the notables present were heard from, among them Honorable Harry G. Keats, one of the supreme rulers of the Probate Court in Chicago, Brother Milton T. Miller, past Vice Supreme Justice, prominent patent attorney, and our good old friend, Brother Thomas P. Octigan, one of the past Supreme Justices of our fraternity. Most of these talks brought out ancient history which was of much interest to the active men.

Next in line we had a good report from Brother Ludwick on the present status of the fraternity and suggestions relative to activities of other chapters in the United States, bringing brilliant pictures of the work done in the West and the enthusiasm of the Western District convention recently held. Various reports from the active chapters showed finances excellent and a bumper crop of new initiates of excellent quality. Upon motion made and duly carried, the secretary was instructed to write letters of appreciation of P A D enthusiasm and constructive missionary work done for the fraternity, to August A. Rendigs, our past Supreme Justice, and United States District Judge Tuttle of Detroit, who upon his own initiative has organized the Detroit Alumni into a body that I understand will rival Chicago Alumnal Chapter,

The following officers were elected for the ensuing year:

District Justice, Allan T. Gilbert (Chicago Alumnal): Vice Justice, Robert G. Manlu (Mitchell): District Secretary, Henry L. Chatroop (Chicago Alumnal): District Treasurer, E. H. Pett (Ryan): District Marshal, W. N. Leonard (Blackstone).

This convention was much honored by having present three of the national officers, Frank Fawcett, our Supreme Justice, Frank Ludwick, Supreme Secretary-Treasurer, and Dwight Green, Supreme Historian. At this point the convention adjourned to participate in the joint initiation of the five local chapters of Chicago, wherein about thirty-five men took unto themselves by proper ceremony membership in our beloved fraternity. About one hundred attended this little ceremony. Immediately following these exercises, the convention adjourned to the banquet hall and there participated in one of the greatest gatherings of the P A D's on record. The credit of the arrangement for the banquet, entertainment, etc., is due to Brothers Emmet Byrne, Chairman, Henry L. Chatroop, George E. Fink and Allan T. Gilbert.

The committee on arrangements had planned for an attendance of about 125, but low and behold! when the meeting got under way seated at the banquet board were approximately 200. Brother Allan T. Gilbert acted as official toastmaster, and if you don't believe P A D is in strong in Chicago, cast your widening orbs upon the following list of speakers called upon. First came the pugilistic Alderman John H. Lyle, who couldn't

stay long; then came our venerable Willmettian, Samuel H. Roberts, followed by Frank Ludwick, who presented us with the real history of the fraternity. A Letter From Brother "Jack" Carmody

of Washington, D. C., to the New York Alumni Chapter February 20, 1923

It is fitting that P A D, immortalized by the brilliant record of public service of a long list of its members, should meet and call the roll at this season—midway between the days when the nation celebrates the anniversary of the birth of its two outstanding statesmen.

It is a happy coincidence that we may simultaneously join in the nation's reverence and expression of gratitude to Washington and Lincoln for their unparalleled service to America and all mankind, and pay tribute to our own fraternity brothers who have attained high places in the legal profession and in public life.

As the records of the life and service of Washington and Lincoln inspire every American boy to greater ambition, perseverance, industry and application to his studies, so the record of accomplishment and service of our fraternity brothers inspires every member of this fraternity to higher hopes, greater desires and renewed courage to take up each fight and surmount each obstacle—for there are many obstacles in the path of the legal student and the practising autorney.

But we must not be content to hold before us as our goal, and much less bask in, the reflected glory of the accomplishments and noble work of our fraternity brothers, whom not only the entire legal profession, but the nation, is pleased to respect and honor. This record is in our keeping. P A D must continue to give to the world just as great and powerful men as ever before. Our contribution to society must be as great, not in numbers alone, in the future as in the past. The nation needs more and more each day the service of patriotic, noble and self-sacrificing men in every walk of life, and this is not the least true in the legal profession where men must be possessed not only of love of country and devotion to duty, but the capacity for leadership and great minds to combat the ever-present dangerously shrewd and scheming elements of society.

As the honored members of P A D round out their journey here on earth, it is as though to us they say:

Those groups in America who would mask their faces and in the night-time secretly proceed to substitute lawlessness for the orderly processes of law, distrust and animosity for comity and peace, must know that they are shaking the pedestal upon which this Republic is held in the eyes of all races and peoples the world over whose only hope of attaining a government in which they will have a voice, is the stability of this Republic, and it is with this thought I will conclude, placing the responsibility of the future on you, my brothers.

I deeply regret my inability to be present, but did not want this occasion to pass without a few words.

Tribute of Livingston Chapter

To the Memory of Professor Charles Thaddeus Terry

Charles Thaddeus Terry (Williams College, 89; School of Law Columbia University, 93; University of Berlin), Dwight Professor of Law at Columbia Law School, died February 19, 1923. Professor Terry was Columbia University Orator; Trustee of Williams College; Counsel for the Association of Automobile Manufacturers; Commissioner of New York State on Uniformity of Laws in the United States, being elected Secretary of the National Conference of Uniform Law Commissioners and for three years its President; and member of the Executive Committee of the American Bar Association.

In 1893 Professor Terry was Prize Lecturer on Practice and Pleading under the New York Code of Civil Procedure. In 1895 he was made regular lecturer. In 1901 he became Professor of Law.

As an undergraduate Professor Terry was Valedictorian of his class. He earned the rare distinction on graduation at Williams of being the winner of fourteen of the fifteen prizes awarded to members of his class. He was a member of Phi Beta Kappa, Phi Delta Phi, and Phi Delta Theta fraternities.

In the bar of New York City Professor Terry held a position of leadership. His dynamic powers, brilliant intellect and charming personality rightly merited this place of note and distinction in his profession.

Professor Terry was one of the leading laymen of the Brick Presbyterian Church, Fifth Avenue and 37th Street. At that church for many years he had conducted one of the largest of the city's Men's Bible Classes.

For Professor Terry every student of Columbia Law School, present and past, had an unequalfied admiration. He worked students the hardest, and was requited by the firmest love. His sparkling humor, his brilliant repartee, his bouyancy of spirit, magnetic personality and utmost efficiency all combined to make a perfect gentleman whom it was the rarest privilege to know and have as teacher. It is the unvarying tribute of students and alumni that on the tablet of their life, high above other names, is written the name of Charles Thaddeus Terry.

Tuttle Recommended for Supreme Court

Detroit Bar Association Will Urge President Harding to Make Appointment

A committee of eight members of the Detroit Bar Association will be appointed to recommend United States Judge Arthur J. Tuttle to President Harding for appointment to the United States Supreme Court, to fill the vacancy left by the resignation of Judge Mahlon Pitney, of New Jersey.

A copy of the resolution was forwarded to the attorney general of the United States and to Senators and members of Congress from Michigan. The text follows:

"Whereas, through the resignation of Mr. Justice Pitney, a vacancy now exists in the United States Supreme Court, and distinguished lawyers and jurists in various parts of the United States are being considered for appointment to fill that vacancy; and

"Whereas, the State of Michigan has a

lawyer of marked ability who has made as splendid record as judge of the United States court for the eastern district of Michigan, whose appointment to the Supreme Court of the United States would be a well-deserved recognition of devotion to duty ably and conscientiously performed, and would place upon our supreme bench a man of the highest integrity, a citizen of proved worth and a lawyer of brilliant attainments; therefore,

"Resolved, by the members of the Detroit Bar Association in special session assembled, that we each, individually and collectively, take great pleasure and esteem it an honor and a privilege to recommend the appointment as justice of the United States Supreme Court of the Honorable Arthur J. Tuttle, Judge of the United States Court for this, the eastern district of Michigan; and

"Resolved further, that the president of the Detroit Bar Association appoint a committee of eight members of the association to present to the President of the United States the qualifications of Judge Tuttle for this high office and the earnest desire of the members of the association that he receive the appointment; and

"Resolved further, that copies of these resolutions be immediately forwarded by the officers of the association to the attorney general of the United States and to the Senators and members of Congress from Michigan."

He wuz maid into a 100% medie, a regular guy, ran off wid all de prizes, an graduated wid a laude and summe cum; aw yer no wat I meen.

Den he wants ter git in a horspitel, and de older members wats got out yeers a-go, gets him a job, and dey even slips him ops; rup-tures an evryting, before slipping dem to guys wat is strangers. An den wenn he gets out de welfair comitee gives him the dope wear to open an orfiss an smack, rite off de bat, the ex-gink goes big. Nocks all de does in de block for a row uv chineese milk cans. De boys wats in de bunch makes him wat he is terday, and he knowed it all de time.

Woodntyer tink a boid like dis wood pitch in an giv a hand to de yung guys in de place he wuz in yeers a-go? Woodntyer tink a boid like dis would mix wid de good guys dat maid him? Woodntyer tink a boid like dis wood pay three bucks a yeer to help carrie on de expenses of poor ginks like him dat never pade no jitney for nitiation nor noting all de time dey wuz at collije? Woodntyer tink a boid like dis wood like to go to de convent-shun wunst a yeer and see de gude fellers dat he plaid aroun wid? Woodntyer tink a boid like dis would rite some stuff in klassy kings inglish like dis fore de "news" wen he had de talent?

Naw, he figgers dat de guys dat dun all de woik yeers a-go kin go on rite a-head. He dont figger dat dey has famleez an kids to take care of but dat dey has to go rite on a-head takin care uv him two. He wuz one uv dem take evryting an giv noting boids. An he figgers, too (2), ef he kwits kold de hole outfit wood die anyway. He knows bekause he wuz SUM IMPORTANT BOID.

Although he did not live to see his final plan carried into operation, he died with the satisfaction of knowing that he had made it possible. And his wishes have been fulfilled. Next September a new building for the College of Law, "Lafferty Hall," will be dedicated to his memory.

Aside from the great loss to the University, the community, the bar, the state, the church and society, the members of Clay Chapter have suffered a distinct loss. We have lost the friendship of a beloved brother, the advice and leadership of an able and upright man and the good and efficient examples of an honest, industrious and capable lawyer, instructor and leader.

In most ways Clay Chapter has enjoyed a most profitable year. Fourteen old men returned to the University in September, and under the leadership of Brother J. L. Hays we have made rapid strides. Brothers S. H. Rice and C. M. C. Porter have been initiated since our last letter, and both have already proved themselves worthy brothers in our fraternity.

The Convention advance notices and detailed program are sent in a separate bit of copy. Perhaps the most interesting feature of life at the Hay Chapter House is the occasional publication of Brother "Bang" Taylor's informative sheet, "The Hwyph," to which the Chapter Scribe contributes in a small way. After all the brothers had noted the particularly denunciatory tone of one of these articles published in a regular edition, speculation was rife as to what further revelations would follow. During the night following this publication, as investigations of Brother Admiral Sir Roscoe Trostle, Chief of the Sahara Sleuths of the East Cleveland Navy Yard, later proved the edition of The Hwyph was torn from its proper place on the north door of the bathroom, pulled to shreds and cast upon the bathroom floor. Brother McNabb was indicted by a Special Gland Jury after Brother Admiral Trostle testified that finger prints on the torn shreds of The Hwyph were identical with McNabb's. Justice Cardozo is author of "The Nature of the Judicial Process." Dr. John Bassett Moore, Hamilton Fish professor of international law, is on leave of absence this year. As Italian representative; he is the only American sitting on the International Court at the Hague.

In the field of authorship our faculty have been active. Professor Herman Oliphant has recently published a case book on Illegal Contracts and Combinations. There have been published under one cover the several articles by Dean Harlan F. Stone. These are scholarly and scientific treatises on the various branches of Trusts. They are not infrequently cited by appellate courts and constitute a real contribution to law literature. Mr. Medina, associate in law, who specializes in the incicacies of New York practice, has recently published a handbook on New York Practice.

Dr. Hicks, associate professor of Legal Bibliography and Law Librarian, is author of "Men and Books Famous in the Law."

University authorities have just announced the appointment of Justice William Renwick Riddell, of the Ontario Supreme Court, as Blumenthal Lecturer. Justice Riddell lectures this semester. In addition to being an honorary member of the bar associations of a number of states, he is an author of note. Carpentier Lecturer was also appointed in the person of Sir Paul Vinogradof, Corpus Professor of Jurisprudence at Oxford. Formerly a professor at Moscow, conflict of authorities caused him to go to England and continue his legal work there. He will be resident here during the winter session next year.

Now, as I told you early in the letter, we have taken in fourteen brothers since our last letter to you all. This means a chapter of just twenty men. We already have a few pledges and along in the spring we hope that another fine group of men will be added to our number. Of the new brothers only highest words of praise can be said. MAGRUDER CHAPTER

As spring approaches with its sunny days and beautiful evenings, we are aware of a new energy that takes possession of us. It is only fitting, however, that we recall the activities of the winter months before we enter into new fields.

At a meeting of the Law Club on the second of November, 1922, the Honorable David Kinley, president of the university, suggested that a debate be arranged on the proposed State Constitution. The president offered a prize to the winner. The debate was held on December 7th in the university auditorium. Magruder was represented on the negative side by Brother Tom Marshall, '23. When the constitution was voted on by the people on the 12th of December, it was rejected. A rather interesting sidelight previous to the voting was Judge Oliver A. Harker's activity in favoring the new document, while Mr. Justice James H. Cartwright of the State Supreme Court, a very strong friend of the judge, was strikingly opposed to the constitution. Their opinions were published in the Chicago Tribune.

Judge Harker has been connected with the law school in one way or another ever since setablishment in 1897. He is well known by the profession throughout the state as he was on the bench for twenty-five years, serving in the Circuit and Appellate Courts. When Henry Craig Jones resigned as Dean last year, Judge Harker recommended the appointment of Professor Albert J. Harno, a newcomer to the faculty of the College of Law. The Judge had heard of Professor Harno's ability long before he came to Illinois. It was upon Judge Harker's strong recommendation that our President, David Kinley, of-

fered the appointment as Dean of the College of Law to Professor and Brother Albert James Harno. Dean Harno is a very able man. He has the interests of our college at heart. The College of Law—it's good fellowship and scholarship are being strengthened under his leadership.

The fall initiation was held on the 9th of November at the Phi Kappa Tau house. The purpose and ideals of P A D were solemnly impressed upon the minds of the following:

His Honor, Brother Hank Vreeland convened court after every dance. The parties were represented by Brothers Stanley Icenogle and John R. Snively. Brother Tom Marshall acted as Sheriff. While the jury was being selected Brother Clyde Bankson begged to be excused from service because he had the seven-year itch. His Honor directed the clerk to scratch him out.

Our Memorial Stadium is moving along rapidly. It is the expectation that the seats on the main floors will be ready for use for the Chicago-Illinois game on November 3, 1923, which will be homecoming. The Illinois Stadium is not only utilitarian, but it is the first stadium that emphasizes architectural beauty. It is far more than a structure merely to enable people to see athletic contests—it is a noble expression of a great ideal—the giving of self to a higher cause than self. The loyalty of the Illini will be imperishably recorded when the great Memorial Stadium and Recreational Field becomes a reality.

On the 11th of January, 1923, the Chapter gave a dinner in the banquet hall of the Illinois Union Building. He is also secretary of the Champaign County Bar Association.

Brother William P. Holaday, '08, of Danville, was elected to the House of Representatives from this district. He succeeds "Uncle Joe" Cannon, who retires on March 4th, after having served his twenty-third term. The election of Brother Holaday is a recognition of his ability and has brought honor to the fraternity.

Brother D. Gordon Watts of Kansas City has returned to the university this semester. He has attended the University of Missouri the past year and a half. We are very glad to have him back with us.

Dean Albert J. Harno and Professor Frederick Green of the College of Law were in Washington on the 23rd of February, 1923, attending the first meeting of the new American Law Institute. The meeting was called for the purpose of organizing and placing in the hands of experts the various divisions of the law, with a view to obviate the uncertainties and to simplify where possible the complexities of the law by analyzing the law critically and constructively. Among those present were Elihu Root, G. W. Wickersham, former Attorney-General of the United States; Justice Cardozo of the Court of Appeals of New York; Herbert Hadley, former

Governor of Missouri; Chief Justice Tatt, James M. Dickerson, John W. Davis, all the Associate Justices of the Supreme Court; the deans of the leading law schools and many prominent lawyers. This is the first endeavor to do anything toward securing co-operation among the leading jurists of the United States.

The University of Illinois had a very able representative in the person of Professor Frederick Green. He is a graduate of Harvard. During 1903-04 he was a lecturer on Admiralty in the Harvard Law School. He has been at the University of Illinois for eighteen years and is recognized as a leading authority on Carriers, Public Utilities and Constitutional Law. He is the compiler of Green's Cases on Carriers in the American Case book series. Professor Green has a mind of high culture and intellect, which aids his keen power of analysis. The success of many practicing attorneys is due to the thorough instruction given in his classroom. The alumni have a deep affection and sincere reverence for him.

A meeting of the Assembly of the Eastern District of P A D was held at the John Jay Chapter house in Cleveland, Ohio, on March 2 and 3, 1923. The delegates were Brothers John R. Snively and Henry K. Vreeland.

With the coming of spring we hope to cross bats with the other legal fraternities in a fer friendly games on the south campus. We trimmed Phi Delta Phi last fall in a fast game. It is safe to predict that P A D will hold its own because we have some good players in the chapter. Brother Robert Barnes is a former varsity pitcher.

The College of Law will have its first summer session this year since 1909. There has been a strong demand among the student body for its establishment. The faculty will consist of Professors J. Norton Pomeroy, W. L. Summers and George W. Goble. Courses will be offered in bankruptcy, insurance and municipal corporations. These subjects were omitted from the curriculum this year. We hope that in the near future the authorities will see fit to offer graduate work in the College of Law. The larger universities realize the necessity of this addition. As a step in this direction a course in legal history is being offered this semester. It is under the direction of Professor F. S. Philbrick, who is a very able teacher and has a wide knowledge of the background upon which the law is founded.

In December we initiated two new men and are planning on initiating about ten freshmen within the next two months. Then we will clamp the lid down tight until next year. By this system we have gotten the reputation of being exclusive and the boys never do anything else, once they are offered a bid from PAD.

Taft delegates to the Atlantic District Convention, reported the affair to be a huge success, and Taft Chapter desires to, through the medium of the Quarterly, thank Brother Bernstein for the courtesy and favors shown

the chapter by his splendid treatment of our delegates.

During the fall, when we were without a house, we gave a dinner at the Arlington Hotel for the purpose of acquainting the brothers with prospective junior and freshmen candidates. M., some of the brothers decided they wanted some sleep and stopped the music and put the musicians to bed. You should have been there, brothers, it was such a sight as would make Mr. Volstead weep with envy.

The first smoker in our new home was held on Monday evening, January 15th, 1923, and was one of the most successful smokers ever given by the chapter. We have had a few smokers of late and are now planning for another in the near future as well as a dance for early spring.



From an Editorial in the New York World, February 4, 1923:

Democratic government, which had its true beginnings in the rural township, has moved away to the national capital and the international conference. It has been transformed from an affair of a self-governing community, where the governors and the governed were neighbors, into a gigantic, distant, meddlesome and alien bureaucracy. And in that transformation the ordinary man has lost all sense of self-government. all feeling that his vote counts, all belief that he is obeying laws which he has really helped to frame. He devotes himself consequently to trying to use that distant power of government to impose laws on others, while he hopes these laws won't touch him. But of course they do. And the result is that he cries out one day that he wants to be let alone and the next that a new law is needed to keep somebody else from going wrong.

Government has become so complicated that nobody hopes or pretends to watch all of it. The great machine works mostly in the dark, lit up at one point for a day by some scandal, at another by a fight, at a third by a temporary collapse. The private citizen has long ago abandoned hope of following the course of government or of understanding a fraction of its activities. He just accepts it cheerfully or sullenly, like a fact of nature about which on the whole he can do little.

If the ultimate hope of mankind lies in science and in education, the ultimate hope of government lies in simplification, clarification and decentralization.
