CHAPTERS OF PHI ALPHA DELTA LAW FRATERNITY



HISTORY OF THE TULANE UNIVERSITY AND OF THE COLLEGE OF LAW

The Tulane University of Louisiana was originally the University of Louisiana, which was established in 1834. In the year 1884 Paul Tulane heavily endowed the University of Louisiana, and it was to perpetuate his memory and name that the Board of Trustees changed the name of the University

of Louisiana to The Tulane University of Louisiana.

The College of Law was established in 1847, and in the seventy-seventh year of its existence it has conferred diplomas on over fourteen hundred graduates. The College of Law is located in Gibson Hall, on the uptown campus of Tulane University, in the City of New Orleans. The location of the Tulane College of Law offers many special attractions and advantages to the law student. Due to its location the students have the advantages of instruction from, and personal association with both types of law teachers. The faculty is composed in part of judges and practitioners and in part of teachers thoroughly trained for the work, who have made the study and teaching of law their life work and sole profession, and who give all their time to the work of the college. New Orleans, besides its municipal and other local courts is the seat of the Supreme Court of Louisiana; of the United States District Court for the Eastern District of Louisiana and of the United States Circuit Court of Appeals (the opportunity to observe the proceeding of these courts; the practice of many eminent lawyers, and the conduct of much of the most important commercial litigation of the South is of material advantage to the law student).

The library of the College of Law includes the full reprint of the English decisions from the earliest printed reports of the Sixteenth Century to 1865; a complete set of the English Law Reports since 1865; the reports of the United States Supreme Court; of the Lower Federal Courts; and complete reports of the Courts of Last Resort, of all the States of the Union from their beginning. The Library, includes also a complete set of digests and encyclopedias, in addition to which there is a careful selection of text books. The Library contains ten

thousand volumes.

The State Library, to which students have free access, is located in New Orleans and contains over forty thousand

volumes

The college of law is a member of the Association of American Law Schools, and among its graduates are listed, the late Chief Justice White of the U. S. Supreme Court; Hon. Rufus E. Foster, Judge of the U. S. District Court for the Eastern District of Louisiana; Hon. Pierre Crabites, Judge of Tribunal Mixte, Cairo, Egypt (M. le., Pres.) who was the presiding Judge in the King "Tut" dispute; Chief Justice and several associate Justices of the Supreme Court of Louisiana.

Beginning with the Session 1925-26, two years of college work (in addition to the required High School work) will be required for entrance as a regular student. At the present time one year of academic work is the entrance pre-requisite.
