

# HISTORY OF THE WEST VIRGINIA UNIVERSITY COLLEGE OF LAW

The College of Law was established in 1878 and is the oldest professional school in the University. It is the only law school in the State of West Virginia. A large proportion of the bench and bar of West Virginia have been enrolled among its students.

Its course of instruction for the degree of Bachelor of Laws, originally requiring but one and later two years of law study, was, in 1912, fixed at three years. In 1913 a requirement of one year of college work for admission was added. In September 1924, a requirement of two years of college work for admission became effective.

In 1914 the College of Law was admitted to membership in the Association of American Law Schools, which is an organization of the leading law schools of the United States for the purpose of establishing and maintaining high standards of legal education.

The College of Law of West Virginia University is listed as a Class A Law School fully complying with the standards fixed by the American Bar Association through its Section on Legal Education.

The present enrollment is 120. The legal fraternity now existing is Phi Delta Phi.

The law faculty is headed by Joseph Warren Madden, formerly professor of law at Ohio State University. Five other able instructors compose the faculty.

The purpose of the instruction in the College of Law is to train the student thoroughly in the principles and procedure of the common law with particular reference to their application or modification by decision and statute in West Virginia.
