GEORGE SUTHERLAND

GEORGE SUTHERLAND was born in England in 1862. He received his common school education in Utah and was educated in law at the University of Michigan. Elected to the Senate of the U. S. in 1905, he served in that capacity until 1911. President Harding appointed him to the position of Justice of the Supreme Court September 3, 1922.

History of the University of Utah

The University of Utah, then known as the University of Deseret, was founded about two and one-half years after the arrival of the Utah Pioneers in the valley of the Great Salt Lake. An act of the Provisional Government of the State of Deseret, February 28, 1850, incorporating the University of Deseret was ratified October 4, 1851, by the Legislature of the Territory of Utah.

In 1884, the legislature amended the charter, and gave the University definite power to confer degrees. In 1892 a new charter was granted by the Legislature which changed the name from "The University of Deseret" to "The University of Utah."

The Normal School was early established as a department of the University. In 1901, the State School of Mines was formally established by act of Legislature as a part of the University.

Timely attention has been given to and means provided for the growth of the older schools and departments, and new ones, such as the Schools of Medicine, of Law, and of Commerce and Finance, have been established as the need for them became apparent. Buildings have also been enlarged, or additional ones crected, as required. There is at present a drive under way among students, the alumni, and friends to raise \$500,000 for the erection of a Students' Union Building.

Registration has increased yearly until at present with a registration of 2.616 there is at the University of Utah the largest student body of any University in the Great Inland Basin.

History of the Law School

The Law School graduated its first class with an LLB. degree in 1913. At that time classes were held in the down-town district. Practicing attorneys and judges comprised the Law School faculty.

In 1915, Wm. H. Leary, graduate of Amherst and the University of Chicago Law School, succeeded to the position of dean of the Law School. Through his efforts the School of Law has been brought on the University campus, where it is now housed in comfortable quarters in the John R. Park Building. A standard working library has been provided with reading room and class rooms. Students also have easy access to the splendid law libraries in the State Capitol and the City and County Building. Moot Court is also held once each week in the Supreme Court chamber under the direction of Justice J. E. Frick of the Utah Supreme Court.

The instructors have all been educated under the modern case system and are graduates of standard schools: Harvard, University of Chicago, and Columbia. They are also engaged in the practice of law. Present plans call for the engagement of sufficient full time instructors next year to comply with the requirement of the Association of American Law Schools.

Dean J. P. Hall, University of Chicago Law School, in a 'etter to the president of the University of Utah, said, "I am glad to say that we have always given full credit here for law work done in the University of Utah with good grades - - - . Almost every student who has entered here with advanced standing in law from Utah, has done well here, and the record of your school in this respect compares favorably with that of any law school from which a substantial number of students enter with advanced standing." Similar statements have been received regarding general U. of U. standing from Harvard, Stanford University, and Columbia.

The Law School follows the recommendation of the American Bar Association regarding entrance requirements. Graduation from the Law School admits a person to practice law in the State of Utah.

There are at present 85 students, exclusive of pre-legal men, enrolled in the Law School







The Sutherland Law Club

The Sutherland Law Club of the University of Utah, was organized in November, 1923, with fifteen members, all students of the University Law School. The main purpose of this little group of enthusiasts was to encourage the attainment of higher standards of work and to create an esprit de corp among its members.

At the monthly meetings prominent members of the bench and bar were invited to address the members. The meetings were largely devoted to the discussion of legal problems but social interests were not entirely forgotten.


Shortly after the organization of the club a movement was started to obtain a charter in some legal fraternity—the presenting of this petition s the result.

One of the incentives urging the Sutherland Club to the successful accomplishment of its tasks has been the desire to be worthy of its name. Justice Sutherland of the U.S. Supreme Court, a Utah man, had graciously consented to the use of his name and accepted honorary membership in the club. The desire to honor him who honored us has ever been a prime factor in all the Club's endeavors.

At the present time it is apparent that the organization of the Sutherland Club has been worth while in the interests of its members as well as in the interests of the University. Through its efforts the Barristers Club has been made to really function; the Moot Court has been stimulated to greater success; and school activities have been given more sincere support by the Law School than ever before.
