

The Supreme Justice's Recent Trip

Around the Loop With Brother Hardy in his Swing Through the South and East



THINK that the fraternity at large will be interested in knowing the

high-lights of my recent trip through the south

There were a number of reasons that made this trip necessary, not the least of which was to give official expression to the action of the last convention in creating a Southern District. Many of you know that considerable agitation for the creation of a Southern District has gone out for a number of years, the southern chapters feeling that their problems were local to themselves and not bound up with problems incidental to northern chapters, and that for that reason a straight up and down - longitudinal - division of the United States into districts did not meet the situation presented by the Southern District. The new Southern District Justice is Amzi G. Barber, of Birmingham, who is an alumnus of the University of Alabama, and who was, during his college days, a strong factor in the success of Morgan Chapter at that University. He has been trying to bring the chapters in the newly created Southern District together, letting them know that they were in fact parts and parcels of the fraternity and that he was the direct representative of the official fraternity in their midst.

By REX HARDY Supreme Justice I first met with the men of Martin Chapter (Tulane University), at New Orleans, and nothwithstanding the fact that

school had not yet opened, was fraternally greeted and royally treated by those of Martin Chapter who were then in the city. I can readily say that the interests of the fraternity in and about New Orleans are in capable hands, and that the fraternity can well be proud of Martin Chapter. Particular credit must be given to Brothers Irion, Singreen, Robinson, and de la Vergne. The fraternity will be very much interested in knowing that the P. A. D's. in New Orleans have petitioned for the establishment of an alumni chapter in that city, and the Supreme Board has passed favorably upon that petition, and as of October 15, 1926, the charter was issued.

At Birmingham I saw Brother Barber, going over the general situation in the Southern District with him for a period of two days, during which time we visited Morgan Chapter at the University of Alabama, which had just then opened its fall semester. Brother Barber and I attended a meeting of Morgan Chapter at the University, which is located at Tuscaloosa, and I am very pleased to say that I believe that the troubles of Morgan Chapter which were reported to the last convention have all been corrected. The chapter was back

in school, in force, and a great deal of interest was shown in my visit inasmuch as it had been years since Morgan Chapter had had any con-

tact with the fraternity in general.

From Birningham I went on to Atlanta and had a number of conferences regarding fraternity expansion in that particular district with Brother Alex M. Hitz and Brother Henry M. Quillian, Jr. Older P. A. D's. who were in Washington, D. C., will remember Alex M. Hitz, while Calhoun alumni will be glad to know that Brother Quillian is an instructor in the Law Department of Emory University at Atlanta.

At Chicago I enjoyed the hospitality at the P. A. D. table in the restaurant of the Bar Association, and held a semi-official gathering at the Hamilton Club which was attended by representatives of the chapters in and about Chicago—at least all the representatives that we could get in touch with. At this conference a number of matters were discussed, not the least of which was a sounding of the attitude of the Chicago chapters upon summer conventions. Let me say right here that the question of summer conventions is one you will hear more about later on. I was also

fortunate in being in Chicago at a time when Blackstone Chapter was holding a rushing smoker, and I hope that the fact that Black stone was able to get to that smoker four national officers made an impression upon their rushees.

The trip was necessarily rapid, and I am only sorry that I was not able to take more time and visit more places. The primary need for the visit was in the South, as this administration wants to do everything that it can to get the newly established Southern District upon a sound basis.

On the question of summer conventions I will be glad to hear informally from officers of all chapters in the near future as to what your attitude on this matter is. There are a great many things to be said both for and agains summer conventions and the matter is well worthy of careful consideration. The time is going to come when you will have to pass upon the matter officially, and in the meantime it is well to be considering the situation. Your response to this request for your unofficial ideas will in a large measure determine the energy with which the matter will be pressed in the future.

NEWS OF P. A. D. A L U M N I

Brother William Howard Taft (Calhoun), Chief Justice of the United States, was presented with the honorary degree of Doctor of Laws by the State Board of Regents of the University of the State of New York at the Sixty-second annual convocation of the Board at Albany late in October.

Brother Curtis D. Wilbur (Holmes) Secretary of the Navy, was the only member of the President's Cabinet that did not vote in the last general election in November. The election laws of California do not provide for voting by mail. All the other members of the Cabinet went home to vote with the exception of Secretary of State Frank B. Kellogg, who cast his vote by mail, and Brother Wilbur, who did not wish to make the long trip to California and return.

Brother Duncan U. Fletcher, United States Senator from Florida, underwent an operation for an infected bladder at the Battle Creek Sanitarium at Battle Creek, Michigan, during the past summer. He entered the Sanitarium on the 24th of July and was able to leave there on October 11. He suffered a preliminary and major operation while there. They left him very weak but he gained strength rapidly. His physicians have assured him that the operations have added some years to his life and that his health will be better than it has been for some time past. He already feels greatly benefited.

Brother Charles Bridgham Hosmer (Hamlin, who is American Consul at Sherbrooke, Quebec, Canada, has returned there after a leave of absence. During his leave he visited at Danielson, Connecticut. Brother Hosmer has been in the American Consular Service for quite a few years. He was formerly Consul at Santo Domingo, Dominican Republic.

Brother Waldemar C. Wehe (Ryan) of Milwankee, Wisconsin, is the senior member of the law firm of Wehe & Landry. The firm has its offices in the Plankinton Building, which is located at Grand Avenue and West Water Street.

Brother John T. Chadwell (Magruder) of Chicago, Illinois, was married to Miss Edna Morris of Missoula, Montana, during the past summer. Their acquaintanceship was formed while Brother Chadwell was teaching at the University of Montana. After the wedding ceremony at Missoula, they enjoyed a delightful trip through Yellowstone National Park before returning to Chicago. Brother Chadwell-is associated with the law firm of Nicholson, Crandall & Snyder in the Otis Building.

Brother Hal Curran (Green) of Casper, Wyoming, is in partnership with William B. Cobb under the firm name of Curran & Cobb, with offices in the Consolidated Royalty Building. Both are graduates of the University of Kansas but Mr. Cobb is a member of Phi Delta Phi.

Brother Leland S. Forrest (Campbell) is now a member of the faculty of the School of Law of the University of North Carolina at Chapel Hill. He is on a leave of absence from Drake University where he was Dean of the Law School.

Brother Benton Baker (Calhoun) is Referee in Bankruptcy at Bismarck, North Dakota. He is Chairman of the Committee on Ethics of the National Association of Referees in Bankruptcy and is now engaged in the preparation of a Code of Ethics for Referees and Practitioners in Bankruptcy matters.

Brother Glenn G. Paxton (Magruder) of Chicago, Illinois, was married to Miss Florentine Anne Nosek of Chicago, on October 15, 1926. Brother Paxton is associated with the law firm of Cloyes & Klinger.

Brother James J. Gill (Kent) has been a Professor of Law at the University of Idaho at Moscow for the past thirteen years. He was acting Dean of the College of Law from June 1917 to September 1919. He served as District Attorney of Oconto County, Wisconsin, from 1898-1904 and as Special Prosecutor from 1904-1912.

The decision of the Supreme Court of the United States in the Right of Removal Case is of extraordinary interest. It will undoubtedly rank with the most notable decisions of that Court. Its significance is political, in the broader sense of the term, for it will be a lasting landmark in the never-ending development of the Constitution.

On October 25 the Supreme Court declared that the President was fully and exclusively empowered to dismiss officials appointed by him, in spite of any legislation to the contrary. The particular case passed upon has been running so long that the original complainant is deceased. He was Frank S. Myers, who had been appointed Postmaster of Portland, Oregon, in 1917. In 1920 he was removed from office by President Woodrow Wilson (Jefferson) without the consent of the Senate. He brought suit to recover the salary that he would have received for the balance of his four-year term. The Court said that he could not get his pay because he was legally

Chief Justice William Howard Taft (Calhoun) handed down an exhaustive and masterly opinion consisting of fifty-five pages. There is indeed a scholarly solemnity in his document, which was a year and a half in preparation. In it he said:

"The power to prevent the removal of an officer who has served under the President is different from the authority to consent to or reject his appointment. When a nomination is made, it may be presumed that the Senate is, or may become, as well advised as to the fitness of the nominee as the President, but in the mature of things the defects in ability or intelligence or loyalty in the administration of the laws of one who has served as an officer under the President.

idents are facts as to which the President or his trusted subordinates must be better informed than the Senate, and the power to remove him may, therefore, he regarded as confined, for very sound and practical reasons to the governmental authority which has administrative control. The power of removal is incident to the power of appointment, not to the power of advising and consenting to the appointment, and when the grant of the executive power is enforced by the express mandate to take care that the laws be faithfully executed, it emphasizes the necessity for including within the executive power as conferred, the exclusive power of removal."

The fact that the Constitution places no express limit on the power of removal by the Executive is taken by the majority of the Court as "a convincing indication that none was intended." Chief Justice Taft, therefore, says "we must hold that the provision of the law of 1876 by which the unrestricted power of removal of first-class postmasters is denied to the President, is in violation of the Consti-

tution and invalid.

These points were made in the course of the opinion of the Chief Justice, which consisted of some 24,00 words. Justice James Clark McReynolds, after whom McReynolds Chapter of Phi Alpha Delta is named, used 20,000 words to tell why he disagreed. In a very emphatic opinion he says:

"The very foundation of the government is gone. After today no man can tell just what are the powers of the President and Congress. Yesterday we supposed we had a government of specified limited powers. Today no one knows. Nothing short of language clear beyond serious disputation should be held to clothe the President with authority wholly beyond Congressional control arbitrarily to dismiss every officer whom he appoints except a few indexs. There are no such words in the Constitution, and the asserted inference conflicts with the heretofore accepted theory that this Government is one of carefully enumerated powers under an intelligible charter."

However, the exhaustive opinion of Chief Justice William Howard Taft leaves little opportunity for comment upon the decision. It passes upon the question clearly and decisive. The removal power of the President rests upon a direct grant of power and is not a mere incident of the power to appoint. Thus, Congress may not, by any law, prevent the President from removing anyone in the Executive Department whom he has appointed.

The Hon. Erskine M. Ross, after whom Ross Chapter of the University of Southern California is named, and who recently retired from the United States Circuit Court of Appeals for the Ninth Judicial District, recently gave to the boys of Ross Chapter a handsome, autographed and framed picture of himself, which is now reposing in the place of honor in Ross Chapter house at 1154 West 30th Street, Los Angeles. Judge Ross has been a famous figure in California jurisprudence for over forty years, and is a constant inspiration to the boys of Ross Chapter.

BROTHERS IN THE PUBLIC EYE

Brother U.S. Webb

Brother Ulysses Sigel Webb (Jackson Temple Chapter) was born in Flemington, West Virginia, and when very young removed to Kansas. His early education was in the district schools. Attended high school in Augusta, Kansas. Received his Bachelor degree at Kansas Normal College at Fort Scott. Became editor of weekly paper at Augusta. Came to California in 1888 and shortly after took up the active practice of his profession. Was elected District Attorney of Plumas County in 1890, which position he held until 1902 when he resigned to accept the appointment of Attorney General of California.

Twenty-four years have passed and each succeeding election serves to show the appreciation of the people of California for the able, learned and dignified manner in which he has conducted his office. He has just been elected for another four-year term without opposition.

Brother Webb has attained State, national, and world-wide recognition by virtue of his legal ability and extensive knowledge of

political economy.

Webb drafted the Alien Land Act which prevents aliens ineligible to citizenship from owning real property and sustained his contentions in every instance before the Supreme Court of the United States. At the request of the Imigration Committee of the United States Senate he appeared before that body in 1924. General Webb was chosen as a member of the National Crime Commission, which body is acting toward the adoption of a uniform criminal code for the United States.

General Webb is past-president of the Association of Attorney Generals. He is a Mason, an Elk, and a member of the Union League and Commonwealth Clubs of San Francisco, Sutter Club of Sacramento, and the

American Bar Association.

J. Zach Spearing

When the voters of New Orleans, a few years ago, chose Brother James Zacherie Spearing to represent them in the Congress of the United State they selected a man who had not only made a success in business; not only made a success in the practice of law, but who had ever given of his time and effort for the public

weal. His election to Congress, as an independent Democrat, came after years spent uselfishly as a member, successively of the Orleans Parish and Louisiana State Boards and Education, and it is of especial importance to note that it was during the years that Broths Spearing served in the work of educational development, that Louisiana forged ahead to the enviable position she holds today.

Brother "Zach," despite the fact that he was born during the Civil War, is a young may of energy, enthusiasm and that breadth of vision so much needed in our national affairs. But this enthusiasm is tempered by the practicability of the man of affairs, for before tecoming an honor graduate of Tulane University, and eventually head of one of the larges law firms of New Orleans, Brother Spearing was a level headed business man. Much of his success as a lawyer and as a statesman is attributed to his early training.

Running as an Independent, he has three times been sent to Congress, first defeating tw very popular and powerful opponents, the sec ond time without opposition, and he will take his seat in the new Congress after having defeated, by a two to one vote, three very able opponents.

One gets the impression that this man is a youngster. He ever talks of the future. His hobby (he wouldn't admit he had a hobby) we suspect, is aviation, with a big A. He is on the exclusive committee of Post Offices and Post Roads, in the national House of Representatives, and that to him means aviation. He looks to the future, and believes that the air is the sea of tomorrow.

He is a Phi Alpha Delta who has not forgotten the days in school. When he talks with the youngsters at the chapter smokers, or attends the initiation, it is with the spirit and fire of the youngest freshman, but when he turns to a discussion of affairs of state, one realizes immediately that he is listening to an authority.

Arthur A. Morrow

Brother Arthur A. Morrow (Cole) of Des Moines, Iowa, is Dean of the School of Law at Drake University. He was born on a farm

hear West Alexander, Pennsylvania, on August 10, 1893. His ancestry is Scotch-Irish and German. He attended grade school in Donegal Township, Washington County, Pennsylvania, and graduated from high school at Claysville. In the fall of 1907 he entered Bethany College at Bethany, West Virginia, graduating therefrom with an A. B. degree in June, 1911. He was selected by the faculty as Salutatorian of his class. For some time after graduation from Bethany College, he taught mathematics and science in the high school at New Martinsville, West Virginia. He also devoted a portion of his time to the study of law in the office of the District Attorney of Wetzel County, of which New Martinsville is the county seat. In the fall of 1913 he entered the University of Michigan Law School and graduated with the degree of J. D. in June, While at Michigan he was a student editor of the Michigan Law Review; a member of the Order of the Coif; and Valedictorian of the Class of 1916. During the World War he served in the United States Navy. He was a Quartermaster, First Class (Aviation)-QM (A)1C-and was stationed at the Charleston Navy Yard and the naval base at Hampton Roads. He has traveled in France, Italy, Austria, Czechoslovakia, Germany, Switzerland, Holland, Belgium, England, Scotland, Ireland, and Wales.

For the past eight years Brother Morrow has been a member of the law faculty of Drake University. On April 5, 1926, he was elected Dean of the School of Law, his duties as such beginning June 15. He will teach Contracts, Negotiable Instruments, Common Law Pleading, Code Pleading, and Conflict of Laws during the coming year. In July, 1921, he was selected as Dean of the College of Commerce and Finance of Drake University and continued in this position until June 15, 1926. While he was Dean of the College of Commerce and Finance he continued to teach in the Law School as his work in the College of Commerce and Finance was administrative only,

Brother Morrow was initiated as a member of Cole Chapter in May, 1921. He is a member of Tau Psi, local social fraternity at Drake; Delta Sigma Pi, national Commerce fraternity; Order of the Coif; the Frontier Club and the University Club of Des Moines

Arthur A. de la Houssaye

Brother Arthur A. de la Houssaye (Martin) of New Orleans, Louisiana, is Assistant United States Attorney for the Eastern District of Louisiana. He was born at Franklin, Louisiana, on September 2, 1900, the son of Mr. and Mrs. E. A. de la Houssaye. His early training was received in the schools there and on June 6, 1919, he graduated from Franklin High. In the fall he entered Tulane University at New Orleans. While at Tulane he became a member of Beta Theta Pi social fraternity. He was active in college affairs, being Vice-Pres-

ident of the Freshman Law Class and Secretary-Treasurer of the Senior Law Class. He was also a member of the Freshman-Sophomore Tug-O-War Team and a member of the Varsity Rowing Team. On June 6, 1923, he received the degree of LL. B. from Tulane University and was admitted to the bar of Louisiana the same day. Brother de la Houssaye was an alumni member of the Omega Rho fraternity which petitioned for a charter to Phi Alpha Delta. Upon the installation of Francois Xavier Martin Chapter at Tulane on December 13, 1924, he became an alumni member of the same. In October, 1923, he became associated with the law firm of Henriques & Duchamp. Brother Edouard F. Henriques, who is Special Assistant to the Attorney General of the United States in Admiralty, is the senior member of this firm. On February 1, 1925, he was appointed Assistant United States Attorney for the Eastern District of Louisiana on the recommendation of Brother Louis H. Burns, then United States Attorney and now United States Judge for the Eastern District. He was placed in charge of all violations that come under the National Prohibition Act. Since he was so appointed he has filed in the United States District Court over a thousand informations charging violations

of the National Prohibition Act, together with at least two hundred equity actions to abate nuisances under Section Twenty-Two of the same Act. Over eight hundred criminal cases have been successfully disposed of either by a plea of guilty or by a verdict of guilty by a jury, and over one hundred fifty padlock cases have likewise been disposed of successfully. During a period of three months over \$100,000 in fines were collected together with the for feiture of over a hundred trucks and automobiles which will be sold and the proceeds deposited in the Treasury of the United States. This is indeed a very good record.

Ivan A. Elliott

Brother Ivan A. Elliott (Capen) of Carmi, Illinois, is the new Senior Vice-Commander of the Department of Illinois of the American Legion. Brother Elliott was born in White County, Illinois, on November 18, 1889. After he had completed his elementary and high school education, he entered Illinois Wesleyan University at Bloomington in the fall of 1913 when he was initiated as a member of Charles Laban Capen Chapter. During his entire course he lived in the chapter house, being a roommate of Brother Scott W. Lucas of

Havan, who has just retired as State Commander of the Legion. He was active in athletics, being a member of the track and basehall teams during his three years in school. In 1915 he was Captain of the baseball team. He graduated from Illinois Wesleyan in the spring of 1916 with the degree of LL. B. He attended the First Officers Training Camp at Fort Sheridan, Illinois, and Fort Monroe, Virginia. On August 15, 1917, he was commissioned a First Lieutenant in the Coast Artillery. He served overseas with the First Batallion of the 52nd Artillery (C. A. C.) from Septmber 12, 1917, to November 26, 1918. He was promoted to the rank of Captain on September 21, 1918, and now holds a commission as Major in the Coast Artillery Reserve, commanding the 532nd Artillery. Since the organization of the American Legion in Illinois he has been Adjutant of Carmi Post No. 224. For three years he served on the State Executive Committee and also served as a member of the State Finance Committee for the same length of time. During 1925-26 he was Junior Vice-Commander for the four Districts in Southern Illinois. He was elected Senior Vice-Commander of the Legion at the State Convention at Springfield on September 14, 1926. He succeeds Brother Ferre C. Watkins of Chicago, who was elevated to the post of State Commander. It is indeed a coincidence that they are both members of the same chapter and also graduates of the same law school. Since the war he has practiced in Carmi, White County, Illinois, with the law firm of Conger and Elliott. He is also a part owner of the White County Abstract Company at Carmi. He is a member of the Kiwanis Club and has been Chairman of the District Citizenship Committee of Illinois and Eastern Iowa District. Brother Elliott is married and has two sons, Ivan A., Jr., and Norman.

Hjalmer W. Swenson

Brother Hialmer W. Swenson (Corliss) of Devils Lake, North Dakota, is State's Attorney of Ramsey County. He was born at Minneapolis, Minnesota, on November 18, 1885. Later his parents moved to a farm near Wheaton, Minnesota, where he lived until he was nineteen years of age. He received his elementary and high school education at Wheaton. After he graduated from high school, he taught school for five years in Minnesota and North Dakota. In the fall of 1911 he entered the University of North Dakota and graduated from the Law School in 1914 with the degree of LL. B. He was admitted to the bar of North Dakota the same year. During the next six years he served as Assistant Cashier of the State Bank of Brocket. In December, 1920, he was appointed County Judge of Ramsey County, North Dakota, to fill a vacancy caused by the death of the presiding Judge. After serving a little over two years on appointment, he was elected for another two-year term. Thereafter he was elected State's Attorney of Ramsey County, which office he is now holding for the first term. On being elected State's Attorney he formed a

ALUMNI CHAPTERS

CHICAGO

The following are notes from Minutes of Chicago Alumni Chapter, at Chicago Bar Association, October 19, 1926:

Blackstone Chapter was the guest of honor and responded with seventeen active members present and thirteen alumni chapter members. Brother George Patterson of Blackstone Chapter responded to call with well chosen and interesting remarks.

Plans for the fall informal dance, to be given during the first part of December, were reported in process of perfection and receiving the active support of the inter-chapter

council of Chicago chapters.

Suggestions that chapter dues be raised from \$2.00 to \$3.00 and thereby include a subscription to the P. A. D. Quarterly were received. Action was deferred for further investigation and discussion.

A committee upon revision of the twentyyear-old constitution of the Alumni Chapter is giving such revision serious consideration. A lively meeting is expected for November when the revision will be presented for adoption.

The honor bestowed upon our Brother Supreme Historian Allan T. Gilbert, by virtue of his appointment as Judge Advocate of the Illinois Department of the American Legion, was announced and congratulations extended

to the Brother.

Chicago Alumni Chapter is fortunate in counting amongst its members the Hon. Judge John P. McGoorty, Judge of the Superior Court of Cook County. In his eloquent and interesting manner the Judge spoke upon the subject "Privileges of the Legal Profession." He described the dignity of the Irish Courts, which he visited this past summer, and spoke of the friendliness between judge and lawyer in such courts, the beautiful simplicity and dignity of that most magnificent court of the world, at the Hague in Brussels. By contrast the speaker led his listeners to view the conditions of our Chicago law and courts-a challenge to the Bench and Bar! "Society looks to the lawyer for leadership and during the Constitutional days of crisis of American life, they have not looked in vain. It has been the lawyers who have shown the way in times of strife. Lincoln was such a lawyer-leader to whom we owe much to his clear foresight in

perceiving that slavery was secondary to the question of the Union in the Civil War period. With the intrusion of government upon individual rights, however, our criminal rules have become antiquated, obsolete and broken down. The rule that silence of the accused shall not be taken against him, the rule graning bail to convicted murderers pending an appeal—such rules are unjust to modern society. For leadership in these matters the people look to the bench and bar and lawyers must realize their duty of leadership—the ministers of the law must shoulder this responsibility.

Meeting November 16, 1926

The meeting was designated as "Founder's Meeting," and three of the original founders were present, together with twenty-five other members. Brothers Prentiss, McCormick, and Sidney Meyer were the founders present and each responded to a call for impromptu remarks. Brother Prentiss told how he had lost touch with the fraternity until some three years ago when he found a very active Cleveland Alumni Chapter in existence. He was amazed at the growth of the fraternity, which he said was beyond any dreams they had back in 1902. Brother Meyer informed us that it was Brother Prentiss who designed the P. A D. pin and he also told us of various interest ing events connected with the early days, such as the numerous "continuances" granted at the time of organization at South Haven for the purpose of keeping the machinery well oiled and properly refreshed. Brother Meyer congratulated the younger members for carrying on the work so well. Brother McCormick told further choice and juicy bits of founder's history, especially how as a curb on the curiosity of a now prominent Chicago lawyer as to the activities of the founders, our gentle (?) voiced and mannered brother, Dwight McKay, conducted a certain ceremony where in a bottle of indelible ink did its work well Brother McCormink also told us of the work which he was now greatly interested in, of securing judges by appointment instead of election.

Brother former Justice George Fink, a pillar if not a founder of the fraternity, suggested a pilgrimage to South Haven in 1927 to commemorate the founding of the fraternity. He

told of the bronze tablet which the founders had placed securely upon one of the pillars of the old Colonial Hotel, which was the headquarters of the founder's convention. Brother Prentiss said he made a search a year or so ago for such bronze tablet, but could not find it. The old hotel had burned down he found. He suggested a new tablet being placed with proper ceremonies.

Other old-timers who reminisced were Brother Harry Moran and Brother Cambridge. The address of the evening was made by

Brother Ferre C. Watkins (Capen), now State Commander, Illinois Department of the American Legion. Brother Watkins said he found many P. A. D's. active in Legion work. The Legion will play a great part in American life during the next fifty years, he said. The bonds which secure adhesion in the Legion were firmly knit during the war and by the needs of its members after the war. Twentyseven thousand veterans are still in hospitals, he said. During 1921-22, the Legion did important work in the bread lines in counteracting the work there of agitators. At present an average of eighteen in Cook County alone become insane weekly. In the field of Americanization the Legion does important work in counteracting the activities of organizations masking as humanitarian, whose work, especially amongst women and in schools and churches, is insidious and more dangerous than the work of active radicals. Of late there has been much tampering with school text Through the work of the Legion, attendance at R. O. T. C. camps increased fifty per cent. "Rational Patriotism" is the watchword and aim of the Legion. Its work was directly responsible for the restricted immigration laws in force at present. The Legion voices American feeling in a non-political way. It is high and clean in its aims—its policy is to give, not to receive. Its activities are nation-wide. In Illinois alone there are 658 Posts, each a vital active part of its community life and each carrying on its duties as a sacred trust.

A unanimous vote of thanks was tendered Brother Watkins and ordered spread of record.

Five new members were admitted to membership: Ralph W. Abbott, (Fuller) 1913, Paul Arthur Warme, (Blackstone) 1917, Larned V. Eklund, (Fuller) 1923, Leo N. McGlinn, (Story) 1924, and John E. Roche, (Blackstone) 1926.

Because of conflict with local chapter dances. it was decided not to hold a fall joint-chapter informal dance this year but to go ahead with the yearly formal joint-chapter dance next Spring.

Brother Supreme Historian Allan T. Glbert told of the progress of the new national directory in process of issuance. Several members expressed tribute to the directory and the chapter went on record as ready to lend its assistance to the Historian in his work.

Next year, being the twenty-fifth year of the founding of the fraternity as a national organization, a committee was appointed to arrange for a "Founder's Outing" at a date as close as possible to July 27, 1927.

WASHINGTON D. C.

It may be of interest to know that we have enrolled approximately 175 members. We have been able up to date to interest only a relatively small number in our activities. Those that have attended the meetings are very enthusiastic and have been doing their utmost to push P. A. D. forward in this section of the country.

The alumni chapter has made great strides forward during the past year under the leadership of Justice K. N. Parkinson. He has made the meetings attractive and is hopeful this coming year of securing an attendance of at least lifty to seventy-live members at each

One of the principal reforms instituted by the present Justice is in the matter of eliminating from the meetings the usual waste of time over non-essential business matters. Brother John E. Nelson (Hamlin) of Augusta, Maine, has been returned to Congress to again represent the Third Congressional District of Maine. The election was on Suptember 13, 1926. As the Maine election was almost two months prior to the date of the general elections held in the other States the Republicans and Democrats alike had their attention centered on Maine as the election there furnished the first barometer on the sentiment as between the two parties. The State of Maine went Republican by a large vote.

Brother Thaddeus H. Caraway (Jay) of Jonesboro, Arkansas, has been re-elected to the United States Senate, so will continue as the Junior Senator from Arkansas. He is a member of the Committee on Agriculture and Forestry; Claims; Education and Labor; Judiciary; and Privileges and Elections. Several weeks ago his son, Forest, was appointed to the United States Military Academy at West Point by Senator Joseph T. Robinson, colleague of Senator Caraway.

Brother John E. Martineau (Garland) of Little Rock, Arkansas, was elected Governor of Arkansas on the Democratic ticket at the general election held on September 13, 1926. He will be inaugurated next January and will continue to occupy the position of Chancellor of the First Chancery District until then. Back in 1907 when a vacancy was created in the office of Chancellor of the Little Rock district by the elevation of Brother Jesse C. Hart to the position of Associate Justice of the Supreme Court of Arkansas, Brother Martineau was appointed to the position. Since his appointment he has served uninterruptedly for a period of nineteen years.

Brother Duncan U. Fletcher (Fletcher) of Jacksonville, Florida, was re-elected to the United States Senate at the general election held on November 2, so will continue as Senior Senator from Florida. Only two Democratic Senators, Simmons and Overman of North Carolina, have had longer service than Senator Fletcher, and only four Republicans. This gives Brother Fletcher a commanding position on leading committees. He is the first Democrat on the Commerce Committee and like-

wise on the Military Affairs Committee, and very high up on the Banking and Currence Committee, besides having membership on several other committees. If the Democrats should obtain control of the Senate, he can take his choice of Chairmanships from these Committees. During the Wilson Administration when the Democrats were last in control he was Chairman of the Commerce Committee He supervised the drafting and enactment of the measures which created the United States Shipping Board and Emergency Fleet Corporation. Since the Republicans gained control he has given non-partisan aid to the administration in every move to strengthen the American Merchant Marine.

Brother Adam McMullen (Reese) of Lincoln, Nebraska, has been re-elected Governor of Nebraska. He had a lead of more than 3,000 votes over his Democratic opponent, Charles W. Bryan, former Governor and Vice Presidential nominee two years ago. Brother McMullen has made a fine record during the past two years and we are indeed glad to see him returned to guide the affairs of the State of Nebraska for another two years. He practiced law at Wymore, Nebraska, many years prior to his election to the Governorship in 1924. He has been active in political affairs for over twenty years.

Brother Lawrence DeGraff (Cole) of Des Moines, Iowa, has been re-elected Judge of the Supreme Court of Iowa for another term of six years. The office of Chief Justice rotates among the members of the Court. For the past year Brother DeGraff has been serving as Chief Justice. Brother DeGraff is a graduate of the Northern Illinois College of Law at Dixon, Illinois, and has held numerous important positions in the State of Iowa during the past twenty-eight years. He has also been active in the affairs of Sigma Chi social fraternity, having been National President of the same. At the general election on November 2 Brother DeGraff ran considerably ahead of the normal vote both locally and throughout the State, which is indeed a very fine compliment to his work on the bench.

He was first elected to the General Assembly in 1894 and has served continuously since then. He was Speaker of the House for a period of eight years. Brother Albert E. Carter (Temple) of Oakland, California, has been returned by the Republicans to represent the Sixth Congressional District of California in Congress. He is now serving his first term and is a member of the Committee on Rivers and Harbors. University of Kentucky

The College of Law at the University of Kentucky celebrated a great forward step in its progress on October 27 that is significant in the develop-

ment of legal education in Kentucky and the South.

A handsome new building, adequately equipped and
containing all the conveniences necessary to the
proper study of law, was formally dedicated. The
ceremonies marked the emancipation of the College
of Law as a separate and distinct unit of the State's
educational system, as this year is the first year that
this institution has been located in a separate building, exclusively devoted to the study of law.

From an obscure beginning eighteen years ago, the College of Law at the University of Kentucky has developed rapidly and is now one of the South's best. Seventeen years of its existence have been handicapped by inadequate quarters in a building which also was used by other colleges and departments of runiversity. The law college formerly was located on the third floor of the Natural Science Building and students were compelled to climb three flights of long stairs to gain access to their crowded quarters.

The building which now belongs to the College of Law is a three-story brick structure, containing airy class rooms, locker rooms and one of the completest libraries in the entire Southland.

At the ceremonies of dedication, Judge Charles S. Whitman, twice governor of New York and the present president of the American Bar Association, de-

livered the principal address.

"The College of Law at the University of Kentucky has gained recognition throughout the nation for its high scholastic standards," Judge Whitman told the students and members of the Kentucky Bar who assembled for the occasion. Judge Whitman referred to the fact that within four years after its organization under an Act of the 1908 Legislature, the institution became a member of the Association of American Law Schools and it has steadily advanced until in 1924 it was placed on the approved list of the American Bar Association.

The Jexington Heratid, one of Kentucky's leading dailles, in a leading editorial published the day of the dedicatory exercises, after reviewing the development of the College of Law, pointed out that Kentucky had particular reason to rejoice in that Kentuckians could be trained for the profession of law as thoroughly at home as elsewhere. In the past the majority of the leaders of the Kentucky Bar have gone elsewhere to obtain their training, returning to Kentucky to practice. This was a great disadvantage to the State as it prohibited much individual development in the legal standards of its courts. But it is believed that this has been remedied by the material and candenic development of the College of Law and, as stated in the Heratid, the future leaders and law-yers of the State can be properly trained in the State.

The ceremonies of celebration served also to bring together many of the alumni members of the Henry Clay Chapter of Phi Alpha Delta, who were welcomed

to the institution by the active chapter.

Although the Henry Clay Chapter has but few members this year, it is one of the most active organizations upon the campus. Plans have been made by the Chapter for various social functions during the year and the prospects for pledging the best of those eligible seem excellent.—Paul Porter,

Speech by J. F. T. O'Connor presenting autographed picture of Irskine M. Ross to Ross Chapter of Phi Alpha Delta on Wednesday, October 13, 1926, Los Angeles, California,

The wisdom and foresight of the University of founders of Phi Alpha Delta provided that chapters should be named after distinguished jurists. The chapters in Chicago, where the fraternity was organized, selected the greatest names in the history of jurisprudence-Blackstone, Kent, and Story, and as other chapters were organized the same policy was followed.

The roll of our chapters contains such names as Calhoun, Benton, Campbell, Chase, Clay, Jefferson, Marshall, Wilson, Taft, Rapallo, and many others. In 1911 when this chapter was installed it selected the name of the greatest jurist in the history of California. It is a great pleasure to be requested today to present to the active chapter a picture of Judge Irskine M. Ross with his autograph and best

wishes to the fraternity

There is nothing finer in life than the influence of a great soul as it sweeps through its alloted period of time. A life of service is like the headlight on a giant engine which dispels the darkness with its brilliant light. Judge Ross has been such a light in the legal history of California. He was born at Bel Pre, Culpaper County, Virginia, on June 30, 1845, and graduated from Virginia Military Institute in 1865. He was admitted to the California Bar in 1869, and ten years later was elected a Justice of the Supreme Court of the State and since that time and up until two years ago he had served with distinction on the Supreme Court of California as a United States District Judge on the United States Circuit Court until he voluntarily retired two years ago.

In these forty-five years he indelibly impressed of thought, accuracy of expression and justice in results have never been equalled or surpassed by any California judge. He came to this State when its institutions and its courts were in their infancy and at a time when a strong, clear mind was needed to expound and apply the great principles of law and equity upon which the prosperity of this States has

Other men during this period bent their mental goods. Some have retained the wealth they won. others have dissipated it. Some fortunes have passed into hands that are unworthy. Judge Ross sends to us today his message of regret from a bed of pain. His mind is as clear today as when his greatest decisions were written. The eighty-two years have not heavily upon his body. He does not boast of great wealth. He looks back today over those forty-five years spent as a judge in the various courts in this State, certainly with some degree of pride. In that
