#### CHICAGO ALUMNI CHAPTER OUTING

Saturday and Sunday, July 21-22, A. D. 1928, saw nearly one hundred P.A.D.'s of Chicago Alumni and adjoining chapters journey to Oak Hills Country Club, situated about thirty miles southwest of the city.

The scores for Sunday on the golf course were a great deal higher than those on Saturday. Nobody has attempted any explanation. None has been called for.

Many of the old timers were there. To Brother Donald P. Blake, Wilson Chapter, master of arrangements, goes the credit for making the outing a memorable success. Even the ancient classic

Brother Hayes pitched a sterling game for the Married Men, resulting in victory for them, 8 to 5. # JUDGE JONES ADDRESSES CHICAGO ALUMNI CHAPTER

Members and friends of Chicago Alumni Chapter enjoyed an outstanding evening on October 23, 1928. After a splendid chicken dinner, the Honorable Edgar A. Jonas (Webster), a past Supreme Justice of the fraternity, ever a loyal and active P. A. D., and now one of the judges of the Municipal Court of Chicago, addressed the members and their friends, all members of the Bar of Chicago having been invited and many of them having come, in the first of three lectures upon the life of John Marshall, the first Chief Justice of the Supreme Court of the United States. The speaker's subject was, "The Cause and Effect of Marbury vs. Madison."

Judge Jonas, who is widely known as an orator of no mean ability, drew a vivid picture of the setting in which the famous decision of which he spoke, was laid. He ably portrayed the causes leading to the necessity of the decision and gave his audience a very informative history of the judiciary system of our government.

When John Marshall was appointed Chief Justice of the Supreme Court in 1801, the City of Washington to which he came was as yet but little more than a dream. The streets had been laid out, but no improvements whatsoever had been made. In the winter months they were a morass of mud and slush, over which travel was almost impossible, and many a guest failed to arrive at his destination because his vehicle had become stuck in the mud and the condition of his clothing made him unpresentable. During the summer the passage of a carriage would send up great clouds of dust.

It appears that upon his appointment, Marshall took lodging in a boarding house. An interesting side light of his place of abode, which was typical of its contemporaries, was that one rate was charged guests who desired only the customary lighter drinks, while a higher rate was charged those desiring their favorite libations.

At this time the federal courts had become objects of ridicule and contempt among the populace, there being little purely American law and the judges seemingly having adopted the ideas controlling the bloody assizes of Jeffries. The federal judges assumed jurisdiction of any matter they could lay their hands upon, and in contemptuous disregard of juries proceeded summarily, and sometimes without hearing the defense at all, to impose cruel and unusual punishments. Marshall saw the dangers and this situation was one of the first things to receive his corrective attention.

Jefferson was just beginning his first term of office at this time, after a long regime of the Federalists. Jefferson, being a man of

the people and opposed to strong centralized powers, contended that the Federalists had packed the judiciary, seeking to maintain it as their stronghold. That stronghold had to be taken, so Jefferson set about to break the power of the judiciary. Opposed was Marshall, the lawyer, who, believing that the courts should be the bulwark of liberty, set about to elevate them to the power and dignity which he believed they should have.

Marshall, although not widely known in public life before he became Chief Justice, had been Secretary of State for a short period under President Adams. While Marshall was Secretary of State, Adams had appointed forty-two Justices of the Peace for the District of Columbia and had sent their appointments to Marshall as Secretary for the issuance of the warrants. The issuance of these warrants was apparently overlooked by Marshall, who just about that time was appointed Chief Justice, and they were left on his desk with the warrants unissued. Jefferson caused twenty-five of these appointments to be confirmed, but withheld seventeen, among which was that of one Marbury. Seeking to obtain his commission Marbury filed an original application with the Supreme Court for a writ of mandamus against Madison, then Secretary of State, to require him to deliver his commission as Justice of the Peace.

Jefferson, seeking to break the Federalists last stronghold, the courts, sought to arouse public opinion so as to force the judiciary into that position which he considered it ought to hold, viz, an arm of the executive branch. The question was hotly debated in the press and Jefferson made great political capital out of the controversy. But Marshall was not to be bluffed. By reason of the application of Marbury for his writ of mandamus, Marshall was confronted with either exerting the powers of the courts to the disadvantage of the executive department of the government, or with ruling that the judicial department has no power to coerce the executive department.

By a masterly decision, supported very little on precedent and authority, but almost wholly upon outstanding reason and logic and comprehensive political theory, Marshall took the position that under the Judicature Act of 1801, having to do with the originating of writs of mandamus, an original application therefore did not lie to the Supreme Court, but at the same time ruling, by logic so convincing that it was not questioned thereafter for forty years, that the judicial department of the government could and would prevent the executive department from acting contrary to the powers conferred upon it by the Constitution and laws of the United States. This decision took all the flame out of the heated discussion that had been going on over the whole country. Denying the right of Marbury to his warrant under such an ori-

ginal application, it satisfied the Jeffersonians. Establishing that the judiciary was an independent branch of the federal government, and of the same magnitude as the executive branch, his decision had the double effect of satisfying both the executive branch and at the same time firmly establishing the power of the Supreme Court to enforce the supreme law of the land.

Other effects of the decision were widespread. It encouraged the people and the bar to pin their faith on the Constitution as the backbone of their rights and liberties. It established the rule of law whereby the courts have ever since had the right to declare void any law or act repugnant to the Constitution. It encouraged commercial expansion throughout the country, because the merchants began to see that their contracts would be upheld and would not be overriden by conflicting laws or by reason of political influence. It established the place of the legislative, judicial and executive departments of the government, and it established John Marshall as one of the greatest jurists of all ages.

On January 15, 1929, at the annual meeting of the Alumni Chapter, Judge Jonas will deliver the second lecture of the series entitled, "Marshall and his Conduct in the Trial of Aaron Burr." The third and last of the series will be given at the meeting on March 19th, and the subject will be, "What has Marshall contributed to the Judicial Department of the United States."

Chicago Alumni Chapter also held its regular monthly meeting at the Chicago Bar Association on the evening of November 20th. Brother Frances L. Boutell (Marshall), a member of the Cook County Board of Commissioners, gave an illustrated lecture on "Cook County By-Ways." He told of the Cook County Hospital, one of the largest institutions of its kind in the world, wherein over one hundred thousand patients, were treated last year; of the skilled physicians upon its staff; of the great work it does for the poorer classes, and of the great reputation it has throughout the world. He also told of the Mother's Pension Fund work, of the modern institution which has taken the place of the old county poor farm, of the work of training wayward boys in institutions provided for such purposes, which have displaced old penal institutions, of the new Cook County criminal court and jail, the House of Correction and of the concrete highways which are being extended throughout the county. The lecture informed many of the members with knowledge of the great work being carried on of which but few had previously had but a hazy idea.

# THE SUPREME SECRETARY VISITS ALUMNI CHAPTERS

The Quarterly, betraying its natural instinct towards yellow journalism, has much pleasure in publishing a private—and we know closely guarded copy of a letter recently written by our Supreme Secretary to two high officials of the fraternity. This is enclusive to the Quarterly and is protected by copyrights, injunctions, mandamus and all other suitable legal engines and devices:—

I am handing you herewith a belated report of my inspection October 12th and 13th of the Dunbar and Seattle Alumni Chapters of our fraternity. On account of the limits of time and space and further on account of your jealous dispositions, I shall not attempt to cover my pleasant experiences in making the boat trip from here to Seattle and return, nor shall I relate my unusual and altogether delightful experience enjoyed within the confines of our neighbor to the North other than to suggest Victoria, B. C., as a fitting place for either a Supreme Board meeting or a National Convention. The trip was altogether delightful and the fact that I regained nine pounds of the eighteen which I had lost during the summer my two weeks sojourn up North will indicate to you that the trip was not only pleasant but profitable.

But to get on with my report. I feel that it would be difficult to be too complimentary regarding the manner in which these two chapters, segregated geographically as they are, have carried forward through the past years. Our boat being late I received a radiogram from Justice Harold Holden requesting that I proceed, upon my arrival in Seattle, directly to the D. U. House which I did. I found Brother Holden to be a vigorous, aggressive, and outstanding man on the campus. In addition to being Justice of Dunbar Chapter he heads the D. U. Fraternity and is president of the local Inter-fraternity Council, as well as being active in all of the University affairs. It is quite evident that like all busy men he finds time to do all of his tasks especially well. After a conference with him I was conducted to the Butler Hotel to a special luncheon which had been called by the Alumni Chapter by Dr. Leslie J. Ayer. It would be difficult to imagine a more pleasant escort. While Dr. Ayer has the reputation of being a hard boiled slave driver in the Law School, he is universally liked and respected and is another justification of our provision for election of honorary members. The only possible criticism I could make of him is that perhaps he talks too much, in that he has invited me to return to Seattle for a fishing trip with him on his yacht and some of these days he is most assuredly going to have to deliver.

Upon our arrival at the Hotel Butler we found some thirtyfive or thirty-six members of the Alumni Chapter assembled for

luncheon, a pleasing turnout when you consider the limited size of our Alumni Chapter and the fact that this was not a regular chapter meeting. After luncheon I was accorded the privilege of talking to them upon the affairs of the fraternity in general and alumni chapters in particular. I must confess that the interested attention accorded me caused me to forget the lapse of time and to prolong my discussion unreasonably. At least I so felt when I discovered that I had talked the greater part of an hour. However, my embarrassment in this respect was somewhat relieved when, with the exception of four or five brothers who had appointments in their offices, all of the remainder plied me with questions regarding the affair of our fraternity for about an hour longer. It was exceedingly gratifying to find that these busy lawyers, far removed geographically from contact with other chapters, have maintained so keen an interest in Phi Alpha Delta. Their interest and their hospitality was an inspiration. Frederick Henricksen, 14 Columbia Street, is their present Justice and Dinsmore Taylor, 726 Third Avenue, their Secretary. Their dues for the current year have been paid. The chapter is in a sound financial condition. The officers are alert and progressive and the future of this chapter is bright.

In the afternoon I inspected the books and records of the clerk and of the treasurer of Dunbar Chapter. This Chapter does not maintain a fraternity house nor club rooms. They hold their meetings in the chapter rooms of the various general fraternity houses. Practically all of their members are general fraternity men. The chapter treasurer had \$15.00 in the treasury with all outstanding obligations paid. The present officers of the fraternity and their addresses are as follows:

Justice-Harold Holden, 1818 E. 45th, Seattle.

Vice-Justice-Jerald Imus, 4543 E. 17th Ave. N.E., Seattle.

Clerk—John W. Day, 4725 E. 15th Ave. N.E., Seattle.

Treasurer—Franklin R. Manning, 5036 E. 36th Ave. N.E., Seattle. Marshall—Kenneth E. Case, 5604 E. 16th Ave. N.E., Seattle.

The chapter opened the school year with a membership of fifteen. The treasurer's records are, of course, simple and easy to keep under the circumstances. I examined the chapter records for the past few years and found that they were very neatly and accurately kept.

At 6 P. M., we had dinner at the D. U. House followed by a chapter meeting immediately after dinner, the members of this fraternity having turned their house over to us for the occasion. The chapter dispensed with the usual routine of business and we devoted some three hours to a more or less informal discussion of the local problems and questions of general interest. The personnel of the Chapter is excellent and they should have an exceedingly

good year. While they do not pledge until the end of the first term, they were on the alert for new men. As the greater portion of our discussion was of a general nature I shall not touch upon it in this report but one or two items I feel are important. It has been the custom of the Chapter to consider scholarship first in the selection of their members. While stressing the importance of a high scholastic standing, I advised them that in my opinion scholastic standing should probably be secondary in pledging men, but if the proper material were secured that then the chapter could bring about the proper scholastic rating.

In my opinion, the Chapter has probably been overlooking good material in the Law School among men who were not members of general fraternities. I attempted to point out to them the advantage to be gained through the selection of fraternity and non-fraternity men.

At 10 P. M., I was forced to leave to attend a party which had been arranged by friends in Seattle in honor of Marie and me and left the boys in a heated discussion regarding the possibility of establishing a chapter house at the University. The boys were extremely interested in learning the manner in which our various chapters had succeeded in operating fraternity houses and I believe that within the next year or two we will have some developments there in that respect.

On Saturday I made a tour of the campus and various buildings. The University of Washington, as you know, has a campus which will compare favorably with any in the United States. I called upon the instructors in the Law School and found that our fraternity is very highly regarded and that our standing is one of which we can be justly proud.

In closing I might state that while I found both of the chapters in excellent condition I believe this inspection has created added interest in our fraternity both locally and nationally and that it will be fruitful of better conditions in the future. Many brothers expressed to me their appreciation of the visit, stating that It was the first time within their recollection that anything of the sort had occurred there. If I have omitted any information in this report which you would like to receive, I should be pleased to supply it upon request.

#### EMMET F. BYRNE

Brother Emmet F. Byrne (Story Chapter), is one of the younger generation of PAD's who is bringing distinction to the fraternity through his outstanding ability and achievements. His record needs no editorial praise, for mention of the facts alone tells the story louder than eulogy.

Fraternally, Brother Byrne, was an outstanding member of Story Chapter while preparing for the bar at De Paul University. From Justice of his active chapter, he graduated into Chicago Alumni Chapter, of which he shortly became secretary, and then in rapid succession, treasurer, vice-president and president. Thereafter he rendered such excellent service as Justice of the Northern District, that he was persuaded to serve in such capacity for several terms. In 1923 he was the delegate for Chicago Alumni Chapter to the national convention at Washington, D. C., and his has become a familiar face at all subsequent bi-ennial conventions.

A World War veteran, Brother Byrne, was admitted to the Bar of Illinois in 1919 and to the Supreme Court of the United States in 1923. In June 1921, he was appointed an assistant corporation counsel for the City of Chicago and served in such capacity for two years. By that time he had gained no little reputation as a trial lawyer, and was called to the office of the States Attorney of Cook County, as an assistant. There he was shortly assigned to the trial of murder cases and prosecution of other major crimes. Teamed with Harold L. Levy, they soon became known as "the hanging prosecutors," by the underworld of Chicago, because of their success in obtaining convictions. During Brother Byrne's five year tenure as a States Attorney, he has secured twenty-two death verdicts in murder cases, an all time record for the criminal courts of Cook County, being three more convictions than were obtained by O'Brien and Prystalski, homicide aces for eight years under the former widely known successful States Attorney, Maclay Hovne.

Amongst the prosecutions and convictions in which Brother Byrne played a leading role, was that of Henry Fernekes, the notorious bank robber, nick-named the "Midget Bandit"; that of Robert Scott, killer of Joseph Maurer in the City Hall Pharmacy, whose case was given world wide notoriety; that of Eddie Jackson, called "The Immune," a notorious pickpocket who had successfully escaped the law for twenty years; that of the International Harvester robbers; that of the \$160,000 diamond robbery at the Palmer House; that of "Three Fingered Jack White," who killed a police officer of Chicago, and that of Anselmi and Scalise, notorious Sicilian Genna gangsters, whose exploits also received national publicity.

A record was also set by Brother Byrne, before Judge Hosea W. Wells, of the criminal court, by securing fifty consecutive convictions for robbery with a gun, during the period January 1925 to July 1925.

Brother Byrne has now prosecuted that which he says is his last criminal case, returning to private practice in December to be associated with the firm of Reeda and Peace, in the general practice of law at 35 East Wacker Drive, Chicago, Illinois.

And strange as it may seem, his last prosecution was featured by his dramatic appeal to the jury to return of verdict of not guilty. There wasn't a dry eye in the over-crowded courtroom after the appeal of Brother Byrne, it is reported; even two husky policemen who had testified that they arrested the accused the night that he came home intoxicated and fired the shot that killed his own son, were seen to wipe away tears. "When I came to the State's Attorney's office five and a half years ago, I wondered if I could ever prosecute anybody," Mr. Byrne said. "The job of prosecutor has not been an easy one. Regardless of tears of wives and mothers, we have been called upon to demand justice on behalf of the State. But justice is all that the State seeks; our job in seeking justice is to present evidence to you, gentlemen of the jury; it is not our duty where evidence does not warrant a verdict of guilty to demand that punishment be meted out. The evidence here shows that the accused's son took the shotgun from the wall, saying 'I'd rather be dead than see my father a drunkard.' Falk tried to take the gun from his boy and in some manner it was discharged. The father tried to reload the gun to shoot himself after realizing what he had done, but he did not even know how to load or fire it. The evidence shows that the father and son were pals. This is probably the last case in which we shall appear as prosecutors and we cannot ask for punishment for Falk." The accused was found notguilty by the jury.

Phi Alpha Delta will hear more of its eminent brother in days to come.

The first impression made upon a pledge is a lasting one and too much work cannot be expended in preparation for his entrance within the portals of Phi Alpha Delta. If the brothers conducting the initiation are careless and slovenly in their preparation and presentation of the Ritual, the new member will fail to realize the importance of the step he is taking and will not grasp the beauty and deep-seated meanings intended to be conveyed by the authors of the Ritual and the spirit afterwards shown by him will no doubt reflect the attitude of those who have conducted him into the secrets of our fraternity.

Much time and labor was spent to prepare the Ritual in such a way as to properly convey to the neophyte the ideals and purposes of Phi Alpha Delta and the officers of the Active Chapters were entrusted with the duty and privilege of so exemplifying the Ritual that none of its fine purposes be lost.

Let me therefore urge you who are responsible for your chapter's present, and in a large measure future, success to make elaborate and careful preparation for your next initiation. Appoint those who are to assume the various parts now and insist that each part be memorized perfectly. Hold frequent rehearsals and become familiar with the meanings and purposes of each line.

You will need some equipment. See that it is prepared and on hand before the time set for your ceremonies. The Marshal can now supply you with a standard branding iron, which seems to be the most difficult article to procure. Write to him and order one if your chapter does not have one.

I also urge that you advise me of the time and place of your next initiation ceremony. Perhaps one of the Supreme Officers may be able to make a visit to your chapter.

#### Putting Over That Meeting

The often profound and complicated problem indicated by those few words is one which is more likely to harass chairman of entertainment committees of Alumni Chapters than any one else. The active chapters have their regular meeting nights and the "problem of getting out the votes" is not often a serious one. In the Alumni Chapters, however, it is often a very real and difficult one, and since no P. A. D. knows when he may be made Chairman of an entertainment committee, or some similar body, the matter is one of interest to us all. Of course the usefulness and effectiveness of an Alumni Chapter is not only to be found in meetings. banquets, outings, or the like. It can function as a supremely useful body to its members in a great many ways which do not entail such meetings. At the same time, however, they are a very important and by no means to be neglected feature of Alumni Chapter activities. One of the most important functions of an Alumni Chapter is to get the P. A. D's. in a given locality together and not merely make them acquainted with each other, but to bring them on terms of real friendship and intimacy. To accomplish this end a formal meeting will not be effective, and this is a fact which P. A. D.'s at large thoroughly realize. The average practising lawyer, especially in large cities, has many demands upon his spare time. There are numberless organizations to some of which he must inevitably belong and it is a fact which those in charge of the destinies of Alumni Chapters must realize and face, that members will not come out to meetings merely because a meeting happens to be called. The pressure of other activities is too great, and to put it bluntly a P. A. D. meeting must be sold to the members just as any other meeting is sold by any other organization.

One phase of this problem has to do with the object with which the meeting is to concern itself when it is called. It is not the purpose of this article to deal with that phase of the matter. The entertainment committee will of course decide upon a number fo meetings with a serious object, and a number of other meetings designed for relaxation and amusement. Of course the meeting will not be a success unless the agenda at them is adequately planned and put over. It is, however, equally true that they will not be a success unless the Brothers attend them and it is upon the gentle art of wheedling the P. A. D. into the meeting that this article will enlarge.

From time to time the writer has received a number of notices for various meetings in different parts of the country and the thought has occurred that it would be both instructive and of use to others if some of these were offered as possible guides for future use. The summer just having passed of course the meetings then held were out-of-doors meetings for entertainment only. These meetings are often run in the face of considerable opposition of a variety of kinds. Brothers may be planning on vacations, they may have regular golf dates, or similar matters, and therefore the first step in advertising a meeting would be some form of an advanced notice which will reach all the membership and give it a first warning. This is often done by means of postal cards, but some chapters run a small magazine or news letter and this can be very effectively utilized. The Chicago Alumni Chapter for instances blocked out on the front page of the "Dictum" the following advance notice:

#### ANNOUNCEMENT

Meet me at the ANNUAL JULY OUTING Saturday and Sunday, July 21 and 22 Oak Hills Country Club, 131st St. and 76th Ave.

Don't Miss It

There is something noteworthy about this very short announcement, namely, the suggestion of informality and general get-together spirit which it displays. It gives a definite date and a definite place, both important matters even in the earliest advance notices. It is short enough to catch the eye and impress the mind.

The advance notices must of course be followed up and this can generally best be accomplished by sending a detailed notice through the mail to each of the Brothers. This notice is probably the one which will sell the proposition if it is going to be sold. Follow-up postal cards thereafter serve\_to remind the forgetful and possibly win over a few of the wavering, but the first broadside which reaches the member is the one which is most likely to sell him.

To pick another example, this time from the Alumni Chapter of Los Angeles, the following notice is set forth verbatim:

EL CABALLERO COUNTRY CLUB ALL DAY SATURDAY, JUNE 9th, 1928. Brother Bob Dexter has secured for us the Club and Golf Course and the SUCCESS of this venture now SHIFTS TO YOU.

Brother Jay Jacobs has arranged a mean golf tournament, but it is NECESSARY that you tee off by 11:30.

Dust off your glasses and cast your lamps at this.

#### THE ORIGINAL

THE NATIONAL SEVENTY-SEVEN YEAR OLD KING OF MEXICAN BARBECUE EXPERTS will serve you THE REAL BARBECUED DINNER. We are just PLAIN LUCKY to have him with us June 9th.

The only comment necessary on such a notice as this is that it immediately impresses the reader with the fact that a good time has been planned and that all he has to do is turn up and enjoy it. It is unquestionably true that you do not get a man out to a meeting with any degree of ease or confidence if he has a dubious frame of mind as to the sort of time he is going to have. A notice which lets him see that the details are well planned and taken care of and that a specific entertainment of an adequate kind has been provided, is the kind of notice that sells him. This particular notice in question does that particular thing. Other entertainment committees during the summer might have planned just the same events for a day's outing, but might not have received as good a response unless they were as temptingly set out as in the example which we are now considering.

Leaving for a moment summer outings it is next in order to consider the more serious type of meeting which takes place during the winter months and in halls and meeting rooms. Of course the same general comments apply to these also, but some of them need to be more particularly stressed. It may be stated as a general proposition that an organization undertaking to run a number of meetings during the winter will meet with the best success if a regular schedule of dates and events can be sent out in advance. This enables the members of chapters to make plans to be present on the dates indicated, and also begins to sell them the idea of being there through the interest of the programs offered. At the

same time it is not always possible for an entertainment committee to know in advance what speaker or what other form of entertainment will be available on distant dates. The next example offered from the Washington Alumni Chapter indicates a way in which this difficulty can be effectively overcome. The Washington Alumni Chapter, during last year, held a number of highly successful meetings at which recognized experts of national standing spoke to the Chapter on important phases of the law. These meetings having met with success it was decided to continue them and early in the season the following letter was sent to each of the members:

"Dear Brother:

Here is something special! Because of the success of last season's educational meetings we are giving you advance notice of this season's program.

The executive committee acting with Brother Justice Aitchison has fixed the schedule for this fall and winter.

If you attended the meetings last spring we know you will mark the following Thursdays in *red ink* on your calendar: October 18th, November 8th, and December 6th, 1928, and January 17th and February 21st, 1929.

Will you make a resolution to be at the University Club, 15th and H Streets, N. W., on all the dates given above? Let's make it 100 per cent!

Special notice will be sent prior to each meeting giving the name of the speaker and his subject; but a mark on your calendar now may insure you against the disappointment of a previous engagement.

It is noteworthy that this letter stimulates the members interest by recalling to him the successful meetings of the previous year and then gives him definite dates on which similar meetings will be conducted during the coming winter. The mind of the member of the Chapter in Washington, after the receipt of this letter, is favorably influenced to receive the next notice which will advise him of the definite subject to be discussed at the first meeting. This next notice, in the particular instance under consideration, was as follows:

Dear Brother:

Supplementing the general notice sent you on September 15, your alumni chapter now reminds you of the first meeting for this fall to be held at 8 o'clock P. M. on Thursday, October 18, 1928 at the University Club, 15th and H. Streets, N. W.

Continuing last year's policy of having interesting and in-

structive programs, your executive committee has secured Judge Frank K. Nebecker, former Assistant U. S. Attorney General, as the speaker for next Thursday.

Judge Nebecker will discuss the prosecution, under the Espionage Act, of 150 I. W. W.'s which he conducted at Chicago.

The members of both active chapters are invited to be with us in our first get-together of this fall.

A nominal charge of 50 cents will be collected to cover the cost of refreshments to be served after Judge Nebecker's address.

It is to be noted that in this letter the speaker and his subject are both announced. This announcement is in a general way, but gives a degree of particularity which would enable any member so inclined to look the matter up in advance if he desired to get the fullest possible benefit from the discussion at the meeting. This is a small matter, which, however, often produces considerable results. It encourages the members to become acquainted and therefore presumably interested in the subject matter of the discussion before they go to the meeting, and of course it is axiomatic that a meeting which is interested in the subject in advance will be more successful than the meeting which has to be interested in the subject at the meeting itself.

The above given examples might be multiplied considerably were space available. The ones chosen were picked for one reason —because they represented chapters widely separated in distance and illustrated ways of handling the same problem by chapters remote from each other. In conclusion it may be said that the business of putting over a meeting, as has here been considered, is only a case of applied psychology. The examples above given are not susceptible of universal application, nor indeed would any examples be. Their real value lies in disclosing the approach made to the problem and they and this article are offered as a suggestion which the individual chapter can use mutatis mutandis for its own needs.

#### NEW YORK

While it is a fact that the Alumni Chapter has not heretofore been very regular in forwarding letters for publication in the Quarterly, nevertheless, the Chapter has been undergoing a process of reorganization which bids fair to continue regular letters in the future.

The Alumni Chapter of New York was organized on March 28, 1911, by alumni from various chapters, who had located in or about New York City. The charter was signed by John

Doyle Carmody as Supreme Justice and Edward J. Hess as Supreme Recorder, and meetings have been held with more or less regularity from the date of the inception of the Chapter. The number of alumni who located in New York City and vicinity from time to time has rapidly increased during the past few years, and as a result of this large increase in members from the various states in the Union, it was concluded that the Alumni Chapter should be organized on more substantial lines to meet its national character. Accordingly, the Alumni Chapter was incorporated under the Laws of the State of New York as a membership corporation on June 7, 1928.

The purposes of the corporation, as stated in the Certificate of Incorporation, are as follows:

"The purposes for which said corporation is to be formed, are to promote the friendly association, health, comfort and recreation of all alumni of Phi Alpha Delta Law Fraternity, who may become its members; to continue the association between the alumni and the active chapters of the Fraternity; to further the influence and interest of Phi Alpha Delta Law Fraternity throughout the universities and colleges, and to stimulate the interest in and devotion of its members to the ideals of said Fraternity; to further at all times the best interests and general welfare of the legal profession and its members both in the city of New York and elsewhere; to maintain and promote the highest standards of professional among the members of the bar in the City of New York and throughout the United States; and, in the discretion of its Directors, to assist and actively cooperate with the New York Bar Association, the New York County Lawyers Association; and other organizations of like nature in accomplishing any worthy governmental reform in the United States, or in bringing about any improvement in our present system of jurisprudence; and for the aforesaid purposes, to purchase, lease

or otherwise acquire, hold and own, and to mortgage, convey, sell, lease or otherwise dispose of real or personal property of every class and description."

The incorporation of the Alumni Chapter of New York has been received enthusiastically.

Our records show that there are more than 200 members of the Fraternity from various chapters located in and about New York City, and it is confidently believed that a very large proportion of this number will shortly have joined this Chapter. The subscription rate for the time being is only \$10, for which a membership share of the Corporation is delivered. The annual dues commencing July 1, 1929, are to be \$10 a year. Of the amount so paid for dues, it is proposed to deposit one-half in a sinking fund for the purpose of accumulating funds for future needs and conservative expansion of the Chapter.

Arrangements have been made to provide facilities at the Fraternity Club, 38th street and Madison Avenue, New York City, for not only our local members but for all members of the Fraternity who may from time to time visit New York City. The Fraternity Club maintains one of the best club buildings in the United States and we may well feel fortunate in making such a desirable contact for our Alumni Chapter. Identification card required in order to use the Fraternity Club facilities, (such as the dining room, lounge rooms, board and lodging, etc.) may be obtained from the Clerk of the Alumni Chapter.


