

On September 28, 29 and 30, the Supreme Executive Board held its annual meeting at the beautiful home of Supreme Justice William S. Culbertson. His home, pictured here, is known as "Charmain Manor." It is located at Charmain, Franklin County Pennsylvania.

Meeting of the Supreme Executive Board

THE meeting of the Supreme Executive Board of the Phi Alpha Delta Law Fraternity was called to order by Supreme Justice Culbertson at his country home at Charmain, Pa., on September 28th, 1935.

There were present when the meeting opened, Supreme Justice Culbertson, Supreme Vice-Justice Green and Supreme Secretary Ludwick.

Supreme Alumni Advisor Rutledge arrived on the morning of September 29th.

The Supreme Justice announced that he had received a communication from Supreme Faculty Advisor Wilson to the effect that he would be unable to attend the meeting.

The Supreme Secretary reported that he had visited eight chapters en route to the Board meeting, namely, Knox, Taney, Harlan, Green, Benson, Benton, Clark and Jefferson. He further reported that on his return trip he expected to inspect Taft, Jay, Hay, Willey, Watson, Marshall, Story, Fuller, Blackstone, Webster, Hammond, Cole, Reese, Hughes, Gunter, Sutherland, Field and Temple.

The Supreme Secretary reported to the Board on the condition of all the chapters which showed most of the chapters to be in excellent condition and that the prospects were favorable for an exceedingly satisfactory and prosperous year.

After considerable discussion, upon

motion duly made, seconded and carried it was resolved: That the annual subscription price of the Reporter be reduced from two dollars to one dollar and fifty cents per annum; that at least every two years beginning with 1936, the Fraternity publish a chapter manual edition which would include a business exchange directory in geographical ar-

rangement; that a charge of one dollar per year be made for such listing; that listings be limited to members who are subscribers to the magazine and professional listings; that such listing indicate any special form of practice in which the member is engaged; that if the member is holding public office the nature of such office be stated; that if the member is not engaged in the practice of law that the nature and location of his business be stated. Resolved further, that for the remainder of 1935 and for the year 1936 alumni dues and alumni charter fees be suspended; that the duty of soliciting subscriptions for the magazine and professional listings be delegated to the District Justices and the Justices of Alumni Chapters.

The purpose of the resolution was to insure the absolute accuracy of the Directory, a reduction in the expense of publishing it and, insofar as possible, to limit the exchange of business to members who are most interested in and contributing to the support of the Fraternity.

The Supreme Secretary was instructed to prepare a combination subscription blank and questionnaire for the use of the District and Alumni Chapter Justices in securing subscriptions and the data necessary for the Directory.

Upon motion duly made, seconded and carried, the Supreme Secretary was instructed to prepare and submit to the Chapters as provided in Section I, Article XII of the By-Laws amendments to Chapters IV and X of the By-Laws which would

- a. eliminate compulsory life subscriptions to the official magazine, provided, however, that the individual chapters should have the right, at their option, to require members upon their initiation to take out a life subscription to the magazine at a price of nine dollars payable at the time of their intiation.
- b. entitle all members of chapters in good standing with the Supreme Chapter to receive the magazine during their attendance at law school.
- c. provide that in the event installments had already been paid on life subscriptions that the members would have the option of completing the payments on such life subscriptions on or before January 1st, 1937 or receiving a credit for the amount already paid on annual subscriptions and professional listings after graduation or after leaving law school.
- d. reduce the annual per capita tax from eight to five dollars.

The Supreme Secretary was instructed to prepare and forward with such proposed amendments a complete statement of the arguments in favor of and opposing the adoption of such amendments.

Upon motion duly made, seconded and carried, it was resolved that here-

after the Supreme Secretary and Editor discontinue the publication in the magazine of legal and quasi legal articles and that all available space be used for the publication of news of the chapters and of alumni and information of a fraternal nature.

Upon motion duly made, seconded and carried, it was resolved, that Phi Alpha Delta affiliate with the Inter Professional Fraternity Conference and become active in the work of the Conference. It was further resolved that the Inter Professional Fraternity Conference be urged to present a protest to the Inter Fraternity Conference against the interference or participation of social fraternities in the rushing and pledging activities of Professional Fraternities.

Upon motion duly made, seconded and carried, it was resolved; that the date of the next biennial convention be set for December 29th, 30th and 31st, 1936 and that the convention be held at Washington, D. C.

Upon motion duly made, seconded and carried, it was recommended that the Supreme Justice appoint Brother Richard Gardner of Jacksonville, Florida, as Deputy District Justice and that he be requested to devote particular attention to the rehabilitation of Keener Chapter at Emery University and to the establishment of new chapters at the University of Georgia and Duke University.

Upon motion duly made, seconded and carried, the action of the Supreme Executive Board in approving by mail applications for permission to initiate honorary members was ratified and approved.

Upon motion duly made, seconded and carried, the Board approved expenditures of funds under vouchers numbered 1857 to 2103 inclusive.

Upon motion duly made, seconded and carried, it was resolved that the Supreme Alumni Advisor be instructed to continue his efforts to organize additional alumni chapters and state associations: that he institute a campaign to induce alumni chapters to participate more actively and as a unit in the activities of local and state bar associations for the purpose of advocating and bringing about needed improvements in local conditions affecting the legal profession and for the purpose of promoting constructive programs which may from time to time be approved by the Supreme Executive Board as proper subjects for the endorsement of Phi Alpha Delta as beneficial to our profession and our commonwealth.

Further resolved; that the Supreme Alumni Advisor be instructed to have all alumni chapters and associations carry forward through their chapters and through their local bar associations the program endorsed by the Supreme Executive Board looking toward the improvement of the manner in which newspapers report important and notorious trials to the end that they will be reported in such a manner as to command the respect and admiration of the public for the courts and the bar. That he further urge such chapters and associations to oppose any untruthful slurs upon the legal profession or its members and to cause im-

proper actions of any publicity seeking jurists to be criticized by local bar associations when possible.

Upon motion duly made, seconded and carried, the Supreme Secretary was instructed to use the first money received from subscriptions and geographic listings in the directory for the purpose of sending out an annual news letter to every member of the fraternity, such letter to contain fraternity news of outstanding importance, announcement of National Phi Alpha Delta Night and such other material as he may deem proper. He was further instructed to enclose in this letter subscription blanks and questionnaire for the Reporter and Directory.

Upon motion duly made, seconded and carried, the Supreme Secretary was instructed to urge each chapter to send out at least one news letter per year to their alumni and the Supreme Alumni Advisor was instructed to urge all alumni chapters to issue monthly bulletins to their members.

Upon motion duly made, seconded and carried, the date of the next National Phi Alpha Delta Night was fixed for February 8th, 1936, and the following National Phi Alpha Delta Night for December 29th, 1936. The Supreme Marshal was instructed to proceed with the necessary arrangements for the holding of these celebrations and is further instructed to arrange for a national broadcast of the Convention banquet program on December 29th, 1936.

The report of the Chairman of the Board of Trustees of the Endowment Fund was received and approved. The Supreme Secretary was instructed to advise the Chairman of the Board that while the members of the Supreme Board felt that probably his suggestion regarding the purchase of a limited amount of high grade common stocks might be good business judgment, that nevertheless on account of the nature of the trust fund, such a procedure tending to be of a speculative nature, should not be recommended.

The Supreme Secretary was instructed to, as rapidly as possible, pay into the endowment fund the amount currently owed to it, leaving the old indebtedness to be liquidated by subsequent appropriations for that purpose.

The Supreme Secretary was instructed to accept the proposition of Brother Carey for the liquidation of the Taft Chapter loan and to advise the Chairman of the Board of Trustees the terms of the settlement and of the Supreme Executive Board's approval.

The Supreme Secretary was instructed to arrange for the early inspection by National or District officers of all chapters which he is unable to reach on his inspection trip.

The financial report of the Supreme Secretary was received and approved.

Upon motion duly made, seconded and carried, the Supreme Secretary was instructed to enforce strictly the provisions of the Supreme Chapter By-Laws requiring the certification for expulsion all members ninety days delinquent in their chapter obligations or who have left school owing the chapter money. He was further instructed

to certify to the Supreme Executive Board for suspension any chapter failing to comply with these provisions of the By-Laws.

Upon motion duly made, seconded and carried, the Supreme Executive Board expressed the sincere appreciation of the members for the delightful hospitality of the Supreme Justice and his charming wife in entertaining them during the sessions of the Board meeting.

In addition to the formal meetings of the Supreme Board reported above, long, informal discussions for the good of Phi Alpha Delta were held by the members before a roaring log fire in the beautiful country home of the Supreme Justice high up on the top of the mountain. More delightful surroundings for the holding of a Supreme Board meeting could not be imagined. All of the members present expressed considerable gratification over the improvement in fraternity conditions generally and Phi Alpha Delta particularly.

The meeting was declared adjourned at 5 p.m. on Sunday, September 29th, 1935, the members motoring down to Washington, D. C., to attend a joint smoker of Washington Alumni, Jay and Taft Chapters.


Twenty-Five Years Ago

WENTY-FIVE YEARS AGO. our Eleventh Annual Convention was held at Chicago, Illinois, in the College Room of the La Salle Hotel, on July 8th, and 9th. 1910. Twentythree Chapters were represented, and it was one of the hardest working Conventions of the Fraternity that it has ever been the privilege of the writer to attend.

The delegates were

received on the morning of Friday, July 8th, and the first session of the Convention was called to order by Supreme Justice Samuel H. Roberts. The evening was devoted to a "hike to Riverview," at which place excellent spirits were engendered. At the conclusion of the final session on Saturday, July 10th, dinner was served at the University Club. Brother Harry P. Dolan (now deceased) a Judge of the Municipal Court of Chicago, acted as Toastmaster. Among the speakers were Adelor Pettit. a Judge of the Circuit Court of Cook County, an honorary member of Webster Chapter; Samuel H. Roberts, retiring Supreme Justice; John Doyle Carmody, Supreme Justice elect; Harry R. Saltmarsh of Williams Chapter, representing Phi Alpha Delta in the · West; Lawrence W. Ledvina (now deceased) of Ryan Chapter: J. F. T. O'Connor (present Comptroller of the Currency) of Calhoun Chapter, repre-



senting the Order in the East.

An account of the affair states that "Music, singing and night vaudeville, as well as a certain rare old product, added to the sparkle of the evening's entertainment, but the critical eve could discern no one present who it seemed would have a rough voyage to quarters, all of which is added to dispel any inference to the

contrary."

THE REPORT OF THE SUPREME SECRETARY and Treasurer indicated total receipts for the preceding year of \$2233.43, and disbursements of \$1555.92, a balance of \$677.51, to which was added \$105.00 turned over during the Convention, making a total of cash on hand of \$782.51. These figures are interesting when compared to the receipts and disbursements of the national organization 25 years later.

Many weighty matters were taken up and considered at this Convention, such as revision of the ritual, subscription to the national organization, and other matters involving amendments to the Constitution, formation of Alumni Chapters, procedure for expulsion of members, form of credentials to national conventions, publication of a national directory for the organization, initiating of honorary members and official songs.

The election resulted as follows:

Supreme Justice, John Doyle Carmody, Washington, D. C.; Vice Supreme Justice, Edward J. Fleming, Kansas City, Mo.; Second Supreme Vice-Justice, J. F. T. O'Connor, New Haven, Conn.: Supreme Recorder, Edward J. Hess, Chicago, Ill.; Supreme Treasurer, Frank G. Adams, Bloomington, Ill.; Supreme Financial Secretary, James McKeag, Chicago, Ill.; Editor in Chief, Oscar W. Hoberg, Peru, Ill.; Supreme Historian, Paul C. Meier, Chicago, Ill.; Supreme Marshal, Paul D. Higbee, Kirksville, Mo.; Board of Tribunes: Frank E. Rutledge, New York; Henry R. Saltmarsh, Portland, Oregon, and Harry Risinger, Eaton, Ohio.

AN UNUSUALLY LARGE NUMBER of former Supreme Officers and older alumni were present at this Convention, including several men whose early activities would almost entitle them to be known as founders, such as Charles L. Daly, Lawrence W. Ledvina, William P. J. Halley, Harry P. Dolan, Sidney B. Meyer, David W. Taylor, William G. Bopp, Frank E. Rutledge, Edward McConaughy, Edgar A. Jonas, Walter Rooney, Thomas J. Kindsog, William Prentiss, Jr., Arthur B. Koontz, Samuel H. Roberts, W. Howard Demarest, George M. Weichelt, Frank T. Jordan.

The following named constituted the Committee on Arrangements: Thomas Kindskog, chairman; Harry F. Hamlin, Walter Rooney, George E. Fink, William P. J. Halley, Edgar A. Jonas and Edward Hess.

ON MARCH 26TH, 1910, Jefferson Chapter was installed at the University of Virginia. The installing officer was John Doyle Carmody, then Supreme Treasurer. He was assisted by 14 members of Taft Chapter. They left Washington at 2:00 P. M., and arrived at the University of Virginia at 5:30 P. M., where they were greeted by several of the prospective brothers, and

shown the hospitality for which Virginia is well known. The local group had existed for some time under the name of the Jefferson Law Club. ceremonies began at 8:00 P.M., and lasted until midnight. The new Chapter started out with twelve members. The new officers were headed by George R. Greis as Justice, who later as a delegate from Jefferson Chapter, took a very active part at the Eleventh Annual Convention above mentioned. He acted as toastmaster at the installation banquet. The following day the men from Taft Chapter were taken on a trip to Monticello, the home of Thomas Jefferson, just outside of Charlottesville.

The Chapter started off with a fine list of Honorary Members: Honorable William Hodges Mann, Governor of Virginia; Honorable Samuel W. Williams, Attorney General of Virginia; Honorable Andrew J. Montague, Ex-Governor of Virginia; Senator Thomas S. Martin of Virginia, and Professor Lloyd M. Robinette, of the Faculty.

Thomas Lindskog of Chicago went down to assist in the ceremonies, and on his return to Chicago reported that he had had a wonderful time and predicted a wonderful future for Jefferson Chapter.

ON SEPTEMBER 28TH, 1910, the adumni members of the Fraternity living in and about New York City organized the Phi Alpha Delta Alumni Association of the City of New York City. The following officers were chosen:

President, M. B. Bernstein of Rappollo Chapter; Vice-President, Frank E. Rutledge of Webster Chapter; Secretary and Treasurer, F. I. Stokes of Rappollo Chapter.

TWENT-FIVE YEARS AGO, Brother Ode L. Rankin of Chicago, Illinois, ran for Probate Judge of Cook County, Illinois.

IN MEMORIAM Major Roland M. Hollock

First Supreme Justice of Phi Alpha Delta

■ Major Roland M. Hollock passed away on January 28, 1935, after a very brief illness.

Major Hollock was born June 25, 1874, at Harrisburg, Pennsylvania, and shortly after his birth the family went to live near Richmond, Virginia, where his father owned a large plantation. After his father's death in 1878, the mother with her family moved to McDonough County, Illinois, not far from the town of Colchester, where she purchased a farm.

Major Hollock received his education in the country and town high schools, the Normal School at Macomb, Illinois, and Northwestern University. He taught school for several years and became principal of a high school in Adams County, Illinois. While teaching school he entered upon the study of law in the office of Attorney Lawrence Y. Sherman of Macomb, Illinois, who afterwards became United States Senator.

In 1899 Major Hollock went to Chicago to study law and after having finished his course at Northwestern University, engaged in the practice of law in Chicago and continued therein until the early part of the year 1917, when he devoted his entire time and services to the training of men subject to service in the Army.

Major Hollock entered the service as a captain in the Army Service Corps in 1819 and the following year was appointed a Major, Judge Advocate, United States Army, In 1920 he was commissioned in the Regular Army as Major, Judge Advocate General's Department, in which department he served until May 31, 1932, when he was re-

tired from active service on account of disability in line of duty.

After his retirement, Major Hollock took up his residence at Alexandria, Virginia, where he was living at the time of his death.



Major Hollock served as Assistant Judge Advocate, Panama Canal Department, and Judge Advocate, Panama Canal Division, while stationed at Fort Amador, Canal Zone; and during his tour of duty in China he served as Staff Judge Advocate, American Barracks, Tientsin, China.

The remainder of Major Hollock's service in the Army was performed in the United States and included duty at Camp Upton, New York; in the office of the Judge Advocate General, Washington, D. C.; at Fort Sheridan, Illinois; at Headquarters, Sixth Corps Area, Chicago, Illinois; and as Judge Advocate, Fort Benning, Georgia.

Major Hollock was prominently identified with the Masonic fraternity, being Past Grand Commander of the Grand

Commandery of Knights Templars of Illinois. He was a member of Fort Benning Lodge No. 579, F. & A. M., Fort Benning, Georgia; a charter member of Loyal Charter No. 233, R. A. M., Chicago, Illinois; honorary member of Old Dominion Commandery No. 11, Alexandria, Virginia; and life member of the National Sojourners, Panama Chapter. He was also a member of Lincoln Park Commandery No. 64, Chicago, Illinois; Humboldt Park Council No. 113, R. & S. M., Chicago; Oriental Consistory, A. A. S. R., Valley of Chicago; and Medinah Temple, A. A. O. N. M. S., Chicago.

Major Hollock was also a member

of the Red Cross of Constantine, St. Polycarp Conclave No. 69, of Virginia. He was a member of the Army and Navy Club of Washington, D. C. He was one of the organizers of the Phi Alpha Delta Law Fraternity and was chosen its first Supreme Justice.

Major Hollock is survived by his wife, Mrs. Lillian A. Hollock; a sister, Mrs. Thomas Applegate of Macomb, Illinois; and a brother, Mr. C. J. Hol-

lock, of Golden, Illinois.

Interment was in Arlington National Cemetery on January 31, 1935, with full Military honors and Masonic rites at the grave. The funeral services were conducted at the chapel at Fort Myer.

Field Chapter and as President of the Boalt Hall Law Association.


CLAY

A native of Bedford County, Pennsylvania, and of a family of colonial and revolutionary standing, Brother Smith attended school in his home community. Later he taught school in Pennsylvania. He then went to Wash-

ington, studied to enter West Point, received his appointment, and then gave up his military career to be married.

I didn't believe it was in until I got to the green—and there was the hope of every golfer—my ball was in and the score card went Hole No. 4—1."

JOSEPH WARREN MADDEN (Marshall) is well qualified for his important post as head of the National Labor Relation Board.

When he received his appointment, Brother Madden was a lawyer in Pittsburgh and a professor at the University of Pittsburgh Law School.

He is the author of several home tomes on law. Last year, as chairman of an arbitration board, he helped avert a possible trolley car strike in Pittsburgh. He has been chairman of the Hill District Community Council and a member of the Board of the Federation of Social Agencies.

Born in Damascus, Ill., January 17, 1890, he graduated from high school at Freeport, Ill., and attended Northern Illinois State Normal School for two years. In 1911 he took his bachelor's degree at the University of Illinois.

Two years later while still a student, he married Margaret Bell Liddell, of McAlester, Okla. He completed advanced studies at the University of Chicago and in 1914-16 was professor of law at the University of Oklahoma.

For two years he practiced law at Rockford and from 1917 to 1921 was professor of law at Ohio State University. He went to West Virginia University in 1921, where he was dean of the college of law until 1927, and also practiced law there.

For a time he was special assistant to the United States Attorney General and was visiting professor of law at Cornell and Stanford. Pittsburgh was his next destination. Since 1927 he has been professor at Pitt.

BROTHER THOMAS F. McDonald, whose leadership in the fight to purge the legal profession of unethical practice has earned him a nomination for the annual St. Louis award, was elected president of the St. Louis Bar Association at the annual meeting at Hotel Chase last May.

As chairman of the association's grievance committee for the last three years, Brother McDonald has instituted twenty-two suits for disbarment. Of the seventeen tried, thirteen have resulted in disbarments and four in suspensions.

Former Governor Caulfield who nominated him declared:

"In his work as a member of the grievance committee and as a member of the State Board of Law Examiners, he has contributed to the highest standards and best traditions of the legal profession. He will be a symbol of the finest things for which the association stands."

An editorial in the St. Louis-Post Dispatch said:

"It is highly doubtful if in the 61 years in which it has been in existence, the St. Louis Bar Association has chosen as its president a lawyer more deserving of that post than Thomas F. McDonald, the new leader. To Mr. McDonald, membership in the bar association has been an obligation and a responsibility. Because it has, recent years have seen much fine work in the purification of the legal profession in this city.

"When Mr. McDonald became chairman of the Grievance Committee three years ago, the record of that body as a disciplinary agency was pitifully weak. In 10 years, but two suits had been filed against lawyers for unethical practices, and only one of these resulted in disbarment. Under Mr. McDonald, the Grievance Committee promptly became an effective instrument for public service. Since June, 1932, 22 disbarment suits have been filed, resulting in 12 permanent removals from practice and four suspensions, with six suits awaiting trial.

"Mr. McDonald has modestly given credit for this achievement to his fellow committee members, but after due allowance has been made for their help, the fact remains that he has borne the brunt of a difficult and unpleasant if highly important work. This is attested by his recent nomination for the \$1000 St. Louis Award for outstanding community service. Mr. McDonald believes fully in the supervision of the bar under the new State Supreme Court practice rules and has pledged himself, as president of the local bar, to support to the utmost that notable reform. A finer stand could not be taken." A.E.

A native of Independence, Ia., Brother McDonald received his law degree at the University of Michigan Law School in 1917. After service in the army as a major in field artillery, he entered the practice of law in St. Louis. He is now a partner in the law firm of Donnell & McDonald, with offices in the Bell Telephone Building.

Brother McDonald was a member of Campbell Chapter (17) and is now a member of the St. Louis Alumni Chapter.
