standpoint of sight-seeing Washington is unsurpassed. The new Supreme Court Building alone offers a great inspiration to members of the bar.

In addition, those visiting the convention will have an opportunity to observe the influx of officials, politicians, lobbyists and others who will be attracted by the organization of the new Congress on January 20, 1937. The value of this experience cannot be overestimated.

Mindful of it's responsibilities for the success of this convention and having a desire to contribute in a substantial measure to the continued development and advancement of Phi Alpha Delta, the Washington Alumni Chapter, with the cooperation of Taft Chapter and Jay Chapter, pledges you hospitality, entertainment, recreation and a warm fraternal welcome . . . all in such good measure as properly becomes PAD.

Throughout the convention period everything will be done by the committee, to make the visiting members' stay in Washington pleasant and worth



while. The committees in charge are expending every effort to make this convention impressive, inspiring and entertaining . . . one that will make you realize that Phi Alpha Delta is something more than a name.

RECEPTION COMMITTEE

In the organization of this committee will be presented an inno-

vation for PAD conventions. In Washington there are alumni representatives from about 35 different chapters. These will be organized into committees to assume responsibility for the comfort, welfare and entertainment of the active and the alumni members of their respective chapters from the time the visitors and delegates arrive at the station in Washington until the convention closes. For those chapters without representatives a special committee will be made up from Taft and Jay alumni and active members.

HEADQUARTERS

The Mayflower Hotel, center of the capital's social life, has been selected as convention headquarters. The magnificent ball room of the hotel has been reserved for PAD social activities. Residence at this fine hostelry for the convention period in itself will be an enjoyable experience. A substantially reduced scale of rates has been secured for visiting PAD's.

THE SMOKER

The business sessions of the conven-

tion will begin on the morning of the 29th of December. That evening, at nine o'clock, a smoker will be held at the Mayflower Hotel at which an attendance of more than 500 is expected. Refreshments, cigars and cigarettes will be served. An excellent musical program with entertainment will be provided by the Weede-Meyer Orchestra under the direction of Charlie Strong (formerly Musical Director, Olson and Johnson) featuring vocal selections by Martha Perry, Radio Star. This smoker will afford a splendid opportunity for all attending the convention to get acquainted and enjoy a real fraternal evening.

THE BANQUET

On Wednesday evening, December 30, the Mayflower Ballroom will be the gala setting for the greatest banquet in the history of our fraternity. The banquet room itself is an architectural masterpiece with its stage, galleries and attractive decorations. The banquets at the Mayflower are justly celebrated for the cuisine and service. For this occasion music and entertainment will be provided by the Weede-Meyer Orchestra. Among those present will be many brothers who have achieved national distinction in public service and in the practice of their profession. Attorney General Homer S. Cummings, Comptroller of the Currency J. F. T. O'Connor and Assistant Attorney General Brien McMahon will be present. A reception will precede the banquet.

NEW YEAR'S EVE BALL

In all Washington, there can be no comparison with the Mayflower Ballroom as the "perfect spot" for a New Year's Eve celebration. This ball will be the closing social event of the convention. Upon request in advance of the convention, the committee will invite ladies to be guests of visiting brothers who come to the convention unaccompanied. There will be tables where all may be seated surrounding the spacious dance floor. A delicious supper will be served. Dance music will be furnished by the Weede-Meyer Orchestra.

SIGHTSEEING

The business sessions of the convention have been arranged so as to allow ample time for sightseeing. Washington holds a great diversity of interesting sights particularly to the American attorney. Each day that you spend in the national capital will be packed full of pleasant contacts, interesting sights and educational experiences. The new Congress convenes on January 3rd and most of its members will be in Washington before our convention closes. The entire alumni and active groups of the Washington chapters will be available to act as your guides. Plenty of private automobiles will be on hand to transport you around the most beautiful city in the United States, if not in the world.

There shall be a special LADIES' committee which will see that the wives and sweethearts of the visiting brothers enjoy their visit to Washington and come in for a fair share of the convention activities.

OUR POLITICAL MIRROR

As usual, many members of the fraternity were active in the recent political campaigns. A number of them were elected to public office in the general election which was held on the third of November. Others were defeated by the Democratic landslide.

WILLIAM E. BORAH (Kent), of Boise, Idaho, was reelected as United States Senator on the Republican ticket. He received more than 126,000 votes. This is the largest number of votes that he has ever polled. He was opposed by Governor C. Ben Ross, a Democrat, who had never been defeated for public office. Brother Borah is one of the ablest members of the United States Senate. He commenced his present service on March 4, 1907, and is Dean of the Senate.

Andrew J. Montague (Jefferson), of Richmond, Virginia, was reelected as Representative in Congress from the 3rd Congressional District. He is the ranking member of the Committee on the Judiciary, is a Democrat and is serving his twelfth term. The Seventy-fifth Congress convenes on the 3rd of January.

ALBERT E. CARTER (Temple), of Oakland, California, was reelected as Representative in Congress from the 6th Congressional District. He is a Republican and is serving his sixth term.

VIRGIL CHAPMAN (Clay), of Paris, Kentucky, was reelected as Representative in Congress from the 6th Congressional District. He is a member of the Committee on Interstate and Foreign Commerce, is a Democrat and is serving his fifth term. He maintains his law office at Lexington.

WILLIAM P. LAMBERTSON (Marshall), of Fairview, Kansas, was reelected as Representative in Congress from the 1st Congressional District. He is a member of the important Appropriations Committee, is a Republican and is serving his fourth term.

J. Hardin Peterson (Fletcher), of Lakeland, Florida, was reelected as Representative in Congress from the 1st Congressional District. He is a member of the Committees

on Irrigation and Reclamation, Mines and Mining, and Public Lands, is a Democrat and is serving his second term.

Francis E. Walter (Taft), of Easton, Pennsylvania, was reelected as Representative in Congress from the 21st Congressional District. He is a member of the important Committee on the Judiciary, is a Democrat and is serving his second term. Brother Walter served as County Solicitor of Northampton County, 1928-33. He is a native of Easton.

C. Jasper Bell (Benton), of Kansas City, Missouri, was reelected as Representative in Congress from the 4th Congressional District. He is a member of the Committees on Elections, Insular Affairs, Public Buildings and Grounds, and Rivers and Harbors, is a Democrat and is serving his first term. Brother Bell is a former Circuit Judge.

ORVILLE ZIMMERMAN (Lawson), of Kennett, Missouri, was reelected as Representative in Congress from the 10th Congressional District. He graduated from the University of Missouri in 1911 with the degree of Bachelor of Laws, was admitted to the bar the same year and commenced the practice of law at Kennett where he has resided ever since. He is a member of the Committees on Flood Control, Invalid Pensions, Irrigation and Reclamation and Roads, is a Democrat and is serving his first term.

Scott W. Lucas (Capen), of Havana, Illinois, was reelected as Representative in Congress from the 20th Congressional District. He is a member of the Committee on Agriculture, Elections No. 2, and the special committee to investigate the American Retail Federation, is a Democrat and is serving his first term.

HARRY SAUTHOFF (Ryan), of Madison, Wisconsin, was reelected as Representative in Congress from the 2nd Congressional District. He is a member of the Committees on Insular Affairs, Pensions, and World War Veterans Legislation, is a Democrat and is serving his first term. Last summer he de-

clined an appointment as Judge of the Circuit Court for the 9th Judicial Circuit.

JOHN J. SPARKMAN (Morgan), of Huntsville, Alabama, was elected as Representative in Congress from the 8th Congressional District. He is a member of the law firm of Taylor, Richardson & Sparkman, is a Democrat and is thirty-seven years old.


JOSEPH E. HENDRICKS (Brewer), of DeLand, Florida, was elected as Representative in Congress from the 5th Congressional District. He is a Democrat and a former Justice of David J. Brewer Chapter.

Teller Ammons (Hughes), of Denver, Colorado, was elected as Governor of the State of Colorado on the Democratic ticket. He is a former State Senator and is now City Attorney of Denver. Brother Ammons will succeed Governor Ed C. Johnson, who was elected as United States Senator. He is a son of former Governor Ammons and is forty-one years old.

JOHN K. VALENTINE (Ryan), of Centerville, Iowa, was elected as Lieutenant Governor of the State of Iowa. He is a member of the State Senate and in the last session served as Democratic Floor Leader. Brother Valentine is a member of the law firm of Valentine & Valentine. He is thirty-two years old.

HARRY K. ALLEN (Benson), of Topeka, Kansas, was reelected as a Justice of the Supreme Court of the State of Kansas. He defeated Rosseau A. Burch (Benson), present Chief Justice, who has been a member of the Supreme Court since September 29, 1902. Brother Allen is the first Democrat that has been elected to the Supreme Court since the days of Populism. He has been Dean of the School of Law of Washburn College since 1922, having succeeded Albert J. Harno (Calhoun), who had been appointed as Dean of the College of Law of the University of Illinois.

CHARLES TAGENHORST, JR., (Chase), of Cincinnati, Ohio, was elected as Judge of the Court of Appeals for the First Judicial District. He is a former member of Congress, having represented the 2nd Congressional District, is a Republican and is now a member of the law firm of Tagenhorst & Lytle with offices in the Gwynne Building. LAWRENCE R. LYTLE (Chase) is the junior member of the firm.



GEORGE S. MYERS (Hay), of Cleveland, Ohio, was elected as a Judge of the Supreme Court of the State of Ohio for a six year term. He received the highest vote of any of the candidates on the judicial ticket. Brother Myers is a former member of the General Assembly, 1917-20, is a Democrat and is now serving his second term as Secretary of State. He is an able lawyer and will make an outstanding record in this important post. Brother Myers has long been active in the fraternity, having served as Acting Supreme Recorder, 1916-19, and is also a former District Justice. He will assume his duties on the Supreme Court in January and we shall follow his work with great interest.

RAYMOND C. VAUGHAN (Campbell) of Buffalo, was one of the few Republicans to be elected in the recent landslide. He will become Judge of the Supreme Court, 8th Judicial District.

Cary D. Landis (Brewer), of DeLand, Florida, was reelected at Attorney General of the State of Florida. He is a Democrat and is serving his first term. Prior to his election to this office, he was a member of the law firm of Landis, Fish & Hull of DeLand. He now resides at Tallahassee.

JOSEPH A. GRABER (Story), of Chicago, Illinois, was reelected as an Associate Judge of the Municipal Court of Chicago for a six year term. He was admitted to the bar in 1906 and was engaged in general practice until 1930. He is a Democrat and is serving his first term. Brother Graber received the highest vote of any of the 24 candidates.

JAY A. SCHILLER (Story), of Chicago, Illinois, was also reelected as an Associate Judge of the Municipal Court of Chicago. He is a former Assistant Corporation Counsel and an Assistant Attorney for the Sanitary District. He is a Democrat and is serving his first term.

J. Ollie Edmunds (Brewer), of Jacksonville, Florida, was reelected as County Judge of Duval County. He is a Democrat.

A. O. KANNER (Brewer), of Stuart, Florida, was elected as a member of the State Senate from the 33rd District. He is a Democrat and a member of the law firm of Smith & Kanner.

DAVID LANNIER (Fletcher), of Madison, Florida, was elected as a member of the House of Representatives of the State Legislature. He is a Democrat.

T. FRANKLIN WEST (Fletcher), of Milton, Florida, was elected as a member of the House of Representatives of the State Legislature on the Democratic ticket.

DAN KELLY, JR. (Fish), of Fernandina, Florida, was elected as a member of the House of Representatives of the State Legislature from Nassau County. He is a Democrat.

Franklin U. Stransky (Campbell), of Savanna, Illinois, was elected as Representative in the General Assembly from the 12th Senatorial District. He is a Republican and will retire as State's Attorney of Carroll County on the first Monday in December. The next session of the General Assembly will convene in January.

HAROLD C. SEWELL (Blackstone), of Belvidere, Illinois, was elected as State's Attorney of Boone County on the Republican ticket.

IVAN A. ELLIOTT (Capen), of Carmi, Illinois, was elected as State's Attorney of White County. He is Democratic State Central Committeman for the 24th Congressional District and is a former State Commander of the American Legion.

Samuel J. Holderman (Magruder), of Morris, Illinois, was reelected as State's Attorney of Grundy County. He is a Republican.

CLAUDE M. SWANSON (Magruder) of Paxton, Illinois, was elected as State's Attorney of Ford County on the Republican ticket. He is a former State's Attorney of this county, having served from 1920-1932. Brother Swanson defeated Sidney Dilks, who was elected in the Roosevelt landslide four years ago.



BERT FISH (Brewer), of DeLand, Florida, contributed the sum of \$10,000 to the Democratic National Campaign. He is American Minister to Egypt. His address is Cairo.

ARTHUR K. BLACK (Fletcher), of Lake City, Florida, was elected as District Attorney of Columbia County. He is a Democrat and a member of the law firm of Farnell & Black.

JAY A. SHULER (Brewer), of Apalachicola, Florida, was elected as District Attorney of Franklin County. He is a Democrat.

ROY N. McCue (Benson), of Topeka, Kansas, was reelected as Probate Judge of Shawnee County on the Republican ticket. John D. M. Hamilton (Fuller) served as Probate Judge, 1921-25.

ARTHUR W. LUECK (Ryan), of Beaver Dam, Wisconsin, Democratic candidate for Governor of the State of Wisconsin, was defeated by the incumbent, Philip F. LaFollette, a Progressive. This was the first time that Brother Lueck ever sought public office. He is the senior member of the law firm of Lueck, Skupniewitz & Lueck.

CHARLES W. HADLEY (Fuller), of Wheaton, Illinois, Republican candidate for Attorney of the State of Illinois, was defeated by the incumbent, Otto Kerner, a Democrat.

JOHN T. DEMPSEY (Fuller), of Chicago, Illinois, Republican candidate for Representative in Congress from the State at Large, was defeated.

EDGAR A. JONAS (Webster), JOHN H. LYLE (Webster), WILLIAM E. HELANDER (Fuller) and EMMET F. BYRNE (Story), of Chicago, Illinois, Republican candidates for Associate

Judges of the Municipal Court of Chicago, were defeated. Brother Jonas and Brother Lyle are sitting Judges and have served on the Municipal Court for many years. Brother Helander is a former Associate Judge.

FRANK G. THOMPSON (Magruder), of Mt. Vernon, Illinois, Republican candidate for State Senator from the 46th Senatorial District, was defeated by the incumbent, H. S. Burgess of Fairfield, a Democrat.

JESSE R. WILLIS (Capen), of Bloomington, Illinois, who was a candidate for reelection as State's Attorney of McLean County on the Republican ticket, was defeated by Bernard Wall, a Democrat. He will retire on the first Monday in December.

RICHARD W. VELDE (Magruder), of Havana, Illinois, Republican candidate for State's Attorney of Mason County, was defeated by Lyle R. Wheeler, a Democrat.

Francis J. Loughran (Story), of Joliet, Illinois, Democratic candidate for State's Attorney of Will County, was defeated by James E. Burke, a Republican.

CARL A. SWENSON (Magruder), of Rockford, Illinois, Democratic candidate for State's Attorney of Winnebago County, was defeated by the incumbent, Robert E. Nash, a Republican. Nash also defeated him four years ago.

JOHN D. M. HAMILTON (Fuller) of Topeka, Kansas, Chairman of the Republican National Committee, left Chicago by plane on November 12, 1936, for a conference with Governor Alfred M. Landon at Kansas City, Missouri. They discussed the future plans of the Republican Party. It was their first meeting since the election. Shortly after the election the campaign headquarters at Chicago were closed and the records moved to Washington. Brother Hamilton expects to establish the largest permanent headquarters in the history of the Republican Party. "There is always a place in the American political system," he said, "for a militant, vigorous minority. The duty of the Republican Party will be to see that the program of the majority is consistent with sound government, socially and economically, and that the program is carried out under the Constitution."

BROOKS HAYS (Jay), of Little Rock, Arkansas, accompanied President Franklin D. Roosevelt on his Southern trip last June. He is Democratic National Committeman for Arkansas.

HAROLD W. STULL (Jay), of Johnstown, Pennsylvania, served as Executive Assistant to the Director of the Young Republican Division of the Republican National Committee. His office was in the McCormick Building at Chicago. While he was Justice of John Jay Chapter he initiated his father, Howard W. Stull, a former member of Congress, as an honorary member. His father was a candidate for the Republican nomination again this year, but was defeated.

CHARLES E. LANE (Taft), of Cheyenne, Wyoming, was active in the recent political campaign in his state. He served as Chairman of the Naturalized Citizens Division of the Republican State Central Committee. He has given much study to the Constitution of the United States and believes that the members of the bar should do everything that is humanly possible to maintain and defend it.

Martin A. Brennan (Capen), of Bloomington, Illinois, will retire in January as Representative in Congress from the State at Large. He is a member of the Committee on Foreign Affairs, is a Democrat and is finishing his second term. Brother Brennan is a former Presiding Judge of the Court of Claims of the State of Illinois, 1913-17, and served as Representative in the General Assembly, 1921-23. He was not a candidate for reelection.

DAVID SHOLTZ (Calhoun), of Daytona Beach, Florida, will retire in January as Governor of the State of Florida. Brother Sholtz was not a candidate for reelection.

General Meade is a veteran of the Philippine Insurrection; the Cuban Pacification; the Occupation of Vera Cruz, Mexico; the World War, having served with the American, British and French forces; the Occupation of Haiti; and, the Second Nicaraguan Campaign.

While in the Republic of Haiti, as Commander of the Department of the North, General Meade, then a Major of Marines with the rank of Colonel in the Gendarmerie d'Haiti, cleared the Department of the North of bandits and personally directed the operations which resulted in the death of the supreme leader of the bandit forces, Charlemagne Peralte, which in turn resulted in the collapse of the civil war in that country, bringing peace and prosperity to Haiti. For his work in Haiti, he was twice decorated with the Haitien Medal Militaire, cited in orders for services in the field, and twice decorated for his administrative work, including the award of the Haitien Medal of Honor and Merit, with the grade of Commander, the highest Haitien decoration.

In 1927, he commanded the First Marine Corps expeditionary force to land during the Second Nicaraguan Campaign. He was awarded the Navy Cross, by the President of the United States, and the Medal of Merit by the President of Nicaragua, for his outstanding service in that country.

He was twice Officer in Charge of the Marine Corps Reserve which he reorganized in 1925; the Officer in Charge of Marine Corps Recruiting activities; has commanded Marines at Guantanamo Bay, Cuba; the Marines in the Virgin Islands; and, Marine



Detatchments aboard ships of the Navy. One of his early assignments as a captain was the command of the Marines aboard the U.S.S. Missouri. He organized and trained the first signal company of the Marine Corps which later acquitted itself with great distinction in the seizure of Vera Cruz, and later furnished trained communications personnel for service in France during the World War. He has served in Washington in the Judge Advocate General's Office of the Navy, as Chief of War Plans Division of the Marine Corps Headquarters, and as Officer in Charge of Recruiting and Reserves of the Marine Corps.

General Meade is a graduate of the Marine Corps Schools, of the Army War College, and of Georgestown University with degree of LLB 1912. He was admitted to the bar in the District of Columbia and, in 1928, was admitted to practice, before the Supreme Court of the United States.

Two incidents, partially obscured by the lapse of time, illustrate a reason for his success. In the year 1901, during the Philippine Insurrection, he jumped into the angry waters of the Rio Grande de Cagayan, swollen by cloud bursts, and saved the life of an American soldier. Again, in Guantanamo Bay, he jumped overboard at night in full dress uniform to save the life of an American sailor. For this he was commended by the Secretary of Navy. These occasions, of minor importance nationally, demonstrate his character and his disregard of personal safety when the life of another, a subordinate, is endangered.

On October 5, 1936, he was married to Helen Troesch, of Springfield, his private secretary while he was Speaker of the House, and she survives him. It is said that he left an estate which is valued at more than \$1,000,000.

The idea of a university located in the Capital of the Nation was sponsored by George Washington, who during his public life urged the establishment of such an institution and in his will left fifty shares of stock in the Potomac (Canal) Company for the endowment of a university to be established in the District of Columbia "to which the youth of fortune and talents from all parts thereof might be sent for the completion of their Education in all branches of polite literature: -- in arts and Sciences. -in acquiring knowledge in the principles of Politics and good Government."

In furtherance of that hope and project of the first President of the United States, this University, founded as Columbian College and now named George Washington University, was founded. The stock which General Washington willed toward such an institution became valueless owing to the failure of the canal properties, and it was necessary for the "College" established in the District of Columbia to obtain funds from other sources.

In 1819, the Reverend Luther Rice, a Baptist missionary, formed an association to buy land for the use of a college in the city of Washington. General Washington's idea in mind, John Quincy Adams, Secretary of State of the United States: William H. Crawford, Secretary of the Treasury; John C. Calhoun, Secretary of War; William Wirt, Attorney General; and Return J. Meigs. Postmaster General, became patrons of the new college and together with thirty-two members of Congress, contributed to a fund raised for the purchase of the land and development of the work.

The George Washington University Law School was established as part of the Columbian College program in 1826, discontinued later, reorganized in 1865, and is the oldest in the District of Columbia. In 1900 the School took part in the organization of the Association of American Law Schools and has been a member of the Association since that time. The School is approved by the Council of Legal Education of the American Bar Association. Effective this year the Law School required an A. B. degree or its equivalent for the admission to the Law School course.

John Jay Chapter is more than proud to do its share in the coming convention. May the rail-ways, highways, and air-ways speed you all to Washington for a Happy New Year.

KNOX

University of Arizona

This list completes the revival of the Watson Chapter and places it again where it properly belongs as the strongest law fraternity in the University of Pittsburgh Law School. One year ago due to the heavy graduation losses, the chapter consisted of one senior and three second year men. It was a choice of either intense activity or ceasing to exist as a Phi Alpha Delta Chapter. A rushing program was begun and fortunately the visit of Supreme Secretary Ludwick coincided with the first event of the series. With

the start he gave the chapter and the drive of Justice Dreher aided by the few actives, twelve men were pledged, and are now all actice members.

The present school year began under much more auspicious circumstances. All actives and pledges returned to school. An elaborate rushing program was planned consisting of a smoker for a selected group of first year men held in the Cardinal room of the William Penn Hotel. The second event was a moot court trial which had been in process of preparation during the entire summer, and, as a result, the opposing counsil, Petrillo and Husband, conducted one of the smoothest trials in the history of the fraternity. The closing event was a banquet for a greatly narrowed group of first year men held at the Yale, Harvard, Princeton Club. As a result of this program every prospect bid was pledged, and Watson Chapter takes pleasure in announcing that its bids have been accepted by 15 first year men.

On October 24, the night of the Pitt-Notre Dame game the chapter held a formal dance at the Yale, Harvard Princeton Club, at which Stan Chester's orchestra played. The dance was attended by some 30 actives and pledges, and came to an end acknowledged to have been the most successful social affair conducted by the chapter in recent years. In accordance with the program announced at the end of last year, the chapter has revived the inter-fraternity moot courts. The first one to held in the last six years between University of Pittsburgh Law fraternities was brought about under the auspices of the chapter. Tau Epsilon Rho furnished the opposition and the case was well argued on both sides, but evidently the Watson chapters representatives, Brothers Page and Lewis, had a slight edge for the final decision was in their favor. Further inter-fraternity arguments are planned during the remainder of the year and in addition each active will take part in at least one moot court on an intra-fraternity schedule which is now being made up.

As an integral part of its program the chapter has arranged a three point program for the assistance of the first year men. Study groups have already been organized under the auspices of the fraternity, and at the sessions one upper classman will be present to supervise the review and settle its problems. Prior to examinations, review courses will be taught by the honor men of the fraternity and an intensive lecture on methods of examination writing will be given daily a few weeks before the mid-year examinations.

Brother Schreiner achieved an average sufficient to earn him a place on the University of Pittsburgh Law Review, where he will join the chapter's two other representatives, Brothers Irwin and Kenney.

CONVENTION INFORMATION

Supreme Secretary

The 24th Biennial Convention of our Fraternity will be called to order at Washington, D. C., at 10 a. m., December 29th, 1936, and will be in session for three days.

Our By-Laws provide that the delegates and alternates shall be elected at least thirty days prior to convention; that the first delegate from an active chapter shall be a junior in

the law school (thus assuring at almost. all times the presence in the chapter of a member who has had the benefit of National Convention experience) and the second delegate must have at least six months additional college work afdelegates convention; that the elected to convention as members of the Supreme Chapter shall hold office for two years and until their successors are elected and qualified that their credentials duly certified by the Supreme Secretary shall be presented to the Convention; that the Supreme Secretary shall pay the necessary traveling and hotel expense of but one delegate from each active chapter; and that no chapter shall be entitled to have its delegates seated if it shall have failed to pay any part of its obligations to the Supreme Secretary, has failed to furnish any reports required or has failed to secure the Supreme Secretary's certification of Con-



vention credentials.

You have heretofore been furnished the necessary credential blanks. These should be prepared and forwarded to the Supreme Secretary immediately accompanied by any reports or fees now due.

Attached hereto is a chart showing the actual amount the first accredited delegate from each chapter will receive. The table worked out will

cover the expenses of delegates from the Western states to Chicago by rail, intermediate class, lower berth, to Chicago and for all delegates first class East of Chicago, upper berth where Pullman is required.

The amounts are figured to cover a meal allowance of \$1.00 per day enroute, hotel in Washington, D. C. (The Mayflower Hotel, Washington's best) at a special rate of \$3.00 per day, two delegates in a room, with twin beds and bath; meals in Washington \$2.25 per day for two days and \$1.25 per day for one day—the day on which the banquet is held.

This table will enable second and alternate delegates, as well as alumni chapter delegates, to determine what it will cost them to attend. While expenses will be paid to one delegate from each collegiate chapter, there is, of course, no objection to delegates pooling the expense money if desired. Dele-

gates must be prepared to finance themselves until the second day of convention. No delegate will be entitled to expenses unless he is in his seat on time and during all business sessions unless excused by the Supreme Justice.

Arrangements have been made for the Mayflower Hotel to cash expense checks.

A special Pullman will leave Ogden, Utah, at 8 p.m. Saturday, December 26th on The Challenger. It is hoped that delegates from Ross, Temple, Field and Sutherland Chapters will make reservations thereon. Delegates from Williams, Dunbar, Kent, Hughes and Gunter should join at Cheyenne at 8:20 a.m. Sunday, December 27th. train will arrive at Omaha at 8:05 p.m. Sunday, December 27th, at Ames, Iowa, at 12 midnight on Sunday, December 27th and in Chicago 8:42 a.m. Monday, December 28th. All delegates who can join this special should make reservations and advise this office. We should be advised immediately if delegates expect to avail themselves of this service. Pacific Coast delegates will leave Chicago on the Baltimore and Ohio at 2:50 p.m. Monday, December 28th. Western and Midwestern delegates should converge at that point if possible and other delegates should arrange, if possible, to pick up that train on its way East. The train will arrive

in Washington at 8:42 a.m. Tuesday, December 29th.

No provision is made for tips nor for the registration fee which all delegates, National officers and guests will be required to pay. This fee will be \$10.00 each for delegates, alternate delegates and guests from collegiate chapters and \$15.00 each for National and District officers and Alumni delegates and guests. It covers all of the social affairs at convention, including smoker, banquet and supper for guests and ladies at the New Year's Ball. With the splendid program planned this registration fee will leave a substantial deficit which is being assumed by our Washington hosts.

Delegates and guests who wish dates for the New Year's Ball should immediately notify the Convention Chairman Joseph A. Carey, Securities Building, Washington, D. C. Better not delay as the first requests will probably get Joe's best numbers. It will help if you indicate whether you want one tall, short, slim or fat, etc.

Consensus on Reform of Sensational Reporting

Editor's Note: The following report, taken from the Journal of the American Judicature Society, will undoubtedly be of considerable interest to our members on account of the activity of the Fraternity in sponsoring a reform of sensational reporting.

The last session before dissolution, of the Conference of Bar Association Delegates, was one of the most impressive of those held in its twenty years' existence. Chairman E. Smythe Gambrell had arranged, as the major feature of the session, addresses on the subject of improper reporting of court trials, with (former) Judge Thomas D. Thacher, Mr. Frank Hogan, and Sir Willmott Lewis as speakers, and in the order named.

Notwithstanding the interest attaching to these three addresses, this Journal is obliged to forego a complete report for the usual reason. The choice is made of giving the substance of Judge Thacher's and Mr. Hogan's addresses. * * * This is the best that can be done within our space limits. * * *

Judge Thacher set forth a constructive program. He declared that action must be taken swiftly before the reaction to the Hauptman trial has waned. This action should take the course of developing understanding of needs and resources on the part of both lawyers and newspaper men, leading before long to a conference between the representatives of bar and press, where a concensus should be reached. There should be at the same time as much education of public opinion as the self-respecting newspapers may accomplish. But this is to be, not an end, but only a foundation for bar influence directed toward judges for the purpose of stimulating their courage and sense of public responsibility.

For the key to the situation resides in the judges, individually. The speaker related at sufficient length the temptations which embroil judges, prosecutors, court and police officers, and the owners and editors of newspapers. There was no suggestion that these temptations could be exercized, at least without first an exercise of the powers undoubtedly residing in the law. But the Judge spoke with some confidence of the prospects for cooperation on the part of a large share of important newspapers.

As to the power of judges to vindicate their courts, it was declared emphatically, that the law in this country is in every way sufficient, and equal to the English law. Having first recounted numerous instances of punishment for contempt, with references to the nature of the wrongful utterances, under English administration of justice, he almost matched these with like judgments in American courts. (Unfortunately, citations were not included).

There has been no more emphatic condemnation of the Hauptman trial than that given in this address. Whether true or not, certain papers led their readers to believe that lawyers for both state and respondent, had made freely, and for effect on the public mind, most outrageous statements. One paper presented a verdict of guilty rendered by a jury picked up on the streets by its reporters.

"I think, as you think, that the publicity attendant upon trials of sensational cases reached the point in this country long, long ago, where it became a menace to the administration of justice.

"But I have no faith in our ability to correct it."

Such a gambit naturally caught the attention of Mr. Hogan's large audience. His easy manner, fluent speech and apparent candor assisted in keeping that attention throughout. Readers who have not heard this celebrated forum orator should know that he has the charm of appearance and simplicity and directness of speech which makes him one of the leading jury pleaders of the nation.

A principal reason why he could see no chance for reform was the fact (assuming it to be a fact) that one New York paper "increased its daily circulation by more than 570,000 copies" during the Hauptman trial. "That is the chief reason," he stated, "for my saying we are not justified in expecting the newspapers to voluntarily discontinue that sort of sensational publicity. It increases circulation. The Saturday Evening Post editorially expressed the thought in one line: 'It sells newspapers.'"

But the speaker's reported text does not justify Sir Willmott Lewis' reference to Mr. Hogan as an "arch pessimist." He only said that the press could not be expected to surrender its pet "voluntarily." And, continuing, he made the usual analysis.

"Where, then, do I think the vice rests, and the remedy, if there is any remedy, must be found? First, with the government, whether it be state or national. Secondly, with the bar. Thirdly, and most important of all, with the courts.

"I not only assert that the remedy lies with the courts, but I submit to you that the vicious situation which exists today is due to the lack of courage of many trial judges."

And here the speaker received hearty applause.

From this point the address was devoted to "the art of propaganda as now practiced by government." The art did not start recently, but has been used by every administration since the War, and has reached a peak in the last three years. Every department in Washington has its expert publicity agents. This is not, of course, directly in point, but soon Mr. Hogan accused the department of justice of employing an expert publicist to put out openly official "publicity relating to cases in which the government appeared on one side and citizens-your client and mine-were on the other side."

The speaker identified himself as one who defended prosecutions in the "oil lease," or Teapot Dome scandal, and later told of his defense in the litigation over the Mellon income taxes. He directly charged that the "executive assistant to the attorney general" obtained publication in the press of articles which "played up officials who are handling the case." These articles, he said, "create an atmosphere into which you have to go with your clients . . . to battle with the government."

With considerable detail the charges were pressed, involving also a member of the United States Senate, who by a radio speech, demanded indictment in the Teapot Dome affair. In conclusion the speaker urged definite action by the bar.

"And so I repeat that the courts are at fault. To meet this problem more legislation is not required. The inherent power of courts of justice, if courageously, impartially and firmly exercised by the contempt process, which does not interfere with freedom of the press and which does not set up a censorship, but which deals only with wrongs after the wrongs have been committed, is all sufficient for the purpose. If we make the judges see that they have ample power and that power must be exercised, then, but only then, will present conditions improve."
