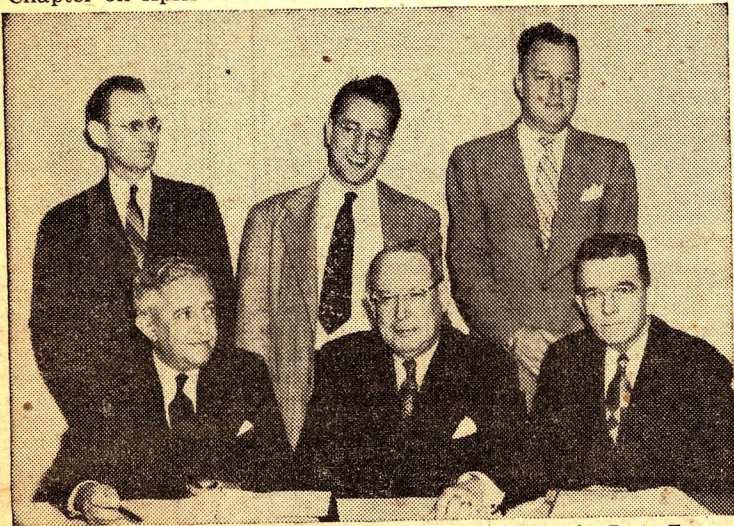

Supreme Executive Board Meets

The annual meeting of the Supreme Executive Board was held at the Atlanta Biltmore on April 22, 23 and 24. Atlanta, Georgia was selected as the place for the holding of this meeting by Supreme Justice Edmonds due to the fact that never before in the past has the Supreme Executive Board met in this locale nor had any of the National Conventions been held in this part of the South. The Supreme Executive Board extended an invitation to 13 chapters in the near vicinity of Atlanta to meet with the Supreme Chapter on April 23rd.

On Friday night preceeding the meeting of the active chapters with the Board, a reception and smoker was held at which time representatives of the three North Carolina chapters, the three chapters in Georgia, the three in Florida, two in Tennessee, one in Mississippi, and the one at University of Alabama were represented. This reception and smoker was very beneficial in introducing the various members, one to the other, and to the members of the Supreme Executive Board. On Saturday morning, some 43 delegates from the 13 active chapters, met in the conference room at the Atlanta Biltmore at which time they were introduced to the members of the Supreme Executive Board and a discussion was had of their general problems. Following this meeting, the active chapters met with District Justice Cloud Morgan for further discussion of their problems and for laying the groundwork for a District Convention in October of 1949. That evening the Board, Atlanta Alumni and the delegates from the various chapters met at a formal banquet presided over by Brother James Howard of Atlanta, Georgia.

Supreme Secretary A. A. McDowell was unable to attend the meetings of the Supreme Board due to illness. He did, though, report to the Supreme Executive Board by way of a letter the progress his office had made in the past year and its plans for the future. On Thursday night, October 21, 1949, the members of the Supreme Executive Board who had made an early arrival met with the Supreme Justice for a general discussion of its problems and for planning an agenda for the business the next day. On the 22nd the Board was in meeting until late that evening. Again on Saturday afternoon and again after the formal banquet on Saturday evening, the last session lasting until 2:30 in the morning.

Much was accomplished at this meeting of the Board and plans and programming for the future was the main topic of discussion. The budget that was set up for the operation of the Executive Office for the coming year was determined on the basis of what value would the fraternity receive on the expenditure. By reason of the added in-

come from alumni dues and large amount of initiation fees received, the Supreme Executive Board approved a budget which allowed greater activity in help to the active chapters, the young admittees and to the practicing alumni.

The 1950 Convention was determined to be held during the Easter vacation week starting on the Tuesday and ending on the Thursday before Easter Sunday. Invitations for the holding of this convention were extended to the Supreme Executive Board, but a determination of the place was left for further development with the understanding that the location would be determined by September in order to allow the host chapters sufficient time to prepare for this convention.

Approval was given for the preparation of an officers' manual which would set forth the duties of the actives and alumni officers and the District Justices. This manual was to be prepared by the Executive Secretary, and after submission to the Board for their approval was to be printed and disseminated to all officers of the fraternity.

Approval was given for the establishment of a new service to be extended to all new admittees to the Bar by the Executive Office. Under this system, when the Executive Office is notified that a young attorney has opened up his offices for the practice of law, or has become

FIELD CHAPTER REACTIVATED

On May 20, 1949, Sullivan Chapter (University of San Francisco) conducted an initiation at which time Robert M. Desky, Glen T. Mitchell, Richard H. Kirkpatrick, John H. Draa, Philip E. Michaels, Edward L. Merrill, Richard S. Miller, Bert Schoenberg, and Kenneth A. DeMattei were initiated as members of Field Chapter.

This group, which was pledged to the fraternity by Temple Chapter (Hastings College of Law), had organized and elected Edward L. Merrill as their Chairman and Philip E. Michaels as their Secretary. This initiation was conducted by officers of Sullivan Chapter and following the initiation a dinner was given by the East Bay Alumni Chapter, presided over by Samuel H. Wagener, Justice of the Chapter. In addition to members of the East Bay Chapter attending, Brother I. M. Peckham, Associate Tribune of the Associate Tribunal and District Justice J. Albert Hutchinson of the 2nd District, were present.

The reactivation of this chapter brings the strength of Phi Alpha Delta to 61 active chapters in Class "A" Law Schools throughout the United States. The East Bay Alumni Chapter, Supreme Justice Edmonds and District Justice Hutchinson were very helpful in sponsoring this group and with the assistance of Temple and Sullivan Chapters in San Francisco getting them underway.

Official recognition of this new chapter is now pending before the administration at the University of California at Boalt Hall. The National President of Phi Delta Phi is Dean of the Law School at Boalt Hall.

Field Chapter was one of the most active chapters of Phi Alpha Delta until its ranks were completely deleted during World War II. The chapter then became inactive, but the Supreme Executive Board did not withdraw its charter which was still outstanding. The group of new initiates petitioned the Supreme Executive Board for authority to be initiated as members of Field Chapter and to reactivate this chapter accordingly. The petition was favorably acted upon by the Supreme Executive Board and authority was given to Temple and Sullivan Chapters to conduct the initiation on behalf of the Supreme Executive Board Field Chapter plans to expand during the summer and fall sessions and to again take its place as one of the active and prominent members of the chapters of Phi Alpha Delta.

Alumni who know of young men planning to attend the University of California, Boalt Hall, are urged to submit the names of the men to Philip E. Michaels, Secretary of the group, whose school address is 2419 Durant, Berkeley, California, and whose home address is 1394 Yosemite Avenue, San Jose, California.

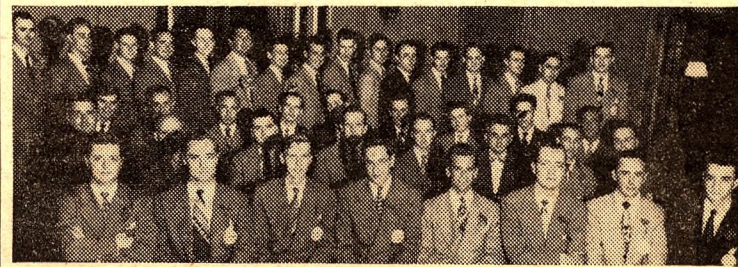
The charter at the University of California, Boalt Hall, was granted on May 13, 1911, under the name of Jackson Temple Chapter. The installation was conducted jointly with Holmes Chapter at Stanford University. In 1923 a division of this chapter was granted by chapter vote and the original charter name going to Hastings College of Law, a division of the University and a new charter granted to Boalt Hall at the University of California in the name of Stephens F. Field Chapter. The Stephens F. Field Chapter bears the same date of installation as the original charter for Temple Chapter and the same charter members.

60th Chapter Installed at St. Louis

On May 14, 1949 at the Shearson Hotel, St. Louis, Missouri, the John L. Sullivan Legal Fraternity was duly installed as the John L. Sullivan Chapter of Phi Alpha Delta. The festivities began at 4:00 p.m. in the ballroom of the hotel at which time 41 members were conducted through the ritual and received the oath of office. The initiation team was composed of E. A. Bert Taylor, Supreme Vice Justice, Carl Einbeck, President of the St. Louis County Bar Association, R. Forder Buckley, President of the St. Louis Bar Association, Hugh Wilson, Past Justice of the St. Louis Alumni Chapter and Ferd J. Cook, Justice of the St. Louis Alumni Chapter. Brother Taylor headed the initiation team.

Following the initiation, the Charter of the John L. Sullivan Chapter was presented to the group by Supreme Vice Justice E. A. Bert Taylor on behalf of the Supreme Chapter.

A banquet and reception followed the installation in the French ballroom of the Shearson Hotel, which was attended by past Supreme Justice John J. Nangle, Dean Paul Fitzsimmons of St. Louis University Law School and other members of the St. Louis Alumni Chapter.

Supreme Treasurer Anthony P. Savarese came from New York City to be the principal speaker at this banquet. Supreme Treasurer Savarese spoke in his usual effective manner and his timely remarks were well received by all in attendance and very materially added to the success of the occasion.

The installation of this chapter is largely responsible to the faithfulness, superb assistance and effort of Brother Hugh Wilson, Ferd Cook, past Supreme Justice John Nangle and Supreme Vice Justice Bert Taylor.

This chapter, named after John L. Sullivan, is the outgrowth of a local chapter existing at St. Louis University known as the John L. Sullivan Legal Fraternity. The namesake of this chapter received his legal training at St. Louis and later re-

turned in 1937 as a member of the faculty. At the time of his death he held the academic rank of Professor of Law. However, Mr. Sullivan's accomplishments as a lawyer were not limited to the pedagogic field alone. Until a few months before his death he was actively engaged in the practice of law as a member of the Missouri Bar and he was known and respected nationally. Some of the charter members of this new chapter were students of his in the last class he taught before his death.

St. Louis University was established in 1818 at the St. Louis Academy. In 1827 the Jesuits took over the directorship of the college and on December 28, 1932 the St. Louis College received its charter as the St. Louis University. This was the first University

MESSAGE FROM THE SUPREME JUSTICE

The close of the school year will bring many of our active members to the threshold of professional life. The practice of law opens new opportunities for the effective helpfulness of our alumni. That helpfulness should be expressed in as many different ways as the graduates have need for it. I hope that every alumnus will cooperate effectively with the local placement committee. He should equally be ready to give the new lawyer information regarding opportunities for practice or advice regarding the procedure in his own state. This is the spirit of our fraternity in action, the works which prove our faith in the principle of brotherhood.

Some 10,000 students will graduate from the law schools and apply for admission to the bar. This is a large number of persons for our profession to absorb, but there is work to do for every young lawyer who has the courage and determination to seek out the ways and means to be of service to his profession and to the community which he chooses as the place to live.

The new lawyer should always remember that his license to practice law represents a large amount of integrity, resourcefulness, steadfastness and hard work. He has a right to expect large returns from his investment of time and effort. However, these returns will not come as a result of wishful thinking. Success demands a continuance of the same perservance and devotion to duty which his law degree required. But there is plenty of room at the top for the uncommon man, the man who is willing to make sacrifices for professional advancement.

Those sacrifices are not large in comparison with the satisfaction one receives from a law practice built upon the foundation of service. To the lawyer is brought every conceivable problem in human relations and the solution of those problems is a challenge to his patience and industry in the measure which he solves them. With the purpose of bringing about a better understanding between employer and employee, business and government, merchant and customer, or in any other relationship which controversy has struck, he will find rich rewards in many ways.

To the young men entering the law schools in the summer or fall the members at our active chapters should point out that the primary purpose of Phi Alpha Delta is to provide the opportunity for congenial companionship among students of the law. But the friendships one makes during the college years do not end with those years. On the contrary, they extend through professional life and open doors wherever one may be. We welcome the pledges who will take their places in our active chapters with the same fraternal purpose with which we accept into the ranks of our professional brothers those who have completed their formal legal education and are joining us in carrying on the great tradition of lawyers in general and Phi Alpha Delta in particular.

PAD RE-ELECTED SAN BERNARDINO MAYOR

Carrying three out of the city's five wards, Mayor James E. Cunningham was re-elected on April 11, 1949, to his second term as Mayor of the City of San Bernardino.

Brother Cunningham, Ford Chapter (Loyola University), is 32 years of age and was first elected two years ago, at which time he defeated the uncle of his recent opponent in the election.

Brother Cunningham, at the time of his original election to the office of Mayor of the City of San Bernardino, ran on a ticket of youth and vigor as opposed to "old man" administration. Previous to his election as Mayor of the City of San Bernardino, he served in the District Attorney's office for the County of San Bernardino.

Hobson Elected to Supreme Court Of Florida

Brother Tolbert Francis Hobson, more commonly known among his friends and acquaintances as T. Frank Hobson, Brewer Chapter (Stetson University), was elected last year over his opponent, the Attorney General of Florida, to the Supreme Court of Florida. He is the youngest member of the Supreme Court of Florida. Brother Hobson was in general practice until 1927 and then was County Judge of Pinellas County, in 1928 he became Circuit Judge of the Sixth Judicial Circuit where he served until 1948 when he was elected Justice of the Supreme Court.

At the time of Justice Hobson's original appointment as Circuit Judge he was only 27 years old and was the youngest Judge in the U. S. sitting on the bench of a Court of unlimited trial jurisdiction and limited appellate powers.

Rutledge Chapter Pledges 20 Men at Rushing Close

Wiley Rutledge Chapter at the Duke University School of Law in Durham, N. C., closed its annual Spring rushing program with a formal pledge ceremony for twenty first-year law students at a luncheon ceremony in the University Union on March 17 at which Brother John S. Bradway, head of the Duke Legal Aid Clinic, was the principal speaker.

Duke law students who were taken into the Chapter as pledge brothers at the luncheon meeting included James Barfield, Donald Bebout, Morton Engelman, Edward Free, Arnold Harlem, John Hondulas, Fred Klein, John McCoy, Arthur McDonald, Everett Mast, William Millar, George Morrow, Marion Morton, Gordon Nazor, Alfred Oppenheim, Fred Pace, James Phipps, Daniel Pino, Robert Styers, and Robert Page. The pledging ceremony followed the most hotly contested rushing period in the history of the Duke Law School, during which 80 of the eligible 90 first-year students were pledged by three legal fraternities at the school. This percentage of law school students in the first year class pledging legal fraternities is the highest percentage ever recorded in District 12.

Professor Bradway, who is internationally famous for his work in the field of legal aid and who has been called "the father of the legal aid clinic system," discussed the place of the young lawyer in the profession at the luncheon. The pledging was conducted by Louis C. Allen, Jr., Justice of the Chapter.

Rutledge Chapter had presented its final rushing function on Thursday, March 3, at a luncheon in the University Union to which all rushees were invited and at which Brother Robert E. Freer, former chairman of the Federal Trade Commission and now practicing attorney in Washington, D. C., was the guest of honor and Brother Malcolm McDermott, member of the Duke Law School faculty, was the principal speaker.

Brewer Chapter Reports

Brewer Chapter (Stetson University) has had three months chocked full of activities and accomplishments. Their first activity, which was a great success, was a trip to Tallahassee for a day with the Supreme Court. Almost 200 per cent attendance of the chapter was accomplished. The chapter heard five cases pled before the states' most august tribunal and then the chapter was host to the Supreme Court for a luncheon. Brother "Ike" Tribble, one time Dean of the Stetson University College of Law and a founder of Brewer Chapter, served as toastmaster. Second Supreme Vice Justice Charles Tom Henderson, a past professor at Stetson University, now an Assistant Attorney General in the state of Florida, was also present.

When the State Law Association met in Clearwater in April, Brewer Chapter was represented by 8 members. This group was instructed by the chapter to show much activities in attempting to maintain the Diploma privilege in the State of Florida.

On the 23rd of April, Brewer Chapter was busy attempting to get its three delegates off to the meeting with the Supreme Executive Board at Atlanta. The rest of the chapter went to New Smyrna Beach for a party. Wives and dates, as well as 14 new pledges were entertained with a softball game in the afternoon. Refreshments were served while the groups were gathered in foursomes of bridge.

Brewer Chapter has initiated a Big-Brother system for the new freshman. Each member is assigned to a newcomer to act as his big-brother to help him with his studies and familiarize himself with the library as well as to supplement his regular classroom lectures. The newcomer need not be a member of Phi Alpha Delta, but every entering freshman is assigned to one of the members of the chapter. This has resulted in very successful pledging and has given Brewer Chapter the opportunity of meeting all incoming men of Stetson University.

Brewer Chapter is looking forward to the District Convention to be held at Dayton Beach in October, 1949.

TAFT CHAPTER INITIATES SENATOR PAT McCARRAN

Senator Patrick A. McCarran (D. Nev.), warned the peoples of America to turn their eyes from Berlin to Asia where, "Red Hordes from the North are driving democracy out of China," in his featured address at the banquet held in his honor following his initiation as an honorary member of Taft Chapter (Georgetown University Law School) in Washington, D. C., on April 30.

"We should not be blinded by the lifting of the Berlin blockade by the Russians," Senator McCarran said. "If we lose now, there is no such thing as depicting the slavery which will be visited upon the freedom we have known," he warned. Continuing with his theme, Senator McCarran stated that civilization is resting on the shoulders of American citizens and that, "if we lower our arms only God can say when civilization will come to the surface again."

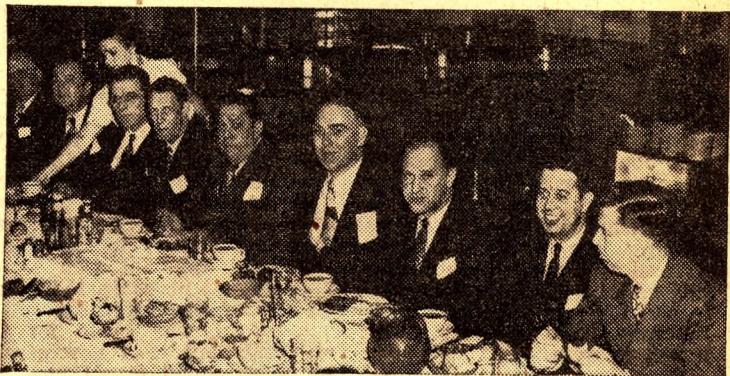
Senator McCarran spoke at a dinner held in the Federal Room of the Statler Hotel in Washington, D. C., under the sponsorship of Taft Chapter with the co-operation of Jay Chapter (George Washington Law School) and the Washington Alumni Chapter. The program of the evening had opened in the South American Room of the Statler Hotel with the formal initiation of Senator McCarran as an honorary PAD by Thomas J. Shannon, Justice of Taft Chapter. Following the formal initiation, which was attended by active and alumni brothers from Washington, D. C., and vicinity and by visitors from throughout District 12, a cocktail party and reception was presented as the social portion of the evening's activities.

Distinguished PAD brothers from the Federal and D. C. governments attended both the initiation and reception and the banquet which followed, in addition to national and local fraternity officers. H. Mason Welch (Taft), Justice of the Washington Alumni Chapter, acted as Toastmaster for the banquet. Congratulatory remarks were extended on behalf of District 12 by Matthew S. Rae (Rutledge), District Justice, and on behalf of John Jay Chapter by William F. Hyer, Chapter Justice. Justice Shannon of Taft Chapter made the formal presentation of the honorary membership key to Senator McCarran at the banquet. Following Senator McCarran's address, Supreme Justice Douglas L. Edmonds responded on behalf of the national fraternity organization and the Supreme Executive Board.

Preceding the evening's ceremonies, a District 12 business meeting which had been called by District Justice Rae was held during the afternoon in the South American Room of the

Statler Hotel with delegates present from six of the eight Chapters in the District, in addition to representatives of the Washington, D. C., Alumni Chapter and Supreme Justice Edmonds. The 23 visiting delegates from Active Chapters throughout the District were welcomed to the afternoon meeting by Justice Shannon of Taft Chapter as official host for the meeting. Primary business of the afternoon was the appointment by the District Justice of a Steering Committee to plan a District 12 Conclave for the coming scholastic year and a discussion of the type of meeting which should be planned. Invitations were extended to the District to hold the Conclave in either Washington, D. C., Richmond, Va., or Raleigh, N. C., and the Steering Committee was directed to pick a site for the Conclave from these invitations. A meeting of the Steering Committee was directed to be held at Richmond, Va., with Henry Chapter (University of Richmond Law School) serving as host thereafter on Saturday, June 25. Following the discussion in regard to the District Conclave, the meeting was opened to a discussion of topics of common interest to all Active Chapters in the District. The topics discussed were grouped under the headings of "Alumni Responsibilities," "Chapter Financing," "Rushing Techniques," "Chapter Housing," "Professional Activities," "Social Activities," and "Inter-Chapter Programs." Each topical discussion was lead by a visiting delegate from one of the Chapters represented at the meeting. In addition to the visiting delegates from Active Chapters, Supreme Justice Edmonds was present to answer questions for the Active members and Robert E. Freer (Chase) and William J. Goggin (Taft) of the Washington Alumni Chapter attended to offer the co-operation of the alumni to the active Chapters in the District.

KANSAS CITY FOUNDER'S DAY BANQUET



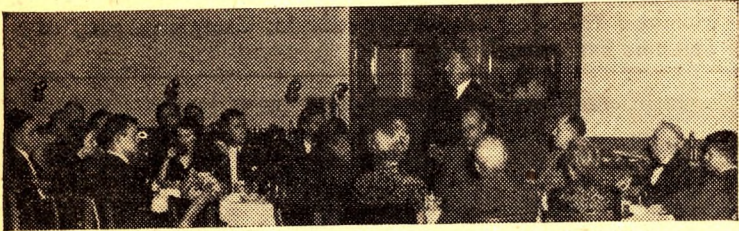

Miss Sue Vick; Mr. Louis Allen, retiring Justice of Rutledge Chapter, and Miss Betty Worth; Mr. Lawrence Dooley, incoming Justice of Rutledge Chapter, and Miss Myrtle Burns; Mr. William Story, Justice of Ruffin Chapter; Mr. Robert Morgan, Justice of Timberlake Chapter; and Mr. Lon Folger of the Wake Forest Law School, who acted as toastmaster for the evening.

In the principal address of the evening Justice Edmonds spoke of the many advantages and possibilities offered by the legal profession today as compared with only a few years ago. Today the fields of opportunity are broadened in which the trained attorney can prove his ability. According to Justice Edmonds, "The great lawyer is no longer only the fiery courtroom orator who can sway juries. It is he who upholds the integrity of the profession in any of the many fields he is privileged to enter, who will be called a good citizen and a credit to the great traditions of the law."

Following Justice Edmonds' address, the banquet adjourned to the dance floor for the remainder of the evening with music by the Bon Air Orchestra.

IT'S A CRIME

Campbell Chapter, University of Michigan, during one of its regular bi-monthly meetings, on March 8, received an interesting talk from Inspector George R. Branton, retired chief of the Detroit Police Department's Homicide squad.

The Inspector, retired after 27 years of active service, presented an absorbing picture of the modern methods of criminal detection and the collection of evidence. The importance of photographic evidence was emphasized. The Inspector commented on how convincing photographs were when presented by the prosecution in court.

He discussed several cases in whose solution he was instrumental. After the meeting closed, a group gathered to see some of the photos from the official police files.

When questioned on the possible factors which contribute to the high criminal delinquency of the present time, Inspector Branton expressed his firm conviction that crime, especially among the youth of the nation, is in the great majority of cases the consequence of parents failing to live up to their obligations of parenthood.

Campbell Chapter has not, however, completed devoted itself to business functions. The evening of March 19 found the brothers together with their wives and dates, attending an informal dinner dance, the main event on the Chapter's social calendar.

The festivities were held at the Ann Arbor Post of the American Legion. The affair, in honor of twenty-one new pledges, was attended by over 60 couples. Mr. and Mrs. L. H. Wright and Mr. and Mrs. C. Joiner acted as chaperons. Mr. Wright and Mr. Joiner are professors of law at the University of Michigan and both are PADs.

Campbell Chapter was honored by the presence of Mr. Paul Manning, Justice of the Sixth District of Phi Alpha Delta, for the gala event. Mr. Manning contributed to the successful evening with an excellent selection of after-dinner remarks in which he outlined the opportunities awaiting the young lawyer.

Although handicapped by lack of permanent quarters, Michigan's Campbell Chapter has proved to be the most active fraternal organization in the law school. Four meetings a month, including two regular luncheon meetings with guest speakers, provide an essential and welcome program to round out the professional curriculum.

Patrick Henry Chapter Carries Richmond Law School Elections

Patrick Henry Chapter at the University of Richmond School of Law, Richmond, Va., operating under the guidance of a Chapter Political Action Committee, carried the annual Spring election of Student Bar Association officers at the school by an unprecedented landslide vote, according to a bulletin from James D. McMullan, recently retired Justice of the Chapter.

Out of a total of 165 votes cast, the PAD ticket at the school captured 114 votes for the President of the Student Bar Association and 101 for the Treasurer of the Association. The overwhelming victory was even more startling in view of the fact that the Patrick Henry Chapter was not installed at the school until the end of October, 1948, and that its total membership at the present time is only 35. Doing political battle with an organized group consisting of better than twice the membership of the PAD Chapter which had controlled school elections without contest for the past several years, the Henry Chapter Political Action Committee organized and administered a disastrous defeat to the opposition group.

Regarding the overwhelming victory for Henry Chapter, past Justice McMullan reported, "a strong and fine feeling of fraternal spirit among the members of Patrick Henry Chapter. The boys got out and worked, and it paid off, and the other group can not believe their eyes."

Governor Jester Initiated At University Of Texas



The Tom C. Clark Chapter at the University of Texas held its Spring initiation at Travis County Court House Friday evening on April 29, 1949. At this time 29 new men were initiated into the fraternity. Approximately 35 alumni members were in attendance at the initiation.

After initiating the new pledges, Governor Beauford Jester of the State of Texas was escorted into the Courtroom whereupon honorary membership in the fraternity was conferred upon him. Chapter Justice Bill Collins presided and conferred the membership on the new pledges and on Governor Jester. Following the initiation, a banquet dance was held at the Country Club at Austin, Texas. The principal speaker at the banquet was William Hensley, District Attorney of San Antonio, Texas. Among the honored guests was J. E. Hickman, Chief Justice of the Texas Supreme Court.

The Tom C. Clark Chapter has been extremely active since its installation two years ago. A regular schedule of events has been followed by the chapter in meetings at which prominent alumni are asked to address the group.

IT WAS JOINT

On April 21, 1949 a joint initiation was held in the Courtroom and chambers of Brother Herbert C. Kaufman, Judge of the Superior Court in the City Hall in San Francisco. The occasion was the initiation of 75 members into Holmes Chapter (Stanford University), Temple Chapter (Hastings College of Law), and Matt Sullivan Chapter (University of San Francisco.) The San Francisco Alumni Chapter and the East Bay Alumni Chapter met with the active chapters for this installation.

Preceding the formal initiation of the members into the active chapter, initiation was held for men who had previously pledged to other chapters but who had not been initiated and, realizing later the value of membership in Phi Alpha Delta, desired to complete their pledgeship and become members of the fraternity. Captain L. J. Jones, U. S. Navy, 12th Naval District Legal Officer of Jay Chapter, (George Washington University); Hershel Champlin, Assistant United States District Attorney for the Southern District, Field Chapter (University of California); and Arthur Samis, Registrar and Professor of Law at Hastings College of Law, Temple Chapter, Hastings College were initiated into the respective chapters to which they were pledged by authority of these chapters. This initiation was conducted in an impressive and inspiring candle-light atmosphere by District Justice J. L. Hutchinson of the 2nd District.

Immediately after the initiation of these alumni, pledges of Holmes, Sullivan and Temple Chapter were initiated in the traditional PAD ceremony conducted by the following: District Justice J. Albert Hutchinson, Vice Justice Jack Hurley (Sullivan Chapter) Treasurer, Larry Donovan (Sullivan Chapter), Clerk Bob Wilson, (Justice of Temple Chapter); Marshal Ted Mulch (Vice Justice of Temple Chapter) and Lecturer John Skinner. (Temple Chapter).

Following the initiation the group re-assembled at nearby Hunter's Point Naval Officers' Club where white-jacketed waiters were ready with good cheer for all. When the prepared libations ran low, a good omen for all law students occurred—all present passed the bar. Good fellowship continued during an excellent dinner in the main banquet hall. In a jovial atmosphere of cigar smoke, toastmaster Walter E. Hettman, Justice of the San Francisco Alumni Chapter, introduced a series of speakers who were directed to confine their oratory to five minutes without jokes. To the delight of the assembled brethren neither charge was obeyed with exactitude. A congratulatory letter from Supreme Justice Douglas L. Edmonds was read to the assembled group which letter conveyed his regrets that he was unable to join with them since he was attending the meeting of the Supreme Executive Board of Phi Alpha Delta at Atlanta, Georgia.

Brother I. M. Peckham, Associate Tribune of the Supreme Executive Board, welcomed the new initiates. District Justice Hutchinson reported on new developments in the area. Brother Judge Leo A. Cunningham lent his weight to the proceedings with Irish anecdotes of earlier days in PAD. Brother Snodgrass, Dean of Hastings Law School won a hearty round applause with a few double-edged comments on the length of the preceding speeches and the general condition of the audience. Brother Judge Don Quayle of the Alamos Superior Court reported on the reactivation of Field Chapter at the University of California. Brother Professor Lawrence Vold, Hastings, urged the married students to honor their wives and recognize the fact that

law school achievements are won "by the sweat of their frau."

Responses were also made by Melvin Swift, Justice of Holmes Chapter (Stanford University), John Hurley, Justice of Sullivan Chapter (University of San Francisco) and Robert Wilson, Justice of Temple Chapter (Hastings College of Law). After a number of other outstanding alumni were introduced the brethren adjourned to serious discourse and oral argument at the bar.

District Justice Hutchinson announced that special meetings of the fraternity have been scheduled during the State Bar Convention to be held in San Francisco in September of 1949.

District VII to Hold Convention

District VII, composed of the States of Nebraska, Iowa, Kansas, Missouri and Arkansas, will hold its annual Conclave and Reunion at Des Moines, Iowa, on October 22, 1949. Host chapters are Cole (Drake University) and Hammond (University of Iowa).

District Justice Jay Kyle reports that the Convention Chairman is James E. Steffarud and that Convention Headquarters will be Fort Des Moines Hotel.

District VII is one of the most active districts in the system, holding yearly conventions at which the 8 older chapters and now the new chapter established at St. Louis are represented. Interim meetings of the steering committee to plan for the convention are held at least six months before a district convention.

Each chapter in the district was requested to appoint a committee for the District Conclave which was to be a great event under the plans of Cole and Hammond Chapters. At this Conclave a permanent District Organization is contemplated and all chapters had been furnished copies of the proposed organization.

Pad Retires as National Chairman of Junior Bar Conference

Brother Skinner is one of the three individuals who has served at every level in the Junior Bar Conference, commencing with his serving as State Membership Chairman in 1939-1940. He has also been active in the Junior Chamber of Commerce, the principal Jaycee posts held by him being President of Bessemer (Ala.) Junior Chamber of Commerce, President of Jasper (Ala.) Junior Chamber of Commerce, Vice-President of Alabama Junior Chamber of Commerce, and National Chairman of the Christmas Activities Committee of the United States Junior Chamber of Commerce.

charter granted west of the Mississippi river. The school of law was originally established in 1842 and may therefore claim the distinction of being the first law school to be established in the western part of the United States. St. Louis University, has as a part of its graduate school, the School of Medicine, the School of Law, Dental College, and the School of Nursing.

The John L. Sullivan Legal Fraternity, now the John L. Sullivan Chapter had held regular weekly meetings and had conducted a series of bi-weekly tours through the various state Courts in the area ranging progressively upward from the Magistrate's Court to the Circuit Court of Appeals. Supreme Justice Edmonds opened the meeting with a cordial greeting to all Brothers assembled and stressed the fact that the members of the Supreme Board were anxious and willing in every way to assist the local chapters in their work, and that they would attempt to answer any and all questions concerning the work and progress of the national fraternity, especially that progress which has been made since the last National Convention. All the National Officers had a word of greeting for the delegates; and Brother Frank E. Gray, Executive Secretary, explained the detailed work of his office and the necessity for co-operation of the local officers, especially the Clerk, in promptly handling all correspondence with the National Office. Brother Gray also informed the delegates of the recent plan of the Executive Board to send letters to all alumni in the area which a brother selects to begin his practice of the law so that the young lawyer may receive all the courtesies of the profession from his brother PAD's in that particular area. Fish Chapter sponsors an annual award to the outstanding senior law student based on grades as well as service to his school.

Brother Leon Coleman, Fletcher Chapter, University of Florida, described their dinner meetings at which faculty, non-fraternity men, and fraternity men are present. Phi Alpha Delta sponsors a breakfast at the Annual Homecoming Celebration for returning

Alumni. Fletcher Chapter also makes an annual trip to the state capitol, visiting the Supreme Court and the Legislature.

Brother Hopkins, Keener Chapter, Emory University, added that an orientation program for the freshmen was extended to preparation for exams at Keener Chapter, as well as familiarization with general law school life. A blanket invitation to the freshmen class is made for all rush functions. Keener Chapter has begun to collect a Chapter history containing all activities of the chapter as well as pictures of the members and a permanent record of their home addresses.

Brother Ward, Lamar Chapter, University of Mississippi, reported that Lamar Chapter offered an annual award for the winner of the Moot Court Competition. The Chapter cooperates with the local organizations of Omicron Delta Kappa and Mortar Board in bringing distinguished speakers to the campus. A grave rushing problem is faced by Lamar Chapter in that pledges are required to have a C average and only about 10% of the class maintains such an average, thus leaving only a small number of men to choose from.

Professional Luncheons are held by the Chapter bi-monthly with prominent speakers from Nashville. Brother Cooley, McReynolds Chapter, University of Tennessee, reported that PAD held the majority of campus offices at Tennessee. An orientation program instituted by PAD has now been taken over by the Bar Association. 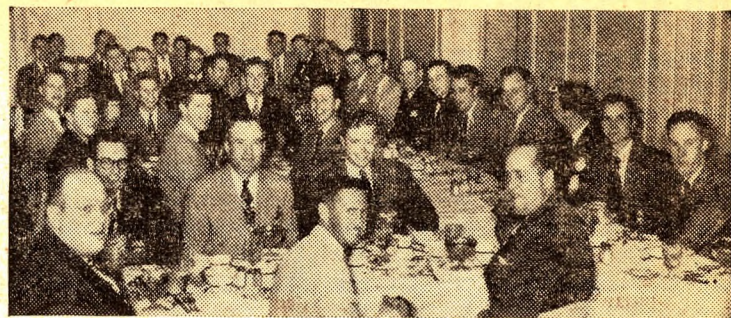

Members attending banquet at Atlanta, Georgia meeting of Supreme Executive Board.



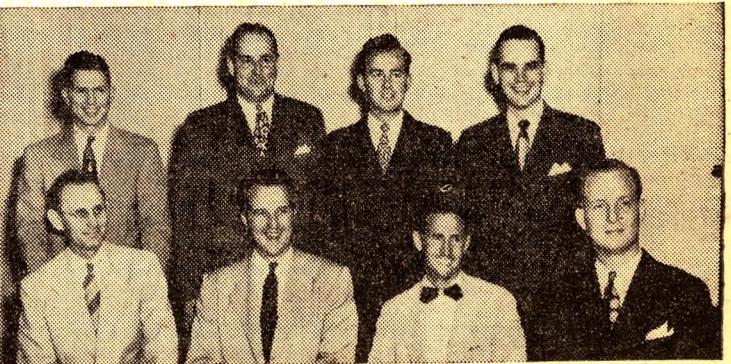

He Is Practicing In Your Town

From time to time you will receive from the Executive Office a letter advising you that a fellow PAD has recently been admitted to the Bar in your State and has opened offices in your town or vicinity for the practice of law. This letter is intended to introduce the new attorney and to make available to you young men who are practicing in your vicinity who would be available for reference work of matters which you are unable to handle or do not desire to handle.

This new service to the practicing attorney and to the admittee is being set up in the Executive Office and should be functioning by September or October of this year. The Supreme Executive Board, at its meeting in Atlanta, Georgia, approved the establishment of this service on the theory that it was one which would be beneficial to all concerned and one which would exemplify the preamble of our Constitution which states, "The purpose of this fraternity shall be . . . to establish a widespread exchange for the interchange of business information and matters of common interest to the members of the fraternity."

It is a known fact that many busy practicing attorneys are unable to adequately handle some of the matters which are brought into their offices due to the fact that they are engaged in other matters, or the new business is of such a nature that the fee to be paid is not commensurate with the work involved. The practicing attorney would appreciate knowing of a young attorney in his vicinity to whom he could refer this work or upon whom he could call and associate with him for that particular case. The information will be made available, but as to whether the system is successful or not depends upon the use made of this information by all concerned.

The establishment and success of a law practice is determined by the first two or three years when the young attorney is exposed to the business world. The help, aid and success that can be given to the young attorney by his practicing brothers will make an indelible impression upon the future of the young admittee. In addition to reporting these young admittees by way of a letter to an older practicing brother in the vicinity, they likewise will be listed in subsequent issues of the "Reporter."

New Chapter To Be Installed At Cumberland

A petition for a chapter at Cumberland University, located at Lebanon, Tennessee, was submitted to the Supreme Executive Board and this petition has now been approved. The petitioning group, composed of 16 members in attendance at Cumberland University, requested that the charter be known as the CORDELL HULL Chapter of Phi Alpha Delta.

Cordell Hull is one of Cumberland University's distinguished alumnus and one who bears a high reputation and esteem throughout the country. He was born in Tennessee in 1871 and secured his Bachelor of Law from Cumberland University in 1891 and was admitted to the Bar that year. He served as Judge of the Fifth Judicial Circuit of Tennessee from 1903 to 1907 and then served in the Congress of the United States from 1907 to 1921 and then again from 1923 to 1931. In 1931 he was elected to the U. S. Senate for the term 1931 to 1937 but resigned in 1933 when he was appointed Secretary of the State by the late President Franklin D. Roosevelt. His chief claim to everlasting fame is his great personal contribution to the cause of peace in the world and the development of the first relations this country had with Latin America.

Cumberland University is a very old and famous institution in the State of Tennessee. It recently rounded out its first 100 years as a great Southern educational institution. It has produced many outstanding leaders in the State of Tennessee and the United States as a whole. It counts among its distinguished alumni, a Secretary of State, two Justices of the United States Supreme Court, 16 United States Senators and more than 100 members of the House of Representatives of the United States. Twelve members now sitting in the present Congress are alumni of Cumberland University.

Cumberland University was recently approved by the American Bar Association as a Class "A" Law School, having petitioned for such recognition several years ago and securing provisional recognition upon compliance with certain requirements of the American Bar Association Committee on Law Schools. Cumberland University is undertaking a great expansion program as far as its law school is concerned, with renovations of its quarters, acquisition of a larger library and increasing the full time members of its faculty.

NEW YORK ALUMNI CHAPTER VERY ACTIVE

The report submitted by Charles Digangi Justice of the Alumni Chapter of New York for the period from May 6, 1948 to April 28, 1949 was received and excerpts from this are set forth showing the various activities conducted by the New York Alumni Group during this period.

The first meeting of the New York Alumni Group was held on May 6, 1948 at the Hotel Holley. This was a dinner meeting, at which time Supreme Treasurer Savarese and District Justice Charles Digangi, as well as Brother Bryant of Rapallo Chapter, reported on the convention held in Los Angeles. At this meeting there was also an election of officers for the year 1948-49 at which time Charles Digangi was re-elected Justice, Horace Teass, First Vice Justice; Robert H. Kilroe, Second Vice-Justice; Donald G. Schenk, Third Vice Justice; J. Aldus Rinehart, Treasurer, Joseph Kennedy, Clerk; and Ambrose A. Arnold, Marshall.

A dinner meeting was held on June 16, 1948 for the purpose of discussing the annual summer outing. Brother Vincent A. G. O'Connor, Chairman of this affair reported that arrangements had been completed with the Westchester Country Club, Rye, New York to hold an outing on Tuesday, July 20, 1948. The annual summer outing took place at this Country Club at that time. The day was spent by the members in attendance at golfing, sailing and swimming. At 7:00 p.m. the members, with their ladies and friends, met for dinner. This was followed by entertainment and dancing completing a long day of fun and merriment.

The Speaker and guest of honor at the dinner meeting, Thursday, October 14, 1948, at Hotel Holley was Dr. Ralph S. Banay of Columbia University, Director of Research of Social Deviations. His subject was "Psychiatry, Juvenile Delinquency and the Law." His talk was most instructive and well received, and interest in the subject was evidenced by the numerous questions put to Dr. Banay at the end of his address.

On December 7, 1948, a meeting of the Directors of the Alumni Chapter was called. Among the matters discussed was the advisability of increasing the dues of the Alumni Chapter from \$3.00 to \$5.00 per year and this was adopted. Financial and active assistance for Rapallo Chapter in its program of expansion, the reactivation of Livingston Chapter at Columbia University and other matters concerning the good and welfare of both active and alumni chapters came up for consideration.

The next meeting of the alumni chapter was held on December 17, 1948, which was a dinner meeting in conjunction with Rapallo Chapter's initiation ceremonies. The principal speaker at this banquet was Supreme Treasurer Savarese. Alumni Justice and District Justice Digangi reported on his trip to Lincoln, Nebraska to the Conclave of District 7.

On January 27, 1949, a dinner meeting was held at which the speaker and guest of honor was Mr. Robert Longhi, graduate aeronautical engineer, formerly connected with the Caproni Aircraft Works in Italy. His subject was "Experience of the Partisans in Northern Italy." Mr. Longhi was well received and threw much light on underground activities in Italy during and after World War II.

A joint meeting with Rapallo Chapter was held on March 30, 1949 at the Hotel Holley at which time eleven men were initiated into Rapallo Chapter. Justice Earnest E. L. Hammer of the New York State Supreme Court addressed the men on opportunities in the field of law. At this meeting, the nominating committee, to prepare a list of candidates for the election of officers and directors for the year 1949-50 was appointed by Alumni Justice Charles Digangi.

Ross Member Finalist In 'Hale Court'

Brother Phil F. Jones, a recent graduate of U. S. C. After working for a year, Brother Jones joined the marine corps. As a lieutenant he served with the invasion forces attacking Guam. While fighting on Guam he received an injury which cost him the sight of one eye.

When the war ended, Brother Jones entered U. S. C. Law School where he became a member of the Law Review. He recently took the California State Bar examination and has hopes of entering the general practice of law in Southern California when the right opportunity comes along.

District Justice Boone Resigns

Daniel B. In addition to this the chapter discussed the coming 1950 Convention of the fraternity and whether the Chicago Alumni Association would extend an invitation to the Supreme Executive Board to hold its 1950 convention in Chicago.

Tracy Honored by Campbell Chapter

A revered figure on the Michigan Law faculty was honored by his PAD brothers of Campbell Chapter at a luncheon meeting in Ann Arbor on April 12. Professor John E. Tracy, who for the last twenty years has devoted his life to scholarship and instruction, is retiring this year at a vigorous seventy years.

Before joining the faculty in 1930, Brother Tracy practiced law in New York and Chicago. While in Chicago, he completed a treatise on the field in which he was then working, investment law. As a result he was invited to deliver a series of lectures at the Michigan law school. These events culminated in his joining the faculty there.

After talks by John Dellenbach, PAD student representative, and Brother Marcus L. Plant of the faculty, both of whom provided interesting sidelights of the life and character of Professor Tracy, Justice Charles D. Bell presented the honored guest with the memoirs of Cordell Hull as a remembrance from Michigan's Campbell Chapter. The gift proved most appropriate when Brother Tracy indicated that he was an admirer of Mr. Hull's and had met him in the past.

Though he didn't set out his plans for the future, Professor Tracy made clear that his years of instructing had by no means brought an end to an active life in law. He will be long remembered not only for his teaching in many fields of law, but for his sincere personal interest in the many students with whom he managed to gain close contact.

Bowles Elected To "Order Of The Coif"

Brother Paul Nathan Bowles, Willey Chapter (University of West Virginia) has recently been elected to the Order of the Coif, National Law School Honorary Fraternity.
