AMONG outstanding events occurring some five years ago in the history of the Fraternity, was the failure of the Bank of Hollywood, California, which bank had carried the account of the Fraternity for several years. Fortunately this failure occurred at a time when the Fraternity balance was low, and such dividends have since been paid that our organization has suffered but little loss.

Lawrence R. Lytle, the Supreme Historian, was working on the preparation of a new General Directory of the Fraternity to be published by Martindales Fraternity Directory Company of New York City.

Alumni

Brother Herman S. Salen (Ryan), Waukesha, Wisconsin, was President of the Association of District Attorneys for the State of Wisconsin, serving his 4th term as District Attorney of Waukesha County.

Brother James P. Harrold (Webster) was re-appointed a Master in Chancery of the Circuit Court of Cook County, Illinois.

Brother Charles W. Hadley (Fuller) of Wheaton, Illinois, was Chairman of the Illinois Commerce Commission.

Brother David E. Shannahan (Webster) of Chicago, Illinois, was re-elected Speaker of the House of



Representatives of the General Assembly of the State of Illinois, making his 5th term as Speaker. He has served longer as Speaker of the House than any other person in the history of the State.

Brother Le Roy B. Young (Marshall) of Ogden, Utah, was elected First Vice President of the Utah State Bar Association on December 13, 1930. He was Dis-

trict Attorney for the first judicial district of the State of Utah from 1921 to 1929.

Brother Allan T. Gilbert (Blackstone) was Second Vice President of the Hamilton Club of Chicago. He had been a former Secretary of the club.

Brother Albert J. Harno (Calhoun), Dean of the College of Law of the University of Illinois, was Secretary-Treasurer of the American Law Schools.

Brother Andrew Y. Wood (Temple) of San Francisco, California, was Editor of The State Bar Journal, official publication of the State Bar of California.

Brother Myron Stevens (Ryan) was appointed United States Commissioner for the Western District of Wisconsin.

Brother Louis P. Donavan (Ryan), former All-American Tackle, was serving his second term in the Montana Legislature.

Brother Frank E. Rutledge was Chair-

man of the Executive Committee on Alumni relations in the conference of Law Fraternities.

Brother Frank Harvey was Justice of the Akron, Ohio, Alumni Chapter.

Brother Hamlet J. Barry (Ryan) of Denver, Colorado, was elected Vice President of the Denver Bar Association at a meeting of the Association held on May 4, 1931.

Brother Silas H. Strawn (Campbell) of Chicago, Illinois, former President of the American Bar Association, was elected President of the United States Chamber of Commerce.

Brother Frank P. Aschmeyer (Clark) completed the first edition of a book of songs for the Fraternity. The book consists of 51 pages of Fraternity songs.



Portland, Oregon Alumni Offers Scholarship Award

■ With the recent reinstallation of Williams Chapter at the University of Oregon, at Eugene, Oregon, plans were immediately made for the formation of an alumni chapter.

The formation of the alumni chapter was successfully culminated on National PAD Nite. Officers elected were Calvin N. Souther, Justice; L. R. Recken, Vice Justice; F. L. Buck, Clerk.

At a subsequent meeting of the newly formed alumni chapter it was decided that a cash prize award be given by the alumni chapter to the law student attaining the highest scholastic average during his first year at law. The amount of the scholarship award was set at \$50 and is to be presented at the end of each school year. The announcement was made at a student body meeting. Professor Charles G. Howard (Magruder) made the presentation in behalf of the Portland Alumni Chapter.

Dean Wayne L. Morse accepted the prize for University administration and the law school faculty.

"The members of the law school faculty deeply appreciate the compliment and co-operation which Phi Alpha Delta fraternity has given to the law school in the form of this very valuable incentive to scholastic endeavor," he stated.

Ray Mize, Justice of the Williams Chapter of the fraternity at the University of Oregon School of Law commented, "Our purpose in reorganizing the local chapter of Phi Alpha Delta was to aid the faculty in maintaining a high scholastic standing within the law school and if possible to foster a closer relationship with the members of the Oregon State Bar. We sincerely hope that the aforesaid award is a step farther toward establishing that relationship."

Let's Face the Issue

If you were not a member of Phi Alpha Delta, would you, with your present knowledge of the fraternity, accept an invitation to join it? Fraternities of all types have always been subject to criticism by those who are not members of the organizations attacked.

These attacks have the common characteristic of being founded upon inadequate and inaccurate information. Journalistic fervor seems to militate against careful investigation, and the desire to be interesting too often overrides the duty of being accurate and fair.

Phi Alpha Delta has not been immune, and no thinking person would ask for immunity. Your Supreme Board is convinced that the fraternity has real value, otherwise they would not freely give so much of their time and effort. Not one of the Board accepted his position for the honors which it confers.

We firmly believe that such an organization may be helpful alike to the graduate and the undergraduate, and that it may be truly useful in maintaining and raising the standard of legal education, and in promoting the welfare of the law schools in which its chapters have been established. We do not believe that we are taking money for which no adequate return is being made. We do not believe that our fees and dues are excessive. Neither do we believe that the organization is perfect, or that it is doing all that it may in the furtherance of the ideals upon which it was founded.

Criticism of a constructive nature has always been welcomed by the Board. It is still solicited. But criticism can be valuable only when it comes from the well-informed. Therefore, we ask every active member and every chapter to consider with care certain questions: Do you consider the organization worth while? Do you find it an aid and an inspiration in your professional study? Is it a valuable asset to your school? Are you as an individual lending your efforts to these ends? We solicit your reactions.

We have faith in the value of Phi Alpha Delta, but that faith does not blind us to the fact that this fraternity must justify its existence in the minds of its members, that it must be a help and an inspiration, that it must serve a work-a-day world, that it must do something more than present beautiful but intangible ideals. Phi Alpha Delta is and will be just what its individual members make it.

Your Supreme Board, despite their many years of interest and activity, do not make the fraternity, though they, too, may mar it. Upon the shoulders of the individual chapters rests the responsibility for the answer to any attacks which may be levelled at it. It is reasonable, in the light of movements now visible, to expect a real renaissance in the fraternity, provided only that there shall be that spirit of cooperation which has made PAD what it has been through the years of its existence. Your Board confidently expects your cooperation.

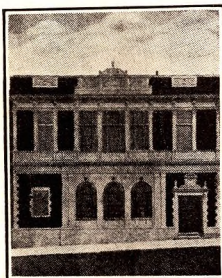

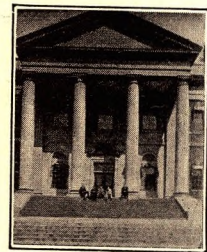
University of Cincinnati

This review work proves of great value to all classes and thus accomplishes its purpose.

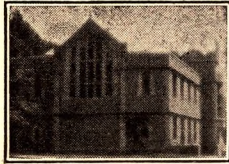

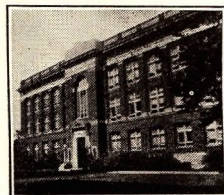
At a smoker alumni Brother Serri spoke on "Modern Criminal Law Practise."

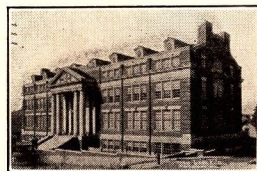

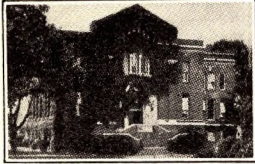
