# Relations Between Federal Government and Industry Since 1933: Four Examples

The past four and one-half years have been a period of unprecedented peacetime activity on the part of American governments and particularly of the Federal government. The amazing mass of legislation enacted during this time has opened up entirely new fields of state action, and has extended many of the old ones far beyond

their accustomed limits. In what manner and to what extent these acts will affect American industry it is impossible to say with certainty, but the general character of most of them is such that either they are of direct importance to the business world or their indirect results are sufficiently important to warrant its concern. To classify and discuss this legislation would be a valuable and instructive endeavor but one which would quickly exceed the limits of a few pages. Hence, the expedient has been adopted here of selecting four acts, each of a different type—two in the field of labor relations, one of the traditional "regulatory" character, and one positive, so-called social measure of a scope and character new among Federal statutes—as examples of the new relations between the Federal government and industry.

Earliest in point of time and most controversial of the four is the National Labor Relations Act, popularly known as the Wagner Labor Act (49 Stat. at

L. 372), which became law on July 5, 1935, effective immediately. Since the early days of the Seventy-third Congress (1932-1934), the policy which this Act embodied had been before the national legislature in one form or another, actively sponsored by New York's Senator Robert F. Wagner. Beginning modestly as Section 7a of the

defunct N.I.R.A., the bill was introduced in substantially its present form in 1934, failed of passage, but was reproposed and passed in the first session of the next Congress.

Outside of the declaration that employees shall have the right to organize for collective bargaining, the keystone of the Act is the group of "unfair labor practices" which it undertakes to prevent. These include any interference with the right to organize, the fostering of so-called "company unions" by financial or other effort, making non-membership in a labor union a condition of hire or tenure, and refusal to bargain collectively. It should be noted here that while an employer may not refuse to bargain collectively, there is no requirement that an agreement, oral or written, be reached.

The enforcement of these provisions is entrusted to a three-man National Labor Relations Board of independent status, appointed for five years. The Board may decide what is the appro-

priate unit-employer, plant, craft-for collective bargaining, and the representatives selected by a majority of the workers in this unit are exclusive representatives of the whole unit, although any employee or group may present grievances to their employer. The Board may investigate by hearing charges of "unfair labor practice" and may determine by hearing, election, or otherwise who are the employee representatives. Where charges are substantiated, the Board issues "cease and desist" orders and may require such affirmative action as the re-instatement of employees, with or without back pay. As in the case of the Federal Trade Commission, the Board's orders and subpoenas are enforceable or may be modified or set aside by the Circuit Courts of Appeals, wherein also relief may be sought by any person injured by a Board order. No penalty, other than re-instatement of employees, is provided for failure to obey a Board order prior to a court decree. Finally, it should be pointed out that the Board is given authority to act only in a controversy "affecting" interstate commerce.

The second measure involving employer-employee relations in industry, although different in type from the one just discussed, is the Government Contract Conditions Act, known as the Walsh-Healey Act (49 Stat. at L. 881). Its provisions markedly like those of the "blanket code" under N.R.A., this Act gives the Federal government, through the Secretary of Labor, control of wages, hours, and working conditions in plants selling supplies to the government exceeding \$10,000 in value. While only those men actually working on or supplying material for a government contract are provided for in the Act, its practical effect is to force the rest of a plant to conform, owing to the difficulty of having more than one hour and wage schedule at the same time in a single plant.

Sponsored in the Senate by David I.

Walsh of Massachusetts and in the House by Representative Arthur D. Healey of Massachusetts, the measure was enacted on June 30, 1936, to become effective in contracts for which bids were asked on or before September 28, 1936. The Act provides that all contracts for government supplies, except those ordinarily purchased in the open market, perishable, livestock, dairy, and nursery products, farm products processed for first sale by the original producer, agricultural products purchased by the Secretary of Agriculture, and contracts with common carriers, shall contain certain representations and stipulations. Of these the following are the most important: that the contractor is a manufacturer of or a regular dealer in the supplies required; that all persons working on the contract, including those employed by sub-contractors but excepting office or custodial employees, will receive a minimum wage set by the Secretary of Labor and will not work in excess of an eight hour day and a forty hour week; that no child or convict labor will be employed; and that working conditions will not be dangerous to the health and safety of employees.

Punishment and damages for breach or violation of these provisions are substantial: a fine of ten dollars per day for each convict or child employed; a sum equal to the amount of reduction or underpayment of wages due any employee according to the scale set by the Secretary of Labor; right of the government agency entering into the contract to cancel it and charge the additional cost of new contracts or open market purchases to the original contractor; and return to the employees of funds recovered for rebate or underpayment of wages. In addition, the Comptroller General is directed to circulate among all the government agencies a list of those firms found to have breached these conditions, and these are to be awarded

no more contracts for three years unless the Secretary of Labor otherwise recommends.

As suggested above, the Act is administered by the Secretary of Labor, who has power to hold hearings upon his own motion or on application of any person complaining and to issue orders and regulations deemed necessary to enforce the provisions of the Act. The Secretary's orders may be enforced in the District Courts or in the Supreme Court of the District of Columbia. The measure provides for modification of these contract conditions by the Secretary of Labor upon recommendation of the contractor and a written finding by the contracting agency that the inclusion of certain stipulations will seriously impair the conduct of government business or upon a finding by the Secretary that justice or the public interest will be served by such modification.

A measure more of the traditional regulatory character than the two above is the so-called Robinson-Patman Act (49 Stat. at L. 592), amending section 2 of the Clayton Anti-trust Act of October 15, 1914 (38 Stat. at L. 730). Sponsored by the late Senator Joseph T. Robinson of Arkansas and Representative Wright Patman of Texas, the measure was written as the result of a House inquiry and was enacted on June 19, 1936, effective after that date. Although popularly regarded as pertaining to chain stores, the Law is designed actually to prevent all so-called unfair price discriminations through the use of false discounts and rebates for services not really performed or accorded to all purchasers on proportionately equal terms. Such discriminations become "unfair" when they tend to create a monopoly in any line of commerce or to prevent competition with any person who either grants or receives the benefit of such discrimination, or with customers or either of them. It should be noted here that the

Law applies to buyers as well as to sellers.

The Act enlarges section 2 of the Clayton Act by making unlawful not only discrimination in price but also discrimination in terms of sale. It specifically does not, however, apply to the following: discrimination in price by reason of differences in quantity of sales to manufacturers for use in producing a new product; discrimination among factories, wholesalers, retailers, and consumers, if limited to "due allowance" for differences in cost resulting from different methods or quantities; discrimination based upon recognized changes in "market prices;" discrimination based upon price changes owing to changing conditions affecting "marketability;" discrimination in price "in good faith to meet competition." However, the Federal Trade Commission, the principal enforcing agency, may after investigation fix quantity limits beyond which discounts may not go. The Law. moreover, does not prevent cooperative associations from returning to their members the net earnings in proportion to purchases from or sales through the associations.

Four ways are provided for the enforcement of the Act: cease and desist orders of the Federal Trade Commission, enforced by the Federal courts; injunction suits prosecuted by the Attorney-General; suit for injunction or damages by anyone injured; penalties through fine or imprisonment. It is interesting to note that when proof has been made at a hearing under this measure that there has been discrimination in price or services or facilities furnished, the burden of rebutting the prima-facie case thus made rests upon the accused.

Obviously, of course, if none of a firm's sales involve the movement of goods across State lines, it does not come under the Act and may make discriminations between customers without respect to it. The affect of the Act upon

other firms is hard to ascertain owing to the difficulty of determining the interpretation of such points as unit cost differentials, changing conditions affecting the market, and price differentials made in good faith to meet competition.

The Social Security Act (49 Stat. at L. 531) is an experiment in social legislation of such tremendous scope, affecting such a large proportion of the wage-earners of the country, that it has become one of the most controversial measures of the whole controversial period. It is estimated that when it is in full operation the Act will affect approximately twenty-five million workers and will raise over two billion dollars in revenue. Introduced early in the Seventy-fourth Congress, the bill was enacted on August 14, 1935, after months of discussion and compromise. It was planned as a first line of defense against unemployment, to remove the fear of poverty during depression and of destitution in old age, to improve care for mothers and children, and to aid State public health programs.

Of these varied purposes the old age pension programs and the unemployment compensation plan are of most importance to industry, since they affect a greater number of people and are supported directly by taxes on employers and employees. The Act provides for two types of old age pensions, grants-in-aid to the States for free pensions to aged persons without other means of support, and a simple annuity plan sponsored by the government. The former are operated on the basis of matching of State funds by Federal funds up to fifteen dollars per month of Federal money for each recipient, providing the State adopts and maintains a pension law satisfactory to the Federal authorities. The administering Board may at any time, after a hearing, suspend payment to a State whose plan is not operating according to specifications, following the usual procedure in

administering grants-in-aid. This part of the Act went into effect at once.

The Old Age Benefits plan differs from the other parts of the Act in that it bears no relation to State taxes or to State old age pension systems. It is an annuity plan operated entirely by the Federal government. Supported by a tax on employers' pay rolls and by deductions from workers' wages-one per cent for the year 1937, increasing to three per cent for the year 1949 and after, in both cases—it will provide no pensions until January 1, 1942, after which time any person of sixty-five or more is entitled to receive monthly pavments. These amount to one-half of one per cent of the total taxable wages paid him between January 1, 1937, and the time he is sixty-five, provided the maximum amount included in determining earnings for any twelve-month period is \$3,000. In no case will the payment exceed eighty-five dollars per month, and it is reduced if the recipient continues working after he is sixty-five. If the worker dies before he reaches the retirement age, three and one-half per cent of the total taxable wages paid him since January 1, 1937, will be given to his estate. If death overtakes him after sixty-five, his estate will receive the difference between three and onehalf per cent of his total taxable wages since the beginning of contribution and the amount already paid him. Thus this annuity plan is similar to private plans of the same nature excepting that there is no loan or surrender value and no assignable or attachable value to the individual's "interest" in the system.

It should be noted that certain classes of workers, such as the following, are not covered by this part of the Act: agricultural, domestic, and casual labor; officers and crews of merchant ships; public employees; and employees of charitable and educational institutions. Further, in this part of the Act there is no provision for previously

established pension systems, private or public.

The Unemployment Compensation plan is operated by the Federal Government with cooperation of such States as choose to adopt laws suitable to the provisions of the Act and acceptable to the administering Board. Partially to support this program a Federal tax on employers of eight or more persons began to accrue on January 1, 1936 of one per cent on the total payroll during that calendar year, increasing to three per cent in 1937 and thereafter. A credit is allowed to employers for funds paid into an unemployment fund under a State law approved by the administering Board, up to ninety per cent of the Federal tax. These State funds are deposited with the Federal Secretary of the Treasury in an Unemployment Trust Fund, invested as a single fund in Federal and Federal guaranteed obligations. Each State may draw upon its account with this Fund by requisitions duly made, but no compensation may be paid for unemployment occurring within two years after the beginning of contributions, and all money withdrawn from the Fund must be used in the payment of compensation, exclusive of administrative expenses. Finally, the State may not deny compensation to an otherwise eligible person for refusing to accept new work under any of the following conditions: if the position is vacant due to a labor dispute; if the working conditions are substantially less favorable than those prevailing for similar work

in the locality; if the individual would be required to join a company union or resign from or refrain from joining any bona fide labor organization as a condition of employment.

To administer these parts of the Act the Social Security Board has been established. Its three members are appointed for six years, one retiring every two years, at a salary of \$10,000. The Board is not in the Department of Labor as was envisaged when it was planned to operate the Act in connection with the recently established Federal Employment Offices, but is a completely independent agency. Owing to the scope of the Act, the Board will shortly be one of the largest single agencies of the Federal government.

Other provisions of the Act need not be discussed in detail. They provide appropriations for aid to the States in caring for dependent children, for maternal aid and child welfare, for aid to the blind, and for public health work. These sections went into effect upon the signing of the Act and are administered along the usual lines of grants-in-aid.

From these four examples can be seen the variety and complexity of the new Federal legislation affecting the interests of industry. Opinions differ widely as to whether they are symptomatic of a long-run trend or are merely ill-advised experiments of short duration. At any rate, they indicate a new factor in the relations of government and business in the United States.

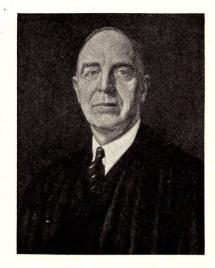


# Twenty-five Years of Service

Both have since married and were joined by their husbands in the festivities honoring their distinguished father.

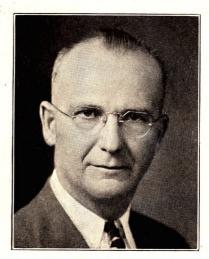
# Phi Alpha Delta at American Bar Association Meeting

Suggested amendments to the present ritual will also be considered. The Board meeting will be, as always, open to all brothers. Supreme Justice Green is extremely anxious that as many as possible attend all sessions of the Board meeting and contribute advice and suggestions. The new section provides for an annual fee payable to the Supreme Secretary in the amount of \$3.00 per year, unless the alumnus shall be a life subscriber to the official magazine, in which event the per capita tax shall be \$2.00. The payment of the per capita tax provided for in this section shall entitle the member to a subscription to the official magazine, to all issues of the Directory with black face type indicating that the alumnos is a supporting member, to bulletins and other services which the fraternity may from time to time render.

No attempt was made to provide means for the enforcement of the collection of this fee, nor were any penalties provided for the non-payment, the delegates feeling that a majority of the members of the fraternity would willingly and voluntarily pay this amount each year toward the support of the organization. 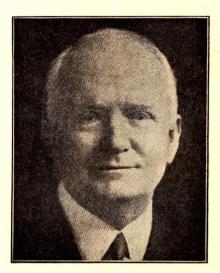

#### Marshall Field's President



Frederick Dexter Corley

Fired by an intense desire to become a great lawyer, FREDERICK DEXTER CORLEY rose from the obscure position of a four dollar a week stock boy to the President of one of the world's largest merchandising organizations—Marshall Field & Company in Chicago.

Arriving in Chicago at the age of eighteen from Tower Hill, Illinois, Corley had a plan worked out in his mind that would be the stepping stone to a successful career in the legal profession. First of all, he had to obtain a job in order to provide a livelihood for himself and to enable him to pay his tuition in the Chicago Law School, where he attended evening classes.

Little did this farm boy realize that the job he was seeking as a means to an end would prove to be a permanent position and completely overshadow his legal ambitions.

That is exactly what happened to Frederick Dexter Corley. When he obtained his job, it was with Marshall Field & Company, and he has been with that organization for the past thirty-seven years. Corley so greatly cherished the opportunity which this position offered that he progressed very rapidly, one step after the other, in this world famous merchandising organization. It

was the desire to make good at his job so that he might continue his legal education, rather than the ambition of becoming another merchant prince, that made his strides to success so numerous in the Field organization.

After seven years with Marshall Field & Company, Corley completed his law courses, won his degree of L.L.B., and was admitted to the Illinois Bar. The first step of his ambition realized, he decided to give up merchandising and turn all his attention to the practice of law.

Corley formally tendered his resignation, but it was not accepted. It was coincidental that at the time he submitted his resignation, the Field executives had planned to send him to Europe as a buyer.

Corley, then only twenty-five, believing this to be an opportunity too great to overlook, postponed the opening of his law office and accepted the offer. Corley claims now that no promotion since has given him as big a thrill as the one he received when he went to Europe for the first time as buyer for Marshall Field & Company.

From that time on, his job of working with Marshall Field & Company absorbed his ambitions and expanded and unfolded into new responsibilities. Three years later he was made assistant manager of millinery for the whole store and was making trips to Europe every year.

In 1911 he became manager of the sections of women's suits and dresses, and then one by one other departments were placed under his control. In 1915 he became assistant general manager and assistant merchandise manager. He became merchandise manager for the whole store in 1916. After ten years in this highly responsible position, he was made vice-president in charge of retail merchandising in 1926.

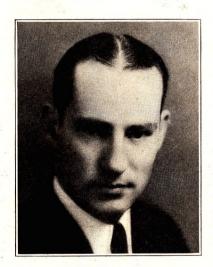
In 1935 he became general manager of the retail store and in March of 1936 he was made a director in the corporation and first vice-president. This was soon followed, July 5, 1936, by his election as president of Marshall Field & Company. In 1937 he was elected Chairman of the Board of The State Street Council, an association which includes the leading mercantile establishments of Chicago.

Mr. Corley resides at 1100 Lake Shore Drive with his wife and daughter, Mary Louise. He is an ardent sportsman and a member of Glenview Golf Club, Chicago Athletic Association, Chicago Racquet, Tavern, Onwentsia, Casino and Saddle and Cycle Clubs.

Corley's policies and rulings as a Field executive are said by his admiring associates to rank him as a living embodiment of the far-famed Field traditions of honorable merchandising at its best.

Phi Alpha Delta is proud to number Frederick Dexter Corley among its members, and we sincerely believe that the career of Corley may well serve as an unfailing inspiration to the youth of our great nation.

#### For Re-Election

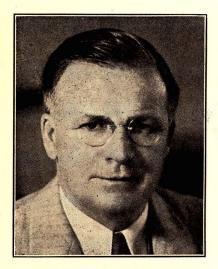

Brother Gray was appointed Judge in August, 1926 by former Governor Gifford Pinchot and was elected in November, 1927, for a ten year term which expires at the end of this year. He is a candidate for the Republican, Democratic and Independent nominations at the primary election on September 14th and will be a candidate for re-election at the general election on November 2nd.

#### Possible Candidate

The name of Brother J. F. T. O'Connor, Controller of the Currency, a Past Supreme Justice of Phi Alpha Delta, and prominent in the fraternity's activities over many years, is being more and more frequently mentioned as a suitable candidate for the office of Governor of the State of California.

Although a former partner of Senator McAdoo, Jefty, as he is affectionately called by his brothers, is not aligned with any particular Democratic faction in California, being regarded as strictly an administration man. His broad experience in law and his excellent record as a public servant seem to make him ideally fitted for this most important office. Jefty has not announced himself as a candidate but his many friends in California are insisting that he enter the race. When interviewed on the subject, he said:

"The consideration of any individual

is always secondary to the interests of a great state. California has more complicated problems probably than any other state in the union; and it has the greatest future. Its agriculture, its citrus crops, its ranches, its oil, its manufacturing interests, its shipping, its great motion picture industry, and many other kindred problems are a challenge to the highest and best in the individual who is called upon to assist in solving its complex problems. I am not sure that I am the proper person. I have never indicated that I would be a candidate, directly or indirectly. I felt that these matters should largely be determined by the people of the state. For four years I have held a rather important office in Washington, but the glamour fades when the seriousness of the problems to be solved confronts one.

No one could be insensible to even the suggestion of being worthy of such a great honor, and I regret that I cannot be more definite on the subject at this time."

# To Court of Appeals

ALBERT LEE STEPHENS (Ross) formerly Los Angeles city attorney and county and state judge and now United States district judge, was nominated by President Roosevelt for one of the two new judicial places created by Congress for the Ninth United States Court of Appeals, which sits in the seven western states, including Montana and Arizona.

Judge Stephens whose elevation was recommended by Senator W. G. Mc-Adoo, is 62 years old. He was a Superior Court judge for 13 years, and for the past two years has been on the United States district bench. When appointed to the District Court he was presiding justice of the State Court of Appeals.

Although much of the business of the United States Court of Appeals originates in Southern California, Judge Stephens is the only judge from that part of the state on the bench.

Congress recently increased the size of the bench from five to seven places.

Judge Stephens, while not surprised at the appointment, because of Senator McAdoo's action, said he was none the less gratified.

"It is, of course, a pleasure to receive such proof of trust and confidence," he said. "I shall accept it as a commission carrying grave responsibility, and shall regard it as a duty requiring great and continual labor."

# Supreme Secretary Forms New Law Partnership

#### Our Political Mirror

F. RYAN DUFFY (Ryan), of Fond du Lac, Wisconsin, is expected to be candidate for renomination as United States Senator on the Democratic ticket next year. He is now serving his first term and is a member of the Committees on Appropriations, Foreign Relations, Interoceanic Canals, Patents, and Privileges and Elections. Brother Duffy was born at Fond du Lac on June 23, 1883. He was educated in the public schools and graduated from the College of Letters and Science of the University of Wisconsin in 1910 and the College of Law in 1912. Since then he has practiced law continuously at Fond du Lac except for twenty-five months service in the United States Army during the World War. He is married to Louise Haydon, of Springfield, Kentucky, and they have four children. On November 8, 1932 he was elected as United States Senator, receiving 610,236 votes, and defeating John B. Chapple, Republican who received 387,668 votes. He recently accompanied James A. Farley, Postmaster General and Chairman of the Democratic National Committee, on a trip across Wisconsin. Mr. Farley promised him his active support in the campaign next year. Brother Duffy has also been prominently mentioned for appointment as Judge of the United States Circuit Court of Appeals for the Seventh Circuit to fill a vacancy.

ORLAND S. LOOMIS (Ryan), of Mauston, Wisconsin, and RALPH M. IMMELL (Ryan), of Madison, Wisconsin, have been mentioned recently as candidates for nomination as United States Senator on the Progressive ticket. Brother Loomis is Attorney General at Madison, having been elected last November and Brother Immell is Adjutant General of the Wisconsin National Guard.

MILLARD E. TYDINGS (Jay), of Havre de Grace, Maryland, is also expected to be candidate for renomination as United States Senator on the Democratic ticket. He is now serving his second term and is Chairman of the Committee on Territories and Insular Affairs, and a member of the Committees on Appropriations. Audit and Control of the Contingent Expenses of the Senate, District of Columbia, Naval Affairs, and Public Buildings and Grounds. Brother Tydings was born at Havre de Grace on April 6, 1890. He graduated from the University of Maryland in mechanical drawing and also studied law there. In 1913 he was admitted to the bar. He enlisted in the United States Army on April 6, 1917 and served until June 1, 1919, being promoted through the ranks to Lieutenant Colonel and received the Distinguished Service Medal and Distinguished Service Cross. He is a former Speaker of the House of Delegates of Maryland, State Senator and was elected to the Sixty-eighth and Sixtyninth Congresses. In 1926 he was elected to the United States Senate and was re-elected in 1932. Brother Tydings had a prominent, part in the defeat of the proposed Bill to en 3 large the Supreme Court of the United States. He voted to recommit the bill. Later he was paired against the confirmation of Hugo L. Black as an Associate Justice of the Supreme Court.

SCOTT W. LUCAS (Capen), of Havana, Illinois, is being prominently mentioned as a candidate for nomination as United States Senator on the Democratic ticket. He is now serving his second term as Representative in Congress from the 20th Congressional District, having succeeded the late Speaker Henry T. Rainey. Brother Lucas was born at Chandlerville, Illinois, on February 19, 1892. He

attended the public schools and graduated from Illinois Wesleyan University in 1914 with an LL. B. degree. The following year he was admitted to the bar and in 1920 was elected States Attorney of Mason County. He has been active in the American Legion, having served as Department Commander in 1926. The following year he was selected as National Judge Advocate at the Paris Convention and served four years. In January 1933 he was appointed as Chairman of the Illinois Tax Commission by Governor Henry Horner and served until his election to Congress. Brother Lucas entered the United States Army as a private during the World War and was honorably discharged with the rank of Lieutenant. He served continuously in the Officers Reserve Corps from the close of the war until August 1934 when he was appointed Judge Advocate General of the Illinois National Guard with the rank of Colonel. He was married to Edith Biggs, of Havana, in January 1923, and they have one son, Scott W. Jr. The present incumbent, William H. Dieterich, of Beardstown, is expected to be a candidate for renomination on his record of wholehearted support of the Roosevelt administration. Brother Lucas vigorously opposed the proposed Bill to enlarge the Supreme Court and urged the American Legion to take a similar stand. He made his first speech since the adjournment of Congress at Florence, Illinois, on Labor Day at a big fish fry sponsored by the Democratic organizations of Pike and Scott Counties.

BROOKS HAYS (Jay), of Little Rock, Arkansas, was prominently mentioned for appointment as United States Senator to succeed the late Majority Leader Joseph T. Robinson in July. It was decided, however, not to fill the vacancy by appointment and the Democratic State Central Committee nominated Governor Carl E. Bailey. Brother Hays is an attorney for the Resettlement Administration and is also Democratic National Committeeman for Arkansas.

James P. Aylward (Benton), of Kansas City, Missouri, urged Harry S. Truman, junior United States Senator from Missouri, last July to support Alben W. Barkley for Majority Leader of the Senate to succeed the late Joseph T. Robinson. Senator Barkley won by one vote. Brother Aylward is Democratic National Committeeman for Missouri.

JOHN T. M. HAMILTON (Fuller), of Topeka, Kansas, Chairman of the Republican National Committee, has addressed numerous meetings in recent months. He met with some of the members of the Committee at Washington, D. C. recently and is now mak-

ing plans for the campaign next Spring. It is reported, however, that he expects to resign his \$25,000 post shortly to resume the private practice of law. At the close of the recent session of Congress Brother Hamilton praised the Republican members of Congress for their united opposition of the "Court Packing" Bill. The committee is scheduled to meet in October. The office of the Committee is now located at 718 Jackson Place, N. W. in Washington, D. C.

Teller Ammons (Hughes), of Denver, Colorado, is expected to be a candidate for renomination as Governor of the State of Colorado on the Democratic ticket at the primary election next August. He is now serving his first term and is making a good record. Brother Ammons served in the United States Army during the World War and is a member of the American Legion. Prior to his election last year he was engaged in the practice of law in Denver. He has served as City Attorney and State Senator.

HOMER S. CUMMINGS (Calhoun), of Washington, D. C., Attorney General of the United States made the first of a series of broadcasts on the 14th of last February which were designed to rally the country to the support of the proposal of President Roosevelt to pack the Supreme Court. He advanced two major reasons: (1) New blood should be injected into the judiciary in order that the constitution is continued in keeping with the changing needs produced by new complexities of national life. (2) The congestion of dockets in the Federal Courts was largely due to the inability of aged and infirm judges to perform their share of the work. A rising tide of public opinion, however, forced an abandonment of the proposal in the United States Senate.

J. WARREN MADDEN (Marshall), of Pittsburg, Pennsylvania, and Chairman of the National Labor Relations Board, was prominently mentioned last May for appointment as an Associate Justice of the Supreme Court of the United States. Prior to his appointment as Chairman in 1935, he had served as a member of the faculty of the School of Law of the University of Pittsburg since 1927. He had also been a member of the faculty of the University of Oklahoma, 1914-Ohio State University, 1917-21; and Dean of the College of Law of University of West Virginia, 1921-27. To the position of Chairman, he also brought a wide experience on important Commissions in Pennsylvania. On Labor Day Brother Madden discussed the National Labor Relations Act over the radio from Washington. He is forty-seven years of age.

WILLIAM O. DOUGLAS (Livingston), of New Haven, Connecticut, and Washington, D. C., a member of the Securities and Exchange Commission, was also prominently mentioned for appointment as an Associate Justice of the Supreme Court. He was born at Maine, Minnesota, on October 16, 1898. He attended the public schools in Yakima, Washington, and graduated from Whitman College at Walla Walla, Washington, in 1920. Following this he entered the School of Law of Columbia University, was Editor of the Columbia Law Review, 1924-25, and graduated with an LL. B. degree in 1925. The following year he was admitted to practice in New York and was associated with the law firm of Cravath, DeGersdorff, Swaine, and Wood, 1925-27. He also served as a lecturer in the School of Law of Columbia University. From 1927-28 he was an Assistant Professor. He next served as an Assistant Professor in the School of Law of Yale University, 1928-29; Associate Professor, 1929-31 and Professor 1931 until 1935 when he was called to Washington to direct an investigation of Bondholders Protective Committees and Reorganizations for the Commission. Following this, on January 16, 1936 he was appointed as a member of the Securities and Exchange Commission by President Roosevelt. It is now expected that he will be appointed Chairman of the Commission to succeed James M. Landis, who retired the first of September to become Dean of the Law School of Harvard University. As a result thereof, Wall Street is preparing for a real honest-to-goodness application of the Securities Exchange Act. Brother Douglas has shown that he is in earnest by his brilliant investigation of reorganizations and by his approaches to various problems since he was made head of the Trading Division of the Commission. The two subjects that Wall Street is most afraid of is the right of brokers to trade, included in what is generally called the problem of segregation and the right of specialists to trade for themselves. This is the real heart of the Wall Street speculative problem. Of course, the subject of margins is also essential, but this is in the hands of the Federal Reserve Board. Landis persistently refused to deal with the segregation problem. When his Economic Division made a study, he refused to afford it necessary When they brought in a report in favor of segregation, Landis rejected it and turned it over to another group which knew well in advance what it was supposed to report. It reported a mild criticism of the practices involved and some trivial regulations. Wall Street believes that Douglas will

get to the bottom of this subject. This business involves the right of brokers who handle customers accounts to speculate for their own accounts. It also takes in the right of brokers to run investment trusts and act as investment bankers. The Committee on Banking of the United States Senate has severely condemned both these practices. There is a general belief that if segregation ever took place, there would be an end of Wall Street as a gambling center and that it would become a real market for stocks, and not a great sports Casino. Anyhow, Wall Street is preparing for the worst. It is reported that the Stock brokers fear his intense liberalism and would like a more Conservative Chairman. His selection as Chairman, however, will insure a vigorous prosecution of the stock market "clean up" policies instituted by Joseph P. Kennedy and carried on by Landis.

Brother Douglas has had the sort of life about which Horatio Alger might have written. Newsboy, janitor and farm-hand, he worked his way through college at Walla Walla, emerging as a Phi Beta Kappa. He toured the East by cattle trains, reaching New York with a capital of six cents. In 1935 when he was called to Washington to make a study of 200,000 Bondholders Protective Committees, he was Professor of Commercial and Corporate Law at Yale, receiving one of the largest salaries paid any college professor. This work completed, he was selected by President Roosevelt as a member of the Commission and may soon be Chairman. In addition, he is destined for further advancement.

JOHN H. SEARING (Magruder), of Carbondale, Illinois, attended a meeting of the Republican State Central Committee at Springfield on the 18th of August. He represents the 25th Congressional District and is a former Chairman of the Committee. He also attended a Republican luncheon at the Abraham Lincoln Hotel which was addressed by Franklin J. Stransky, of Savanna, father of Franklin U. Stransky (Campbell), former States Attorney of Carroll County and now Representative in the General Assembly from the 12th Senatorial District. It was suggested at this meeting that an advisory state convention be held before the primary election next April for the purpose of selecting an organization ticket and this proposal received some support.

JOHN T. DEMPSEY (Fuller), of Chicago, Illinois, and CHARLES W. HADLEY (Fuller), of Wheaton, Illinois, were among the prominent Republicans that attended the Republican picnic at Riverview Park in Chicago

on Labor Day, the 6th of September. Brother Dempsey was a Republican candidate for Representative in Congress from the State at Large last year and Brother Hadley was the Republican candidate for Attorney General. Both were defeated, however, in the Democratic landslide.

JOHN J. SPARKMAN (Morgan), of Huntsville, Alabama, is expected to be a candidate for renomination as Representative in Congress from the 8th Congressional District on the Democratic ticket. He is now serving his first term and is a member of the Committees on Accounts, Civil Service, Immigration and Naturalization, and Roads. Practically all of his colleagues from Alabama are candidates for the vacancy caused by the resignation of Hugo L. Black as United States Senator. Upon his election to Congress last year, he retired as a member of the law firm of Taylor, Richardson, & Sparkman in order to give his entire time to his Congressional duties.

MRS. HATTIE W. CARAWAY, of Jonesboro, Arkansas, is expected to be a candidate for renomination as United States Senator on the Democratic ticket next year. She is the widow of the late Thaddens H. Caraway (Jay), who was one of the most brilliant members of the Senate. Mrs. Caraway was appointed on November 13, 1931 and elected on January 12, 1932, to fill the vacancy caused by the death of her husband, and was re-elected on November 8, 1932 for the term ending in 1939. George Creel had a most interesting article concerning Mrs. Caraway in the issue of Collier's for the 18th of September. It was entitled "The Woman Who Holds Her Tongue."

LEON A. ZICK (Fuller), of Oregon, Illinois, is being prominently mentioned for the Republican nomination as Judge of the Circuit Court of the 15th Judicial Circuit to succeed the late William J. Emerson, of Oregon. Brother Zick is County Judge of Ogle County. The judicial convention will be held in October and the election in December.

HASLETT P. BURKE (Gunter), of Denver, Colorado, is expected to be a candidate for renomination as Justice of the Supreme Court of Colorado on the Republican ticket next August. He is now serving as Chief Justice, having assumed this post last January and will serve two years. He has been a Justice for nineteen years and is the only Republican on the Court. Brother Burke spent July and August at his cottage in Estes Park. He is the oldest member of the court in point of service and has made an able record.

He should be returned without opposition. The writer has been acquainted with him for many years and had a pleasant visit with him the last of August.

WILLIAM E. BORAH (Knox), of Boise, Idaho, senior United States Senator from Idaho, believes that the last session of Congress is one of the most important that has ever been held. "History will look upon the first session of the Seventy-fifth Congress as one of great importance-not because of what it did, but because of what it did not do,' he said. "One other session of similar importance comes to mind. That was when President Wilson's League of Nations plan was defeated, another instance when the importance of the session lay in omission rather than commission. It is difficult perhaps to realize the importance of this session but I think that historians will look back on it as of great importance because of the court bill fight. There have, of course, been other important and interesting sessions. The wartime Congresses are one example, and I suppose that many persons would say that the 1933 session, when the present administration was putting its recovery plans into effect, was one of the most important. 1937 session, which had a great deal of proposed legislation shoved toward it and which did very little, was nevertheless responsible for preventing enlargement of the Supreme Court. In addition, I think it was probably for the best that the wages and hours bill was not enacted. The measure was written under pressure in the Senate Education and Labor Committee. It is impossible to draw up a good measure in that way and I think that failure to enact it at the last session may result in a better bill."

His view of the importance of the court bill and League of Nations Conflicts may have been influenced by his participation in both. He was the tenacious center of the battle against President Woodrow Wilson (Jefferson) and, despite the general silence of the Republicans during the recent Court battle, it was the Idaho Senator that Democratic opponents of the measure turned to frequently for advice and assistance.

Brother Borah remains in the Capitol long after most of the members of Congress have dashed for home or on foreign junkets. He is now engaged in writing a new federal incorporation act for the next session of Congress. Joseph C. O'Mahoney, of Cheyenne, Senior United States Senator from Wyoming, is going to collaborate with him. Under the proposed measure any corporation doing interstate business would have to obtain a charter from the United States, instead of

operating, as at present, under a state charter. It is said that this legislation would break up monopoly.

On the second of September Brother Borah said at Washington that he believed that the Senate would go on record against a presidential third term-provided the issue reached a vote. The Dean of the Senate expressed this view after hearing that Rush D. Holt, junior United States Senator from West Virginia, would submit the same anti-third term resolution which the Senate approved nine years ago and the House adopted in 1875. Brother Borah voted for it in 1928 when Calvin Coolidge was in the White House, and said "I have not changed my mind." ever, he joined Millard E. Tydings (Jay), senior United States Senator from Maryland, in voicing skepticism that President Roosevelt desired renomination in 1940, adding that "I doubt the third term will be a vital issue."

ALFRED C. LOCKWOOD (Knox), of Phoenix, Arizona, was re-elected as an Associate Justice of the Supreme Court of Arizona for a six year term last November. He served as Chief Justice last year. Henry D. Ross (Knox), is also an Associate Justice of the Supreme Court of this state.

HOMER S. CUMMINGS (Calhoun), of Stamford, Connecticut, and Washington, D. C.; CLYDE R. CHAPMAN (Hamlin), of Augusta, Maine; and OWEN CUNNINGHAM (Cole), of Des Moines, Iowa, members of the House of Delegates, are expected to participate in its sessions. Brother Cummings is Attorney Gen-

eral of the United States; Brother Chapman is President of the National Association of Attorneys General; and Brother Cunningham is one of the Assembly delegates.

GUY T. HELVERING (Campbell), of Salina, Kansas, and Washington, D. C., Commissioner of the Bureau of Internal Revenue, will submit a statement as to Experiments in Decentralizing Final Determinations of Income Tax, now being conducted in the Cleveland, Dallas and San Francisco Districts, at a meeting of the Committee on Federal Taxation which will be held in the Trianon Room in the Hotel Muehlback on Tuesday, the 28th at 2:00 P. M.

George E. Beechwood (Taft), of Philadelphia, Pennsylvania, will read a paper on "The Recent Miller Act" at a round table conference on Fidelity and Surety Insurance Law which will be held in Room 301 in the Municipal Auditorium on Tuesday, the 28th, at 2:00 P. M. The meeting was arranged by the Section of Insurance Law.

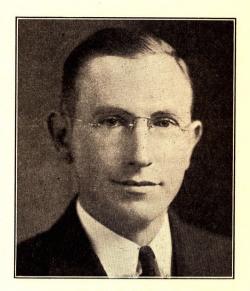

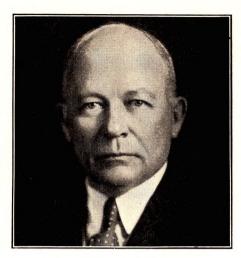
# In Public Service

Early legal education in the United States took the form of apprentice training. This brought the student into contact with traditions, but it came to be realized ultimately that the best type of the theoretical training did not come from this method. The pendulum then swung to the other extreme and legal education became university education. This method afforded the maximum in theoretical instruction-certainly the most important branch—but at the outset it more or less effectively removed the student from any direct contact with law administration and the practical affairs of practice. It strikes me that it is not necessary to lose one or the other of these values-and it is certainly harmful to do so. Tulane has always sought a balance, and new efforts in this direction will certainly be made in the future."

The new Dean is one of the most popular members of the faculty and his appointment was well received by the students.

The Memorial commemorates the victory of the American First Army in the Meuse-Argonne offensive. The dedication was the first of a series which extended over the following two weeks consecrating memorials at the important scenes of American activity. The work of preparing and erecting these monuments was accomplished by the Commission. The actual dedication at Montfaucon consisted of hoisting the American flag to the top of the tall granite column in the

presence of 10,000 people. In his Address General Pershing said that the Meuse-Argonne campaign, in which 1,000,000 Americans participated, was "fiercer and more heartbreaking" than any other World War battle except Verdun. "It is memories such as these that make civilized soldiers hate war, and they do hate it" he said. "The last conflict brought no profit to any one, but left many questions unsettled. But they cannot be settled by war. Yet the prospects for peace do not look promising. Hatred and suspicion still exist and armaments at enormous cost continue to grow. And if no cure is discovered for this temporary madness we are in a hopeless state, for of one thing we may be certain and that is, if another war takes place western civilization, as we know it, cannot survive." Brother Pershing is still in France and on the 13th of September celebrated his seventy-seventh birthday anniversary. He was elected as a member of the Academy of Moral and Political Sciences at Paris on the 22nd of last February. It is expected that he will spend the winter at Tucson, Arizona, as has been his custom in recent years.

FRANK W. HALLIDAY (Hamlin), of Washington, D. C., is now Chief of the Military Justice Section of the office of the Judge Advocate General of the United States Army with offices in the Otis Building. He was formerly Chief of the Patent Section. Brother Halliday is a Lieutenant Colonel and resides at 1342 Somerset Place.

Declaring "we live in a world organized for war," he said, "America did not reveal a constructive approach to the peace problem. We run from responsibility. Our peace movement is usually negative; it is supported by to keep-us-out-of-war sentiment: it is grounded in the belief that we can live at peace in a world at war, and in the concept that we are a more peaceful people than other people who lack our geographical advantage." Brother Culbertson is a former Ambassador to Chile and has had a wide experience in public service.

# In Memorium

WILLIAM A. JOHNSTON (Green), of Topeka, Kansas, former Chief Justice of the Supreme Court of Kansas, died on January 23, 1937, after a long illness. He resigned in the summer of 1935, after having served continuously as a member of the Court for more than fifty years. He was 88 years old and had served longer than any Judge in the World. In addition, he had served as a member of the House of Representatives of Kansas, State Senate, as Assistant United States Attorney and Attorney General. He was an able judge and made a record that will live through the ages.

Andrew J. Montague (Jefferson), of Richmond, Virginia, Representative in Congress from the Third Congressional District, died at his home in Urbana on January 24, 1937. He had had a wide experience in public service, having served as United States Attorney for the Western District of Virginia, Attorney General, 1898-1902, and Governor of Virginia, 1902-1906. Brother Montague was the ranking member of the Committee on the Judiciary, and was serving his thirteenth term

in Congress. He was one of the most distinguished members of the House of Representatives.

FRED H. DAVIS (Fletcher), of Tallahassee, Florida, a Justice of the Supreme Court of Florida, died on June 20, 1937, at the age of forty-three. He was appointed to the Supreme Court in 1930 and served as Chief Justice one term, at which time he was the youngest Chief Justice in the United States.
