Supreme Justice Page

Dear Brothers:

This will be my last opportunity to speak to you through this medium until next Fall. I have enjoyed these brief talks with you and hope that I have succeeded in leaving with you some helpful

thoughts.

As I talk with others and read some of the material which is ground out daily I am convinced that one of the greatest needs of today is tolerance. In a world which is becoming increasingly intolerant of the rights of smaller and weaker people and in which subversive minorities are loudly preaching the doctrine of hate and spreading poisonous propaganda, it is fitting that the mem-



bers of our Fraternity, in whom has been ingrained the love of one's brother, should take the lead in opposing this intolerance of the rights of others which aims to destroy democracy at home and abroad.

Intolerance, the refusal to permit opposing beliefs, is a form of bigotry that must be stamped out if our democratic form of government is to live. Refusal to forbear in the judging of the acts and opinions of others is prevalent in many groups and is generally more insidious and of greater danger in those groups which declare to the world that their object is to promote tolerance and protect civilliberties.

What can we do to eliminate or, at least, decrease this feeling of intolerance which is sweeping the country? We can preach tolerance! We can point out that toleration is merely the recognition of the rights of individuals to their own opinions and practices when they do not interfere with the rights of others or with decency and order. Our forefathers fought to establish tolerance in this country. We have this heritage now! Why should we not fight for it? Eternal vigilance is the price of liberty and unless you are willing to protect those hardearned rights you may shortly find yourself without them. The unrest and dissatisfaction currently present among all kinds of people can be kindled into a real conflagration by some crackpot who, with little sense or respect for his inherited rights, is willing to sacrifice them in an effort to bring about a change, no matter how harmful.

As men about to become members of the legal profession it is your duty to protect the public from these rabble-rousers and the chaos which would follow if they were successful. Teach by your example.

Attorney General Robert Houghwout Jackson

Six years ago a comparatively unknown lawyer from Jamestown, New York, left for Washington to become General Counsel for the Bureau of Internal Revenue. Promising himself and his upstate clients he would return in less than a year, he arrived in Washington, more than a little bewildered by the size and complexity of the govermnent machine. Six years later, despite his original intention, that upstate lawyer was still in Washington, but no longer confused or bewildered, for in that relatively short space of time Robert H. Jackson had risen to the eminently high post of Attorney General of the United States.

When he was asked to come to Washington as General Counsel for the Bureau of Internal Revenue he was living with his wife and two children in a comfortable home in Jamestown, where horse-back riding and sailboating were his hobbies. He left this quiet, although not provincial existence to step into the New Deal whirlpool in March, 1934.

Soon after his arrival in Washington, he went to work preparing the income tax case against that most powerful of economic royalists, Andrew Mellon, and Bob Jackson contended in open court against some of the best legal brains in the country. One day when irked by the tactics of the defense, he said "It is Mr. Mellon's credo that \$200,000,000 can do no wrong. Our offense consists in doubting it."

Bob Jackson's victory in this case, in which he recovered \$750,000 from the ex-Secretary of the Treasury, and ex-Ambassador to the Court of St. Jame's, was obscured by Mr. Mellon's gift of his art treasures to the Government.

Born at Spring Creek, Pennsylvania, in 1892, Bob Jackson moved to Jamestown, New York, when he was about ten years old, and his boyhood was divided between farm life and attending the public schools. While still very young, he decided he wanted to become a lawyer but was much too ambitious and impatient to spend the required four years in college when in only two years at the Albany Law School he could learn all he needed to pass the bar examinations. He entered, and passed the course in one year.

As a result of this, the school refused to give him his degree, so in order to take his first case he had to obtain special permission of the court. In this regard Bob Jackson has been a very unique figure among the New Deal lawvers, many of whom are college professors carrying imposing degrees, and practically all of whom are Harvard, Yale or Columbia graduates. However, he is regarded among the government's lawyers as a most experienced and resourceful strategist, and younger lawyers from all branches of the service take their practical problems to him for solution, for he has proven himself one of the best legalists in a lawyer-ridden New Deal.

After serving as General Counsel for the Bureau of Internal Revenue and Special Counsel for the Securities and Exchange Commission, Brother Jackson became head of the Tax Division of the Department of Justice, as Assistant Attorney General. The Unemployment Compensation Law and the Old Age Benefits Act, as well as other New Deal statutes were his responsibility, and these were attacked from all sides. Bob Jack-

son went into district courts and circuit courts of appeals and fought side by side with the trial lawyers of his division, eventually being rewarded with successful decisions from the Supreme Court.

As head of the Anti-Trust Division, he was in the field repeatedly, battling with his staff in the lower courts in anti-trust cases, and in defense of the milk marketing orders of the Secretary of Agriculture. This he carried through to a successful termination in the Supreme Court, but nearly two years after his appointment as Solicitor General.

Only once before, since the office of Solicitor General was created seventy years ago, has a holder of that office become Attorney General. This was in the case of William D. Mitchell, who was appointed Solicitor General in 1925, and Attorney General in 1929. But not in many years, if ever, has a man come to the head of the Department of Justice who has had such extensive experience in its work.

In the Supreme Court, where he has repeatedly challenged old precedents and urged the Court to overrule itself, his sucesses have been largely due to the careful preparation and lawyerlike presentation of his cases. Justice Justin Miller, of the Court of Appeals of the District of Columbia, in introducing Mr. Jackson at the recent dinner of the Federal Bar Association of Washington, said of him:

"As an Advocate, Mr. Jackson is so admirably poised, so disarmingly frank, so unpretentiously democratic, that the cocksure and unwary adversary may be lulled into a false sense of security and then, suddenly, left gasping from a penetrating thrust, which strips the hokum from an argument and ruthlessly exposes its invalidity."

But more important than his many

victories and his few defeats in the courts has been his concurrent development of a philosophy, deeply imbedded in the traditions of democracy. Because he has discovered no reason to disbelieve in the present system of political democracy, he has sought means for its survival. This, he believes, has been the purpose of the New Deal, and all his many attacks on Big Business have been directed to this purpose. In simple terms, he believes in the necessity of the profit system to keep our inherited system of private enterprise going, and the government's duty is to keep the system in working order.

But this must never be done at the expense of a political democracy, any more than Government should settle its policies in terms of economics alone. Economics and politics are inseparable, but when politics cease to function as a conditioner of economics, then the system fails, and the people may be expected to seek a substitute that will presumably work to their distinct advantage.

Bob Jackson once stated the essence of his philosophy when he said, "Any system, to survive, must feed its people."

Many feel that given the right support his extraordinary talents, his delightful personality, his flexible philosophy and his dependable integrity may yet be counted among the most valuable political assets in the New Deal's impending struggle for selfpreservation. When the President, in one of his whimsical moods, suggested there must be a dozen charming young men quite willing to carry the New Deal banner after 1940, every Washington columnist at once placed Bob Jackson's name near the top of the list, and some political prophets have even gone so far as to say that he is the personal, if not the political choice of Mr. Roose-

velt himself as his successor to the great white throne.

But whatever Bob Jackson's political future may be, his past is secure, and with little formal education he has gone far in a meticulous profession for he has used his native talents well. His family background perhaps has had much to do with this and there is little doubt but that Bob Jackson's life has been greatly colored by his greatgrandfather, old Elijah Jackson, a crusty frontiersman, farmer and rural democrat. He was a stout follower of Andrew Jackson who, in Bob Jackson's words, was the first "American political leader to seek his political support among all the people." Old Elijah Jackson, in a hotbed of Federalists, was a member of one of those Democratic Clubs formed in his time to support the principles for which the French Revolution was fought. Elijah's son, Bob Jackson's grandfather, was so deeply dyed a Democrat that even the Civil War coudn't wean him from his county. Jonathan Mitchell wrote in The New Republic, "To have a family that glories in belonging to a hopeless political minority is something no child could ignore. One of the possible consequences would be to make the child contemptuous of what is elegantly called the climate of opinion."

Bob Jackson's family background made him a political Democrat in a predominantly Republic stronghold, thus teaching him the ways of independence and also instilling in him a deep sense of justice. He has no patience with stupidity. He has a gracious sense of humor; and a biting wit. He does his own thinking; but he knows how to get help. He does his own writing; but he takes the telling phrase where he finds it. He is independent; but not foolhardy. A trained lawyer, he knows the value of precedent and the need for preparedness. A self-made philosopher, he is continually seeking to temper his pragmatism. A politician by chance, he is primarily a democrat . . . and a Democrat well worth watching in the coming primaries.

Brewer Chapter Celebrates 25th Anniversary

Twenty-five years of success was the key note of the anniversary celebration of the David J. Brewer Chapter of PAD on April 6th, and festivities took place on that date at Stetson University in conjunction with the program for the second annual Law School Day.

On Saturday morning several prominent members of the Florida Bar were initiated into honorary membership, and outstanding among these was Justice Armstead Brown of the Florida Supreme Court. Also J. P. Simmons, one of the best known attorneys in the State, who was initiated as an active member.

The highlight and climax of the morning's celebration was the luncheon held at the University Commons. Speakers on the program included E. Harris Drew, West Palm Beach; Hon. Millard D. Smith, Titusville; John D. Harris, St. Petersburg; and Erskine W. Landis

of Deland. All of these speakers are graduates of Stetson University.

There were a great number of charter members also in attendance at the celebration, these included Hon. David Scholtz, Lewis H. Tribble, Justice Elwyn H. Thomas, A. O. Kanner, Handen H. Baskin, William P. Dineen, Ray M. Griffin, Charles P. Phillips, William J. Steed and Howard P. Steward. Silver keys were presented to the charter members to express the appreciation of Brewer Chapter for their continued work and interest.

Following the luncheon, everyone attended the Senior Law Club Argument of the Stetson University Law School. This argument is given by the four seniors who have been successful during their three years in the Law School in winning over all competition. Those participating this year were all Phi Alpha Delta brothers, namely, Hal

Dekle and Thomas Kirkland vs. Harry Newett and John Cherry. Hon. Armstead Brown, Hon. Elwyn Thomas and Attorney General George Couper Biggs acted as judges pro tempore in hearing the case which was entitled, "Coast to Gulf Construction Corp. v. Lon Murcock, et al. This was a case involving the right of a union to induce a contractor's employees to join the union in violation of a "Yellow Dog" contract, and then strike and picket against their employer because of his refusal to cease purchasing non-union building materials. After due deliberation the acting judges awarded the devision to Brothers Dekle and Kirkland.

Another interesting event held in conjunction with Law School Day was a discussion of the Wage-Hour Law given by Hon. George A. McNulty, General Counsel of the Wage-Hour Division of the Department of Labor the title of his talk being "Administrative Process Under the Fair Labor Standard Act." Following his address a discussion of the subject took place between Hon. Counts Johnson, General Counsel of the Florida Citrus Exchange, and Hon. M. L. Fleishel, President of the Putnam Lumber Company.

At 6:30 on the University Commons a "Barrister's Banquet" was held. The menu was chosen with great care and was one of the most delectable dinners ever enjoyed at a celebration of this kind.

In the evening Law Club prizes were awarded, and this was followed by a number of very interesting discussions by members of the Five Minute Club of the Florida legal fraternity.

This Silver Anniversary of Brewer Chapter calls to mind another celebration that took place in 1915 when the chapter was founded. The festivities attendant upon the occasion occupied three days, and the faculty, student body and local townspeople contributed toward making the installation a red-letter day in university annals.

ARMSTEAD BROWN

Armstead Brown, newly initiated into honorary membership in Brewer Chapter, was born in Talbotton, Georgia, in 1875, and attended school only until the age of fourteen when he left to earn his living. In 1897 he was admitted to the bar in La Fayetts, after studying law in the office of J. R. Dowdell, and in 1905 entered practice in that city.

Appointed Associate Judge of the City Court of Montgomery, Montgomery County's highest trial court, in 1909, he was elected the next year for a term extending to 1917. Before his term expired he was appointed General Solicitor of the Florida East Coast Railway Company and associated corporation, and in 1915 removed to Jacksonville, Florida.

Entering the general practice of law in Miami, Florida, in 1917, he practiced there until 1925, when he was appointed Justice of the Supreme Court of Florida, of which court he became Chief Justice in 1925, and served in that capacity until the end of his appointed term. Brother Brown was elected in 1926 to the full six-year term, and has been renominated and re-elected since that time without opposition. He was elected President of the Miami Bar Association in January, 1922, and a few months later was also elected President of the Florida State Bar Association.

This distinguished jurist is royally welcomed into Phi Alpha Delta, and the entire fraternity is honored to call him a brother.

Brewer Chapter was formally installed by Supreme Recorder Conger G. Roads on Saturday evening, April 3, 1915. The petitioning body numbered ten active men and four honorary members. The charter members of Brewer chapter were: Hamden H. Baskin, William P. Dineen, A. O. Kanner, Ray M. Griffin, Charles P. Phillips, David Sholtz, William J. Steed, Howard P. Stewart, Elwyn Thomas, Lewis H. Tribble and Judge J. W. Perkins, Judge Bert Fish, Ex-Governor W. S. Jennings and Honorable Cary D. Landis, Honorary members.

Tri Delta gave an informal tea on Friday afternoon to the members of the new chapter; Sigma Nu was at home to them on Saturday morning; Dr. Lincoln Hulley, then president of the university, held a reception in their honor on Saturday afternoon. The initiation proper took place Saturday evening, followed by a banquet at the Lexington later in the evening. Phi Beta Phi entertained at a breakfast on Sunday morning, and in the afternoon open house was held at the Scholtz home in Daytona Beach.

Early correspondence reveals that David Sholtz, transfer from Yale, Calhoun Chapter, was instrumental in the securing of David Brewer Chapter's charter. The same correspondence shows there was some objection to its granting based upon the future possibilities of the chapter, but with the exception of the years around 1933 when the depression descended, Brewer Chapter thrived and its influence has grown to encompass the whole state. The faith of the founders has been well justified.

TWENTY-FIVE YEARS AGO

In the preceding article (February, 1940), there was published a picture taken at the fourth convention of the Fraternity held in 1903 at Pistakee Bay, Fox Lake, Illinois, with the statement that the picture showed four members who became Supreme Justices of the Fraternity and that this article would give their names. For the convenience of

the reader, the picture is shown again with this article, on the next page.

First row (left to right), the fifth man (sans coat) is Paul C. Meier (Story), Supreme Justice 1905-06.

First row (left to right), the eighth man shown (fourth from right) is Rolland M. Hollock (Fuller), Supreme Justice 1902-03.

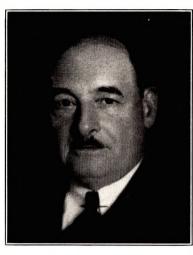
First row (left to right), tenth man (second from right) is Thomas P. Octigan (Blackstone), Chief Justice 1906-07.

It would seem that "in the late 90's" and for a period of ten or fifteen years following, the "taking" of group and individual pictures was a practice more frequently indulged in than has since been the case. Such pictures have become more interesting, not to say valuable, with the march of time, and if those members of the Fraternity who have preserved such pictures would loan them to the Editor of the Reporter, many interesting events in the early history of the Fraternity would be brought to light. Such pictures would, however, be more interesting to those who were then actively participating than those who are carrying on today. The writer, however, laments the passing of the practice, and urges the more frequent use of the candid camera.

Twenty-five years ago this year, March 12, 1915, to be exact, two new chapters were added to the roll of the



Fraternity. The first of these chapters was Manoch B. Reese at the Law Department of the University of Nebraska, Lincoln, Nebraska. Supreme Justice Edgar A. Jonas was the installing officer. The Charter Members were fourteen in number and their names were as follows: Benjamin C. Hopewell, P. Tracy Kohl, Harvey W. Hess, Guy T. Tou Velle, Chas. H. Epperson, Arthur Balis, Hugh Agor, J. E. Jacobson, Marcus L. Poteet, Albert E. Bryson, Jr., E. E. May (Campbell), Ralph W. Harn, Ward B. Spatz, Harold Lee Temple.

The second of the two chapters above-mentioned was the David J. Brewer Chapter at the Law Department of John B. Stetson University at Deland, Florida. The installing officer was Supreme Recorder Conger G. Roads. The petitioning group was made up of fourteen men, ten of whom were students and four older men who were made Honorary Members of the chapter. Their names are as follows: Hamden H. Baskin, William P. Dineen,

A. O. Kanner, Ray M. Griffin, Charles P. Phillips, David Sholtz, William J. Steed, Howard P. Stewart, Elwyn Thomas, Lewis H. Tribble.

Honorary Members were Judge J. W. Perkins, Judge Bert Fish, Ex-Governor W. S. Jennings, and Honorable Cary D. Landis. One of the Charter Members, David Sholtz, later became Governor of Florida.

The five Chicago Chapters, Blackstone, Story, Fuller, Webster and Marshall, united in an initiation and banquet on Saturday, April 24, 1915, at the University Club of Chicago. Supreme Justice Edgar A. Jonas presided as Toast-Judges John P. McGoorty, Kickham Scanlan, and Adelor J. Pettit responded to toasts which were enthusiastically received. Two judges of the Superior Court of Cook County were made Honorary Members of the Fraternity on this occasion: Charles M. Foell, who became an Honorary Member of Fuller Chapter, and John R. O'Connor, who became an Honorary Member of

Blackstone Chapter.

The next major event to take place within the fraternity was the 16th Convention to be held at San Francisco. California, August 5, 6, and 7, 1915. It seemed to overshadow everything else; it was the topic of conversation in the active chapters, in the alumni chapters and wherever members gathered. The fraternity magazine, then known as the "Phi Alpha Delta Quarterly," was not only carrying interesting railroad advertisements, but was replete with pictures of San Francisco, the Exposition grounds, and places en route. Every effort possible was made to stir up interest and maintain interest in the coming convention and to get out a large attendance. It was stated editorially in the May 1915 issue of the quarterly that "present indications are that almost 40% of the total membership of the fraternity would attend the con-

It was the first convention held at a considerable distance from Chicago, the birthplace of the fraternity,—Madison, Wisconsin, having been the farthest

away from Chicago that a convention had ever been held. The 9th, 10th, 11th, 12th, 13th, 14th and 15th conventions had all been held in Chicago. To stage a convention of the Fraternity on the Pacific Coast seemed next to impossible. The idea of a convention at the time and place of the Exposition was first broached by Past Supreme Justice John Doyle Carmody at the 13th convention, held in Chicago, Illinois, in June, 1912. Each active chapter was assessed \$100, payable in three installments. Had not most of the chapters kept their pledges in this regard, the convention could not have been held; but it was held and that convention will be the subject of the next of these articles.

Sir Walter Raleigh once said, "If thy friends be of better quality than thyself, thou mayest be sure of two things; the first, they will be more careful to keep thy counsel, because they have more to lose than thou hast; the second, they will esteem thee for thyself and not for that which thou dost possess."



What is the Supreme Chapter

We recently distributed a booklet containing an historical sketch and outline of the history and structure of Phi Alpha Delta, This has been sent to all subscribers to The Reporter, to national and district alumni and local officers, to chapter counselors and to all active members and pledges. While the booklet was being

prepared for publication and after reviewing reports of chapter inspections by visiting officers, it occurred to me that a great many members of our fraternity have a misconception of what the Supreme Chapter actually is. It is not a separate organization to which the chapters and the members belong. The Supreme Chapter *is* the chapter officers and members who are represented by the national officers and delegates to the national convention.

You have been told in the historical sketch how the fraternity came to be organized, and of its objects and purposes. Our founders realized that the benefits of the fraternity should be made available to law students throughout the country; furthermore, that there is strength in numbers, and the greater number of chapters we could have, the greater the opportunity for fraternal contacts, interchange of business and good work in fact, the realization of the purpose of our fraternity which is so ably set forth in our Constitution. The founders realized the necessity of some focal point where organization



and supervision could be accomplished; new chapters installed and weak ones assisted; magazines and directories published; records kept and information disseminated as a means of unifying and preserving our common interests. So the Supreme Chapter was formed.

As the clerk of the Benton Chapter it was my duty to col-

lect and transmit initiation fees and dues to national headquarters. I must confess that in those days I had the same misconception which many of our members may now have. To me, the Supreme Chapter was a thing unknown an intangible organization to which we had to pay tribute and which was, to put it bluntly, more or less a pain in the neck.

It was not until I attended my first national convention in San Francisco in 1915 that I began to understand and appreciate the wide scope of the fraternity and to realize the thought which I hope to impart to all of you, that Phi Alpha Delta is a great, far-flung and splendid law fraternity, with tremendous power and opportunity.

It is our own fraternity yours and mine. The national office is simply a clearing house which we maintain for the purpose of carrying forward the work necessary to fulfill our purposes. The initiation fees, which you collect and pay in, are merely your pro rata share of the maintenance of this wonderful fraternity of ours. These funds

are carefully used for the support of our organization; the supervision and rehabilitation of chapters, if they are in need of it; the publication and distribution of The Reporter, directories and necessary information, and the accumulation of funds for the purpose of defraying the expenses of your representatives to national conventions.

The national officers are your officers, just as are your local chapter officers, and you elect them just as you elect your local chapter officers, the only difference being that your delegates to conventions cast your collective vote. We are your servants, elected to carry forward the affairs of your (our) organization. As such we need your sug-

gestions and criticisms and, if earned, your commendations. Unless you tell us, we cannot know of your desires nor of your local problems.

It is my earnest hope to see a closer connection and a deeper understanding between our entire membership. There should be more contact between neighboring chapters; more joint meetings and joint initiations; a greater interchange of constructive ideas; more news of the chapters and members in The Reporter; and a keener interest on the part of all toward further conservative expansion. Above all, there should be a realization that we are one great group, working together for a common purpose.



Certificates of Attainment

A recent rule of the Supreme Executive Board announced that a certificate of attainment be issued by the Supreme Secretary to the highest senior Phi Alpha Delta member at the close of their next to last semester. All preceding law school grades are to be considered, the award being made to the senior who has maintained the highest average, on condition however, that the member must have been within the

highest ranking one-fourth of the students in the senior class and further, that consideration be given both to the quality and quantity of the work, including work on the law reviews.

That this ruling of the Supreme Board has met with the wholehearted approval of the Deans of the law schools is here evident. Here are quotations from letters received from the deans of the law schools or from their offices:

I cannot say positively just where Mr. Fulkerson stands in his class as a whole, but he is certainly in the first quarter, and will probably be among the first two or three in the class. In fact he is one of the best men in the school at the present time.

UNIVERSITY OF OKLAHOMA,

Julien C. Monnet, Dean

The Phi Alpha Delta senior holding the highest average in his class is Howard B. Pickard.

Justice Glenn Terrill holds the highest judicial office in the State of Florida as Chief Justice of the Supreme Court. He has served on the State Legislature, the State Senate, the General Council of the Internal Improvement Fund, the Board of Commissioners of the Everglades Drainage District and as a Justice of the Supreme Court of Florida since 1923.

Brother Buford was State's Attorney for nine years, Attorney General of Florida for four years, and since 1925 has been a Justice of the Supreme Court of the state.

FORD

Loyola University

Following the due process according to the requirements of Phi Alpha Delta's constitution and by-laws, the



name of the Hannibal Chapter at Loyola University in Los Angeles has been changed to the William Joseph Ford Chapter.

The former name was issued to the chapter through a transfer of charter. It was considered desirable by active and alumni in the Los Angeles area that the change be made because it was felt that by honoring William Joseph Ford in this manner the interests of Phi Alpha Delta at Loyola University would be advanced to the highest possible degree.

William Joseph Ford, first Dean of the Law School at Loyola University, was a man well known, respected and revered. Born in Oakland, California, to an early settler father and a pioneer mother, he was reared in Los Angeles, attending public and high schools in that city, and continuing his education at the University of California until 1898, when he left to participate in the Spanish-American war.

It was in 1899 that he was admitted to the bar in California and immediately engaged in private practice in the city of Los Angeles. Soon, he became secretary of the judiciary committee of the state senate, later becoming deputy city prosecutor of Los Angeles and then Los Angeles county. He served as chief deputy for most of the period between 1908 and 1914.

For a period of eight years, from 1920 until 1928, Mr. Ford was dean and professor of evidence in St. Vincent's School of Law of Loyola University. In 1920 Loyola conferred upon him the honorary degree of Master of Arts and in 1925 the honorary degree of Doctor of Laws. As first dean of the School of Law of that university, he was instrumental in its growth and advancement. The general practice of law claimed his attention to the time of his death, which occurred in 1932, when he was in his fifty-fifth year.

His military record included service in the Spanish- American war as a private in Company H of the Sixth California Infantry, and in 1913 he was made first lieutenant of the Sixth Company of Artillery in the California National Guard. He was director of the Los Angeles center of the American Academy of Political and Social Science and was a charter life member of the California State Historical Association.

GARLAND

University of Arkansas

Despite its recent reorganization, Garland Chapter has been very busy sponsoring various activities at the University of Arkansas. A most enjoyable dinner was held recently to celebrate

the initiation into PAD of the two topranking men in the first year class, Newton Killough and Frank Headley. Dr. Robert A. Leflar, professor of law, served as principal speaker and his subject was "Legal Education in America." Also in attendance were Dean J. S. Waterman, who spoke on "The History of the University of Arkansas," and U. S. Lovell, the newest addition to the law school faculty. 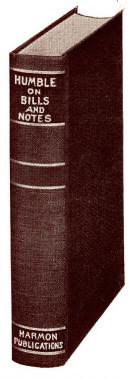
