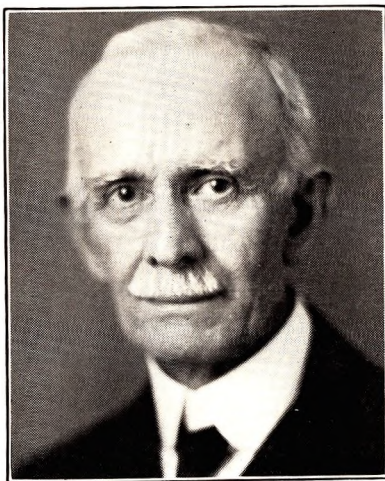

Justice Whitfield Joins PAD

At 5:30 p.m. on December 13th, 1940 the Duncan U. Fletcher and David Brewer Chapters had the high honor to induct as an honorary member of Phi Alpha Delta the Honorable James B. Whitfield, Associate Justice of the Supreme Court of Florida. The initiation ceremony was held in the court room of the Supreme Court building in Tallahassee. The initiation was attended by five other "brothers" of the court as well as many other PADs prominent in the governmental ranks of the state. Following this very solemn and impressive ceremony, the brothers adjourned to Wakulla Springs, twenty miles to the west, where the Tallahassee Alumni of the two Chapters had arranged for a banquet in honor of Judge Whitfield.

At the banquet the Justice was welcomed by the toastmaster, Brother J. Ed. Larson, treasurer-elect of the state, on behalf of all the brothers present. After the introduction of the active members of the two chapters by Brother Julius Parker, head of the arrangements committee in Tallahassee, our newest brother, Judge Whitfield, delivered an inspired address on the honor to be attained in the legal profession and the good work which we, as members of that great profession, can do for our glorious state of Florida.

Congratulatory addresses were then made by the other brothers of the



Supreme Court, the Chief Justice, Brother Terrell, admonishing us to work for the speeding up of judicial procedure, Judge Thomas, a charter member of Brewer Chapter, welcoming Judge Whitfield on behalf of the Alumni of that chapter, Judge Chapman welcoming him on behalf of the Court, and Judge Buford delivering a stirring

oration on the character of Judge Whitfield, whom he characterized as "the foremost citizen of our state." Judge Brown also welcomed Judge Whitfield on behalf of the Court. Brother Larson then followed with the introduction of other prominent guests and alumni.

The two Florida Chapters of PAD feel that the addition of Judge Whitfield to our rolls is one of the highest honors ever granted to our chapters, and adds greatly to the prestige of the whole fraternity. Brother Whitfield has served for 37 years as a member of the Supreme Court of Florida, holding the honor of being on the bench longer than any other Justice in the history of Florida. During this time he has been twice Chief Justice of the Court. Before he occupied his seat on the Court he was County Judge, Clerk of the Supreme Court, State Treasurer, and Attorney General. Fletcher and Brewer Chapters consider it a signal honor to be able to add to the roll of PAD a man held in such high esteem for his unswerving loyalty and love for his state, and we are proud to call him "brother."

During the morning preceding the initiation and banquet Fletcher and Brewer Chapters attended oral arguments before the Supreme Court, before which we all hope to bring our own cases some day. After the court had adjourned, the chapters made a tour of the State Capitol, under the guidance of Assistant Attorney General

Tribble, another charter member of Brewer Chapter, seeing, among other things, the work of Brother Tribble in revising the Florida Statutes in accordance with the Wisconsin statutory system, as well as gaining an insight into the workings of the offices of the Attorney General and the State Controller.

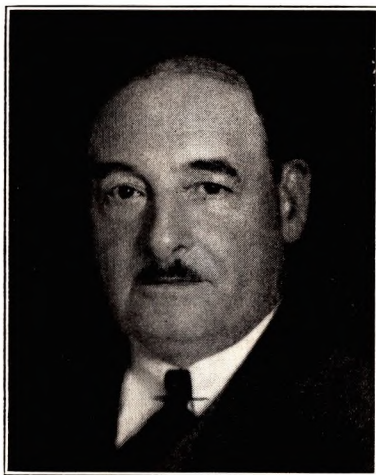


TWENTY-FIVE YEARS AGO

The preceding article, under the above heading, covered the Sixteenth Convention of the Fraternity at San Francisco in August of 1915. As mentioned in that article, the World War was already well under way in Europe, and even before the actual entry of this country, its effects were felt here. Upon George L. Stewart, elected Supreme Justice at the San Francisco Convention, fell chiefly the responsibility of keeping the good ship Phi Alpha Delta afloat until December 1919, when the Seventeenth Convention of the Fraternity, known as our "Victory Convention" was held at Chicago, Illinois, at which convention August A. Rendigs, Jr. was chosen Supreme Justice. Brother Stewart, therefore, has the record of being Supreme Justice of the Fraternity for the longest period in the history of the Fraternity—even longer than those Supreme Justices who had two terms each, viz: Lawrence W. Ledvina and John Doyle Cormody, their respective two terms being for only one year each term.

The Supreme Executive Board of the Fraternity met in Chicago on December 30 and 31, 1916. At this time there were rumors that the United States would enter the war. There was no panic, but the spirit of cautiousness was abroad throughout the land. Fraternal organizations of all kinds began to feel the effect, and among these was Phi Alpha Delta. The spring of 1917 found the United



States in the World War, and every chapter of the Fraternity suffered the loss of active men. It became immediately apparent that a convention of the Fraternity should not be held in the summer of 1917, and Supreme Justice Stewart sent a circular letter to all chapters on May 28, 1917 canceling the dates of July 12, 13, and 14, 1917, theretofore set by that body as the dates for the next convention, and suggesting new dates of December 29, 30, and 31, 1917, for the next convention. Many chapters had reported that their ranks had been practically wiped out by that high and commendable agency—the Call for Volunteers. Upon the outbreak of the war in Germany, the fraternities in its institutions of learning immediately closed their houses and turned their valuable accumulations of property over to their Senior Alumni. Our institutions of learning, of course, were not so vitally affected, but it was impossible to tell what percentage of students would compose the fall classes in the law schools where we had chapters located, nor how heavy the registrations would be. Where could there be any certainty of financial income for the Fraternity? The Supreme Chapter elected at the San Francisco Convention inherited the usual convention deficit, and up to the spring of 1917 had been unable, in spite of careful administration, to overcome it, not only because of the inherited conven-

tion deficit, but because of an insufficient per capita tax. As it was "about to build a new house," along came the war. Although this condition would have remained to a certain extent had there been no war, the national disturbance doubled the emergency by removing the usual sources of income. The only thing to do was to postpone the convention, and in fact no convention was held until December, 1919.

Again we see most of the countries in the eastern hemisphere engaged in a conflict which may involve the rest of the world. We have felt its effects in the United States for some months. Whether the United States will become directly involved, no one at the moment can tell. It is the contention of some that we are already in the War. We are certainly preparing for defense, and many of our members are being drafted for a year of training; also many are volunteering.

It may be timely, therefore, for the writer to permit the publication of a letter dated November 29, 1918, from Ex-Judge William E. Hellander (Fuller), who actively participated in the World War and who gave his permission to the writer to permit its publication whenever he saw fit. "Bill" was one of the first members of the Fraternity to be elected to the bench in Chicago. After he returned from the war, he served two years as Assistant Judge of the Probate Court of Cook County, following which in 1922, he was elected to the Municipal Court bench, where he served continuously for twelve years as one of our most popular judges. He is now practicing law in the First National Bank Building, 33 North Clark Street, Chicago, Illinois, Suite 1763.

His letter verbatim reads as follows:

Nov. 29, 1918.

My Dear George:

Well, old top, I am about to unload a lot of "bull", etc., about my wanderings since leaving Chicago last January.

I suppose I might as well start from home and try to give some idea of what I have done in order of time. So here goes.

Jan. 13th.—Left Chicago, during that heavy snow and cold spell.

Jan. 14th.—Arrived in New York. Met by Louis Mack.

Jan. 15th.—Reported in Hoboken for transportation across. Ordered to sail on Jan. 21st on the Huron, formerly the old Frederick the Grosse.

Jan. 15th to 21st.—Spent seeing New York and Washington. Had a big time visiting many of the gay spots of these cities.

Jan. 21st.—10 a.m. went aboard ship. Met several Chicago boys, including Barney Gissel.

Jan. 23rd.—5 p.m. Boat left dock and at 2 a.m. the next morning started across.

Jan. 23rd to Feb. 5th.—Took a southern route, four boats and a cruiser in our convoy. We encountered all kinds of weather, good, bad and indifferent. Our time was spent playing cards, reading, etc. The last five days out we had to take our turns on watch for subs. My post was out on the aft deck. Barney relieved me and he would begin feeding the fishes as soon as he reached the post. Our food was good and considering the circumstances, we had a very good trip.

Feb. 5th.—Landed in Brest. Cast anchor and lay in the harbor until the afternoon of the 8th, when we were taken ashore. Left the same day for Chatillon-sur-Seine, spending three days on a French train. (Sam Roberts can perhaps explain how the French coaches are constructed.)

Feb. 11th.—Arrived at Chatillon-sur-Seine — Second Course Schools — Assigned to the Tactical School. Here we carried on with a general military course for four weeks.

Mar. 10th.—Left school for our organization. Assigned to the Second

Division. Attached to the 74th Co., 6th Regiment Marines.

Mar. 16th.—Started for the front—in the Verdun Sector.

Mar. 17th.—Arrived at Sommedien, our rest area. Remained here until the 27th. Visited Verdun, shelled while in the town and on our way back.

Mar. 29th.—Went into the front line at Tresavoux, just north of St. Michiel. I was stationed in the town about 250 yds. in front of our front line trenches. Had about 100 men with me. It was a great spot to watch the doings. The Huns were formed in a semi-circle around us, having positions on hills on our right and left. We could not move, but what they could see us. We relieved the French and they said that it was a quiet sector. But things changed. As we were moving in the Huns kept up a continuous bombardment. We spent 10 days in this position, doing the things expected of us, having a few arguments with the Huns as to whether we would stay or give them our position. But as the "leather necks" never give up we were able to turn over the place to our relief. Although we did not see very much action, we had enough to keep us from dropping off or falling asleep.

Apr. 9th.—We moved back to our support positions—a couple of kilometers to the rear. We enjoyed very little rest here. We worked all night, assisting the front line troops in digging trenches and ducking shrapnel.

Apr. 13th.—After a night's work, we were awakened by a shelling. I mean most of us were awakened by the bursting shells. But as I was trying to catch up on a lot of lost sleep, I could not be bothered with it. Fortunately one of the officers was able to get me out after having sniffed some of the Hun's gas. Well, to make a long story short, I was taken to the hospital later in the day. On being put to bed, the gas kept working on me. My eyes closed up and remained that way for

six days. Had some burns on my body. My throat, lungs and heart were affected. Transferred from the hospital to another until on May 4th we reached the hospital at Vichy. My eyes were apparently O.K. when suddenly they went back on me. So for a period of almost two months, could not use my eyes for any purpose.

June 11th.—Left Hospital for rest camp. The June drive made it necessary for all available space for the wounded.

June 12th and 13th.—Visited Paris. The town was pretty down in the mouth.

June 13th.—Reported at Blois. Re-examined. Put on light duty for thirty days. Took command of a Casual Co. Strength 150 to 800 men.

July 4th.—Visited Orleans with my Co. Parade and big celebration.

July 13th.—Another examination. Same result.

Aug. 13th.—Another examination. Same result.

Sept. 9th.—Went to Brest on official business. Returned by way of Paris.

Sept. 13th.—Examined again. Verdict—60 days—no duty. My heart was getting worse, so the doctors advised a complete rest. But I went over and had a talk with the Personnel Officer. Result—Sept. 24th sent to Langres to the Army Schools for a course at the Intelligence School, specialized in Aviation Intelligence. Course ended Nov. 9th. Had been recommended in the meantime for promotion.

Nov. 11th.—Left for my new outfit. Went by way of Paris. Some celebration, being the night the Armistice was signed.

Nov. 18th.—Joined my outfit. Assigned to the Staff of the Third Army Corps. Since this time have had charge of an outfit, but as nothing of an active nature has been done, I am passing away the time doing odd jobs about

the place. We expected to move up to the Rhine, but it is now very uncertain. We are at Mercy le Bav, a town held by the Huns for four years. Hope to see Metz, Lutzenberg and Germany before long.

No doubt this slacker service of mine has been a bore, so I will not trouble you with any more.

Give my regards to the boys and tell them that I expect to get back soon and will try to answer any question about my trip.

Merry Christmas to you all.

P.S. Just another thought and perhaps a little more interesting than the above. While in the first hospital, met a young law student from U. of C. We compared notes and found that we were both PAD's. His name was Bernard MacMeal, since bumped off. Just the other day while riding in a box car with about thirty officers, I bumped into a boy that I had helped put through the jumps at Fuller. Cameron

is his name. Saw Smyth O'Meara a couple of times since coming across. Met a couple more of the boys, but cannot recall their names at present.

So I guess PAD has had a fair representation in this war.

As for lawyers—the whole damned army is made up of them. About 50% of the officers that I have met are lawyers or law students.

NEWS OF ALUMNI

CHICAGO

On November 19, 1940, the Judicial Banquet was held at the Brevoort Hotel under the sponsorship of the Chicago Alumni chapter.

The Judges who attended were Judge M. O'Connell of the Appellate Court, Judge Joseph A. Grager of the Criminal Court, Chief Justice Philip J. Finnigan of the Circuit Court, Chief Justice James J. After a short business session the meeting was turned over to the Judiciary with Chief Justice Fardy, the Will Rogers of the Bench acting as toastmaster. Under his guidance the meeting was kept in a lighter vein and the Phi Alpha Delta razzle-dazzle was very much in evidence.

The fraternity held a banquet in honor of J. Albert Woll on Tuesday, December 17. Dean Albert J. Harno of the University of Illinois and President of the Illinois State Bar Association, as well as Federal Judge Michael

L. Igoe was present.

The fraternity has made great strides forward under the guidance of Peter D. Gachini. It is hoped that 1941 will be a banner year in its history.

PITTSBURGH

The Pittsburgh Alumni Chapter held a dinner meeting in the Pittsburgh Hotel on December 12, at which time the speaker was Dr. Eugene A. Gilmore, an honorary PAD and new Dean of the Pitt Law School.

Dr. Gilmore served for a short time as Governor General of the Philippine Islands. At the meeting he told some of his experiences and discussed the Philippine system of jurisprudence. The Dean's talk was very interesting as well as enlightening and very much enjoyed by the alumni brothers present.

CALIFORNIA

The annual convention of the California State Bar Association held at Hotel del Coronado during the fall was well represented by PADs from all over the state.

According to the State Bar Journal among those active were retiring President Gerald H. Hagar (Campbell); Richard K. Gandy (Hughes) of Santa Monica, a member of the Annual Meeting Committee; Robert Littler (Holmes) in charge of one of the new members of the Board of Governors; Vice President Kenneth G. McGilvray (Temple) of Sacramento, who directed the final session; Joseph W. Vickers (Holmes) of Los Angeles, who was elected Secretary-Treasurer of the Judicial Conference.

MOTOR DIRECTOR



James M. Carter, Los Angeles Attorney, was, on July 8, 1940, appointed Director of the Department of Motor Vehicles. The appointment became effective July 10, and replaced Joseph O. Mattson, a civil service employee, who had been serving as Director following the resignation of Howard Philbrick.

Mr. Carter is a native son, was born in Santa Barbara March 11, 1904. He attended and graduated from the grammar school in Los Angeles, the San Fernando High School, and received his A.B. degree at Pomona College, Claremont, California, in 1924. He studied law for one year at Harvard, and two years at the University of Southern California, receiving the degree of Juris Doctor in 1927.

In 1928 Mr. Carter entered the practice of law in Los Angeles, and has been engaged since in general practice. He is married, lives in Los Angeles, and has a daughter ten years of age.

Mr. Carter is a member of the following societies and organizations:

Ephesian Honorary Society of Los Angeles City High Schools; Order of

Coif, Honorary Legal Scholastic Fraternity; Phi Alpha Delta, national legal fraternity; and Phi Kappa Phi, national honorary scholastic fraternity, U.S.C. Chapter. He is Past President of the Ocean Park Aerie of the Fraternal Order of Eagles, and a member of the Native Sons of the Golden West.

Mr. Carter also belongs to numerous civic organizations in Los Angeles, and managed the Roosevelt campaign in 1936 in the Santa Monica Bay District.

Ernest Palmer, Jr., has entered the law firm of Russell, Bridewell & Palmer with offices in the Field Building in Chicago. Brother Palmer started his law studies at Stanford University where he first joined as a brother in PAD. His last two years of schooling were spent at Northwestern where he was vice justice of the chapter. Upon admission to the Illinois Bar he became associated with the concern in which he is now a partner.

Arthur McGregor (Jay) announces his new association as partner in the law firm of Mackay, McGregor and Reynolds with offices at 1235 Pacific Mutual Building, specializing in Federal and State Taxes. Brother McGregor was formerly connected with the firm of Dempsey and Mackay.

The next meeting of the Los Angeles Alumni will be held Thursday, January 23rd, at the Alexandria Hotel. The meeting will be an informal smoker and dinner and election of officers.

CONFERENCE

The dinner of the National Interfraternity Conference on November 29, 1940 was an outstanding success. It was one of the largest dinners ever held in New York with an attendance of over 3,000. There were representatives present from some 200 fraternities and chapters of all the universities not only in the United States but in Canada.

In these days when so much is said about the decadence of fraternities, it was inspiring to any fraternity man to see this proof that the fraternity spirit is carrying on and that the fraternities continue to render their outstanding contribution to university life, just as always.

Dr. Henry Merritt Wriston, President of Brown University and a Beta, delivered a good address on world conditions.

Medals were awarded to Albert Sprague Bard, Chi Pi and Dr. Alvan E. Duerr, past president of Delta Tau Delta for distinguished services to fraternities and education. Dr. Duerr is editor of the "Baird Manual of Fraternities."

Reinald Werrenrath (N. Y. U. '00) and sometime of the Metropolitan Opera House, sang the "Star Spangled Banner" as it should be sung and rendered other selections. Lowell Thomas was toastmaster. The Dartmouth and Cornell orchestras and glee clubs were present and did themselves proud.

The conference re-elected L. G. Balfour, Sigma Chi, as chairman; David K. Reeder, Delta Tau Delta, vice-chairman; LeRoy A. Wilson, Lama Chi Alpha, secretary; and A. J. G. Priest, Beta Theta Pi, treasurer.

Phi Alpha Delta was represented by William P. McCool and Charles Halla, both of Rapallo.

NECROLOGY



The sudden passing of Brother George S. Myers (Hay) at Cleveland, Ohio, last summer was a deep loss to beloved men who had kept his interest in the affairs of the fraternity for more than 25 years.

When, in 1936, he was elected to the Supreme Court of the State of Ohio, it was with the highest vote of any candidate on the judicial ticket. At that time he was serving his second term as Secretary of State. Brother Myers became active and prominent in PAD in 1916-19, when he served as Acting Supreme Recorder. He was a District Justice and influential in all fraternity affairs in his state.

Robert E. Downs (Blackstone) died in his Chicago home in early October. Brother Downs, who was 44 years of age, attended the University of Chicago and Northwestern University and received his law degree at Chicago Kent College of Law in 1922. He was admitted to practice in 1928. A member of the Illinois Bar Association and the Law Institute, he was a partner in the firm of Downs & Howe.

Washington Elects Phi Alpha Delta Governor

Arthur Bernard Langlie, (Dunbar) the new Governor of the State of Washington, oldest of three sons of Mr. and Mrs. Bjarne A. Langlie, was born at Lanesboro, Minnesota, on July 25th, 1900. Some ten years later the family moved to Bremerton, Washington, where the senior Mr. Langlie established a grocery store. Arthur attended public school, working in the store and running errands after school and on Saturdays.

Upon his graduation from high school in Bremerton he enrolled at the University of Washington—working in the logging camps and wheat fields of Washington not only during the summers, but as necessity required to enable him to finance his schooling.

Graduating from the Law School of the University of Washington in June, 1926, he became associated with the law firm of Shank, Belt and Rode, practicing law for the ensuing nine years.

He was elected to the City Council of the City of Seattle in 1935, where he so merited the commendation of the electorate of Seattle by his fight for good government that in 1938 they elected him Mayor of Seattle by an overwhelming majority.

In March, 1940, the people of Seattle again evidenced their high approval of the fine business-like way he had conducted the affairs of the City by reelecting him Mayor. Without his having spent one cent other than the filing fee, he received 78% of the total vote cast for Mayor and is the second Mayor ever to serve Seattle for two consecutive terms.

Arthur Langlie was married to Evelyn Baker of Pennsylvania in September, 1928, and is the father of two children—Arthur Sheridan, aged ten; and Carrie Ellen, aged five. Shortly after their marriage the Langlies built their own small home at 6020 6th Northeast, where they have since continuously resided.

The Langlies are members of the University Presbyterian Church.

Arthur Langlie is affiliated with the following clubs and organizations: Active Club, Eagles Lodge, Kiwanis Club, Lions Club, Moose Lodge, Norwegian Commercial Club, Phi Alpha Delta, Phi Kappa Sigma, Royal Arcanum, Scandinavian Fraternity, Sons of Norway.

In response to our letter of congratulation, Brother Langlie has sent us the following message.

Brothers of Phi Alpha Delta:

It is with pleasure that I accept the invitation of our honorable supreme secretary to extend to you greetings and a message through the Phi Alpha Delta Reporter.

In these uncertain times, more so than ever before in our lives, we of the legal fraternity must stand solidly with the other professions and all clear-thinking citizens as bulwarks against the attacks on Americanism as we know it and enjoy it. We cherish Americanism as an ideal, a doctrine and a privilege that insures us freedom and individual liberty.

The preservation of Americanism calls for open minds and the willingness to expend whatever time is necessary to see that our perspective and that of our fellow citizens is not impaired by the attacks designed to mislead us.

BENSON

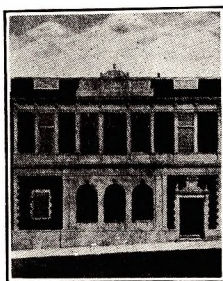
Washburn College

At this occasion D. Niel Ferguson, Chairman of the State Board of Law Examiners, was initiated an honorary member.

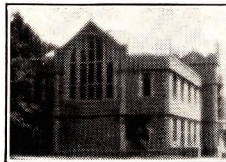

CLAY

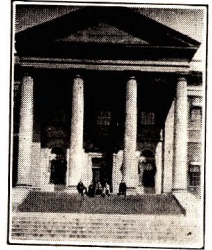
University of Kentucky

CAPEN

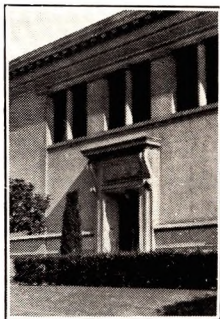

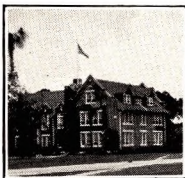
Temple University

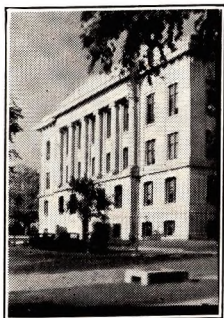

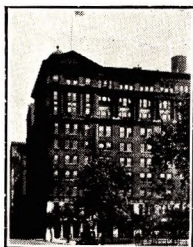

University of Utah

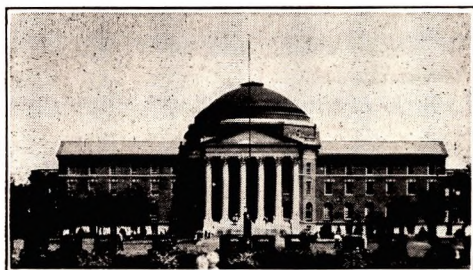
Two PADs here were elected by the student body to head the Barrister's Club for the coming season. They are Mark Miner, president and Wayne Gallagher, vice president.

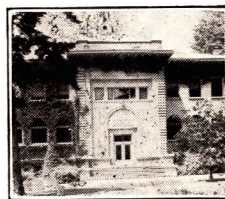

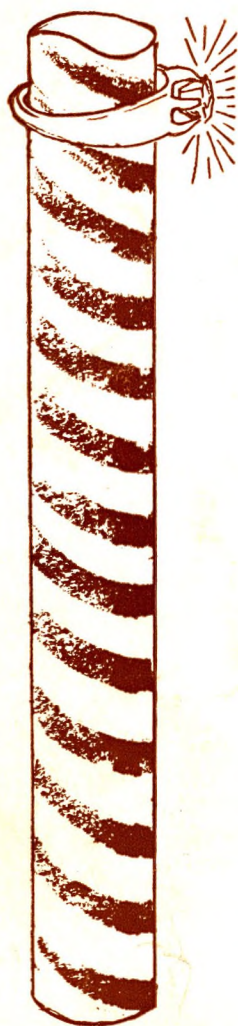
