Owen J. Roberts Chapter Chartered at Temple U.

At one of the most brilliant functions in the history of Phi Alpha Delta, the charter of the Owen J. Roberts chapter at Temple University was officially presented at the banquet held in the Carlton Hotel, Washington, D. C., on February 15, 1941. Approximately 200 brothers in formal attire faced the Speaker's Table at which, in addition to the guest of honor, Associate Justice Owen J. Roberts of the Supreme Court of the United States, the following members of Phi Alpha Delta Law Fraternity who have distinguished themselves in public or fraternity service were seated:

The address of welcome and introduction of the Toastmaster, J. Harry LaBrum, Supreme Justice of Phi Alpha Delta, was delivered by the Hon. Robert E. Freer, a member of the Federal Trade Commission. Toastmaster LaBrum handled the remainder of the program in masterly fashion. He first introduced Supreme Secretary Frank M. Ludwick, who, after commenting on the practice established by the founders of the fraternity of naming the chapters in Phi Alpha Delta after distinguished jurists and statesmen, paid tribute to the qualities of Justice Roberts which had induced the selection of his name for the chapter at the Temple University. He then formally presented the charter to Brother William Turner, the Justice of the Roberts Chapter who accepted it in behalf of his chapter. Brother William O. Jackson, Justice of the Supreme Court of the United States, and Brother George A. Welch, United States District Judge, paid glowing tributes to the guest of honor.

The address of Justice Roberts was everything that might be expected of a man of his outstanding ability and accomplishments. Witty, interesting and brilliant, he held his audience entranced. While expressing in moving words his appreciation of the honor bestowed upon him by, as he put it, "immortalizing" his name, he convinced all of the brothers that the members of the Owen J. Roberts Chapter could not have made a better selection and that the name which their chapter now bore was one which they might ever honor and revere.

District Conclave

For the first time in recent years a plan for fraternal get-together was announced in the holding of the District VII one-day Conclave at Kansas City, Missouri.

The plan was developed by Brother Jay Kyle, District Justice, and to him goes the honor and credit for this highly progressive meeting plan.

Following an indication of general approval for a one-day conclave, alumni and active members of Phi Alpha Delta in the four state area, members from Kansas City, Lawrence and Topeka, pursuant to a meeting in Topeka in February, met at Lawrence in March to formulate plans for the gathering. It was planned that a large number of PADs in this area would have an occasion to lay aside their law books, forget their clients—and for just one day—enjoy a Saturday in Kansas City with old and young alike in the fraternity.

The meeting is called for April 26, and to begin at 2 P.M. Benton Chapter's Founders Day program is to be incorporated in the general plan. All sessions will be informal, stag and inexpensive.

Officers of the national chapter will be in attendance and members of Benson, Benton, Clark, Green, Hammond, and Reese active chapters, and Kansas City, St. Louis and Topeka alumni chapters are urged to attend, in a body and through representatives.

The meeting will be held at the Hotel Phillips. Any and all PADs are urged to attend. The active chapter travelling the longest distance to the meeting will be Hammond Chapter. They will cover more than 650 miles, coming and going.

When the conclave idea was proposed, it was to be held if 100 would

attend. Early in March more than 200 declared their intention to participate. And the number is still going up.

Green Chapter reported a large delegation. Albert M. Cole (Marshall), state senator from Holton, Kansas, along with his colleague, Art Stanley, Jr., of Wyandotte, said YES. From Nebraska came a report that a number of alumni and actives of Reese Chapter would drive in. The smallest chapter in the district, Clark, will have a good representation backed up by a sizable group from St. Louis. Down in southern Kansas, news came in that Walter Patterson of Fort Scott and Bob Allen of Chanute were coming to town. Benson and its alumni from Topeka and surrounding towns will have a big number on hand for the meeting. Four national officers have accepted invitations to be on hand.

The meeting will be conducted through a series of round-table sessions. The first, with the Justice of Benton Chapter presiding, will discuss: 1. Colonization of Chapters, 2. Finances, 3. Social Activities.

After an intermission the Justice of Benson Chapter will preside over subjects: 1. Alumni Interest, 2. Rushing, 3. Cooperation of National Chapter, and this will be followed by a talk by Frank Ludwick, Supreme Secretary. There will also be a round-table to discuss the problems of the alumni.

Beginning at seven that evening will be a banquet for the distinguished guests, honorary members, alumni, actives, pledges and rushees of all chapters.

It should be the beginning of a series of one-day PAD conclaves which will take place all over the country.

New York Alumni Banquet For Brother W. O. Douglas

The Honorable William O. Douglas, Associate Justice of the Supreme Court of the United States, was the guest of honor at a dinner tendered by the Rapallo and New York Alumni chapters, Thursday, April 17. The dinner marked the second anniversary of Brother Douglas' appointment to the Supreme Court, and was attended by National officers of Phi Alpha Delta and prominent New York Judges and members of the bar.

Supreme Justice J. Harry Le Brum and Supreme Secretary Frank Ludwick represented the national association of Phi Alpha Delta. Brother Le Brum announced that the Executive Board had approved the plan of re-organizing the Livingston chapter at Columbia University and changing the name to the William Orville Douglas chapter. Brother Douglas was a member of the Livingston chapter when he attended Columbia.

Brother Joseph Fitzpatrick was the Toastmaster and introduced Brother Douglas. The dinner, attended by several hundred PAD's, was arranged by Brother Thomas Scott who will be admitted to the District of Columbia Bar in May.

Among those who attended were: Brother Lloyd Church, Justice of the New York Supreme Court, Brother Benedict Dineen, Justice of the New York Supreme Court, Brother Hallihan, Justice of the New York Supreme Court, Brother Anthony Savarese, New York City Magistrate, and New York Supreme Court Justice Ferdinand Pecora. Also Brother Irving Ben Cooper, Judge of Special Sessions, New York City; Dean Frank Somers, New York University School of Law; Brother I. Morris Wormser, Professor of Law, Fordham University; Brother Lawrence

P. Simpson, Secretary New York University of Law, and Brother Joseph P. Brennan, Justice of the New York Alumni chapter.

Rapallo chapter of New York University invited as guests of the chapter, a number of students who are being considered as prospective members.

Brother Douglas' address was mostly "off the record" but in part follows:

A contemporary observer has said that as a result of the incredible sophistries and the brutal and ruthless attacks by totalitarian leaders on the democratic processes, "The Declaration of Independence may now be referred to without apology, and even policemen on the beat are becoming dimly aware that there is such a thing as the Bill of Rights."

Certainly those assaults have quickened our sensibilities not only to the imminent world wide threats to liberty but also to the abiding intrinsic values in the democratic faith. And they serve as occasions for rededication of our lives to propagation of that faith.

There is more to the practice of law than the litigation of cases, the drafting of documents, or a subservience to the narrow, immediate interests of clients. Fundamentally the individual and joint efforts of members of our profession must have as their end product the guaranty of a way of life which reflects the dominant hopes and aspirations of the people.

There is only one Liberty and that is Liberty within the law. Without that cementing element there can never be confidence in order—the real basis of all security. And without a common sense of security there can be no effective compact among men based on conceptions of equality and fraternity. But

for such a compact to be continuously effective it must be dedicated to adjustment and change so that contemporary demands may be recognized. Through such compact the terms of domestic tranquility can be found. The effort then will always be to build for the future, not to turn back the clock.

It is that kind of a system geared to our constitutional form of government which it is the lawyer's duty through the years to fashion. That is why the preeminent task of the lawyer is not research in excuses for inaction but imaginative thinking necessary for creative action. Statesmanship is necessary in order to absorb into the common endeavor the energies of all the people.

Whatever may be the ways and means, whatever the effort, the pole star will always be the ingredients of the demo-

cratic faith. These have recently been stated by an eminent American, Carl Becker, as follows:

"To have faith in the dignity and worth of the individual man as an end in himself, to believe that it is better to be governed by persuasion than by coercion, to believe that fraternal good will is more worthy than a selfish and contentious spirit, to believe that in the long run all values are inseparable from the love of truth and the disinterested search for it, to believe that knowledge and the power it confers should be used to promote the welfare and happiness of all men rather than to serve the interests of those individuals and classes whom fortune and intelligence endow with temporary advantage—these are the values which are affirmed by the traditional democratic ideology."

Military Service

Undoubtedly many of our brothers will be entering the military service. We have already learned of some. The Supreme Executive Board, by resolution, has authorized the editor to continue the mailing of THE REPORTER to these members while they remain in the service, in the belief that it will be very welcome to them.

In order for us to do this, it will be necessary for the brothers to keep us advised of their changes in address. Please keep this in mind and see that we are notified promptly.

We are going to attempt to print in future issues an up-to-date directory of the boys in service so that they may have an opportunity to contact each other in their respective posts, camps, or stations. The cooperation of all members of the fraternity is urgently requested in order that we may make this service a success.



TWENTY-FIVE YEARS AGO

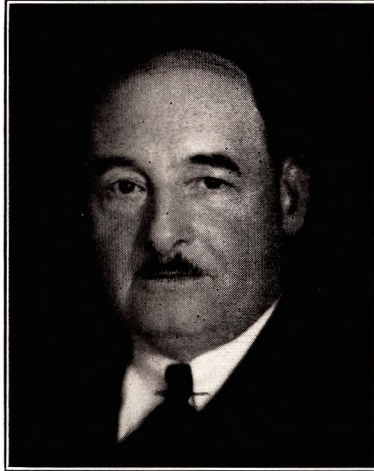

The last contribution under the above heading, published in the December, 1940, number of the "REPORTER," mentioned the fact that there was no convention of the Fraternity between the Sixteenth Convention, held at San Francisco in August, 1915, until the Seventeenth Convention of the Fraternity, known as our "Victory Convention,"

held four years later in December, 1919.

The writer has endeavored to adhere to the events of interest happening in the Fraternity twenty-five years preceding the writing of each article, but is now confronted with a dearth of material for this particular article. The magazine during the period in question was known as the Phi Alpha Delta Quarterly, of which Oscar W. Hoberg (Magruder) was Editor-in-Chief. Issues were put out in January, March, May, and November, 1916. The issue of March, 1916, contained interesting letters from the following named chapters: Calhoun, Campbell, Chase, Clay, Dunbar, Fuller, Hamlin, Hammond, Hay, Holmes, Hughes, Kent, Lawson, Magruder, Reese, Ross, Story, and Taft.

The Supreme Executive Board had met in Chicago on December 30-31, 1916, and again at Chicago on February 12, 1916. There were present at this latter board meeting George L. Stewart, (Story), of San Francisco; Supreme Recorder C. J. Roads, (Hay), of Cleveland, Ohio; Supreme Financial Secretary Glenn E. Miller, (Ryan), of Portland, Oregon; Supreme Treasurer



Abraham J. Hart, (Campbell), of Detroit, Michigan; Supreme Historian Joseph P. O'Connell, (Hughes), of Denver, Colorado; and Editor-in-Chief Oscar W. Hoberg, (Magruder), of Peru, Illinois.

The Sixteenth Convention of the Fraternity, at San Francisco, had provided for the division of the Fraternity into districts (Section 15,

Article 5), and the most important business transacted at this last board meeting was to work out that idea, which it accomplished by creating five Districts, known as Central, Eastern, Western, Atlantic, and Pacific. This plan of division was changed some years later. Each District had a convention which was held between the National Conventions of the Fraternity. Each District recommended legislation to be considered by the next succeeding National Convention. Under this plan, for a number of years, interesting District meetings were held.

At this board meeting the Supreme Historian, Joseph P. O'Connell, was directed to compile and distribute a new directory of the Fraternity. This directory being the fourth, was published in the form of a pocket edition. The directory, when it appeared in 1917, listed thirty-seven active chapters, and twelve Alumni Chapters. It also listed the members both alphabetically and geographically, and the same continued as the Official Directory of the Fraternity until the publication of the Fifth

Directory in 1923, which was compiled by Dwight H. Green, (Holmes-Marshall), destined to become the Governor of the State of Illinois.

Owing to the aforementioned dearth of material for this article, the writer has made a search in his private Fraternity Archives, and submits, in connection with this article, a picture taken at the Twelfth Convention of the Fraternity, held June 24, 1911, at the Hotel La Salle, Chicago, Illinois. While this picture is more than twenty-five years old, and gets back closer to the "horse and buggy days" than the title of this article justifies, it is chosen because of its clearness, and because it includes the largest number of men who had been, or who later became Supreme Justices of the Fraternity, than any other Convention picture of which the writer knows. The writer was Chairman of the Convention Arrangements Committee, and due to this fact, he was prevented from becoming well enough acquainted with all of the other delegates to recall their names now; or possibly, due to the fact that his memory is failing him, he is now unable to identify by name all of the members who appear in the picture. He will be under considerable obligation, therefore, to any who will supply him with names of those he is now unable to identify, and whose numbers are encircled. The names of any such as well as those who furnish their names to the writer, will be published in the next issue of the "REPORTER."

Those shown in the picture who at the time were Supreme Justices, or who were later elected Supreme Justices, are as follows:

No. 6, John Doyle Carmondy, (Taft), outgoing Supreme Justice at this Twelfth Convention. Brother Carmody served two terms as Supreme Justice, the first term in 1910, the second in 1911, being the Eleventh and Twelfth Supreme Justice of the Fraternity; No. 7, Edward J. Hess, (Webster), Supreme Recorder

1910-1911, elected at this Convention as Thirteenth Supreme Justice of the Fraternity; No. 10, Paul C. Meier, (Story), Supreme Justice of the Fraternity in 1905, being the Sixth Supreme Justice of the Fraternity. He was re-elected as Supreme Historian of the Fraternity at this Convention, having been first elected as Supreme Historian in 1907, at the Eighth Convention of the Fraternity, held at Madison, Wisconsin; No. 14, Roland M. Hollock, (Fuller), (now deceased), elected in 1902 as the Supreme Justice of the Fraternity, the title then being Chief Justice; No. 15, Rex Hardy, (Story), the Twentieth Supreme Justice of the Fraternity, elected in 1925; No. 18, George E. Fink, (Story-Campbell), (Supreme Treasurer 1907-8), elected as the Nineteenth Supreme Justice of the Fraternity in 1923; No. 24, Lawrence Ledvina, (Ryan), first elected in 1907, and succeeding himself in 1908, being the Eighth and Ninth Supreme Justice of the Fraternity.

Others shown in the picture, whose name, (when recalled by the writer), are indicated by numbers, are as follows:

No. 1, Harry J. Fleck, (Webster); No. 2, Richard Finnegan, (Webster); No. 3, Harry Lee Stacey, (Webster), Convention Reporter; No. 4, J. F. T. It is interesting to note that our farthest east and farthest west Chapters (both seaboard) were represented at this Convention; east, *Hamlin*, (then at the University of Maine); *Calhoun*, (Yale University); *Rapallo*, (the University of the City of New York); *Taft*, (Georgetown University, at Washington, D. C.); and *Hay*, (Western Reserve University, at Cleveland, Ohio); west: *Williams*, (University of Oregon, at Eugene, Oregon); *Ross*, (University of Southern California at Los Angeles); and *Gunter*, (University of Colorado, at Boulder, Colorado). It is also interesting to note that the only Chapter then in the Fraternity not represented by one or more delegates was Garland Chapter at the University of Arkansas, Little Rock, Arkansas.

A Dilemma

In response to the Supreme Secretary's letter seeking the PAD with the best scholastic record came a response so encouraging and interesting that it was decided to re-print it in the *Reporter* in full. It came from Harry D. Taft, Assistant Dean of the De Paul University College of Law. Certainly, PAD is proud of Story Chapter. The letter follows:

"In naming this candidate, I am faced with a dilemma. You have two members whom we would place practically on a par. One of them, Walter J. Fehr of 4836 N. Claremont Ave., Chicago, has a general average to date of 90.26% and ranks number 1 in the Evening Division and number 3 in a whole class of 88 who will graduate in June. He will undoubtedly receive the honor of a degree cum laude. The other is Charles Zitnik, 1400 Oak Park Ave., Berwyn, Ill. His average to date is 89.17. This places him number 2 in the Evening Division and number 4 in the whole class of 88. As to quantity and quality of work done by each of these men, we feel that they are on a par. In fact we would not like to place either one of them exactly on top. I am giving you the facts and I am afraid that you will have to decide just which one is to receive your award. If it were possible to give the award to each of them, it would certainly be pleasing to us.

"I want to compliment you and the members of your fraternity here again on the high scholarship record maintained by the group. In fact there is something rather remarkable about the record established by the ten seniors in the Evening Division who are mem-

bers of your fraternity. All ten have averages above 80%. Seven out of the ten have averages above 83%. These members are Walter Fehr with an average of 90.26; Charles Zitnik with 89.17; Fred Williams with 85.53; Fred Wittenmeier with 84.31; William Morgan with 83.74; George LeBlanc with 83.10; Franklyn Kraus with 83.09. These men will all be in the upper 50% of the class when they graduate and most of them will be in the upper one-third of the whole graduating class. Again I say congratulations to you and to them.

"I might also say in passing that your fraternity group as a whole maintained a very fine average last year as compared with the averages of all students in school.

"May I again urge that you consider seriously, if possible, the proposition to confer your award on both of the men mentioned in the first part of this letter. If the advantage is with either one—both being on a par as to quality and quantity of work done in school work and other activities—it probably must go to Mr. Fehr, who has a slight advantage in the figures as to scholarship.

"Thank you again for your cooperation and that of your group here in the matter of maintaining high standards in scholarship and in all other qualities which go to make up proper conduct for legal fraternity members.

Brother Kenneth Wilke was elected President of the Washburn Law School student body and Brother Bert Vance was elected Student Council representative.

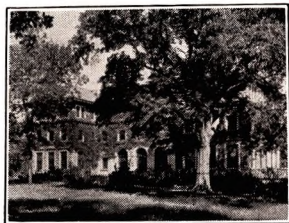
Both active and alumni brothers are preparing to attend the District Conclave which will be held in Kansas City next month. A large representation is expected.

Several members of this chapter have received their Selective Service questionnaires and Brother Al Dawson has been called. He is now at Fort Benning, Georgia.

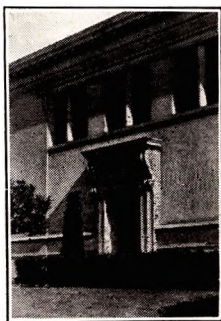

Loyola University

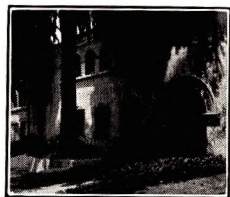
Ford Chapter has had the top ranking student of each class for the past two years. All members stand well above average in their classes in scholastic rating.

The chapter is proud that two of the brothers, Walter L. Rietz and Robert Fousek, were selected to the Order of Coif.

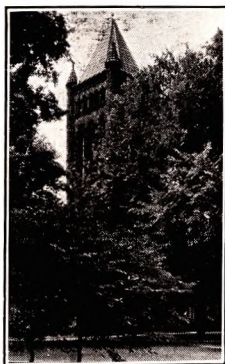
The new officers are now planning for spring and early fall pledge rushing and many social activities.

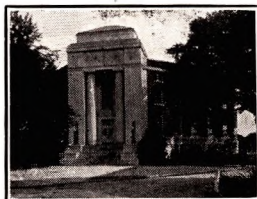
The chapter feels somewhat like a baseball club which has come up with the prize rookie, inasmuch as one of the first semester pledges had a 5-point (straight A) average.

Following a very successful banquet on March 29, five new pledges were inducted. At the initiation exercises election of officers was held and the annual report given.



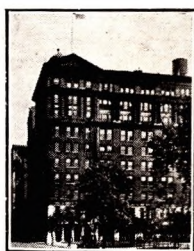

fraternity. He was presented with a key in token of his outstanding service as a member of the New York Legislature and as a Judge of the New York City Municipal

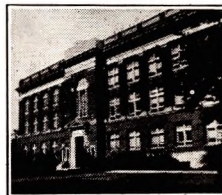

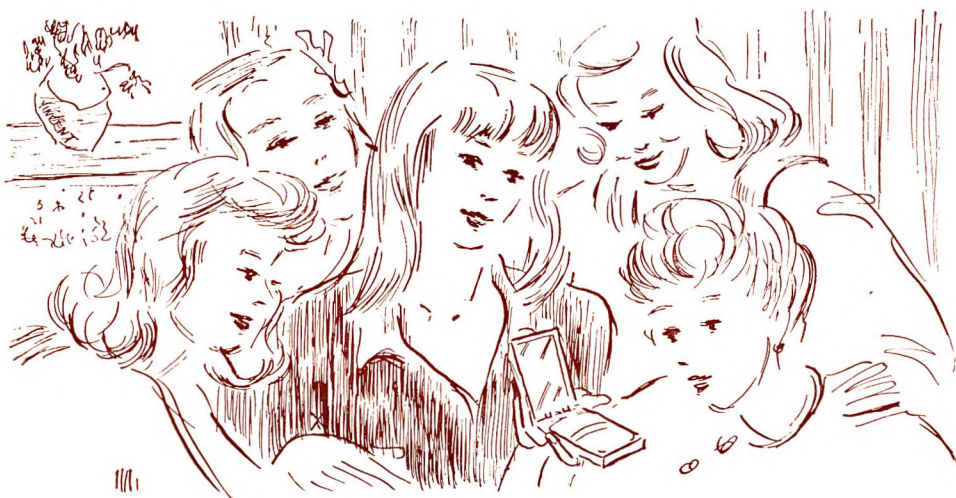
