ΦΑΔ Initiates Attorney General Clark

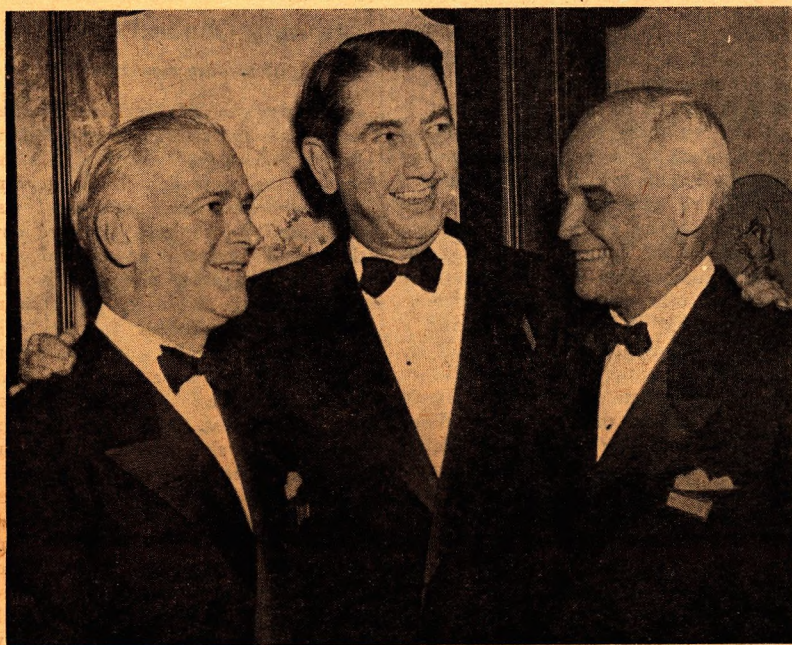
Galaxy of Notables In Attendance

In an impressive ceremony conducted by Supreme Justice J. Harry LaBrum, assisted by Supreme Vice Justice William M. O'Shea and Supreme Secretary Frank Ludwick, Honorable Tom C. Clark was initiated as a member of Taney Chapter of Phi Alpha Delta Law Fraternity, in recognition of his high service and unswerving devotion to the law, in token of his championship of those things to the maintenance of which this Fraternity is dedicated and as evidence of the high esteem in which he is held by this Fraternity.

Brother Clark's induction followed a pleasant cocktail party, the hosts being Ray Beebe, Russell Brown, Joe Carey, Marshall Diggs, Arthur Koontz, Frank Ludwick and Bob Smith, of the Washington Alumni Chapter. It was followed by a brilliant testimonial dinner to the newly initiated Brother and climaxed a day of meetings of the Supreme Executive Board and the Supreme Advisory Board of the Fraternity. Joseph A. Carey, Justice of the Washington Alumni Chapter, presided. Following an address by Supreme Justice LaBrum and the induction ceremony, Brother Dwight H. Green, Governor of Illinois and Supreme Tribune of the Fraternity, paid a glowing tribute to our honored guest. He said that the Fraternity "is honored to have this great American come into its ranks and march side by side with other great men in the organization."

"He is a great human man with tolerance and understanding in his soul. By his actions he already has shown that he will go down in history as one of the greatest and strongest Attorney Generals of the United States."

Brother Clark responded in an extemporaneous talk. "If I could do all the things Governor Green said I could, I'd take the place of Superman in the comic strip," he began. We quote further from his remarks: "I

feel somewhat like the GI who was asked why he joined the Army.

"First," he said "I wanted to serve my country, second, I thought that Army life would make a man of me, third, they came and got me."

"I had been familiar with your great organization for a long time, but I had not anticipated this magnificent welcome. I am deeply touched and will try to uphold the standards of Phi Alpha Delta as best I can."

"Up to now my fraternal activities have been confined mainly to that widespread and rather fascinating organization, the Democratic Party. It has initiations—consisting of ringing door bells and folding circulars in one's young days. It has its dues and once every four years it has a fine party, oftentimes in Chicago. It has a President and some prominent officers currently, and I believe that it will continue to have them for a considerable time. There are no hon-

orary members, but if there are any of you to whom I can return the compliment, I shall be glad to help you join, as there are chapters everywhere under the American flag. I don't suppose that Governor Green will accept this offer at this time, but we will be glad to have him with us at any time. Seriously, I feel deeply honored that I have achieved the rank of honorary member here, along with the late President Taft, General Pershing and President Truman. The steady growth of this organization since its beginning in Chicago in 1902 is remarkable and it is an indication that you have sought and acquired the right sort of men in our profession. The list of luminaries of bar and bench is impressive.

"I would like to speak briefly on a few matters of interest to the legal profession. The first is to tell you of the fine reaction that there has been

NIC Gives Pertinent Rush Tips

A special committee of the Interfraternity Conference on deferred rushing, has offered the following recommendation after stating that rushing should not be deferred to the sophomore year:

1. That rushing be concluded prior to the Thanksgiving holiday or, in default of such a system, that the rushing period begin immediately after the Thanksgiving holiday.

2. That the pledging ceremony be concluded prior to the beginning of the Christmas holidays, or begun immediately following the conclusion of the Christmas holidays. If the traditions of the college demand, pledging can be postponed until the beginning of the second semester when the scholarship ratings of the prospective pledges have been published; we do not recommend delay thereafter.

3. Initiation should not be so early that the scholarship ability of the neophyte is an unknown quantity, nor so late that he has lost substantially a year of fraternity life. The scholarship of the student need not necessarily receive complete demonstration from his work in college. High school records will help. But there should be some demonstration of scholarly interest after admission to college.

4. We also recommend that no initiation be permitted until after the conclusion of an adequate pledge training program, requiring at least thirty calendar days for its completion. Freshman year, and not too late in freshman year, is a favorable time for such indoctrination.

Fraternity War Records

It is reliably estimated that 40 per cent of the total living membership of a normal Chapter has been in the service; that 400,000 Fraternity men contributed to winning the victory and that approximately 10,000 Fraternity men made the supreme sacrifice.

An Inspiring Message . . .

FROM OUR SUPREME JUSTICE

Dear Brothers:

The period of reconstruction and reconversion has about run its course. Starting with six active chapters which managed to survive the impact of World War II, we are now well on our way toward realizing our ambition of years' standing of having at least fifty chapters represented at our National Convention to be held in Kansas City the last three days of this year.

This goal, if it is achieved, will reflect great credit on not only the active members of the chapters represented, but also on those many self-sacrificing members of our Alumni who have devoted much time, energy and money to the rehabilitation of lapsed chapters and the establishment of new ones.

Just about a year has passed since the Army and Navy made effective its program for the discharge of its members. Many of our brothers have returned from the armed forces to the practice of the law; others to take up their studies, interrupted when they were inducted into the service. Law schools today have more students than at any other time in their history. The number of men preparing to come to the bar is both a threat and a challenge to the legal profession generally and Phi Alpha Delta particularly.

A threat because many men who have taken advantage of the GI Bill of Rights are not fitted or adapted to the study and practice of the law. These men will gradually be eliminated by the law schools and the bar examinations, but many of them will become bitter by reason of their failure, and unless some medium is found to encourage them to seek other fields of endeavor much of the effort to rehabilitate them will be lost. All members of Phi Alpha Delta, both active and Alumni, should constitute themselves an advisory committee for consultation by these men, so that they may be helped over the rough spots or detoured to the road which will lead them to the kind of a career for which they are best fitted.

A challenge because with the ever-increasing number of men coming to the bar the competition for place is becoming keener and keener and a man must be better fitted for his work than ever before if he is to have even a modicum of success. Again Phi Alpha Delta can be of great help. The fostering of moot court competition, the holding of discussions, the study of developments not part of your regular curriculum will do much to prepare our members and your associates for their advent to the bar.

All of this means considerable additional work for the active and Alumni members of our Fraternity, but it will pay off large dividends in satisfaction, and will definitely establish Phi Alpha Delta as the law fraternity with a real purpose and which more than meets its obligations to its members and the law schools in which it has established chapters.

This kind of work will inure to your benefit and the benefit of all those with whom you come into contact.

Col. Rex Hardy, Past Supreme Justice, Writes From Paris

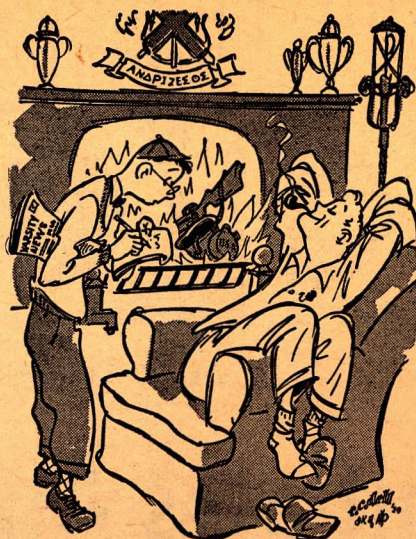
Dear Frank:

Your letter of October 1 addressed to my old office at Los Angeles was forwarded on to me by my Father. Here I am still in Paris now entering on my fourteenth month. Even though I have been stationed in Paris for so long, I have had an opportunity of making trips all over France, Belgium, parts of Holland, most of Germany and Austria and down to Italy as far as Rome. During my stay in England I saw pretty much of what is known as Southern England and was completely charmed with it. I have indeed been fortunate in seeing as much of Western Europe as I have even under the terrible combat and post-combat conditions. France, generally, and even Paris are still in bad condition because of a lack of national economy which is necessary to make a great nation. France, in

order to live, needs importations of raw materials so that its factories may commence manufacturing French products but the poor financial structure, lack of fuel, and transportation have completely slowed up the normal processes. Germany, of course, is a complete mess and heaven knows when anything normal will be happening there. Belgium, because of a fortunate position in Reverse Lend-Lease seems to be the most prosperous country in Europe with the best change for a quick recovery.

Mainly I have handled the Displaced Persons situation in liberated countries having collected, housed, maintained and ultimately repatriated nearly 200,000 out of France and Belgium. I set up the Board of Control plans whereby about a million and a half French, 600,000 Belgians and

to the proposal of President Truman to increase the salaries of our Federal Judges and to give advances to members of the profession in the government who have been neglected for so much and for so long. We are now the world's greatest power and cannot be so niggardly that we drive the youth and the brains of the country out of the government, for their skill is needed nationally and internationally. At last we have found the courage to place the facts on remuneration before Congress. We hope that this body has the similar courage to grant this sorely needed remedy.

"I am also very interested in getting to you and to your law associates my deep desire to avoid witch-hunts in the anti-trust litigations which come up from time to time. I have urged before bar associates and publicly and privately, wherever I have met lawyers, that the system of fair compromise be adopted. Bring your anti-trust problems to us and we will sit down and talk them over with you."

In the course of his talk he stated that many lawyers have rejected the ideal of public service when offered judgeships on the ground the salaries are low and their obligations to families and clients too great. "There is no better service a lawyer can render than that of service to the Government. Belief in our form of government is what makes America great today," he said.

Secretary Reports Fraternity's Condition

36 Chapters Are Active

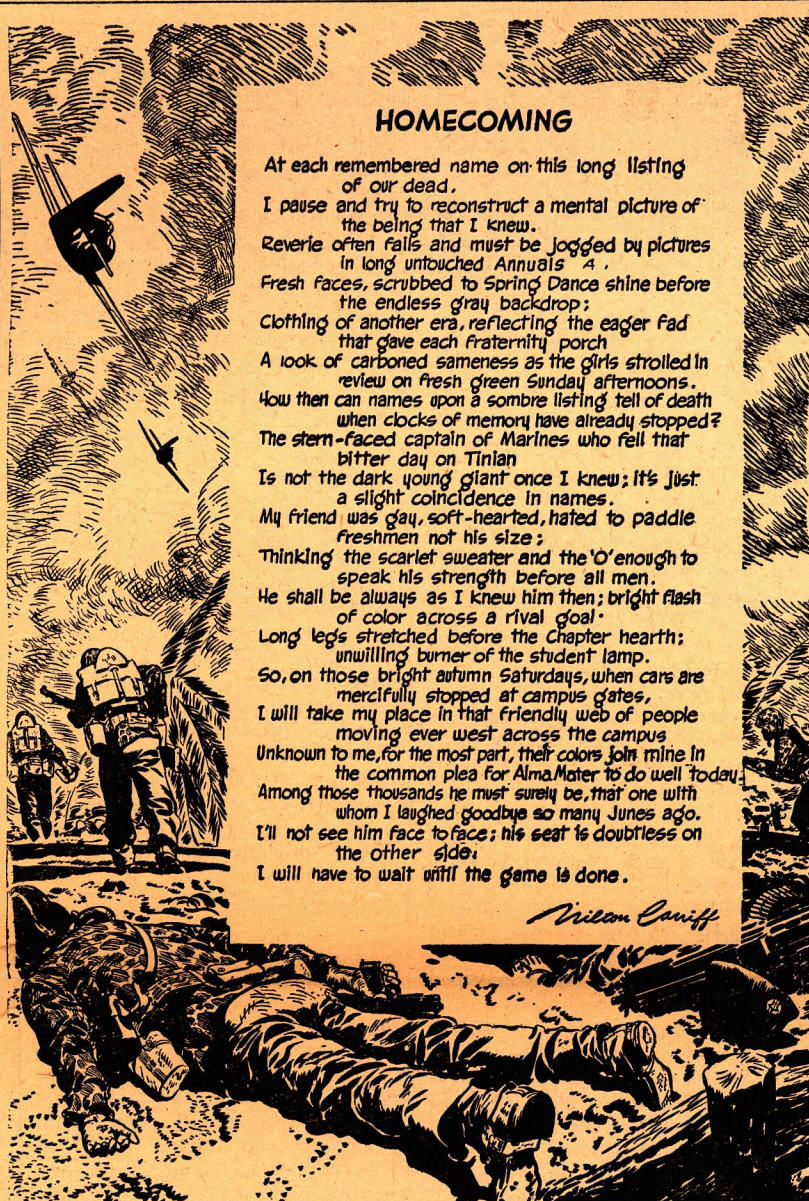
Our last report to the membership on the condition of the Fraternity was contained in the special war emergency edition of February 1945. This issue met with such universal approval, the Supreme Executive Board in resuming publication of THE REPORTER decided, for the time being at least, to use the same format instead of returning to the old book form. The Constitution and By-laws provide that each member shall receive a subscription to THE REPORTER while he remains in attendance at law school without charge. Thereafter, he must pay an annual subscription price of \$3.00 or a life subscription of \$10.00. Our mailing was very limited and no method was provided for reaching our entire membership. We found that the publication of the February 1945 issue, including the cost of mailing to approximately 17,000 members, was less than that of the magazine type with a restricted mailing list. We plan to publish another issue similar to this one between now and the next Convention which will be held in Kansas City, Missouri on December 29, 30 and 31, 1946 and it is hoped that periodic publications of this kind with a general mailing, can be maintained, even though it be decided to resume the publication of a magazine. In addition to the great advantage of bringing news of the Fraternity to all members, quarterly general mailings will make it possible for us to keep our general card file and mailing list up-to-date permitting the publication of accurate directories with greater ease and less expense.

Directory

Our last published Directory was issued in 1935. The publication of a Directory in 1941 was suspended because it was then obvious that we were about to enter World War II. Obviously the last published Directory is to a great extent obsolete. Equally understandable is the fact that our present card file and general mailing list is sadly out of date, despite the fact that much work has been devoted to maintaining it. It is hoped that the returns on this and the following issue will enable us to bring our mailing list to date and that a new and accurate Directory can be published early in 1947. *If the address to which your copy is mailed is incorrect and you ultimately receive it, you are urged immediately to write to the supreme secretary either on post card or letter giving your old and new mailing address. Please do this without delay.*

Reactivation

During the past year, your Supreme Secretary and Editor has been unable to resume many of the normal activities for the reason that all available time was devoted to Chapter reactivation and expansion. At commencement of the last school year, our roster of active Chapters numbered six. As this report is being dictated, we have thirty-six Chapters reorganized and in excellent condition. By the time this issue goes to press seven

more Chapters should have been reactivated and the new Wiley Rutledge Chapter will have been installed at Duke University, bringing our Chapter roll up to forty-four. We confidently hope to have an active Chapter roll of 50 Chapters by the time the Convention is held.

The Supreme Secretary appreciates the consideration and understanding of the Active Chapters, their officers and members, of the difficulties which have confronted him. They will shortly be rewarded with the resumption of monthly Chapter Bulletins, a new system of reports, the re-publication of the Chapter Manual, increased attention to their needs and greater supervision of their activities.

Appreciation

A detailed report of activities during the past school year would be lengthy and uninteresting. Space in this issue will not permit proper tribute to the large number of individuals who have loyally contributed their time and money to the reactivation program without which the present condition of the Fraternity would have been impossible. To them the Fraternity owes a debt of deep gratitude. Supreme Justice LaBrum resuming his law practice, after several

years' service in the Army, both at home and abroad, has devoted a vast amount of time and energy to the affairs of the Fraternity and has fully earned the title of a great P.A.D.

Finances

By the exercise of rigid economy, the elimination of all, except out-of-pocket expenses, our financial position has steadily improved and there is sufficient money on hand to take care of current operating expenses and defray the cost of the next Convention expense. Financial statement furnished on request.

Reactivation Assistance

In concluding this report a general statement on the condition of all of our Chapters is submitted. You will find in this report a number of Chapters yet to be reactivated. Your attention is directed to the fact that for the past five years, the Fraternity has had no paid officers and has relied upon the gratuitous services of its officers and members. Should it appear from the report that your own Chapter is in need of assistance we implore you to offer your services and help. Contact the Brother who is listed as heading the reactivation effort or if none is listed, write to the Supreme Secretary's office and volun-

teer your services.

Benson Chapter, Washburn Municipal University. Through the progressive and substantial financial assistance of the Topeka Alumni Chapter, Benson Chapter was reactivated on April 16, 1946 by the initiation of sixteen members. Since that time a large number of men have been pledged and the Chapter House at 1620 College has been redecorated and refurnished and occupied by the Chapter. George C. Wingerson, Clerk.

Benton Chapter, University of Kansas City. Managed to survive the war but reached an all time low for that Chapter. In 1941 they initiated six members, none in 1942, two in 1943. In 1944 with substantial help from the Kansas City Alumni Chapter, they initiated thirteen, in 1945, five, and so far this year, seven. A recently published Chapter Directory lists thirty-one members and ten pledges. Sixteen of the members and five of the pledges are veterans. The Chapter has an ambitious program, is well officered and in good condition. L. (Parky) Parker, Justice, Jim Shine, Clerk.

Blackstone Chapter, Chicago-Kent College of Law. This Chapter staggered, but did not fall. One man was initiated in 1942, none in 1943, one in 1944, none in 1945 and five in 1946. The Chapter is fighting to regain its former position and I think needs more alumni assistance. Officers are Ralph Faust, 8108 N. Kostner Avenue, Skokie, Illinois, James Greco, 3937 West Flournoy Street, Chicago. Contact Jerry J. Sereda, 5026 S. Hermitage Avenue, who is largely responsible for the continued activity of the Chapter.

Brewer Chapter, John B. Stetson University, Deland, Fla. Chapter is inactive. The Law School was closed during the war. Reopens this fall. Plans for reactivation are under way under the leadership of Clarence Thacker, Justice of Fletcher Chapter, Guy A. McPherson and J. Lancelot Lazony all of Gainesville, Fla.

Calhoun Chapter, Yale University. Chapter is inactive and conditions at Yale make reactivation improbable.

Campbell Chapter, University of Michigan. Reactivation program under direction of George E. Fink, 33 North LaSalle Street, Chicago, Illinois and Brother Forrest A. Hainline in the Law (Quad) Club, Ann Arbor, Michigan. Detroit Alumni Chapter please note.

Capen Chapter, University of San Francisco, School of Law. Chapter rehabilitated May 23, 1946 by the initiation of twelve men an account of which appears elsewhere in this issue. John Trimbur, Justice; Dennis Keegan, Clerk.

Chase Chapter, University of Cincinnati. Chapter was rehabilitated April 3, 1946 with the initiation of nineteen members, largely through the efforts of Brother Robert Toepfer, Professor in the Law School. Seventeen more members were initiated on June 20, 1946. Chapter in excellent condition. John R. Fletcher, Justice; Raymond E. Shannon, Clerk.

Clark Chapter, Washington University, St. Louis, Missouri. Chapter inactive, reactivation program headed by Brother Hugh S. Wilson, 706 Chestnut Street, St. Louis, Missouri.

Oldtimers Honor John Doyle Carmody

Col. John Doyle Carmody (Taft) was elected Supreme Treasurer of Phi Alpha Delta at the 10th Convention in Chicago, Illinois, May 22, 1909. He was elected Supreme Justice at the 11th Convention and re-elected as Supreme Justice at the 12th Convention. Brother Carmody was largely instrumental in bringing about the installation of Rapallo Chapter at New York University on February 20, 1909 (and installed the New York Alumni Chapter March 28, 1911). The Chicago Alumni Chapter issues a monthly publication called *The Dictum*.

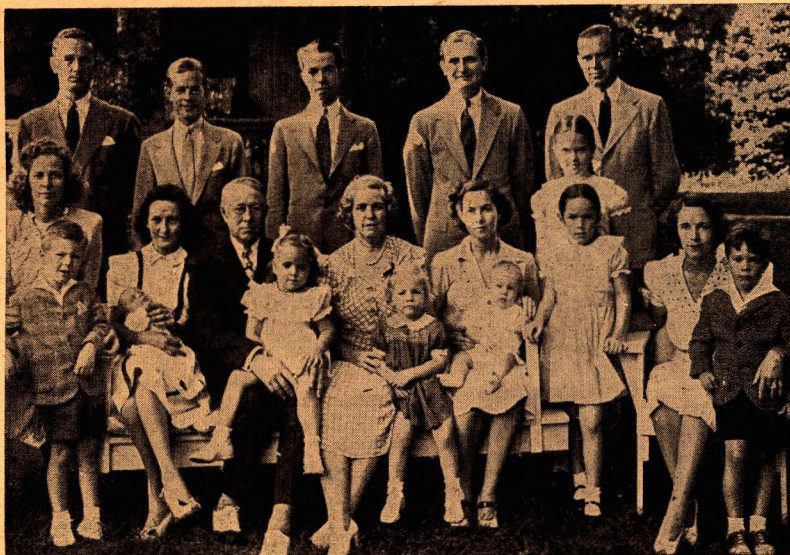
Los Angeles Alumni Chapter

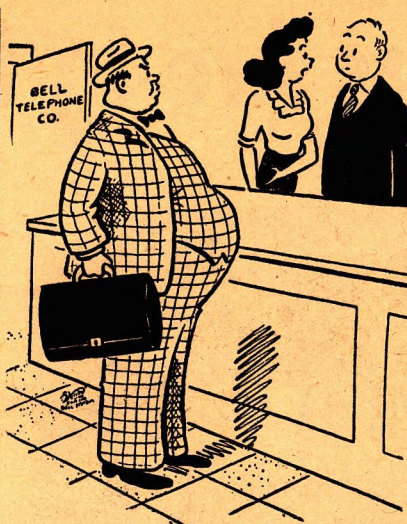

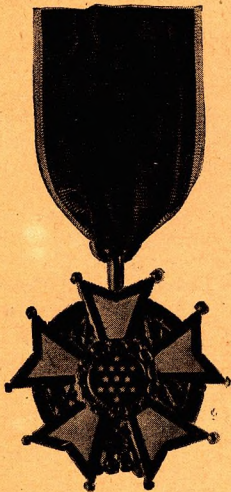

Col. F. L. Orth Awarded the Legion of Merit

ATLANTA, GA.—Col. Franklin L. Orth, Director of Military Personnel, Headquarters Fourth Service Command, has been awarded the Legion of Merit for his outstanding work in the Military Personnel Division, Army Service Forces, in Washington prior to being assigned in Atlanta. Major General Edward H. Brooks, commanding general of the Fourth Service Command, presented the medal to Col. Orth before he reported for separation from the service.

Coming on active duty in Jan. 1941, Col. Orth served at Camp Grant, Ill., Military Personnel Division, Headquarters ASF in Washington, and with the overseas replacement division on the War Department General Staff. He reported to the Fourth Service Command in August of this year.

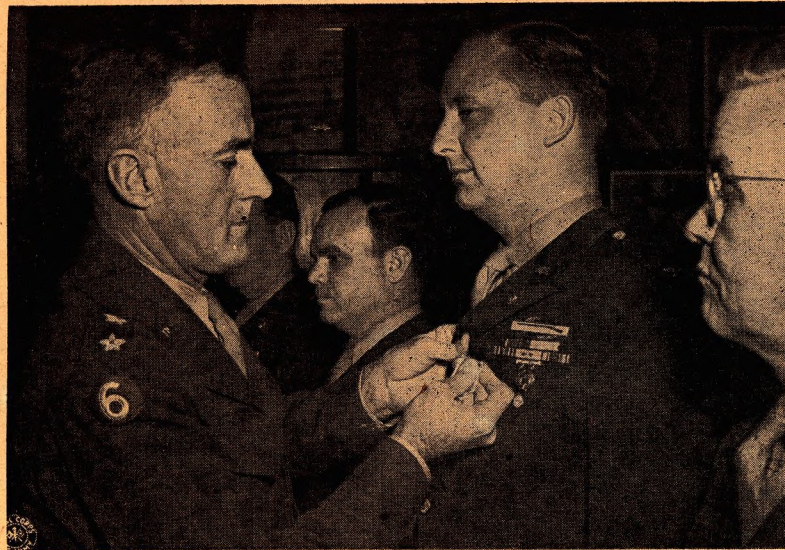
In December, 1943, Col. Orth volunteered for a tour of particularly hazardous duty in the China-Burma-India theater with the famous Merrill's Marauders. He served as battalion commander of the 2nd battalion, 475th infantry for 13 months and wears the Presidential Unit Citation, Bronze Star, American Theater ribbon and the Asiatic theater ribbon with two battle stars.

Col. Orth has graduated from West Division High School in Milwaukee and was graduated from the *University of Wisconsin* with degrees in both *economics* and *law*. Following graduation Col. Orth stayed at the university to coach crew and football for two years and then practiced law in Milwaukee with the firm of Orth and Orth. Col. Justice Edmonds Talks to Revise Phi Alpha Delta

In an auspicious inaugural gathering, the University's Capen Chapter of Phi Alpha Delta Law Fraternity began its postwar reactivation at The Bostonian Restaurant in downtown San Francisco.

Special guest at the occasion, which marked the formal rebirth of one of the University's outstanding fraternal organizations, was the Honorable Douglas L. Edmonds, Associate Justice of the Supreme Court of California. Marvin Giometti, Justice of P.A.D., was toastmaster.

The event commenced a series of monthly dinners at which leading jurists and dignitaries of the State Bar will address members of Phi Alpha Delta. Officers who will assume duties following next month's initiation are John Trimbur '48, Justice; Dennis Keegan '48, Clerk, and Allison Rouse '47, Treasurer.

Justice Edmonds, second ranking senior member of the State's highest court and a leading member of the fraternity in California, in his address to the group of student and alumni members, gave encouraging assurance that the field of the law today is embarking on a scale of activity that will create expansive opportunities in the decade to come for young lawyers.

Stressing the relatively recent attitude of the high courts of the land to engage in vigorous dissents to legal problems presented to them, the Justice granted that such an attitude is healthy, but is, in reality, the "inevitable out growth of change—in fields of commerce, of sociology and of human relations."

He stressed, also, the importance of a sound college training that is expertly woven in a pattern of competent instruction and amiable fellowship. "If for no other reason," he stated, "a young man of today should pursue a college education for the purpose of developing the power 'to think' soundly and reasonably."

Justice Edmonds remarked that in his experiences, he has found that today more than ever before, the tendency has been to employ college graduates in positions of responsibility to the utter exclusion of others. The fields of taxation and administrative law were singled out as realms of opportunity for the law graduates of today.

The balance of his address concerned an informative tabloid discussion of the workings and machinations of the Justice's favorite concern—The Supreme Court.

Brother Floyd L. Croxton (Harriman), is now practicing law in the Oare Building, Cherokee, Oklahoma.

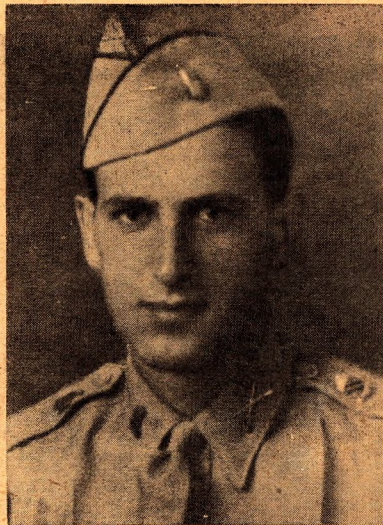
William S. Sparks (Field), was in the Philippines with the armed forces.
