This present good feeling for rancient profession has made self felt in many directions. on the lawyer for assistance all affairs touching any hase of law. There is accepance and recognition of lawyers Bleaders in every field of community and public life. Most immant-there is solid public respect for courts of law and the judicial system.

But none of us lawyers and judges is so naive as to suppose hat our present good state of polic relations just "happened" or that such relations cannot and should not be further improved-or that we may now est on our oars and content our-Elves with reaping the monebry rewards of public accep-

The fast is that such standing s our profession has today in mitage of long years of dediated effort by man yindividual lawyers and their associations. The fact is that there still is a mongnized and can be effectively lealt with. The fact is that, should we relax in a spirit of untentment with what has been Mileved, public esteem will surely wane.

Dean Roscoe Pound has graph-Mally portrayed the public standing of American lawyers from colonial times to the wesent day. When the colonies were first formed, there was a very definite attempt to get along without lawyers altogether. In an effort to accomplish this, laws were enacted lorbidding the charging of legal fees, or fixing very low fees. Other laws strictly limited the number who could engage in the practice of law, or specified conollions of admission which necessarily produced that re-sult. Still others established alternative methods of obtaining Justice which wholly circum-vented judicial process—as by the Pennsylvania system of conciliation by "common peacemakers." Many of these enactments contained most uncomplimentary recitals concerning lawyers and their profession.

Pound was able to report that, "by the time of the Revolution, the legal profession in most of the colonies had become well established in public estimation, well educated, and well qualified by study of law." In some colonies, effective bar organizations were already in existence, and the old prejudice against lawyers had all but worn away bee is ever-increasing reliance Twenty - five of the fifty - six signers of the Declaration of Independence, and thirty-one of the fifty-five members of the Constitutional Convention were lawvers.

From the American Revoltion to the 1830's, which Pound calls the formative era for American law and legal institutions, the fortunes of the legal profession in this country were constantly ascending. It was a time for great judges- John Marshall, Joseph Story-and for great lawyers-William Pinckney, William Wirt, Jeremiah Mason, Daniel Webster, Rufus Choate.

Then, about the mid-1830's, the pendulum again began to swing the other way. Between 1836 and 1870, there was a near breakdown of organization, education, and professional training.
But with the development of

the present-day type of bar association in the 1870's, there was a revival in the profession, which be public eye is the direct has continued to this day. The organization of the American Bar Association, in 1878, gave impetus to this movement. The development of integrated state bar associations, bginning with North Dakota in 1921, added stability and substance. The reorganization of the American Bar Association, in 1936, to create a House of Delegates, added new force and vigor. The tremendous increase in local bar associations and the expansion of their activities brought needed grass-roots

The fact that our profession in stature at the same time that effective bar associations have been spawned and activated is no coincidence. Led by unselfish men of vision and energy, these organizations have been ferreting out and correcting the major causes of public dissatisfaction with our profession. This dissatisfaction, in so far as it has merit and is therefore subject to correction, per-tains to the dishonesty and incompetency of some lawyers, and the inadequacies and delays in the judicial system itself.

These organizations have also been taking effective steps to overcome a misunderstanding on the part of the public, which has prejudiced our profession in the past. This misunderstanding arises partly from the fact that the practice of law involves, as in the case of no other profession, a clash of personal interests. Each litigant usually feels that justice is on his side. So, in each case, there is likely to be one litigant who feels strongly that justice has miscarried.

Misunderstanding also arises from the fact that lawyers (Continued on Page 6)

Message From The Supreme Justice

Upon them falls the task of maintaining direct contact with active and alumni chapters within their respective geographical districts. Each of our District Justices has performed his job well during the past year and the current year gives promise of even more visitations and contacts by them.

All these men who serve in this capacity do so without any monetary remuneration whatsoever. Each devotes countless hours, days, nights and weekends to the execution of the duties of his office. The purpose of this newsletter is to acquaint you with these men who are performing so splendidly a yeoman's task.

In District I, comprised of the states of Washington, Oregon, Idaho and Montana, George T. Nickell, of Seattle, Washington, labors as District Justice. Brother Nickell has served as District a strong unit. Brother Nickell is in the private practice of law in Seattle and is a former partner a PAD. Brother Nickell visits all of his chapters at least annually and his current plans include visitations again to all chapters.

Nevada and that portion of California lying north of the Tehachapi Mountains is governed by John R. Griffin, who is Justice of District II. John is a partner in the well known law firm of Gaylord and Gaylord. Visitations have already been made to two of Brother Griffin's chapters and others are scheduled for the remaining chapters.

Brother Day works closely with the University of Utah chapter and visits the other chapters in his District when he occasionally journeys to Denver, Colorado to try federal cases. In addition to chapter visitations, Brother Day plans to attend the initiation by Hughes Chapter of Frank H. Hall, Colorado Supreme Court Justice, and the initiation, in the near future, of Governor Stephen L. R. McNichols of Colorado by Gunter Chapter.

One of the sturdiest workers in the vineyard is T. Julian Skinner, of Alabama, Julian is a Past President of the Junior

Bar Association, a Past President of the Alabama Bar Association, and a former member of the House of Delegates of the American Bar Association. So he is abundantly equipped to render great service to an organization such as P.A.D. Throughout the past year he has made a stupendous contribution of time and talent to the fraternity and his plans for the current year demonstrate that his interest and energy are unflagging.

A man with an enormous job is Robert J. Gorman, for he has an extremely large district containing eleven chapters. The states in his bailiwick are Illinois, Michigan, Indiana, and Wisconsin. Brig. Gen. J. Harry LaBrum Honored **Upon Retirement**

Brigadier General J. Harry LaBrum (U.S.A.R.) was honored last September 14 by a garrison review on the occasion of his retirement.

LaBrum, a member of Taft Chapter at Georgetown University, is a Past Supreme Justice of the fraternity, having held the fraternity's highest office for eight years (1938-46). He entered military service in June of 1942. Since that time, both on active duty and as a member of the United States Army Reserve, he has made many significant contributions to our national secur-

Some of his assignments have included cost analysis and contract renegotiation tasks with the Signal Corps Procurement District of Philadelphia. Later he served as legal officer of both the Signal Corps Eastern Signal Service and the Signal Corps Legal Office, which was located in Philadelphia. For over twelve year he has willingly served as an informal consultant to the various Chief Signal Officers of the Army on supply and legal matters.

LaBrum's honors are many and varied. Some of them are as follows: Chairman, Section of Insurance Law, American Bar Association (1946-47); Fellow American Bar Foundation; President (1957-58), Federation of Insurance Counsel; American College of Trial Lawyers; President Chamber of Commerce of Greater Philadelphia (1952-54); Army Commendation Ribbon; Award of Legion of Merit; Order of the Crown of Italy, and President, Philadelphia Council of the Boy Scouts of America (1956-57).

He is one of the senior partners of the law firm of LaBrum and Doak, in Philadelphia and he is a member of the Philadelphia, Pennsylvania and American Bar Associations and the Inter-American Bar Association, the International Association of Insurance Counsel, and the Association of Insurance Attorneys.



Former Senator Herman Welker Dies

A former Senator from Idaho, Herman Welker, died at the age of 50 only recently. The political figure had practiced law in Los Angeles until 1943.

While he practiced law in Los Angeles between 1938 and 1943, Welker handled legal affairs of such film notables as Bing Crosby and the late Wallace

After one six year term in the Senate, he was defeated only last year.

He was born in Cambridge, Idaho, and received his law degree from the University of Idaho where he became a member of Kent Chapter of Phi Alpha Delta.

He was District Attorney of Weiser, Idaho, when Wallace Beery persuaded him to come to Hollywood to represent the star in contract negotiations.

In 1948 he was elected to the Idaho State Senate from Payette County. In 1950 he moved up to the United States Senate in a campaign marked by support from Crooner Crosby, owner of a Alpha Delta ranch in Idaho. He also served as In 1942 Bro a part time baseball scout for the Pittsburgh Pirates, which was partly owned by Crosby.

Since his last political defeat, Welker had practiced law in Boise, Idaho, but collapsed twice while in the capitol last year.

George Morris Fay Dies

On November 17, 1957, George Morris Fay (Taft Chapter), former United States Attorney for the District of Columbia, died from cancer in Washington, D.C., at the age of 48.

Brother Fay was appointed United States Attorney for the District of Columbia by former President and brother PAD Harry S. Truman in November, 1946, and served in the capacity of the District of Columbia's top prosecutor from that time until 1951.

In 1948, Brother Fay headed an unprecedented grand jury investigation into gambling activities in the District of Columbia, culminating in the conviction of a number of well known gamblers. Much of the investigative work was carried out directly by Brother Fay's staff. In recognition of his outstanding performance of duty, he was renominated for a second four-year term by President Truman in 1951 but resigned to form the law firm of Fay and Anderson in partnership with H. Loy Anderson, President of the Metropolitan Mortgage Company and a former local director of the Federal Housing Authority.

He continued in private practice until his death with the exception of a brief period in early 1956 when he served as General Counsel of the Senate Special Lobbying Investigation Commit-

Later he became the Navy's liaison officer with the Congressional committee investigating the Pearl Harbor attack.

Following World War II he returned to the Attorney General's Office and worked wih William O. Dwyer, later to become mayor of New York City, in the prosecution of war fraud cases. It was from this post that he was nominated for the position of United States Attorney for he Supreme Court District of Columbia.

Surviving Brother Fay are his wife, the former Dorothy Donovan; five children, Mrs. Richard Pa.; three sisters, Mrs. Marshall Jordan, Maywood, N.J.; Mrs. Warren Heeg, Forest Hills, N.Y., and Mrs. John J. Dempsey, Plymouth, Pa., and two brothers, Joseph, Kingston, Pa., and William, Kenwood, Md.

ABA Mid-Year and Southern Regional Meetings to Attract Record Crowds

What is expected to be the largest gathering of lawyers in the history of the Southeast will be held in Atlanta, Ga., next month when the American Bar Association holds its Mid-Year and Southern Regional meetings concurrently in that city Feb. 19-25. The dual programs will be filled with important professional events and top personages in the field of law, education, and government.

There will be seminars and panel discussions on no fewer than 23 subjects of current interest to the practicing lawyer. Well over 60 speakers and panel participants will take part in the various regional meeting programs.

Starting with the nine-state Southern Regional meeting Feb. 19-22, and continuing with a crowded Mid-Year meeting calendar embracing sessions of the ABA Board of Governors, the National Conference of Bar Presidents and The Fellows of the American Bar Foundations, the series of events will wind up Feb. 24-25 with sessions of the House of Delegates.

Among other things, the House scheduled to receive the widely-debated report of the American Bar Foundation recommending revision of the text of Judicial Canon 35, but retention of its present ban against news or television cameras and radio microphones in court rooms during trials.

Indications are a special hearing will be held before the House on the Canon 35 report, with representatives of the press, radio and television industries being given an opportunity to be before any final House action is taken.

One of the highlights of the Southern Regional meeting will be the presentation of a special program on the "Law of Outer Space." Speakers on that panel will be Thomas E. Dewey, chairman of the ABA's new Committee on International Law Planning; Dr. Ernest Stuhlinger, research chief of the Army Ballistic Missiles Agency, and John Cobb, professor of international air law at McGill University, Montreal.

Other key regional speakers and panel participants will be John Davis Lodge, U.S. Ambassador to Spain and former governor of Connecticut; David Sarnoff, chairman of the board of the Radio Corporation of America; Sir Leslie Munro, New Zealand's ambassador to the U.S. and President of the United Nation Assembly; Justice Tom C. Clark of the U.S. Supreme Court and Victor R. Hansen, chief of the anti-trust division of the Justice Department.

Besides the seminar on space law there will be workshops on the economics of law practice, methods of financing small businesses, use of the blackard during trials, trial of a fraud case, income tax problems of small busineses, bankruptcy proceedings, labor relations law and mony others. In all, 24 of the Association's sections and committees are sponsoring special programs during the regional meetings. (Continued from Page 1) ordinarily hold themselves out to represent litigants on either side of a controversy, and lawyers fraternize socially while representing adverse interests. To many a layman, this looks like insincerity, to say the least.

Once we recognize these major causes of dissatisfaction and misunderstanding, we may, as individuals, and through our bar associations, adopt a course of action designed to remove them or lessen their detrimental effect. This is just what has been going on, especially during the last twenty years.

But, as I have said before, retention of the gains already made and the overcoming of such discordant public reaction as may persist require constant thought and work.

The responsibility of the individual lawyer in this undertaking is a heavy one. He has it within his power to add to or detract from not only his personal standing as a lawyer, but the standing of the legal profession as a whole. Howard L. Barkdull, in his annual address as president of the American Bar Association, in 1952," put it this

"I submit that in the long run the most effective way for the profession of the law to improve its relations with the public and to bring about a more favor-able attitude toward the lawyer on the part of the people is by deserving such an opinion on the basis of conduct and performance."

A Lawyer's Responsibilities

There is no mystery as to the kind of conduct and performance on the part of lawyers, as in-dividuals, which will maintain and strengthen public relations.


First, there must be constant and exacting adherence to the high ethical standards of our profession. The built-in conscience and sense of decency with which every man comes equipped ordinarily provide all that is needed in the way of standards of right professional conduct. For the doubtful or unusual case, the forty-seven canons of professional ethics, first formulated in 1908, provide detailed guides which should be regarded as controlling.

Maintenance of high ethical standards, however, require more than individual adherence to the accepted code. It calls for the exercise of a lawyer's moral force in obtaining adherence by others. It calls for the willing cooperation and assistance of all lawyers in effectuating the established disciplinary procedures of the bar and courts. The true attitude must be, "Who sullies the profession, sullies

maintain a high degree of comptence and skill as a legal technician and craftsman. In our complicated civilization of today, this calls for a constant and purposeful effort by each lawyer to keep himself abreast of current legal thinking and writing, and significant changes and developments in both legislative and court-made laws.

Modern Tools

There are modern tools and facilities available to all attorneys for carrying on this post-admission legal education. A third responsibility which the individual lawyer must accept is to render legal service without expectation of compensation in those instances where justice cannot otherwise be attained. Few of us can measure up to George Wharton Pepper's record of devoting five-eights of his total output in time and effort to legal services for which there was no possibility of compensation. But perhaps we do, or should, at least come up to the standard disclosed by a recent survey conducted in the state of Oklahoma. The average lawyer in Oklahoma, according to this 1953 survey, spends 46.7 hours per week in legal services, and 5.9 hours, or 13 per cent of the average work week, in legal work for which he knows he will not be compensated.

A fourth responsibility of the lawyer is to make an individual contribution in time and effort towards the improvement of the administration of justice. As President Theodore Roosevelt put it: "Every man owes some of time to the upholding of the profession to which he belongs.

The drive to improve judicial administration in this country received its initial impetus from something which happened just a little over fifty years ago. I refer to that remarkable address made at the 1906 meeting of the American Bar Association by a young Nebraska lawyer, then known to few, but now recog-nized and respected by lawyers

Nor has the influence of Pound's address abated since Wigmore wrote. As late as 1949, in his introduction to the work on the Minimum Standards of Judical Administration, the late Chief Justice Vanderbilt of New Jersey said that Pound's 1906 paper "should be required reading once a year for every judge, lawyer, law professor, and studen on the day he returns from his summer vacation and faces his work anew."

One way in which a lawyer can contribute to the improvement of the administration of justice is to take an active interest in one of the many organizations which are now engaged in this great enterprise. Among these is the American

York University's annual survey teen sections open to any lawyer of the law. related national organizations as the American Judicature Society, the American Law Institute, and the National Conference of Commissioners on Uniform State

> Perhaps as important as, or more important than, any of these are the local bar associations such as the Bar Association of San Francisco. Local organizations, serving close to the lawyer and to the courthouse door, are in a position to identify problems as they arise. They can foster new precedures and techniques which need to be practiced on the local level before being proposed for general acceptance. They afford an opporunity for service to lawyers who may find it impracticable to accept responsibilities in a national organization. Above all, they provide indispensable grass-roots support for the great nation-wide projects sponsored by the national organizations.

A fifth responsibility of the individual lawyer in upholding the dignity and prestige of the profession is to seek and accept positions of leadership in the educational, cultural, patriotic, charitable, and political life of the community. The lawyer can and should be the directing or stimulating force in most of the worthy group activities of our people. This opportunity is his because he is, as F.D.G. Ribble has said, the technician of democracy, the specialist in man's relation to man. To the extent that lawyers accept this responsibility, the stature of the entire profession is enhanced.

HEAR TIMBERG

On Monday, November 4, 1957, Sigmund Timberg, a prominent Washington, D.C., anti-trust attorney, addressed approximately sixty-five members and guests of the Washington, D.C., Alumni Chapter of Phi Alpha Delta at a luncheon meeting held at the Touchdown Club, on the subject of the du Pont-General Motors Case, which held that acquisition of stock of a customer corporation may be in violation of the antitrust laws.

Mr. Timberg referred to the decision as a bombshell or "corporate sputnik" in antitrust and corporate circles, stating that the decision had reached back to hold invalid a forty-year old transaction and applied Section 7 of the Clayton Act for the first time to a "vertical" stock acquisition, i.e., the acquisition of stock in one concern by another concern which is the market for its products. The speaker discussed the case in some detail and indicated various problems presented by the Government's proposal that the du Pont group divest itself of General Motors
