It Was A Prayer for Owen Meany and a Revelation of Courage for Me

So, this was the face that was behind all of the anonymous letters my English department had received this past school year. Her pursed lips pressed tightly into a frown, her hair pulled up into a precise bun and her dark pupils staring past the point of eye contact established a strong tension in the room. As I was seated across from her at the large conference table, I knew this meeting was about more than a book.

As I planned my first semester as a high school English teacher, I struggled to find a book in my school district's curriculum that l both literary merit and appeal to teenagers. I still was not convinced I had found it when the English department decided that John Irving's "A Prayer for Owen Meany" would be the semester's required novel. I was worried that a 600page novel was too intimidating; I feared I would lose half of my students' interest before they even opened the cover. However, as we started to read the novel and dive deep into its plethora of meanings, I noticed a phenomenon. My students were actually reading, discussing and enjoying the book!

It was around this time when I received the first anonymous letter in my staff mailbox. It was a letter full of venom spitting at the lack of morals and obscene language used in "A Prayer for Owen Meany." It was a letter with a message, a letter with a mission, a letter to ban a book.

After months of meetings, and committee reviews with this parent, "A yer for Owen Meany" was approved and praised for young adults to read by the district's administrators, teachers and community members. However, this verdict was not

enough for the lady who lacked the courage to sign her name to her complaints. She carried on her mission. She collaborated forces. She sent misleading quotations to 70 community members defacing our English department and our decisions. She did not want to stop the readings of a novel; she wanted to censor a book and the teachers who taught it.

This is how I wound up in a cold, barren conference room staring tensely across the table from the frowning parent. As she started to speak, her shrill voice brought back the many vicious letters she had penned. Her words about "A Prayer for Owen Meany" made it obvious that she had spent her time counting how many "God Damn It(s)" were on a page rather then noticing the overriding theme of a need for faith in life. I thought to myself, "How can this be stopped? Do I have any authority as a first year teacher to speak up and confront this parent? Where is my courage to speak out?"

I did not snap back to the cold reality of the meeting until I heard her say, "It is up to you as teachers to pull this book. Only you guys can make the right decision and not teach it in your classrooms. It is the teacher's responsibility to take "A Prayer for Owen Meany" off of the shelf." As I digested the implications of her words, I wondered how this woman had the audacity to imply that it was my job to censor a book.

My eyes darted from my colleagues, to my department chair, to my principal, to my superintendent as I waited for one of them to reply to her absurdity. I waited for one of my superiors to explain that censoring should not happen in the classroom. A teacher's purpose is to expose

her students to new worlds, new ideas, new opportunities they might not find on their own. I thought adamantly to myself, "I do respect this parent's right to control what her child is exposed to in school, but this parent does not have the right to take away that opportunity from every student."

Instead of hearing the uproarious clamor that was going on in my head break out in the conference room, I was deafened by the silence. Nobody protested, nobody defended, nobody said anything. It took all my will to keep my thoughts—my beliefs—in my head. I shamefully contributed to the silence; I muted my own voice. I lost my courage.

As the meeting came to an end, we muttered the forced goodbyes. I knew we would all agree on how wrong this parent's request was as soon as the she left the room. Instead, the silence continued. I knew then that I was fighting a battle on my own, and cowardly that battle was being confined in my head.

As a group of teachers, we knew there was strength in numbers; we knew we had to stick together on our potentially precarious next actions. As we silently looked at one another, the air seemed to thicken like a depressing fog. The silence was broken when one beaten teacher said, "I don't want this issue to be the defining moment of my teaching career."

My entire body screamed, "Why not?" but my stubborn mouth remained tightly shut. As the other teachers shook their heads in agreement, I hung my head low. I had been defeated, both by my employment and by myself. I had contributed to an act of censorship. I hadn't the courage to stand up for what I believed in.

As the school year finished up and a new one began, my cowardice of compromising my beliefs remained in the forefront of my mind. My participation in censorship invaded my thoughts daily. I could not get over my individual right of protest being hushed by my colleagues, my community, my superiors and most regrettably myself. If I had that moment back, I would shout my protest. My voice



I was formally sworn in as the 24th Governor-General of the Commonwealth of Australia on 11th August 2003 for a three-year term. The office of the Governor-General of the Commonwealth of Australia was established by the Australian Constitution in 1901 – the year of federation of the six Australian states.

The Constitution describes the Governor-General as The Queen's representative. Queen Elizabeth II, Queen of Australia, appoints the Governor-General on the advice of the Australian Prime Minister and under the provisions of the Letters Patent relating to the office. The office of Governor-General is non-political and quite distinct from that of the head of government.

Under Australia's system of parliamentary democracy, the executive power of the Commonwealth is vested in The Queen and is exercised by the Governor-General as her representative. In practice, however, the Governor-General exercises usually all of those powers in Australia but acts in the main on the advice of the Prime Minister and the members of the Federal Executive Council (I will refer to that body further on in this article).

The Governor-General fulfils many important roles – constitutional and governmental, community relations, defence and ceremonial.

Constitutional and Governmental

The constitutional role is not a purely formal one. The Governor-

General determines the machinery of Federal elections for both Houses of Federal Parliament (the House of Representatives and the Senate), dissolves the House of Representatives and issues writs for new elections. In late October I commissioned the Prime Minister and other ministers following the results of the 2004 federal election held on 9 October.

The Governor-General may, in certain circumstances, act on his own initiative or exercise his own discretion. This does not mean that I question government policy, but I am obliged to scrutinise matters brought before me to be satisfied that the processes of government are conducted lawfully. As referred to earlier, the Governor-General presides at meetings of the Federal Executive Council.

Executive Council processes the decisions of Cabinet, fleshes out legislation by way of regulations, and enables the mechanisms of government to continue smoothly. At those meetings, acting on the advice of ministers, the Governor-General also makes regulations and appointments including judges, ambassadors to foreign countries and senior military chiefs and government officials. The meeting is attended by two or more ministers, and in no way is it an occasion to 'rubber stamp' the paperwork of government.

It is not my business to interfere in government policy making and decisions, however Executive Council is one of the 'checks and balances' mechanisms in the process of governance, in which I have to be assured that the matters being put before me have both constitutional and legal authority. I also welcome the constructive opportunities I have question, to seek more information, to offer advice and to raise issues.

After the formal meeting is completed, I take the opportunity to present feedback and to put forward my observations about activities I attend and communities I visit throughout our nation.

On separate, regular occasions, it is the Governor-General who gives assent to the legislation passed by both Houses of the Federal Parliament.

In essence, the Governor-General's role is to protect the Constitution, to secure the orderly transition of governments, and to facilitate the work of the Federal Parliament and government.

Community Relations

Possibly the most visible role of the Governor-General is to encourage, articulate and represent those things tunite Australia as a nation. As Governor-General I am patron of many organisations. I travel throughout Australia to participate in important local events and activities where I can support the work of community and volunteer organisations, disadvantaged individuals and groups, and recognise the contribution of all Australians in advancing Australia as a nation — a nation of excellence.

Through my program my wife and I support the Australian community in all its forms, especially through the 180 not-for-profit and philanthropic organisations of which we are patron. Through my speeches I publicise widely the skills, innovation and technological achievements of our citizens especially in agriculture, mining, education, medicine, the arts and in military operations. Of special interest to me is the cause of young Australia particularly in education, youth group participation and family cohesion. As

would be heard. My teaching career would be defined by standing up for what I believe in. I would have the courage to represent the voice that others feared to hear.

Although this experience led to one of my most regrettable actions, I have learned the most about myself because of it. Now I know that I need a career where I am encouraged to speak up. I need opportunities to defend what is right. I need to encourage other people to shout their beliefs when they are silenced by outside forces. I need the opportunity to let my voice be heard. I once thought the world of education provided these opportunities, but now I see I must start from the top. I must be a representative of human rights, a spokeswoman for the law.

With the Fall Semester quickly ending, it's time to once again remind chapter clerks (and other officers) of a few key dates!








- 3. All membership applications and initiation fees are due to the Executive Office within 10 days of a person's initiation. If an initiate misses the ceremony, send the application and fees in with a note indicating that they will be initiated at a later date. This way the chapter doesn't run the risk of mishandling the membership materials.
- 4. Spring Initiations should be held no later than the first week of March. The applications and materials are due within 10 days of the initiation date.
- 5. Officer elections must be held no later than March 30th (with officer transition to be held within 10 days)
- **6.** Fall 2005 chapter calendars must be submitted by April 15th.

What Does It Take to Be a Good Clerk?

So often, when we see articles like these, we hear about what not to do as an officer. Generally, these stories are filled with chapter horror stories about how the officer failed at their job. Take heart because I'm going to give three thoughts that will help you be a successful chapter clerk.

1. Organization

The chapter clerk must be organized. As custodian of all chapter records, you cannot haphazardly do your job. Admittedly, record keeping can be tedious and sometimes boring. However, the clerk is the lifeline of the chapter.

So, how does the clerk stay organized? First, sweat the details. Success lies in the little things. For instance, when you get your applications turned in, makes copies of them to use them as a checklist when you hand out pins and certificates later. Second, take notice of all the awards for which your chapter qualifies. Fill those applications out throughout the semester. Third, I would recommend purchasing a pen drive. They hold more information

than a 3-1/4 floppy disk and they are smaller. Thus, you can store more information in a less cluttered manner. Finally, find someone you can



mentor. This way, you not only have someone ready to take over for you next year, but you also someone who can help you with your responsibilities.

2. Communication

The way you communicate to the law school impacts the health of the chapter. Sending notices out in a timely fashion not only reflects good organizational skills, but it also shows good communication skills. When you distribute notices to the chapter or to the school, make them appealing—use color in your advertisements. Additionally, get the notices out early enough so that your members can plan to be at the program. A good rule of thumb when I was clerk was to give notice for events at least two months in advance.

Also, keep in touch with Executive Office. We are here to answer any questions, dispel any rumors, and calm any fears you may have. We love to hear your good news and help you work through chapter problems. Make sure and send us your


Make A Difference Day - Hayes Chapter

Van Zandt Chapter Helps the Homeless






Fleming Initiation

South Africa

The externship includes an intensive weeklong course covering environmental and administrative law at Pace Law School and a minimum seven-week work experience in Washington that includes weekly classes taught by a Pace faculty member.

Brazil Comparative Environmental Law – A short course held in late May and early June involving an intensive oneweek course on Brazilian law at Pace Law School followed by a week of classes, meetings, and field trips in Brazil. The course is cosponsored by the Rio do Janeiro City Attorney's Office.

CHINA or IRELAND

The University of Missouri Kansas City School of Law of two unique summer law study abroad opportunities.

The China program, at Peking University (Beida) in Beijing, China, is a comprehensive survey of Chinese law and political and legal institutions. Classes are conducted in English by leading Peking University faculty. Students live on campus, interact with Chinese law students, and sightsee in and around Beijing. Coursework begins Monday, May 16 and ends Saturday, June 4, 2005. \$2,500 includes 4.5 hours of transferable ABA-approved academic credit, instructional fees, books and materials, on-campus housing, field trips, tours (including the Great Wall, Summer Palace, Tiananmen Square and Laama Temple), and a farewell banquet. An optional externship opportunity is also available.

The Ireland program is conducted in phases at three differ locations in Ireland; Dingle, Galw and Dublin. It focuses on the law of the European Union, doing business in Ireland, and international human rights. Classes are taught by distinguished Irish and American faculty. Coursework begins Monday, May 16 and ends Wednesday, June 15, 2005. \$3,995 includes six hours of transferable ABA-approved academic credit, instructional fees, books and materials, housing, field trips, tours, and social events. Student accommodations include private bedroom, common living area, and kitchen. Both programs are open to US and foreign law students in good standing who have completed at least one year of study before the start of the program.



Pre-Law Advisory Council Report

The Pre-Law Advisory Council (PLAC) wrapped up the first quarter of the 2004-2005 year on November 7, 2004 with an excellent meeting held at the conclusion of the Pre-Law Conference at the Crystal City Hilton in Washington, D.C. The Conference itself was an enormous success and the Council members can attest to the energy, ambition, quality and value that our prelaw Student members possess. Many thanks go out to the numerous students and faculty advisors that took the time to talk to me and other PLAC members throughout the Conference and who gave me frank and valuable thoughts as to how we might improve the pre-law program.

The PLAC is pleased to welcome a new pre-law student representative. Tanner Coleman of William Woods (and co-counsel on the winning Mock Trial team at the Conference competition) has en appointed to replace Shelby Allen, Jr. Mr. Coleman is currently a sophomore and we look forward to working with him over the next two years.

In accordance with the mandates established at convention, the PLAC has undertaken the tasks of finding better ways to track pre-law students beyond graduation, regardless of whether they attend law school or not. As a part of this effort, our subcommittees are considering and evaluating many issues and proposals for possible International Board action, including:

- studying or creating a fee structure for pre-law members who do continue on to law school
- creating a joint networking opportunity for graduates of our prelaw and law school systems, whereby our PAD members could have joint events with leaders in other fields (business, philanthropy, theater, real estate, etc.) as well as those in the practice of law
- devise a parallel volunteer/staff infrastructure devoted solely to prelaw members but governed by the International Executive Board
- looking into formal pre-law alumni programs for those who do not go on to law school.

In a step towards better communication and increased service provision, PLAC member Mara Harvey has been appointed to head the Council's electronic communication subcommittee. Mara looked into the viability and utility of reviving the pre-law dedicated listserv. She found that many pre-law students felt such a listserv was too limiting and would not give them the interaction they were looking for with law students and alumni. However, she has started an initiative to look into the possibility and feasibility of an electronic discussion board. Mara's committee will look into the costs and potential popularity of such a medium and will submit this issue to the IEB for consideration and review. An update will

follow in the next issue of the Reporter and by means of the PAD listset.



Another project beginning to take shape under the direction of the PLAC is a pilot event to test the productivity and viability of an inter-profession, multi-trade networking event open to all graduates of the PAD pre-law and law school systems, whether in the practice of law or otherwise. This event would be designed to provide our Executive Board with targeted test results for evaluating the likely value of such coordinated interaction. A report and possible proposal for such events will be submitted to the IEB for further evaluation and analysis. Substantive additional details on this exciting concept will be provided as they are generated.



Lowenstein Chapter Raises Money For Pediatric Cancer Research

On October 5-6, 2004, Lowenstein Chapter sold lemonade to the student body to benefit Alex's Lemonade Stand for Pediatric Cancer Research.

Alexandra Scott was the 8 year old founder of Alex's Lemonade Stand for Pediatric Cancer Research. Two days before her first birthday she was diagnosed with neuroblastoma, an aggressive childhood cancer. Since that time Alex continually fought her cancer, with doctors and researchers still trying to achieve a cure. At the age of four, Alex decided to do something to make that cure more likely. Her goal was to raise \$1 million.

As word has spread, donations have poured in from around the world, and she has raised over \$900,000 for pediatric

The class selected to participate is Mr. James Howard's 6th grade class from Steele Elementary.

LEAP Kids provides age appropriate illustrations to the students about how the law benefits those seeking justice, how it punishes those who disobey it, and how they can set and achieve goals for themselves. Students were taught to utilize the legal system to resolve problems and accomplish goals they set for themselves.

For example, Widener students, Drew Miller and Jason Lambrino, ask students in one of their LEAP classes "Elementary School draft an Constitution." This proved to be very enlightening for students and teachers, and allowed the students to draw a positive correlation between their ability to participate in making the rules, enforcing the rules, and changing the rules. This project also had the added effect of helping the students develop a greater appreciation for the rules they were told to follow in school.

The November presidential election was also a very exciting topic during the fall classes, where students were educated in the Electoral College

process and the casting of state Electoral College votes. Finally, the classes re encouraged to wrap-up the semester program with an in class mock trial based on either "Jack and the Beanstalk" and "Goldie Locks and the Three Bears." The teachers were really encouraged by the students' enthusiasm displayed during the mock trials, and several of the law student teachers provided enthusiastic feedback and eagerly anticipate the spring session.

Though the LEAP Kids Program has traditionally been a spring semester event, this fall's programming was the first step in making LEAP a year-round Pepper Chapter Event.

One of the key "selling" points we use is to show them how much they have by having an opportunity to attend law school, and explain that there are far less fortunate people in the world. It is our duty to give something back to the society. And, give they did.


This year, we shattered our 6,000-can record set last year — raising the bar to 7,149! The cans were donated to the Daily Bread Food Bank, a local food distribution center.

Governor-General, I focus on these issues by publicly supporting many hundreds of events and reinforcing proven programs that nurture youngsters. A particular emphasis for me is the importance of numeracy and literacy in early childhood development, and school based pastoral care and mentoring programs that assist students during the crucial transition years to young adulthood.

Defence Role

The Governor-General is the Commander-in-Chief of the Australian Defence Force, although in practice he acts only on the advice of ministers. The day-to-day administration and operation of the defence forces are under the command of the Chief of the Defence Force. The Governor-General attends military parades and special occasion such as Anzac Day (a national day of significance commemorating the military contribution of Australian servicemen in World War One at Gallipoli, Turkey; the term Anzac is the acronym for Australian and New Zealand Army Corps), presents medals and visits military establishments.

The Governor-General must approve (on advice) the 'call out' of the military in aid of the civil authority, where police measures might be inadequate to deal with the problem.

Ceremonial Role

The Governor-General receives visiting Heads of State and other prominent visitors to Australia, receives credentials of ambassadors and high commissioners (ambassadors from Commonwealth countries) appointed to represent their countries in Australia; and as Chancellor of the Order of Australia, approves and presents awards under the Australian Honours System. This system recognises the special contribution Australian citizens make to their communities locally, nationally, and overseas through voluntary endeavour and through a wide range of service

including in the Arts, Industry, Commerce, Education, Health, charities and the armed services. The Order of Australia and the Australian Bravery Decorations are the honours more widely known in the Australian community although there are additional awards which recognise community service, occupation-related civilian activity and service in the Australian Defence Force.

I present honours and awards at Government House, Canberra, and less frequently at other venues around Australia, where I have the privilege to express our admiration and respect for individuals on their achievements and contributions to Australian society.

I believe most Australians would agree that the political neutrality of the Governor-General is essential to the role, and that over more than a century, this trait has been exercised with great integrity. I have no doubt it encourages an openness that might not otherwise be forthcoming, and I believe it is one of the principal reasons for the great affection offered and the warm welcome we receive wherever we visit.

There is still much more to be done. For example I want to continue expanding on my theme of developing Australia as a 'nation of excellence – a global example' as a means of supporting our nation's long-term prosperity and security.

As we move around Australia I also want to talk more about other issues I see as crucial to Australia's future, including:

- elevating teaching in the public eye to the status of a noble profession;
- promoting literacy and numeracy for all young Australians;
- promoting the family as the basic building block of a cohesive society;
- supporting innovative indigenous projects especially in cultural, health and educational activities;
- encouraging efforts to promote water conservation and the reduction of salinity;

- re-invigorating interest in, and development of, rural and regional Australia: and
- promoting closer regional dialogue between Australia and the Ind China arc.

To participate in service with literally millions of Australians from all walks of life is the most humbling but uplifting of human experiences – which is one reason why being Governor-General of Australia is such a wonderful privilege.

About the Author

Major General Michael Jeffery, AC, CVO, MC was born in Wiluna, Western Australia in 1937 and educated at Kent Street High School and the Royal Military College, Duntroon.

He graduated into Infantry and served operationally in Malaya, Borneo, Papua New Guinea and Vietnam, where he was awarded the Military Cross and the South Vietnamese Cross of Gallantry. After command of all combat elements of the Army from platoon to division - including the Special Air Service Regiment - he retired in 1993 to assume the appointment of Governor of Western Australia, which he held for almost seven years. His major interests during his tenure were in youth affairs, education, environment and the family.

For his services to the State he was appointed a Companion in the Order of Australia, a Commander of the Royal Victorian Order and a Citizen of Western Australia.

On his retirement as Governor in 2000 he established in Perth, a not for profit research institute - Future Directions International (FDI) - whose object is to examine longer term issues facing Australia. On 20 December 2000 he was awarded an Honorary Doctorate of Technology by Curtin University.

On 11 August 2003 he was sworn in as the twenty-fourth Governor-General of the Commonwealth of Australia.

He and his wife Marlena have for children and five grandchildren. General Jeffery enjoys golf, cricket, fishing, reading and music.

"In the Interest of Justice- Great Opening and Closing Arguments Over the Last 100 Years," by Joel Seidemann

Book Review and Interview by Eddy Friedfeld

"In the Interest of Justice- Great Opening and Closing Arguments Over the Last 100 Years," by Joel Seidemann, is not only a collection of the most interesting and informative openings and closing in legal history, it is also a history of jurisprudence in America. Seidemann provides insightful analysis and commentary on trials, including O.J. Simpson, Sean "P. Diddy" Combs, Adolf Eichmann, Amadu Dialo, and Bill Clinton. This creatively crafted book offers real insight not only into our criminal justice system but also into larger societal issues, with each argument an interesting exploration of "justice" in our complex adversarial legal

Seidemann is a 22 year veteran of the kew York County District Attorney's Office and since 1989 has been senior trial counsel responsible for trying murder cases and other serious and complex crimes. He is also an adjunct professor of trial advocacy at Pace University since 1995, and was named Pace's Outstanding Professor of the Year in 1999.

A dedicated and talented prosecutor, Seidemann is also still refreshingly passionate and excited about his job, even more notable in an era where disillusionment and burnout is prevalent among lawyers. In an interview he spoke candidly about his distinguished career, working with dedicated lawyers and cops, long hours and limited resources, and how the legal process has evolved over the last two decades:

Q: What was your finest moment as a prosecutor?

A: The conviction of the accomplice of the killer of Dr. John Wood. The case is in the book. The case was tried 20 years after the murder. The chapter lays out the sad facts the case. Dr. Wood, a resident in pediatric gery, had been on call at the hospital when he went home for dinner to spend time with his pregnant wife, a nurse at the hospital. On the way back to the hospital, while wearing his doctor's surgical greens, he was mugged and shot. As he lay dying on the sidewalk, a Good Samaritan came over to him and asked him if she could help. His dying words were "My wife is pregnant. Tell my wife and baby that I love them." He was rushed to Columbia Presbyterian Hospital where he was operated on by his colleagues, surgeons who in spite of their vast experience with death, cried under their surgical masks as their efforts to save Dr. Wood failed. Dr. Wood's son, John, was born months after his murder. His wife, Diana (whose speech is included in the book) went to Columbia Presbyterian and became an anesthesiologist. (Courtesy of Columbia Presbyterian Medical Center). Every case is sad but this is among the saddest. Special kudos to Detective Gerry Giorgio and Assistant DA Warren Murray who over 20 years never let the case die.

Q: What were your criteria for choosing the pieces for inclusion in the

A: The cases had to represent excellent advocacy and represent a conflict in American society such that average citizens would debate about the cultural ramifications of the case. It is a fact that many of our cultural wars have been fought in the courtrooms. Scopes, Goetz, Eichmann all represent individual disputes that somehow gained a life of their own.

O: What did you learn from the project that made you a better prosecutor or that you would share with your students/ colleagues?

A: Just reading these speeches shows you that different lawyers may have different styles but they somehow through their own idiosyncratic methods, craft brilliant arguments that succeed in persuading. As a lawyer you must operate within the four corners of your own personality, in terms of passion, humor, style. You have to find your own way, your own words and analogies to convince juries to convict. Another aspect of trial lawyers that I certainly knew before but was made even more acutely aware of was the ability of lawyers to take facts that are not in their favor and to creatively spin these facts to their advantage. There is no "NO SPIN ZONE" in courtrooms in the America.

Q: What are the most important qualities for being a prosecutor/trial lawyer?

A: You need to be intelligent and streetsmart, know how to talk to people from all walks of life, pay attention to detail (often the truth is found in the details; people lie in conclusory terms), and be able to approach each case with a sense of solemn duty to find the truth, whatever it may be. You also have to have an open mind to what happened in each case and a healthy skepticism. You should never assume uncritically that the person who is telling you a story is telling the

Q: Should trials be televised? Should they have all the media attention attached to it? Is if fair to the defendant and the process?

A: This is a tough question. In an ideal world, televising trials would show our system to be a perfect system, public trials that portray the justice being rendered on a daily basis. My ambivalence to televising trials is that it affects all the parties. The judge, the lawyers and the witnesses often behave differently. Even the jurors may want to get on the case because it is being televised. There is a law in NY which prevents jurors from accepting money for giving information about the case prior to his discharge from jury service (PL 215.28-Misconduct of a Juror in the Second Degree). This is a legislative recognition that jurors can fall victim to Andy Warhol's 15 minutes of fame syndrome. That is a huge danger in a televised case. Televising a trial can be unfair to the defendant but it also can be unfair to the prosecution. It depends on the case, the judge, and a variety of other circumstances. On the whole, I think TV in the courtrooms is a mistake.


