
#### Message from The International **Justice: Attend the 2008 Convention!**

**Networking**. Develop or enhance your personal P.A.D. network. Add valuable, diverse contacts that will benefit you in your law practice or other vocational pursuits.



#### P.A.D. Charity Ball In Minnesota



#### Langston Chapter Recycling Initiative

As the leaders of the largest student organization at Howard University School of Law, the Langston Chapter Executive Board is taking their vow of service to the student, the school, the profession, and the community to heart. They spent the summer of 2007 tirelessly pledging their energies to enhancing Howard Law's commitment to on-campus recycling.

Pursuant to the Commercial Recycling Guide, the District of Columbia requires all commercial establishments through a recycling program, to 1) separate recyclables from other solid waste, 2) ensure there are adequate containers for separated recyclables, and 3) hire a licensed recycling hauler to regularly pick up recyclables. Failure to comply with such requirements is punishable by fines, ranging from \$25.00 to \$1,000.

The Langston Chapter Executive Board began a letter writing campaign to Howard's administration, including everyone from the Dean of the law school to the Facilities Manager at Howard's main campus. They were also in close communication with the District of Columbia Office of Recycling, which helped develop a plan simple enough to be immediately effective. After much persistence, their efforts proved fruitful in that the administration promised to adhere to the recycling mandate by the end of Fall 2007. In the future, Langston Chapter has agreed to be responsible for monitoring the law school's use of the recycling bins through a committee consisting of both P.A.D. and non-P.A.D. members- a true community effort!

## **@LERK'S**

Throughout my travels this fall on behalf of the Fraternity, I have noted a competitiveness that was contagious from one district to the next. Chapter leaders were unfazed by the challenge to initiate as many or more students during this academic year than had ever been done in the history of their chapter. Many of them have already stepped up to

"meet or beat" the old record, and still others are hard at work laying the groundwork for programming that will ensure successful rush efforts throughout the fall and spring. I am optimistic that this spirit of fraternalism will result in yet another record-setting year.

Much of the success of the fall thus far can be attributed in large part to the completion of fall calendars during the spring and summer. Armed with a program of events, our chapters hit the ground running this fall in their rush efforts and were able to demonstrate to

interested students the kinds of activities that their chapters were planning to conduct this year. That kind of organization and preparation goes a long way in convincing a new law student – and a few older ones as well – that P.A.D. is a viable, productive organization.

With that in mind, and with the fall semester in full swing, you need to be thinking about and putting together your spring calendars. They are due to your DJ and the EO on Founder's Day, November 8th. They should include the same mix of academic and social programs that you have in place for the fall, with some community service and fund raising sprinkled in. Most important, you need to highlight the spring initiation date(s) so that students still looking to get involved will know that they have another opportunity to join next semester.

Chapter clerks and secretaries need to have an updated, current roster of members to be sure that you know how many members you have and who they are. Information about the membership, including e-mail and home addresses and telephone numbers, are vital to maintain

your members at general meetings that any changes in contact information should be updated online at www.pad.org. We need to know who and where our members are in order to keep them in the loop and active in chapter activities.

Even more importantly, the chapters need to convey that information to the EO when it is received. Our rules state that within 10 days of chapter initiation, the chapter clerk (or secretary if a prelaw chapter) shall forward completed applications of membership – along with appropriate initiation fees – to the Executive Office for recording. Only then will our members be afforded the benefits of membership, including the indicia of membership – their membership certificate and pin, to which they are entitled.

If you have any questions about the duties of the clerk or secretary regarding membership information, please do not hesitate to reach out to the Executive Office for assistance. We are on our way to another outstanding year, culminating in our biennial celebration in Scottsdale, Arizona next August. Please encourage your newest members to become involved in P.A.D. by inviting them to take part in your fall and spring programming. It is only through their direct involvement in

P.A.D. activities that they will become the next generation of leaders at your chapters.

How do you learn to play a song on the piano? You memorize the notes, then practice playing them. Law school is like that. You memorize black letter rules, then practice applying them. Ask any law professor or practicing lawyer, and he or she will tell you that memorizing the rules is the trivial part of learning the law. Skill in application—skill in legal reasoning—is what distinguishes good lawyers from poor ones. Developing legal reasoning skills is one of law school's primary goals. This is why law school so heavily emphasizes interaction in the classroom as well as other opportunities for applying rules (such as moot court, clinics, externships, and the like). Acquiring legal reasoning skills requires practice. How well does this work?

Ask any student for a frank response, and he or she will tell you that most students spend most of the time imperfectly memorizing (some of) the rules, and very little time practicing applications. Why is there this disconnect between the pedagogical aspirations of law school and the reality of what students do?

One reason lies in the use of cases—written legal decisions—as the primary reading material. To avoid misunderstanding, let me emphasize that there is a compelling reason to use cases in this way. To learn how to apply legal rules, students must understand the "law in action"; they must understand the variety of ways in which the law both guides behavior and provides a basis for resolving disputes. Cases comprise the primary lens through which students see the law in action.

It could hardly be otherwise. How else are students to see the law in action? Activities like moot court provide a glimpse, but only reading several hundred cases provides a vision of sufficient breadth and depth. Unfortunately, judges write their decisions primarily for an audience of other judges and lawyers. This audience has background knowledge and interpretive skills which law students—especially first-year students—lack. As result, students miss consequences and distinctions obvious to a legally trained audience. Students know they are supposed to see something in the cases but they do not know what that is, or how to find it. Most waste a lot of time looking for what they cannot find (and some just give up and do not try at all). There are a few students gifted with such an excellent "legal ear" that they can "hear" how the law works just by reading cases; just as there are some people with such a fine musical ear that they can play a song once they hear it. The vast majority, however, need more guidance.


Students would see more if they knew the relevant black letter law before reading the cases. The applicable black letter law plays a crucial role in sorting the complex of facts presented in a case into the relevant and irrelevant. This statement will provoke the—correct objection that black letter rules are by no means the determiner of relevance. Many other factors are involved. Nonetheless, the black letter rules do provide a basic road map to the consequences and distinctions which matter to the law.

So why not teach students

the black letter rules before they read cases? This is what other disciplines do in analogous situations. In medical school, for example, students learn anatomy before they dissect cadavers; when they do dissect, they know what to look for and understand what they see. They see where the body has followed the standard road, and where it has struck out on a new path of its own. Why not teach law students the "anatomy" of the lawthe black letter rules—before they "dissect" cases? Without this map, students dissect blindly. With the map, they can see when the court is following an established road, and when it is—perhaps with justification striking out on a new path. In this way, students would more quickly learn to read cases critically and analytically. This would mean more time for what matters most: developing skill in legal reasoning, both inside and outside of class.

This is the goal of Law Study Systems http://courses.lawstudysystems.com. It offers interactive tutorials which present rules and relevant consequences and distinctions. The tutorials differ from commercial outlines and other study guides because they are interactive. In a tutorial, you first read some

Each year about 50,000 new law graduates leave school for the work force. While not all seek employment as lawyers, most do and in relation to the market demand, that means you have a lot of competition when you go looking for work. So, in preparation, what is it that employers are looking for and how can you improve your chances to land the job you want?

Let's get the obvious fact out of the way. The quality of your law school and your performance there always will be a significant, if not dominant, factor in any decision to hire you. Some firms (but usually not the large ones) are less obsessive about this than others but it must be stressed that a key to getting a leg up in the hiring game is to attend the best law school you can and, above all, work hard to excel at whatever school you attend.

To improve your hiring chances, think about pursuing a clerkship while in school. "Any clerkship enhances a resume. The more selective the clerkship, the more selective the candidate can be when finding employment," says Victoria Gamble, Attorney Recruiting Coordinator for Morgan, Lewis and Bockius in Southern California. Other internships and summer associate positions also contribute to a weightier resume.

Next, make sure your written materials work for you. "Lawyers expect your written product to be flawless, so your resume and cover letter must be error-free," says Graham Sherr, Assistant Dean for Career Services at Loyola Law School in Los Angeles. That means proofing your resume and having someone else do so as well. Make it fit on a single sheet of white paper (color theory is lost on lawyers) and use a conservative font, like Arial or Times Roman.

Cover letters should each be written for the specific employer you are sending it to. "Employers want to know why you are interested in them so try to avoid using a generic cover letter," says Sherr. It's more work, but if your cover letter shows you know about the firm and have specific interest in what they do, you have a better chance at landing an interview.

Materials in hand, the next step is getting interviews. Use all your resources. That means mining all of your contacts and networking to get a personal introduction to as many firms as possible. Though it may not guarantee an offer "referrals get noticed," says Gamble. Make yourself a regular in your law school's career services office and consider using services like EmplawyerNet (www.emplawyernet.com) which gathers job information from a wide variety of sources. EmplawyerNet also provides a discount to Phi Alpha Delta members.)

Once your background, presentation materials and job

sourcing

results in interviews the rest is, well, up to you. "What ultimately distinguishes the successful candidate who receives the offer is their ability to personally engage and connect with the diverse attorneys that they meet during their interviews," say Joan Fondell, Principal at Russo & Fondell, Inc., a legal recruiting firm.

This is because there is always a subjective factor in a hiring decision. Once you are part of the interviewing process, the employer is trying to determine if they would enjoy working with you and if you fit in with their work environment. That means gauging your enthusiasm, sincerity, energy level and temperament. While interviewing, you are always "on" and, for however the process is going, remember that each person you meet is meeting you for the first time, including the receptionist.

Most importantly, the interviewing process is your attempt to convince the firm that you would be an asset. "The purpose of the exercise is to convince employers that you will be useful to them," emphasizes Sherr. However engaging your personality, the candidate who gets the offer is the one who can demonstrate that by dint of his or her background, enthusiasm, drive and interest, they represent a true positive addition to the firm and its business goals. In the end, the art of job hunting is the art of selling yourself.

Lincoln Chapter also hosted the District XI Conference on September 8th. District XI officers were treated





I'm glad that you had a good fall and are already looking forward to the spring! The key to success is planning ahead and keeping in mind the shorter length of time you have to work with.

Each chapter is expected to submit their **Spring Calendar** to the Executive Office by **November 8**<sup>th</sup>. The early deadline for calendars will allow you and your chapter to plan ahead and begin holding programs as soon as you return to classes after the winter break.

You'll also need to keep in mind that the spring semester typically is shorter due to holiday breaks and the need to hold Chapter Elections by March 30<sup>th</sup>.

Your chapter should plan on holding many of the same types of programs as it did in the fall: Academic Assistance Events, Community Service Programs, Social Events, Professional Development programs and at your first Spring Initiation by the end of February.

Many people ask why the chapter needs to hold Academic and Professional Development Events in the spring and the simple answer is that 90% of each 1L class is wondering why they're not in the top 10% and want to do everything they can to get a good job while in school and after they graduate.

Another reason to hold Academic and Professional Development Events is that your 2L and 3L members will be looking for programs that will help prepare them for life after school. 





### Australian Efforts to Reduce Greenhouse Gas Emissions

#### A Global Challenge – An Australian Perspective

Climate change is a serious issue for the world. Over the next 50 years, it is estimated that cumulative global carbon dioxide emissions could double to 2 trillion tonnes, raising global average temperatures by between 1.4°C and 5.8°C this century.

Climate change is also seriously complex, with potential impacts not only on Australia's fragile and highly vulnerable environment, but also on our economy. We rely heavily on low-priced fossil fuels, supply a large amount of the world's energy needs and enjoy a competitive advantage in some energy-intensive industries. Climate change is an issue which generates passionate debate, both domestically and internationally, as the global community seeks solutions to reducing greenhouse gas emissions without stifling the economic and social aspirations of individual nations.

Despite this complexity, the Australian Government's policy approach to climate change is based on two relatively simple constructs.

- 1. Climate change is a global problem, that demands an effective global solution involving all major greenhouse gas emitting nations.
- 2. While Australia represents only around one and a half per cent of global greenhouse gas emissions, we have a responsibility to take domestic

action to reduce our greenhouse signature – and we are doing so.

#### An effective global solution

Three reports released this year – each from a different perspective – have served to highlight the magnitude of the challenges we face in addressing climate change.

In May this year I released a report, commissioned by the Australian Government and prepared by world-renowned Australian scientist Professor Will Steffen, which revealed that climate change may be occurring at a more rapid rate than previously thought and that the risk is now more likely that we will reach the high end of temperature projections by the end of the century.


The Steffen report lent increasing weight to calls to halve global greenhouse gas emissions over the coming decades. Set against this, an International Energy Agency report (World Energy Outlook 2006) found that energy-related emissions of carbon dioxide could increase by 55 per cent between 2004 and 2030.

Sir Nicholas Stern recently brought a new dimension to the debate, with his economic comparison of the global costs of addressing climate change. His main message was clear — and consistent with what Australia has been saying for some time — that the world needs to take significant action to prevent

dangerous climate change and that this response must involve all major greenhouse gas emitting countries.

Countries, particularly those that produce large quantities of greenhouse gas emissions, must work together to take significant action to prevent dangerous climate change from occurring. The current mechanism for doing this, the Kyoto Protocol, simply doesn't deliver the necessary response. At best, it will produce a 1 per cent reduction in growth in greenhouse gas emissions. Or, to put it another way, under the Kyoto Protocol global emissions are expected to grow by 40 per cent of 1990 levels by 2012. Without it, they will grow by 41 per cent. Even an extension to Kyoto, with deeper cuts by developed countries only, will not fix the problem.

The international debate on greenhouse strategies is moving beyond Kyoto. A key component of Australia's policy response to climate change is to continue to press for and support the development of a global response to climate change that is environmentally effective, economically efficient and socially responsible – allowing countries to continue to meet their sustainable development objectives, while at the same time reducing greenhouse gas emissions.

Australia has consistently argued that the world needs a truly global and comprehensive response to climate change – or what Australia has recently coined New Kyoto. Australia's push for a New Kyoto calls for an improved, more effective, global response that involves all major economies; that will deliver real benefits for the environment; and that fits the national circumstances of all countries.

There is no 'one-size-fits-all' approach to this task, and Australia is very much at the centre of efforts, through a number of major forums, to develop an effective international framework for action:

- Australia is an active member of the United Nations Climate Change Convention, with the head of the Australian Government's Greenhouse Office co-chairing its Dialogue on Long-Term Cooperative Action to Address Climate Change.
- We are a founding member of the Asia-Pacific Partnership on Clean Development and Climate (AP6) which is bringing together key regional economies (Australia, China, India, Japan, the Republic of Korea and the United States) to develop, deploy and transfer the cleaner, more efficient technologies the world will need to make deep cuts in global greenhouse gas emissions.
- We have established a series of strong bilateral climate change partnerships that are advancing practical action to reduce greenhouse gas emissions.

#### Domestic action

While working to build an effective framework internationally, Australia is also taking strong domestic action to reduce its greenhouse gas emissions.

The Australian Government moved early to establish a partnership with governments, industries and communities across the country to begin the task of reducing our greenhouse signature. Our total commitment to climate change is now more than \$2 billion, and when coupled with commitments by our state and territory governments and industry, we are among the world's leading nations in responding to climate change.

We are committed to meeting our internationally agreed greenhouse gas emissions target of 108 per cent of 1990-level emissions by 2008-12 and have introduced a range of measures to ensure we do so. These include, for example, encouraging a broad range of new low emissions technologies; improving the efficiency of current energy technologies; reducing our energy demand through improving energy efficiency; and revegetating our land, protecting existing vegetation, and promoting sustainable agricultural and land management practices.

Of necessity, the development and deployment of breakthrough low emission and renewable technologies is a critical focus of both our domestic climate change strategy and our international engagement, particularly through the AP6. The full suite of technologies must be the cornerstone of any effective global response - it is the only means by which we can support the ongoing development of all countries while reducing global emissions. The Australian Government is investing heavily in advancing understanding of the technologies that will be required to safely and effectively capture and store carbon dioxide from fossil fuels; further developing renewable energy technologies and addressing market barriers to their uptake; and encouraging leadership, innovation and investment in the next generation of low emissions energy technologies.

The need to reduce our greenhouse signature while maintaining a strong economy underpins the Australian Government's climate change response. However we recognise that some degree of climate change is already effectively 'locked in' given levels of carbon dioxide already in the atmosphere. Helping regions, industries and communities to adapt to the impacts of climate change is another key

element of Australia's multi-track response.

#### Conclusion

There is no doubt that climate change presents the world with an environmental and economic challenge the likes of which we have not previously seen. This challenge demands that all countries of the world work towards a comprehensive and effective response. Through both its international and domestic policy approaches, the Australian Government will continue to strive for such a response. We will do this while balancing strong economic growth with concerted action to reduce our domestic greenhouse gas emissions.





Members of both the Chicago Alumni Chapter and the West Suburban Alumni Chapter have met with one of DuPage P.A.D.S. boards of directors to discuss ways that P.A.D.'s can support P.A.D.S. – including participation in their September walk-a-thon and their November Charitable Partners Breakfast.

The Anthony A. DiGrazia Scholarship Program: The chapter has established a scholarship fund in honor of past Supreme Justice Anthony A. DiGrazia who contributed a lifetime of devotion to Phi Alpha Delta and its members. Annual awards will be given to applicants selected from P.A.D. students at area law schools in Chicago, Illinois, DeKalb, Illinois, Milwaukee, Wisconsin, and Valparaiso, Indiana.
