

### Benson Chapter's Recordbreaking Year!

By Kevin Mechtley, Justice We are happy to report to that Benson is having a record year in terms of recruitment and events. Our enthusiastic executive board set a goal at the beginning of the year to recruit more than 100 new initiates and hold at least one event per week for the entire school year to benefit our members.

As of this writing, we have officially broken the Benson initiation record with 107 new initiated members and have

averaged one event a week for the school year. We have found that putting on a wide range of events has helped immensely in terms of recruitment and membership involvement. We have focused on four types of events and have put together committees to assist in the development of these events. These areas include community service, professional development, social interaction, and educational enhancement.

Our community service events have included: bringing in the Red Cross to host a blood drive that produced a record number of good blood units; a bowling tournament for the Rescue Mission that brought over \$400 in donated food items; adopting a local 5-person family over the holidays; a pool tournament for Let's Help that produced over \$200 in canned foods; working our annual "Washcall" event that raised over \$2,500 for Washburn Law scholarships; and, sponsoring a golf tournament to fund a separate Washburn Law scholarship.

Our professional development events have included: our annual "Street Law" panel consisting of local attorneys that discussed constitutional issues in search and seizure law; a Benson alumni reception that followed our Fall initiation; a "Starting Your Own Law Firm" event with alum speaker Kevin Muxlow; a "Dress for Success" event with Kelly Anders, author of *The Organized Lawyer*, a Wine & Cheese night with Washburn alumni and professionals; a networking golf instructional event for our members; and a "Casino Night" with Washburn Law students, professors, and alumni.

Our social interaction events have included: 10 recruitment-oriented events at the beginning of the semesters; a Welcome-Back party for our membership and the new 1Ls; an All-Law School Party; a bar-b-que for our membership at one of our professor's homes; an all-law student Halloween Party that doubled as a fundraiser; a second semester Welcome-Back party for our membership; and, an all-law school Valentine's Day party that doubled as a fundraiser

Our educational enhancement events have included: a Question/Answer Panel of upperclassmen for our new 1Ls; a "War Stories" Panel made up of Washburn Law professors sharing their favorite stories from practice; a Question/Answer Panel with 3Ls to discuss enrollment, classes, and professors; a Question/Answer event for our new January students; and, critiquing our 1Ls' oral arguments in preparation for their big legal writing assignment.

In addition, we have great plans to put on even more events to close out this banner year at Benson. I would also like to personally thank Benson's executive board, committees, membership, professors, alumni, and our District Justice Christine Hutson, for all of their hard work and support throughout the year! Without all of these great people, Benson would certainly not be where it is today.

### Staples Chapter's Annual Charity Auction a Big Success!

On Thursday, February 12th, students at the Washington and Lee School of Law once again showed their generosity, raising over \$11,000 during the 2009 Phi Alpha Delta charity auction. The last four auctions together have raised over \$50,000 for local charities.

Every year P.A.D. members choose a worthy local charity to benefit from the auction. The proceeds from this year's auction will be used to benefit Hoofbeats Therapeutic Riding Center. Hoofbeats is a local, non-profit organization that provides equine-related therapy services for individuals with disabilities and serious illnesses in the Lexington area. In addition to supporting a



worthy charity, the Auction is one way in which the law school encourages community participation and service.

During the auction, students bid on donations from Law School faculty and staff, the most popular items being dinners and leisure activities with Professors.

Some of the auctions most popular items this year included:

# **@LERK'S**



Allow me to meditate for a moment on a common scenario that comes up this time of year: A new clerk has been elected to replace you. Once you are no longer holding an elected office in your chapter, this means that your obligations to the chapter and to the fraternity are finished

forever, right? Well, not quite vet. Before you build a bonfire with all of those leftover blank P.A.D. membership application forms, and before you shout "hallelujah, hand me the sunscreen and the bar exam application," you may have overlooked one last important aspect of your fiduciary duty to the fraternity. When I was still a District Justice, I recall one outgoing chapter justice who, shortly after officer elections, sent me a voice mail that consisted of a musical au revoir from that unforgettable pop duo Go West: "And I'll tell myself I'm over you/'Cause I'm the king of wishful thinking." (Tothis day, I'm still pondering the multiple layers of meaning and ambiguity in that voice mail message.) My point is that even though your successor has been elected, you are not "over" P.A.D., so stop with the "wishful thinking". You have ongoing

duties, not to mention a lifetime P.A.D. membership (for those who are law school members). So many chapters lose momentum

and institutional knowledge because of an inadequate, or often non-existant, transition between the old officers and the new officers. It is the obligation of each outgoing chapter clerk to continue in the role of leader and mentor to ensure that the newly elected clerk understands even the most mundane details of the job, for example: which forms does the clerk need to fill out: to whom are the forms, minutes, calendars. and other crucial correspondence sent; who are the key contact people at the school, in the community, and in the fraternity; and where are the chapter's P.A.D. supplies. And please do your district justice or district president a favor, advise him or her of the names and contact information of the newly elected officers. Even now, as International Secretary, I still seek guidance from my predecessor and mentor International Vice-Justice Ron Winter. He reads my minutes from the most recent ExecutiveBoard meeting, slaps me around a few times, tells me "that's not the way I did it," and offers me constructive criticism on how to improve my product. I have greatly appreciated his help, and I am sure that your successor as chapter clerk will appreciate it as well, though I don't advocate any literal acts of violence (only literary acts of violence). Speaking of literary acts of violence, here's a bit of doggerel verse that I composed to commemorate the arrival of Spring and the election of new officers: One year ends as the next begins, Proper transition and the chapter wins.

#### Frankfurter - Joins the Fight Against Sex Trafficking

The problem of human trafficking is growing. In 2003 it was reported to be the fastest growing criminal enterprise in the world and the third largest source of criminal profits behind narcotics and arms dealing. By 2007 the U.S. Senate Foreign Relations Committee reported that human trafficking surpassed illegal arms dealing and is now only second to drug trafficking. UNICEF reports that every year 1.2 million children are trafficked internationally for a profit of an estimated \$10 billion. One of the biggest trouble spots for this growing problem is between India and Nepal, where every year it is estimated that 2,500 women and girls go missing.

In October, the Frankfurter Chapter teamed up with several other organizations at Suffolk Law School to try to make a difference. Together we were able to raise over \$1,400 in donations to Maiti Nepal (www.maitinepal.org), an organization dedicated to eradicating the practice of human trafficking. This organization's name means "Mother's Home" and was formed in 1993 by a group of socially committed professionals to raise awareness of the massive problems of domestic violence and sexual trafficking in Nepal, and work to end this horrible practice. Frankfurter Chapter helped run a series of bake sales, and solicited donations to the organization which culminated in a seminar on the global problem led by Maiti Nepal. The seminar featured an Emmy nominated documentary "The Day My God Died" a film about Maiti Nepal's work narrated by actor Tim Robbins. Although the problem of human sex trafficking may seem insurmountable, when organizations band together to help raise awareness of this important issue, the world comes one step closer to eliminating sex trafficking in the world.

Alpha Delta Law Fraternity, International is not just about joining a local chapter but about joining an international network of students and attorneys in over 55 countries. When you look at the big picture, this is an investment you cannot afford to miss during a challenging job market.

Programming:

Many chapters have already been hit by the economic situation as schools have begun to restrict funding and activities of student organizations as a whole. Because of the P.A.D. network, this should not pose the same problem to our chapters as it does to other student organizations.

More than ever, chapters should reach out to our network and bring in P.A.D. speakers. We all know that lawyers love to talk about themselves and what they do! Having local P.A.D. alums come in on their lunch break would provide excellent programming with little or no expense to the chapter and/or the school.

Another way to save money is to make your program a brown bag event. You do not have to have food if you put on a great program as it will draw in students on its merits. Of course if you do want to provide food, there are many affordable ways to do so. One great idea I came across was at Benson Chapter where they had chili cheese nachos.

#### Fundraising:

If the chapter is not getting the funding it needs from the school, then it has to do fundraising. Again, brainstorm and come up with new ways to fundraise. There have been chapters that have received \$400 to \$1000 for a single fundraising event. I have found that adding some form of competition to a fundraising event can really bring about the most money.

Lastly, remember to start seeking Convention funding now. Do not wait until the last minute!

### The PLAC Report

By Marshall Campbell, PLAC Member Do you know you have PLAC? The Pre-Law Advisory Council (PLAC), that is. PLAC's purpose is to advise the International Justices and the International Executive Board on traditions, ideals, policies and practices of the Fraternity and how they relate to the pre-law program and its members. The PLAC is made up of a chairperson, two faculty advisor members, two student members, two Pre-Law alumni, an International Executive Board Liaison, and other P.A.D.s that the International Justice appoints to this council.

So what has your PLAC been working on lately? Three items – district presidents, programming, and "graduates and retention."

P.A.D. has 33 districts across the United States. PLAC and P.A.D. are working to install a District President in each District. As of March 10, 2009, twelve of the districts have a President.

It is the job of the district presidents to communicate fraternity expectations to the schools in their district, monitor their programs and activities, and provide assistance, counsel and coordination. It is also the expectation that each district become stronger, better organized and more professional through the efforts of the district presidents. If your district already has a president, expect that he or she will be in touch with your chapter, if that has not already happened. If your district does not yet have a president, expect that one will be named in the near future.

PLAC has recommended that the Pre-Law Chapters of P.A.D. develop their professional programs and that the Executive Office continue to assist in that endevour. Too often our P.A.D. chapters focus on the social programs to the detriment of professional programs and the purpose of the Fraternity. We have recommended that all Pre-Law Chapters increase the number of

professional programs and to make them as comprehensive and effective as possible. Not only do the professional programs provide the students with important information; they also can help students make contact with various professionals in their legal community.

What do we mean by "professional programs?" Here are just a few examples: bring in local professional speakers to your school (e.g., judges, attorneys, child law specialists, social workers, law enforcement and criminologists); hold LSAT reviews, Law School reviews, and the like. Additionally, your chapter could start programs similar to Arizona's Law School Information Expo and their School of ROK (Rights of Kids) event, where they educate local elementary and middle school students on their basic rights. Chapters could also sponsor mock trials in their local secondary schools or work with Child Law advocates on local teen courts. PLAC has recommended that P.A.D.'s

## You're Not Going to Miss Anything!

I want to ease your mind with this article, and take on a concern that many young (and mature) investors have.

You are not missing out on amassing great wealth by not investing every spare cent in this beaten-down stock market, as long as you have a long-term investment strategy already in place. (For those of you who have no income to invest, living with minimal debt is an important first step in your long-term investment strategy).

But even I have doubts sometimes, so here are the facts that help me when I feel irrationally exuberant about this market.

First, it is statistically highly improbable, if not impossible, that you can time the bottom of this market just right. Second, it is likely you do not make or have enough money to invest relatively massive amounts of your surplus cash in a market this volatile, and be able to absorb the losses.

Statistical Improbability of Timing a Bottom

I often have discussions with one of my biggest clients about how counterintuitive it is that, in a time like this, there are people on the radio promising to teach you how to get rich by working an hour a week at your kitchen table in your underwear. The logic is similar with stock market timing. It's a seductive idea, and many people talk about doing it but, in the end, it's not really possible for most of us, including the experts.

Roger C. Gibson, author of arguably the definitive guide to asset allocation, gives a very detailed analysis of why being able to time a top and a bottom in a market is highly unlikely (Chapter 4, Gibson, <u>Asset Allocation</u>, 3<sup>rd</sup> Ed., McGraw Hill, 2000). Gibson quotes Charles D. Ellis' work <u>Investment Policy</u>, which cites a study of 100 large pension funds:

their experience with market timing found that while all of the funds had engaged in at least some market timing, not one of the funds had improved its rate of return as a result of its efforts at timing. In fact, 89 of the 100 **lost** [emphasis supplied] as a result of "timing" — and their losses averaged a daunting 4.5 percent over the five-year period. <u>Id.</u>, page 80.

It is not likely that you, someone who is engaged in the study or practice of law and not the study of investments, will be able to time a "bottom" if those who are paid to manage money cannot effectively and profitably do it. Your time is better spent on either your studies or improving your specific expertise in the area of law on which you focus. Or even perhaps perfecting your favorite drink recipe, as it will probably result in more enjoyment and less angst than market timing.

You Won't Become Independently Wealthy from Investments In The Short Term (well, it's not likely)

If you're in law school, or even working for a large law firm, it is not likely you have enough cash to put into the market right now to amass life-changing wealth in the short term.

Look at it this way: if you invested in one S&P 500 Index fund when the index was at 700, and the market returns

to 100 points shy of its recent high, you have doubled your money. You may be thinking, "Hey, that's great!" Yes, but you have to be ready to risk losing all of it, and you have to be prepared for the heartburn of wondering WHEN to get out, IF the investment depreciates. I'm not against using a small amount of cash with which to take such chances, but we're talking about your savings. This is, most likely, not consistent with your long-term objectives. This is speculating.

Even if you did have a lot of money to invest in that strategy, say \$100,000, you would end up at about \$200,000 before the tax man cometh and taketh away about 40%, depending on when you sold.

My point is this: don't lose sleep or study time over not investing all of your spare money in the market right now. If you're a student, keep your debt load as low as possible by taking on as few loans as possible, and not taking on any other debt. If you're a young lawyer, max out the 401k and the Roth IRA contributions, and make the Roth contributions over each pay period. That way, you'll take advantage of lower market values, and not miss out entirely on any benefit.

Furthermore, never invest because of an emotional trigger, such as the feeling that you're missing something if you hold back, or that you can be part of a select group if you invest with a particular individual or fund. Personal wealth and security can become emotional issues. However, we make foolish mistakes when we make financial decisions for non-financial reasons.

# Western Illinois University Pre-Law



We know what you're thinking. If you actually understood economics, you'd be considering an MBA, not a law degree. We get it. Which is why, when it comes to figuring out how the biggest economic crisis since the Great Depression is going to affect your decision to go to law school, we wrote an article about it.

Let's start with the good news. The fact that you're reading this article means that you're considering a pretty good option when it comes to riding out a recession. First, going back to school is a great way to wait out troubled economic times. Because while you're studying criminal law and contracts, the economy may rally. Businesses have a good shot at growing again, law firms to be hiring, and credit cards companies to raise limits so consumers can once again buy stuff they don't need (such as the ShamWow<sup>TM</sup> or the first season DVD of MacGyver).

Second, once you've graduated, you'll be better educated and stand a better chance in any economy. A JD is a marketable degree across many professions and the processes you learn in law school (writing, critical thinking, etc.) will stand you in good stead in a variety of desirable professions. After all, one doesn't want picking cotton to be a primary job skill in a recession. The Joads tried that in *The Grapes of Wrath* and it didn't work out so well. So there are lots of reasons to continue with those plans to head to law school.

Of course, as with everything good in life, there is a catch.

Lots of other people are thinking this, too. Historically, economic recessions have been accompanied by surges in applications to graduate school. The last time around, during the dot com fizzle, law school applications increased dramatically. After all, when an uncertain economy makes people nervous, they gravitate toward a career that's a little more certain. As a result, it is very likely that soon there will be more people than ever applying to law school.

There's an additional complication. Remember all those friends of yours who became investment bankers straight out of college? Remember how great they thought they were because they owned a 3-series BMW? Well folks, those people don't have jobs anymore, they sold their BMWs (those that weren't leased), and they're applying to law school. For your very spot.





I know it's rough, but just be thankful you didn't spend the last few years training to be a machinist at the Ford plant. Be relieved that the internship you just finished wasn't at Bear Stearns, and that your heart wasn't set on being the floor manager at Circuit City. Because there is a future in the legal arena; you're just going to have to face some very tough competition to get there.

Luckily, there are ways to become a more competitive applicant. Without a doubt, the best possible way to compete for a spot at a good law school is to have a great GPA and an amazing LSAT score. Of the two, your LSAT score is typically weighted more - as much as 60%. This is because the LSAT provides a way to compare applicants against each other. While different GPAs across different schools and majors can mean many different things (how does one compare a 3.9 from Eastern Tennessee State against a 3.5 from Minnesota University?), the LSAT measures how candidates competed against each other on the same or very similar tests. The LSAT is also predictive of a student's performance as a law student (even small increases in an LSAT score can correlate to better law school performance).

So put your best foot forward during the application process by treating your law school application with the importance it deserves. And keep in mind: the quality of your law school, particularly in a recession, matters. As the economy recovers and law firms begin hiring again, the first students to reap the benefits will be those who were admitted to top tier schools. Even as the job market improves, as a graduate with a JD you'll still be entering an extremely competitive job market. Where you go to law school will play a substantial role in determining the job you'll end up with when you finish your degree. So take the LSAT seriously, put together a great application and go spend the next few years living off the best unemployment that you can possibly find: student loan money from bailed-out banks.

#### Develop a Committee System

We are Not part of the Greek System


The P.A.D. Pre-Law program was created to help students who have not yet begun law school answer the questions they may have about what law school is and what they can do with a law degree. For those students who decide that they wish to pursue a law degree, you are tasked with holding programs that can help them prepare, academically and professionally, so that they have the best opportunity they can have to get into their preferred law school. You will do this by:

- Holding programs such as LSAT practice tests, Personal Statement workshops, etc. that enable members to become comfortable and as adept as possible in these areas;
- Hosting speakers who will speak about the law school experience as well as what you can do, both traditionally and non-traditionally, with a law degree;
- Recruiting new members in line with the Fraternity's Open Membership Policy;
- Holding community service events.

Please note that there is no emphasis put upon holding social programs. While having a limited number of social programs (less than 20%) is fine, keep in mind that as a professional fraternity the focus of each and every chapter is to develop the professional and academic skills of our members!

After leading four of the Leadership Symposia and surveying each of the attendees, the most common reasons people joined P.AD. Pre-Law was to learn about the law and develop a network. If your chapter works to meet Fraternity expectations,

Each issue of The Reporter, the Alumni Advisory Council includes an article concerning some of the alumni issues facing the fraternity and some of the steps that AAC and the Fraternity as a whole are taking to make the Fraternity's alumni program stronger.

In this month's article, AAC features a summary of some of the projects AAC is wrestling with (many of which will be featured in later issues), a biography of the Honorable James F. Holderman, Chief Judge of the United States District Court for the District of Illinois, and the efforts to expand the alumni chapter program (Campaign 100!).

#### Alumni Dues

One of the issues facing the fraternity in providing more resources to help with alumni benefits and alumni programming is finding the money. Although payment of an initiation fee and participating in our initiation rituals makes us members of the fraternity for life, the fraternity does rely on its alumni members to voluntarily support the good work of Phi Alpha Delta through the payment of alumni dues. These dues are much less than those charged by other professional organizations and the more dues received the more support and benefits the fraternity can provide its members. Dues paying alumni are recognized in The Reporter and highlighted in search results on the on line directory. Alumni dues are \$30 if you have graduated in 2006-2008. you'll find that you will have developed a sense of Fraternalism among your members by helping them answer the questions they had about law school and the law while developing your own skills personally and professionally. That bond of Fraternalism will be much stronger, and more beneficial than whatever you may get by having fun at a party last weekend with a number of people who may or may not be going to law school. The chapter whose website states "our purpose is to learn about the law....and party!" is not a viable part of P.A.D., even if they bring in 200 new members a year.

Chapter Officers should always be transparent in their actions and expenditures

Chapter officers should always be upfront with their membership about the money they are spending and the actions they have taken or are considering taking. Chapter finances are hard enough to come by, so all expenditures should be for as much benefit to the chapter as possible. Expenditures that benefit only officers (such as buying dinners for officer meetings) or a small percentage of the membership are inconsistent with that and should not occur. If you're not willing to tell your members that you are using their money to buy yourself dinner then do not do it. Officers exist to support and sustain the chapter, not benefit financially from it.

- Expenditures of significant portions of the chapter accounts should be brought before the general chapter.
- i. While officers are elected to lead and make most decisions, expenditures of more than 15% of the chapters' budget on an event or on events that do not benefit the majority of chapter members need to be brought before the chapter members in a regularly scheduled meeting and opened for discussion, debate and a vote.

Executive Office could and should develop a web page where pre-law chapters can go to get programming ideas, outlines, and "how-to" materials, and could communicate with one another about programming ideas and issues.

Finally, PLAC recommends that P.A.D. establish a "Craigs List®" style program for its Pre-Law graduates. This program would allow Pre-Law graduates, especially those that did not go on to law school, to stay in touch with other P.A.D. alumni, advertise their services, or search for fellow P.A.D. pre-law grads that can provide services. PLAC believes that P.A.D. could use its existing P.A.D. online resources to create what we deem a P.A.D. Partnership Program (PPP.) 
At the Judges' Night reception held at Kent, was a huge success, with almost 200 judges, lawyers and students attending. Based on their remarks, everyone had a wonderful time!

Dade County Bar Association President Timothy Ravich served as the guest speaker, providing some helpful words of wisdom. "Your reputation for professionalism starts on your first day of law school and as newly inducted members of Phi Alpha Delta, I encourage you to follow its core values of compassion, courage, integrity and professional service," said Ravich.

The actual running of the bulls is just a short 1/2 mile dash to the bullring, but it's the windy cobblestone streets that create quite a treacherous terrain even for those who run the event every year. Running through the streets is nothing the Holland Chapter can't handle. In October, the FIU P.A.D. team ran through the streets of downtown Miami with great stride in the Susan G. Komen Race for the Cure event, collecting a total of \$1,602.50 in donations. We then collected over 60 lbs of candy, thanks to the generous contributions from FIU Law students and faculty and Winn Dixie Supermarkets, for the children at Kristi House, which provides a healing environment for all child victims of sexual abuse and their families, regardless of income, through prevention, treatment and coordination of services with community partners.

As we continued the race through the semester, the Holland chapter clearly set the pace for the other organizations on campus, hosting and cosponsoring a slew of events at every turn including:

# Pierce Law Donates More Than Just Time!

On March 14, 2009, 10 brave law students shaved their heads to raise over a thousand dollars supporting St. Baldrick's and the fight to end childhood cancer. The Draft in Concord, NH hosted the event that started at 5:30 p.m. and went on for the better part of the evening. Through donations and the proceeds of a bake sale the Kenison Chapter of Phi Alpha Delta at Franklin Pierce Law Center raised over \$1,000 to support childhood cancer research.

Brian Doigan, said the reason he agreed to have his head shaved was, "It's heartbreaking to see children go through cancer, and this was an easy and fun way to raise money to support research to end their suffering. And I've wanted to shave my head since I was a little kid, but

my mom never let me."

Organizer of the Kenison Chapter's participation for the second year in a row, Justice Phil Apruzzese said his participation stems from when he found out about the fundraiser only a few days in advance last year.

"I participated by myself and raised a few hundred dollars," he said. "In part I did this because I wanted to help defeat childhood cancer and in part I did this because I wanted to show my mother that she was not alone while she was fighting her own cancer."

Apruzzese said he felt it was a positive event for P.A.D. members to participate in. "As a P.A.D. Justice this year I realized I could try to recruit P.A.D. members to help raise money for childhood cancer research. We were able to get ten shavees, both P.A.D. and non-P.A.D. members, to raise over \$1,000. This year I dedicated my shave to my mother who lost her battle with cancer this past October."

St. Baldrick's has been around for nine-years and is the world's biggest volunteer driven fundraising program for

childhood cancer research. Since its inception over \$50 million has been raised in 18 countries and 48 states with more than 72,000 heads.




