

Focus on Community Service

Community service is an essential aspect of P.A.D. Chapter programming. As part of Phi Alpha Delta's mission, service to the community advances integrity, compassion and courage in our members.

Because community service is such an integral part of Phi Alpha Delta Chapter operations, it is important that students support their communities by elevating issue awareness, dedicating time and fundraising. What Chapters choose as their community service projects varies and can range from canned food drives to assisting estate lawyers in planning client wills. Each Chapter is required to participate in community service programs and initiatives every semester; however, a few Chapters exceeded the set requirement in 2011.

The amazing achievements that Phi Alpha Delta members have accomplished is almost immeasurable due to the quantity of programs and the impact each Chapter truly has on their community. However, through the collected 2011 community service statistics, we derived information such as how many organizations Chapters were involved with, the amount of time spent helping and amount of money raised to support individual causes and organizations.

Of our 708 Phi Alpha Delta Chapters, 206 Law Chapters, 303 Pre-Law Chapters and 99 Alumni Chapters, members cumulatively raised over 1.5 million dollars in 2011 to support over 1,100 organizations and causes around the country. Over 33,000 hours were donated; that amount of community service is equal to over three years worth of work, but only if you worked 24 hours *every* day! This success could not have been achieved without the dedication of our Chapter members and their great leadership.

P.A.D. Law Chapters are required to participate in at least one community service event per semester. Even with one event, Chapters can make a huge impact on their communities through raising awareness and providing assistance for specific issues. Collecting donations has proven to be a trend among P.A.D. Law Chapters and provides basic essentials for those in need. Both Lincoln and Tilden Chapters hosted clothing and toy drives. Lincoln was able to collect over five racks of clothing to benefit



the homeless in Chicago, and Tilden collected over thirty toys for the holidays; those toys were gifted to children at the Memorial Sloan-Kettering Cancer Center. Fleming Chapter supported a food bank in South Florida by gathering donations of over 11,400 canned goods, their record to date. Articles about this event were published in the *NSU Current* as well as the *Broward County Sun-Sentinel*—what an accomplishment!

Some Chapters combine their efforts to help their communities. Frankfurter and MacLean Chapters co-organized multiple events to benefit cancer research by participating in the Making Strides Against Breast Cancer Walk in Boston and helping an organization called The Home for Little Wanderers; a New England-based charitable organization whose goal to ensure the healthy behavioral, emotional, social and educational development and physical well-being of children and families living in at-risk circumstances. Their merged efforts raised a combined total of almost \$3,000 in charitable donations. When multiple Chapters work together, it not only furthers P.A.D.'s mission, but their ability to help their community and create a greater fraternal bond.

Alumni Chapters are required to hold at least one community service event per year. The West Suburban Alumni Chapter in Chicago has continued to exceed this requirement and not only provides service to their community, but to P.A.D. student members. Their annual scholarship, The Anthony A. DiGrazia Scholarship Fund, recognizes outstanding P.A.D. student members with scholarships in amounts of \$500 to \$750. Additionally, they annually sponsor a charity bowling tournament to raise money to support the

homeless. Their community involvement, as well as involvement with current P.A.D. students, sets a great example of fraternal commitment to serve the community after graduation.

Pre-Law Chapters are required to participate in two community service initiatives per semester. Although only two are required, many Chapters took leadership in this facet of P.A.D. programming and committed their Chapter to helping their communities.

Florida A & M University gave their time to over 9 organizations and causes including, *Relay for Life, The Shelter, Toys for Tots, Christmas for Katrina, American Red Cross, Community Center, Ronald McDonald House*, food drives and campus cleanup initiatives. These organizations provide necessities to people in shelters, underprivileged families and those battling cancer, to name a few.

The Pre-Law Chapter at Penn State University gave 120 hours of their time to benefit *THON*; an organization that raises money for victims of pediatric cancer, *RAINN*; an assault organization, and the *American Red Cross*. The dedicated Penn State Chapter raised over \$5,000 to benefit these organizations.

David Lipscomb University's Pre-Law Chapter has earned recognition for dedicating 925 hours and raising over \$62,000 to benefit 13 charitable organizations. Their high community service achievement is in part due to initiatives in the Law, Justice and Society major curriculum, general dedication of P.A.D. members to their community and their involved Chapter President, Eric Heath. Heath is the advocate for *Invisible Children* on campus, an

organization that seeks to restore peace and end the use of child soldiers in Central Africa's rebel war. Because of his standing and enthusiasm, community service opportunities are abundant.

Recently, members raised \$15,000 as an operating budget for a related fundraiser called *Twenty-Five*; which fundraises across the country and ultimately raised 1.5 million dollars for the cause. Their achievements in helping the Nashville community are outstanding and P.A.D. is proud of their commitment and achievements.

Although community service is only one facet of Phi Alpha Delta, it is an important one. As budding lawyers whose profession will ultimately be to serve the people, community service is one great way Phi Alpha Delta helps its members become well rounded law students, pre-law students and lawyers.

There is still a place for you in the Fraternity and a place for the Fraternity in you.

Before turning the handle on the bathroom door, I took one last look at the forum, sipped my iced coffee and pondered, "I should have ordered a hot coffee. Perhaps I need a Roman holiday."

Get Ready for the 59th Biennial Convention!

By Jon Bassford (Willis), Director of Law Operations The 59th Biennial Convention will be here before you know it! It is not too early to begin planning.

Why Should a Chapter Send a Delegate?

Every Chapter is entitled to two votes that help shape our Fraternity's future. Votes are cast on elections, rules and resolutions, and Constitution and International By-law Amendments. If a Chapter does not send a delegate, these votes are lost. Chapters are expected to send at least one delegate.

Additionally, Convention is a time for delegates to learn more about P.A.D. and its operations. Delegates leave with useful leadership skills and information that will Hiennial Conversed grades of the cotts dale, A Services help their Chapter provide more services to its members and grow.

Why Should I Want to Go?

Convention is incredible time! Delegates partake in networking opportunities and professional development programs that will help them in their career and throughout life.

Delegates that attend Convention describe it as one of the best times they ever had!

Who Can Attend?

Officers are encouraged to attend but it is open to all members!

To be a voting delegate for a Law School Chapter, you have to be a member of that Chapter and have at least one semester remaining in school following Convention. Alumni Chapter delegates need to be members of the Chapter as well. Alumni Chapters need to have performed certain duties such as held elections and paid the Chapter tax. Law School and Alumni Chapters must also submit the credentials form. Please contact the Executive Office for more information about the credentialing process. We will help make sure your Chapter is represented!

Every District has two At-Large Delegates that can be appointed by the District Justice (or International Justice if there is a vacancy). These individuals must be dues paying alumni who live in the District.

How Much Does It Cost?

Registration/Hotel

Chapters/individuals are responsible for the registration fee. The registration form gives the breakdown of prices. The registration fee covers the hotel room, registration materials, all programming, all events, and most meals.

Please note that there is special pricing for Chapters who wish to have more than two delegates in a room.

Also, if you graduate this academic year, P.A.D. has a special offer for recent graduates. Contact the Executive

Office for details.

Transportation

The Fraternity reimburses airfare for the first delegate. On or about June 1st, we will run airfare from the closest major or regional airport to the Chapter. The amount we find to Phoenix, AZ is the amount we will reimburse up to. If the Chapter spends less than our researched amount, it will receive a 100% reimbursement. Delegates are responsible for transportation to the hotel.

If a Chapter/delegate wishes to drive, mileage is reimbursable at \$.35/mile but will be capped at the lesser amount.

How Do We Get the Funding?

August 1-5, 2012

The two most common ways Law School Chapters acquire funds for Convention are through requests to either SBA or the dean's office. If SBA does not have the funds, Deans have discretionary funding that may be an option. It does not hurt to mention SBA usually receives funds to attend their national conferences.

Besides school funding, Law School Chapters should hold fundraising events or seek sponsorships. Doing a good ol' fashioned "penny war" can raise enough money to send at least one delegate in just a week. If you would like to discuss this idea or other fundraising programs, please give the Executive Office a call. Another route for funding is to seek sponsorships by a company, law firm, or several alumni. If you can get four alumni to donate \$100, that would give the Chapter enough to send one delegate.

Alumni Chapters may perform various fundraising functions, including the ones above, to help them attend Convention.

Conclusion

This only begins to scratch the surface of why Chapters and individuals should attend Convention. If you have any questions, please do not hesitate to contact the Executive Office. We will do everything we can to get you to Convention. We look forward to seeing you in Scottsdale, Arizona!

Advice From "The Vice"

At its recent Winter Board Meeting, your International Executive Board debated and approved some measures which may have long-lasting impact on the growth and vitality of our members, our Chapters and our Fraternity. These amendments to the Constitution and By-Laws of Phi Alpha Delta will soon be posted on our website for all to evaluate and discuss.

Each Chapter, and some individual members, will have a say in whether or not these measures take effect. Those who will have a voice in these matters will be those who attend the biennial P.A.D. Convention in Arizona later this summer.

Each active law school and alumni Chapter of our Fraternity is eligible to send a delegate to the Convention in Scottsdale. Any dues-paying alumnus may attend the Convention and have a vote in a committee and on the floor of the Convention; they must be appointed by the District Justice of the district in which they reside. As in any other representative

body, you must be present during the voting to have a say in the matters of the organization.

Every two years at about this time, the Executive Office reaches out to our Chapters to encourage attendance at Convention. A delegate from a qualifying Chapter may have travel expenses and hotel costs covered by the Fraternity, yet we often have few who take the offer*. With that incentive in place, we expect all Chapter's have representation when the Convention is gaveled to order on August 1st.

Preparation for the debate, as well as camaraderie, is just as important as attending. The proposed amendments to the Constitution and By-Laws will be posted in March, allowing over four months of reading and preparation for discussion of the subjects. A Chapter can decide how it wants to proceed on a

proposal before the Convention, and then send its delegate(s) to vote. It is democracy in action.

Each day of business brings with it an evening of socializing and networking. As we like to say at Convention, "We work hard and we play hard." Why not join us?

You have an opportunity to be part of the history of our Fraternity, and to prepare to help lead it into the next biennium. I urge each chapter to take advantage of that opportunity. Make certain that your chapter is represented in Scottsdale, Arizona this August.

Just my advice.

I can't believe that it's spring already! I just looked at our school's academic calendar and am amazed at how little time is left in the year. What can I do to make sure our Chapter has a great spring and transition to next year?

Dear Days,

I'm glad that you are looking ahead and are ready to plan your spring calendar. With holidays, spring

break and new officer elections, the spring semester is much shorter than the fall.

Here's what you need to do to make this semester (or quarters) the most beneficial to your existing and future members.

1. Continue to hold programs that fulfill the purpose of a P.A.D. Pre-Law Chapter.

Your Chapter programming should continue to focus on helping your members make an informed decision about continuing their education into law school. If your programming last semester included something like LSAT Prep or speaker presentations, do it again! Your membership has grown and your new members will be eager to have that information as well.

You'll also want to continue holding new programs that will benefit your seasoned members. To do that, your Chapter calendar should include or expand upon programs that answer both traditionally and non-traditionally, "What can I do with a law degree?" You can find speakers from both categories in local P.A.D. alumni. Programs should also provide information that

The Princeton Review helps members understand the admissions process and the financial side of attending law school. Your Chapter programming should focus heavily on helping your members make an informed decision about law school and a law career. While Chapters can contribute 15% of their programming to social events, helping members determine their future is the priority of Chapter programming.

2. Keep recruiting.

Your Chapter is about to graduate a significant portion of its membership. Chapter's that are unable to bring in new members each year can quickly go inactive by graduating all of their members. Ensure that does not happen by holding programs that fulfill your Chapter's purpose and publicizing them across campus; you will generate significant interest. Students gain interest in the law through their undergraduate experience, make sure to continue to spark that interest until the end of the semester.

3. Hold elections before the first Monday in April.

The greatest measure of your efforts this year will involve how well the Chapter does after you leave. Be sure that your successors are able to build on your efforts. Make sure that you hold elections before the first Monday in April (and preferably in early March) so that you have time to hold an officer transition. Many of us have felt like our predecessors left us without any guidance and it happens every year. Be different; take the steps necessary to enable success in the future! Hold your elections early enough to have a transition, and then communicate during that officer transition what worked and what didn't during your tenure as an officer.

4. Attend the Leadership Symposia and Prepare for the 2012 Pre-Law Conference.

Each Chapter is expected to be represented at the Annual Pre-Law Conference in November. Next year's will be held in Alexandria, VA November 8-10. The Pre-Law Conference features a wide variety of speakers and programs that discuss topics such as networking, the LSAT, and Chapter operations.

We also are in the process of holding the spring 2012 Leadership Symposia. So far this year, more than 300 students from 72 Chapters have spent a Saturday developing their leadership and organizational skills.

5. Complete all of the required courses at P.A.D. University.

As a Chapter Officer, you have accepted a great responsibility to serve the Fraternity and your local members. The Executive Office regularly provides information through the online learning system, P.A.D. University. All officers are expected to take assigned courses on the Fraternity's policies regarding Open Membership, Alcohol, Anti-Hazing and Financial issues. The courses are short (10–15 minutes each) and the quizzes are fairly simple.

The Executive Office will send each officer an email with their course assignments and completion deadlines.

University of Mississippi


Phi Alpha Delta's Pre-Law Program continued its rapid expansion this fall when a Charter was granted to the University of Mississippi.

In Memoriam: William G. Conover (Halleck), 1926–2012

Judge William Conover, a Valparaiso native who rose through the ranks of the judiciary and served on the Indiana Court of Appeals, died January 9, 2012 at the age of 86.

Conover served in the Navy during World War II. He graduated from Valparaiso University in 1949 and from Valparaiso University School of Law in 1951. He served as judge of Valparaiso City Court and later served as Porter County prosecutor from 1963 to 1971. Conover served as President of the Porter County Bar Association in 1965. Conover was appointed to the Court of Appeals in 1981, retired in 1993, then served as a senior judge for two years.

Court of Appeals Judge John G. Baker in a written statement said, "He was a true gentleman who spoke glowingly of his children and grandchildren, was very interested in his community, state and nation, and he was a good student of the law."


In Memoriam: Richard W. Konig (*Holmes*), 1930–2012

Richard W. Konig died at the age of 82 on March 22, 2012.


Konig was born in Stockton, CA in 1930. He graduated from Stanford University with a Bachelor of Arts Degree in Economics before attending Stanford Law School and earning his J.D. While at Stanford, he was a member of the Holmes Chapter of Phi Alpha Delta as well as Alpha Phi Omega, a national service fraternity. Konig was admitted to the California Bar in 1955, and following service in the U.S. Army, returned to Stockton to practice Taxation Law and Estate Planning. One of his many career accomplishments included authoring the language known as the Crummey Clause, used nationally in Estate Planning Trusts. Konig also served as the president of the Stockton Estate Planning Council, the Rotary Club and the Stockton Rotary Endowment.

CLEO was founded in 1968 as a nonprofit project of the American Bar Association Fund for Justice and Education. Its primary goal is to expand opportunities for minority and low-income students to attend law school.

Students arrived in Des Moines, not knowing what to expect, as none of them had ever been to Iowa's capital or had ever taken a law school course. What they got was a rigorous six-week training on how to be a successful law student.

Students took four first-year law school courses including Property, Criminal Law, Torts and Legal Research and Writing. They were given the opportunity to explore all of Iowa's court systems and visited the State District Court to the Iowa Supreme Court and the Southern District of Iowa's Federal District court in Des Moines. They also had the opportunity to meet local practitioners, six judges and watch an Iowa Cubs game!

The majority of students had been admitted to schools around the country, but for a few, the Institute was an opportunity to prove that they have the ability to be a successful law student.

In order to provide a well-rounded education and preparation experience for CLEO students, activities focused on providing practical experiences in the law. In coordination with the clerks and judges of Polk County, the CLEO students were able to witness a portion of a trial in a Trial Practicum experience.

This aspect of the institute was similar to a program Drake Law has been coordinating for over a decade, in which first-year law students are able to watch a jury trial from beginning to end.

Students watched a trial of two high school students convicted of second-degree robbery and willful bodily



injury, and were facing up to 10 years in prison. The trial was integrated into their criminal law class curriculum to help solidify the concepts they were learning from their textbook.

Oluwafunmilayo Akinmulero, a CLEO student who chose Drake for her legal education said, "Watching the trial helped to humanize the cases we were reading in the institute."

"In planning my CLEO criminal law course, I wanted not only to teach students about fundamental principles of criminal law, but also to introduce them to the "real

world" of criminal law practice," said Professor Ellen Yee, who taught Criminal Law for the Summer Institute. "In the Trial Practicum experience, students had the opportunity to see how lawyers, witnesses, judge, and jury contribute to the fact-finding process."

"The trial practicum was my favorite experience of the summer," said Sasha Mayo, a CLEO Institute student. "It really made me realize the importance of lawyers and the legal system." Mayo has decided to attend Drake Law School and, because of her experience with the trial practicum, is considering a career as a prosecutor.

Along with helping the 43 participating students prepare for law school, hosting the Summer Institute was an opportunity for Drake Law School to fulfill its commitment to diversity. According to Allan Vestal, Dean of Drake Law School, hosting the Institute "is a reflection of our innovative curriculum and our long-standing commitment to a diverse and inclusive community."

Summer Abroad In Cambodia

In Cambodia, the Communist Party of Kampuchea, otherwise known as the Khmer Rouge, took control of their country on April 17, 1975. The Khmer Rouge were in power until January 1979.

In this short span of just under four years, the Khmer Rouge repressed and massacred their own citizens on a massive scale. In this tragic event of epic proportion, it is estimated that nearly two million Cambodians were killed.

After many years of negotiation, the Cambodian government and United Nations established a joint court to

bring to justice the senior members of Khmer Rouge for charges that include crimes against humanity, war crimes and genocide. The Extraordinary Chambers in the Courts of Cambodia, commonly known as the ECCC or "Khmer Rouge Tribunal has completed one trial—that of Kang Kek Iew or "Duch," the head of the most notorious prison in Phnom Penh. The long-awaited Duch verdict, and the 35-year sentence imposed on him created strong emotions among a people ravaged by the brutality of the late 1970s.

Here, now, is an article written by a Santa Clara University School of Law summer student who completed a summer internship in Cambodia during the period of the Duch trial.

Law and Technology: LSAT Prep...For Free?

In this day and age of technology usage in education, especially legal education, we have come to be accustomed to content, all kinds of content that is readily available at any time and on any day. yourself for the heavy reality of sitting across from someone and having them tell you that a Khmer Rouge Cadre bundled their daughter into a rice sack and threw her into the river right before their eyes.

It is at moments like this you realize that the gap between physical reality and abstract theory is an infinite abyss. Belief systems and moral concepts that have bolstered your existence up until now count for little when confronted by the cold experience of a person for whom those support systems have been challenged and found woefully inadequate.

On trips out to the provinces with the Victim Participation Project of the Documentation Centre of Cambodia (DC-Cam), I have witnessed some interactions with Cambodian communities in Kampong Chhnang and with Cham Muslim communities in Kampot; had conversations with Cambodians kind enough to share their stories, and spent some slack jawed afternoons at the Extraordinary Chambers in the Courts of Cambodia (ECCC) listening to witness testimony. Like the Bett of Cambodian folklore whose mouth is too small to ever eat, the issue of forgiveness hovers in the air after each terrible tale but remains largely unsatisfied.

When DC Cam goes out into the village communities they welcome those who choose to attend and ask them how much they know of the ECCC already. They proceed to inform them on the workings of the court, who is being tried and how they can be involved by filling out complaints or civil party applications. In the course of these meetings, people are encouraged to share their experiences in an atmosphere of openness and mutual understanding. Often participants express the difficulty of retrieving these memories and the cathartic effect of being able to talk about their pasts amongst others who have similarly suffered. There is a tangible feeling of sympathy and support at these meetings and it is wonderful to see. Towards the end of the speakers' talk, just before willing participants usher their plastic chairs to the privacy of the corners of the room and others slowly wander home, 'Searching for the Truth' magazine in hand or carefully wrapped in kramas; the question turns to forgiveness...

from one life to the next, what do you think?'

This was Kampong in Chhnang everyone laughed when the woman in the black shirt blurted that out in the meeting on Thursday, but she summarized the feeling well. In one way or another, the majority of those spoken to expressed the view that forgiveness is a lot easier in theory than in practice.

Religion often highlights this internal conflict. For example, when asked how their religion is reconciled with their feelings towards the Khmer Rouge, one woman said perhaps Buddha did not realize how we could suffer when he wrote on forgiveness. I found that many of the people we spoke to refer to different tenets of their religious philosophies depending on their inclination to forgive. One person may quote the Qur'an citing forgiveness as virtuous and another such as the old woman at the Cham village in Kampot will refer to another passage saying,' if you take a life, you owe a life,' but these people took many lives...' It is the view that appeared predominately shared by others in the Cham communities that I came into contact with.

The ability to forgive is a virtue, like generosity or patience. They are desirable, they should be practiced, but circumstances do not always allow for them. There is no objective standard of forgiveness, it cannot be imposed or judged because it is a deeply personal process. However, the perception of forgiveness belonging to a person who has lived in relative comfort most of their lives, is unavoidably different from another who has suffered horrific crimes against them. It is only the latter who have truly had their beliefs tested and you can see that amongst the Cambodian villagers in Kampot and Kampong Chhnang. Whether Buddhist, Muslim or of no formal

religion at all, there seem exceptional fissures in their daily belief systems where their pain and their inability to forgive is stored; and it sits alongside the regular principles of normal life apart from the Khmer Rouge.

At the meetings I attended, participants were typically shy. In Kampot those that did grasp the microphone would often express their happiness that efforts are being made to bring their abusers to justice. They said it could never bring their families back, nor undo the wrongs they have suffered, but to have some of the leaders of Democratic Kampuchea brought to justice is a start. When asked by DC

Cam to share their stories, there usually appeared two or three in each meeting who were particularly keen to talk.

One woman sat and stared keenly at every mention of the court proceedings and took the microphone and spoke whenever she had the chance, telling us about the death of her family and how she was the only one to survive. At the next meeting on the same day, another older gentleman remained seated in the corner for most of discussion and then rose and spoke powerfully about being forced to eat pork because they knew it was against his religion, about how he was only kept alive because he worked so hard and how they killed everyone else...

Law and Retribution

It is at times like that, when I've sat cross legged on the floor staring up at these people that it has occurred to me that the ability to forgive is often praised and most religious texts expound the virtues of forgiveness, but why should these survivors have to relinquish their anger? The withholding of their forgiveness is their right. Thirty years after the Khmer Rouge era ended, many of the perpetrators are dead and only five defendants are being tried in an internationalised criminal court. The only retribution many of the survivors will ever really have against their abusers is the retention of their anger and their choice not forgive them.

I find it curious how many survivors equate the ECCC tribunal with revenge. Some survivors, who expressed their lack of desire for the trial, did

> so because they no longer yearn for revenge and others expressed their support directly, because of this desire. In countries with more developed legal systems the law is not necessarily viewed in this way. The law is taken for granted as something that is above and separate from the people's will. Criminals are punished for their wrong, not for the victim's desire for retribution, but because society has deemed that it should be so. Viewing the law in this objective and impersonal manner may make forgiveness a little easier because there need not be a thirst for revenge. The wrong is acknowledged and punished automatically leaving the victim the freedom of choice to forgive or not. In a country such as Cambodia where most of the perpetrators have gone unpunished, this choice is not the same. Because they have received no justice from society so far, these people must feel as though their anger is the only form of punishment that the perpetrator will ever receive. Absent that, there is only a series of heinous crimes that have returned no consequences.

The Philosophy of Forgiveness

The concept of forgiveness is a nebulous one in itself and returns more than one definition. Bishop Joseph Butler described it as cessation of a desire for revenge and the relinquishment of the victim's anger. This view





promotes a fairly unilateral perception of forgiveness, which requires no interaction between aggressor and victim, aligning itself with Buddhist values that urge people to let go of their 'bad karma'. Professor Charles Griswold has rejected this approach arguing that the victim fails to truly come to terms with their feelings, burying them instead.

In Griswold's view the process of forgiveness requires far more interaction between aggressor and victim. The individual's forgiveness requires that they see evidence of their injurer's attempt to understand their victim's pain and acknowledges how their actions have caused it. Furthermore the injured must see that their injurer takes responsibility for their actions, repudiates them, and will not do the same in the future. The contrition of the offender is effectively key to the victims' forgiveness.

I find the latter approach over ambitious, effectively precluding the Cambodian survivors from ever forgiving their Khmer Rouge abusers. This suggests that Butler's relinquishment of anger idea is probably the only kind of forgiveness that the Cambodians can ever really achieve. Many survivors do not know who the Khmer Rouge cadre are who harmed them directly and the majority of the upper echelons of the regime have disappeared. Even if they had not, every individual harmed by the Khmer Rouge cannot be apologised to and mass apologies are not likely to be the balm that soothes the deep wounds inflicted. 'It is easy to ask for forgiveness 'one survivor said, 'but then the person could do it again'. Clearly the sincerity of the apology is a factor in its acceptance and the victim's are hesitant to believe. Having said this, the only apology these survivors have ever received has come from Duch, the former head of S-21 who is currently being tried for crimes against humanity and grave breaches of the Geneva Conventions of 1949. He is responsible for the torture and murder of over 10,000 men, women and children, and is the only one out of the current leaders of Democratic Kampuchea to beg forgiveness from his victims. At the meetings I attended, the survivors were often asked for their reactions to this apology and although one woman felt it was nice to have some acknowledgement of wrongdoing from someone, others have rejected Duch's appeal for the people to 'at least leave the door open for forgiveness.'

I can understand how such a request for forgiveness must seem almost inappropriate to some of the victims; for once you have forcibly taken everything from someone, it is too late to ask for anything.

The Victim Participation Project asked some individuals what their response to Duch's apology was and found little support. Piseth from Svay Rieng carries on with his wife's dream of confronting Duch in Court claiming, 'I believe people in general, including me, cannot forgive him;' agreeing with Sophea of Kampong Thom who also said he can never accept Duch's apology, 'no matter what.' When Sophan from Kampong Cham was also asked if she could forgive Duch she responded he must have a 'very cruel nature... [because] from my experience living through the regime, they would keep alive only those who are cruel,' so she, 'cannot forgive him in light of what the victims suffered...'

One survivor raised a thought provoking point, saying Duch's apology only extends to those who suffered at S21, '... what about the rest of us?'

Conclusion

For the rest of Cambodia and those unconvinced by Duch's apology, it may realistically be too late for forgiveness. Before I came to Cambodia, I may have admonished someone for such a bleak perspective, but ideals are sometimes a luxury that not everyone can afford and these people have lost everything. They did not suffer once thirty years ago, they suffer every day because they cannot put the past behind them. The woman who had four children and now has one, the survivor who lives alone because her husband was killed, the man who is too maimed by torture to work are all examples of this. Evidently time does not heal all wounds.

Forgiveness is a choice. It is a legitimate decision that transgresses the heralded ethics of religion and philosophy to settle on something more powerfully human, such as the decision to gather one's dignity about oneself and quietly turn away from forgiveness.

The survivors are not angry every minute of day; they do not hate every day. But if you ask them, this is what most of them will tell you they feel towards the Khmer Rouge. It has become a fact, something they live with. As they live with the absence of loved ones, and the memories that return at unexpected moments and linger on the walk back from the pagoda, long after the meeting is over.
