What's In a Name?

From the day we're born to the minute we take our last breath, a name is one of the most important characteristics we can possess. Names are of vast importance to virtually all cultures, whether they are family or fraternity; we take them with us wherever we go and in whatever we do. The naming of Phi Alpha Delta is no exception; it has played a pivotal role in the history of the Fraternity. Since the Fraternity's "birth" in 1902, the name has represented the foundation of the Fraternity's mission.

While the exact meaning and motives behind the chosen name have been lost in translation, one former Supreme Justice took on the challenge of gathering as much information as possible on its origin. C. Raymond Judice, Supreme Justice from 1974-1976 and author of "P.A.D.: The History Continues..." wrote hundreds of letters to P.A.D. members for 40+ years seeking information. Many members came forward to piece together the reasoning for choosing the Greek letters "Phi," "Alpha," and "Delta." Unfortunately, they were unable to come up with the concrete answers they had hoped to find. "The only thing that is certain is that they are the 21st, first, and fourth letters of the Greek Alphabet," Former Supreme Justice Judice wrote (Judice, 2000, p. 6).

Declaration of Purpose

"The purpose of this Fraternity shall be to form a strong bond uniting students and teachers of the law with members of the Bench and Bar in a fraternal fellowship designed to advance the ideals of liberty and equal justice under law; to stimulate excellence in scholarship; to inspire the virtues of compassion and courage; to foster integrity and professional competence; to promote the welfare of its members; and to encourage their moral, intellectual, and cultural advancement; so that each member may enjoy a lifetime of honorable professional and public service."

Mission, Vision & Core Values **Mission**

Phi Alpha Delta Law Fraternity, International is a professional law fraternity advancing integrity, compassion and courage through service to the student, the school, the profession and the community.

Vision

We are the preeminent law fraternity promoting the bonds of fraternalism and we are the leader in the development and advancement of professional ideals.

Core Values

Bound together by tradition and our common interest in the law, we share these core values: Integrity, Compassion, Courage, Professionalism, Service, Diversity, and Innovation.

Furthermore, Former Supreme Justice Judice explained that many fraternities chose their names based on selected passages of Greek Classic literature. "To ensure secrecy, the first letters were then selected as the identification for the organizations" (Judice, 2000, p. 6). In the case of Phi Alpha Delta, it is believed that "Philos Aldephos," otherwise known as "brotherly love" or "fond of one's brother," had great significance in choosing the Fraternity's letters. Many of the letters returned by members made reference Philadelphia, the city of brotherly love. However, "The one in Pennsylvania was named by the Quakers, one of whose main tenets was brotherly love," Alumnus Charles C. Montgomery explained in his letter (Judice, 2000, p.8).

Due to a lack of tangible support for the name's origin, the International Executive Board decided to add a connotation to the Phi Alpha Delta name. "Exhaustive research having failed to discover the exact intention of the founders in selecting these particular letters of the Greek alphabet for our name... and after giving due consideration to the information supplied by our early members determined that henceforth the phrase 'Phi Alpha Delta' will connote the Greek phrase 'Philos Adelphos Dikaios,'" Former Supreme Justice Judice wrote (Judice, 2000, p. 10). In this sense, Dikaios, means justice. More specifically, the connotation stands for "Love of Humanity Ensuring Justice For All" (Judice, 2000, p. 10).

It is with that connotation that we reflect on the two basic canons the fraternity is founded upon: "Fraternalism—the joining together of dedicated people in a common spirit to promote the improvement of humanity; and Justice, that ideal which we who have chosen the legal profession must preserve by exemplifying the principles of Integrity, Compassion and Courage" (Judice, 2000, p.10). While the name may have endured some changes, Phi Alpha Delta will forever represent the core values and brotherly love it aims to instill in its members.

Historic P.A.D. Society for the Arts

One popular approach to learning history is to memorize important dates. For a P.A.D. member, such dates could include November 4, 1887 (the day the IL Supreme Court adopted a rule which resulted in the formation of the Law Student League), July 27, 1902 (the day that the Articles of South Haven were signed) or November 8, 1902 (Founders Day!). For me, significant dates include November 5, 2008 (my initiation), August 17, 2006 (the chartering of the West Suburban Alumni Chapter (WSAC), and December 11, 2012. Why? That's the Day the WSAC established the P.A.D. Society for the Arts.

The P.A.D. Society for the Arts is an association of WSAC members regularly gathering to experience and enjoy the arts. Sometimes the enjoyment is through mere attendance, sometimes its hands on. Over the first six months, the group has enjoyed activities including a community theatre production of A Christmas Carol in which one our members (modesty prevents me from mentioning any names) performed, a production of A Music Man, burlesque parodies of Star Wars and The Empire Strikes Back, Classic Monday Movie Nights, stage performances by Tony Bennett, Penn & Teller, and Cirque du Soleil, and a Vino Van Gogh-Gogh





gathering in which members tried their hands at painting and reproducing 'Summer's Last Bloom'.

One member, a little known but much loved local artist, has been selected as the group's 'Artist in Residence' for 2013 and commissioned to prepare a portrait in epic, heroic style of our own Brother B.J. Maley. An unveiling event will be later this summer as part of an art show which will include other pieces prepared by or featuring members of the P.A.D. Society for the Arts.

Another project under consideration by the Society is a video production dramatizing significant events in Fraternity history, including the Fraternity's founding and the adoption of the Articles of South Haven. The Society hopes to recruit local P.A.D. members to be part of the production.

P.A.D.'s Sisterhood

P.A.D.'s history is made up of many stories. Some of these stories are told at convention insuring that members of the Fraternity are aware of what occurred before their time. Other stories are held close in the hearts of a select few—the "you had to be there to know it" stories. No matter what story helped create the traditions and legacy of P.A.D., they are important as they teach us where we came from and provide role models. It is the stories of our Sisters that truly fascinate me. The first woman to become an attorney, a judge, a law professor; these are the stories I want to know more about. How did P.A.D. include a sisterhood?



1924 Phi Delta Delta Convention

In 1911, a group of women law students at the University of Southern California formed Phi Delta Delta Legal Sorority, the first legal fraternity for women with the goal to create a national fraternity. Although there were a number of

law schools that had female students, most only had a couple. Five students were required to form a P.D.D. Chapter and only 12 law schools in the entire country had enough female students to meet this requirement. The founding members did not let this deter them and by P.D.D.'s First National Convention in 1917 there were five Chapters across the nation.

Nine years earlier, the all male law fraternity Phi Alpha Delta was formed. P.A.D. would remain all male until 1970. During the 1970 convention, the amendment to allow women to join the fraternity passed with the necessary two-thirds vote. Brother William B. Robertson (*Taft*) had offered the amendment previously at the 1948 convention and it was proposed at several later conventions, but it never had the required vote to pass. Upon passing the amendment, P.A.D. became the first law fraternity to accept women into membership. Two years later, P.D.D., with 68 active Chapters and ten Alumni Chapters, merged with P.A.D. and brought 5,000 women judges, attorneys, and educators to the fraternity.

During the past 43 years, many women have joined the ranks of P.A.D. and added to its rich, proud history. Many of the legal world's 'first woman to...' have been P.A.D. members. Current Sisters and Brothers have many exceptional female members to look up to, follow, and thank for paving the way for us. There are still 'firsts' to be accomplished, many of which will hopefully be completed by a Sister.

2013 P.A.D. Day at the U.S. Supreme Court

PAD Day at the Supreme Court was truly amazing on June 3rd. Thirteen P.A.D. alumni were admitted to the Supreme Court Bar and, shortly after, visited by Justice, and Brother, Samuel Alito (Paterson). We were lucky to be witness not only to their admission but to the upholding of a Maryland law that allows officials to take DNA without a warrant from those who have been arrested, but not convicted of a serious crime. Congratulations to those admitted!



This issue of *The Reporter* takes us back to an earlier time when hair was big and waistlines were not. When music was loud, and so were the clothes. It was a simpler time, when phones were attached to a wall and computers were the size of one! We had to actually TALK to someone to get information.

The 1970s were witness to many innovations in P.A.D. as well. It was the decade of the first female members and the merger with P.D.D. Our first (and only) convention held outside of the continental U.S. occurred when delegates traveled to Toronto, Ontario, Canada in 1974. We added "International" to our



Much has happened since then, and I was fortunate to be at the center of much of what occurred. I served as a student on the 1980 Convention Constitution and By-Laws Committee which approved the pilot program for undergraduate student membership—our Pre-Law Program. I was present in 1992 at "Big Daddy's Bash" as we bid farewell to our Executive Director Emeritus after 40 years at the helm of this great Fraternity. When we elected our first female IJ, I was a member of her cabinet as International Advocate. Then I served as Vice Justice to the only Justice to be elected to two consecutive terms since World War II.

We are making history today with the expansion of our Pre-Law Program beyond 300 Chapters, with two new advisory councils (Law Student and International Relations), with record-breaking initiations in several districts, and with new headquarters in Towson, MD. There is more history to be made, with virtual Chapters on the horizon and expansion overseas within our grasp, in the next decade—and beyond. My question for you is: "What will be your place in P.A.D. history?"

Each of us has the same opportunities to make a difference in shaping the future of our Fraternity. The issue is whether or not we choose to accept the responsibility of taking a leadership role. For some, it will stop at the Law or Pre-Law Chapter level. Others will accept the challenge of being a leader in their Alumni Chapter or district. Still others will seek service on a larger stage. Your level of service, and its duration, will be defined by you. Your role in building a vision for this Fraternity, and carrying out the mission,

is yours to accept.



November 4, 1897

The Law Student League is formed whose members seek exemption from the provisions of "Rule 39" which requires all candidates for admission to the Bar to be graduates of high school, followed by three years of legal study and successfully pass the bar exam. They seek modification to exclude those who began the study of law before the adoption of this rule.




May, 1908 The "Board of Tribunes" is established to hear all appeals from decisions of Chapters. Today, this is called the "International

Tribunal".





February, 1899 Lambda Epsilon's



The name "Phi Alpha Delta" is chosen and the constitution, ritual, and fraternity rules were adopted This day is known as Founder's Day.

December, 1919

The 17th convention is held in Chicago where a new constitution is adopted and post-war rebuilding efforts are discussed.

Blackstone Chapter is established at Chicago College of Law.

May 5, 1903

P.A.D.'s First Convention installs the first non-Chicago based Chapters, Ryan Chapter at the University of Wisconsin and Magruder Chapter at the University of Illinois.

Phi Delta Delta, the women's legal fraternity, is established



July 26, 1902

Lambda Epsilon is dissolved. Its structure provides the groundwork for Phi Alpha Delta.

July 27, 1902

The Articles of South Haven are written and become the foundation for Phi Alpha Delta. Members who are determined to re-group hold their first session to reorganize Lambda Epsilon at the Colonial Tavern in South Haven, MI. After considerable discussion and debate "The Committee" prepares and submits a plan of organization entitled "Articles of Organization", later known as the "Articles of South Haven."

May 5, 1906

P.A.D.'s magazine, The Quarterly, is born at the seventh Convention

July 28, 1914 -November 11, 1918

World War I deactivates almost all Chapters as members go on active duty.

February 2, 1911

The Chicago Alumni Chapter becomes the first Alumni Chapter.

December 1923

The National **Endowment Fund is** established to assist local Chapters in purchasing/ remodeling Chapter houses.

1948 The Executive Office moves from D.C. to Los Angeles.



May 14, 1969 Phi Alpha Delta Law Fraternity becomes 'International' with the first Chapter outside the U.S. being MacDonald Chapter in Ontario, Canada

The Distinguished Service Chapter is established and is to be composed of members of the Fraternity who have been selected in recognition of unusual and outstanding service to the Fraternity. Election is the highest honor awarded by the Fraternity, other than election to International Office.


As we all remember from our



initiation ceremony and Fraternity history, the third convention of our predecessor Fraternity, Lambda Epsilon, was held in South Haven. It was at that time that our Lambda Epsilon brothers decided to dissolve and form a new fraternity. The Articles of South Haven were signed at this convention, and from these Articles and the remnants of Lambda Epsilon, Phi Alpha Delta was born, like a phoenix from the ashes. (The original Articles of South Haven are in my care having been passed down through four successive Chicago area guardians over the last 111 years.)




Brother Miquel flew from Colorado to meet me in Chicago; his journey in space was longer than mine, but our journey through time was the same. After a three hour drive, one time change, and a disturbing 'Man vs. Food'-like detour in New Buffalo, we arrived in South Haven. The Colonial Tavern and Hotel where that fateful meeting took place has survived fire, rebuilding, and remodeling. No longer a hotel, the proud old building is now the Colonial Condominiums. After photographing the Colonial, we explored South Haven and visited local



Many of us consider Chicago to be P.A.D.'s true birthplace, and it is the 'Meeting of the Fraternity at Large' on November 8, 1902, at DeJonghe's restaurant in Chicago, that the Fraternity memorializes as Founders Day. It was at that meeting that our name was chosen and a constitution, ritual and rules were adopted. The DeJonghe no longer stands and is only

Tribunal Celebrates Its Golden Anniversary

The 2012 Convention in Scottsdale, AZ was the "Golden Anniversary" for the International Tribunal, as it was the 50th convention at which Tribunal members were seated.

The International Tribunal is given the difficult task of deciding cases and controversies. In the past, the Tribunal has entered opinions in the areas of membership, expulsion, scholarships and elections, amongst other things.

We honored the efforts of these members, by presenting them with a "Ceremonial Pin" designed by Past International Associate Tribune, Glenn P. Milgraum.

The design offers a visual reminder to all that the Tribunal is an integral part of the fraternal structure that, at times, must stand by itself.

The triangle is used to remind everyone that the Tribunal is made up of three individuals, who sit as a whole, but that any tribunal members can support a resolution to any point presented.

The Book of Law is duplicative of the one found on the right side of the Fraternity's coat-of-arms, and reminds the Tribunal of that immortal and undying spirit which is in truth the Law—to which all precedents must bow and all rules conform. It reminds the members of the Fraternity that the Constitution and By-Laws are the fundamental documents to which all must make reference.

The Turtle is symbolic of the foundation upon which our principles are built. It reminds us that when change occurs it occurs slowly and is the result of due deliberation.

The Gavel depicts the ability of the Tribunal to rule for either side of an issue, when persuaded as to the argument's strengths and its conformity with the principles and ideals of the fraternity.

The Owl reminds us that the wisdom that goes into the decision making process is to be based in education and the law.

In the 2010-2012 biennium, we suffered the loss of three distinguished members of this group: Robert E. Redding, (*Assoc. Tribune '54–'56*); Deborah Hottel, (*Assoc. Tribune '92–'98*); James M. Bierce, (*Chairman '76–'78*).

In the Beginning: P.A.D.'s Pre-Law Program

For many P.A.D.s the presence of the Pre-Law Program has always been part of P.A.D.'s structure. With 316 Pre-Law Chapters, an annual initiation total of approximately 4,000 new members and a total membership of more than 50,000, it is hard to believe that the Pre-Law Program has not always been around! Yet, 40 years ago Phi Alpha Delta consisted only of Law student, Alumni and Honorary members. How did the Pre-Law program emerge from the 1970s, which is often described as the "Me" decade, where Americans were shifting from a sense of community towards a

self-focused attitude?

"Message The from the Supreme Justice" printed in *The* Reporter at beginning of the '70s, reports on conversation the Supreme Justice had with a student who stated that his class "feels no loyalty to school, fraternity, or any organization." The picture painted was of a new generation oflone wolves. motivated solely by

self interests. Participation, according to this student, could be achieved only with the promise of immediate benefit to the individual. The concepts of "Service" and "Tradition" were, according to him, obsolete (*P.A.D.: The History Continues*, C. Raymond Judice).

Fortunately the young man was wrong in his assessment of the makeup of P.A.D. members. While many organizations resisted change, P.A.D. forged ahead in its quest to continue to provide Service to the Student, the School, the Profession and the Community. It was in this environment of conflicting values and goals that the concept for the Pre-Law Program was born.

There was much debate during the 1979 Summer Board meeting that influenced the proposal for the Pre-Law Program. While the support for the proposed program was not unanimous, former International Justice (IJ) McCown's passion for the development of the program resulted in it being a priority that would be brought before the International Chapter at the 1980 Convention.

For over 30 years P.A.D. members have refuted, on a daily basis, the assertions of that young man who claimed that the idea of service to anyone but oneself was dead. This ongoing commitment to service and tradition, through the selfless actions of our members, shows that in P.A.D. the future is bright indeed when one cares for the welfare of others.


Since 2001, Sister Deidre has been a partner

A Unique Scholarship in South Florida

Stewardship and community service are just some of the values that Phi Alpha Delta aims to instill in its members. Brother Richard Steele, Justice of the Holland Chapter, has exemplified all these characteristics and more through his creation of the Charles Rodger Steele Scholarship and

continuous community service to the South Florida region.

An FIU College of Law Student and University of Florida alumnus, Steele came up with the idea of creating a scholarship to benefit the high-school students of South Florida. The scholarship is designed to give aid to students who come from disadvantaged background, more specifically, those who have parents or guardians that are incarcerated.

"I chose this class of students because after gaining a better understanding of the criminal justice system, I have come to realize these classes of individuals are some of the most ignored, shunned and disadvantaged of all," Steele explained. The money to fund the scholarship will be raised by holding poker events, various social events, and holiday themed gifts, to name a few.

Steele chose to name the scholarship after his father Charles. "[My father] taught me that a part of being a man, among many other respects, is to help those who need help, even when it is a great sacrifice", he explained.

Much to Steele's advantage, FIU is also home to one of P.A.D.'s outstanding Pre-Law Chapters. Both Law and Pre-Law Chapters have been in communication and plan on coordinating events to raise money for the scholarship. However, the support for such endeavors does not end there.

"I also think our District has a lot of potential in the South Florida area," he explained. "The legal community here is enormous and impressive. I am trying to work together with the other Chapters on coordinating more events to help our members network with each other and be more effective with our causes." Steele commends both the Law and Pre-Law chapters for their motivation and interest in taking on and completing these tasks.

Steele credits much of the coordination in the South Florida district to the enthusiasm and interest of District Justice, Jason Haber. Haber has been an intrinsic part in creating unity amongst members in the area. He goes on to explain that "the versatility of the organization, the bond of fraternity with others, and the huge networking opportunities" have been a tremendous help as well.

When Steele and Holland Chapter are not busy with fundraising for the scholarship, they also plan on organizing other charitable events such as food drives, clothing drives, and are exploring the idea of possibly offering some type of pro bono legal help for the indigent.

As for Steele, while he hopes to open his own firm upon graduation from law school, he acknowledges that legal career paths often change throughout schooling.

"Whatever I do, I hope I enjoy it and that I always continue to try to do the best [I can]."

Mentorship Program Grows Beaumont Chapter

I saw what a difference being a mentor made, especially to 1Ls, to have someone there who has been through the gamut and is 100% on your side. A lot of upperclassmen wish you good luck and will be there if you reach out, but as a mentor, I reached out to my mentees. I told them what to expect for finals, held their hands when grades came out, helped them learn to study (and studied with them), and basically answered all the questions they didn't know they should be asking. I thought everyone should have a mentor. As Pledge Director, I learned a lot about our membership and the wonderful diversity - every organization on campus is represented, which meant we were a good fit for anyone!

- **R:** So, how did you do it? How did you manage to more than double membership?
- L: I really pushed the Mentorship Program. We started reaching out to 1Ls and new students the summer before their 1L year and offered events and advice during the first week. Also, because I tutored most of them in Property each week, I had a 'captive' audience open to my suggestions! We also encouraged every member to be an everyday advocate for P.A.D.
- **R:** And you found so much success! What obstacles or challenges did you face?
- L: The hardest part was getting 2Ls and 3Ls involved. We experienced some good growth my 2L year but the organization really exploded during my 3L. It was challenging to try and focus on all the new faces while also making sure that the upperclassmen were getting what they needed. Luckily, I had an amazing Board, or I couldn't have done any of it!
- R: What was most rewarding?
- L: The most rewarding part was providing mentors for new members. I firmly believe that our Program is the biggest

- benefit we have for 1Ls. I love it when I see them having lunch, delivering care packages, or even just chatting on Facebook.
- R: You gave a lot to P.A.D., but what did P.A.D. do for you? How did your involvement as Pledge Director, and later as Justice, change your law school experience?
- L: First and foremost, I met amazing people. It goes back to diversity - I met people I had no classes with and who weren't in any other organizations with me. P.A.D. kind of defined my 3L year-it seemed like everywhere I went, there were PADdies: I loved it! Also, it meant so much to me to be elected Justice. I came to law school a little later in life, and I was so honored when all the 20-somethings picked me to be their leader and trusted me with this amazing organization.
- **R:** P.A.D. shaped your time at California Western. How does it feel to graduate?
- L: While it's bittersweet to hand over the gavel, I know I leave a strong organization behind with an enthusiastic new Board. I have such faith in the new Justice, Sara Khosroabadi, and I'm just so excited to see where the Beaumont Chapter goes next!



Taking the Guesswork Out of The Bar Application

As a P.A.D. member, each of you has access to study material, including Bar Exam questions. These resources are offered because P.A.D. wants each of its members who so desire to become lawyers to actually have that wonderful opportunity to represent other people or entities for their legal needs. For many



of us, the path to achieving that lifelong goal has a few obstacle; for example, the dreaded Bar Exam. There are stories—even legends—describing the horrors of that one fateful test that has the power to impact the rest of your life. The problem is, the Bar Exam is only one piece of the puzzle. The other piece, albeit less flashy and dreaded, is equally, if not more influential than the Bar Exam. That piece is the Bar Application.

The problem with the Bar Application is that it seems innocuous enough. After all, how can a form that is asking you about yourself be that difficult, right? Especially in light of the Bar Exam! Unfortunately, that trap has delayed the careers of countless otherwise fully qualified and capable law grads. The reason the Bar Application is so difficult is because the state Bars are not normally collecting volumes of personal information from each applicant because they want to include you on their holiday mailing list. Rather, the Bars use the information they obtain from you to probe into your background and confirm every single statement (or omission) in your application. The slightest mischaracterization or ambiguity can be the difference from clearing the committee's investigation to waiting an untold amount of time for that clearance. These committees are not trying to delay your careers. Instead, they are generally concerned with taking every precaution into

ensuring that their state Bar is not filled with liars and thieves who will dishonor the profession the Examiners have dedicated their lives to. However, irrespective of the various Examiners' motives, an investigation into your past can delay your career by months, if not years.

Indeed, what is the difference, really, from failing the Bar Exam and not being admitted because of your Bar Application? If either of these are not overcome, you, the would-be attorney, is prohibited from adding those three cherished letters after your name—Esq. On some level everyone knows about this, which is why Bar Exam courses charge thousands of dollars preparing students for the test. But who helps you with your Bar Application? The truth is that there are very few organizations out there that are dedicated toward that end.

One such organization is Ethos Reports, which is a featured P.A.D. sponsor and currently in the process of applying for its 501(c)(3) non-profit status. Ethos Reports is not a law firm, but is rather a background investigation company that only investigates Bar applicants who specifically want assistance with their own Bar Application. The company's goal, as stated on its website, is help take the guesswork out of the Bar Application by performing the preliminary background research for you and then compiling all of it into an easy-to-read and understand product that can then be used when filling out and finalizing your own Bar Application. Not everyone remembers every

speeding ticket they have ever gotten, or knows for sure how that incident report read that was filled out by a public safety officer in college. The Bars want to know every address you



have ever lived, or job you have ever had and they will find it, even if you do not disclose that information. In fact, sometimes it is the failure to disclose that part-time job you had in between college and law

Niagara Falls Attorney Receives P.A.D.

Integrity Award

The Niagara Falls Country Club was the setting as members of the Niagara Frontier Alumni (NFA) Chapter gathered for the presentation of its annual Integrity Award on May



3. The International Justice was on hand to present the award to Thomas J. Caserta, Jr., a Niagara Falls (NY) attorney in solo practice for nearly 30 years. The occasion was the annual Law Day Luncheon of the Niagara County Bar Association.

The P.A.D. Integrity Award is presented to the attorney who epitomizes the cornerstone principle of our fraternity through his/her actions in and out of the courtroom. Caserta was nominated by one of the four sitting Supreme Court Justices in Niagara County, and selected by a committee of members of the NFA. Caserta, a graduate of Canisius College and University at Buffalo Law School, but not a member of Phi Alpha Delta.

Concentrating his practice in the areas of family and matrimonial law, Caserta is an esteemed and well-respected attorney in Niagara County. He is a former President of the Bar Association of Niagara County and the current Chairman of the Cerebral Palsy Associations of NY. He also serves on the Character and Fitness Committee of the NY Eighth Judicial District, which oversees admission to the NY State Bar. He has won numerous awards for his work as a guardian on behalf of children.

Caserta is the father of two sons. He and his wife, Judith, reside in Youngstown, NY.

What Was The Most Significant Event in P.A.D. History?

"Anna Carolyn Fox Hinds made history when she became the first female member. But the real answer to the question is this: The merger with Phi Delta Delta.

In 1972, the Convention in San Diego was the sight of this historic collaboration, at which time two board members of PDD became the first women members of the Supreme Executive Board. That opened leadership roles to women in our fraternity, and they responded. Over half of our current District Justices are women, and in the 12 years preceding my election as International Justice in 2012, six of those years had a woman occupying this office, holding the gavel. Shelley Weinstein and Rhonda Hill are pioneers in the second century of this organization, and they have set the benchmark for others to follow."

- **Q**: Do you know the chartering members?

- **Q**: What did you do to preserve P.A.D.'s history at FIU?
- **P**: One thing I personally had the honor of starting is what I dubbed the 'P.A.D. Semesterly Book', a nod to a high school yearbook. Basically, every incoming P.A.D. class gets a couple pages in the book. Alongside the large "New Brothers" picture, kind of like a high school graduating class picture, tons of others taken over the course of the semester at various events are featured.
- **Q**: Why was preserving the history of P.A.D. at FIU important to you? Did you choose the role?
- P: I've moved around a lot, 3 elementary schools, 2 middle schools, 2 high schools, FIU in Miami and now I'll be moving across the country to LA to attend Southwestern Law. Through these moves, one thing has been clear: there are the friends you eventually (unfortunately) lose contact with and then there are those that become a part of your life and have changed you forever for the better. It is of this second group that I consider my FIU Phi Alpha Delta brothers. I cherish the memories we made and this was important to preserve.

I initially interviewed for the Recruitment Chair position. Right before I walked out of the room post-interview, all of the eboard asked me to step outside so they could discuss something. After about 10 minutes, Octavio Mella (the President at the time) says that my emphasis on social media (Facebook, Twitter, Youtube, Flikr, etc.) and the FIU 'P.A.D. Semesterley Book' had prompted them to discuss the creation of a new position for me. the Chair. Historian Unsurprisingly, I was very shocked; I was astonished that they would create a new chair for me. I said yes in less than a heartbeat. Is that possible? They changed my life that day.

- **Q**: Were you the only person in charge of history preservation?
- P: Initially, yes. I was extremely excited about the position and all the open air the rest of the executive board gave me to really fly that Firebolt. I had so much I wanted to do with the position that I started working on things during the Summer semester. With the new class that joined that Fall I was able to take on a committee that wanted to help.
- **Q**: Did you use technology to preserve the history? (most of P.A.D.'s history is in paper form)
- P: I had no idea that most of P.A.D.'s history is in paper form, that is quite unique! Well done! We do use technology to preserve the history, it's undoubtedly easier. In my opinion, it's very easy to use technology to preserve history but it is for that same reason that it

becomes easy to lose the human element to it as well. This is why the P.A.D. Semesterly Book is a HUGE purple book instead of an online slideshow. When I presented the idea of the book. remember specifically saying, if I ever get to come back to a FIU P.A.D. Chapter 10 years down the line, I'd like to be able to pick up the book and show the newer brothers what it used to be.

- **Q**: Did your position ever require research or was it solely creating history and making sure the next generation will know about it?
- P: Mostly helping to create the history, however I did add in the previous 2-3 classes that joined prior to me. We had a couple of the brothers from those classes looking at the book during a few of our recruitment week events. I'm ecstatic to say they loved what they were seeing! +10 to Gryffindor!
- **Q**: Suggestions for other Chapters to preserve their history?
- P: Being a Historian can be difficult and very time consuming but take my word for it, it is very well worth it. Take lots of pictures and videos, crack lots of jokes, always be friendly to those around you. In general, make friends! You'll have a full website in no time. Have fun, stay awesome.

In the Beginning: P.A.D.'s Pre-Law Program

For many P.A.D.s the presence of the Pre-Law Program has always been part of P.A.D.'s structure. With 316 Pre-Law Chapters, an annual initiation total of approximately 4,000 new members and a total membership of more than 50,000, it is hard to believe that the Pre-Law Program has not always been around! Yet, 40 years ago Phi Alpha Delta consisted only of Law student, Alumni and Honorary members. How did the Pre-Law program emerge from the 1970s, which is often described as the "Me" decade, where Americans were shifting from a sense of community towards a self-focused attitude?

The "Message from the Supreme Justice" printed in *The Reporter* at the beginning of the '70s, reports on a conversation the Supreme Justice had with a student who stated that his class "feels no loyalty to school, fraternity, or any organization." The picture painted was of a new generation of lone wolves, motivated solely by self interests. Participation, according to this student, could be achieved only with the promise of immediate benefit to the individual. The concepts of "Service" and "Tradition" were, according to him, obsolete (*P.A.D.: The History Continues...*, C. Raymond Judice).



Fortunately the young man was wrong in his assessment of the makeup of P.A.D. members. While many organizations resisted change, P.A.D. forged ahead in its quest to continue to provide Service to the Student, the School, the Profession and the Community. It was in this environment of conflicting values and goals that the concept for the Pre-Law Program was born.

There was much debate during the 1979 Summer Board meeting that influenced the proposal for the Pre-Law Program. Most notably, the IEB had to decide whether to accept a sudden change in advice from the Fraternity's tax counsel that, should such a concept be approved, a Pre-Law Program would need to be incorporated as a part of P.A.D. While the support for the proposed program was unanimous. former International Justice (IJ) McCown's passion for the development of the program resulted in it being a priority that would be brought before the International Chapter at the 1980 Convention.

"It wasn't a slam dunk," remembers John Weitkamp (Ford, Past IJ). "We spent the majority of the convention talking to the student delegates and getting support for it. Their general comment was that 'We need to do something like this because if I had known what law school was like I would

never have gone.' It was discussed for three hours and then blessed into concept in a report to the International Chapter on the floor of the convention."

With approval in place, the IEB and Executive Office were now tasked with actually starting a Pre-Law Program. John Weitkamp remembers that "the most daunting thing, despite all of the previous contacts by schools inquiring about a Pre-Law Program, was getting Chapters established. No one wanted to be a guinea pig, especially with most undergrad administrations envisioning an 'Animal House' type of fraternity."

Fortunately, a Chapter charter was applied for by Southwest Missouri State University (now Missouri State University). The location of the school, the presence of several alumni and a potential legacy member provided the Fraternity with the perfect test site. International Secretary Jack Miller (Benton) was an adjunct professor and the Chartering President, Eric, was the son of Past IJ Don Hutson. All individuals involved understood P.A.D.'s purpose and the expectations for the Pre-Law Program. On April 24, 1981, the first Pre-Law Chapter was installed by IJ Steve Clark (Garland), who was also serving as Arkansas' Attorney General.

Entering its 33rd year, the purpose of the program that was presented to the delegates at the 1980 Convention remains. Providing Service to the Student, the School, the Profession and the Community while continuing to expand (the first online Chapter has been approved and will be installed this August) has enabled Pre-Law to not only grow quickly, but stand on its own and be a valuable part of our Fraternity. It is this dedication to the original purpose of helping Pre-Law members make an informed decision about pursuing a law degree and to be as prepared as possible for the application process and the rigors of law school that has enabled its ongoing success.

For over 30 years P.A.D. members have refuted, on a daily basis, the assertions of that young man who claimed that the idea of service to anyone but oneself was dead. This ongoing commitment to service and tradition, through the selfless actions of our members, shows that in P.A.D. the future is bright indeed when one cares for the welfare of others.

Phi Delta Phi had that distinction.

It was not that long after the merger, in which 5,000 women law students. attorneys and judges became, literally overnight, members of P.A.D., we were the largest law fraternity in the world. We could and did then adopt slogans such as: "We are not the best because we are the biggest, but we are the biggest because we are the best".

Another benefit of the merger with P.D.D. is it enabled P.A.D. to truly embrace an organization of both men and women. That



was so because P.A.D. had removed the male only restriction only two years the earlier. at 1970 convention. In those years from 1970 to 1972, only a small number of female law students joined P.A.D. Furthermore, until the merger with P.D.D., since P.A.D. had been coed for only two years, understandably,

there were few, if any, women alumni of P.A.D.

That is what I think is the most significant event in P.A.D. history. As a litigator and advocate, I welcome the thoughts of my fellow P.A.D.'s as to whether they agree, and as to what others may consider the most important event in our great law Fraternity's history.
