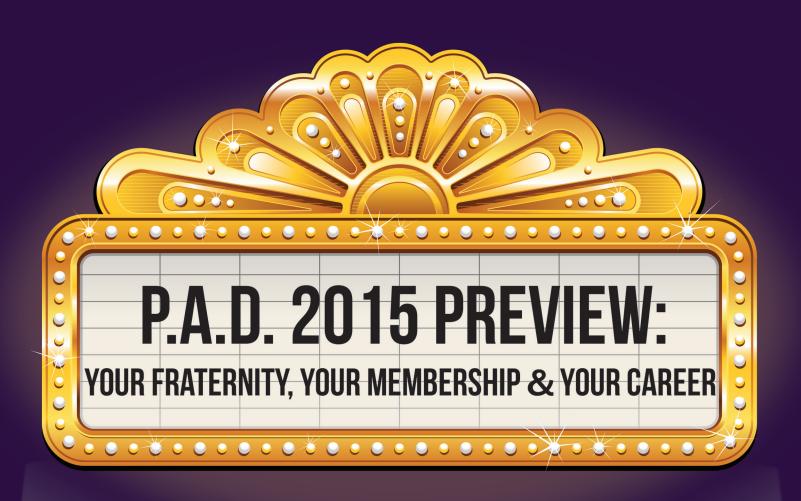

# Message from the International Justice

I registered for the 2016 Convention and paid my alumni dues. Although Convention is approximately 18 months away, now is as good a time as any to register. If you have not attended a Convention, now is the time to attend. If you have not been to a Convention in many years, now is the time to return. But I also urge the Law and Pre-Law Chapters not to neglect their spring initiations and officer transitions. Without robust recruitment numbers and a well-informed set of new officers, there will be no one around to attend our Convention.

The International Executive Board (IEB) recently concluded the winter board meeting in Towson, MD. Admittedly, I griped about the fact that we moved the meeting to Towson instead of traveling to my preferred location of New Orleans. I had envisioned jazz music by candlelight, dinner at Galatoire's, fun-filled rides on the old St. Charles streetcar line, and moonlit walks on Bourbon Street. Alas, it was a mirage. New Orleans proved significantly more expensive than Towson as a meeting site. Ever cost-conscious, we elected to meet in Towson, which is famous primarily for being home to the P.A.D. Executive Office.

In retrospect the choice proved delightful. All of the IEB members, plus past International Justices Ron Winter and Curtis Anderson, arrived in time on Friday night to attend dinner together. In fact Brother Winter drove all the way from Buffalo to Towson, with a short detour into snowy ditch. ignoring for the past half century or more. On a more somber note, we opened several boxes of P.A.D. items that had belonged to our dear departed Brother C. Raymond Judice. Among the treasures were a 1904 copy of the P.A.D. Constitution (elegant in its brevity); a copy of the



transcript of Judice's roast (composed in rhymed couplet); the official P.A.D. wick trimmer; and a slide ruler for the application of Robert's Rules. Brother Judice left us a box full of happy P.A.D. memories.

Life is short, P.A.D. endures. Many of us recently attended Brother Judice's funeral in Houston, TX, including a large cast of former International Justices. Many have come before me in this role and many will come after me. Ralph Waldo Emerson opined that "The purpose of life is not to be happy. It is to be useful . . . honorable. . . compassionate, to have it make some difference that you have lived and lived well." I would submit that P.A.D., in its own modest way, is an expression of a meaningful life, one devoted to service and to the ideals of integrity, compassion, and courage. Through P.A.D. we create communities and networks of individuals steeped in the ideals and traditions of P.A.D. We create opportunities for leadership and professional development. The opportunity is there for each member to participate in some meaningful way in Phi Alpha Delta that will persist well beyond my brief tenure as International Justice and well beyond my brief moment on the stage of life.

# Between Professionalism and Personal Life in Law

When I first opened my law practice, I had a rigid perception of how an attorney should act and dress. When you say "attorney" most people imagine the same person. It's a rather stuffy professional, in a suit, cleanly groomed, who avoids any off-colored comment in order to play the role. That's certainly what I thought.

I do not have any attorneys in my family. I interacted with many attorneys throughout law school, but most of the interactions only reinforced my jaded perception. So naturally, when I launched my legal practice after law school, I dressed professionally and avoided any conversion that aroused suspicion in my work ethic. I was the king of boring small talk while dressed in a suit. I was an attorney for my clients, but rarely a friend of my clients. I felt fake.

I decided I was going to be myself and if clients didn't like it, then tough, we probably wouldn't be a good fit anyway. I figured this would kill my number of leads and new clients, but the heck with it. To my pleasant surprise, it had the opposite effect. I opened up on social media. I posted more fun, social, and personal facts rather than blog articles about the law. I started attracting more like-minded professionals and clients. On top of that, I built stronger business relationships where I did not feel guilty grabbing a beer with a client to discuss business or sharing a personal experience to help relate to the current situation. It was invigorating. I felt alive again! And now today, most importantly, I feel authentic.

I share this story because I think the practice of law has a cruel tendency to push attorneys into something that they are not. It is no wonder there is such a high level of career dissatisfaction among attorneys. I advise all law students and attorneys to stay true to themselves. 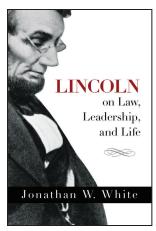

#### **Lincoln Offers Timeless Advice** for Legal **Professionals**

Professor Jonathan White (Christopher

Newport University Pre-Law Advisor) combines specific, yet applicable advice from Abraham Lincoln's experience as an attorney. Lincoln on Law, Leadership, and Life is a quick read with six chapters offering knowledge on dealing with the various aspects of the legal profession. White incorporates personal excerpts and quotes from Lincoln and other close acquaintances to emphasize Lincoln's impact.

Throughout the book, anyone unfamiliar with Lincoln before his presidency will now understand his important influence to the law profession. Lincoln represented the positive aspects of lawyers that many are currently attempting to achieve. Whether working with bad clients or tough judges, he remained fair, honest, and upheld the law. While Lincoln had his struggles such as being unorganized, he was always prepared for his cases.

White, who introduces Lincoln to his pre-law students, mentions how his book will inspire current and future practitioners.

"Here was a guy who overcame incredible obstacles and personal troubles. He was born in a rustic log cabin in the frontier, was surrounded by death and hardships, and he never had much formal education, but he taught himself how to think and read well, and he used those skills to teach himself law," says White.

Lincoln is a helpful guide for people looking to improve themselves in the profession. White reminds readers that Lincoln often served as a "peacemaker." Students, faculty, and other attorneys will find helpful tips for engaging with other P.A.D members or handling cases.

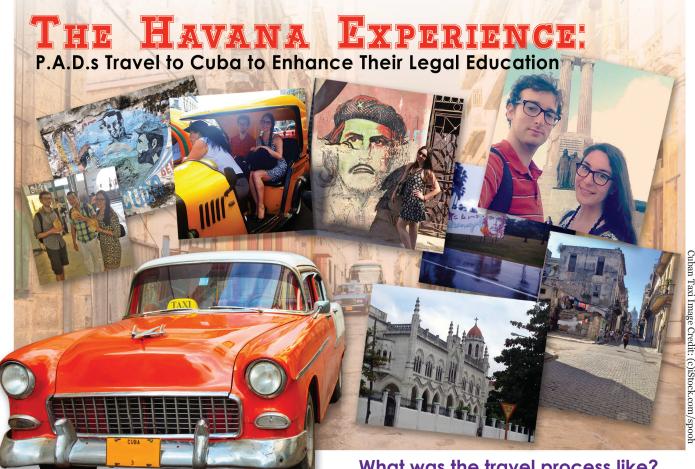

A group of 24 students at Suffolk University Law School in Boston, MA travelled to Cuba in January this year to complete a negotiation/ mediation course at University of Havana Law

> School. Former Massachusetts judge and adjunct Suffolk Law professor Isaac Borenstein, a native of Cuba, coordinated the trip. Only a third of the applicants for the course were accepted

pplicants for the course were accepted into the group.

Melanie Klibanoff and Alex Zamenhof, members of Phi Alpha Delta's Frankfurter Chapter on campus, were two of these students that spent 11 days in Cuba, just three weeks after the announcement

restoring diplomatic relations between the U.S. and Cuba for the first time since 1961.

The below are their shared experiences in Cuba from a tourist perspective and insight into Cuba's legal education and legal system.

What was the travel process like?

**Alex:** We had to travel through Toronto because at the time of our trip, the new regulations had not yet been fully implemented. Toronto to Cuba was an uneventful trip, although the visa process required

at the time was incredibly complicated and strenuous.

Melanie: The school had a travel agent from a company arrange our tickets; airfare from Boston to Toronto to Havana and back was about \$1,000. We also needed international health insurance for our trip.

#### What was it like being an American in Cuba?

Alex: The Cubans were very welcoming when they found out we were American—we didn't experience any pushback; on the contrary, everyone wanted to talk to us about the U.S. and to tell us about their families who live there. They certainly pegged us as foreigners—even the native Spanish speakers among us—and as a result we were grifted and overcharged on

intilitation of

numerous occasions; however this was common to all tourists.

**Melanie:** It was incredible. Due to the unique timing of our trip, the Cubans were very welcoming and loved that we were there. Their culture is very different than ours. I find Cubans much more friendly, warm, and welcoming. The best way to describe Cuba: "it was beauty in chaos."

#### What information/skills did you learn there that you could bring back to your legal education/ a future career in the legal field?

**Alex:** I was able to learn a lot about the Cuban legal system and international conflict of laws in general. Learning alongside Cuban law students, hearing their ideas, and being educated by them in the workings of the legal system of a very different country provided me insight that will be valuable in my future legal career.

Melanie: We took a course at the University of Havana in International ADR (negotiation/mediation). It was very helpful in learning ways to overcome language barriers and cultural divides with clients. We conducted several mock situations where students role played with interpreters to try and resolve disputes out of court. I've learned alternative methods to solving problems not only through course instructors, but also listening to Cuban law students and their resolve approach to a hypothetical from an angle I would

#### Are there any standout differences in Cuba's legal system versus ours?

never have thought of.

**Alex:** The biggest difference in my mind is that criminal defense is victim centered as opposed to defendant centered. It is the rights of the victim

that are more prominent, whereas in the U.S. the defendant is always forefront in debates about mistreatment, abuse of human rights, etc. Additionally, law firms in Cuba operate more as a team than as individual lawyers. Also, professors in Havana make about \$30 a month in salary.

Melanie: There are obvious differences in the laws of Cuba versus the U.S., i.e. Cubans can marry at the age of 14. In a communist country, the government has a much larger role in setting the laws, for example there isn't a lot of seafood in Cuba because the government regulates their fishing activity. In criminal cases, attorneys are involved much earlier on in the U.S. than Cuba.

## Would you recommend this academic trip to fellow law student P.A.D.s? Why?

**Alex:** I would recommend the trip, although I fear any future trips will be quite different due to the new regulations and the more open method of travel now available. I would stress that any students

desiring the "Havana Experience" we had should try and go as soon as possible before things change and the country loses some of its "lost in time" feel.

Melanie: I would absolutely recommend this trip! I think it's important when learning to be an advocate to understand different backgrounds and cultures to better represent any client you may have. If you are interested in practicing international law, this trip is for you!

# What's the highlight of your membership/ best thing you've gotten from P.A.D. so far?

**Alex:** I like the "insider" feel of P.A.D. job postings. In a world where a job is a treasure to be found rather than an automatic privilege, any extra bit helps!

**Melanie:** I have participated in a number of P.A.D. events nationally, in my District, and my Chapter. P.A.D. is more than just an organization, it welcomes you into a family. I have had so much help from attorneys and I believe I will become a better lawyer and advocate from the support and mentorship I have received. So I would have to say that my favorite thing about P.A.D. is the people I have met and the lifelong friendships I have formed with law students and lawyers in all four corners of the U.S. (and Alaska too).

# Median Salary at Largest Firms Drops

The latest salary survey is out and while some salaries for new graduates appear lower, they are, in fact, flat.

The nation's largest firms, those with more than 700 attorneys, reported a median salary of \$135,000, down from \$160,000. But the drop is a reflection of more law firms reporting data in that size range, as opposed to salaries dropping.

"I was surprised that the aggregate data fell so much but I understand why," said James Leipold, NALP's executive director. "It's not that firms are paying less, it's that the list of law firms surveyed are different."

Leipold said through mergers and acquisitions, regional law firms with 700 or more lawyers are becoming more common.

The number of entry-level lawyers earning \$160,000 at large law firms has dropped significantly during the last five years, as more firms grow and move into that range. In 2009, nearly two-thirds of entry-level salaries were \$160,000, while that figure clocked in at only 27 percent this year.

only 51 percent from \$45,000 in 1995 to \$68,000 in 2014. Inflation was 56 percent during that same time period.

NALP found that mid-sized firms, those with 26-50 attorneys, saw the biggest increase in median associate salaries. Firms of this size saw a 110 percent increase from \$50,000 in 1995 to \$145,000 this year.

Firms with 51 to 100 attorneys saw an 85 percent increase and firms with 101-250 attorneys saw a 79 percent increase.

The National Association of Law Placement reports that the overall national median first-year salary at firms of all sizes is \$125,000, the same figure since 2012.

"Many law offices that are part of large firms, particularly those in the largest markets, continue to pay \$160,000," Leipold said. "But the data since 2009 clearly show that the large firm market now also contains many firms that do not pay \$160,000. In some ways the data simply reflect the growing cohort of large firms and its shows that they are not a monolithic entity. In many markets starting salaries of \$145,000

or \$135,000 or even less are the norm."

Law firms with more than 250 attorneys have increased median associate salaries by 93 percent from \$70,000 in 1995 to \$135,000 in 2014. Small firms (those with less than 25 attorneys) increased by

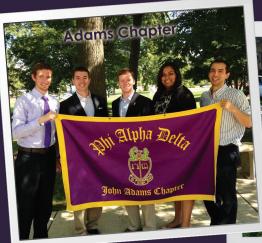

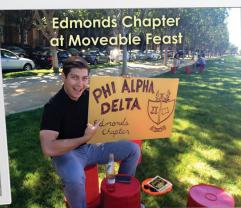

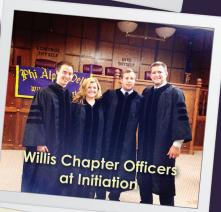
