Compassion and courage are essential if a lawyer is to be a true servant of the law for all the people. One who would serve the law and attempt less than complete loyalty to these principles is unworthy of the status of a lawyer, or of membership in this Fraternity."—P.A.D.'s Book of the Ritual (Page 10)

Service for Hurricane Harvey Victims

Hurricane Harvey was one of the most devastating natural disasters to ever hit the United States. During these seemingly impossible moments, we as P.A.D. brothers and sisters rely on our core values of integrity, courage, innovation, diversity, professionalism, compassion, and service. There were many acts of heroism and bravery during the hurricane, including those performed by Erik Smith a 3L P.A.D. student from South Texas College of Law.

During the storm, Erik was watching the news and saw that people were being inundated with water and in desperate need right down the street from him. Erik went into action. In addition to his studies, he's a law clerk at Evans and Powell in Houston, Texas; a firm which specializes in DWI and criminal defense which just happens to own a 2015 Ford F-150 with a 12 inch lift and 36 inch tires. After he received permission from the partners at his firm (including Sean Evans, founder of the firm, who held the office of Marshal at P.A.D's Houston Chapter), Erik hopped in the truck.

"We were very lucky in my neighborhood with only a few houses flooded, however, almost every surrounding neighborhood flooded. Fortunately, our company truck was high enough to get in and out of the neighborhood. The water was higher than I'd ever seen it and I've lived in this house for almost 15 years," Erik said.

From August 27-30, Erik and his friend Tim Buchanan who also had a lifted truck, were on a mission to help rescue people in Houston and Port Arthur. Erik estimates that during that time they moved 1,000 people to safety.

"The scariest moment of the storm was when I drove through water that was much deeper than I was anticipating." He continued, "Everyone in the truck was telling me to stop but I knew if we stopped the truck was toast. We kept pushing through and made it across."

One particularly memorable moment for Erik happened in Port Arthur while rescuing an elderly man.

"The water came in so quickly that he didn't have time to get his medications. Despite there being reports of gunfire in the area, my friend Jeramey Bullock, flagged down a boat and went to retrieve the medicine for the man."

The people rescued were extremely grateful for Erik and his friends' help.

Erik remarked, "It was an amazing sight to see people from all walks of life coming together to help one another out. Being of service to others is in essence what we do as aspiring and current attorneys. Some people equate the word lawyer with greed and selfishness. I am fortunate to work for a firm where helping people is our number one priority."

One might think that after three days of being on rescue duty was service enough. Erik, his girlfriend Kimberlee, and his daughter Kaela then helped deliver hot meals to the hardworking first responders for two days.

Things are getting back to normal for Erik and his team. His last semester of law school began right after the waters receded.

"The criminal courthouse is completely closed, and the administrative hearing office is still closed as well. Despite the closures, we are managing the best we know how," Erik said.

Erik found that overall, "Hurricane Harvey was an experience I will never forget. I worked in television news for 10 years, before law school, covering Hurricanes Katrina, Rita, and Ike. I have never seen a community come together to help one another like the people did during Harvey. It was everyday people that were the real heroes of this disaster. I will be forever grateful that I was able to help."

He believes that "Phi Alpha Delta is a fraternal SERVICE organization. We aim to serve our communities and fellows. Being of service to others in an unselfish manner is the epitome of what P.A.D. members should strive to be. Without integrity and compassion for others, all we are is a group without direction."

Thank you Erik, Tim, Jeramey, Kimberlee, Kaela and Evans and Powell. You are an inspiration to us all.

New technologies give lawyers the opportunity to expand their client base, break down geographical barriers and compete with big law firms. Even for bootstrapping solo firms, technology provides affordable opportunities to reduce overhead costs and increase output.

Still, many lawyers are hesitant to integrate these innovations into their practices.

"Lawyers have a tendency to put their heads down and focus on the law and not think about business development and technology development impacts the way they practice," said Martin Pritikin, dean of Concord Law School of Kaplan University, the first online law school. "The technology used to drive down legal costs already exists, it's just a matter of using it."

There is a large, untapped market in need of legal representation, Pritikin explained, but these potential clients are priced out of the legal market. Instead of hiring a local lawyer, they turn to cheaper options online, like LegalZoom. It is not that these potential clients do not want to pay for legal services; it is just that they find traditional law offices to be too expensive and inefficient.

Big law firms that represent large, corporate clients and wealthy individuals do not have an incentive to accommodate the needs of modest means clients, he said. Their tech investments, which may include predictive coding and pricing analytics, are aimed at trimming costs for their corporate clients.

Small law firms, by contrast, have the greatest potential to expend their client base and reach the underserved legal market. Instead of competing for clients at the top of the legal market, law firms can expand their reach and serve traditionally underrepresented communities while increasing profits. And

they can do this by integrating innovative technologies into their practice.

"Why should smaller firms fight for a piece of the pie when they could be expanding the pie?" Pritikin asked.

Another issue that smaller law firms are encountering in the digital age is the demand for greater transparency, Pritikin said. With the use of a smartphone, people can check the balance of their bank accounts, look up the status of their flights and see where their Uber drivers are in real time. Clients have come to expect the same kind of transparency from their lawyers.

Fortunately, lawyers do not need to program a new app to deliver legal services, reach more clients and achieve greater transparency, Pritikin said. There are many simple, and affordable, solutions already on the market.

For example, video conferencing like Skype can be used Continued on next page.

to remove geographic barriers, cut down on transportation costs and save hours of billable time. This technology was once out of reach to many law firms, but has since become an affordable communication solution for both lawyers and their clients.

Video conferencing also facilitates the delivery of limited scope representation. Clients of modest means may be willing to shoulder some of the responsibilities of their legal representation, such as filing documents or representing themselves in court proceedings, but need help completing the forms and learning procedural rules. In these situations, lawyers can unbundle their legal services to provide inexpensive representation to their clients.

As for increased transparency, law firms can share client files in real time through secured cloud computing, send automated emails alerting clients of actions taken on their behalf and meet with clients via Skype without leaving the office.

"Lawyers are beginning to think about technology and how it intersects with their practice," he said. "They are using it in a way that is beneficial for them and their clients."

Virtual office or not, law firms are discovering innovative ways to leverage existing technology to deliver their services. In turn, underserved communities will have access to legal representation that they have been priced out of. And this isn't "bleeding-heart talk," Pritikin said. "It's good business."



Pro-Bono Experience at the Border

I volunteered for one week in Dilley, TX at the Family Detention Center for many reasons; to be a witness of how the families were treated, to give back to the immigrant community as they have supported my law practice, and to learn more about immigration practices.

What I Saw

When a nuclear family asks for asylum, the government separates them. The father is sent to a detention center, which also houses convicted criminals, and the mother and children are sent to a family detention center. Adults who come without children get the same treatment as the fathers: they are sent to prisons and have harsh living conditions.

I must admit that my expectations of the Family Detention Center were different from what I saw. I expected prison-like conditions but instead saw an orderly facility where mothers and children receive food, shelter, and proper medical attention. I asked how they were being treated, to which they replied with a graceful "very well." Sure, they don't have their freedom, but they like the food and accommodations. This is not a 5-star resort but, considering the standard of living which most of the detainees are used to, I dare say that their living conditions at the Family Detention Center are, in comparison, "very good."

While conditions at the center have improved thanks to advocacy groups, there is still room for improvement for pregnant women. Upon entering, there was a sign at the door warning pregnant women not to enter as there was a small pox outbreak; there were *nine* pregnant women detained in that center while I was there. The policy is to allow pregnant women to reach their final destination inside the United States instead of detaining them, but ICE is apparently not following this policy.

The stories of the atrocities these women and children have experienced are disturbing. In listening to their testimony, I was angry at the corrupt police officers who would victimize the very citizens they should be protecting.

Giving Back

I believe that we lawyers live privileged lives, and that we have the duty to volunteer our skills. It was amazing to listen to the stories of these courageous and resilient women and children. I am certain that these kids will do great things in this nation. At least one will be a doctor or engineer and will make the life of others better. True grit is a common denominator for successful people, something many of these kids showed.

After working in Dilley, I drove to McAllen, TX, where I trained six members of the Salvadoran Consulate staff on border needs and detainees. The consul in McAllen graciously gave me a tour of the border, where I touched the waters of the Rio Grande, visited a park in Mexico, and saw many border patrol officers.

What I Learned

I learned that humans are resilient and that in adversity people will show the best in them. I learned that immigrants asking for asylum do not need to cross the river, all they need to do is to walk through the bridge and ask officers for asylum where they will then be taken to the detention center for processing.

I learned that the living conditions at the family detention center are "very good." I believe that access to proper legal advice in the detention center will make a big difference to these asylum seekers. I imagine that many people don't ask for asylum so they do not receive any legal documents. In this center, at least the women and children receive proper legal advice and are encouraged meet the filing deadlines and continue fighting their case in immigration court.

I encourage P.A.D. members to go there and volunteer, especially those who can speak even just a little Spanish.

Thank you so much for your time and generosity. Is there anything else we should keep in mind?

JFW: "Absolutely. Making a bequest is the ultimate gift because there won't be any more after that. It is extremely rewarding to know that we can still benefit our sisters and brothers, who mean so much to us, after we are gone."

P.A.D. Adapts to Changing Legal Academia

In 2011, the American Bar Association (ABA) changed their post-grad survey to more accurately assess what law graduates were doing with their degrees. The survey confirmed what most law students and legal professionals already knew: there were too many graduates and not enough jobs. With this news, fewer undergraduates decided to seek J.D.s and law schools began reducing class size. In 2010, law schools across the United States had enrolled a record breaking 52,488 new law students. Since then enrollment has dropped by almost 30% across the board.

With these sudden shifts in law school interest, the climate of the legal academia has changed. Pre-law students are taking their graduate school decisions seriously, with more of a focus on exactly what their future will look like as a law school graduate.

Law students are looking for new ways to make themselves more competitive candidates in a tight job market.

Phi Alpha Delta has taken note of these shifts and reformatted programming and member benefits to adapt to the needs of P.A.D. members. The focus in the pre-law program continues to be making an informed decision-is law school the right path for you? For law students, the emphasis is on leadership development, creating opportunities to gain practical skills like task delegation, event planning and time management, and making the P.A.D. alumni network more accessible.

As law school enrollment dropped, some law schools decided to close their doors. P.A.D. has worked with a number of chapters that are dealing with unique situations, such as

this, that will affect the future of their legal education. When a law school closes, P.A.D. works with the students at the chapter to transfer their membership, connect them with other members and provide them with any member benefits that would assist in their specific situation. We closely monitor all news and reports regarding law schools so that we are able to predict which students will need our help and when we should take action.

Phi Alpha Delta's mission—to serve the student, the school, the profession and the community—continues to be the focus as the future of the profession evolves. This mission is shared by P.A.D.'s staff and the over 330,000 members across the globe, who are all dedicated to nurturing the success of P.A.D. students.

Partnerships: A Key to Law School Success

As someone currently applying for law school, I am doing everything in my power to ensure I get into the best one possible. As President of my

P.A.D. Pre-Law Chapter, I make sure our members have resources that increase their chances of also getting into their dream law schools. I have found forming partnerships with organizations that focus on aspects of the law school application process is a great way to achieve these goals.

An ideal partnership is an agreement between a chapter and a company where the chapter agrees

to promote the company's product to the members in exchange for the company's service at a discounted rate. Because Phi Alpha Delta



already has partnerships with certain companies on a national level, obtaining new partnerships for individual chapters can be as easy as calling or sending an email to an organization and asking for similar partnerships/discounts.

Effective partnerships maximize resources that increase a member's chances of getting into law school. I recently secured a partnership with BARBRI's Law Preview, a law school prep course that helps pre-law students prepare for their 1L year. Students who finish the 6 day course have a median 1L class rank in the top 16%, and 67% of students were offered a summer associate job or clerkship after 2L. This course normally costs close to \$1,400, but forming a partnership allowed us to cut the cost

down to \$795 with early enrollment (half the price of a standard LSAT course). And because my chapter receives discounts on LSAT courses, some as large as 50%, we receive two courses for the price of one!

Partnerships can also minimize the cost of law school significantly. Law school can easily cost \$200,000-\$350,000. Certain partnerships can help members find the best ways to reduce the cost of law school. LSAT prep courses can help students get high LSAT scores which can help students earn merit based scholarships. A two point score increase in some cases can be the difference between mere acceptance and a full tuition scholarship.

Law school admissions consulting agencies can help reduce the cost of law school by offering help with scholarship negotiation during the application cycle. Spending \$2,000 on services gained through partnership before applying to law school can save you hundreds of thousands of dollars in the future.

Obtaining partnerships is fairly simple; call or email a company you are interested in partnering with and explain that a lot of your members would

be willing to buy their service. Inform them that you would invite them to speak to your chapter about their services in return for discounts on those services for members.

Googling "LSAT prep companies," "law school prep companies," or "law school admissions" should give you a good starting point to find companies that can help your members achieve their goals. Some companies may want you to make an exclusive partnership with your chapter, but refrain from taking those offers. Exclusive partnerships limit your options and are prohibited by Phi Alpha Delta national policy.



What NOT To Say In Your Personal Statement

Tips From Stetson University College of Law's Admissions Office

You may have read my Top 8 Most Common Mistakes When Writing a

Personal Statement blog. These mistakes focused mostly on grammar issues, inattention to detail and the result of poor editing. Here are a few additional tips focused on what not to say in the statement itself.

I want to go to law school because I've been told I argue well. We prefer for you to more thoughtfully and artfully explain your passion for studying the law.

I want to "Be the change I wish to see in the world"—Mahatma Gandhi. We want all of our law students to change the world—or even their own small corner. However, we hear this a lot so think of an original way to describe your passion for being a change-maker.

The Quote: Be careful incorporating quotes into the statement. If you start off with a quote, incorporate a quote or end with a quote, make sure it fits (tie it to your theme), and is not just plopped into the statement for dramatic effect.

Be mindful of oversharing. We appreciate learning about your personal journey. Sometimes those journeys came with painful experiences or life lessons. They made you who you are today and we respect that. Just remember that we don't always need descriptive details to comprehend the adversity you overcame.

Don't pass the buck. If you choose to explain something negative in your personal statement rather than in an addendum (which we prefer), be careful about how you explain the situation. We prefer that you own up to your mistakes. Candor and acceptance of responsibility go a long way in our evaluation of candidates.

The personal essay is your chance to shine! Show us your excellent writing skills and your passion for law school and your ultimate career as an attorney. Attorneys need to write well. This is your chance to show us your talents.


