Cornell Internship

If you had asked me a year ago what I thought I would be doing for my sophomore summer, I would have responded something along the lines of, "making spreadsheets and getting my boss coffee." Nowadays, most internships that are targeted at undergrads anticipate their extraordinarily talented applicants to alternate between "delivery service" and "file cabinet organizer." While they build work ethic and offer experience, these types of experiences can be so disenchanting to young people that they deter us from pursuing careers that we're passionate about. I was incredibly lucky to endure none of that this past summer, interning for a judge in the Civil Division of the **Hudson County Superior Court in** New Jersey.

My days at the William J. Brennan Courthouse were equal parts exhilarating and intimidating. While attorneys delivered their motions, I would sit in the empty jury box, taking notes and avoiding eye contact with the litigants. The judge, a formidable historian with deep roots in the North Jersey populace, conducted his courtroom with zero tolerance for rule-breaking. He relished in interrupting the seasoned, "too cool for school" attorneys who would deliver their opening arguments while remaining seated, and once gave me a very public admonition for attempting to follow him through the door marked "Judge" where I should have gone through the

one marked "Chambers" (please note: they both led to the exact same room). When I wasn't in the courtroom or reading in the judge's library, I shadowed the law clerk, a recent Seton Hall Law graduate who walked me through life as a law school student and taught me the ins and outs of the courthouse. He had a particular knack for figuring out when I didn't know what I was doing, shielding me from the wrath of the judge when I misplaced a document or "answered the phone wrong."

I should preface the rest of my tale with a warning: if you are unfamiliar with the inner workings of a judge's chambers (or are set to appear before one in a case), you may find yourself uneasy after reading this.

The work of chambers staff is incredibly demanding; during our "slow" summer season, we were constantly receiving poorly written motions, caucusing with stubborn litigants, and returning calls to snarky attorneys who couldn't bother to respect public employees. At times, it seemed as though plaintiffs used the courtroom as a means to pursue childish vendettas, seeking damages for claims that were legally valid but wasted the time of the judge and his staff. We heard heartbreaking stories of the exploitation of minorities in the workplace, but those trials would often be followed by ones in which the principal actors could not accept any culpability or responsibility for their actions ("Sir, you put your car in neutral while you were going up a hill, it IS your fault that the car behind you took out your rear headlights.") From those interactions, I learned the significance of the courtroom as an institution, a place in which two parties, no matter how influential or powerful, must sit before a higher authority and make a succinct case for the actions they take.

I was so fortunate to have had the experiences I had, during what could have been a terribly tedious summer.

And I only got them coffee once.

Building an Effective Law Practice That Scales in the Digital Age

Starting and running your own law practice is one of the most daunting challenges an attorney can face. Most of us do it because we have a desire to assert greater control over our quality of life. In hanging your shingle, there are some major pitfalls to be wary of. This Practically Practicing article series will provide tips, tricks, and lessons learned by me, an attorney who chose to be my own boss and managed to make my career a success after numerous failures. In line with Phi Alpha Delta's emphasis on members putting P.A.D.'s Core Values into our daily practice, I will also do the same herein. Enjoy!

No matter where you stand on the political spectrum, all it takes is 5 minutes of reading the news to be alarmed by conflict ensuing both nationally and abroad. One may find it easy to give into the constant left-right battle and alienate colleagues, friends, and loved ones. Those taking a firm stance for their respective political parties, may lead to greater fallout as this same scenario plays out the United States.

In Phi Alpha Delta, we take stances which align with our values: lead with integrity, compassion, and courage through service to the student, the school, the profession, and the community. We are committed to advancing the ideals of liberty and equal justice under the law. We are a fraternity of brothers and sisters that support one another, regardless of political leanings.

As members of P.A.D. and the legal profession, we must be aware of our own values and those with whom we interact with. Being aware of others' values can help us communicate empathetically and build stronger professional relationships. Doing so in the face of everything happening today calls for us to find within each of us our own version of one of P.A.D.'s important core values: courage.

To have courage, in part, is to have the strength dealing with pain or grief. While I try to avoid discussing my personal life and leanings in the context of fraternal discussions, I believe my own lived experiences, as both a

transgender woman and attorney, speak directly to the topic at hand. Getting to where I am in life now has not been easy. In fact, it has been a journey fraught with anger, pain, suffering, and despair. I have been assaulted and have had my life threatened in the streets for being trans. I lost my marriage, most of my friends, and even some family because I am transgender. I've been directly attacked for being trans in the context of litigation while simply trying to advocate on behalf of my clients. When I read the news, the thought of "am I next?" regularly comes to mind.

Still, I must continue to show up and advocate for those who have yet to find their own voice. Because, as my staunchly conservative father puts it, "You are a human being, and nobody deserves to be treated this way." When this journey began, my family was dead-set against me being trans. During the worst of times, it took my everything to refrain from lashing out and instead choosing to help my father (and many others in my

life) reach a place where they realized his views towards trans people need to be re-examined. It was a fight that was well-worth it. Instead of being alone in the world, I now have a circle of loved ones that embrace me for being my authentic self. I now have my father rooting for his daughter to succeed. Being aware of my father's values enabled me to advocate for myself from a place of empathy and compassion to bridge the divide.

In your practice as an attorney you may have to fight for someone that is unjustly attacked. We are in a unique position where we can either escalate or de-escalate to significant degrees on a legal level. It takes guts to enter into this kind of life and fight for a cause; but it takes real courage to venture forth into hostile territory and listen to what your opposition thinks about your stance and lead with empathy for their position while remaining steadfast in your convictions.

I've won my fair share of court battles, but what I consider to be my greatest victories are the battles that were avoided when I and/or my opposing counsel were able to stop fighting for 5 seconds so we could walk the parties to a place of understanding and compromise. Doing so can save those you serve from hardship. It can avoid putting strain and poisonous sentiment into society. It can lead to new relationships and understanding with those you once believed were your worst enemies.

This is my challenge to you: find the courage to lead with empathy. Step into the best version of yourself instead of falling back into that place of endless conflict. Remember your commitments as brothers and sisters of Phi Alpha Delta, and choose to be an example that others will be inspired to follow.



It also educates readers on branding strategies that will set them apart from the competition, no matter their background.


