### Phi Alpha Delta Day at the Supreme Court of the United States

*Officially, the first “P.A.D. Day at the Supreme Court” was held on May 22, 1967, when the national chapter began to sponsor the event. The Chicago Alumni Chapter, however, had conducted its own day at the Supreme Court at least as early as 1964 and again in 1966. The Chicago Alumni’s P.A.D. Day at the Supreme Court is included here as well as the nationally/internationally sponsored events.*

## William B. "Robbie" Robertson (1916-2009)



*Brother Robertson*

Justice, District XII Justice which then included Delaware, the District of Columbia, Maryland, and Virginia (1953-1956), and Tribune (1960-1962). In 1954, he was Chair of the convention awards committee which developed the Outstanding Chapter Competition, now known as the Stanley H. Kohn Outstanding Law School Chapter Competition.

Brother Robertson proposed amending P.A.D.'s constitution to admit women at his first P.A.D. convention, the 1948 Convention – some twenty-two years ahead of his time. When the amendment removing gender restrictions on membership finally passed at the 1970 Convention, Brother Robertson was there and led the cheering. At the conclusion of that convention, Brother Robertson was inducted as the seventh member of the Distinguished Service Chapter.

The member most credited with organizing the event on a national level and firmly establishing it as a fraternity tradition was Brother William B. Robertson (Taft, D.C. Alumni, and Distinguished Service Chapters). He was himself admitted to practice before the Supreme Court during the Second Annual P.A.D. Day and chaired the event for fourteen years, from 1970-1983. Under his leadership, the event became one of the most popular events that the Fraternity sponsors.

Brother Robertson was initiated by Taft Chapter on March 13, 1948, and graduated from Georgetown Law in 1951. Robertson served the fraternity in many capacities including Convention Delegate, Taft Chapter Justice, Washington, DC Alumni Chapter

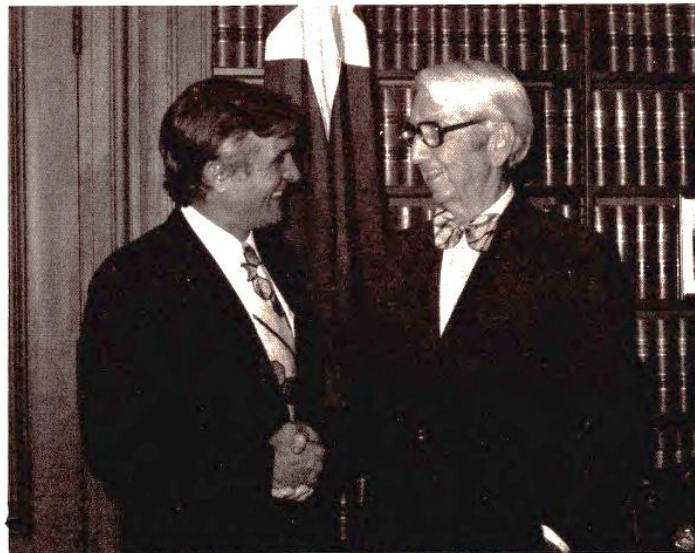

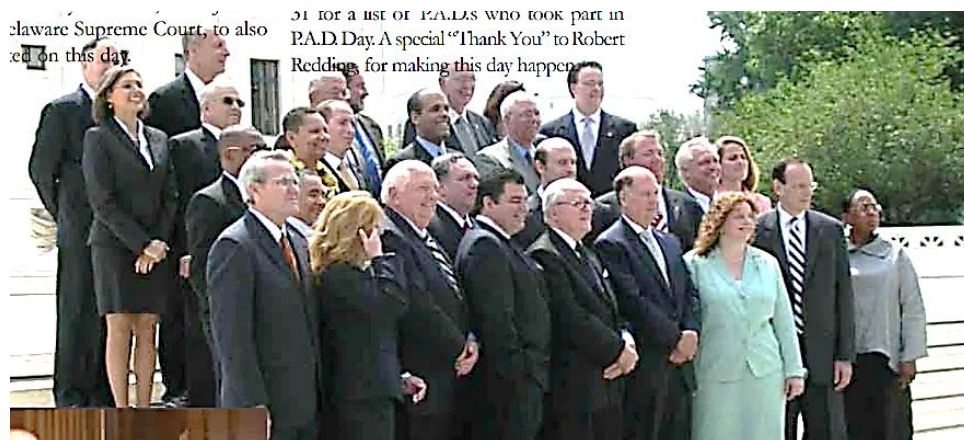

## About the Movants

### Curtis M. Anderson (2003-2004)



Curtis M. Anderson was born in 1958 in Albuquerque, New Mexico. In 1975, he graduated from Robert E. Lee Senior High School in Houston, Texas. In 1979, he graduated from the University of Pennsylvania Wharton School of Finance and Commerce with a Bachelor of Science in Accounting and a Bachelor of Arts in Economics. In 1982, he earned his Juris Doctor from the University of Southern California. He is admitted to practice in the states of California and Oklahoma.

While at the University of Southern California, he was initiated by Ross Chapter of Phi Alpha Delta on October 25, 1979. He served Ross Chapter as its Vice Justice of Professional Programs and then as chapter treasurer. (After graduation he served the chapter as Alumni Advisor.) He was the Ross Chapter delegate to the 1980 convention in Hot Springs – his first of many conventions. He has attended every convention from 1982 through 2024. He has been an active member of the Los Angeles Alumni Chapter

and is currently an active member of the Robert E. Redding National Capital Area Alumni Chapter. Brother Anderson is the thirty-third member of the Phi Alpha Delta Founders' Circle, recognizing his commitment to providing financial support to the P.A.D. International Foundation.

Brother Anderson was appointed District VII Justice in 1985 and became District VIII Justice in 1987 after a redistricting. He received the Outstanding District Justice Award in 1986 and 1988. In 1988, he was elected Associate Tribune, and in 1990 he was elected to the International Executive Board as International Proctor. He continued to serve on the I.E.B. in various capacities for 12 years, culminating in a term as International Justice from 2002-2004. As International Justice, he spearheaded an effort to create the fraternity's first formal strategic plan and make strategic planning part of the I.E.B.'s ongoing activities. On August 1, 2024, Brother Anderson was inducted into the fraternity's Distinguished Service Chapter which is considered one of the highest honors than can be bestowed upon a member.

Brother Anderson started his professional career as an Associate attorney at Huffman, Arrington, Kihle, Gaberino, & Dunn in Tulsa, Oklahoma where he worked from 1984-1988. In 1988, he joined the U.S. Department of the Interior as an attorney and legal advisor. From 1990-1994, he served as Secretary to the Board of the Farm Credit Administration and served as Secretary to the Board of the Farm Credit System Insurance Corporation from 1991-1994. From 1995-2002, Brother Anderson served as Chief Financial Officer and General Counsel to the National Association of State Departments of Agriculture. From 2002-2009, he served as Deputy Administrator of the U.S. Department of Agriculture Rural Utilities Service. In 2009, he became Vice President and General Counsel of MELE Associates, Inc., a position he held for nearly five years. In 2013, he started Curtis M. Anderson Consulting and served as its President until 2017, at which time he became the Chief of Staff for the U.S. Department of Agriculture Rural Housing Service. In 2019, he became Chief of Staff for the U.S. Department of Agriculture Rural Utilities Service. Since 2021 he has restarted Curtis M. Anderson Consulting and has served as an independent strategic advisor and business consultant on a contract basis, along with consulting he has served as Chief Financial Officer for the National Industrial Hemp Council of America since 2022.

#### Noel J. Augustyn (1993 and 1994)



Noel James Augustyn (Redding NCAA) was born December 25, 1976. He attended Dartmouth College (BA, 1968), Stanford University (MA, 1969), and the University of Notre Dame (1974). He was admitted



to the bars of Massachusetts, the United States Court of Appeals for the First Circuit, the District of Columbia, and the United States Supreme Court. He was initiated as an honorary member of the Robert E. Redding National Capital Area Alumni Chapter of Phi Alpha Delta during a P.A.D. Day at the Supreme Court on June 6, 1994, while working as administrative assistant to Chief Justice Rehnquist.

He worked as Assistant dean, instructor, Ripon (Wisconsin) College, 1969-1970; assistant dean, instructor, Linfield College, McMinnville, Oregon, 1970-1971; associate, Vom Baur, Coburn, Simmons & Turtle, Boston, 1974-1979; associate, Burt & Taylor, Marblehead, Massachusetts, 1979-1980; assistant professor, assistant dean Law School, Boston College, Newton, Massachusetts, 1980-1983; associate director, Association American Law Schools, Washington, 1983-1987; administrative assistant to Chief Justice William Rehnquist, Supreme Court of the United States Court, Washington, 1987-1989; of counsel, Seyfarth, Shaw, Fairweather & Geraldson, Washington, 1989-1991; assistant director, Administrative Office of the United States Court Justices, Washington. Adjunct Professor Georgetown University Law Center, Washington, 1985-1987. Trustee Aquinas at Dartmouth, Inc., Hanover, N.H.

Thomas H. Bentz, Jr. (2011-2012, 2015-2019)



Thomas H. Bentz, Jr. was born in 1973. He received his Bachelor of Arts (Political Science and Communications) from the University of Michigan in 1995 and his Juris Doctor from Loyola University of Chicago in 1998.

During his time at the University of Michigan, Brother Bentz was a member of the University of Michigan – Ann Arbor Prelaw Chapter. While attending law school at Loyola, Brother Bentz was initiated by the Daniel Webster Chapter of Phi Alpha Delta on September 29, 1995. He served two terms as Webster Chapter Justice (1996-1997 and 1997-1998). In 2001, he was appointed District XXIII Justice and served in that position until 2006. During his time as District Justice, Brother Bentz was twice selected as the Stan Jones Outstanding District Justice and District XXIII was selected Outstanding District three times. In 2006, Brother Bentz was elected to the International Executive Board and served three terms as a Board Member-at-Large until 2012. In 2008, Bentz was admitted to the practice before the U.S. Supreme Court as a participant in P.A.D. Day at the Supreme Court. He has acted as movant for P.A.D. Day at the Supreme Court seven times (2011, 2012, 20015-2019). In 2012, Bentz was appointed to the Board of Trustees of the Phi Alpha Delta International Foundation and has served as a member and as Chair from 2012 until the present. During the overhaul of the Fraternity's governing docs in 2014-2016, Brother

Bentz obtained the pro bono services of his firm Holland and Knight to assist in review of the fraternity's revised Articles of Incorporation, Corporate By-Laws, and Fraternity Policy Manual. He also assists the fraternity in reviewing and obtaining appropriate insurance coverage – his area of expertise. During the 2024 Biennial Convention, Brother Bentz received the fraternity's Meritorious Service Award. He is the first member of the Phi Alpha Delta Founders' Circle, recognizing his commitment to providing financial support to the P.A.D. International Foundation.

Professionally, Brother Bentz is a partner with Holland & Knight and practices insurance law with a focus on D&O, cyber and other management liability insurance policies. He leads Holland & Knight's D&O and Management Liability Insurance Team which provides insight and guidance on ways to improve policy language and helps insureds maximize their possible insurance recovery. He also co-chairs the firm's Insurance Industry Team.

### Jhanalyn Blount (2024)



Sister Jhanalyn Blount received her Bachelor of Science in Marketing from Wingate University in 2007 where she began her journey with P.A.D. as a pre-law member. While at Wingate, she served as president of the pre-law chapter. In 2009, she completed her Bachelor of Arts in International and Global Affairs and Development at the University of North Carolina at Greensboro. She attended law school at the University of Arkansas at Little Rock Bowen School of Law where she was initiated as a law student member of Robinson Chapter on September 16, 2011. There she continued her involvement in P.A.D., serving as the 1L representative, Vice Justice during her 2L year, and as Justice during her 3L year. While at Bowen, she implemented P.A.D.'s tailgate signature event and helped create a Zero K fundraiser. She received her Juris Doctor in 2014 but continued her studies at the University of Arkansas at Little Rock earning her Master of Business Administration in 2016.

Sister Blount served as Assistant District VIII Justice from 2017 to 2020. She was admitted to practice before the United States Supreme Court as part of P.A.D. Day on June 3, 2019. On December 16, 2020, Sister Blount was appointed an International Executive Board Member-at-Large to fill a vacancy left due to a board member's resignation. She was reelected to the International Executive Board in 2022, and in 2024 she was elected International Marshal. She has served as the IEB Liaison to both the Diversity, Equity, and Inclusion Advisory Council and the Phi Alpha Delta History Committee. In 2024, Sister Blount was the first black woman to serve as movant at P.A.D. Day at the Supreme Court. She is the sixth member of the Phi Alpha Delta Founders' Circle, recognizing her commitment to providing financial support to the P.A.D. International Foundation.

While in law school, Sister Blount worked as a law clerk for the Equal Employment Opportunity Commission and a general practice law firm. From 2016-2019, she served as Legal Counsel for PerfectVision Manufacturing in Little Rock, AR. From 2020 – 2023 she served as Corporate Counsel for Kinesso in its Conway, AR office. As of 2025, Sister Blount serves as Principal Attorney for NextEra Energy in their Houston, TX office. Despite her busy work schedule, she finds time to give back to the legal community and community at large. She is a member of the Junior League of Houston, Houston Lawyers Association, Urban League Young Professionals of Houston, and Alpha Kappa Alpha Sorority, Incorporated.

#### Hon. Tom C. Clark (1970-1973 and 1976)



Hon. Tom C. Clark was born in 1899. He received his Bachelor of Laws degree from the University of Texas School of Law. During World War I, he attempted to volunteer for service in the U.S. Army but was rejected for being underweight. Undeterred, he served as an infantryman in the Texas National Guard, where he attained the rank of Sergeant.

Following his military service, Brother Clark began his legal career in Dallas, Texas. Aside from a brief term as a district attorney, he practiced law privately from 1922 until 1937. In 1937, he entered public service as a special assistant to the U.S. Attorney General. During World War II, from 1943 to 1945, he served as Assistant Attorney General for the Criminal Division. In 1945, he was appointed United States Attorney General by President Harry S. Truman, a role he held until 1949, when he was nominated and confirmed as an Associate Justice of the United States Supreme Court. He served on the Court until 1967.

While serving as Attorney General, Brother Clark was initiated as an honorary member of the Taney Chapter of Phi Alpha Delta on November 3, 1945. A dedicated and involved member of the fraternity, he frequently addressed student and alumni chapter events and national conventions. He was instrumental in helping to organize the earliest P.A.D. Day events at the U.S. Supreme Court and served as Supreme Vice Justice of the fraternity from 1964 to 1968.

In 1947, the Tom C. Clark Chapter of Phi Alpha Delta was founded in his honor at the University of Texas at Austin on August 8. In 1966, during his tenure on the International Executive Board, Brother Clark proposed the establishment of the Distinguished Service Chapter. He was the sixth member ever



inducted into that prestigious group in 1969. He has acted as movant for P.A.D. Day at the Supreme Court five times (1970 -1973, 1976)

Professionally, Brother Clark is remembered as a prominent American jurist who played a vital role in the mid-20th century U.S. legal landscape. His legacy includes significant contributions to both the Department of Justice and the U.S. Supreme Court, as well as his lifelong commitment to the principles and mission of Phi Alpha Delta Law Fraternity.

### Anthony A. DiGrazia (1964 and 1966)



Past Supreme Justice Anthony A. DiGrazia (Story and Chicago Alumni Chapters) served as movant for two Chicago Alumni Chapter P.A.D. Days at the Supreme Court (1964 and 1966). Tony was himself admitted to practice before the Supreme Court on October 20, 1949.

Born in Chicago on January 7, 1912, Anthony A. DiGrazia was one of eight children born to Italian immigrants who arrived in Chicago from Nicosia, Italy in 1910. By the time he had finished one year of high school, Tony was forced to start working to help support his family. He worked during the day and attended school at night to finish his high school education and eventually to receive his Bachelor of Laws from DePaul University. While at DePaul, Brother DiGrazia was initiated into the Joseph Story Chapter of Phi Alpha Delta Law on March 6, 1937, and quickly became a leader at the chapter and district level. From 1937-1938, he was entrusted with management of the Chicago Alumni Chapter Fraternity House, a brownstone on Dearborn St. rented by the Chicago Alumni for use by their fraternity brothers. In 1938, he attended his first national convention in Kansas City. From 1938-1939, he served as Story Chapter Justice. Brother DiGrazia continued to be active in Phi Alpha Delta throughout his life. He served in various offices for the Chicago Alumni Chapter, including Chapter Justice. He also served as District VI Justice. At that time, District VI included Illinois, Michigan, and Indiana. He led the convention host committee for the Golden Anniversary Convention in Chicago in 1952 and was elected to the Supreme Executive Board that year. He served for 10 years on the board, culminating with two years as Supreme Justice from 1960-1962. He remained active in Phi Alpha Delta until his death in 2000 and is honored by the West Suburban Alumni Chapter annually through presentation of the Anthony A. DiGrazia Scholarships.

### Hon. Arthur J. Goldberg (1986)



Brother Arthur J. Goldberg (Brandeis Chapter) served as movant at one P.A.D. Day at the Supreme Court (1986).

Brother Goldberg enjoyed an extraordinary legal career with an incredibly impact on the United States and arguably the world. He was a prominent litigator focusing on labor law during the Great Depression. He served as general counsel of the Congress of Industrial Organizations (CIO), negotiated the merger of the CIO and American Federation of Labor, and also served as general counsel of the United Steelworkers of America. Goldberg later served as United States Secretary of Labor (1961-1962), Associate Justice of the United States Supreme Court (1962-1965) and United State Ambassador the United Nations (1965-1968).

As a Supreme Court Justice, one of his most historic opinions was in the concurrence of *Griswold v. Connecticut* (1965) in which he argued that the Ninth Amendment supported the existence of an unenumerated right of privacy. In an internal court memorandum, in 1963, Goldberg argued that the imposition of the death penalty had been condemned by the international community and should be considered a “cruel and unusual punishment” by the United States. His dissent in *Rudolph v. Alabama* led to numerous challenges to the constitutionality of the death penalty and the capriciousness of its imposition. The effect of these challenges is still felt today. He also wrote the majority opinion in *Escobedo v. Illinois* which guaranteed criminal defendants the right to counsel during interrogation.

Rhonda K. Hill (2010)



Brother Rhonda K. Hill was born on October 16, 1955. She earned her Juris Doctor and was admitted to the bar in Iowa in 1982, Arkansas in 1986, and Colorado in 1988. She was initiated into the Cole Chapter of Phi Alpha Delta and began her lifelong commitment to the fraternity that same year. Brother Hill first attended a Phi Alpha Delta Convention in 1982 and has since attended an impressive twenty conventions, demonstrating her enduring dedication to the fraternity.

Brother Hill's service to Phi Alpha Delta spans over four decades and includes an extensive list of leadership roles. She served as District V Justice from 1982 to 1983, and later as District IV Justice from 1990 to 1995. From 2004, to 2006, she held the role of Chief of Staff, followed by her election to the International Executive Board as a Board Member-at-Large, serving from 2006, to 2008. In 2008, she was elected International Justice, and served two full terms from 2008 to 2012.

Following her term as International Justice, Brother Hill continued her service as Chair of the International Advisory Board from 2012 to 2014 and has remained an active member of the Advisory Board since that time. In addition, she served as Chair and Trustee of the Phi Alpha Delta Endowment Fund from 2012 to 2014, during which the Endowment Fund transitioned to become the Phi Alpha Delta International Foundation. She then served as Chair and Trustee of the Foundation from 2014 to 2016, and later as a member of the Foundation's Advisory Board from 2016 to 2018.

In recognition of her extraordinary service and dedication, Brother Hill was inducted into the Distinguished Service Chapter in 2008, one of the highest honors conferred by P.A.D.

Professionally, Brother Hill is a respected member of the legal community, with bar memberships in three states and a long-standing record of service and leadership. Her contributions to Phi Alpha Delta have left a lasting impact and reflect the highest ideals of the fraternity.



## W. James Jonas III (2006)



Lieutenant Colonel William James Jonas III (U.S. Army, Retired) received his Bachelor of Laws degree from the University of Texas School of Law, where he served as Editor of the *Texas Law Forum* and as a National Associate Editor for the Symposium Edition of the *Harvard Journal of Law and Public Policy*.

Prior to law school, Brother Jonas graduated *magna cum laude* with honors in Politics from Washington and Lee University. Upon graduation, he was commissioned as a Second Lieutenant in the U.S. Army Field Artillery by Lieutenant General George S. Patton III. His military career culminated in retirement with the rank of Lieutenant Colonel.

Just four years after graduating from law school, Brother Jonas became a partner in a national law firm and went on to establish a thriving legal career with offices in San Antonio, Austin, and Washington, D.C. Over the course of three decades, he specialized in government affairs, representing a diverse portfolio of clients that included one of the world's largest private prison companies, multiple municipalities, and numerous entities connected with the prison construction boom that swept the United States beginning in the late 1980s.

In addition to his legal practice, Brother Jonas served in key municipal roles, including City Manager and City Attorney. In those positions, he exercised significant authority over public safety operations—hiring and firing police chiefs and coordinating inter-local law enforcement efforts. His expertise and leadership extended into the political arena, where he was active in local, state, and national political campaigns from 1976 through 2016.

Brother Jonas was honored to serve as District IX Justice and won the 1989-1990 Stan Jones award for the Most Outstanding District Justice. Brother Jonas on the International Executive Board from 1992 - 1994. His service to the fraternity reflects a deep commitment to its ideals and mission, as well as to the professional and ethical development of future generations of lawyers.

## Daniel R. Levinson (1995)



Brother Daniel R. Levinson was born on March 24, 1949, in New York City. He earned his Bachelor of Arts degree from the University of Southern California, where he was a member of the Tau Kappa Epsilon fraternity. He then obtained his Juris Doctor from the Georgetown University Law Center and a Master of Laws from George Washington University Law School.

Brother Levinson began his legal career in public service, serving as General Counsel for the U.S. Consumer Product Safety Commission. He then served a seven-year term as Chairman of the U.S. Merit Systems Protection Board, overseeing the integrity of the federal civilian personnel system.

On June 5, 1995 the members were admitted to the Bar of the nation's highest court on the Motion of Brother Daniel R. Levinson, Chief of Staff to Congressman Bob Barr—a longtime PAD member from Georgia.

In 2001, he was appointed Inspector General of the U.S. General Services Administration by President George W. Bush, a role he held until 2005. Later that year, he was appointed Inspector General of the U.S. Department of Health and Human Services, a position he held until his retirement in 2019.

During his tenure at HHS, Brother Levinson led an independent organization of over 1,600 auditors, evaluators, investigators, and lawyers, overseeing the integrity and efficiency of the nation's \$1 trillion annual investment in federal health and human services programs. He participated in several interagency oversight entities and public-private partnerships, including serving on the Executive Council of the Council of Inspectors General on Integrity and Efficiency.

Brother Levinson's commitment to public service and integrity in government operations has left a lasting impact on federal oversight and accountability.

Alice Louise O'Donnell (1974-1975, 1977-1985, 1987-1993)



*"Alice O'Donnell, who he [Justice Tom C. Clark] graciously called 'Miss Alice,' was a perennially youthful fount of efficient cheer for judges, lawyers, law clerks, and wayfaring strangers."*

Sister Alice Louise O'Donnell (Zeta (PDD)/Jay and Washington Alumnae (PDD)/National Capital Area Alumni Chapters) was the first woman to serve as a P.A.D. movant and served as movant at seventeen P.A.D. Days at the Supreme Court (1974-1975, 1977-1985, and 1987-1992), more than any other single person in fraternity history.

Sister O'Donnell was a native of Stanwood, Washington. She attended the University of Washington in Seattle and the University of Southern California. She served on the staff of the Attorney General of the United States Tom C. Clark and then as legal secretary/personal assistant for Associate United States Supreme Court Justice Tom C. Clark from 1949-1967. She attended law school at night while working for Brother Clark and earned her law degree. While attending law school, Sister O'Donnell was initiated as a member of Zeta Chapter of Phi Delta Delta on February 28, 1954, and she became a member of Phi Alpha Delta when the two fraternities merged in 1972. She served as the first woman Director of Interjudicial Affairs at the Federal Judicial Center before retiring. She also served as a Division Delegate to the A.B.A.'s House of Delegates and was formerly a Chairperson of the American Bar Association's Division of Judicial Administration.

Lindsey Marie Rames (2023)





Sister Lindsey M. Rames was born in 1983. She earned her Bachelor of Arts degree from the University of Texas at Dallas in 2005, graduating cum laude. She then obtained her Juris Doctor from Oklahoma City University School of Law in 2008, where she was a Hatton Sumners Scholar.

Prior to her legal career, Sister Rames worked in the insurance industry. She served as the subrogation administrator for a national insurance company based in Dallas, Texas. She later worked as an in-house attorney and adjuster for an independent insurance adjusting firm headquartered in the suburbs of Philadelphia, Pennsylvania.

In 2010, she founded Rames Law Firm, P.C. in Dallas, Texas. Her practice focuses on civil litigation and appeals, representing individuals, businesses, and insurance companies throughout Texas and nationwide. She has handled cases in both state and federal courts, including the Texas Supreme Court and the Fifth Circuit Court of Appeals.

Sister Rames has been recognized as a Texas Super Lawyer Rising Star from 2016 to 2021, an honor received by only 2.5% of Texas attorneys under the age of 40. She was also named to America's Top 100 Personal Injury Attorneys for North Texas.

Active in the legal community, Sister Rames served as a Director for the Dallas Bar Association. She is a former chair of the Dallas Bar Association Judiciary Committee and the Legal Ethics Committee. She is also a member of the State Bar of Texas Center for Professional Responsibility.

In addition to her legal practice, Sister Rames is deeply involved in Phi Alpha Delta Law Fraternity. She joined as a pre-law member at the University of Texas at Dallas which she was part of reactivating that chapter, where she served as Treasurer. She later attended law school at Oklahoma City University School of Law, where she joined the Vaught Chapter and served as Vice Justice. After law school, she moved to Philadelphia and helped reactivate the Elden S. Magaw Alumni Chapter. Since returning to Dallas, she has served two terms as District Justice of District XXXI and is currently serving as an International Board Member-at-Large. She is the sixteenth member of the Phi Alpha Delta Founders' Circle, recognizing her commitment to providing financial support to the P.A.D. International Foundation.

Outside of her professional endeavors, Sister Rames enjoys traveling, working on her pilot's license, and flipping houses.

Robert E. Redding (1967-1969, 1997-2000, 2002, 2007-2009)



Past Supreme Justice Robert E. Redding (Taft, National Capital Area Alumni, and Distinguished Service Chapters) served as movant for eleven P.A.D. Days at the Supreme Court (1967-1969, 1997-2000, 2002, 2007-2009).

Brother Redding served District XII Justice and Justice of the Washington, DC Alumni Chapter (since renamed the Robert E. Redding National Capital Area Alumni Chapter in his honor). He was elected to the Supreme Tribunal as an Associate Tribune at the 1954 Convention and served in that capacity for two years. He was subsequently elected to the Supreme Executive Board and served as: Supreme Marshal (1956-1958), Supreme Treasurer (1958-1962), Supreme Second Vice Justice (1962-1966), and Supreme Justice (1966-1968). Brother Redding spent more than four decades working as the liaison between the United States Supreme Court and Phi Alpha Delta. Due to his efforts and those of other Washington, DC based fraternity members, P.A.D. Day at the Supreme Court was born and has continued since May 22, 1967.

His varied professional career has included government service with the Civil Aeronautics Board, the Tax Court of the United States, Judge of the Appeal Tax Court of Montgomery County, Maryland, Vice President, Secretary and General Counsel of the Transportation Association of America and consultant to the United Nations Development Programme and the Agency for International Development.

[Robert L. Schimmel \(2005\)](#)



Brother Robert L. Schimmel was born in 1954. He earned his Bachelor of Arts degree in Natural Science from Johns Hopkins University in 1976, where he was a member of the Varsity Golf team and achieved Dean's List honors. He then obtained his Master of Health Science in Biostatistics from the Johns Hopkins Bloomberg School of Public Health in 1977. In 1981, he earned his Juris Doctor from the University of Miami School of Law, where he served as Vice President of the Bar & Gavel Society and was a member of Phi Alpha Delta Law Fraternity, International.

After law school, Brother Schimmel began his legal career in Miami, Florida. He practiced law with several firms before founding Schimmel, P.A. in 2010. His practice focuses on real estate, business, and commercial transactions and litigation, including residential and commercial real estate development, conveyancing, financing, leasing, and title insurance.

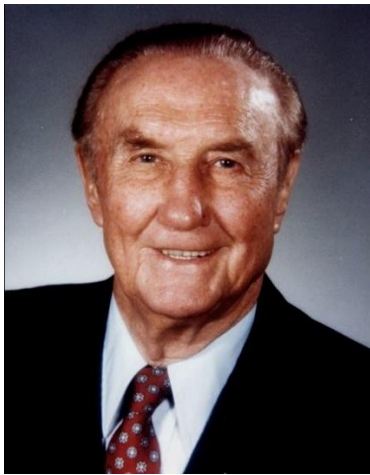
Brother Schimmel has been recognized as one of Florida's Legal Elite by Florida Trend Magazine from 2008 to 2018 and has been named one of South Florida's Top Rated Lawyers by ALM Legal Leaders. He holds an AV Preeminent peer review rating from Martindale-Hubbell.

Active in the legal community, Brother Schimmel served as Chief Tribune of Phi Alpha Delta Law Fraternity, International from 1996 to 2006, Associate Tribune from 1992 to 1996, and District XXVI (Florida) Justice from 1986 to 1992. He was also a member of the Bar and Gavel Society during his time in law school.

In 2005, Brother Schimmel served as the movant for P.A.D. Day at the U.S. Supreme Court, facilitating the admission of members to the Bar of the nation's highest court.

Outside of his professional endeavors, Brother Schimmel enjoys golf and is committed to community service.

### Senator J. Strom Thurmond (1996)



Senator James Strom Thurmond of South Carolina was a trailblazing American statesman, jurist, and military officer. A graduate of Clemson College, he studied law and was admitted to the South Carolina Bar in 1930. Throughout a distinguished legal and political career spanning more than seven decades, Brother Thurmond left an indelible mark on American legal and legislative history.

Brother Thurmond served in the U.S. Army during World War II, earning the rank of Major and later retiring from the Army Reserve as a Major General. In 1954, he made history by becoming the first person elected to the U.S. Senate as a write-in candidate. He went on to serve in the U.S. Senate for 48 years, making him the longest-serving Senator and the oldest member of Congress in U.S. history. He held several prominent leadership roles, including Chairman of the Senate Judiciary Committee and President Pro Tempore of the Senate.

A dedicated and longtime member of Phi Alpha Delta Law Fraternity, Brother Thurmond was initiated through the Pinckney Chapter. He maintained an active role in the fraternity throughout his career, frequently supporting its mission and values. Notably, he personally moved the admission of P.A.D. members before the United States Supreme Court, including during the 30th Annual P.A.D. Day ceremonies held on June 2, 1997. His involvement exemplified his enduring commitment to the legal profession and the fraternal bond of P.A.D.



In recognition of his service and leadership, Brother Thurmond received the International Justice's Award from Phi Alpha Delta in July 1984. Reflecting on the legal profession, he once remarked:

"As an attorney, former judge, and United States Senator, I understand well the contributions that you make as lawyers, and I commend each of you for your great commitment to protecting the rights of Americans as provided by our great Constitution."

Professionally, Brother Thurmond is remembered as a formidable figure in American government and law. His record of service includes decades of judicial and legislative influence, and lasting contributions to the Phi Alpha Delta Law Fraternity. While he was seen as this great politician he was also someone who led the fight against civil rights, was a segregationist, and believed "that there's not enough troops in the army to force the Southern people to break down segregation and admit the Nigra race into our theaters, into our swimming pools, into our homes, and into our churches".

Hon. Dietrich M. von Biedenfeld (2025)



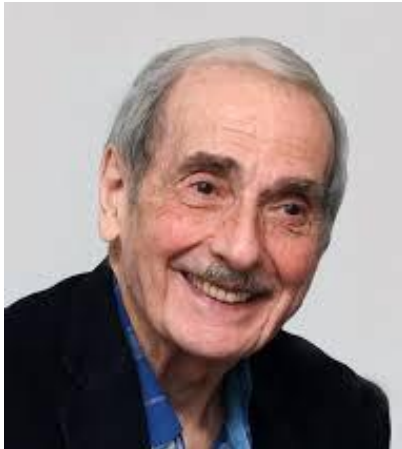
Brother Dietrich von Biedenfeld was born in 1981 in Kansas City, MO. Growing up in Houston, TX, he initially attended Second Baptist High School, then graduated from Willowridge High School in 2000. He earned his bachelor's degree in political science and sociology and a minor in history from the University of Houston in 2005. In 2009, he earned his JD from the University of Mississippi. He is admitted to practice in Texas, Mississippi, and the District of Columbia.

While at Ole Miss, Brother von Biedenfeld was initiated into Morse Chapter (then known as Lamarr Chapter) on November 7, 2007. He is a regular mock trial judge and has served six times overall. He was admitted to the U.S. Supreme Court Bar at PAD Day on June 1, 2015. Brother von Biedenfeld served as a GOLD program mentor in 2022, 2023, and 2024, and he represented District XVI on the 2024 Nominations Committee. In October 2025, he was appointed a Trustee of the Phi Alpha Delta International Foundation. Brother von Biedenfeld is the fifty-third member of the Phi Alpha Delta Founders' Circle, recognizing his commitment to providing financial support to the P.A.D. International Foundation.

As of 2025, Brother von Biedenfeld was serving an interim assignment as the Chief Procurement Officer of the Houston City College System, overseeing approximately half a billion dollars in spending and over one billion dollars of contracts. He is also an assistant professor at University of Houston-Downtown,

where he teaches business law, management, ethics, and supply chain management. Brother von Biedenfeld has served in contract administration for local school systems, starting as a contract administrator for the San Jacinto College District from 2011 until 2013 and then as a Contract Administration manager at the Houston Community College system from 2013 to 2016. He also worked with the Harris County Texas Education Department in its Cooperative Purchasing Unit. He pursued a public service career in his community, serving as a judge for the City of West Columbia, Texas after serving a decade on West Columbia's city council.

#### Lawrence G. Wallace (2001)



Lawrence G. Wallace was a legendary appellate advocate and longtime public servant in the U.S. Department of Justice. He earned his law degree from UCLA School of Law, where he served with distinction as Editor-in-Chief of the *UCLA Law Review*. Following graduation, he clerked for Associate Justice Hugo Black on the United States Supreme Court—a prestigious beginning to a career marked by extraordinary legal scholarship and advocacy.

Wallace joined the Office of the Solicitor General in 1968, where he went on to serve for over three decades under seven consecutive Solicitors General. From 1972 to 2002, he held the title of Deputy Solicitor General, one of the highest-ranking and most trusted positions in the Department of Justice. Over the course of his remarkable tenure, he argued 157 cases before the United States Supreme Court—more than any other government lawyer in the modern era and second only to the legendary Daniel Webster in U.S. history.

Renowned for his meticulous preparation, calm demeanor, and persuasive reasoning, Brother Wallace was frequently recognized as one of the finest oral advocates of his time. His influence on the development of American law was both profound and far-reaching, touching nearly every area of constitutional and administrative jurisprudence.

In 2002, he retired from the Office of the Solicitor General, leaving behind a legacy of unparalleled service and advocacy. Then-Solicitor General Theodore Olson noted upon his retirement that Wallace's career "stands as a model of professionalism, dedication, and integrity."

### Ronald J. Winter (2013-2014)



Brother Ronald J. Winter has been one of Phi Alpha Delta's most active and dedicated members for over forty-five years. He received his bachelor's degree from the State University of New York at Albany in 1976 and his juris doctor from the State University of New York at Buffalo in 1981. While attending law school, Brother Winter was instrumental in the reactivation of Carlos C. Alden Chapter and was initiated at its reactivation ceremony on April 12, 1978. He served as Marshal and twice as Justice of Alden Chapter. He was named the Alex A. Hotchkiss Outstanding Chapter Justice for 1981. He attended his first Biennial Convention as a student delegate in 1978 and has attended every convention since. Following his law school graduation and passing the New York bar exam in 1981, Brother Winter was appointed to the position of Executive Secretary at the P.A.D. National Office (a position similar to what would later be known as International Field Representative or Member Services Consultant). He also served as Director of the new Pre-Law Chapter program, what was then a new project designed to assist pre-law students. He is the fourteenth member of the Phi Alpha Delta Founders' Circle, recognizing his commitment to providing financial support to the P.A.D. International Foundation.

In 1983, Brother Winter left his positions at the Executive Office and was sworn in as an Assistant District Attorney for Niagara County, New York. He would serve as a prosecuting attorney for eighteen years, the last ten as Chief of Homicide. In 2001, he became a Confidential Law Clerk to a New York State Supreme Court Justice and continued in that role until May 2019. Brother Winter has since served in part-time capacities as an Assistant Conflicts Defender and as a contract attorney in the Kinship Unit of the Center for Elder Law and Justice CELJ). He has also served as an Adjunct Faculty of both Niagara University and University at Buffalo Law School where he began teaching Trial Technique in 2005. Brother Winter has been a guest lecturer for the Niagara County Law Enforcement Academy and the NYS Bar Association's Criminal Law section. He is admitted to practice law in NY state courts, the Western District of New York federal court, and the United States Supreme Court.

Notwithstanding his busy legal career, Brother Winter has maintained an extraordinarily high level of activity in Phi Alpha Delta throughout his life. In addition to his service in the Executive Office, he has served in multiple officer positions in both the Buffalo and Niagara Frontier Alumni Chapter (which he founded in 2003), District Justice (in two districts), Regional Coordinator, Statewide LRE Coordinator for New York, Associate and Chief Tribune (five total terms), Board Member-at-Large (two terms), International Secretary (three terms), International Advocate, International Vice Justice (two terms) and International Justice from 2012-2014. He also chaired the IAB for two years and served as IEB liaison to both the Pre-Law Advisory Council (PLAC) and the Alumni Advisory Council (AAC). He also serves as a



member and as clerk of the Phi Alpha Delta History Committee. Brother Winter has attended more than 25 Pre-Law Conferences, where he presided over the Mock Trial Tournament, and has visited all 33 districts in the Fraternity. In 2003, he received the Stan Jones Outstanding District Justice Award, and August 6, 2016, Brother Winter received the Fraternity's highest honor when he became just the 25<sup>th</sup> member ever elected to the Distinguished Service Chapter (DSC).

He has also served his community and profession in a variety of ways including serving as Chairperson of the Board of Trustees of Niagara County Community College (NCCC) and serving on its Alumni Committee, he was President of the Niagara County Legal Aid Society, and he is a past President of The Bar Association of the Tonawandas. He served several years as a Director of the Niagara County Bar Association Board, including 2 years as Secretary.

Brother Winter is married to Joan, a retired middle school English teacher who was the first recipient of the Cynthia "CC" Cooper award for service to P.A.D. by a non-member. They have two daughters, Rachel and Lydia. Rachel is an alumni member of the SUNY Geneseo Pre-Law Chapter.
