# **Appendix XIII:**

## **Active Chapters of Phi Delta Delta -**

### **Charter Information**

Phi Delta Delta chapters at the law schools and college/university law departments were called active chapters, and both students and alumnae were permitted to actively participate in the chapters. Chapters were named in alphabetical order according to the Greek Alphabet (Alpha, Beta, Gamma, etc.). When the end of the alphabet was reached, chapters were still named in alphabetical order, but Alpha was placed in front of the name (Alpha Alpha, Alpha Beta, Alpha Gamma, etc.). When the end of the “second alphabet” was reached chapters were named alphabetically using the “third alphabet” (Beta Alpha, Beta Beta, Beta Gamma, etc.). The chapters are organized here in alphabetical order according to the Greek Alphabet as was the custom of Phi Delta Delta. For the most part, this also yields a chronological order by charter date. However, names were given in the order charters were approved, but charter dates are based on actual installation. Accordingly, there are some exceptions.

#### **Alpha Chapter**

School:	University of Southern California
Charter Date:	November 11, 1911
Charter Members:	Gladys Moore Brown, Georgia Philipps Morgan Bullock, Sarah Elizabeth Patten Doherty, Annette Fillius Hunley, and Vere Radir Norton.
Installation:	N/A – This is the first chapter, and the charter members are collectively known as “The Founders” of Phi Delta Delta. The chapter was not so much installed as announced.
Merger Information:	Alpha Chapter merged into the Erskine Ross Chapter of Phi Alpha Delta on August 12, 1972.

#### **Beta Chapter**

School:	Washington College of Law
	[The school later became the law school of American University.]
Charter Date:	April 26, 1913
Charter Members:	Hettie B. Bell, Elizabeth M. Eggert, Scotia Starck Haggerty, Agnes A. Jones, and Hope K. Thompson.

Installation:	The chapter was installed by National President Annette F. Hunley (Alpha) who presented the chapter with a beautiful charter, sorority insignia, and corsages of roses and violets for the five charter members
Merger Information:	Beta Chapter merged into the Louis Dembitz Brandeis Chapter of Phi Alpha Delta on August 12, 1972.

## **Gamma Chapter**

*Gamma Chapter was revoked, and all members expelled at the first National Convention in 1917 “on grounds of disloyalty”.*

School:	Chicago-Kent College of Law
Charter Date:	May 10, 1913
Charter Members:	Records not available. As of this date, the only confirmed charter member of the chapter is Phyllis M. Kelley who was Dean of Beta Kappa Pi at the time of the installation and was reported in the press to be a member of both Phi Delta Delta and Beta Kappa Pi.
Installation:	The chapter was installed by National President Annette F. Hunley (Alpha).
Merger Information:	Not Applicable, the chapter no longer existed at the time of the merger and had no members.

## **Delta Chapter**

School:	University of Oregon
Charter Date:	February 1, 1914
Charter Members:	Nettie Mae Rankin Bolland, Laura E. Cavers, Marie G. Downes aka Sister Mary Justita, Elizabeth Jean Braun Glatt, and Ina J. Jaqua.
Installation:	The chapter was installed by National Vice President Vera Radir Norton (Alpha). A luncheon followed the ceremony at the home Nattie Mae Rankin.
Merger Information:	Delta Chapter merged into the George H. Williams Chapter of Phi Alpha Delta on August 12, 1972.

## **Epsilon Chapter**

School:	University of Washington

Charter Members:	<p><b>Students:</b> Henrietta B. Chamberlin, Mary G. Hoard, Charlotte Kolmitz, Eloise Van Slatte, Sarah B. Stewart, and Clara G. Wein.</p> <p><b>Alumnae:</b> Othilla Beals, Reah M. Whitehead, Reba J. Hurn, Grace McDonald Phillips, and Agnes Richmond.</p>
Installation:	The chapter was installed by Grace Arnold (Delta) and Elizabeth Braun (Delta). Delta Chapter assisted in the organization and installation of the new chapter.
Merger Information:	Epsilon Chapter merged into the Ralph O. Dunbar Chapter of Phi Alpha Delta on August 12, 1972.

## Zeta Chapter

School:	George Washington University
Charter Date:	February 15, 1918
Charter Members:	Bess Wooten Newsom Florence, Jeannette E. Jewell, Laura Volstead Lomen, Ruth Campbell Osolinach, and Bertha Elizabeth Pabst.
Installation:	The chapter was installed by Grand Recorder Jeannette E. Jewell (Alpha/Zeta) at her home in Washington, DC. Jewell had been initiated at University of Southern California, but she transferred back to George Washington University. She installed the chapter and became one of its charter members.
Merger Information:	Zeta Chapter merged into the John Jay Chapter of Phi Alpha Delta on August 12, 1972.

## Eta Chapter

School:	Portia Law School
	[Portia Law School became known as the New England School of Law in 1969.]
Charter Date:	January 24, 1920
Charter Members:	<p><b>Students:</b> Ethel Ruth Miller de Sousa, Neva C. Holden Ginder, Hazel Curnane Gow, Eba H. Johnson, Bertha R. MacLean, and Theresa M. Nelligan.</p>

<b>Honorary:</b>	Emma Fall Schofield (the first woman appointed judge in the New England States).
<b>Installation:</b>	The chapter was installed by Laura Volstead (Zeta).
<b>Merger Information:</b>	At the time of the merger with Phi Alpha Delta, Eta Chapter was inactive, and no Phi Alpha Delta Chapter was then chartered at the school. On March 11, 1974, the chapter was recharted as the Bertha MacLean Chapter of Phi Alpha Delta. The chapter was named for Eta charter member Bertha R. MacLean who had gone on to become a professor at and even serve as acting dean of the law school. Both the charter members of Eta Chapter and the March 11, 1974, initiates are considered charter members of MacLean Chapter.

## **Theta Chapter**

<b>Charter Date:</b>	December 13, 1920
<b>Charter Members:</b>	Ruth May Adair, Consuelo V. Krugg Cronk, Dorothy M. Jackson, Bertha B. Johnson, Helen Zenor Lamming, Carol M. Casner Oxley, and Daisy Fridell Ramey.
<b>Installation:</b>	The chapter was installed by Anita Veale Robbins (Alpha) in Green Hall in the offices of the Dean and was followed by a formal reception at Eldridge House. The chapter had originally been organized as the James Woods Green Club.
<b>Merger Information:</b>	Theta Chapter merged into the James Woods Green Chapter of Phi Alpha Delta on August 12, 1972.

## **Iota Chapter**

<b>School:</b>	Vanderbilt University
<b>Charter Date:</b>	May 19, 1921
<b>Charter Members:</b>	Theresa Sherrer Davidson, Edwina Falkner Mitchell, Mary M. Ryan, and Grace Willson Sims.
<b>Installation:</b>	The chapter was installed by Bess Newsom (Zeta). Following the installation, the chapter entertained the wives of the law faculty with a luncheon and were later taken on a picnic by the local chapter of Phi Delta Phi.

Merger Information: Iota Chapter merged into the Horace H. Lurton Chapter of Phi Alpha Delta on August 12, 1972.

## Kappa Chapter

School: Washburn College  
[The school later became Washburn University.]

Charter Date: May 21, 1921

Charter Members: Ivah C. Raines Glenn, Isabel L. Obee, Mary Phyllis Obee, Mary H. Williams Koger, Esther L. Reed Smith, Ruth M. Kaster Webb, and Marion McArthur Wyman.

Installation: The chapter was installed by members of Theta Chapter, and the ceremony took place at the home of Ruth Kaster followed by a banquet at Pelletier's Tea Room.

Merger Information: Kappa Chapter merged into the Alfred W. Benson Chapter of Phi Alpha Delta on August 12, 1972.

## Lambda Chapter

School: University of Pittsburgh

Charter Date: May 23, 1921

Charter Members: **Students:** Melba H.C. Stucky Billig, Mary C. Thompson Denman, and Helena Agnes Ivory.  
**Alumnae:** Mary Louise Callan and Sara M. Soffel.

Installation: The chapter was installed by Frances Park Kennedy (Zeta). The ceremony took place in a private room of the William Penn Hotel followed by a visit to the Law School and banquet.

Merger Information: Lambda Chapter merged into the David T. Watson Chapter of Phi Alpha Delta on August 12, 1972.

## Mu Chapter

School: University of Missouri - Columbia

Charter Date: January 21, 1922

Charter Members: Sallie Pryor Ely, Edith S. Hamby, Florence Elma Meisner, and Serelda Zoff.

Installation: The chapter was installed by Ruth May Adair (Theta), and the ceremony was held at the chapter house of Phi Delta Phi.

Merger Information: Mu Chapter merged into the John Davidson Lawson Chapter on August 12, 1972.

## **Nu Chapter**

School: Brooklyn Law School at St. Lawrence University

Charter Date: May 7, 1922

Charter Members: Adelaida Artola Allen, Eleanor L. Curnow, Amelia P. Dietrich Lewis, Edweine Schmitt, Madeline W. VanDine, Ione Weber, and Helen T. West.

Installation: The chapter was installed by Frances Park Kennedy (Zeta). The ceremony took place at the home of Helen T. West.

Merger Information: At the time of the merger with Phi Alpha Delta, Nu Chapter was inactive, and no Phi Alpha Delta Chapter was then chartered at the school. On January 30, 1977, the chapter was rechartered as the Fiorello Henry LaGuardia Chapter of Phi Alpha Delta. Both the charter members of Nu Chapter and the January 30, 1977, initiates are considered charter members of LaGuardia Chapter.

## **Xi Chapter**

School: Northwestern College of Law

[The Northwestern College of Law affiliated with Lewis and Clark College in 1965.]

Charter Date: May 20, 1922

Charter Members: Imo Laura De Lay, Hulda Patricia Malone-Anderson, Mary Jane Spurlin, and Louise F. Wilson.

Installation: The chapter was installed by Nettie Mae Rankin (Delta) and the ceremony took place in her home in Portland. Patricia Malone Anderson was the principal organizer of the chapter and worked with Nettie Mee Rankin, then National Recorder, to organize the chapter.

Merger Information: Xi Chapter merged with the James F. Byrnes Chapter on August 12, 1972. Byrnes chapter was later renamed the Karl N. Llewellyn Chapter.

## **Omicron Chapter**

School:	Dickinson Law School
Charter Date:	May 18, 1923
Charter Members:	Eleanor Fairman Buchanan, Mary Vashti Burr Whittington, Anna Elizabeth Davis, Eleanor Fulkerson Stevenson, and Dorothy Elizabeth Stroh.
Installation:	The chapter was installed by Lois Gates Gorman (Zeta), editor of Phi Delta Delta Magazine.
Merger Information:	At the time of the merger with Phi Alpha Delta, Omicron Chapter was inactive, and no Phi Alpha Delta Chapter was then chartered at the school. On March 7, 1975, the chapter was rechartered as Mary Vashti Burr Chapter of Phi Alpha Delta. The chapter was named for one the charter members of Omicron Chapter, Mary Vashti Burr, who later served a P.D.D. National President and as Assistant Attorney General of Pennsylvania. Both the charter members of Omicron Chapter and the March 7, 1975, initiates are considered charter members of Burr Chapter.

## **Pi Chapter**

	[In 1967, Western Reserve University merged with Case Institute of Technology to become Case Western Reserve University.]
Charter Date:	May 19, 1923
Charter Members:	Hazel E. Foster, Florence Cunnea Kapp, Margaret Ramsey Lawrence, Nettie Nulton, and Meta W. Peters.
Installation:	The chapter was installed by Sara M. Soffel (Lambda), and the ceremony was held at the home of Florence Cunnea Kapp
Merger Information:	Pi Chapter was merged into the John Milton Hay Chapter of Phi Alpha Delta on August 12, 1972.

## **Rho Chapter**

School:	John B. Stetson University
Charter Date:	May 27, 1923

Charter Members:	<b>Students:</b> Esther Miriam Finney, Abbie Elizabeth Lapham, Florence Margaret Hazard Mims, and Emily Schirner Williams Ziegler. <b>Alumnae:</b> Edith Merserve Atkinson
Installation:	The chapter was installed by Alabama Assistant Attorney General Edwina Falkner (Iota). After the installation, Dean Lincoln Hulley and his wife gave a dinner in their home in honor of the chapter and installing officer. The Dean excused the members from attending class and sent flowers for the installation. The chapter was first organized as Alpha Beta Gamma Legal Fraternity. At the time, it was believed that Stetson was the only law school in Florida which admitted women.
Merger Information:	Rho Chapter merged into the David T. Brewer Chapter of Phi Alpha Delta on August 12, 1972.

## Sigma Chapter

School:	University of Buffalo [In 1962, the University of Buffalo was purchased and incorporated into State University of New York and became known as the State University of New York at Buffalo.]
Charter Date:	September 22, 1923
Charter Members:	<b>Students:</b> Katherine Karin Welch Brown, Marquerite Elizabeth Kennedy, Ethelyn Dudley Strauss, and Martha Virginia Driscoll Watson. <b>Alumnae:</b> Edna E. Briggs, Frieda H. Brendal Bulger, Alice L. Doorty, Edna M. Bailey Drew, Genevieve J. Goergen, Madge Taggart Doyle Hurd, Mary A. Blakely Lane, Irene O. Sullivan, and Irene M. Croggins Tatu.
Installation:	The chapter was installed by Mary C. Thompson (Lambda) in a ceremony held at the New Statler Hotel in Buffalo. The ceremony was followed by a banquet at which the law school was represented by its Registrar George Crofts and his wife. The following day the chapter and Sister Thompson went on an outing to visit Niagara Falls. The chapter had originally been organized as the Sigma Phi Sorority.
Merger Information:	Sigma Chapter merged into the Carlos C. Alden Chapter of Phi Alpha Delta on August 12, 1972.

Merger Information:	Tau Chapter merged into the Owen J. Roberts Chapter of Phi Alpha Delta on August 12, 1972.

## Upsilon Chapter

School:	Willamette University
Charter Date:	May 29, 1924

Merger Information:	At the time of the merger with Phi Alpha Delta, Upsilon Chapter was inactive, and no Phi Alpha Delta Chapter was then chartered at the school. On March 29, 1981, the chapter was rechartered as Hall S. Lusk Chapter of Phi Alpha Delta. Both the charter members of Upsilon Chapter and the March 29, 1981, initiates are considered charter members of Lusk Chapter.

Installation:	The chapter was installed by Carol Kasner Oxley (Theta) and Florence E. Meisner (Mu). The ceremony was held at

the chapter house of Phi Alpha Delta's Benton Chapter followed by a banquet at the Kansas City Athletic Club. The ceremony and banquet were well attended by members the Kansas City Alumnae Chapter and Theta Chapter.

**Merger Information:** Psi Chapter merged into the Thomas Hart Benton Chapter of Phi Alpha Delta on August 12, 1972.

**Installation:** The chapter was installed by Province Two Secretary Hon. Mary Jane Spurlin (Xi), Veida S. Morrow (Epsilon), and Adelyn Burrus (Epsilon). The installation took place in the Blue Room of the Vancouver Hotel. A banquet followed the ceremony. The chapter had originally been organized as the Vancouver Women Law Student's Society under the leadership of Judge MacGill.

**Merger Information:** At the time of the merger with Phi Alpha Delta, Omega Chapter was inactive, and the Vancouver law school had given way to the Faculty of Law at the University of British Columbia where no Phi Alpha Delta Chapter was then chartered. On February 10, 1974, the chapter was rechartered as the Matthew Baille Begbie Chapter of Phi Alpha Delta at the University of British Columbia. Both the charter members of Omega Chapter and those initiated at the rechartering are considered charter members of Begbie Chapter.

Mary O'Toole (Beta), Judge of the Municipal Court of Washington, D.C. and the first woman judge to be appointed by the President of the United States, gave the address at the banquet. The group which became Alpha Delta Chapter was originally organized as the Inez Milholland Law Club.
